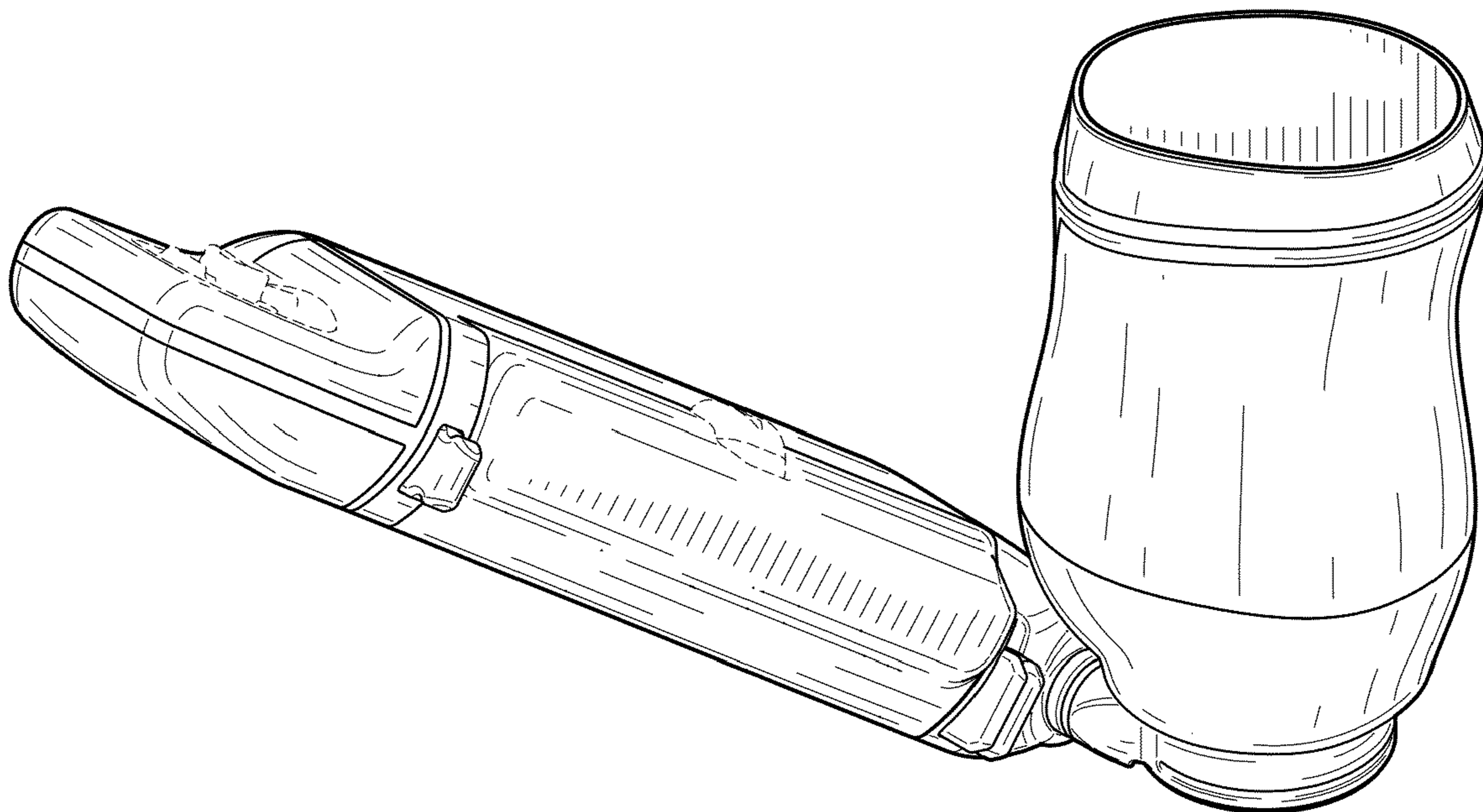
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of a medical device, showing our new design;
FIG. 2 is a rear perspective view of the medical device;

FIG. 4 is a rear elevation view of the medical device;

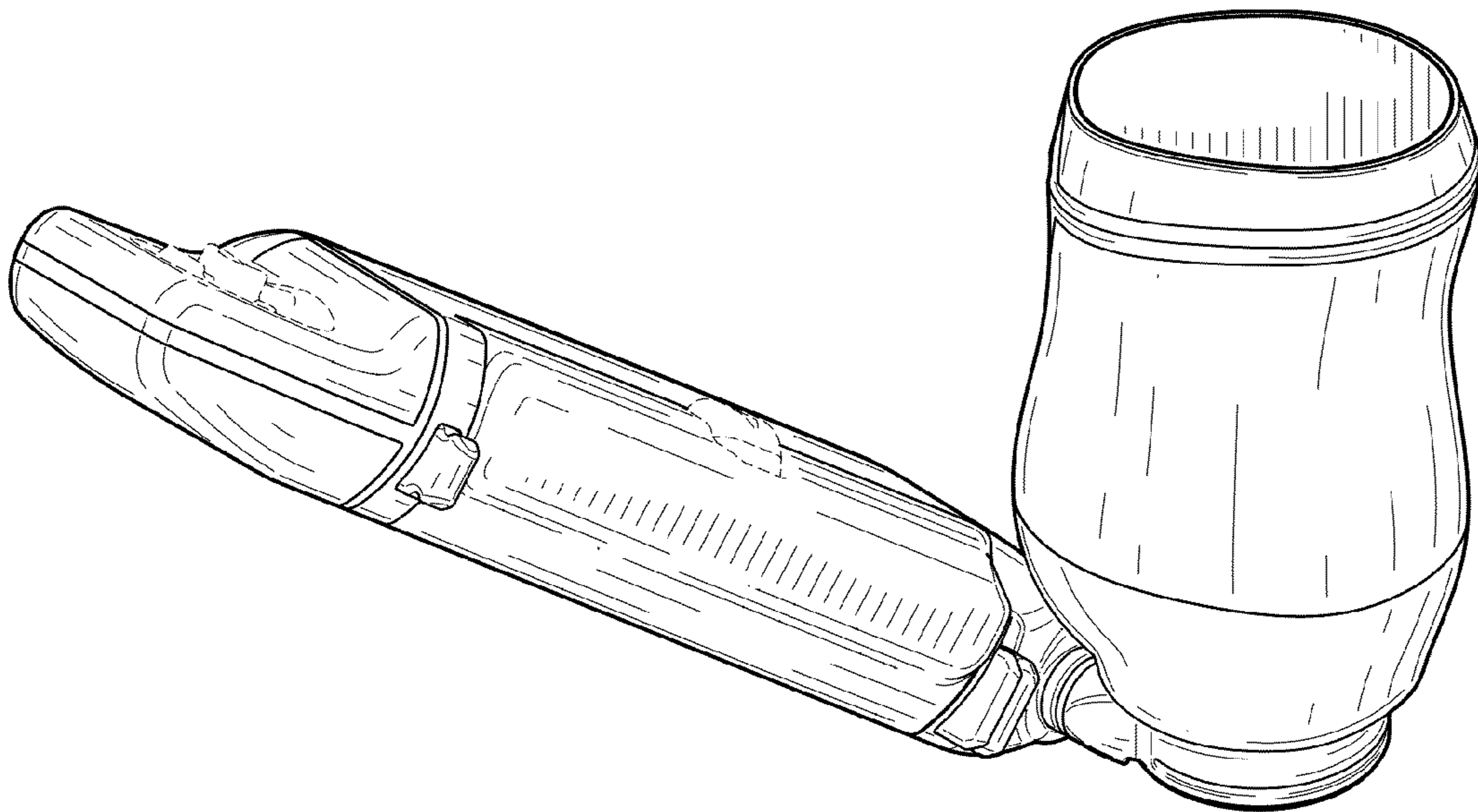

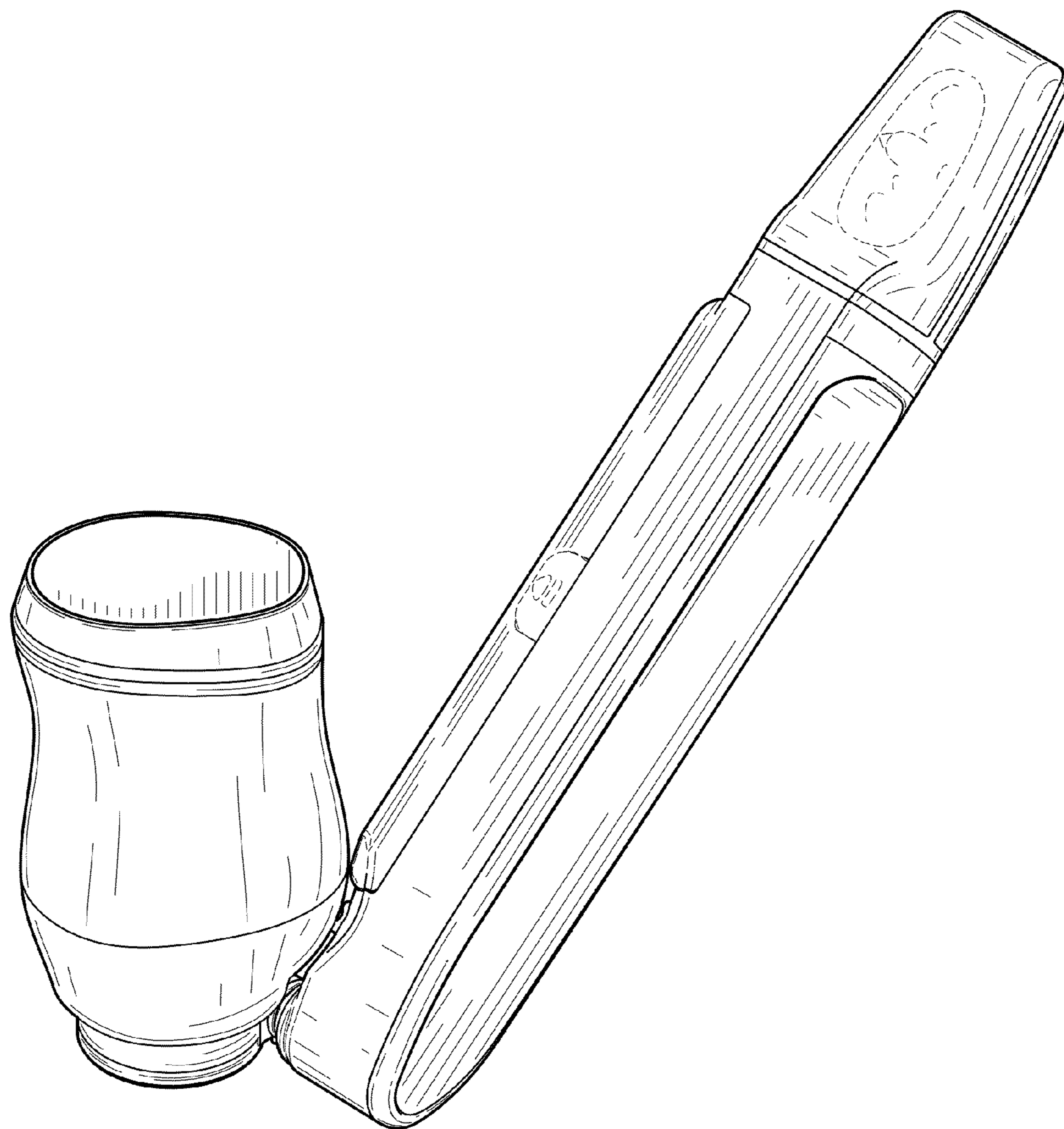

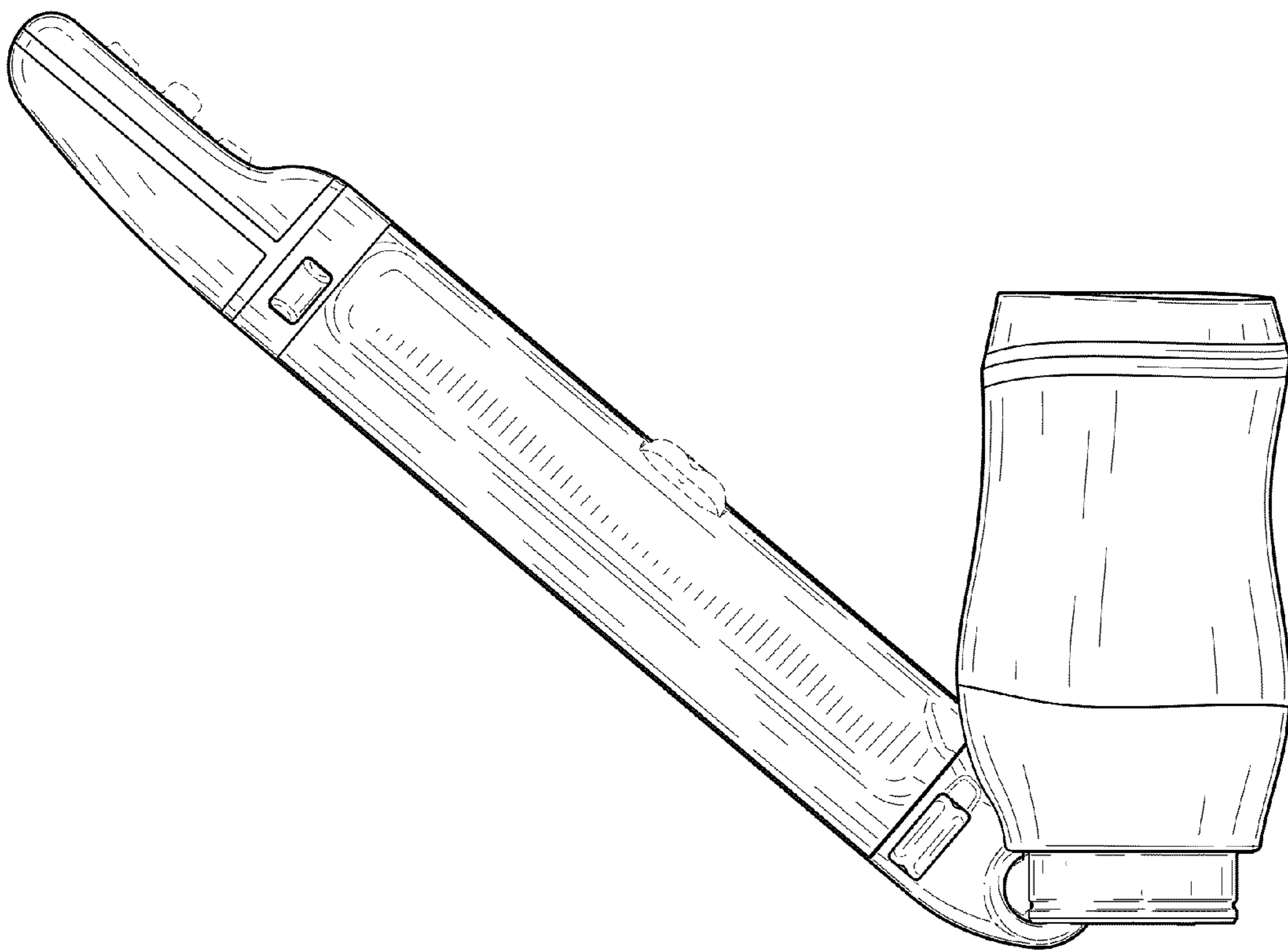

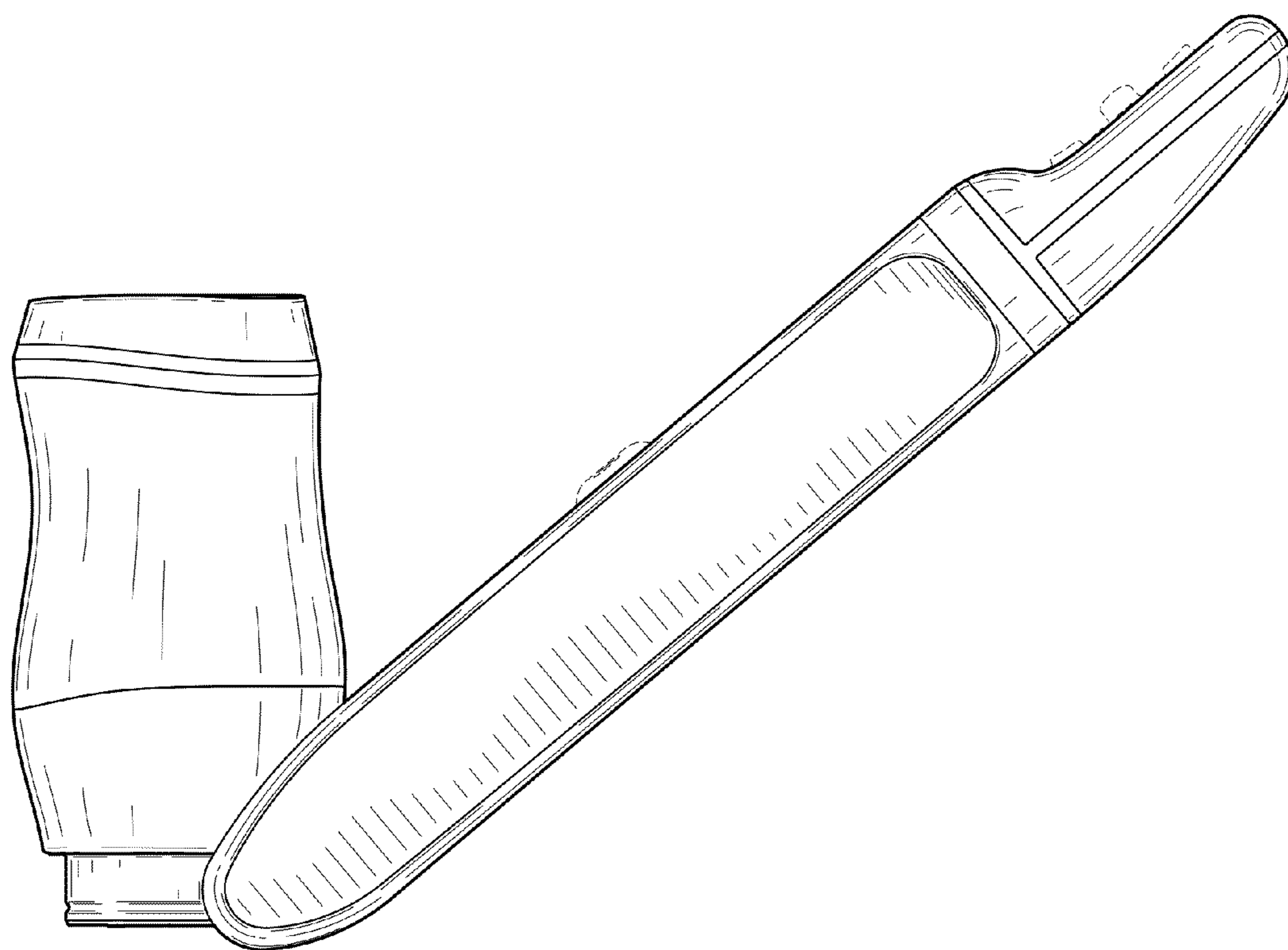

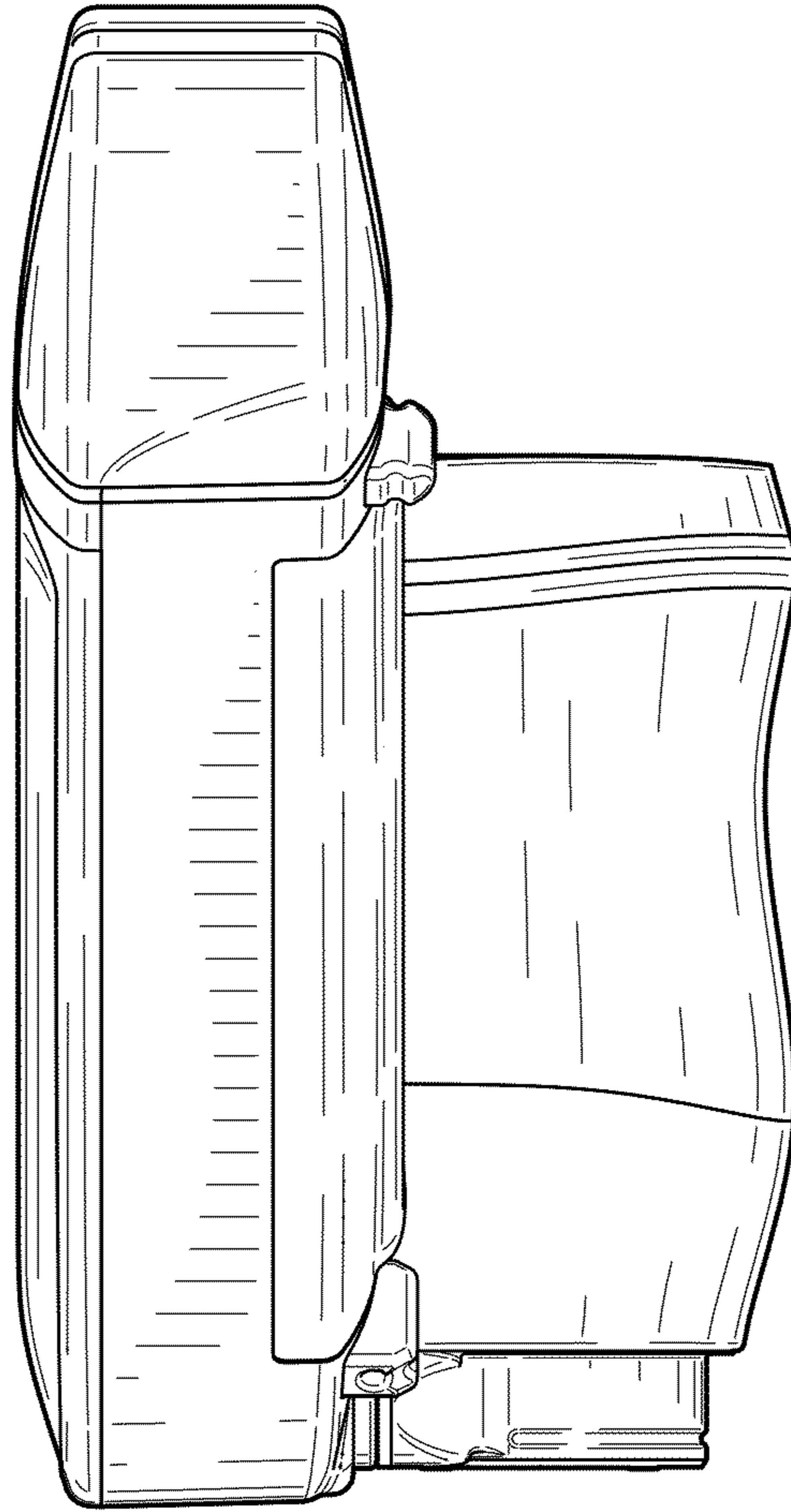

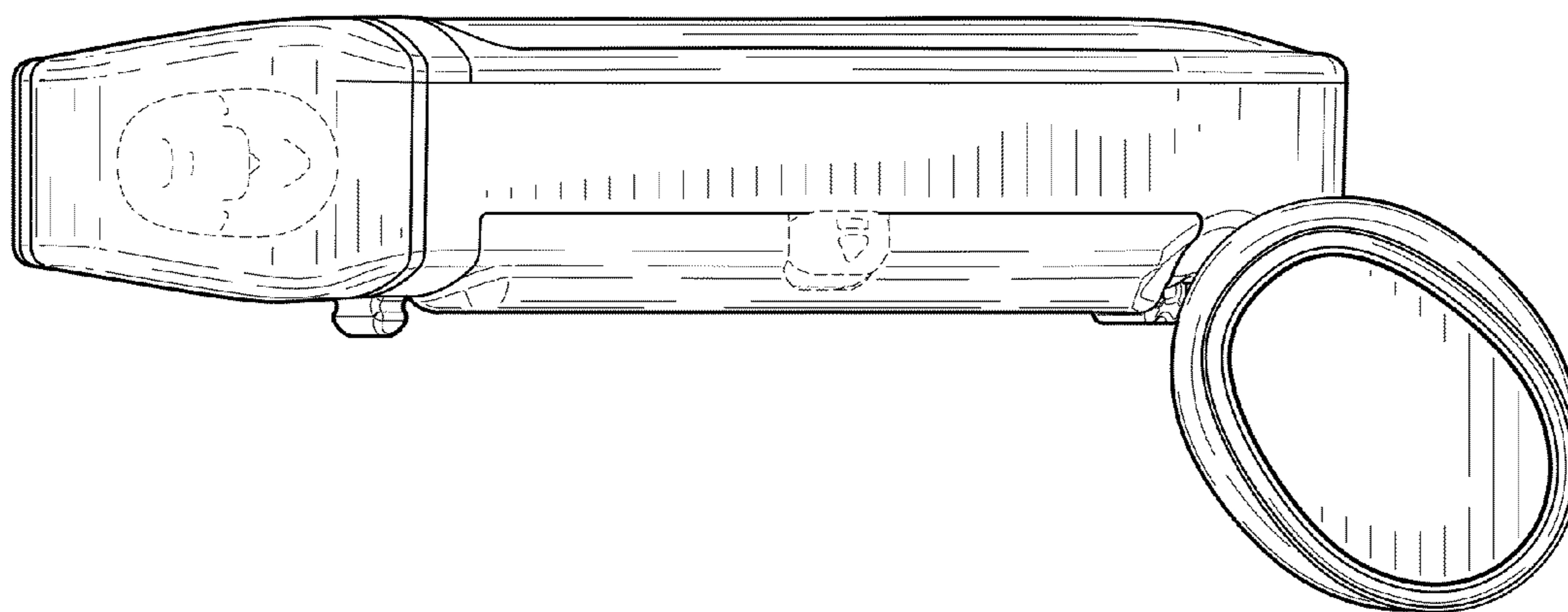

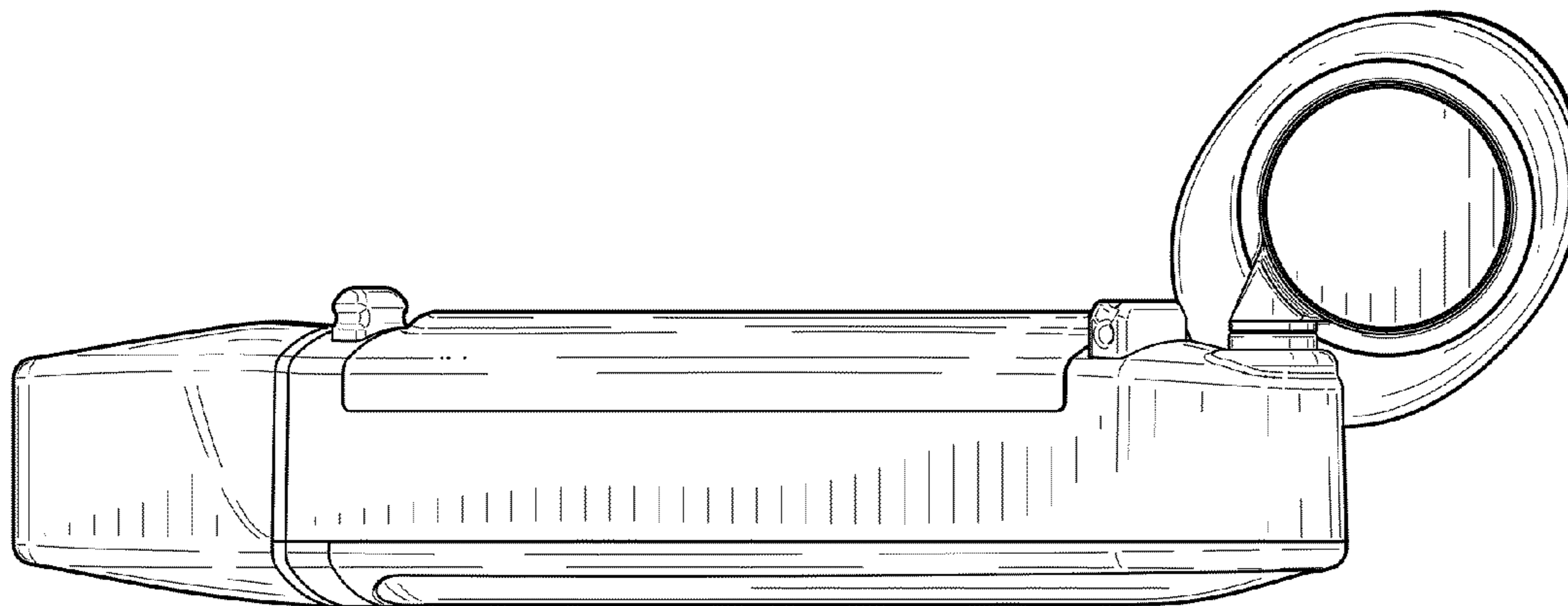
