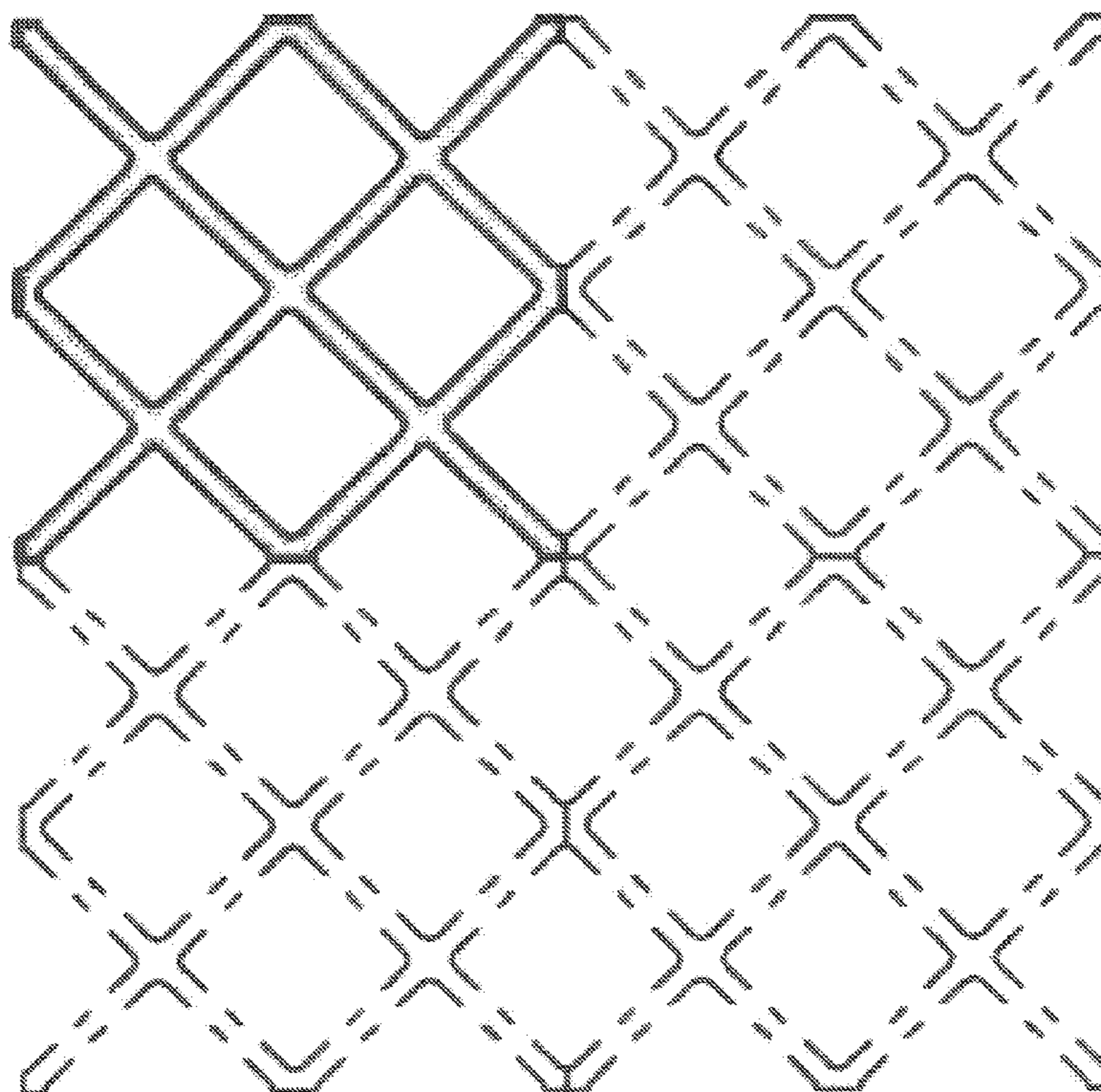
FIG. 1 is a top plan view of a rotatable, homogeneous diagonal preform for traffic patterns, showing the new design; FIG. 2 is a perspective view thereof; FIG. 3 is a top plan view of the assembly of a combination of a two x two patterned preform template creating adjacent design portions as shown in FIG. 1. FIG. 4 is a top plan view of the extended assembly of a two x four patterned preform block portion as shown in FIGS. 1 and 3, assembled in such a manner as to form a more complete and robust design; and, FIG. 5 is another top plan view of a further extended assembly of four x four patterned preform block portions creating the most complete robust pattern as shown in FIG. 4. The broken line showing like preforms is for illustrative purposes only and forms no part of the claimed design.

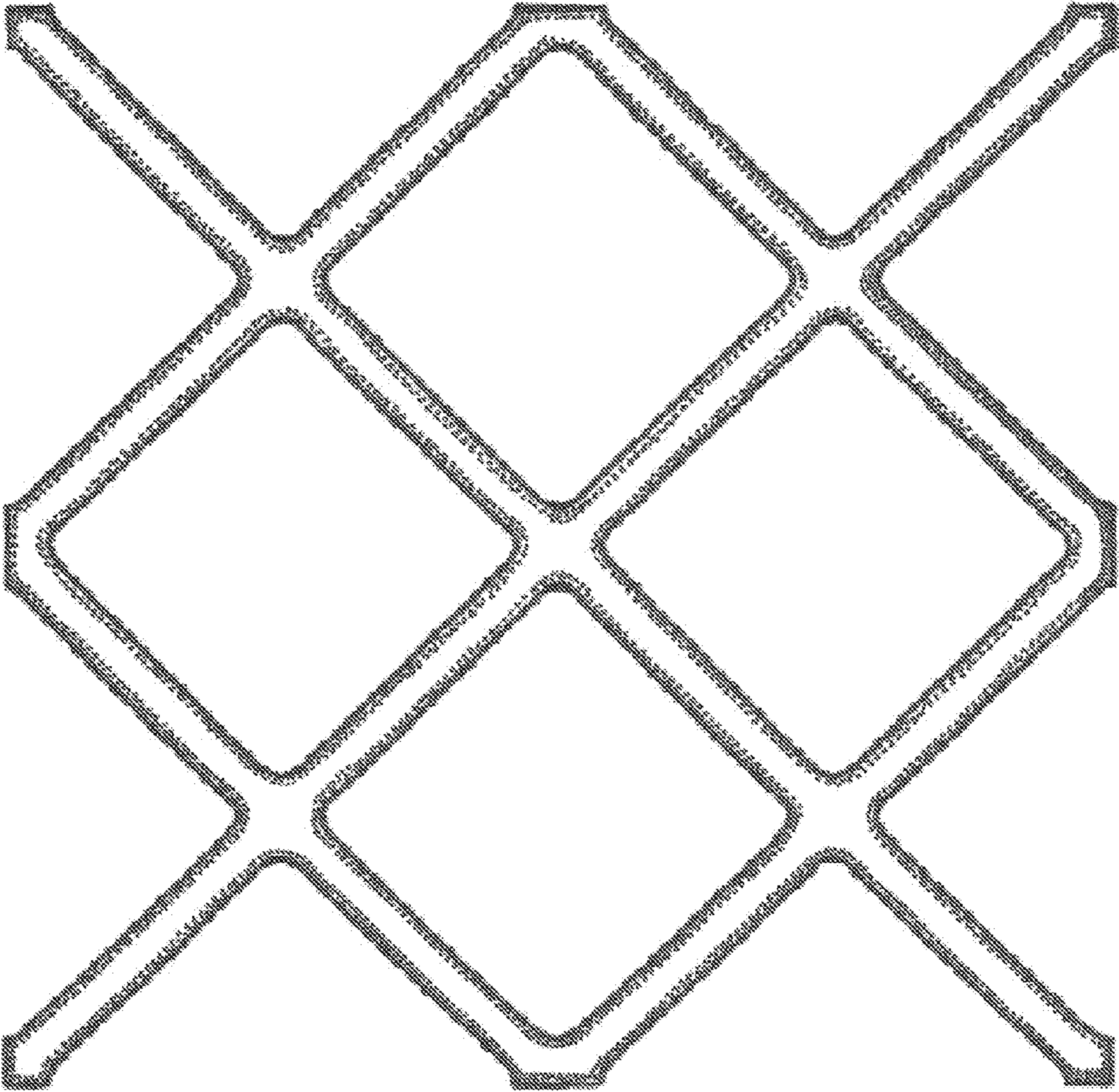

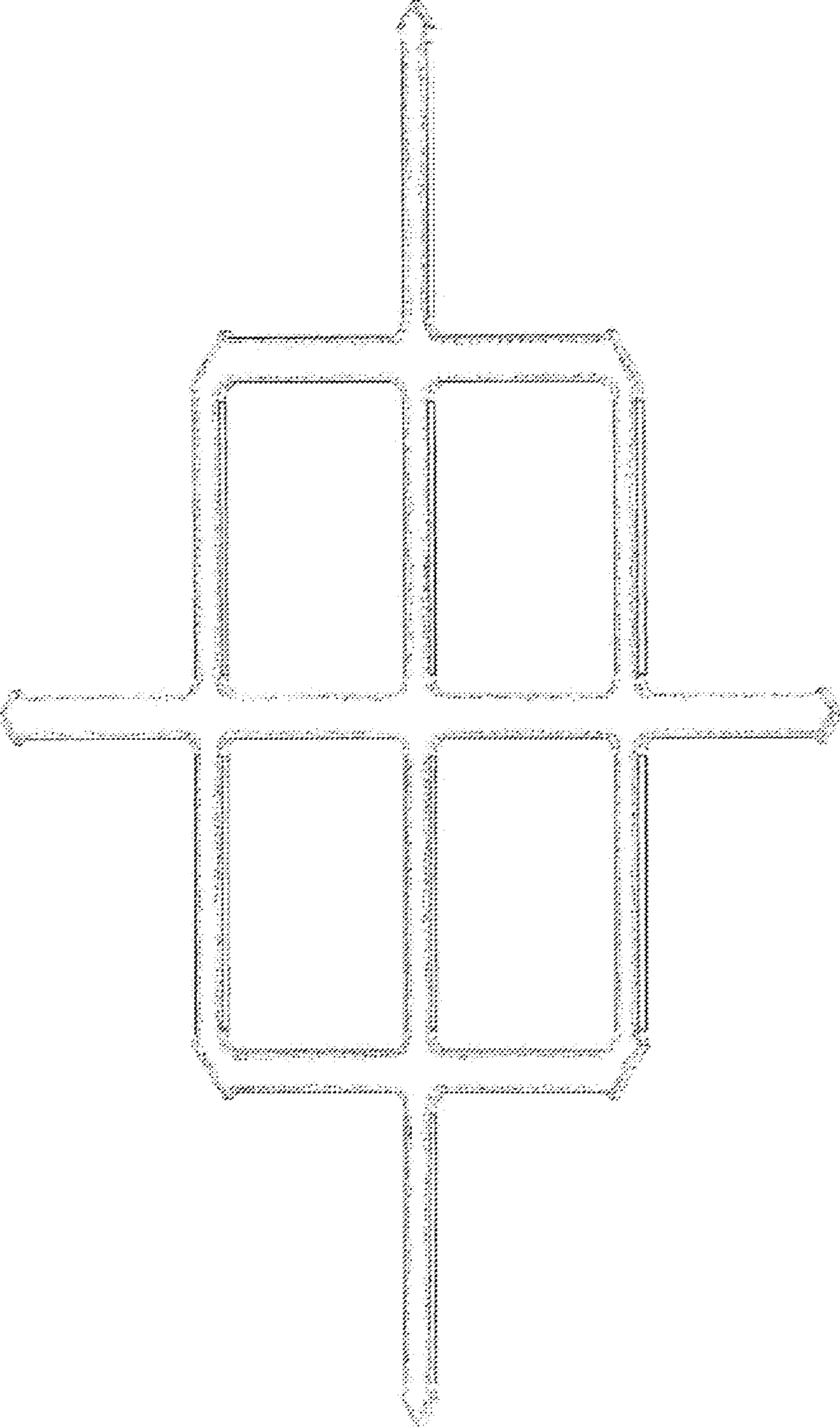

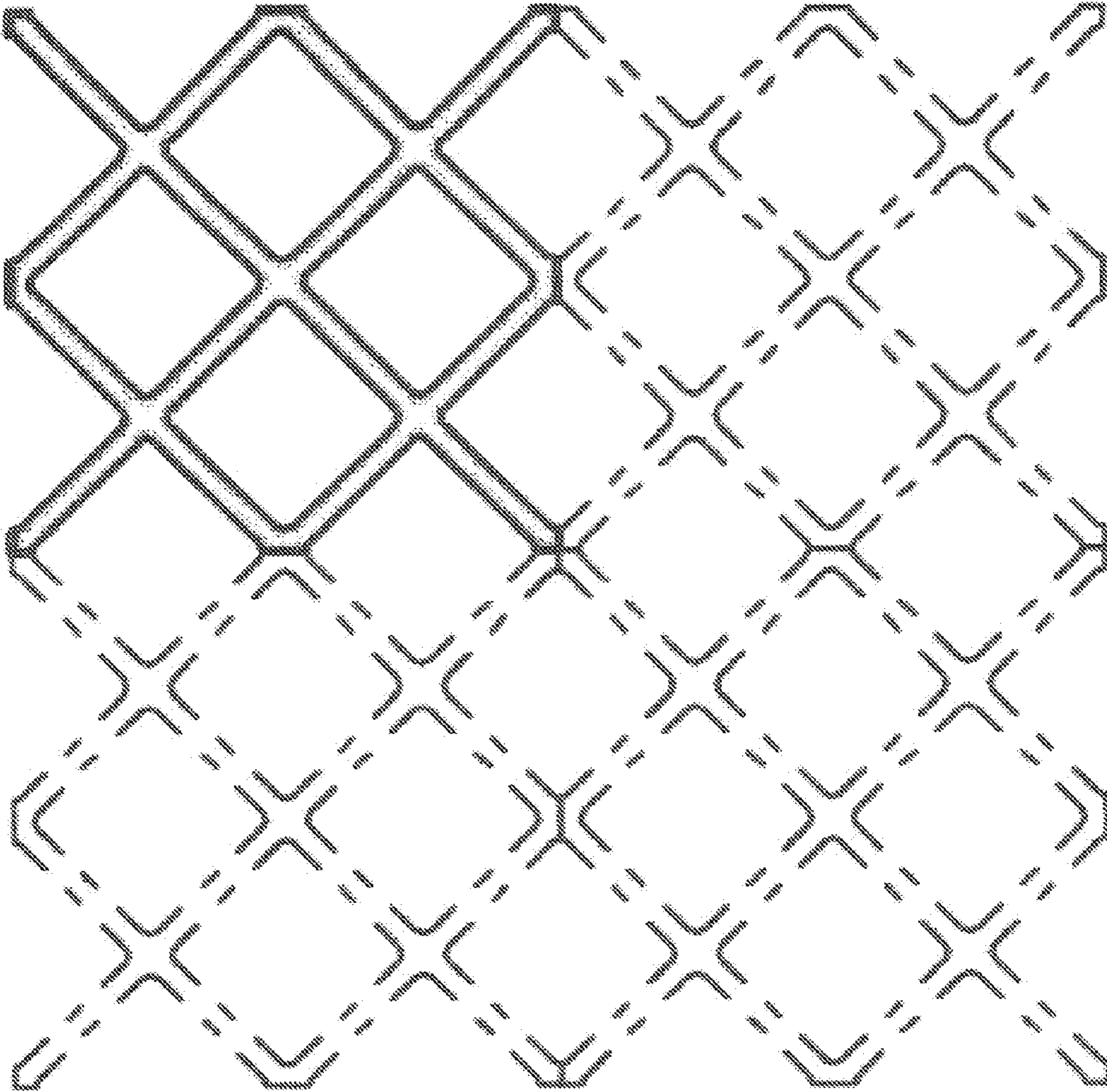
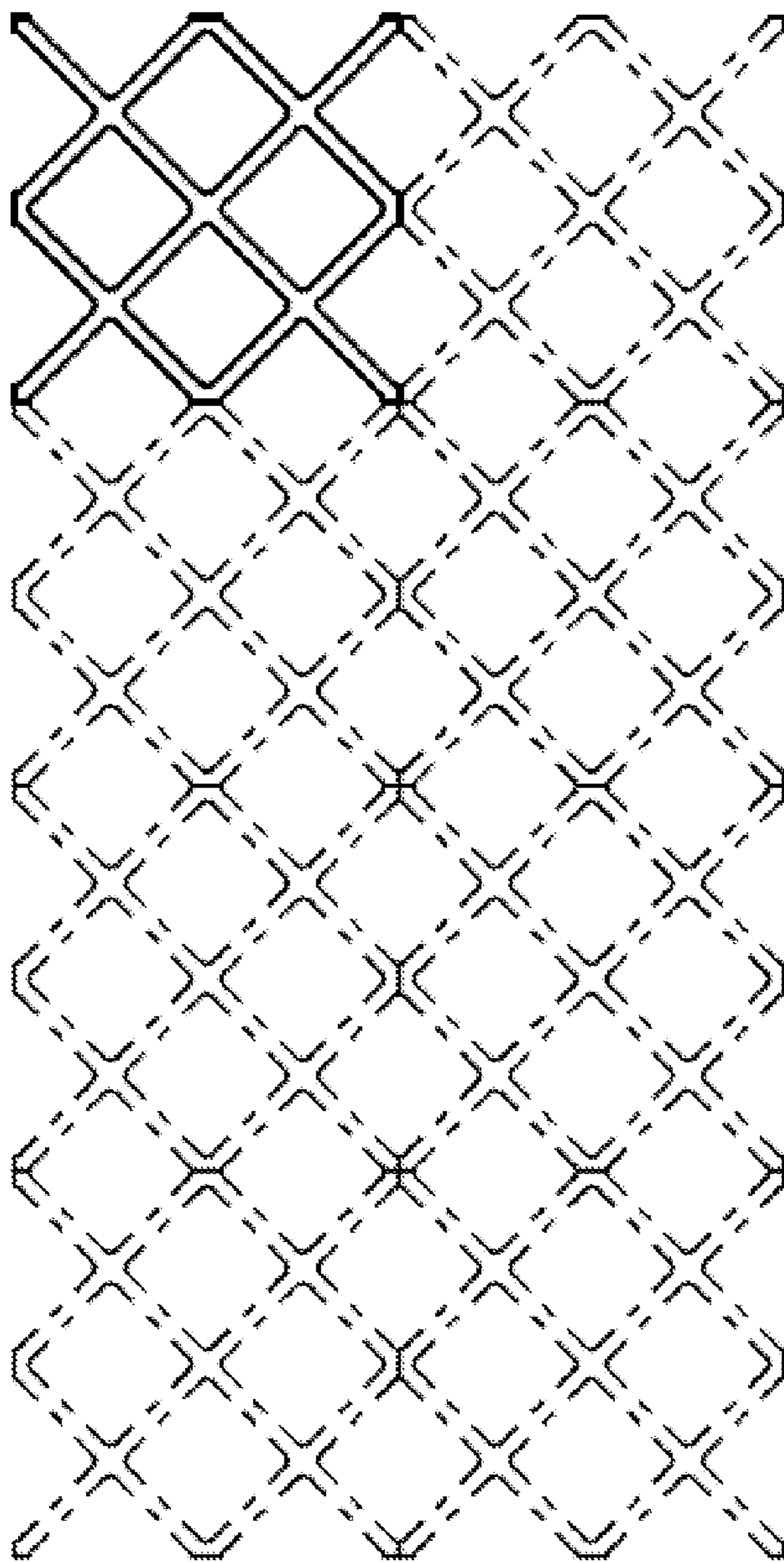

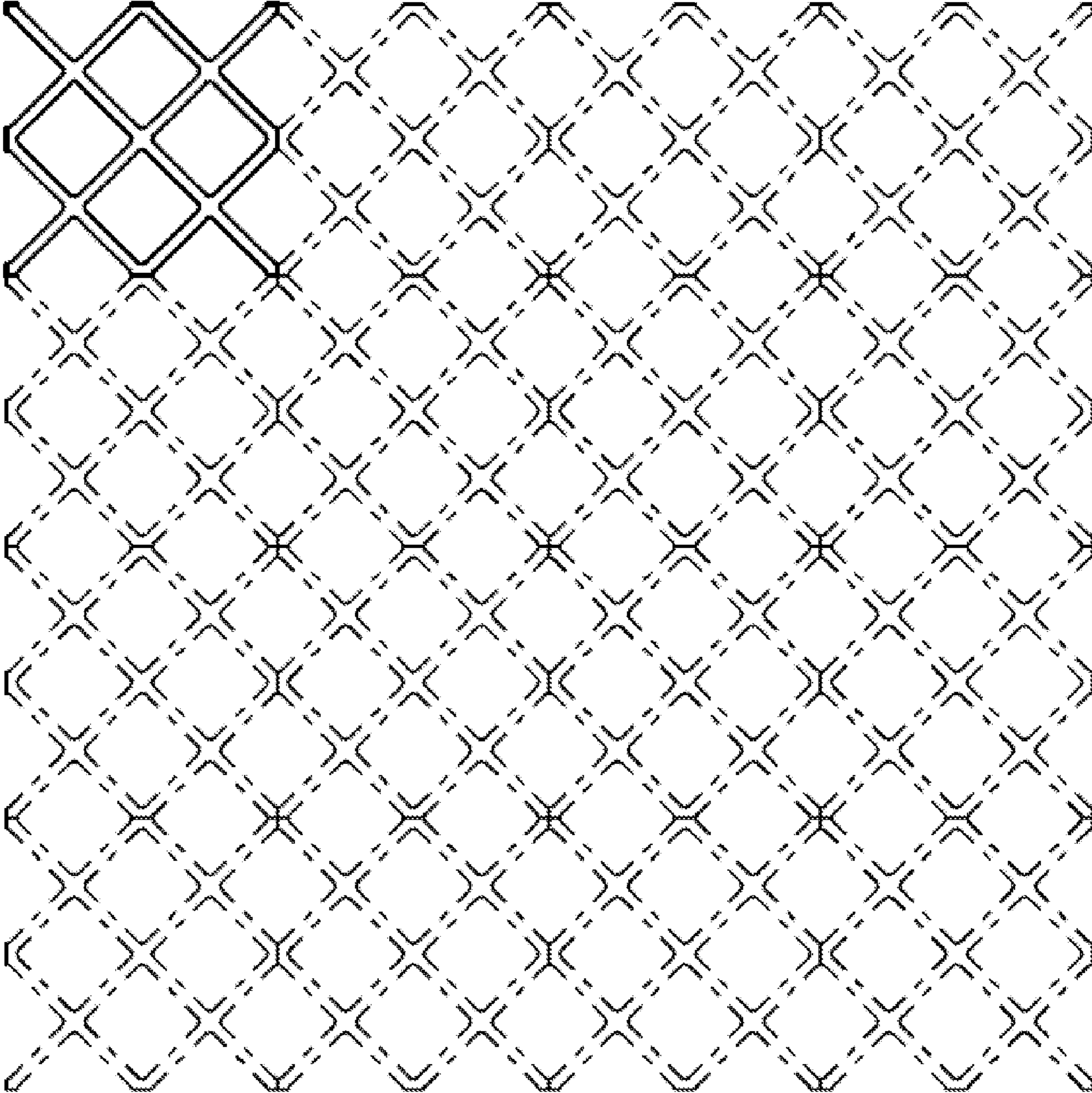
