FIG. 7 is a left side view of the embodiment.

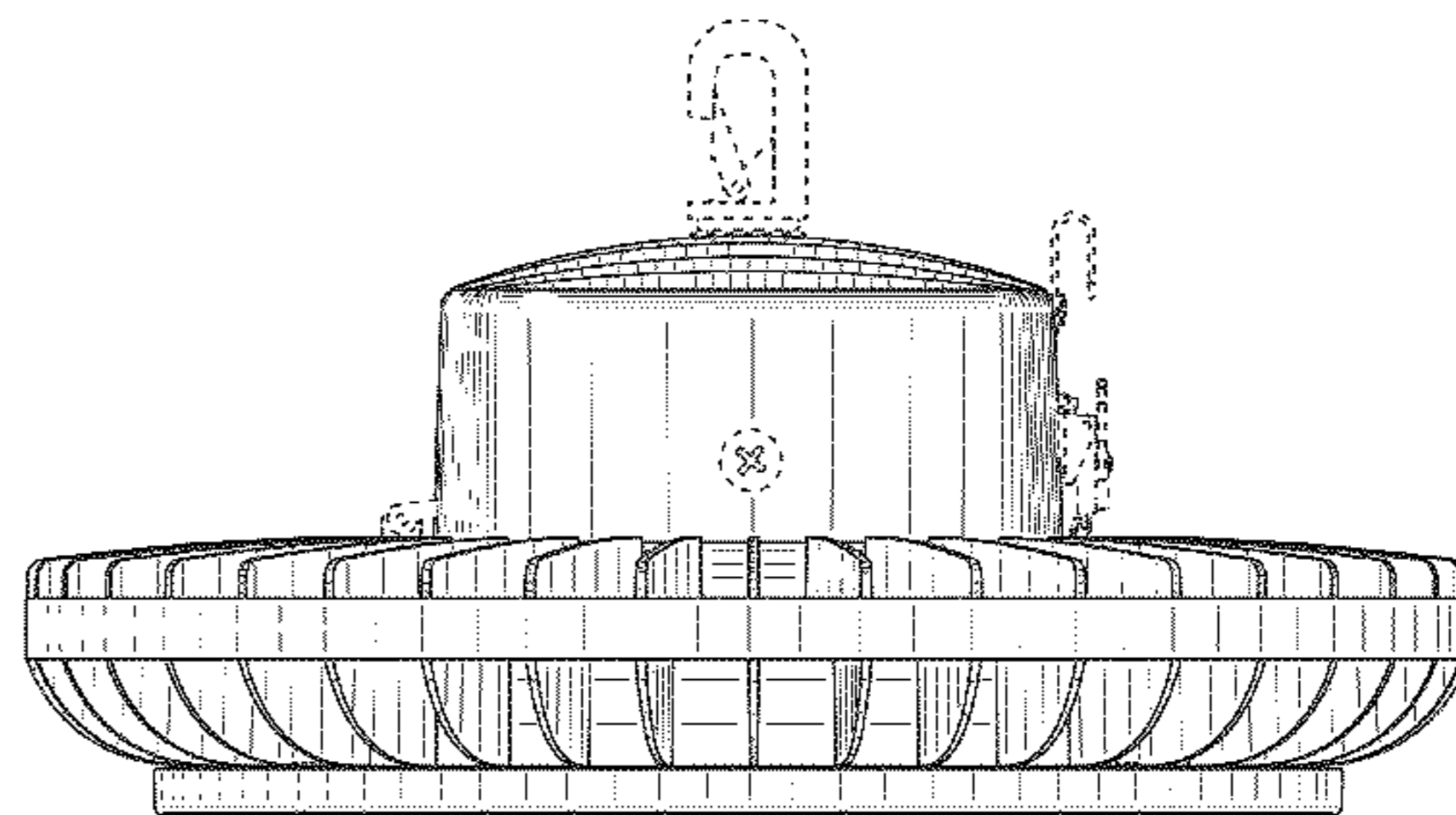
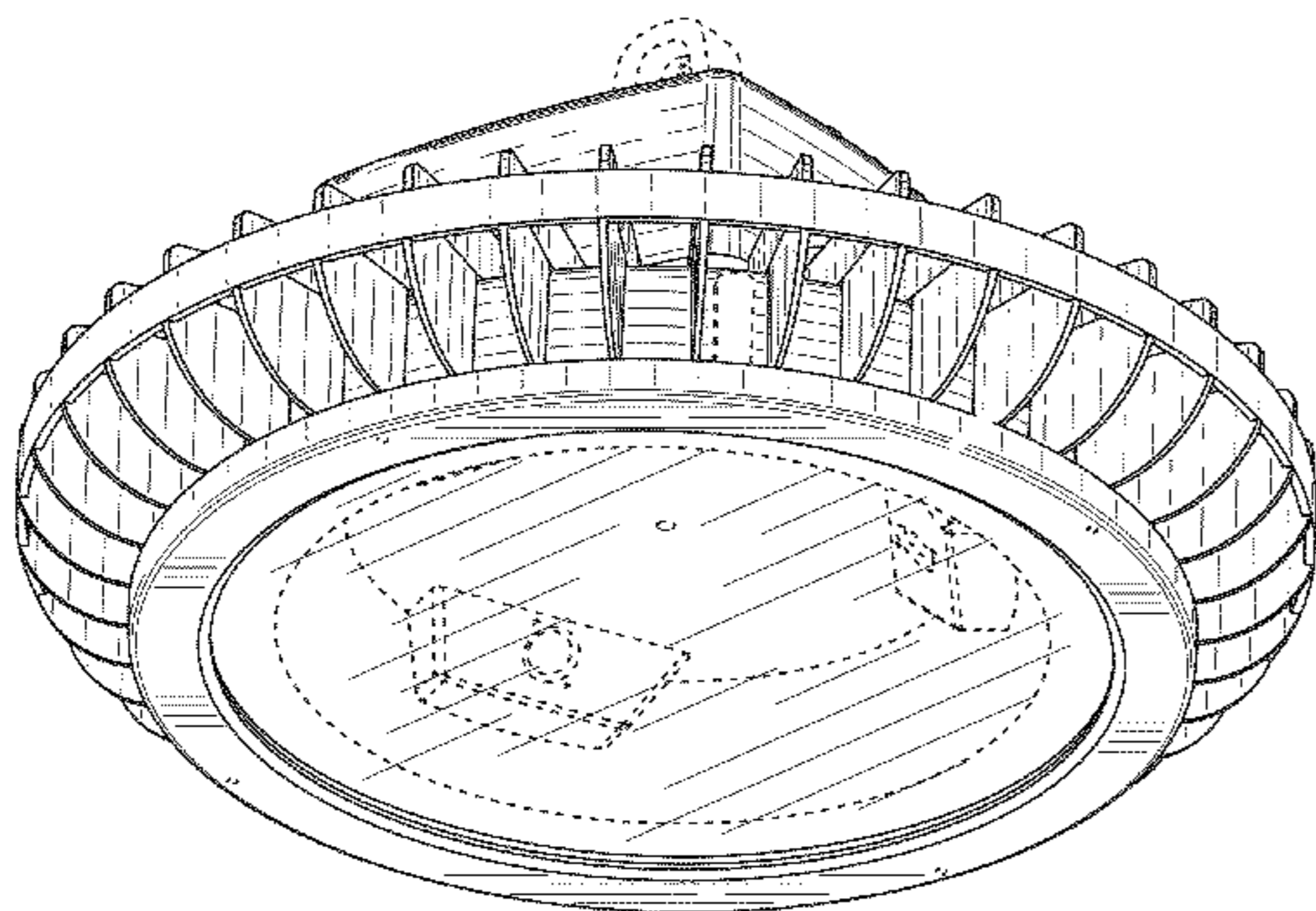

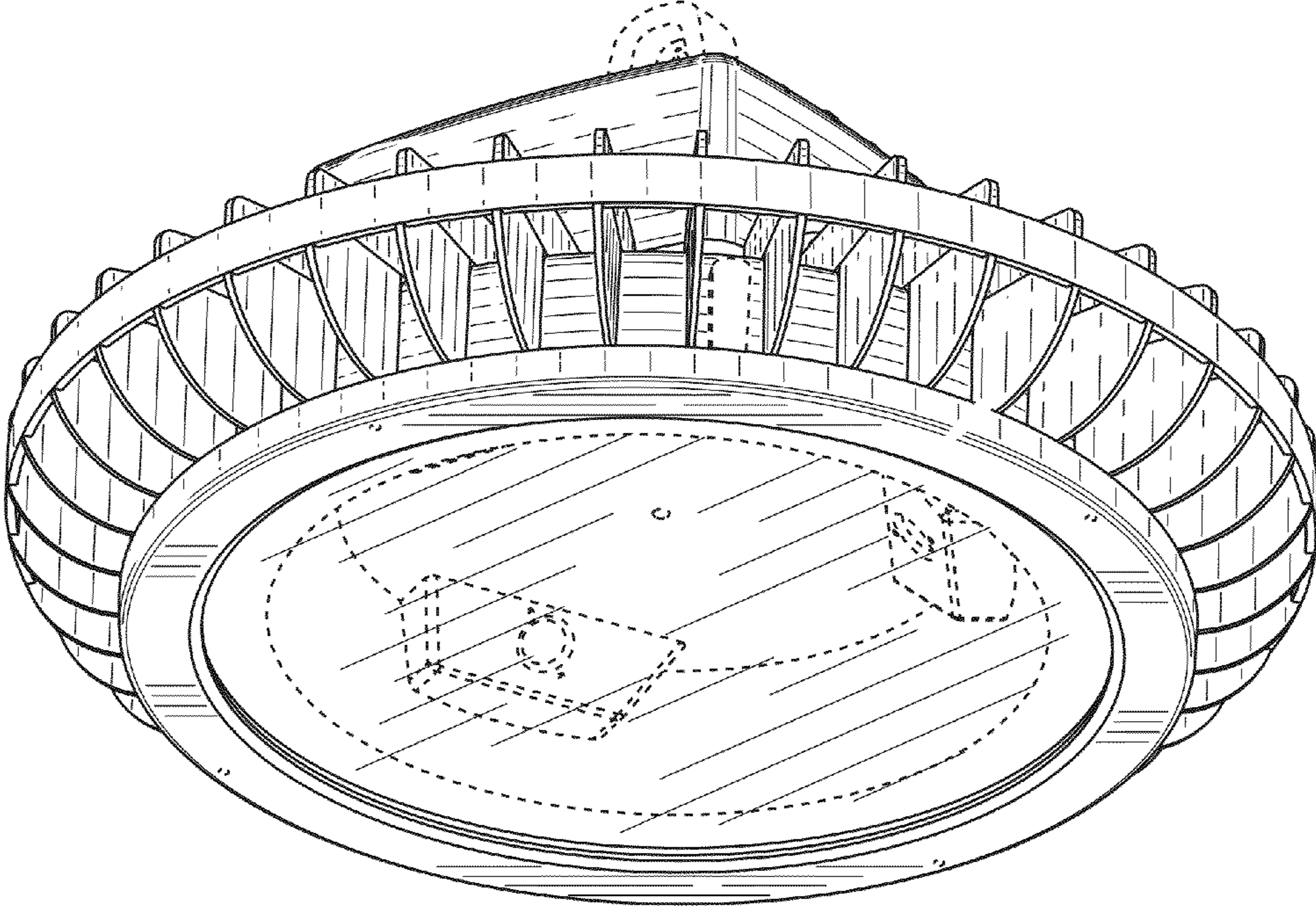

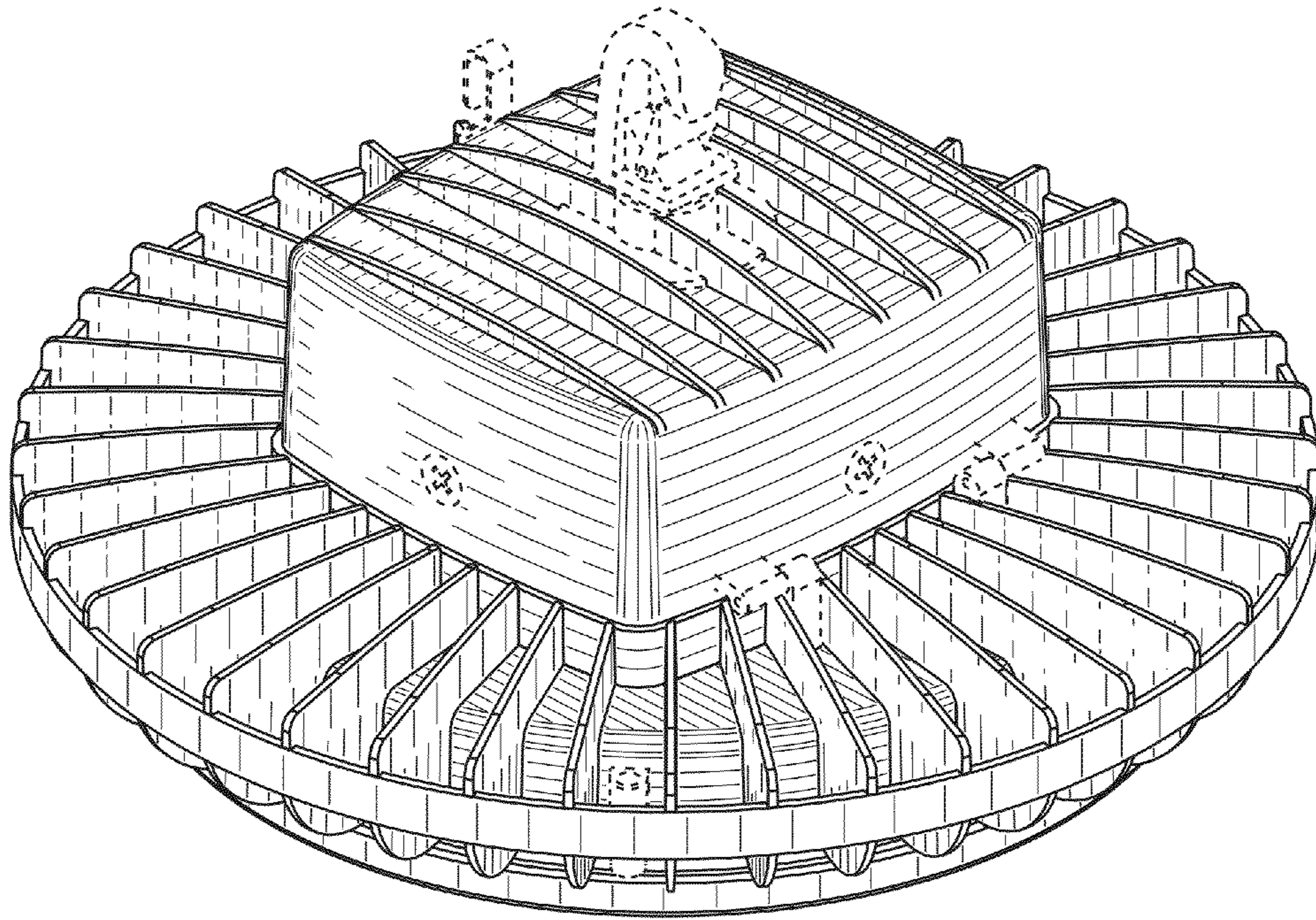

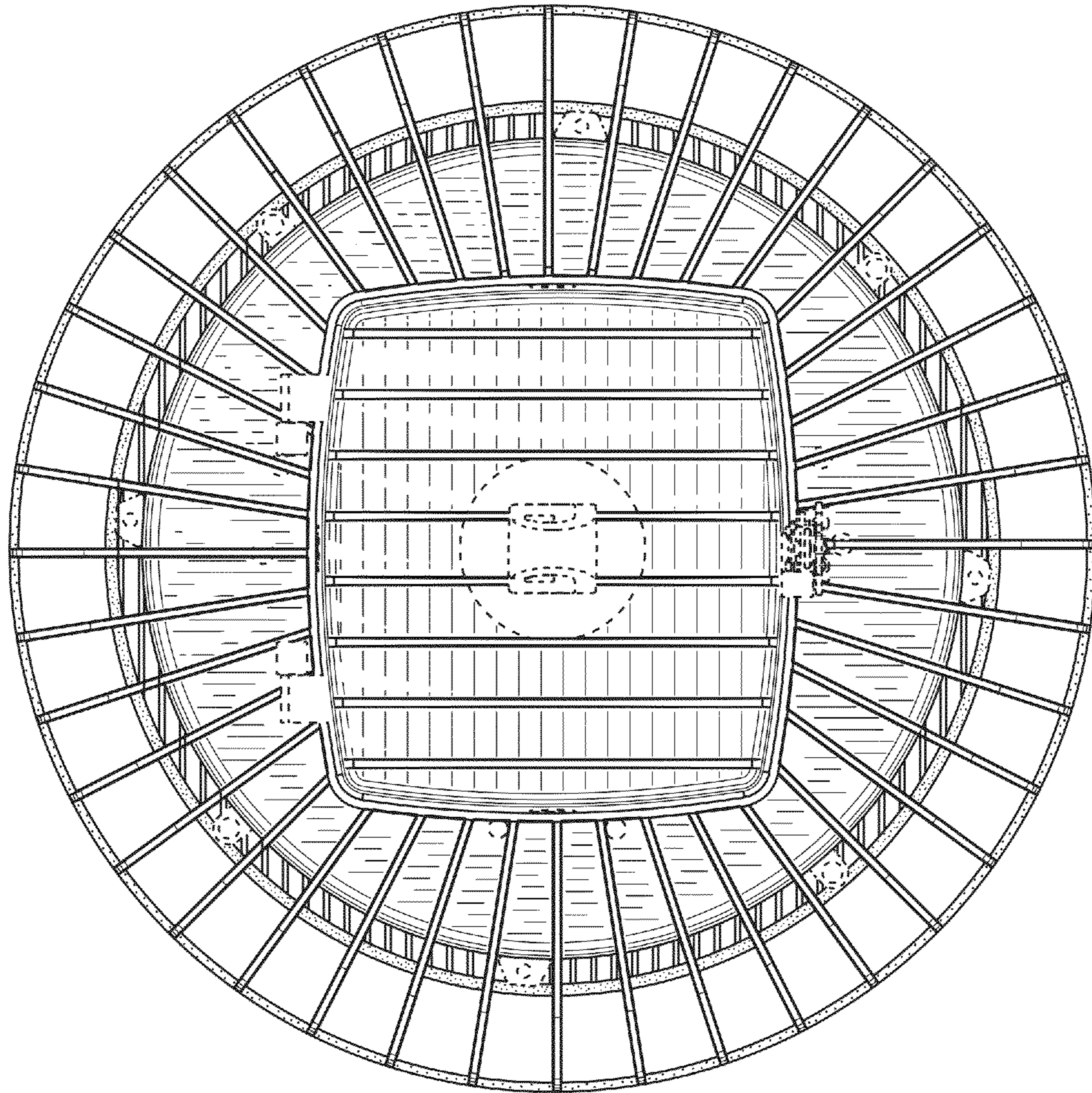

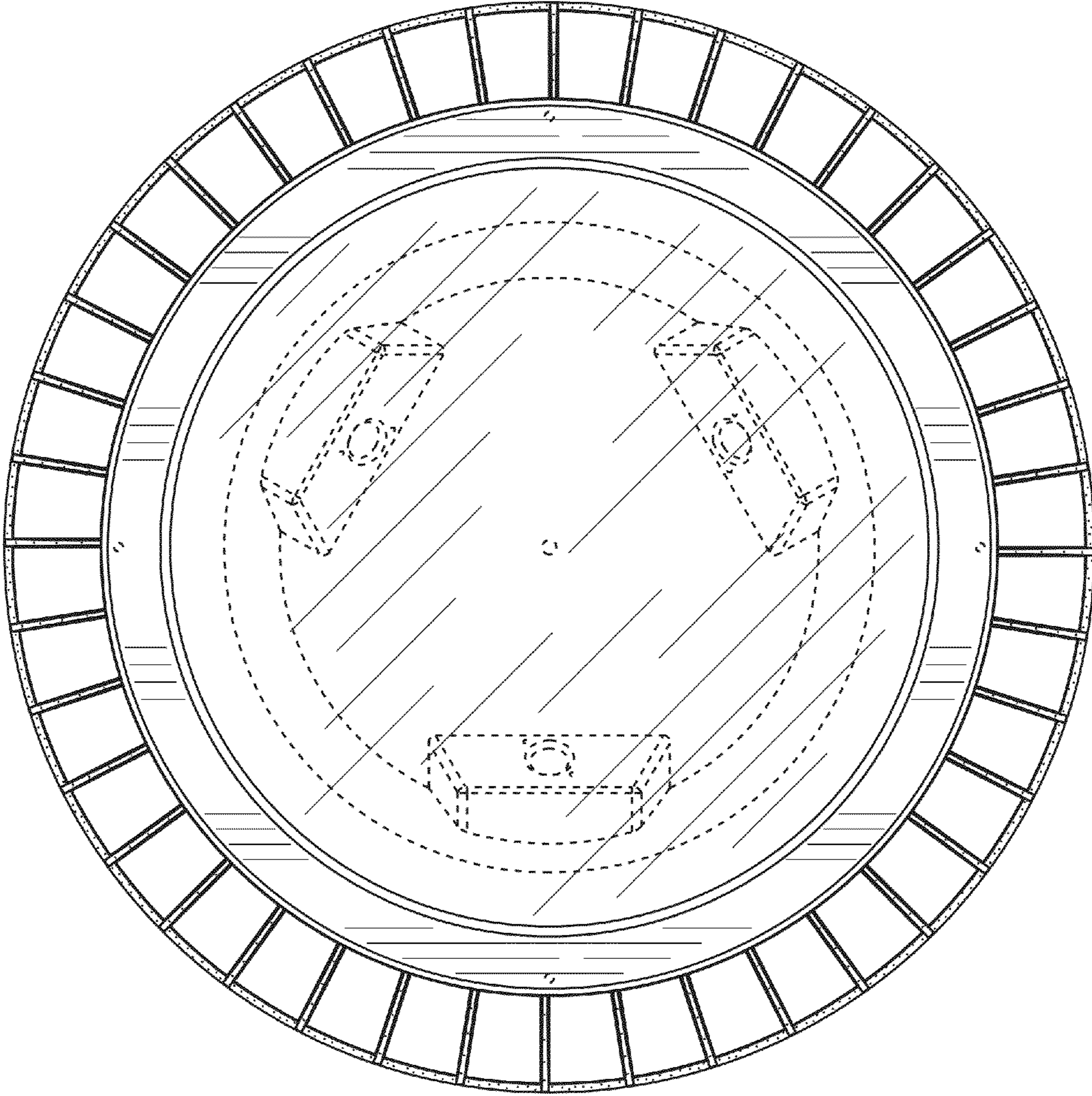

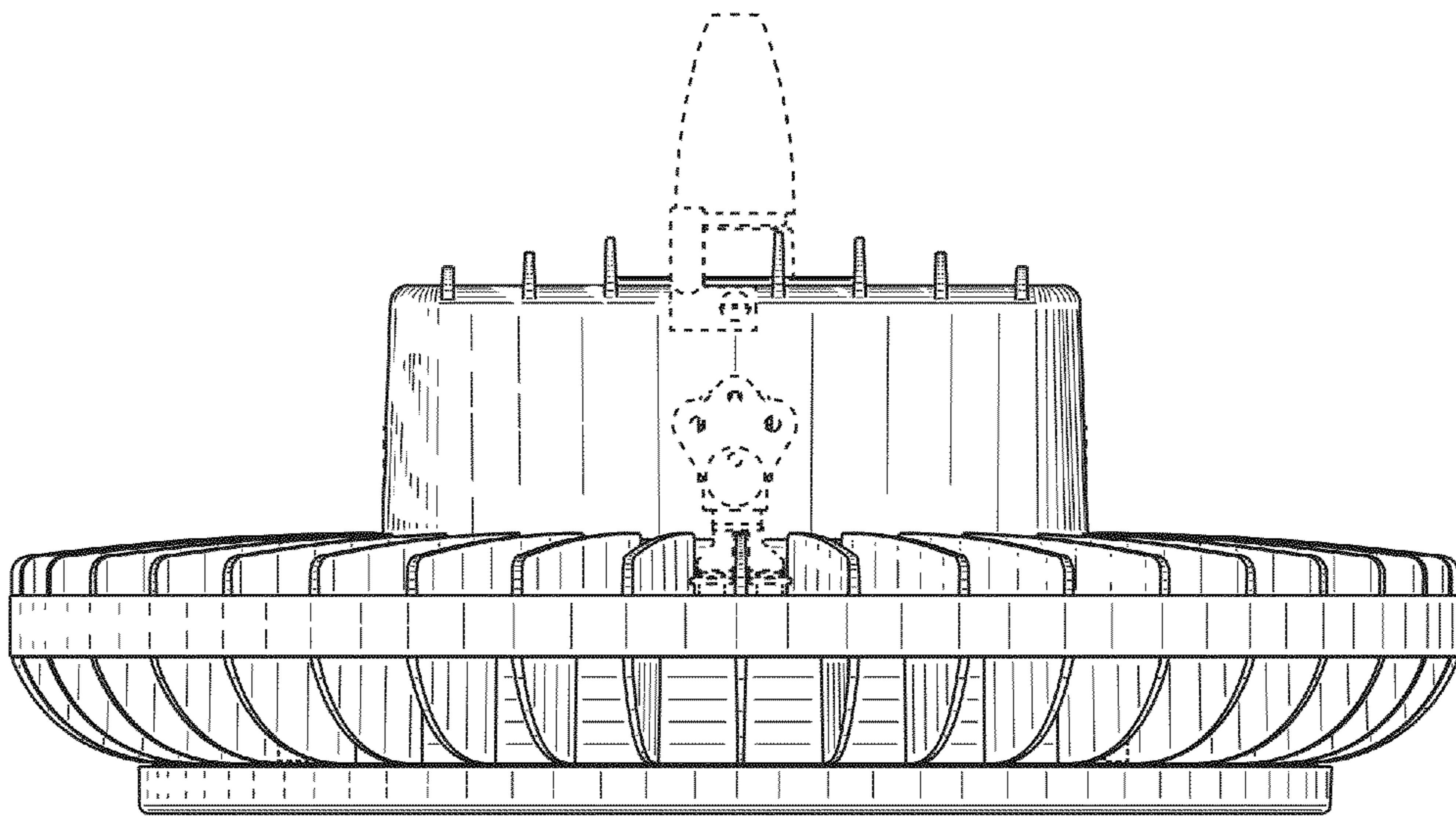

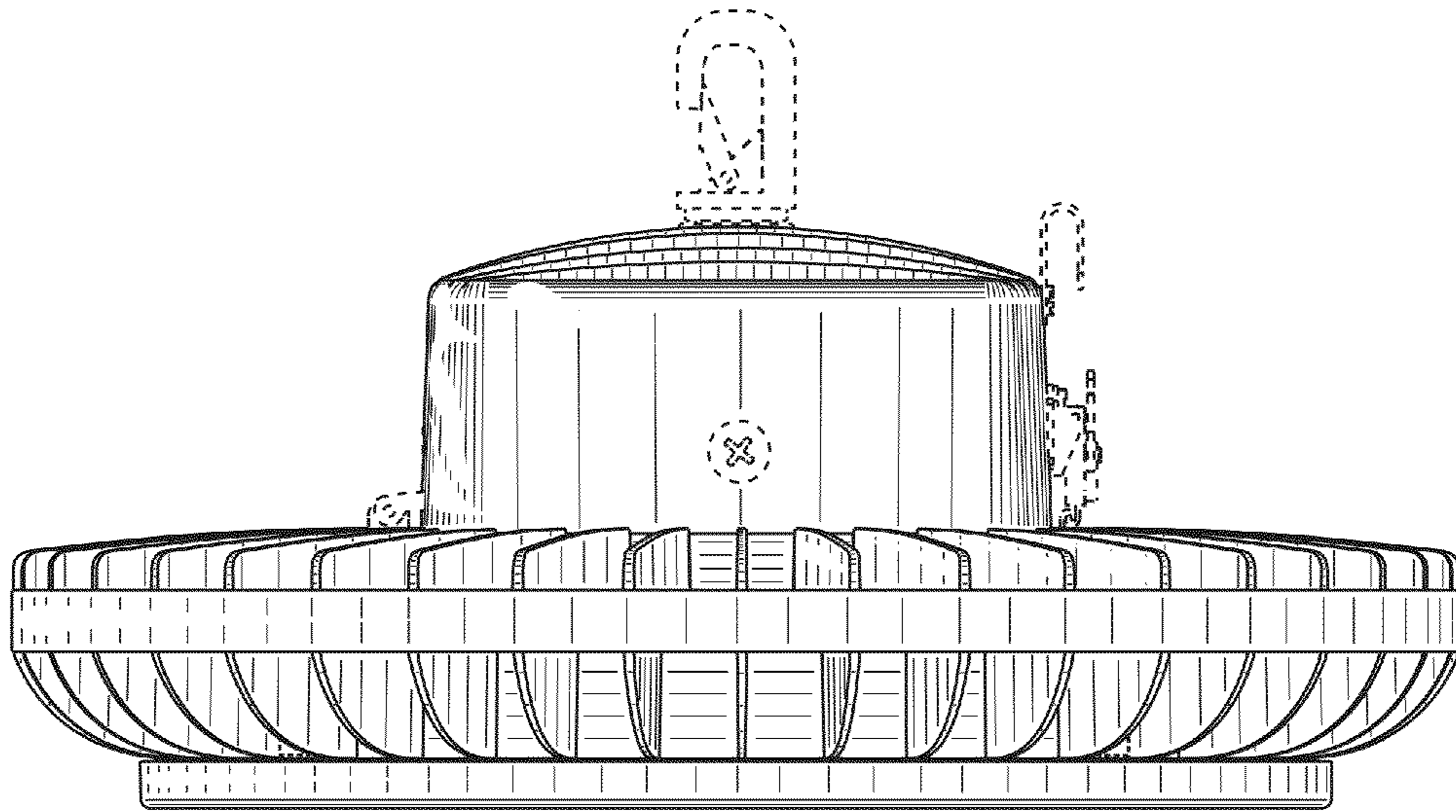

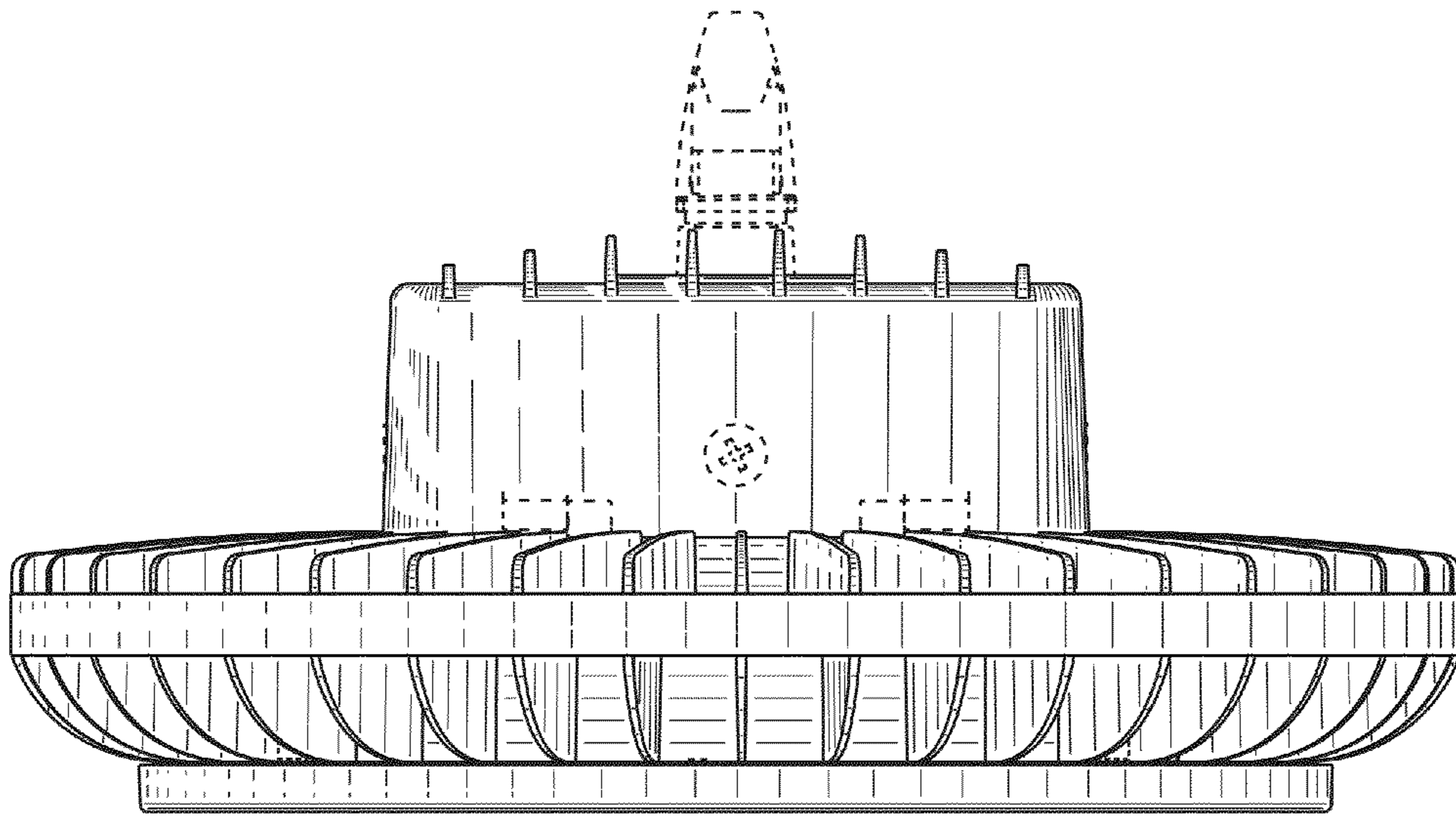
