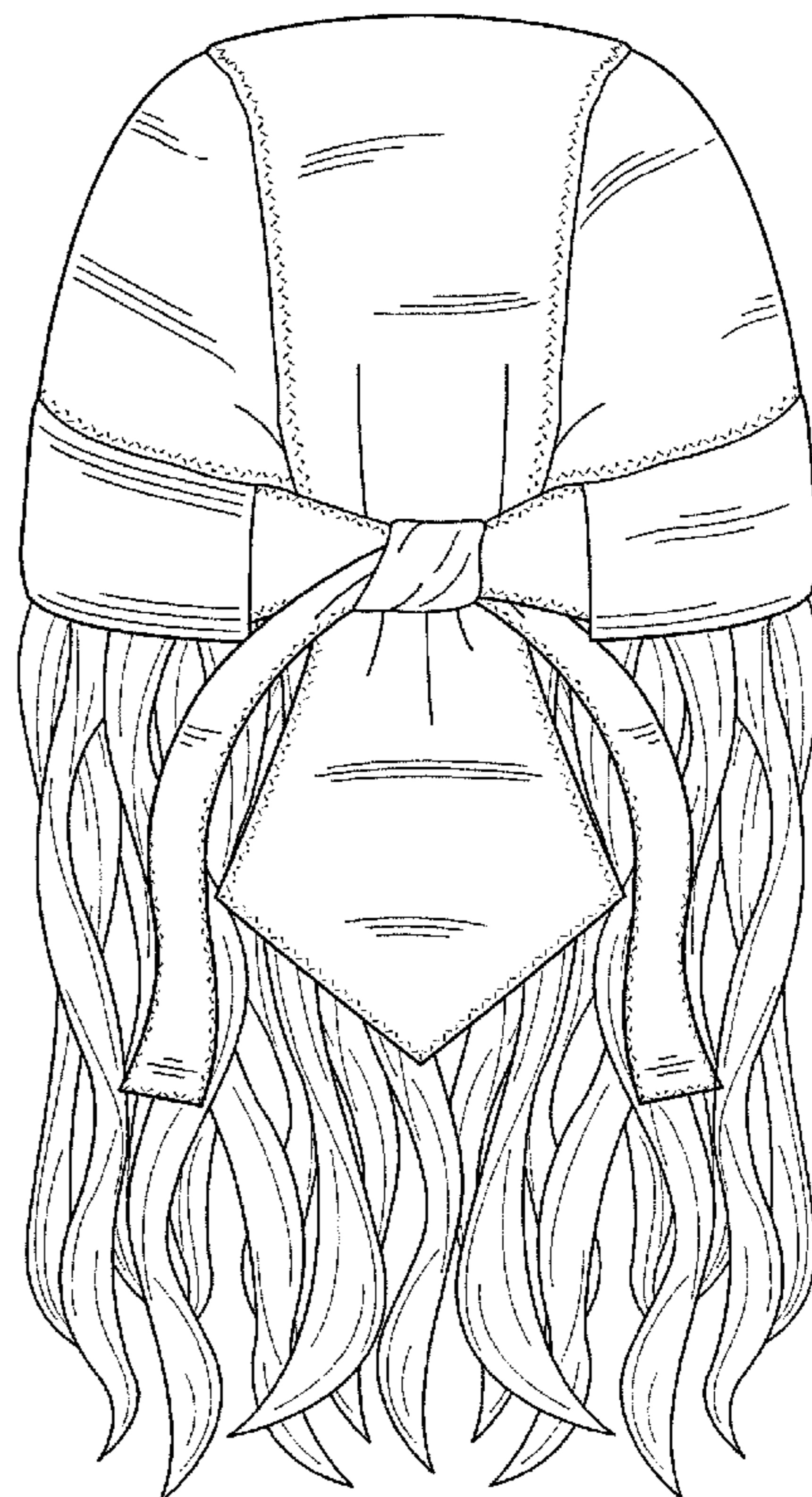
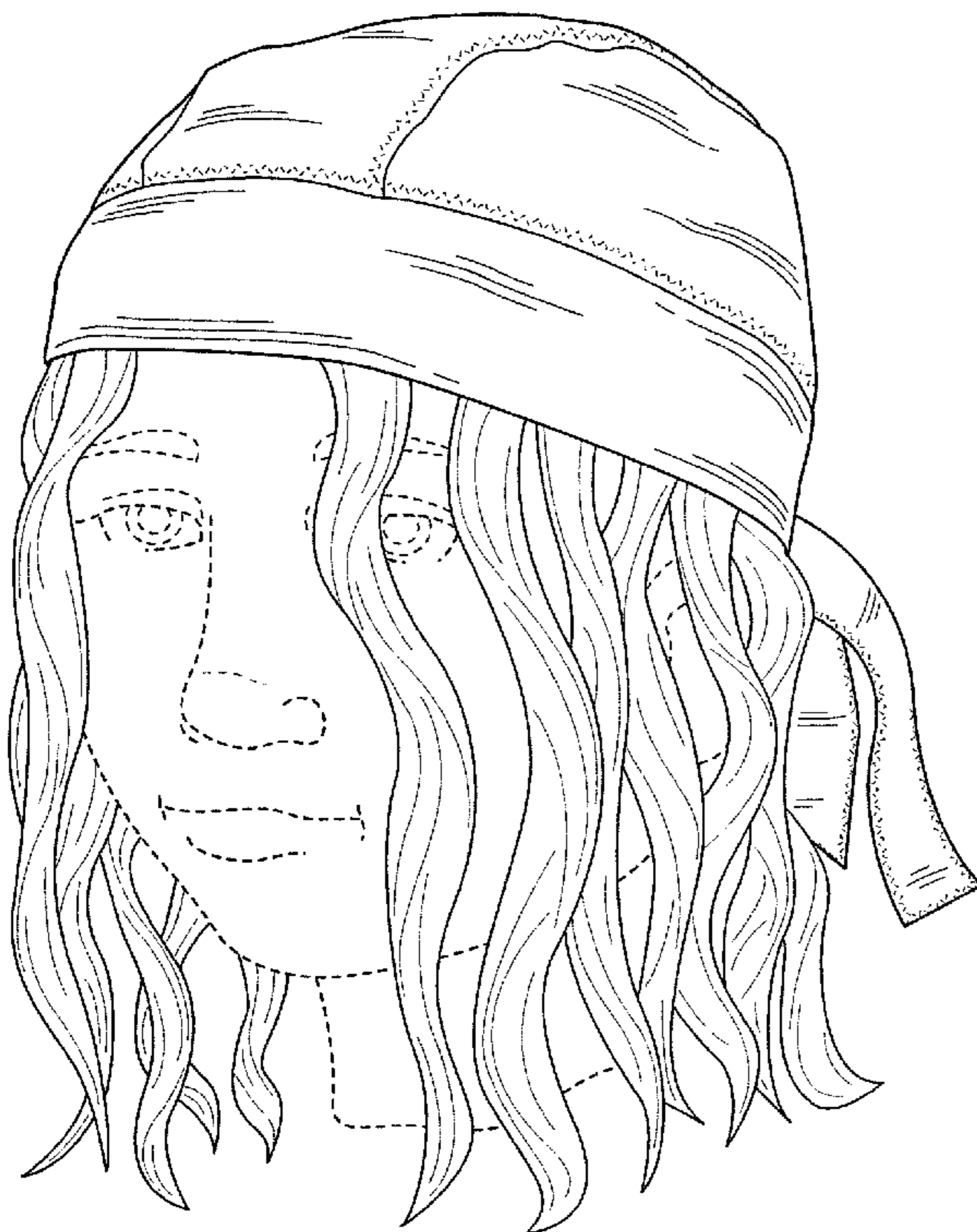
(57) **CLAIM**

The ornamental design for a wig, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the wig showing a head covering and wavy hair;  
FIG. 2 is a right side elevational view of the wig;  
FIG. 3 is a left side elevational view of the wig;  
FIG. 4 is a front elevational view of the wig;  
FIG. 5 is a rear elevational view of the wig;  
FIG. 6 is a bottom plan view of the wig with an inner band of the wig shown in an expanded condition;  
FIG. 7 is a top plan view of the wig;  
FIG. 8 is a perspective view of the wig; and,  
FIG. 9 is a bottom plan view of the wig with an inner band of the wig shown in a contracted condition.  
The broken lines in the drawings show environmental structure that form no part of the design to be patented.

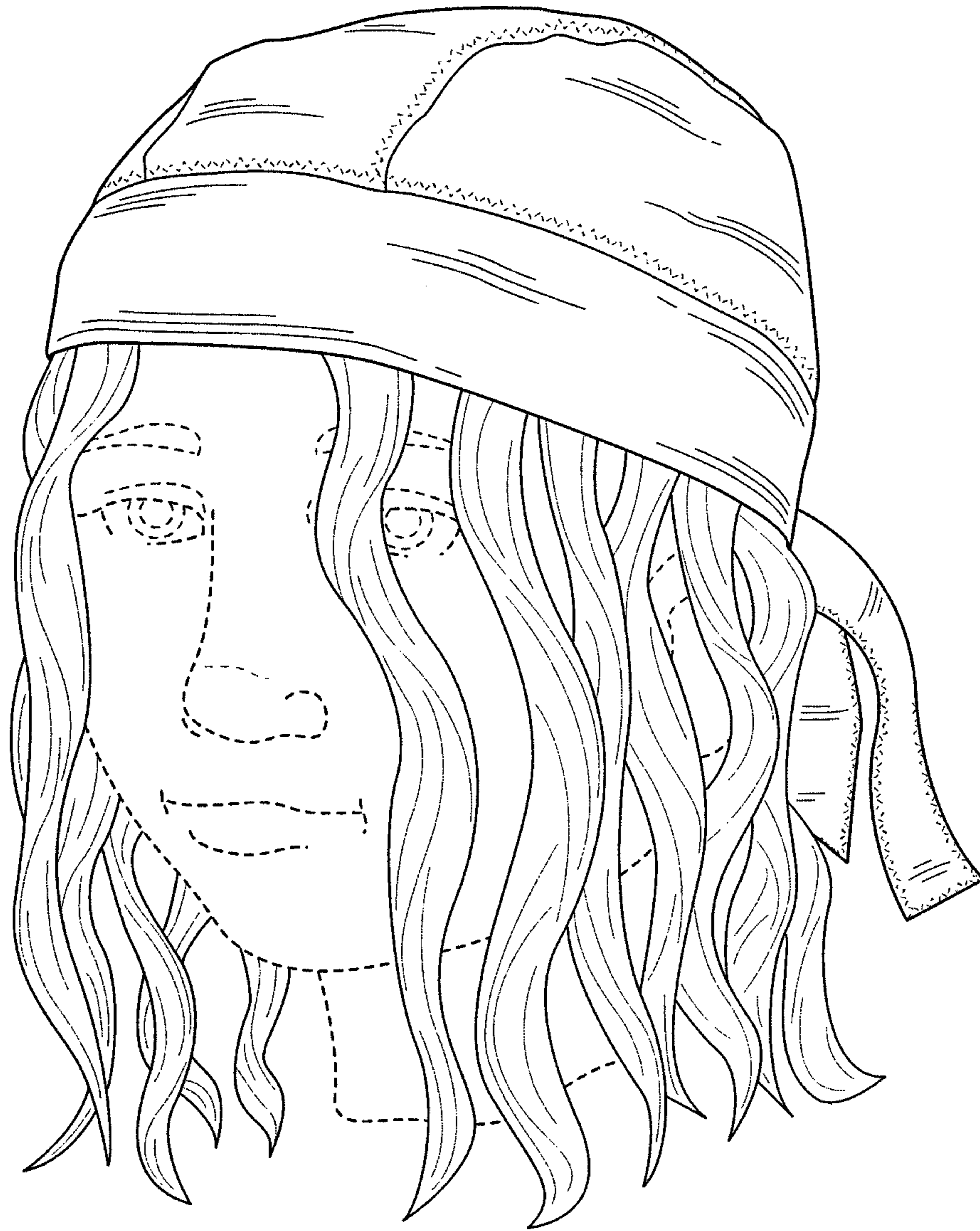

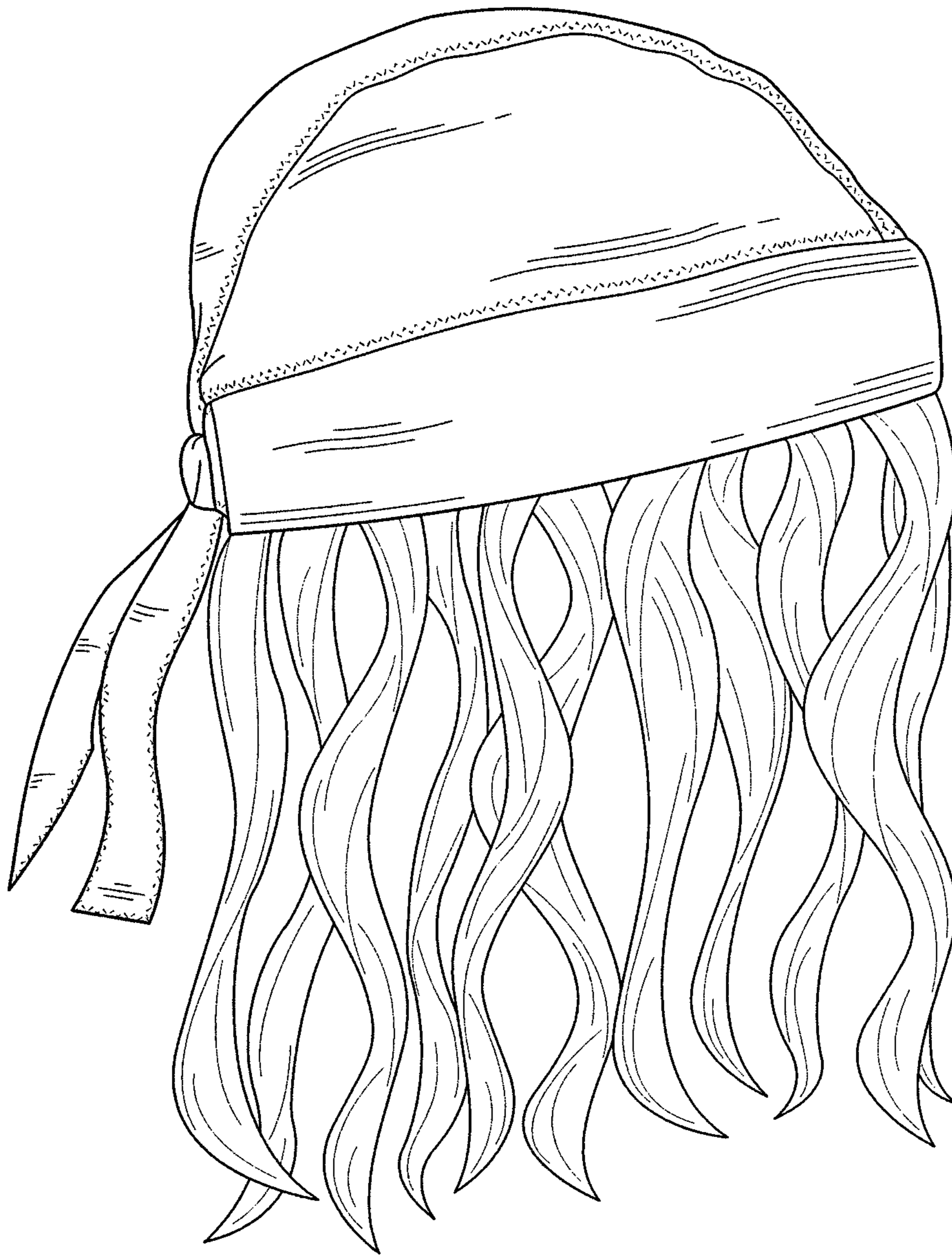

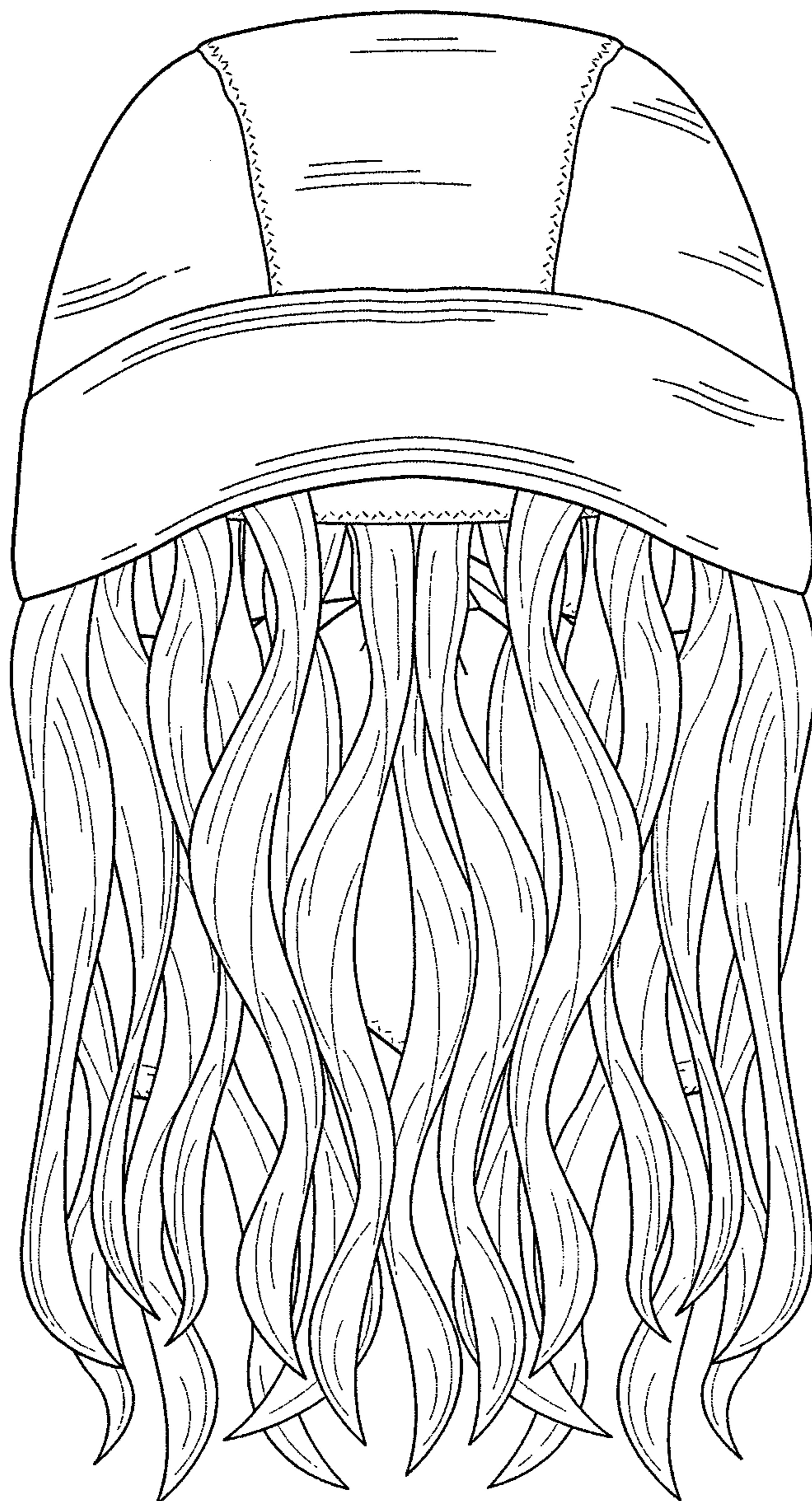

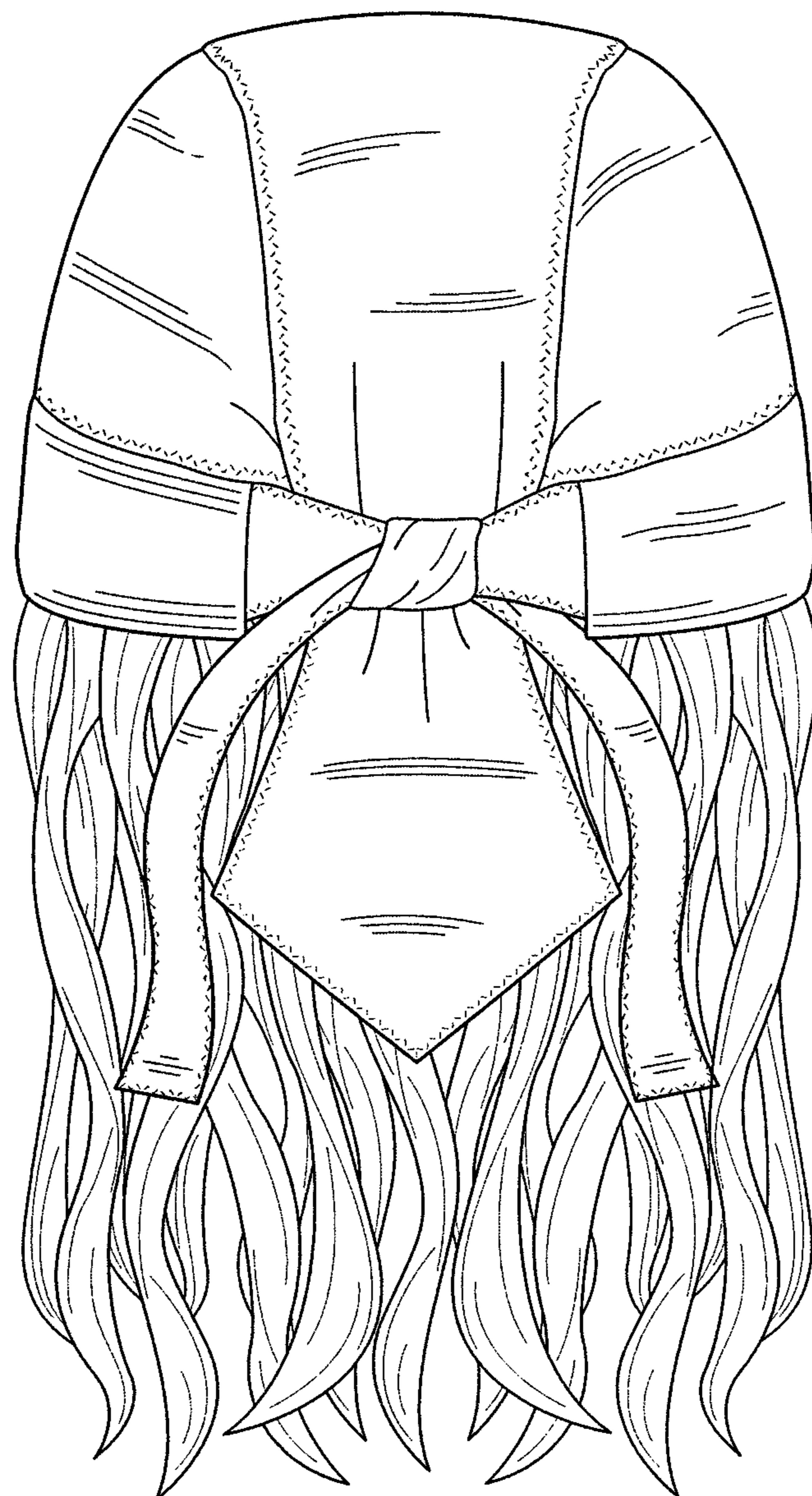

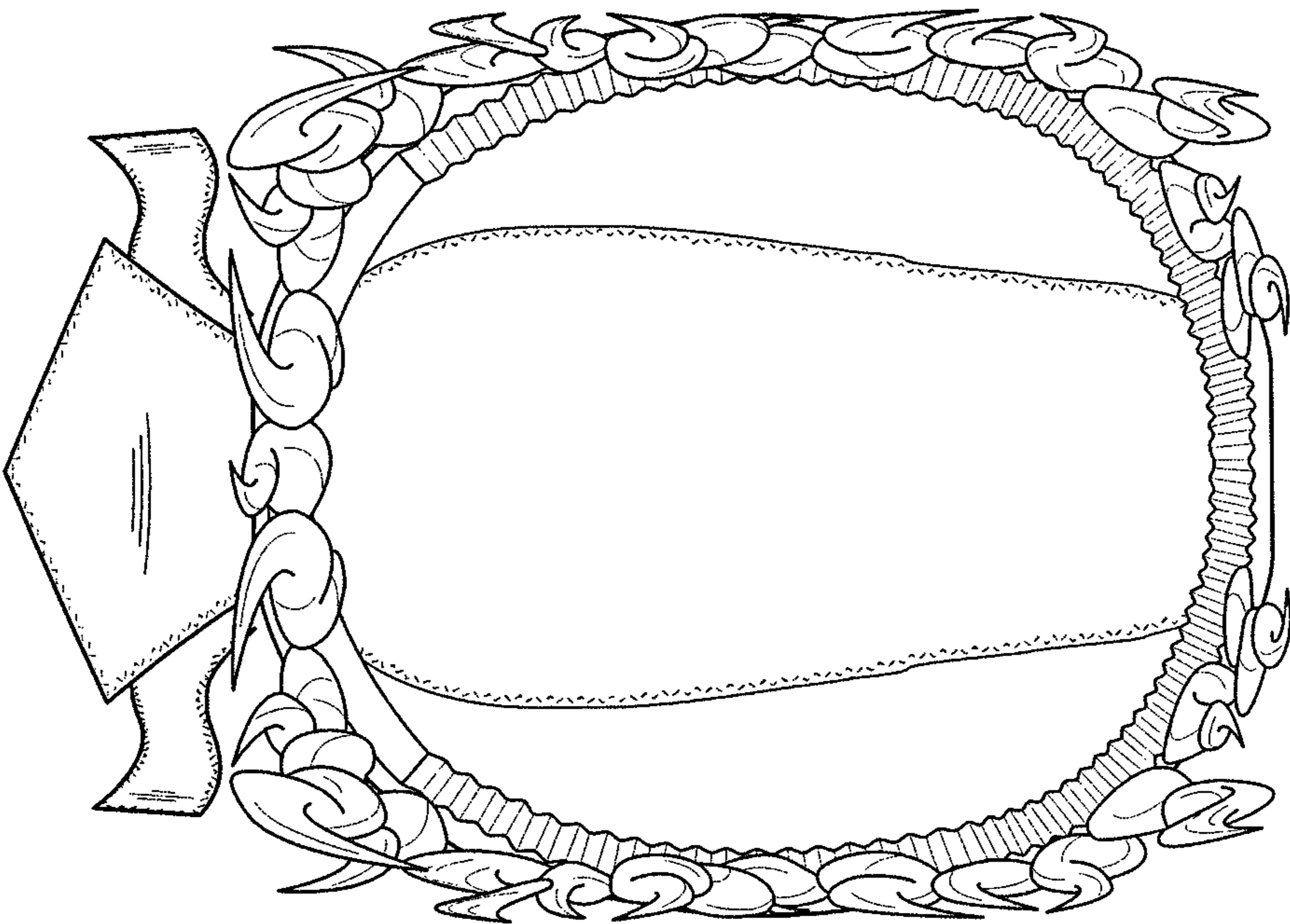

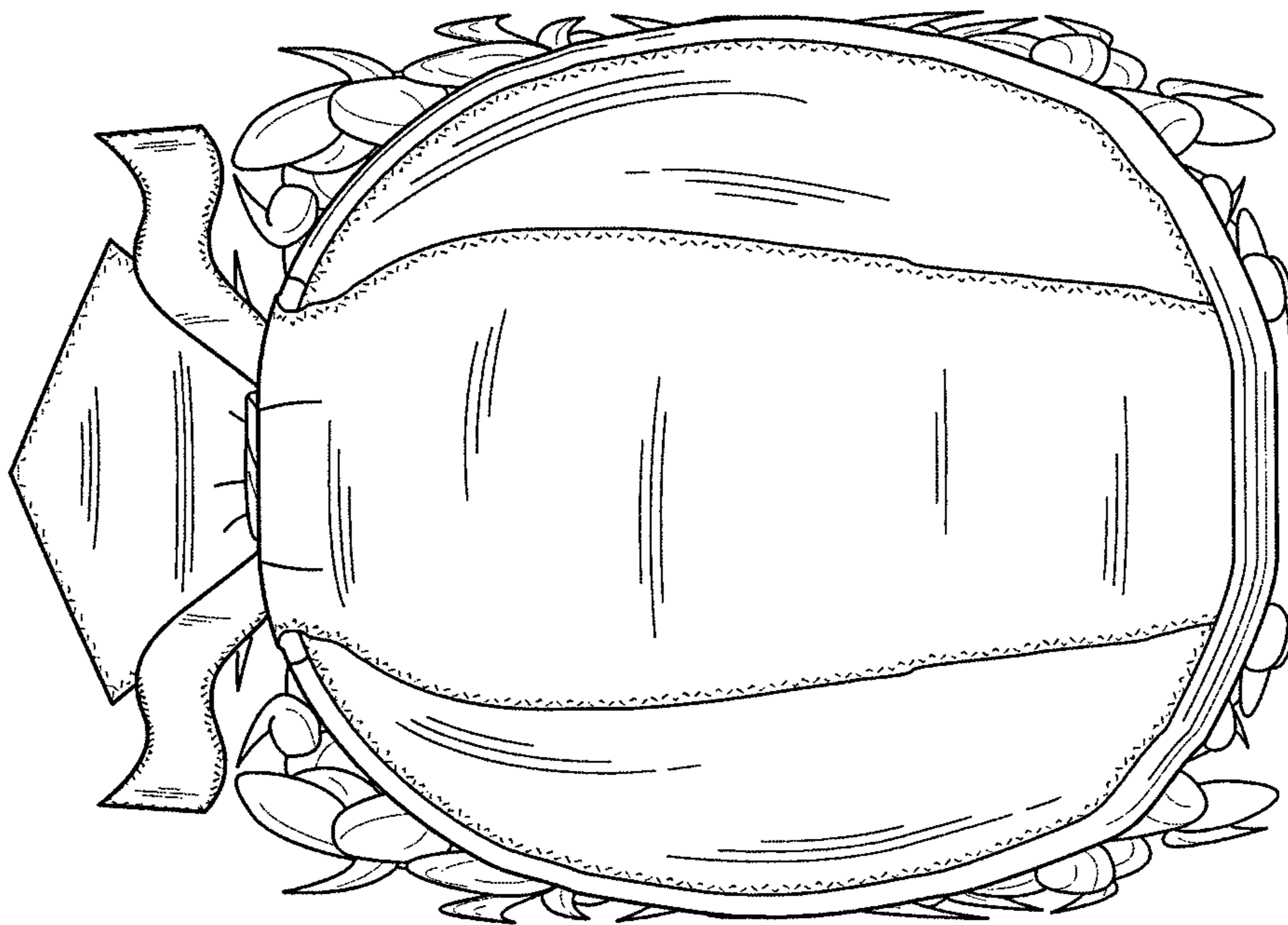

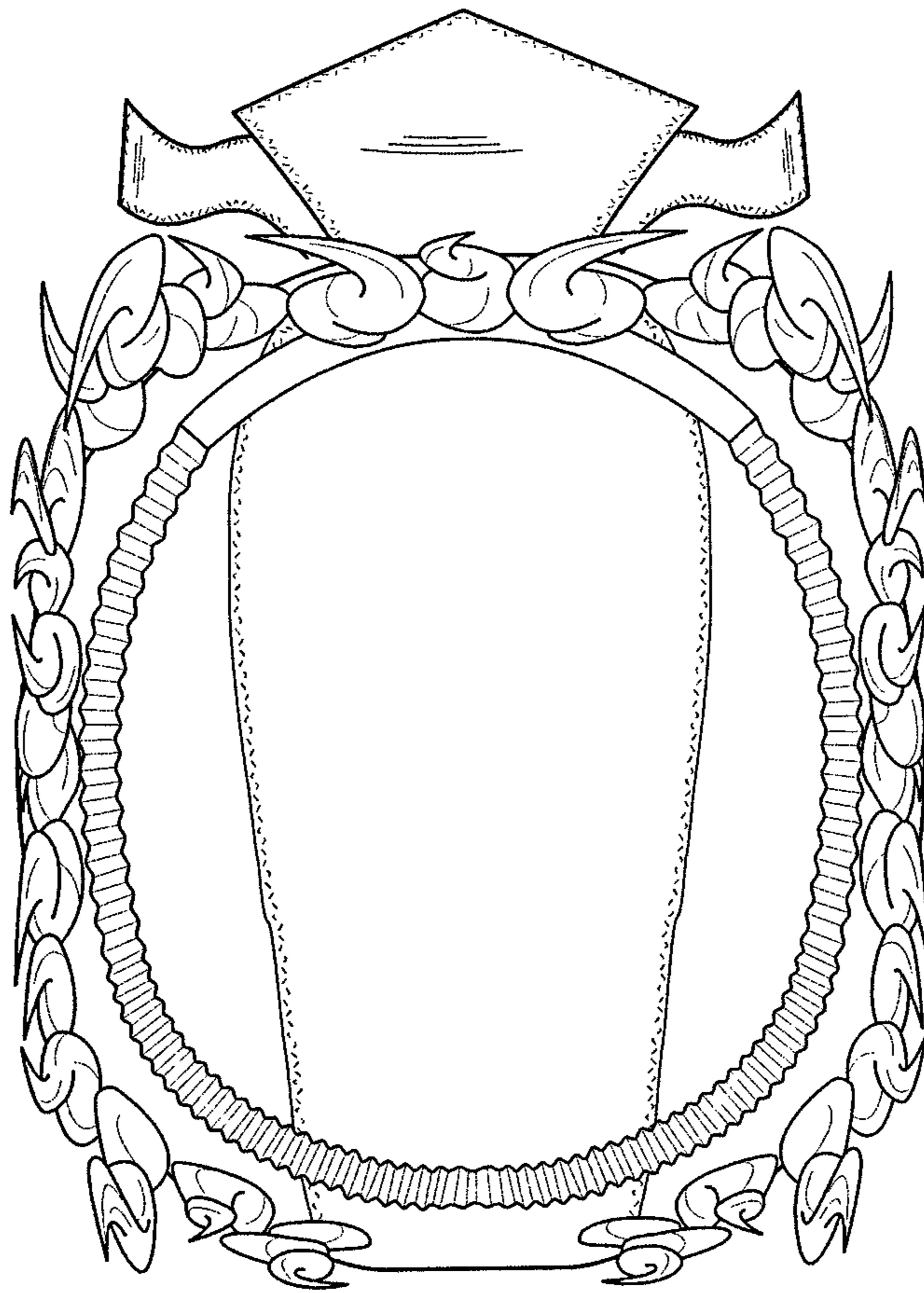
