**DESCRIPTION**

FIG. 27 is a rear elevational view thereof.

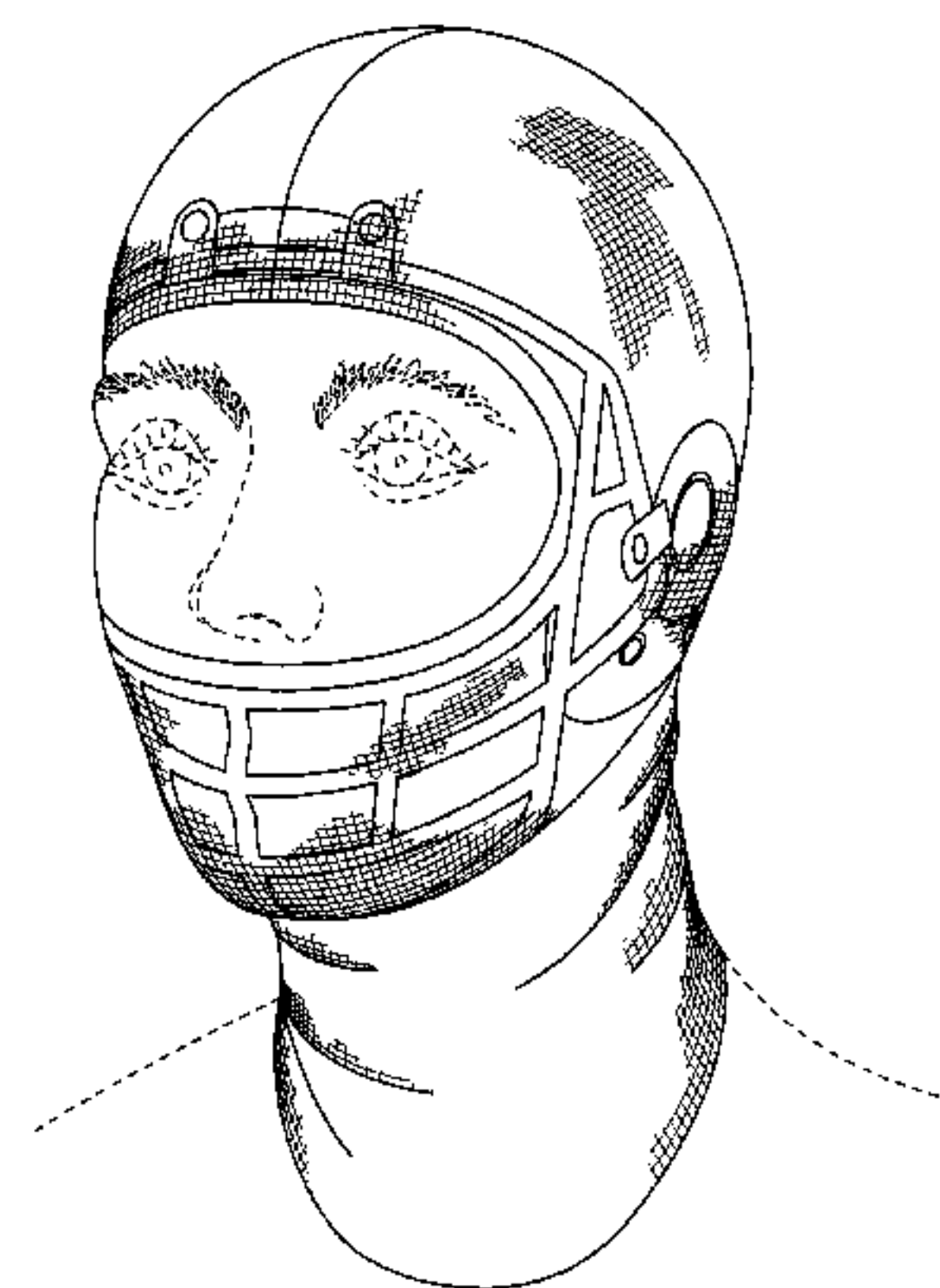
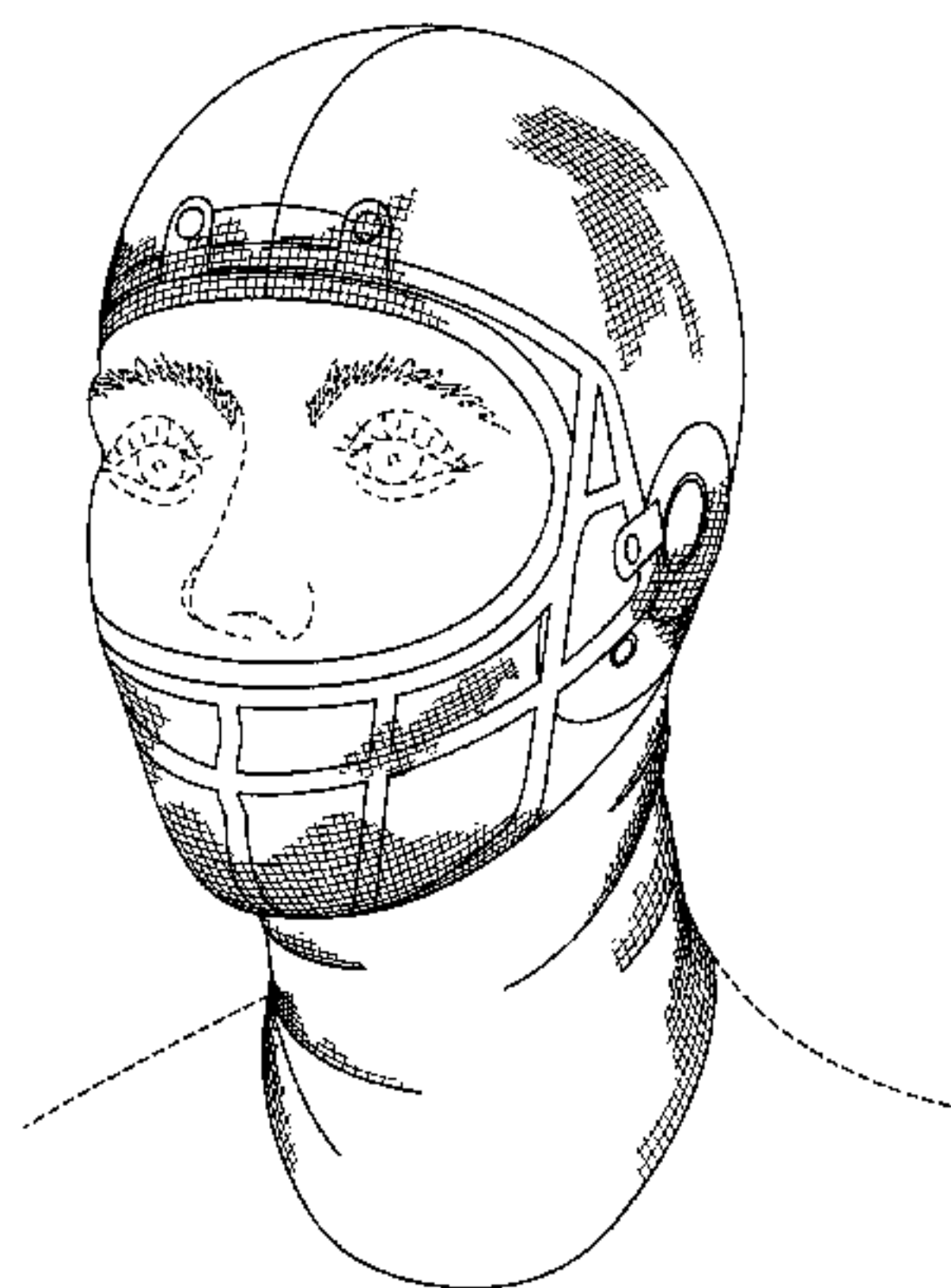
FIG. 28 is a side elevational view thereof.

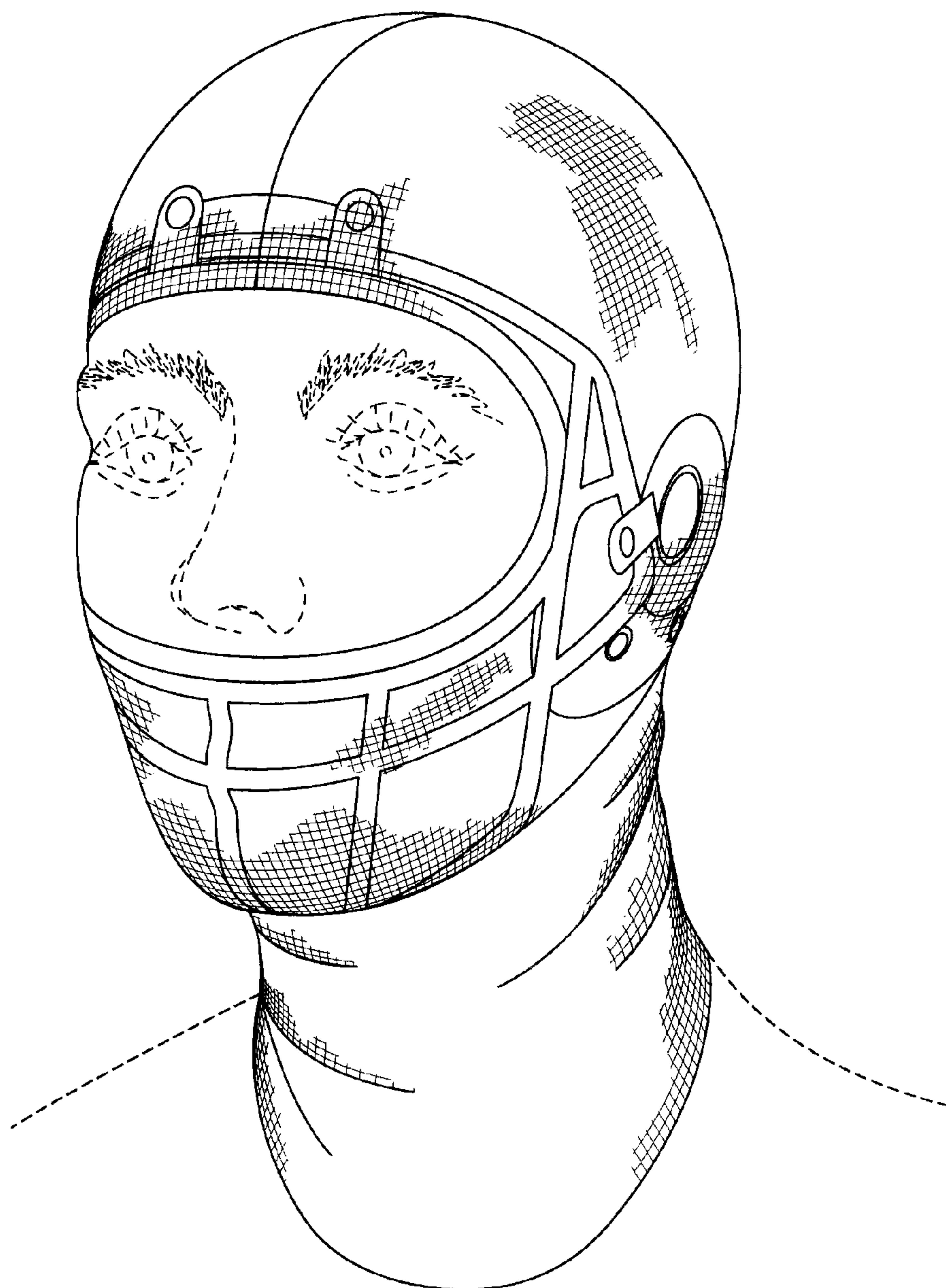

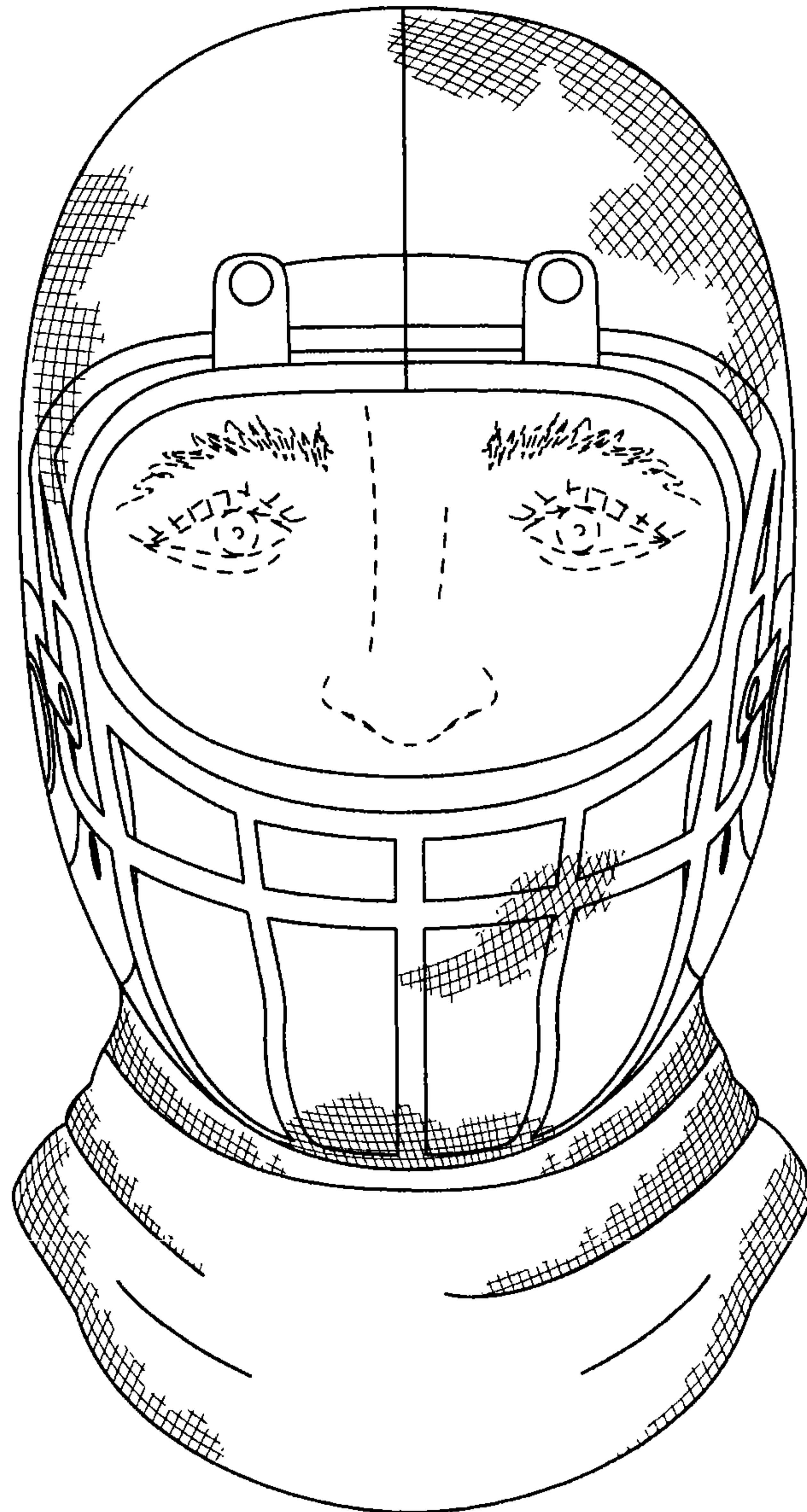

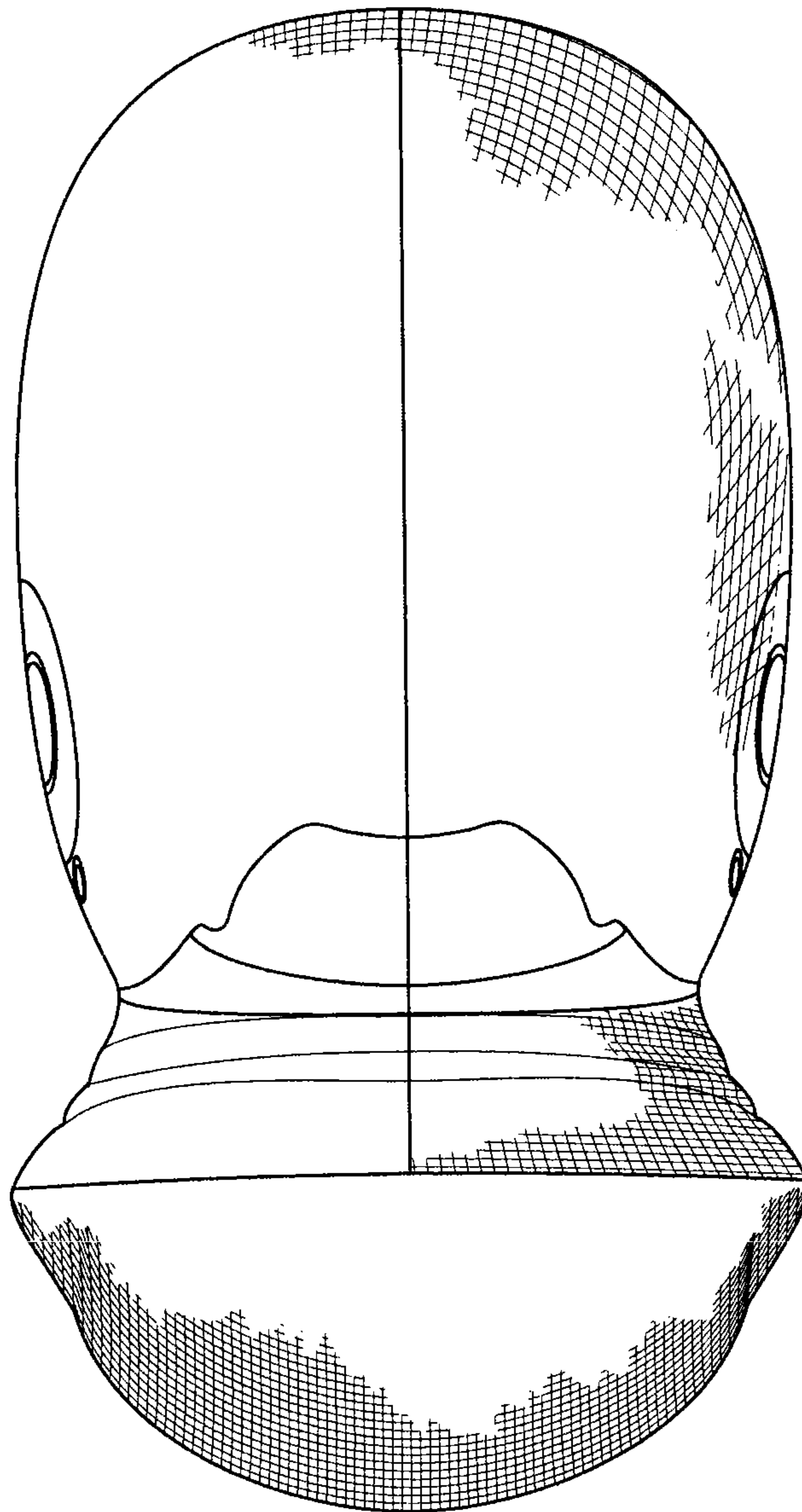

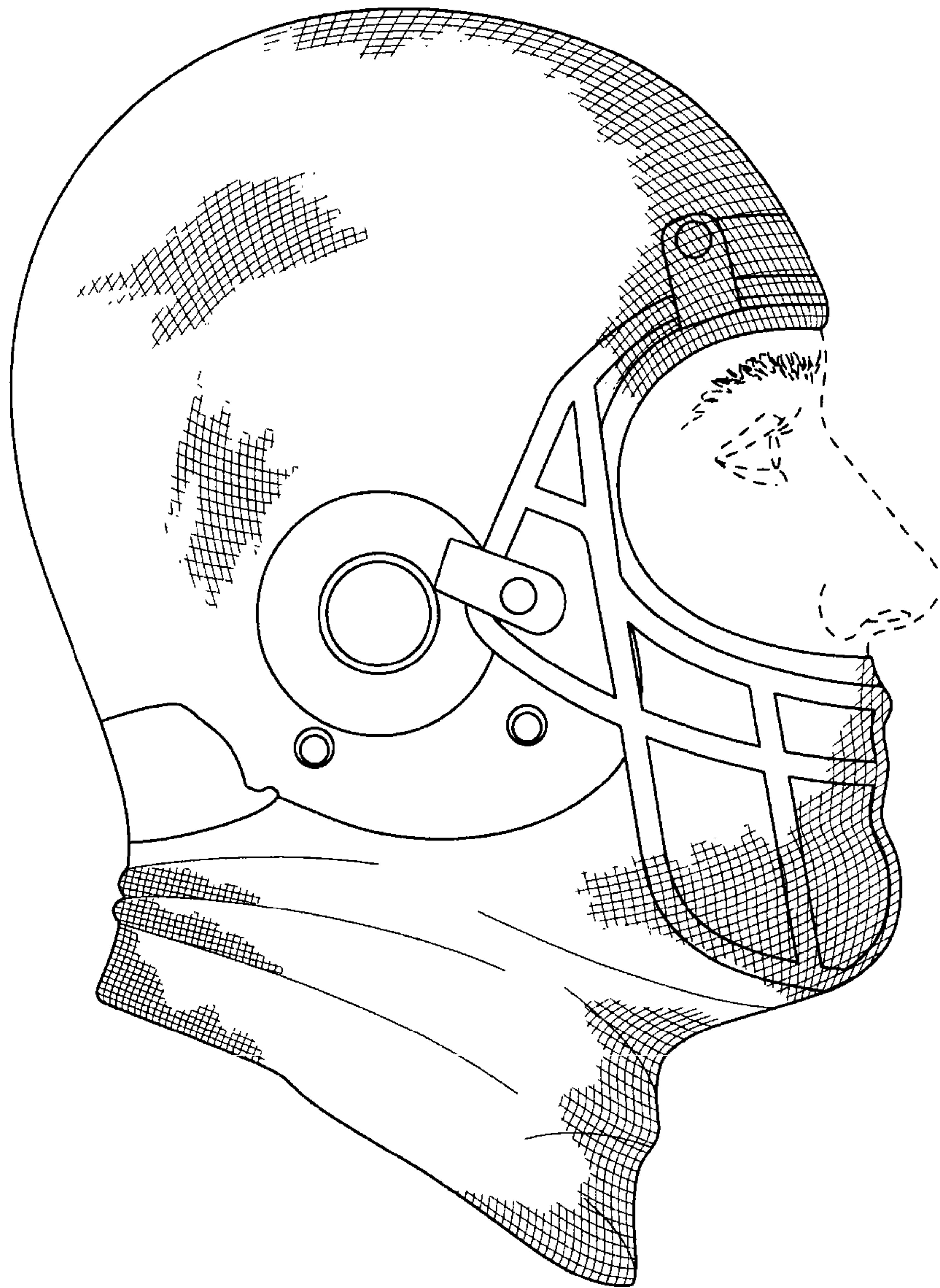

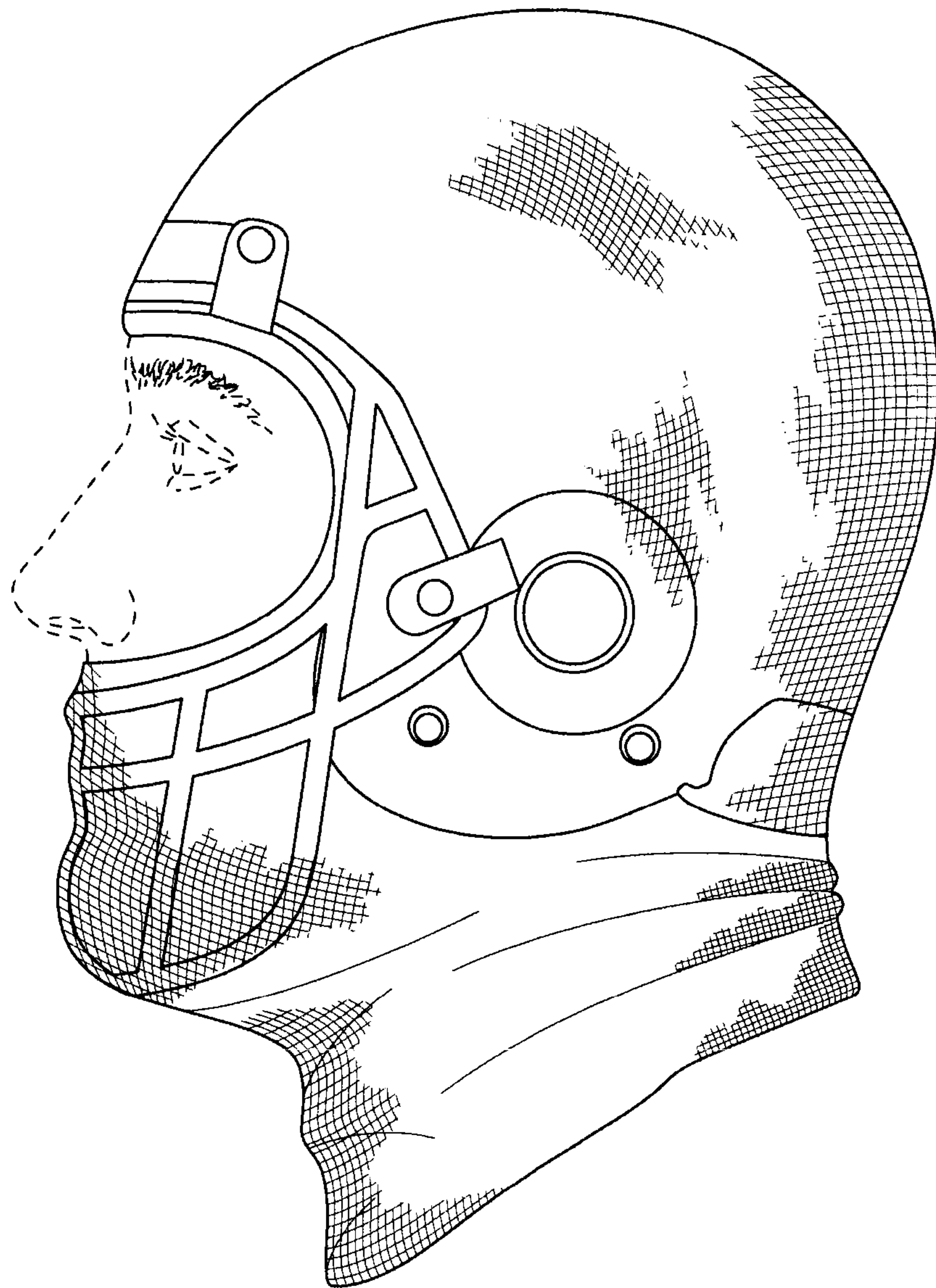

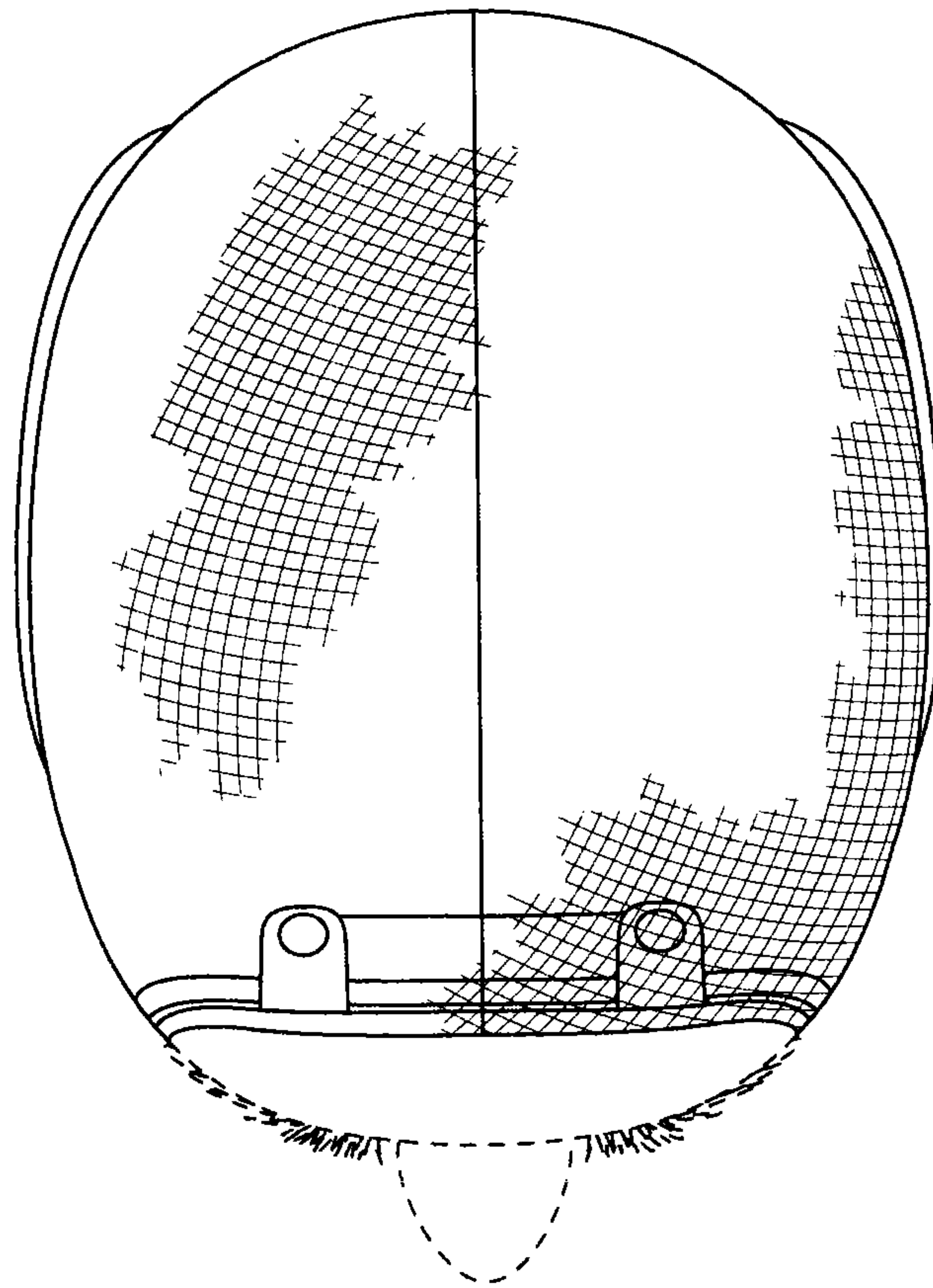

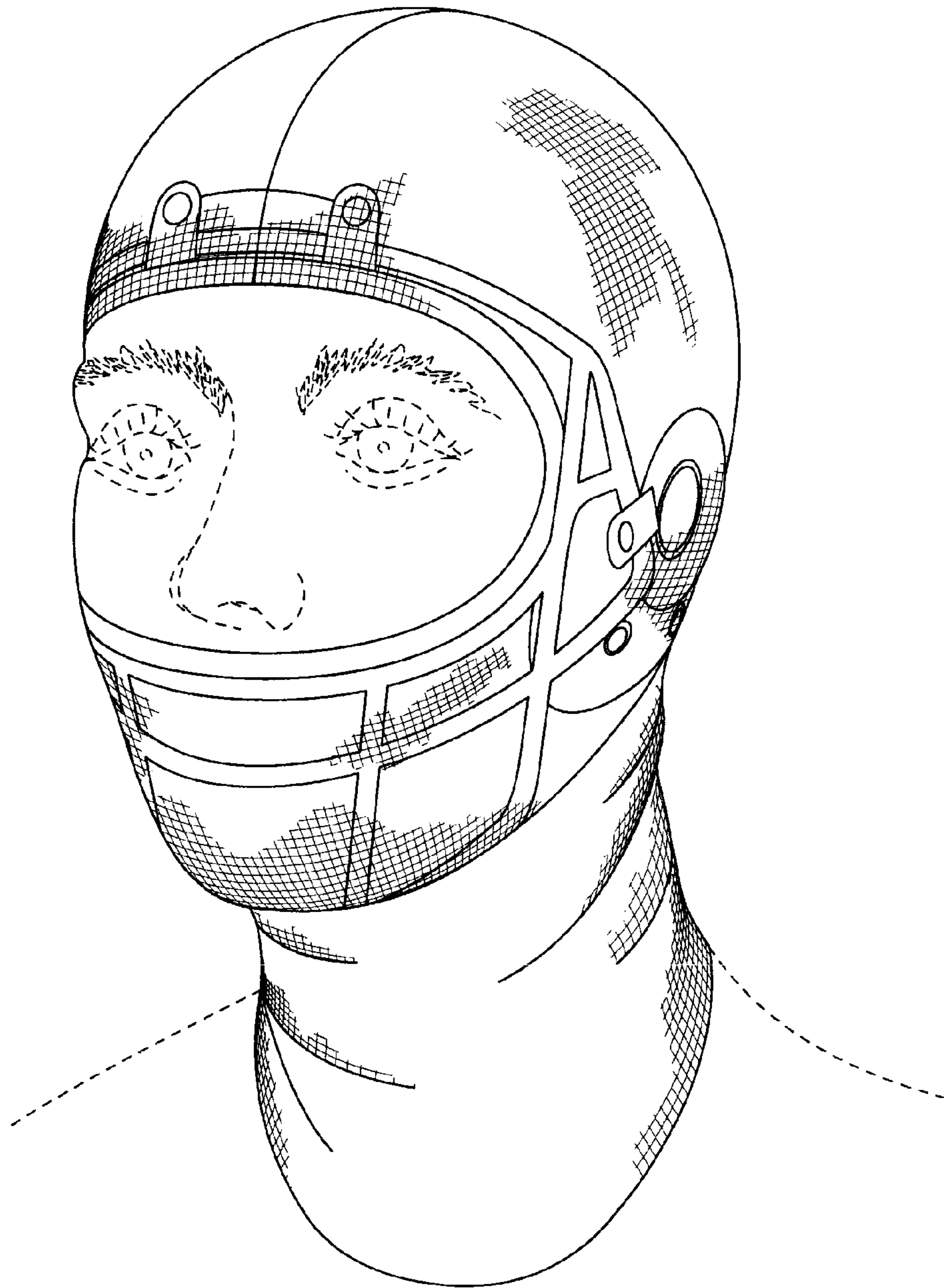

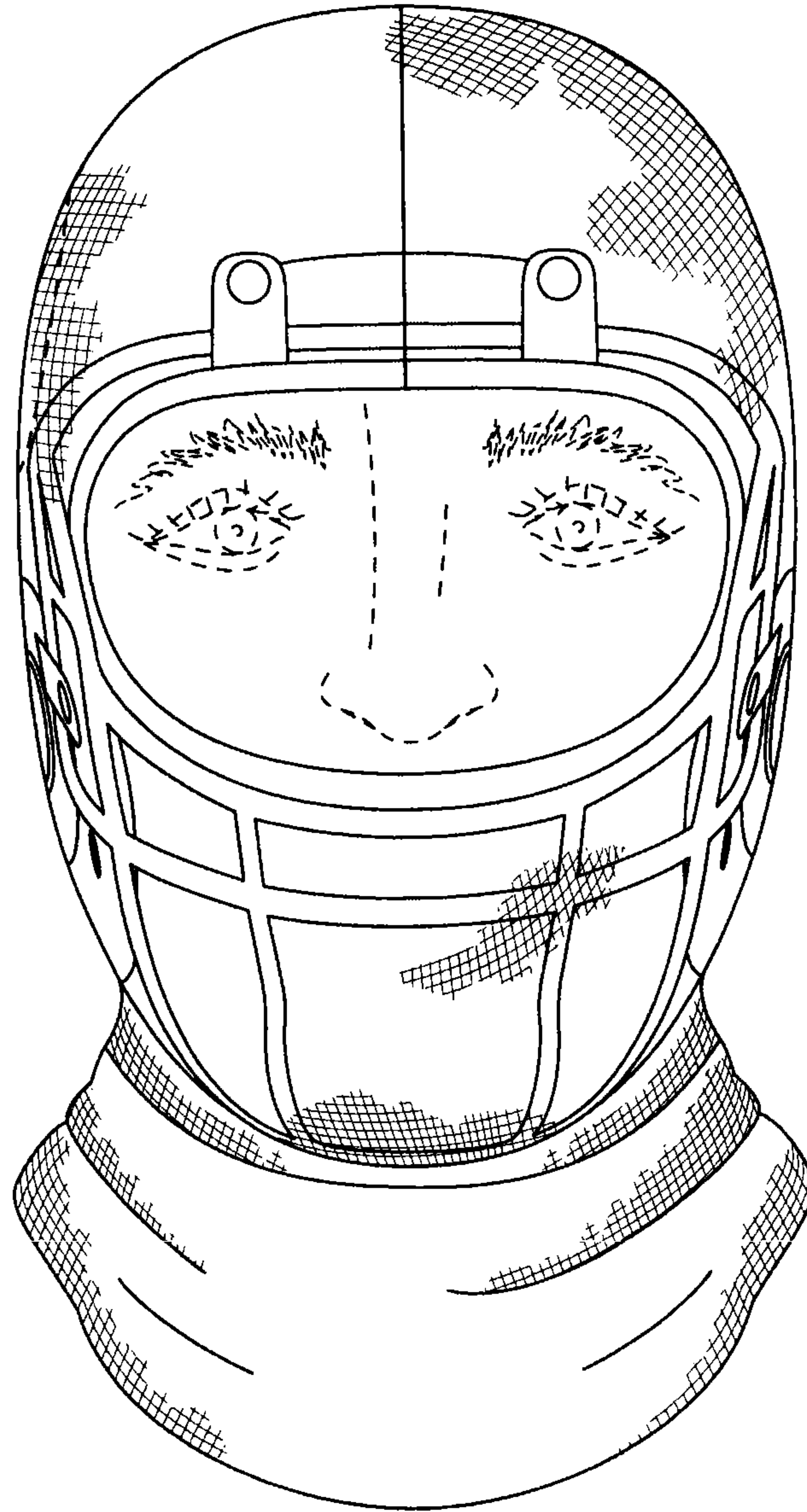

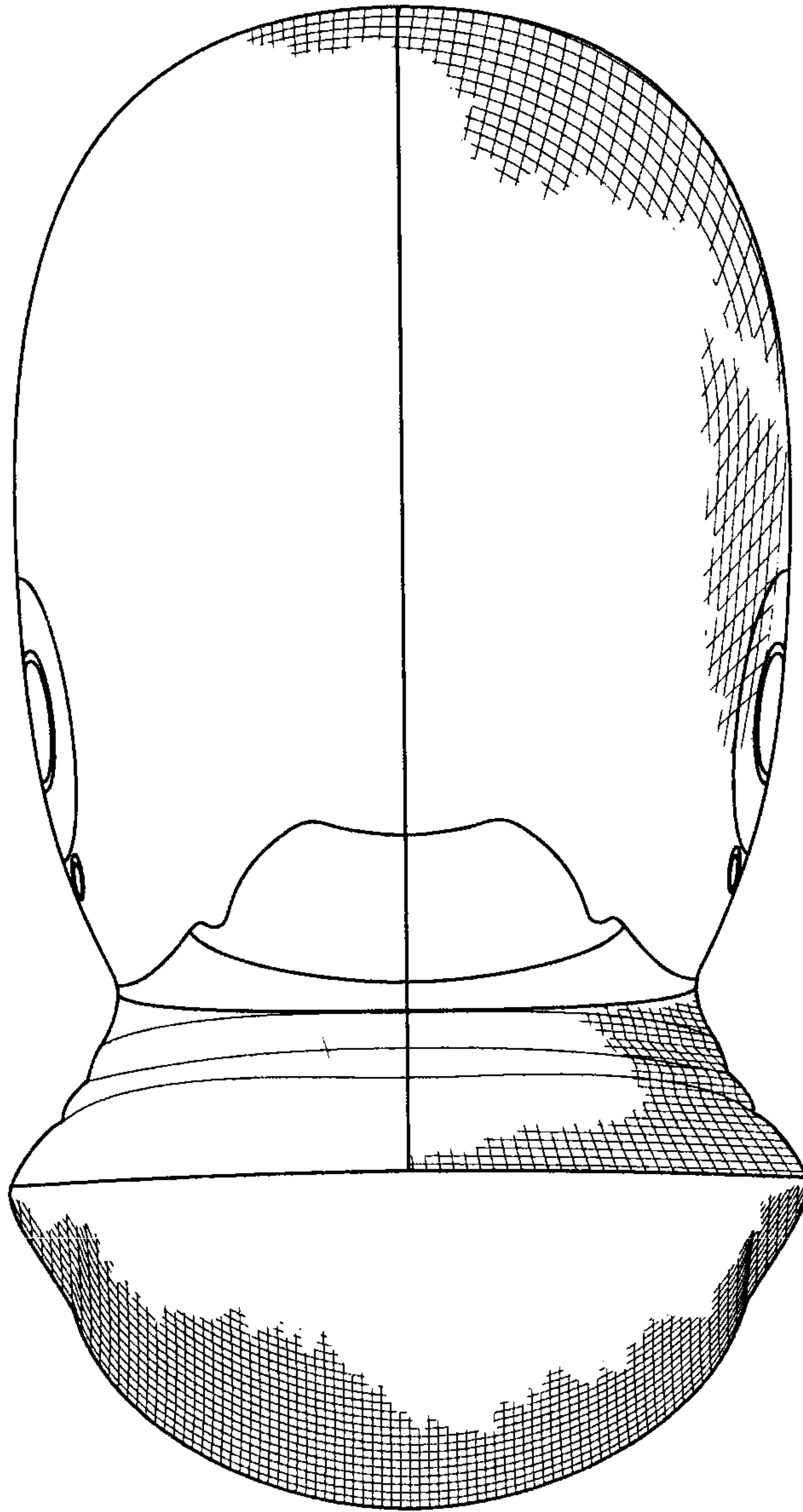

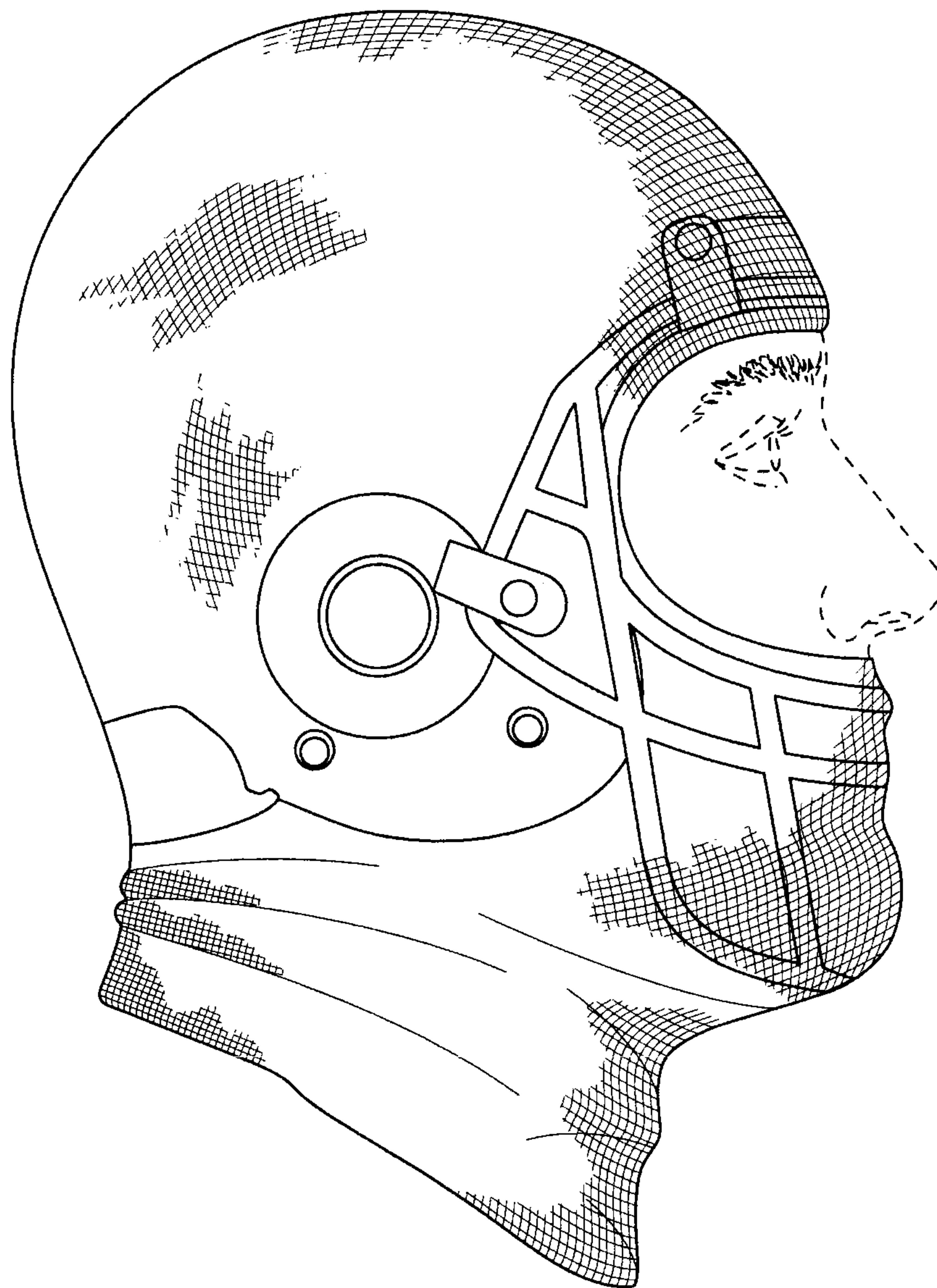

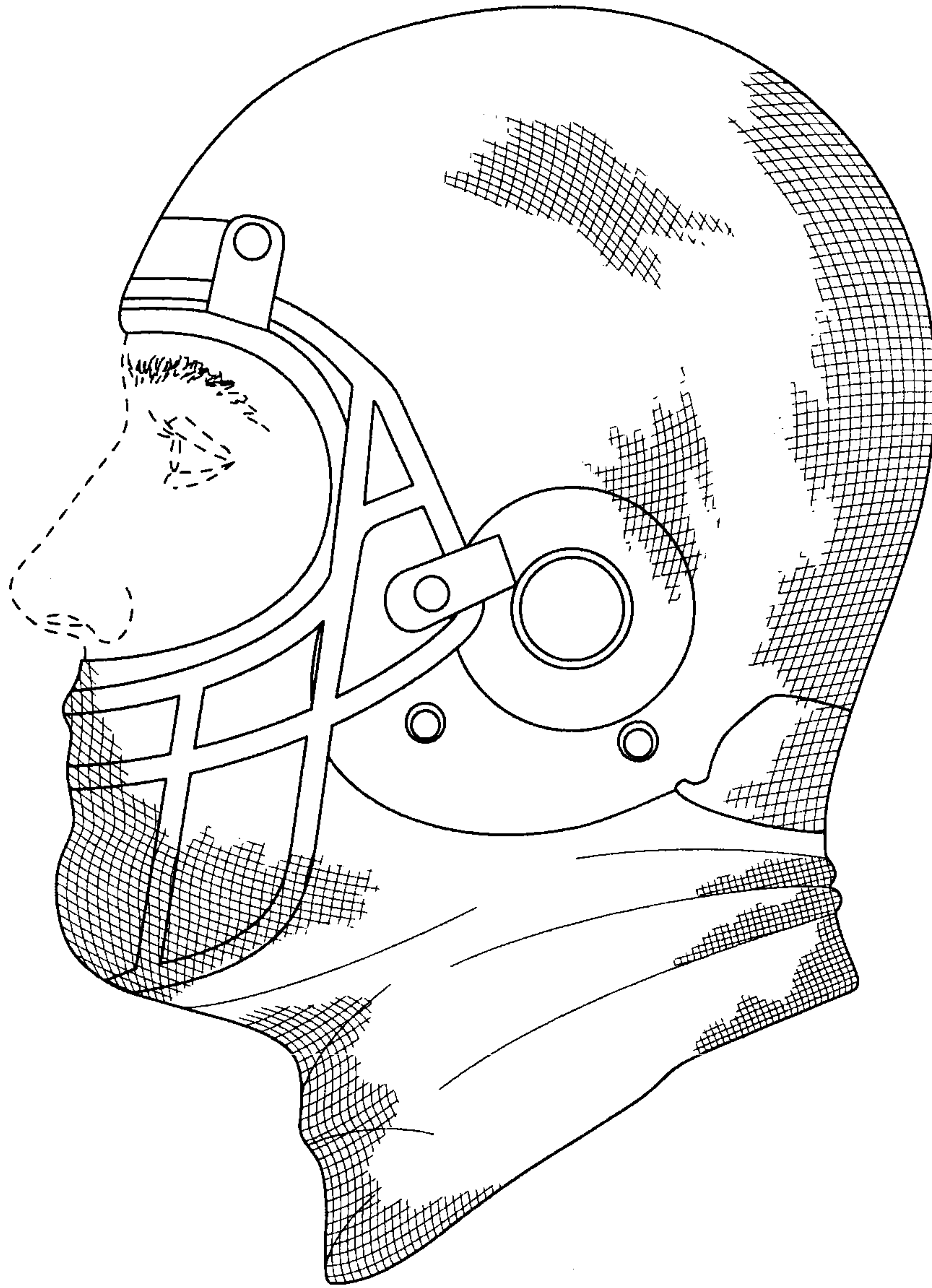

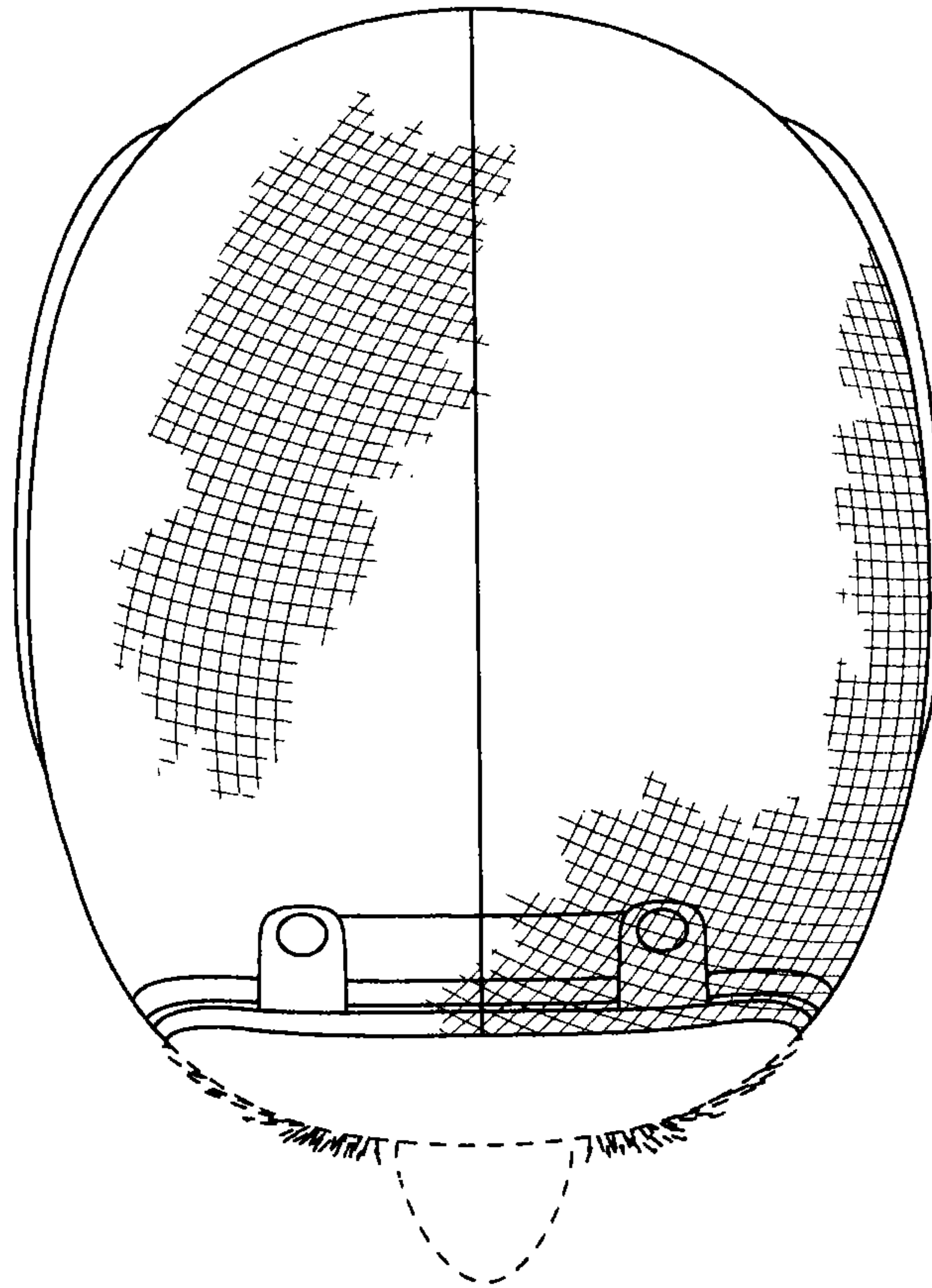

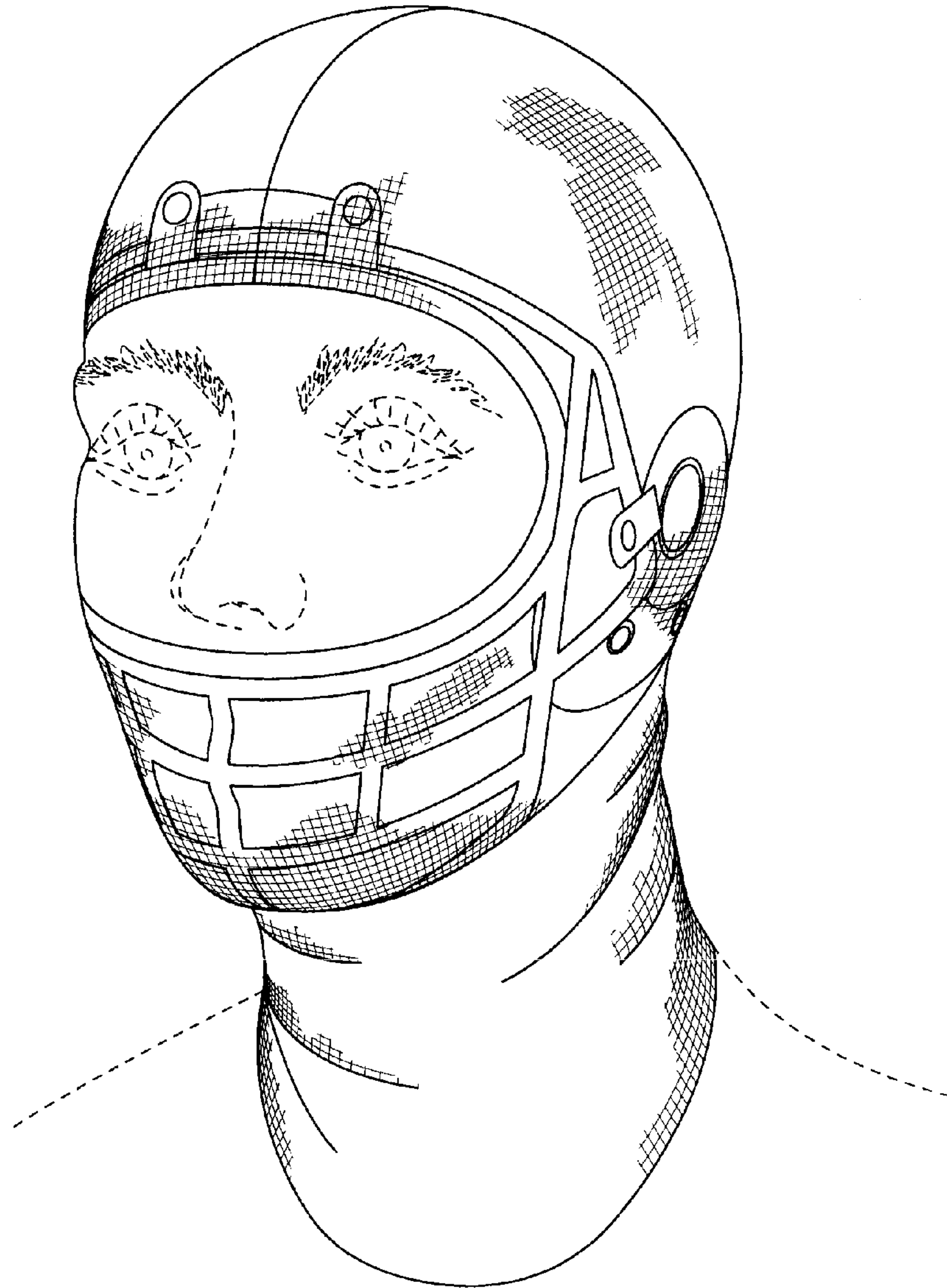

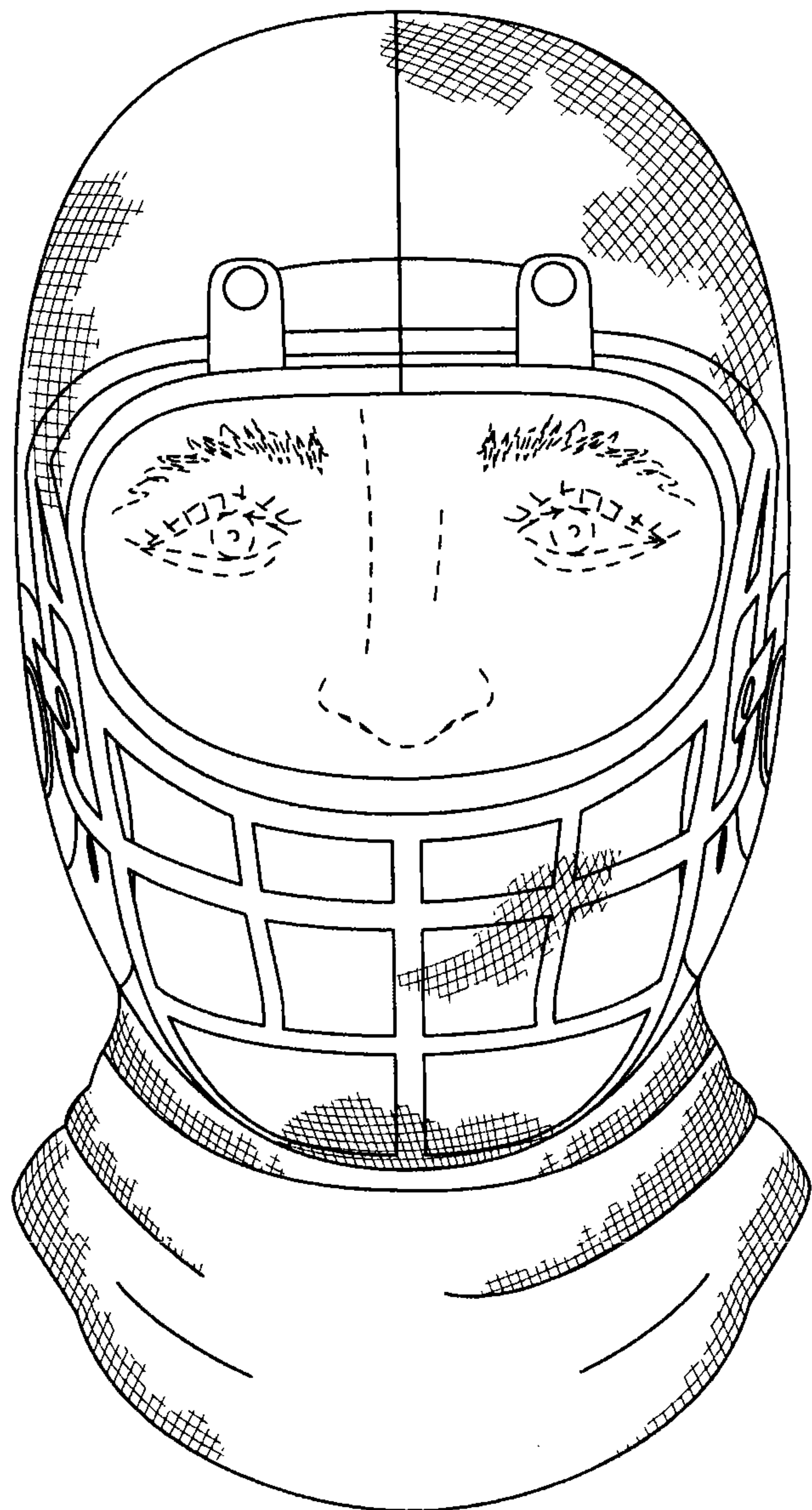

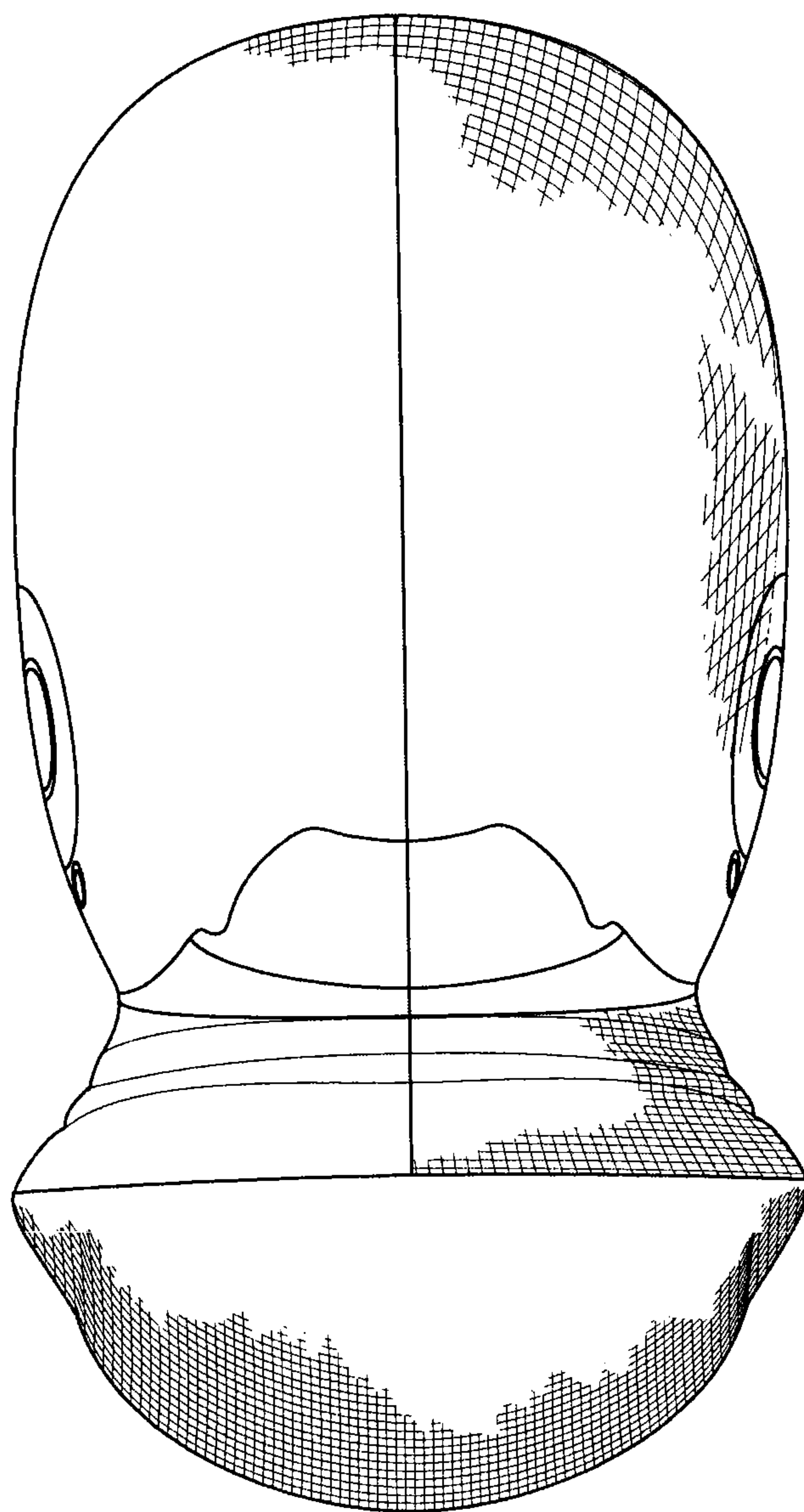

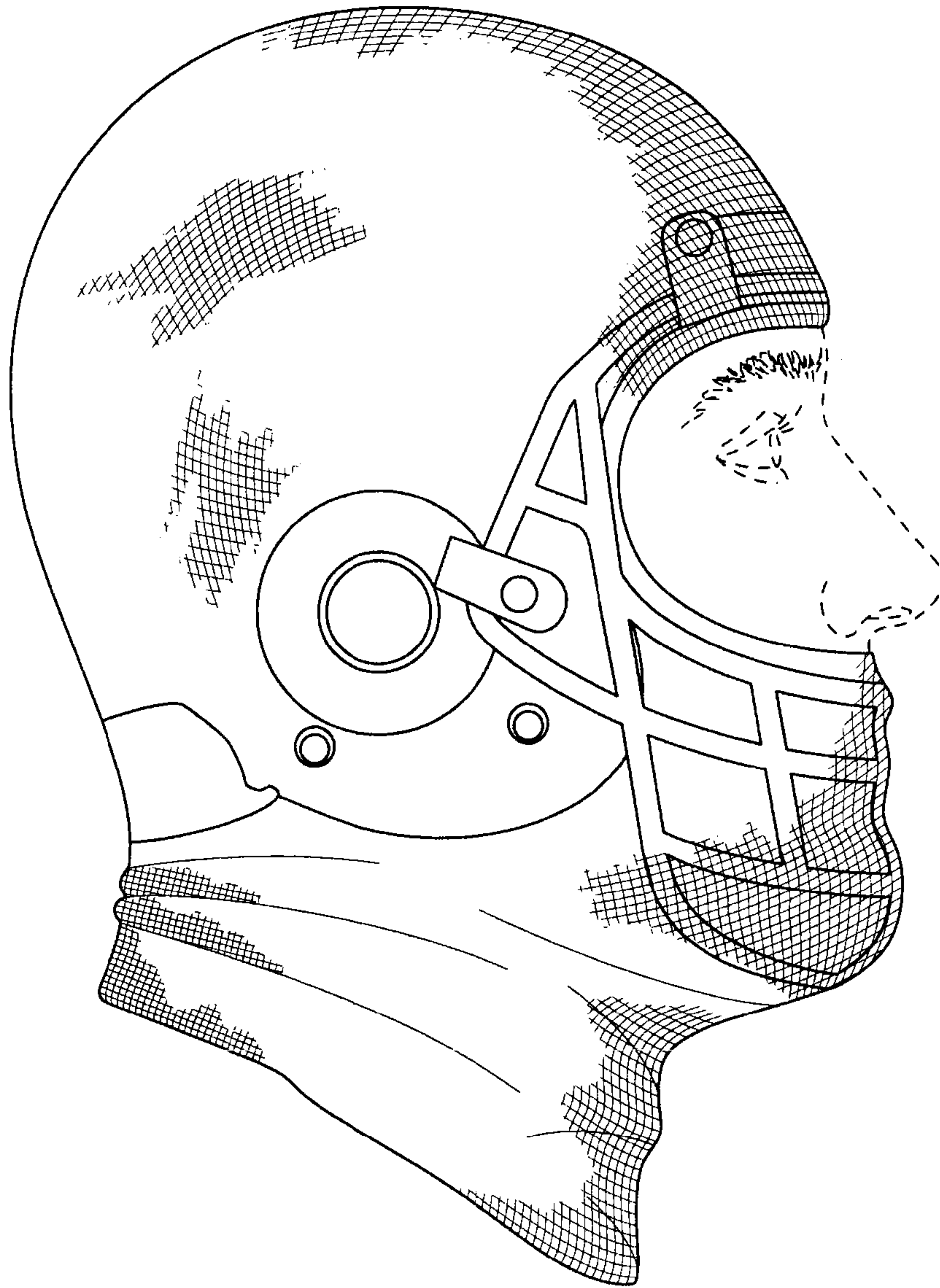

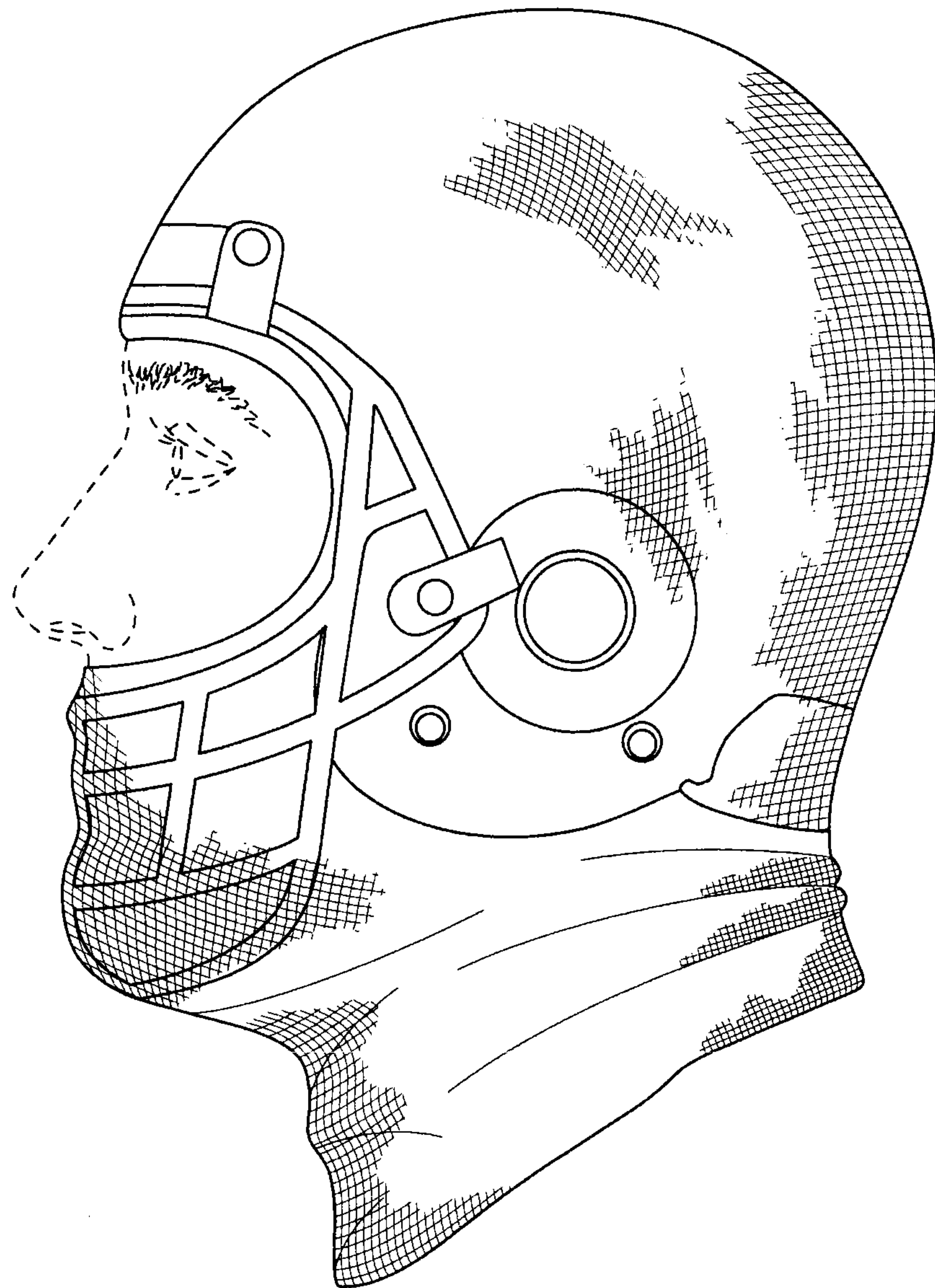

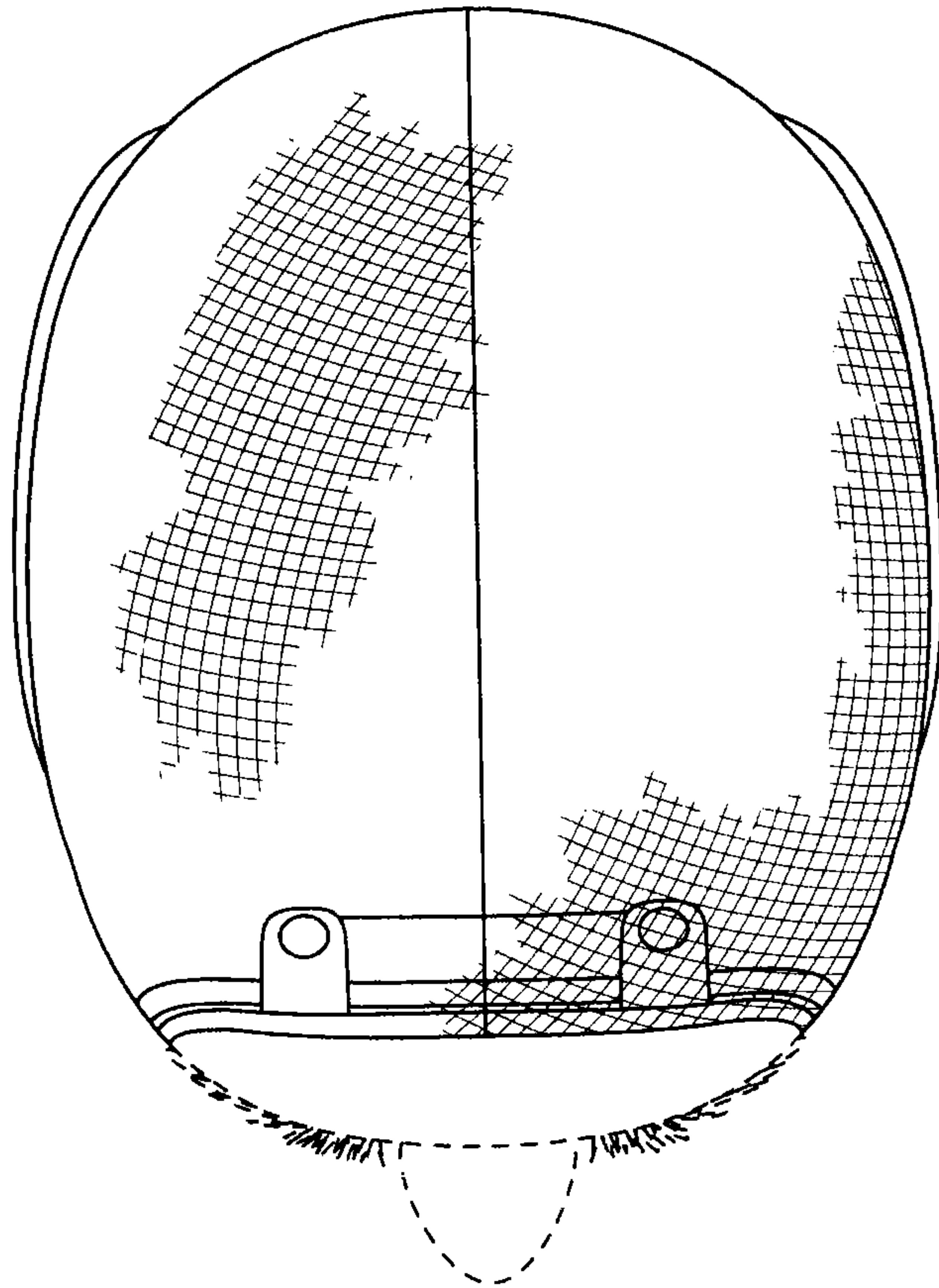

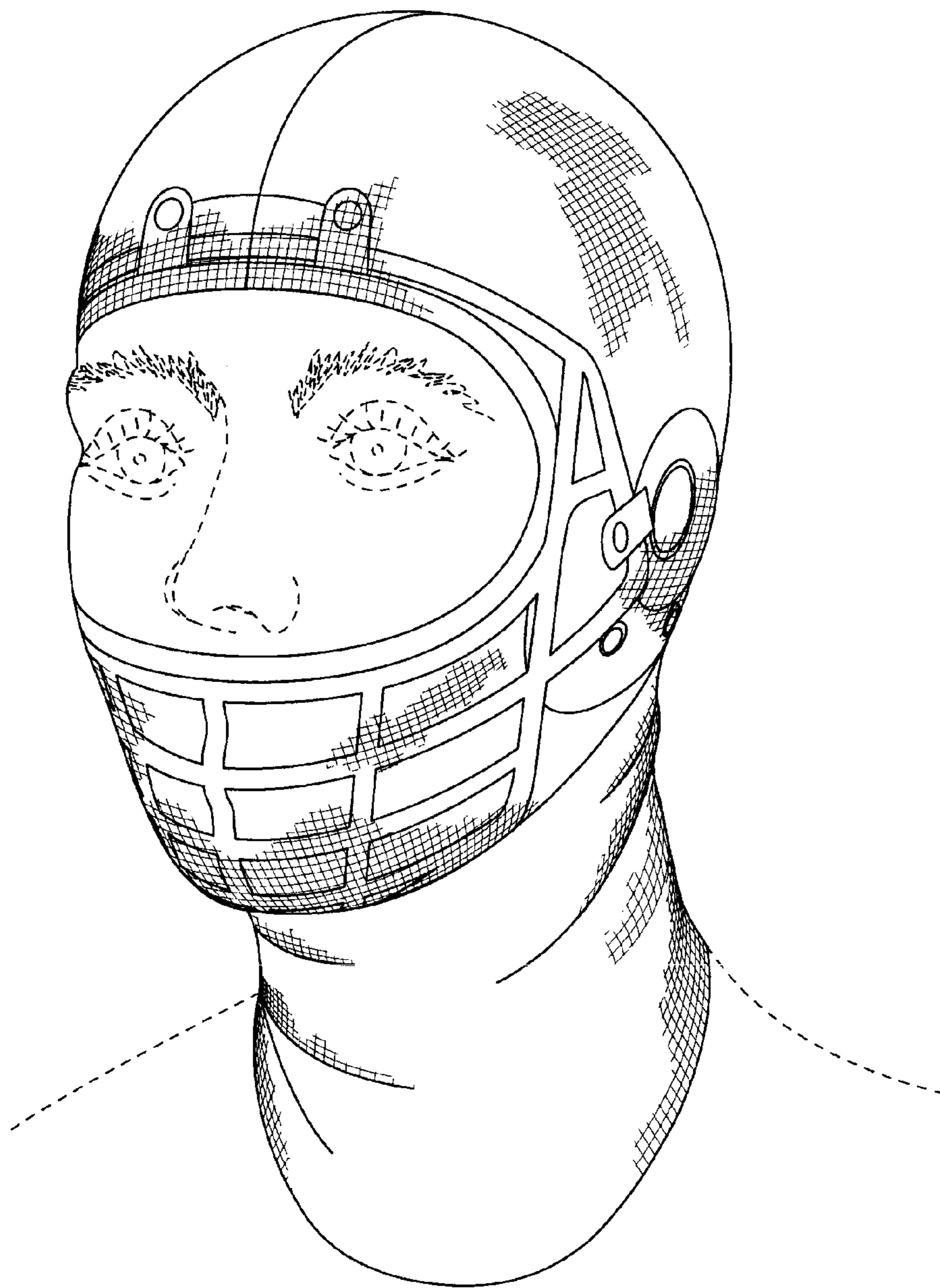

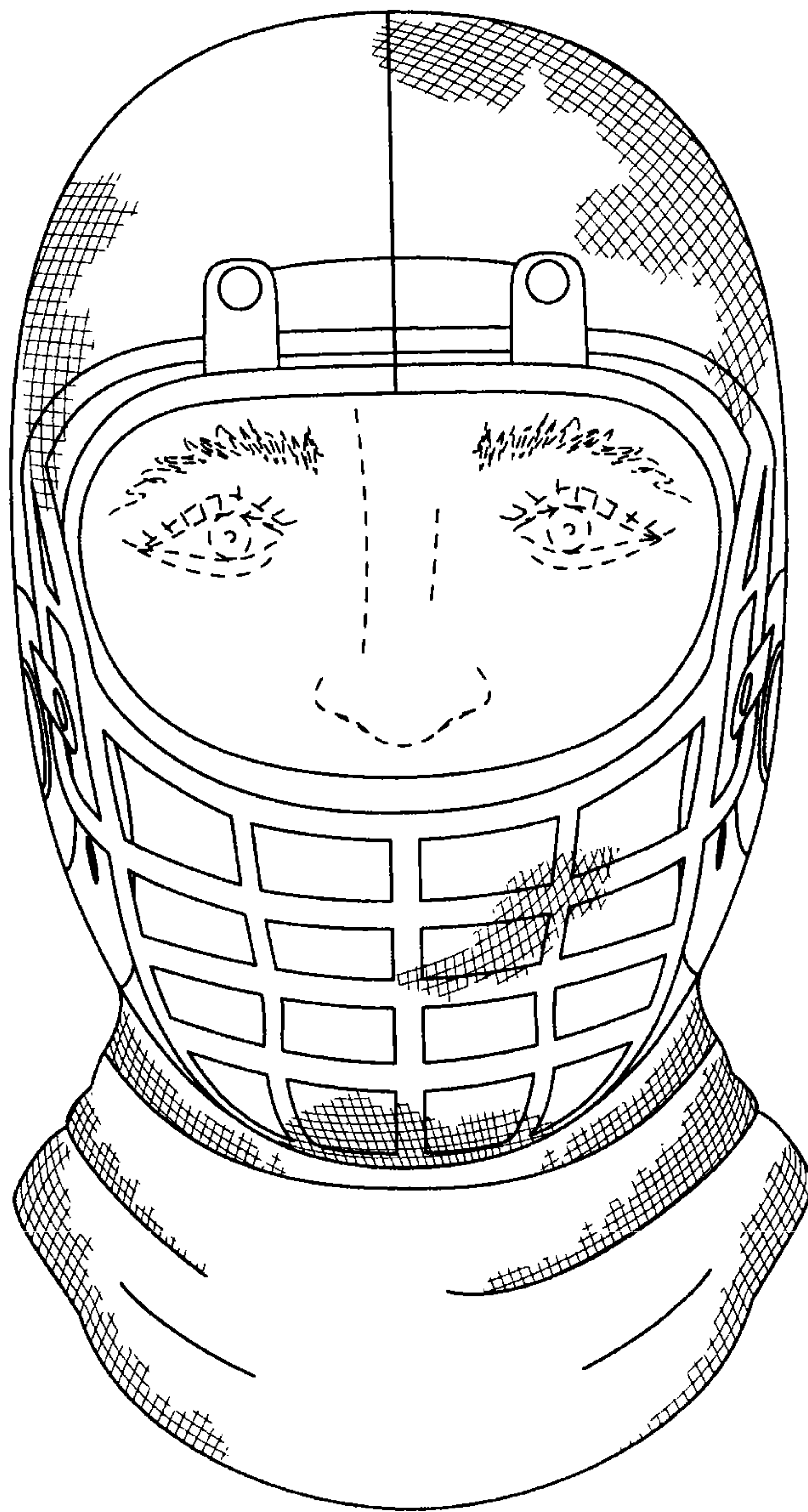

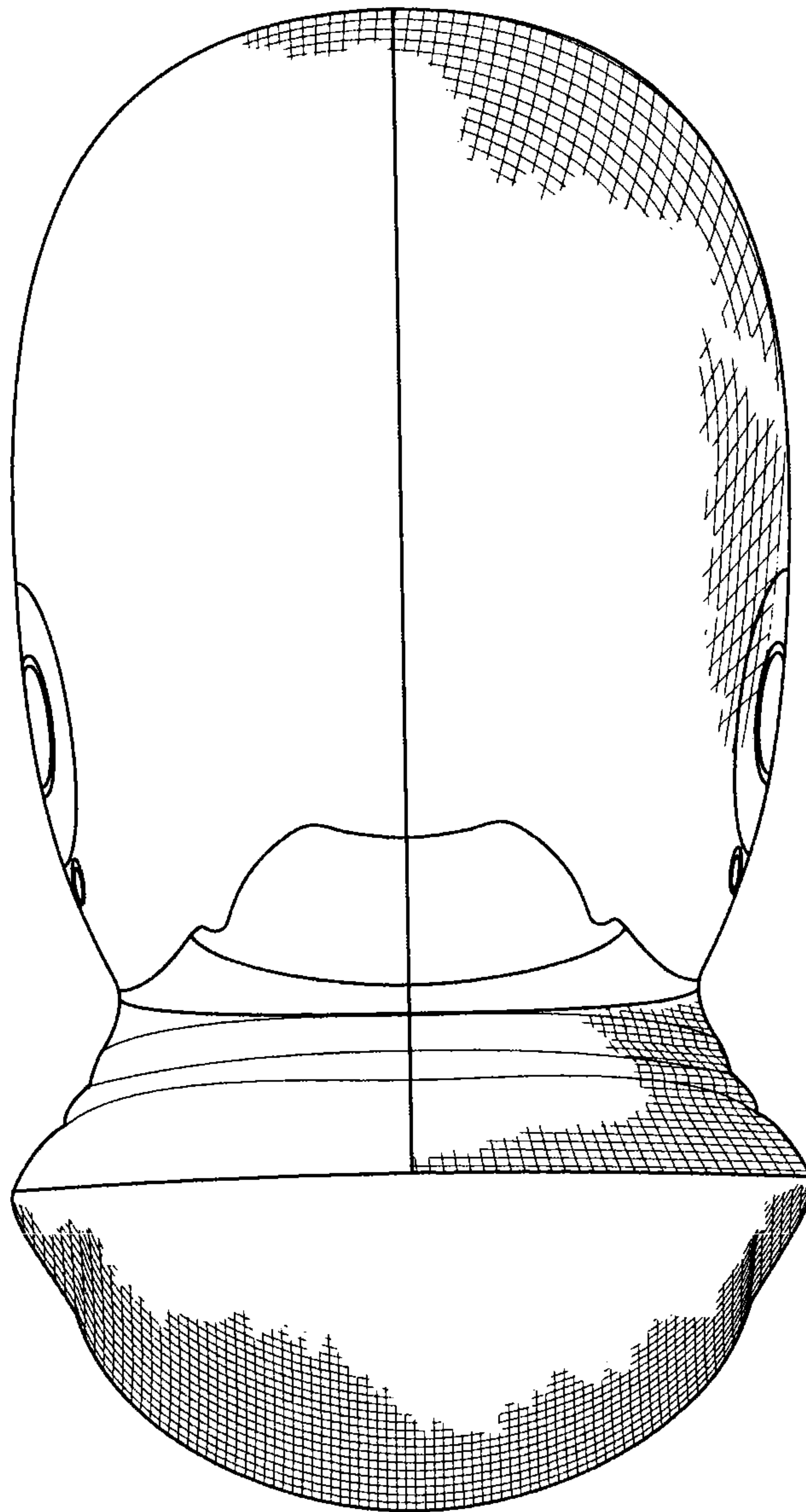

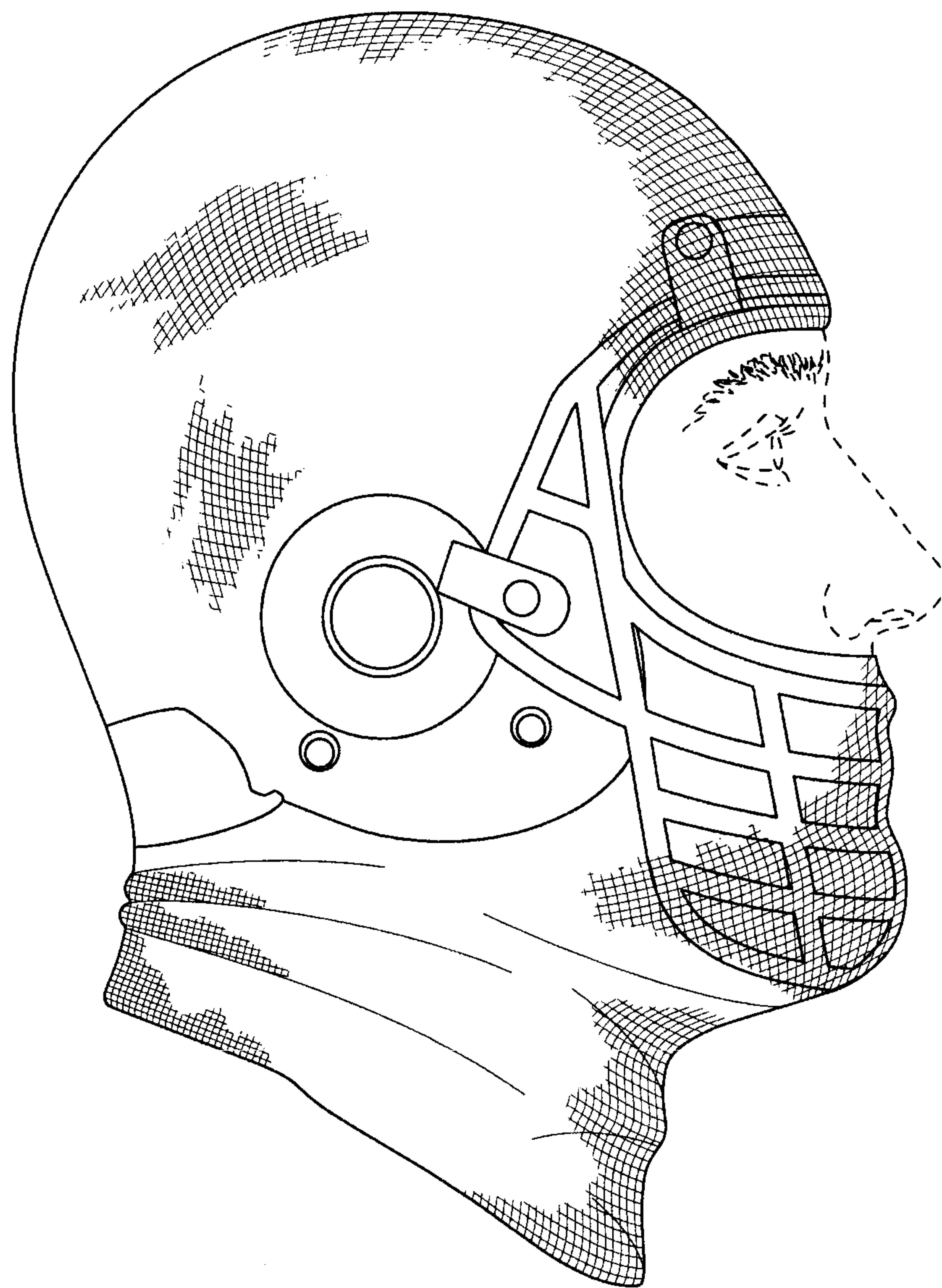

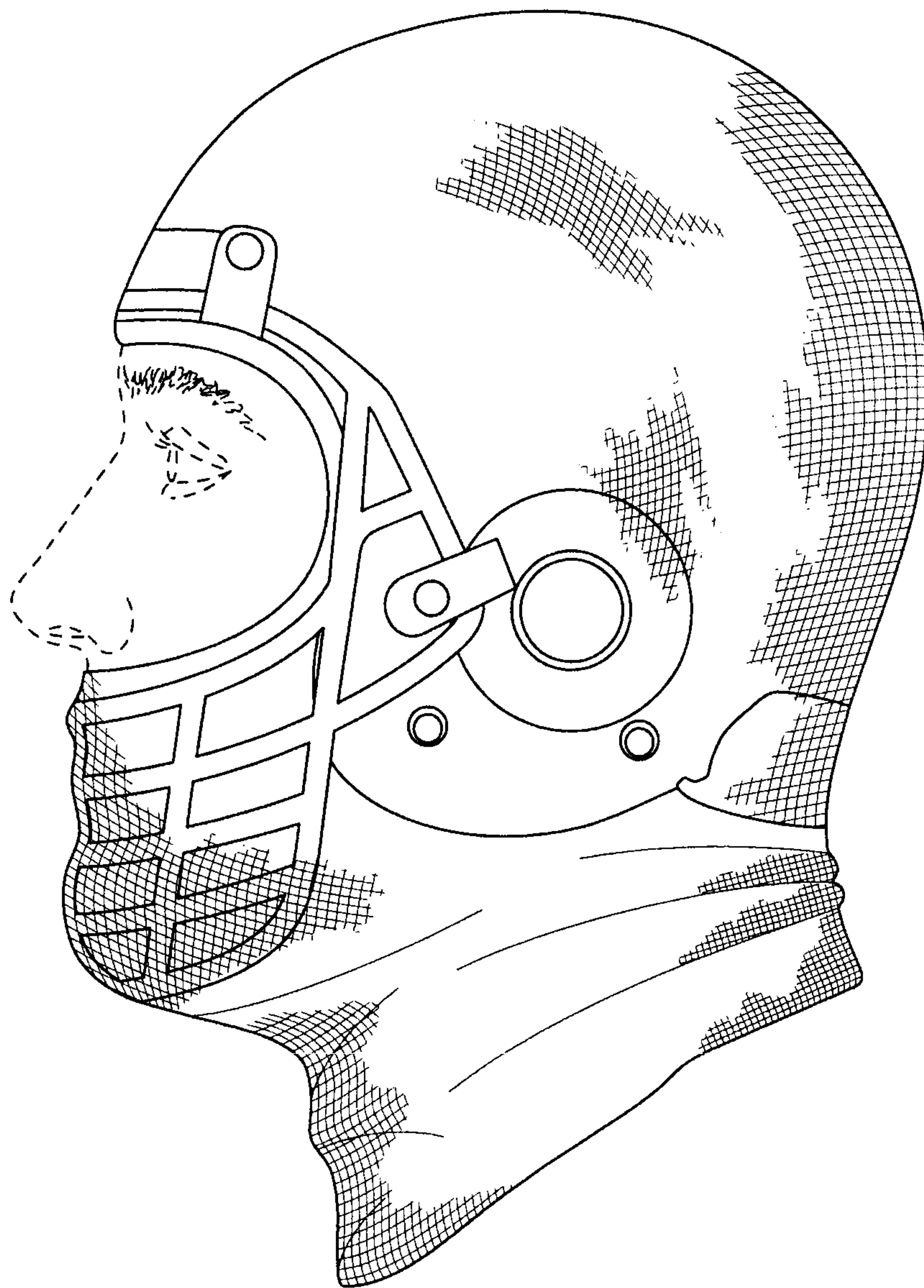

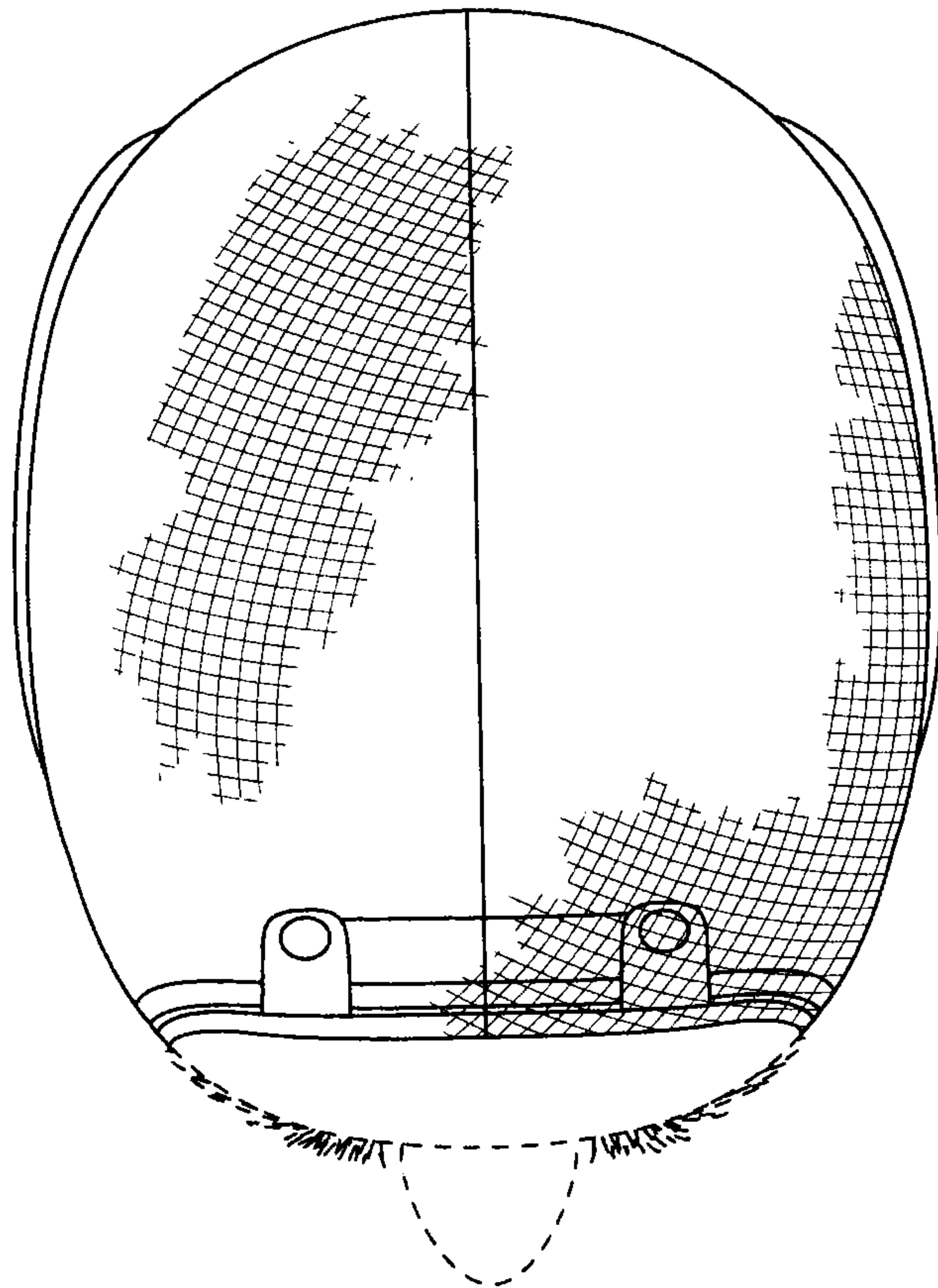

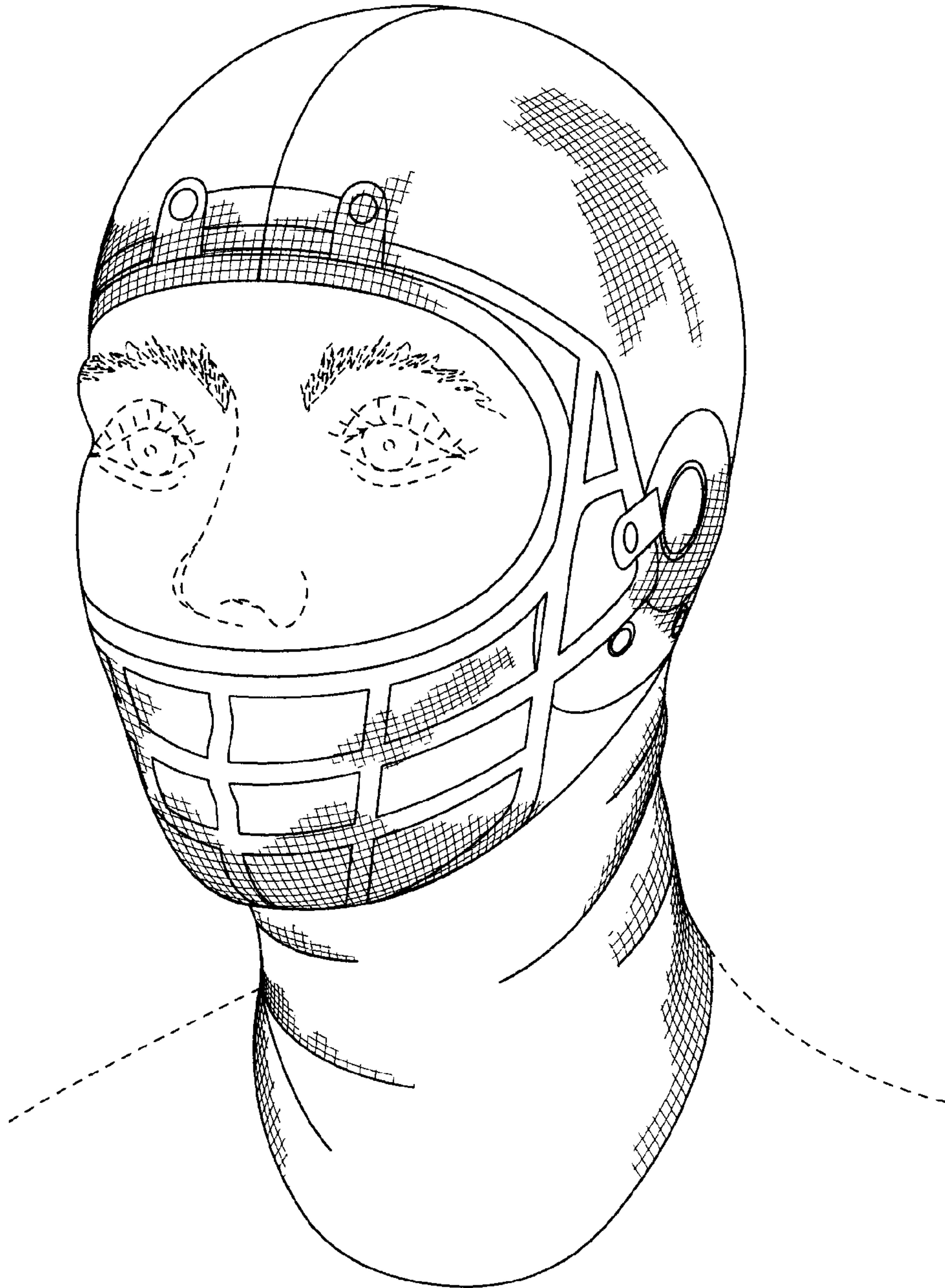

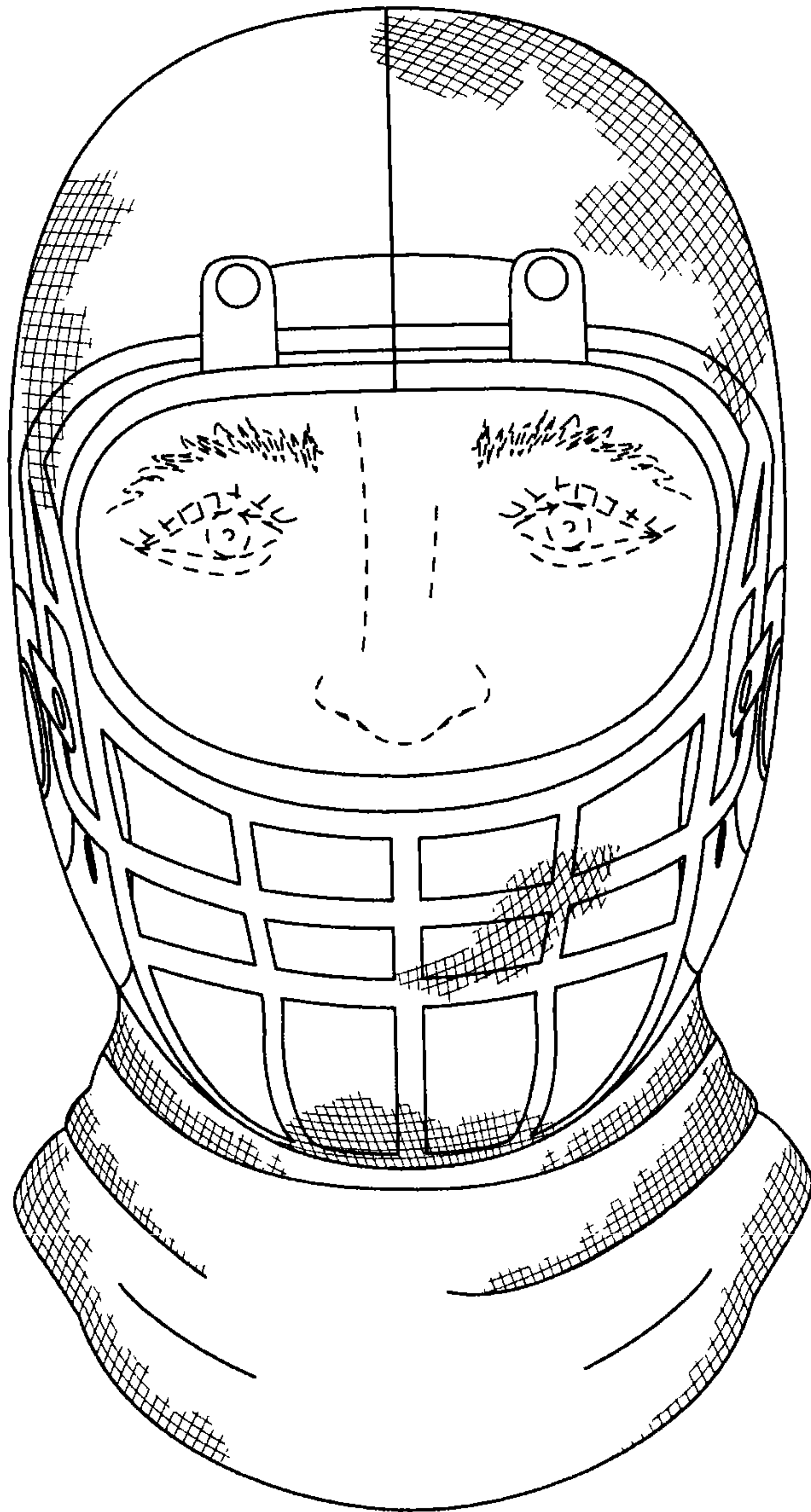

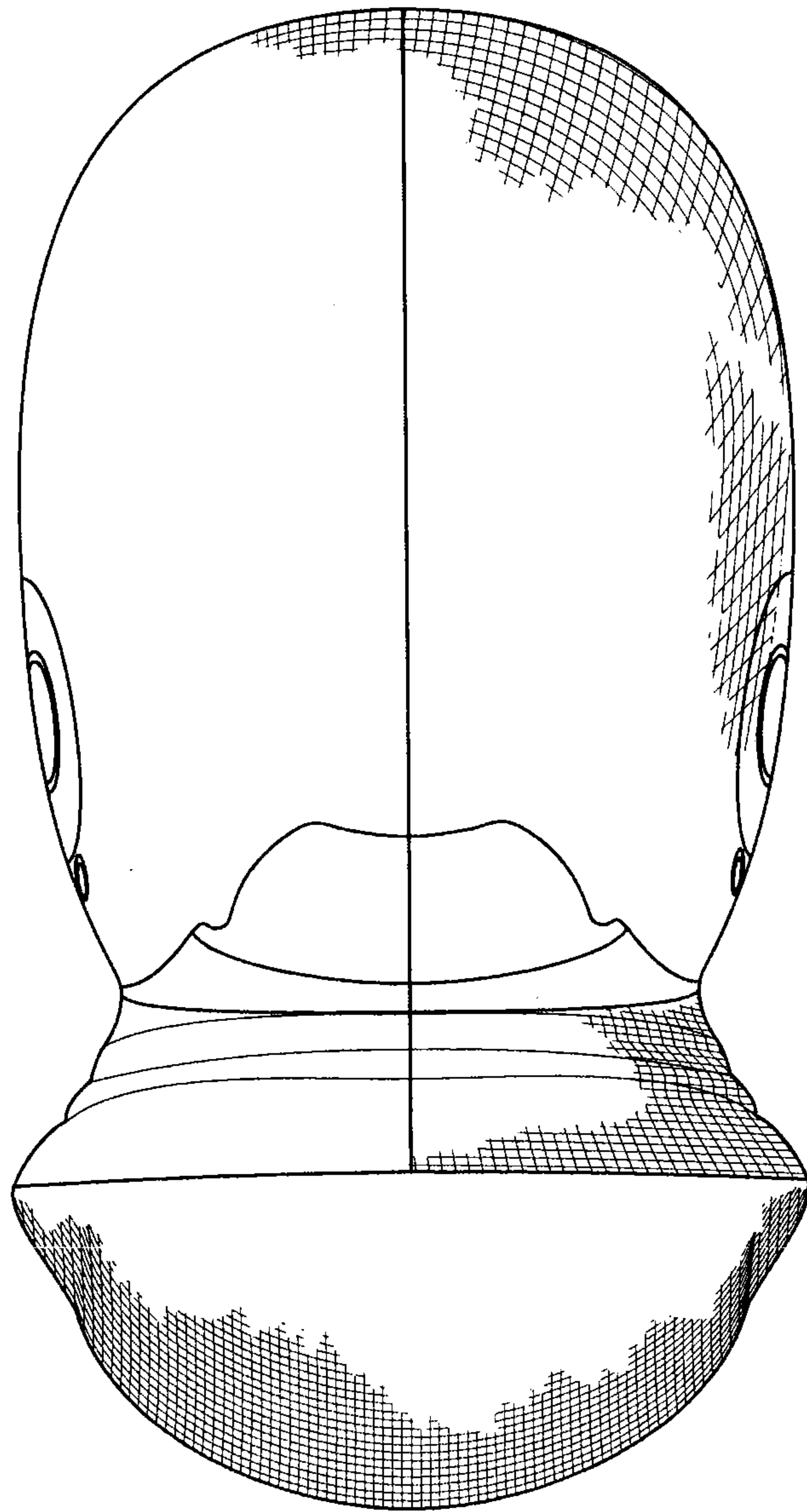

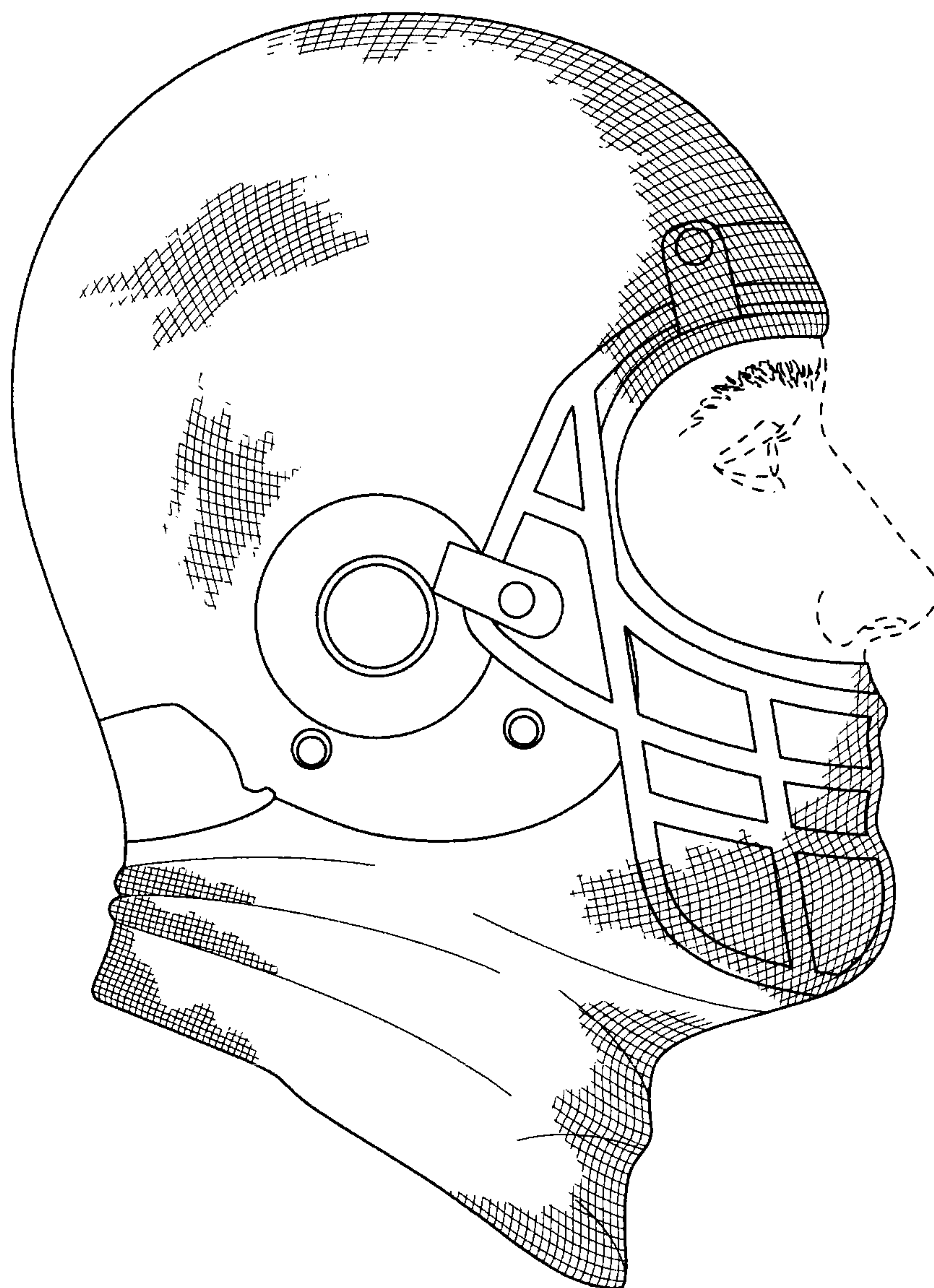

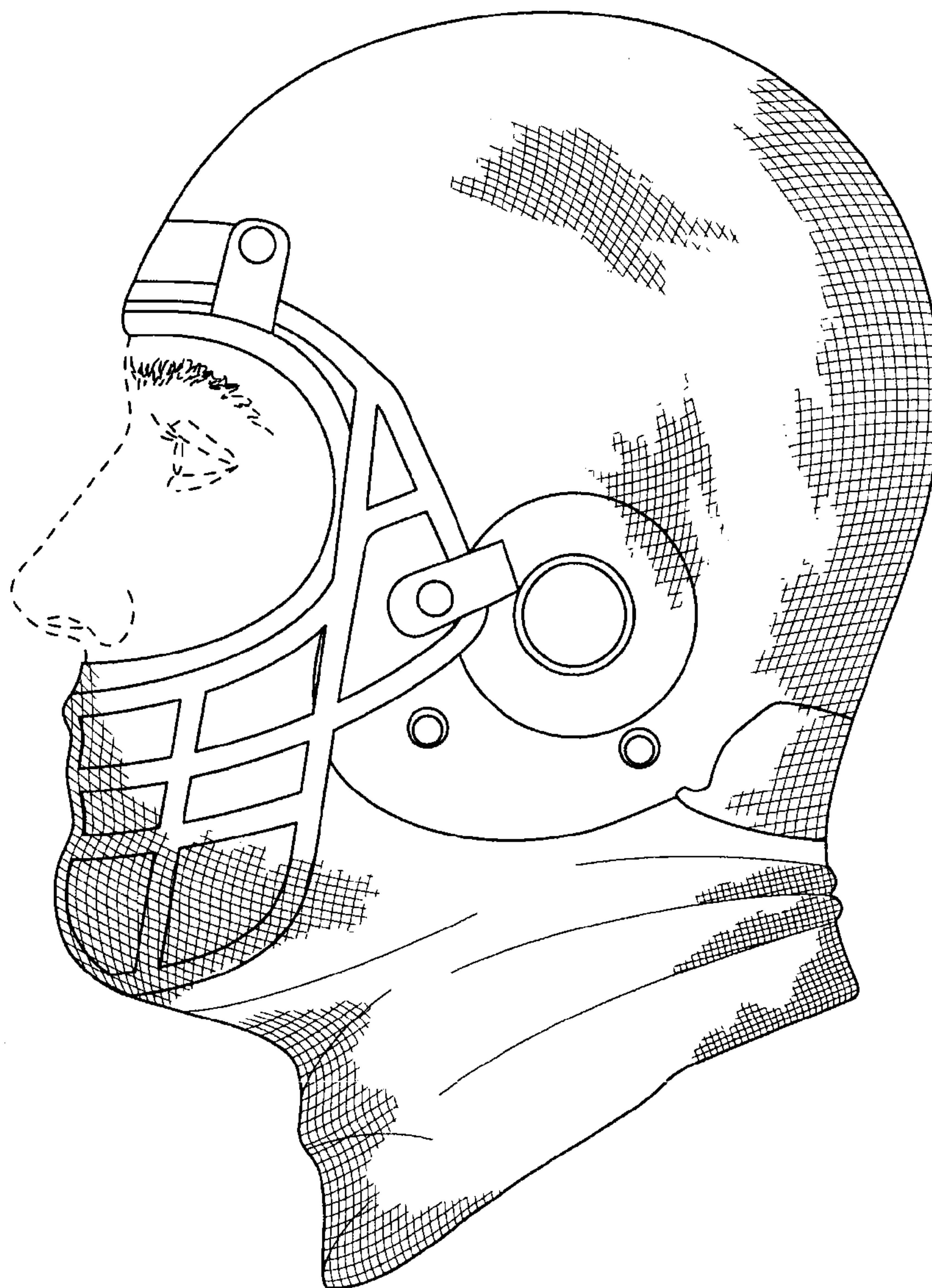

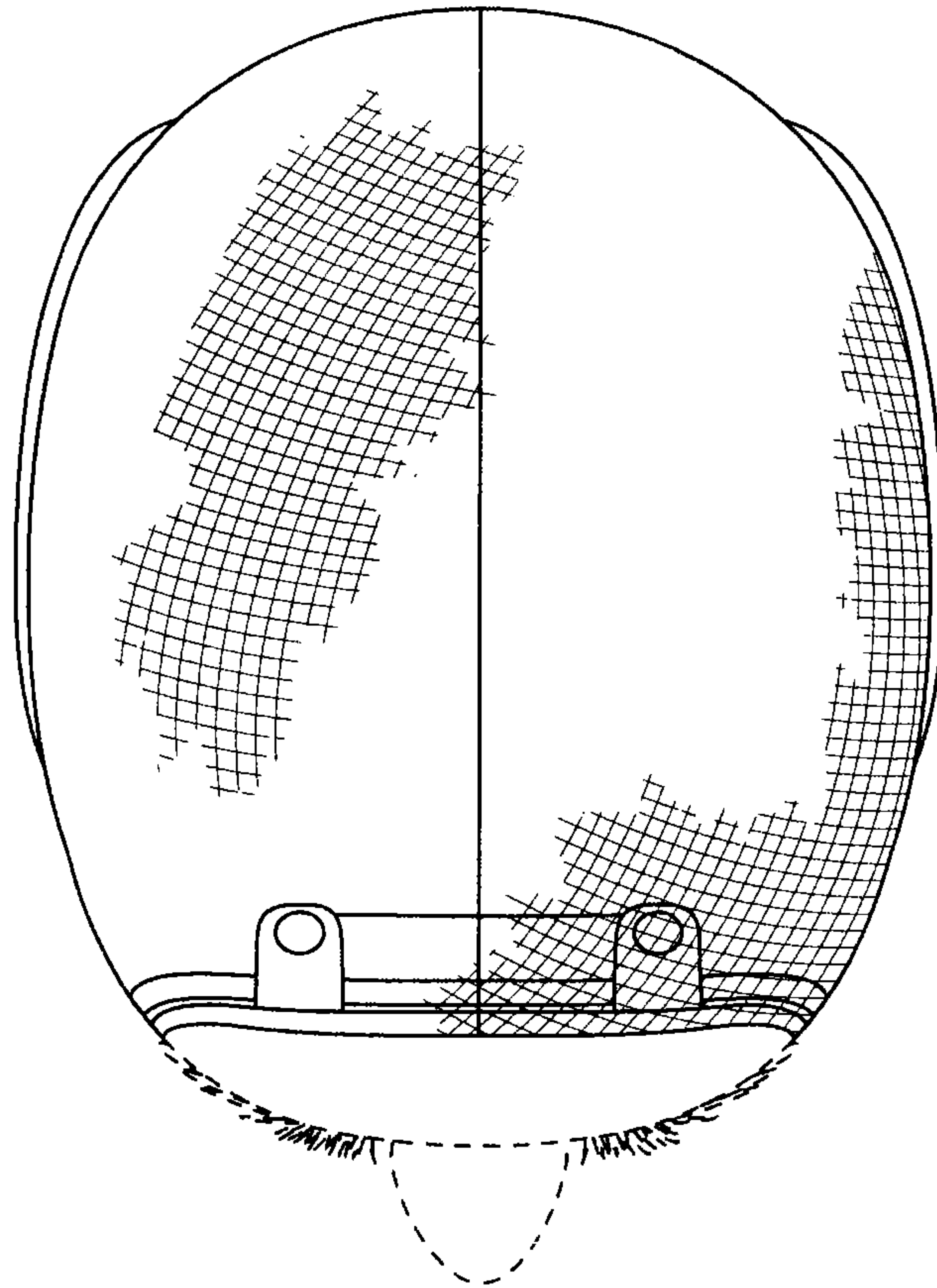
