FIG. 3 is a side view of a first side of the shoe.

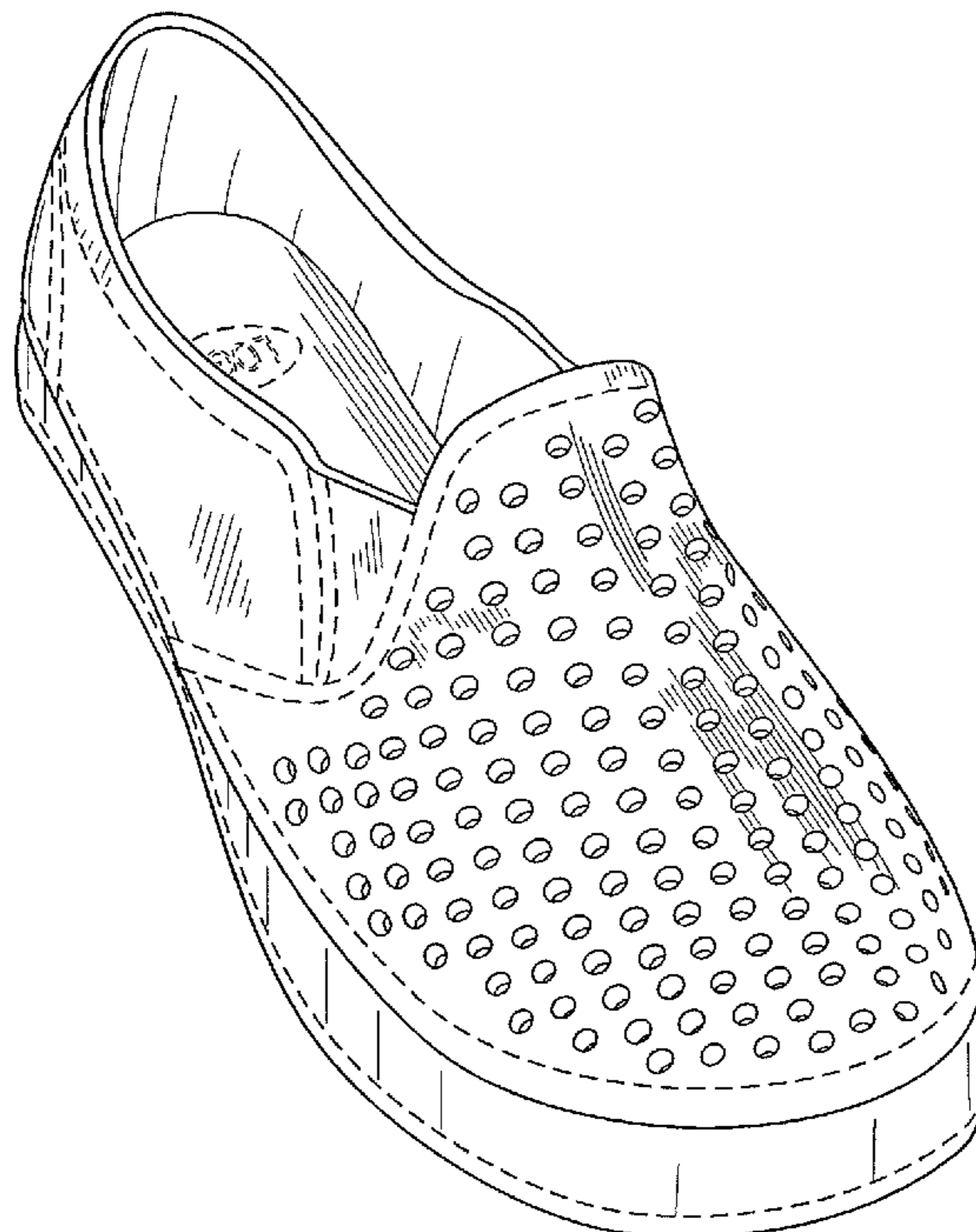
FIG. 4 is a side view of a second side of the shoe.

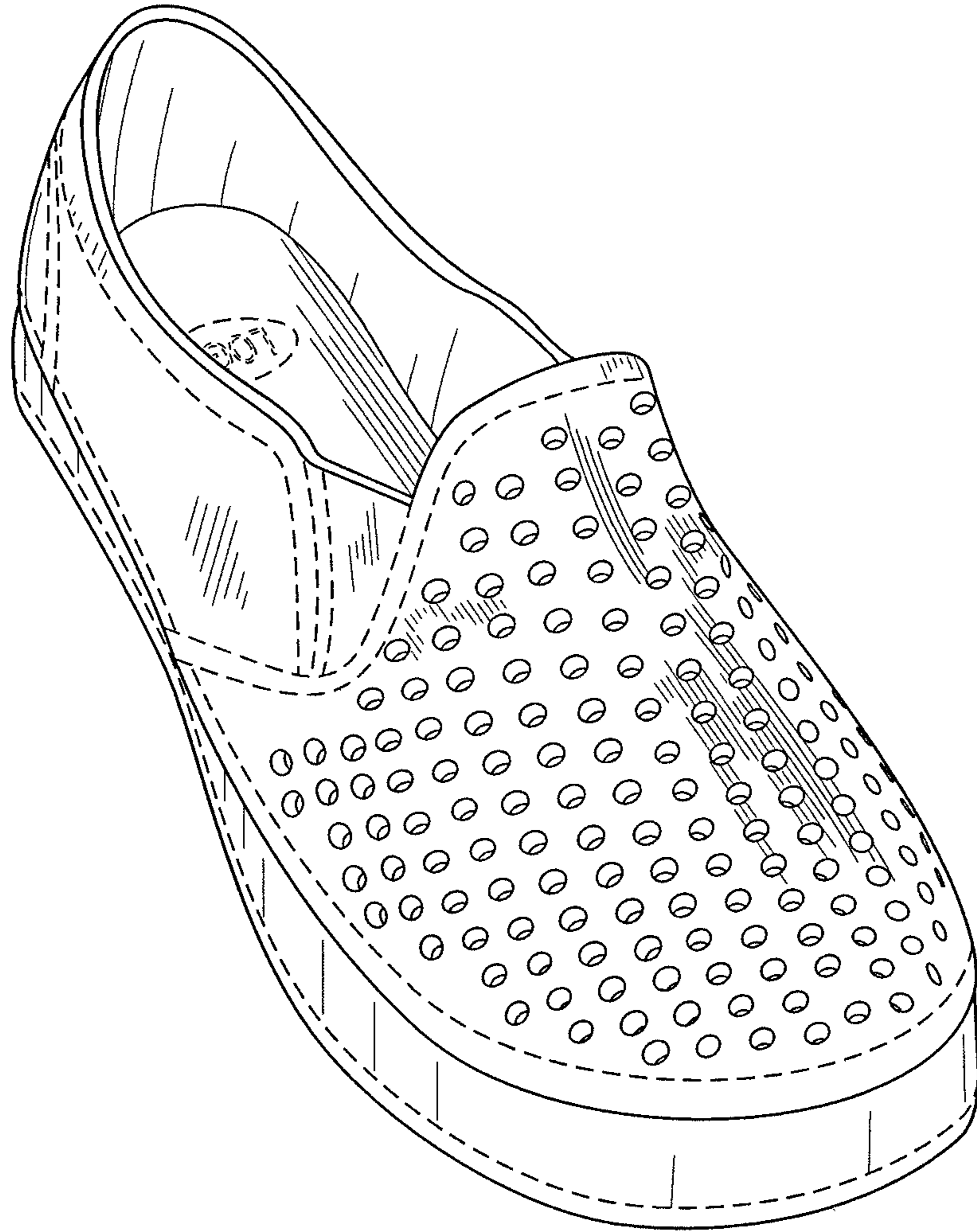

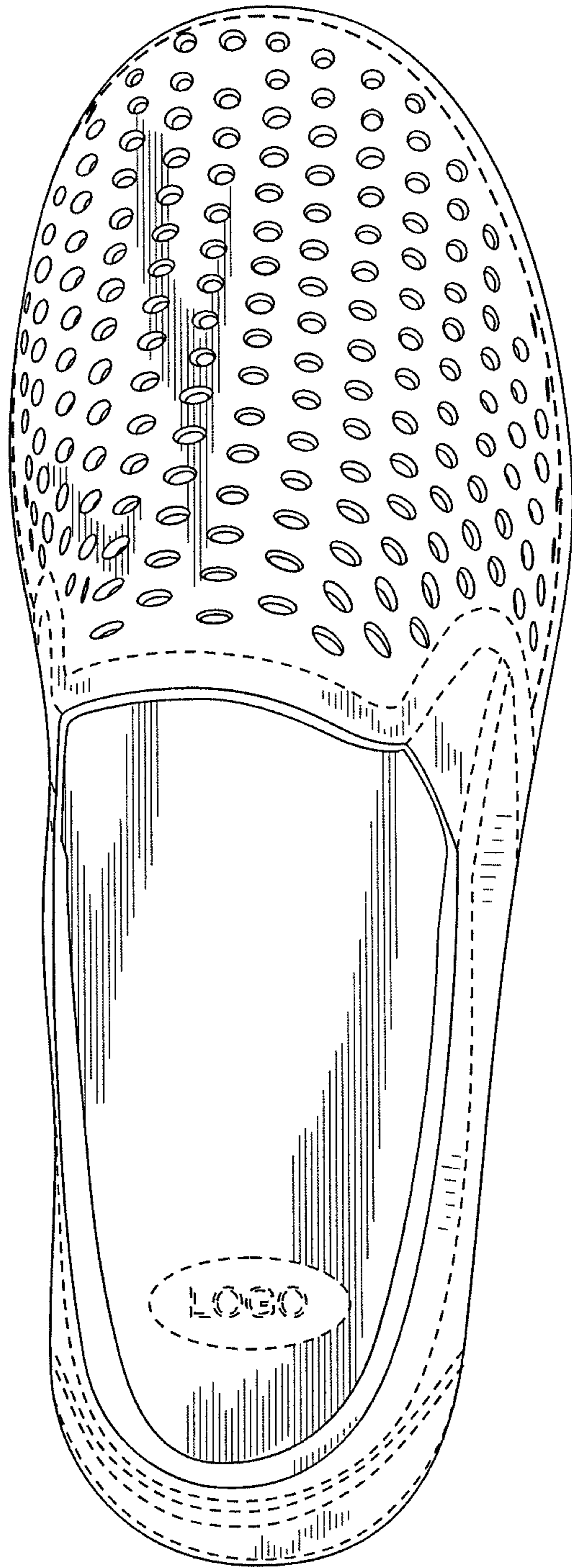

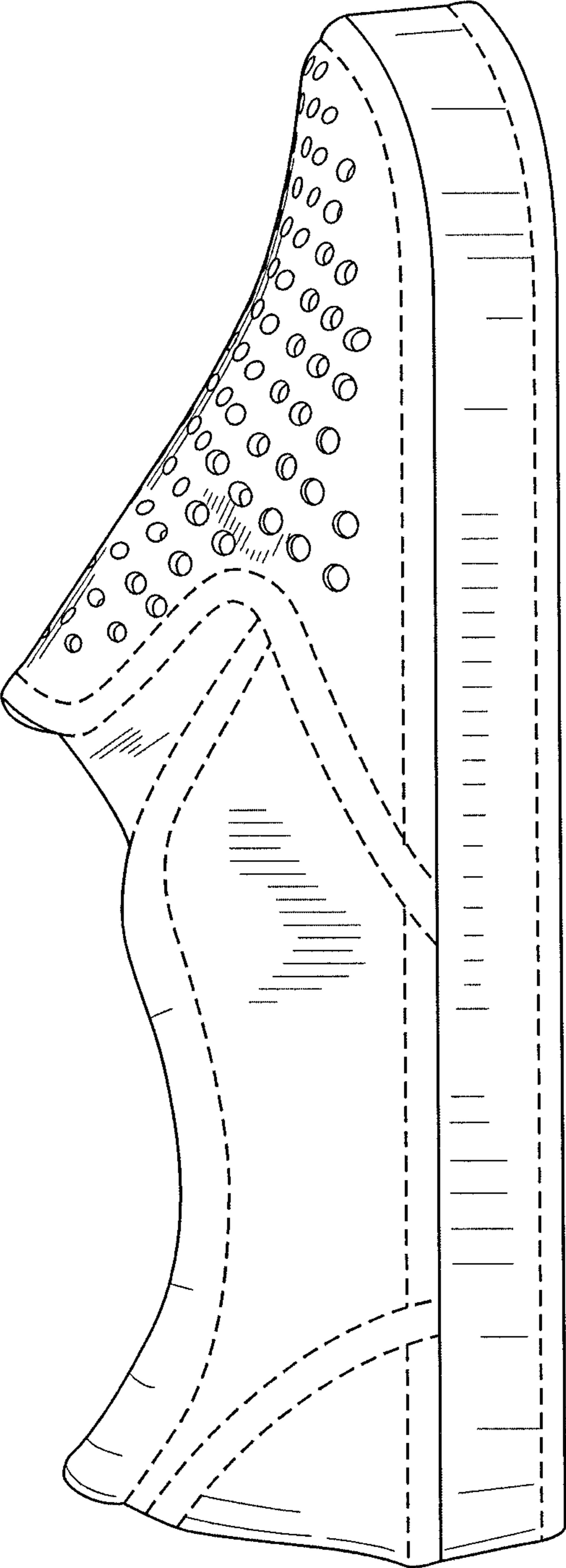

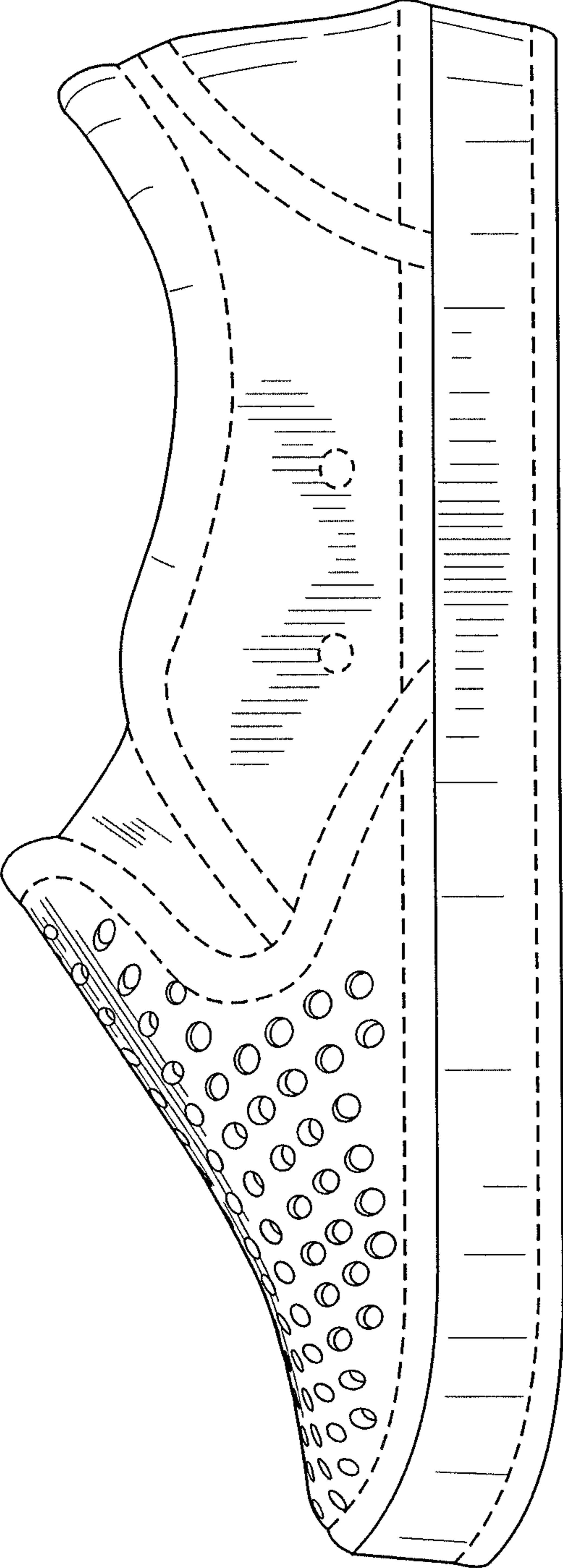

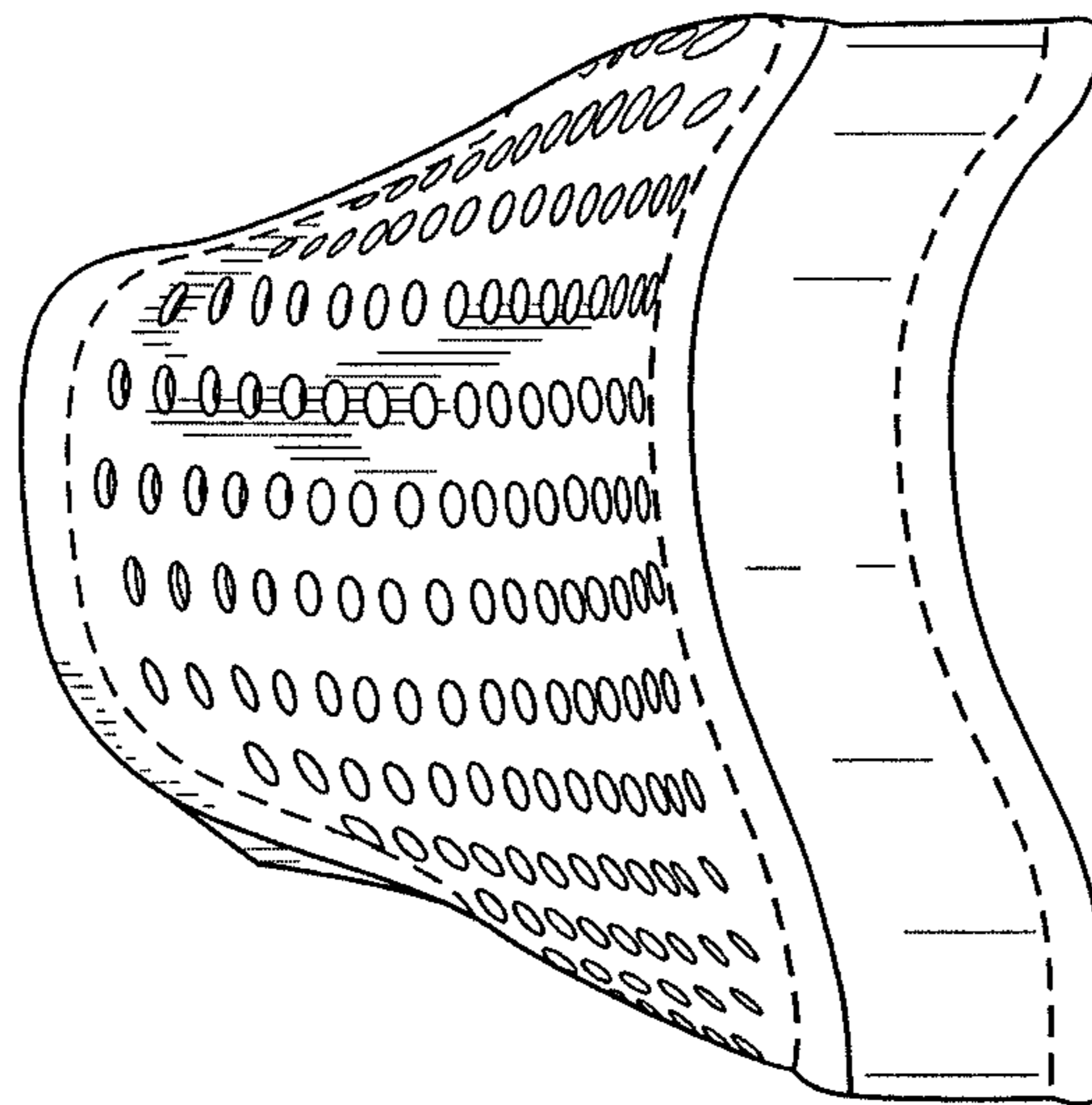

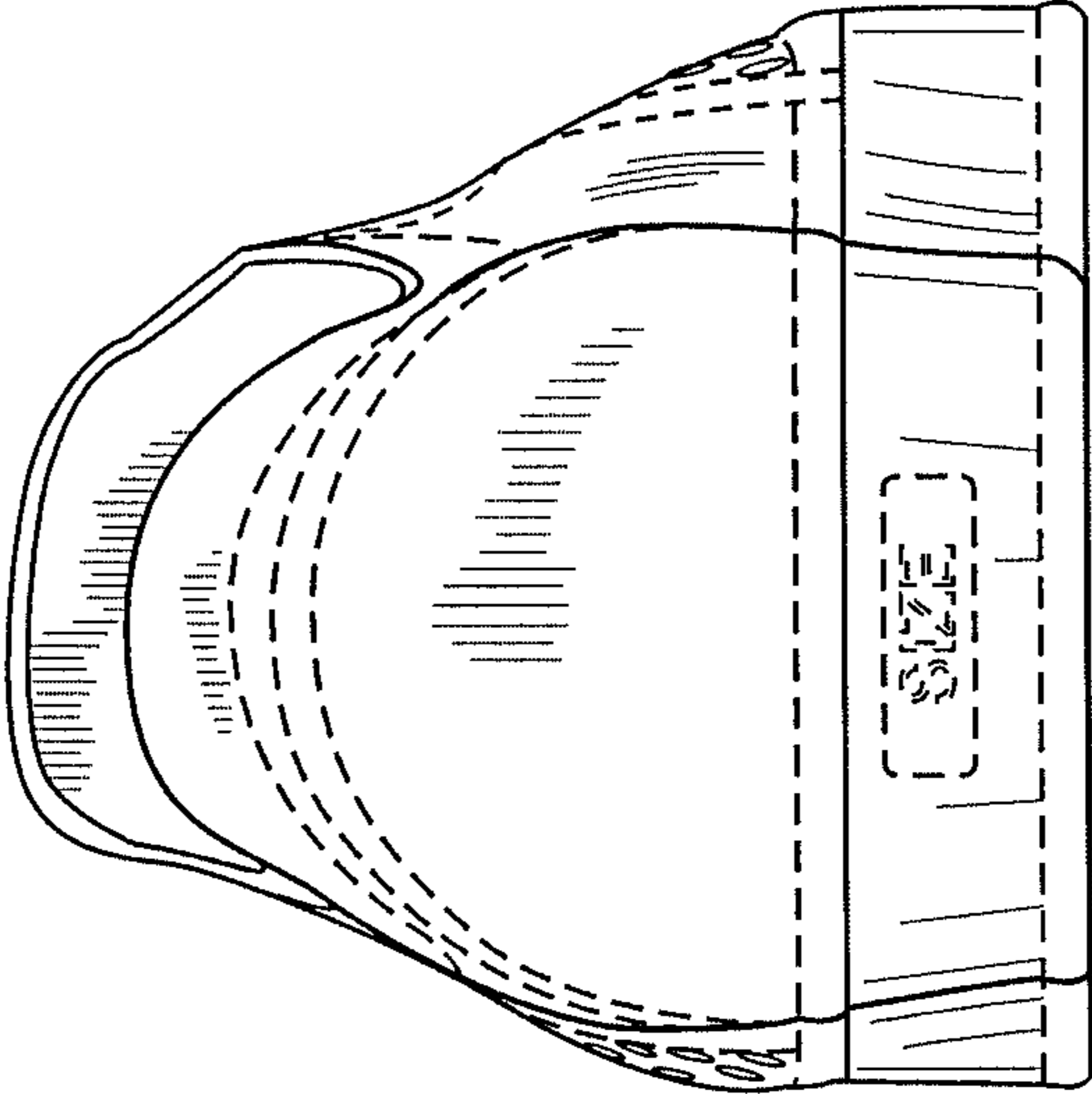
