 FIG. 7 is a top view thereof.

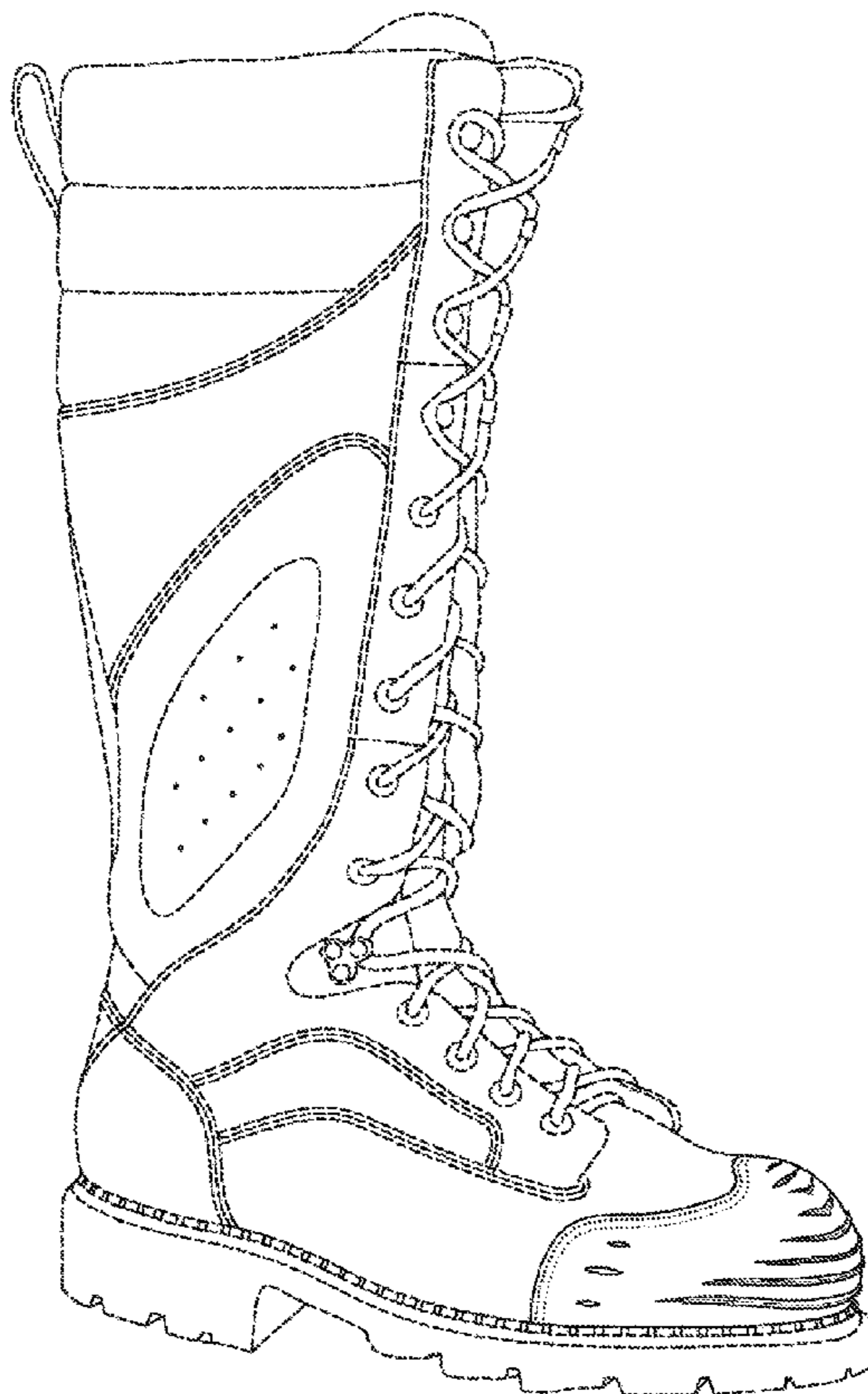

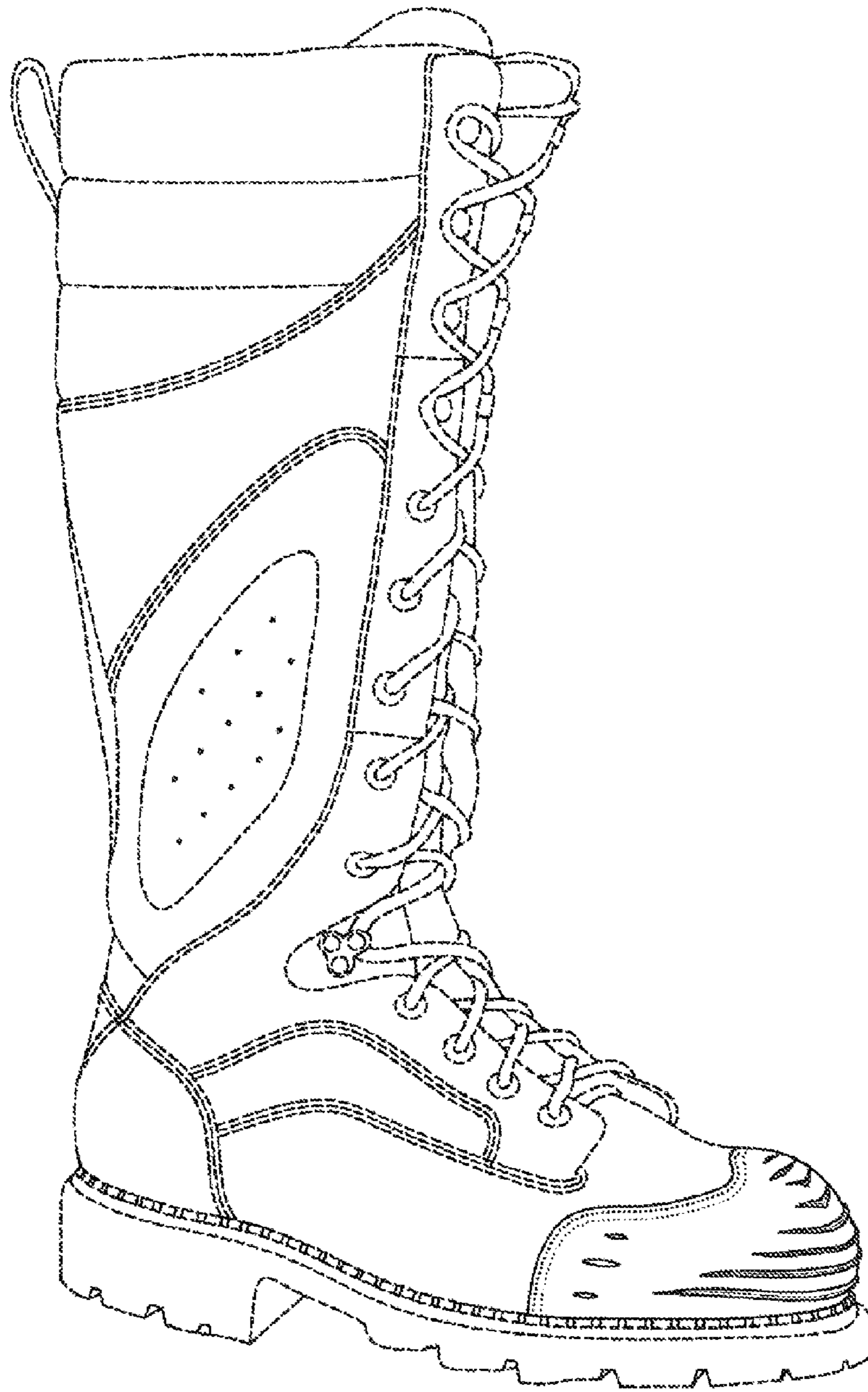

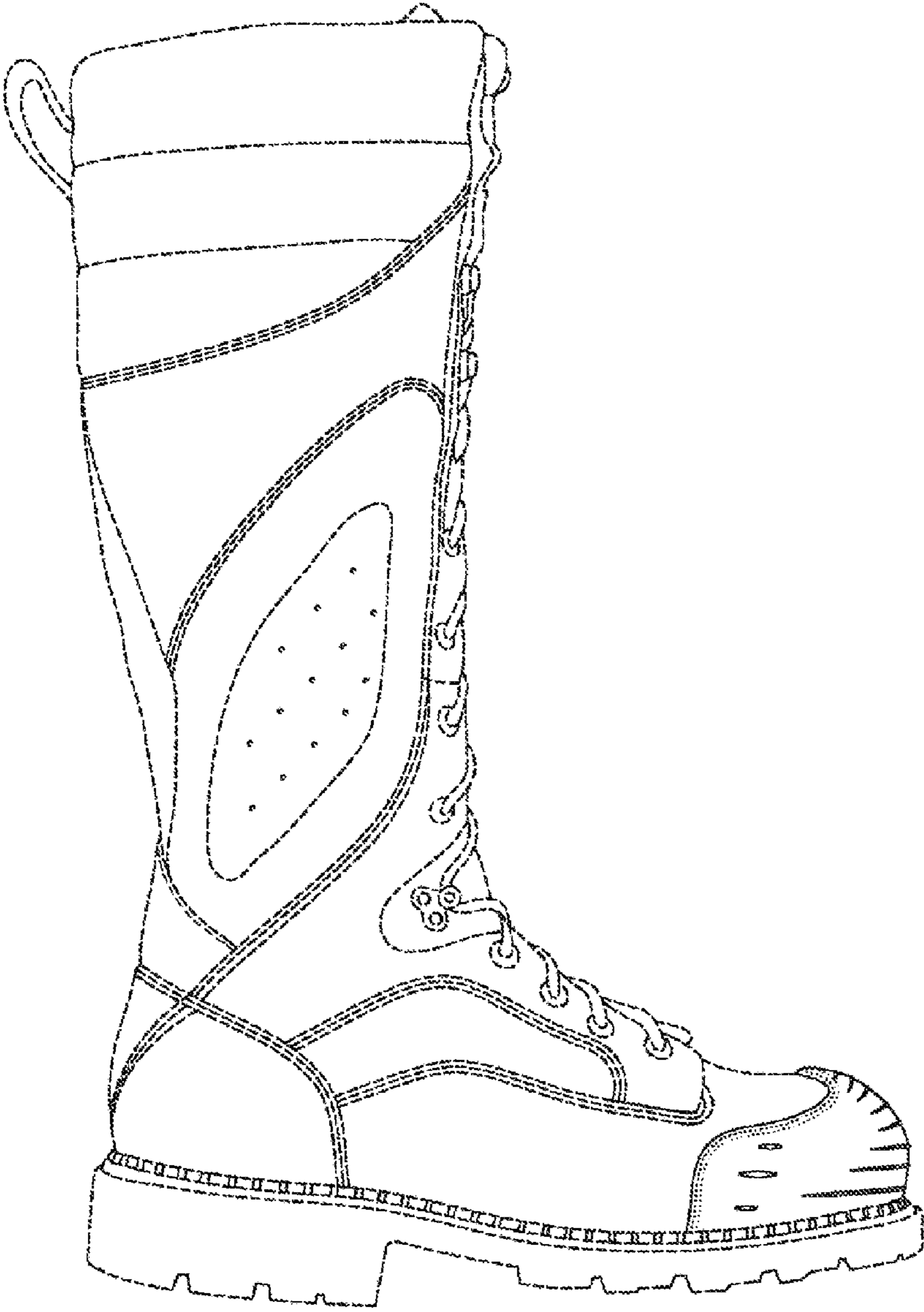

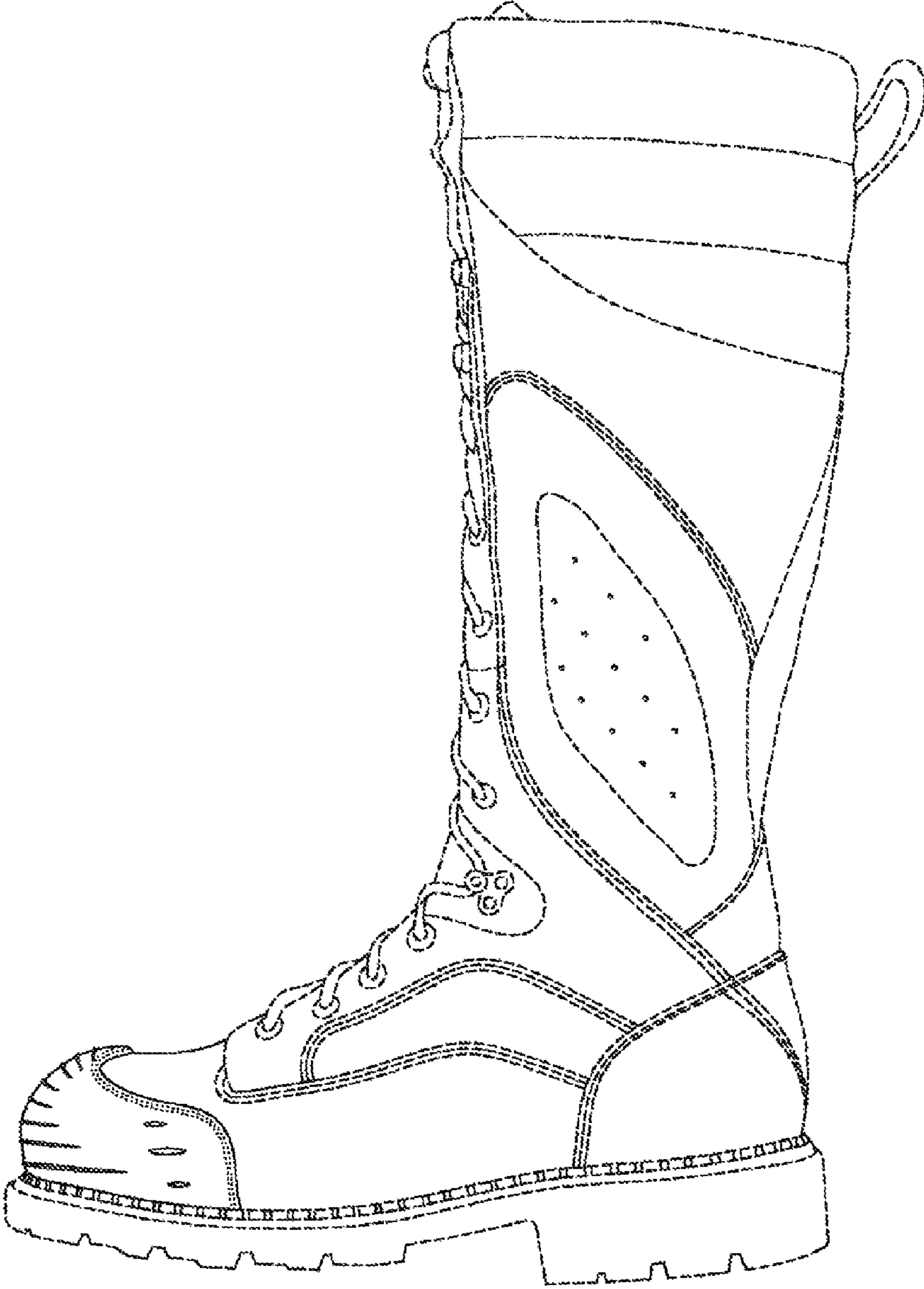

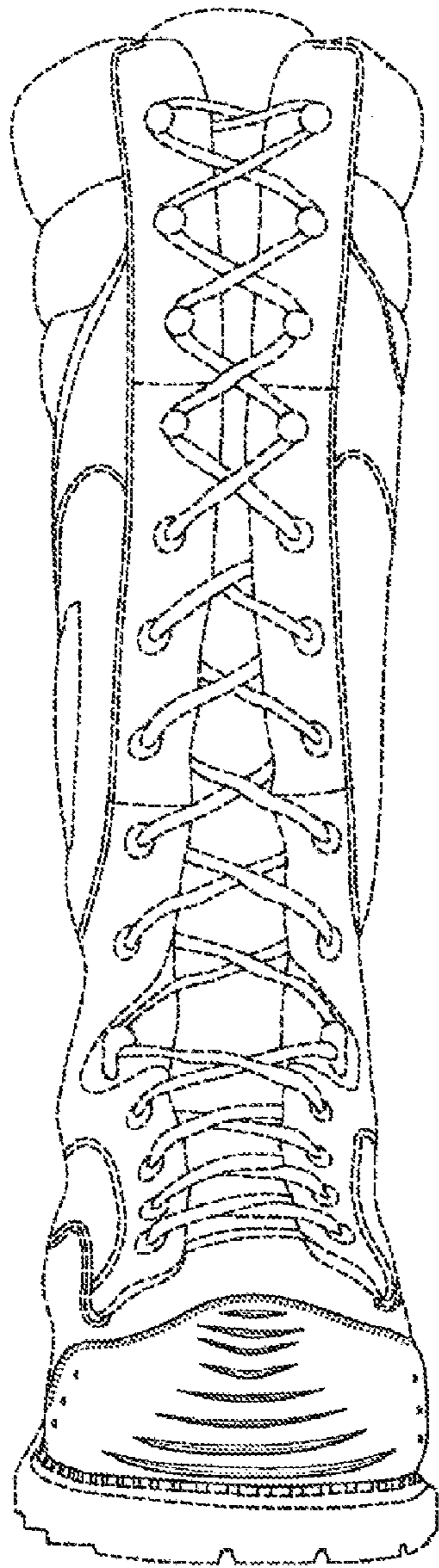

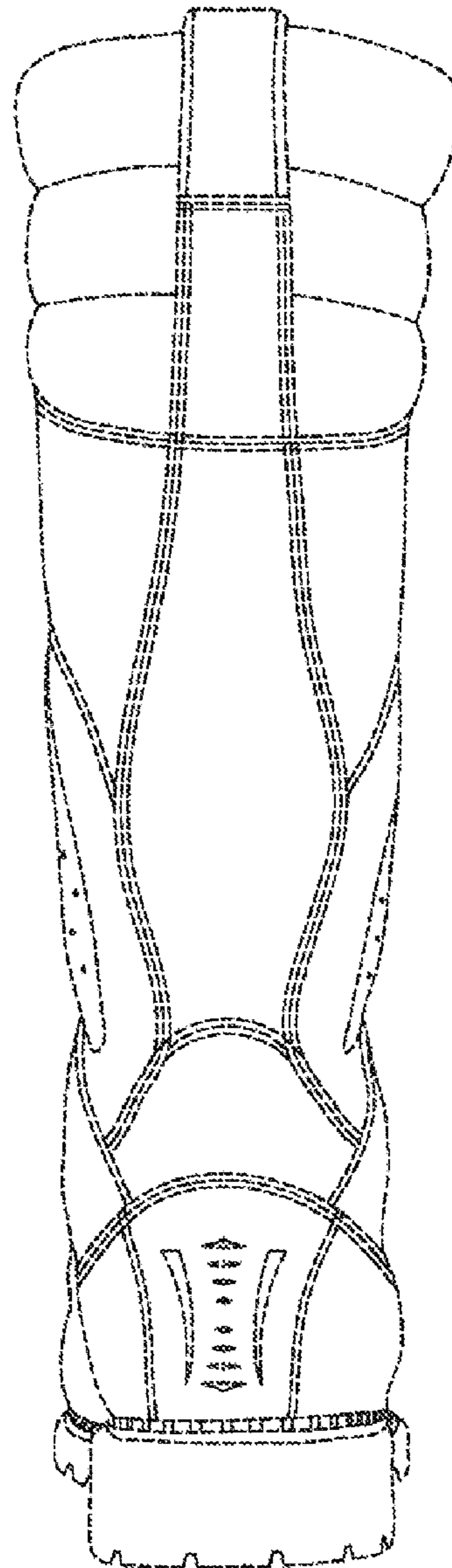

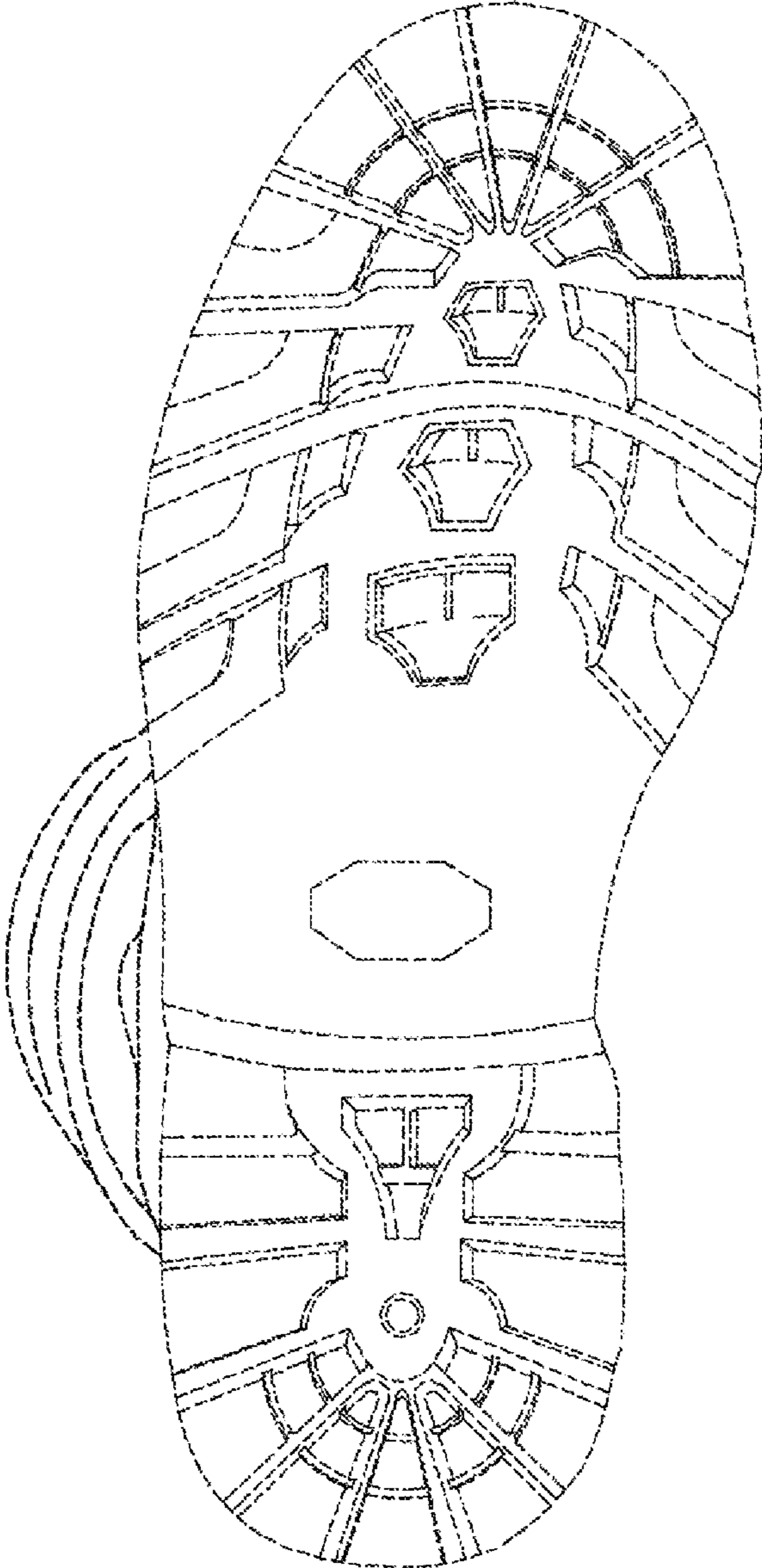

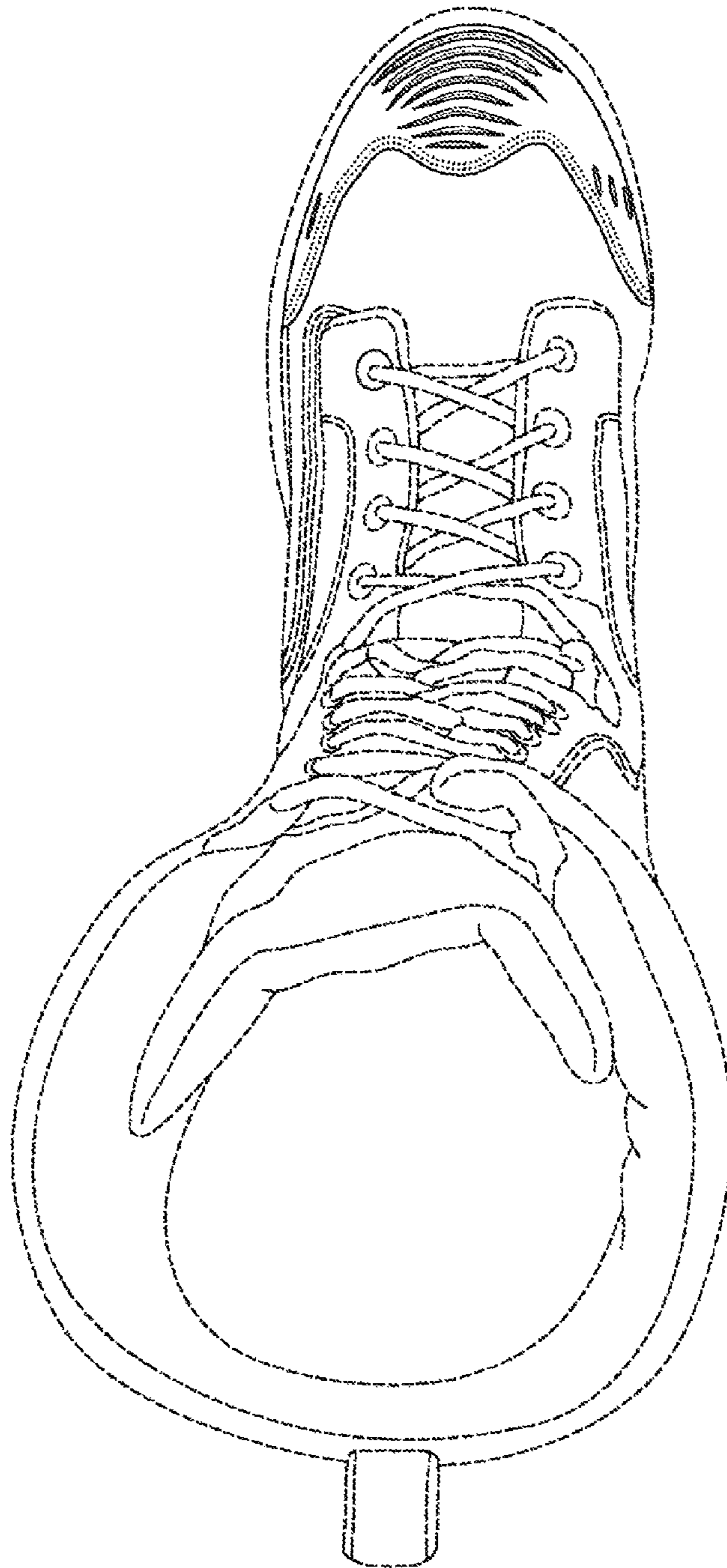
