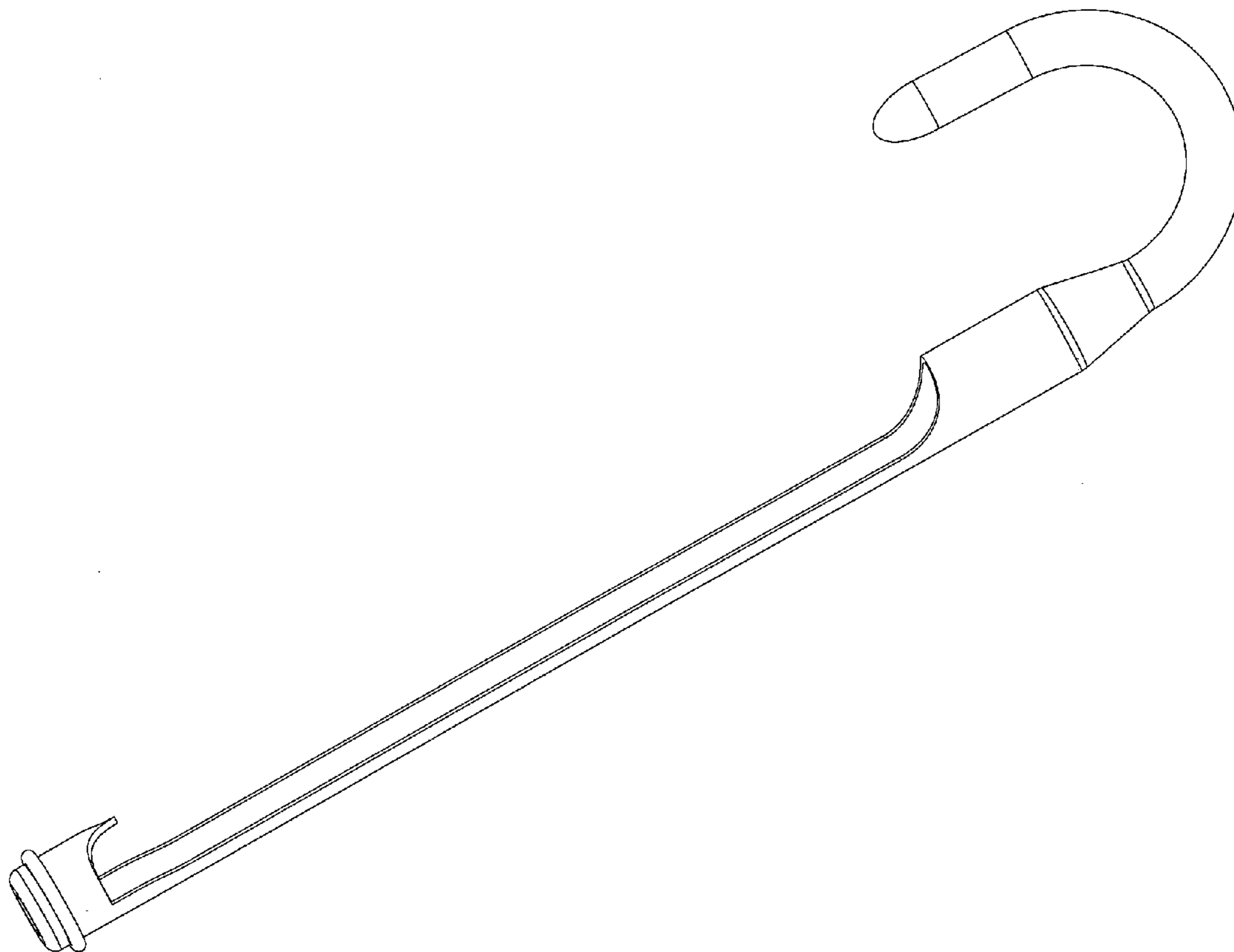
(57) **CLAIM**

The ornamental design for a wine bottle cork removal tool, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a wine bottle cork removal tool of the instant invention;  
 FIG. 2 is a left side view thereof, the right side being a mirror image thereof;  
 FIG. 3 is a front view thereof;  
 FIG. 4 is a bottom view thereof;  
 FIG. 5 is a top view thereof; and,  
 FIG. 6 is a back view thereof.  
 The broken lines shown in FIG. 4 illustrate a circular screen which forms no part of the claimed design.

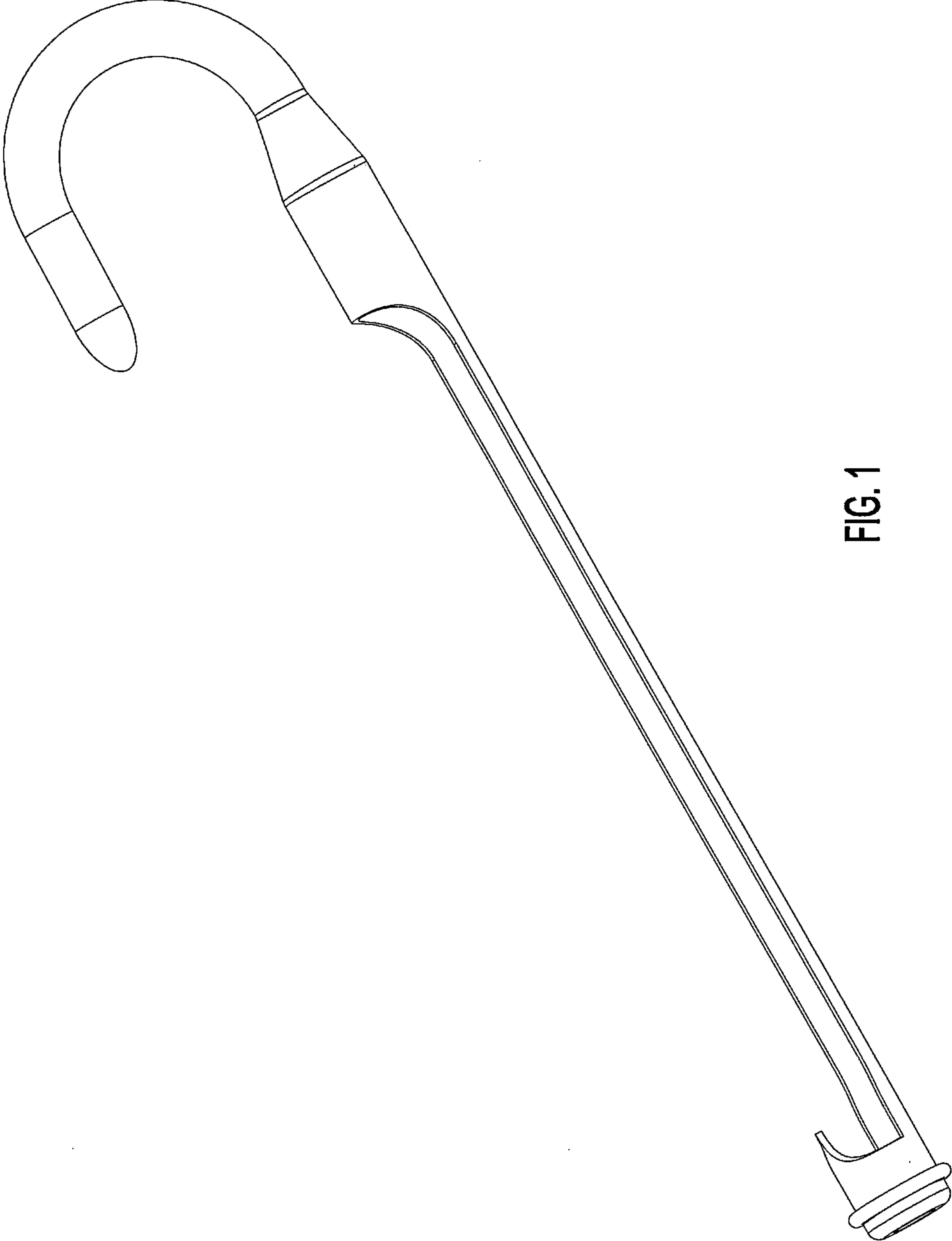

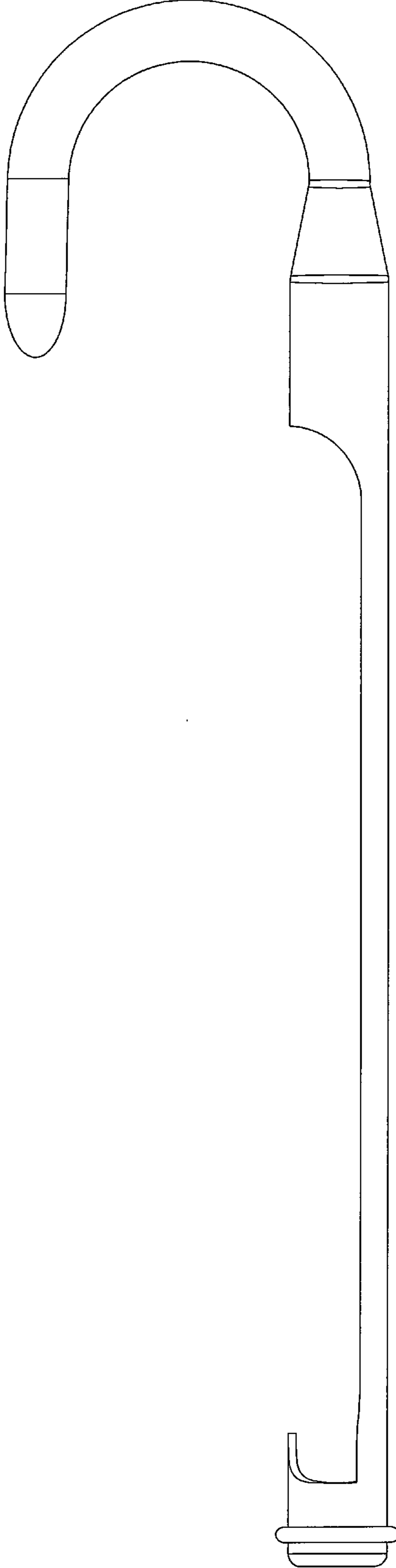

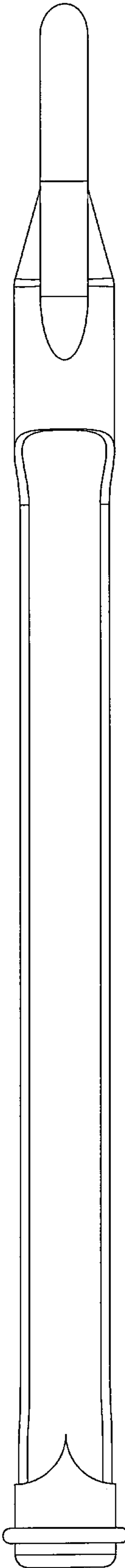

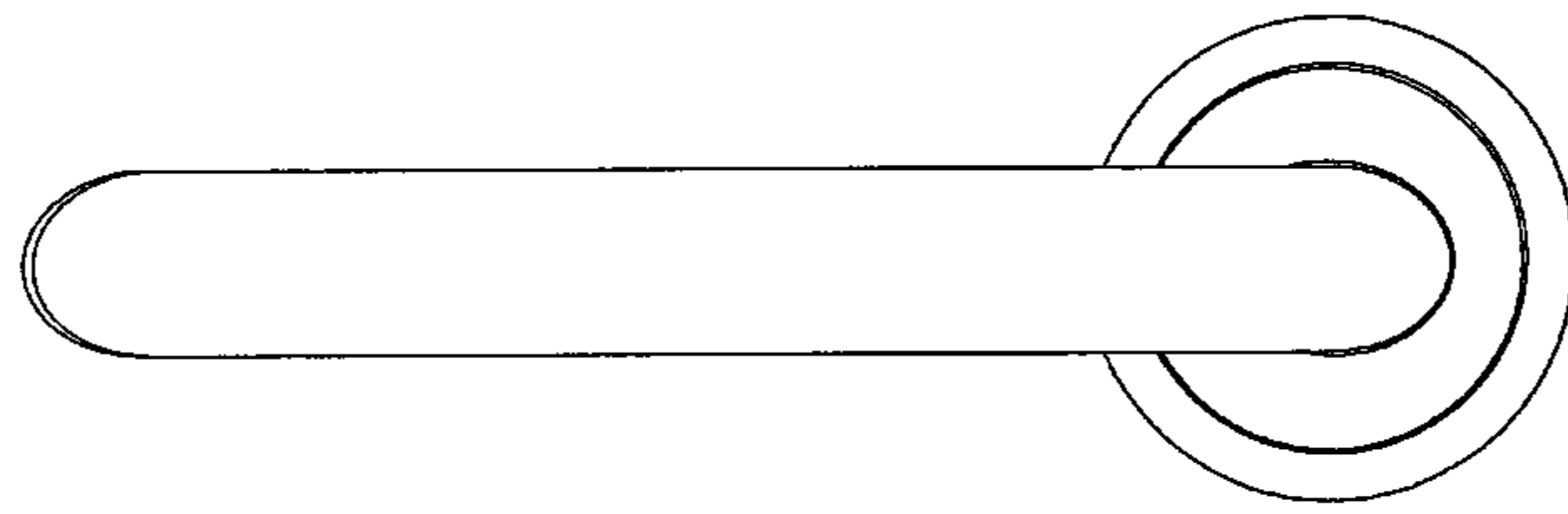

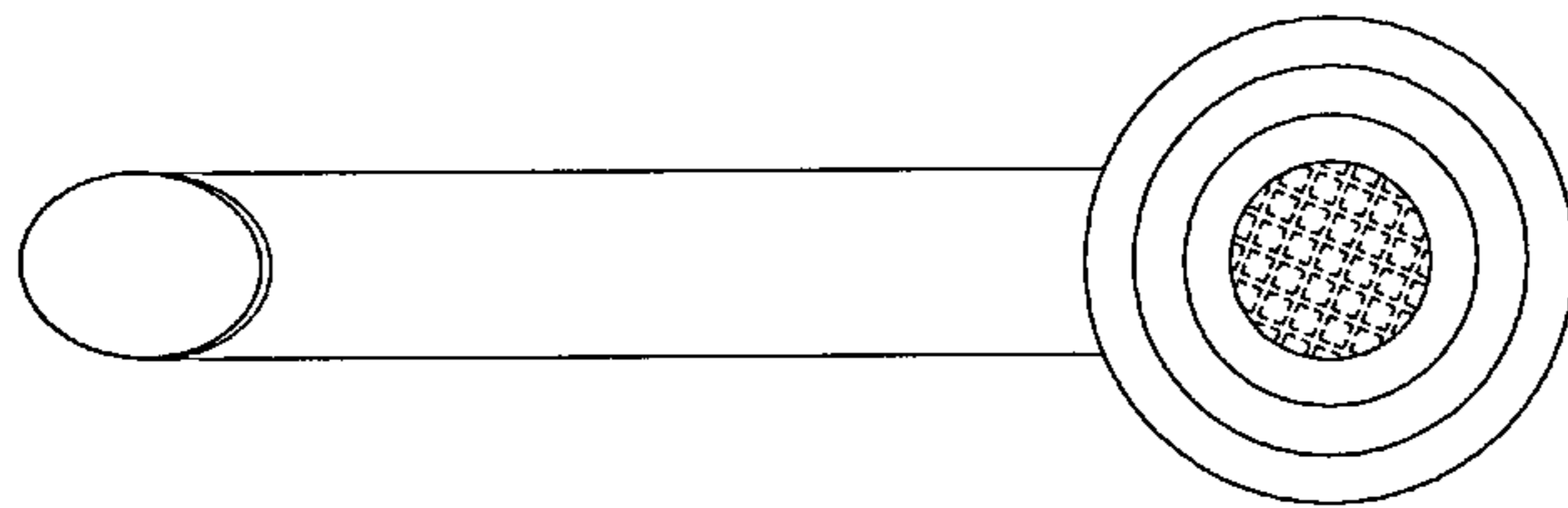

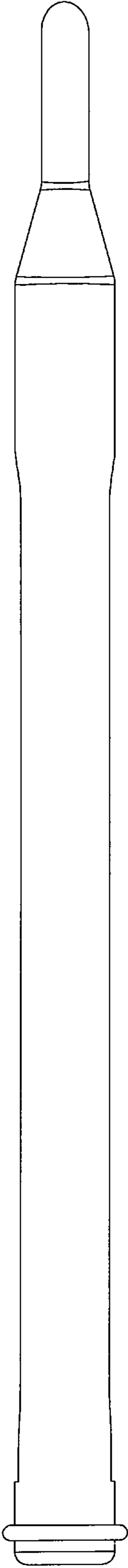
