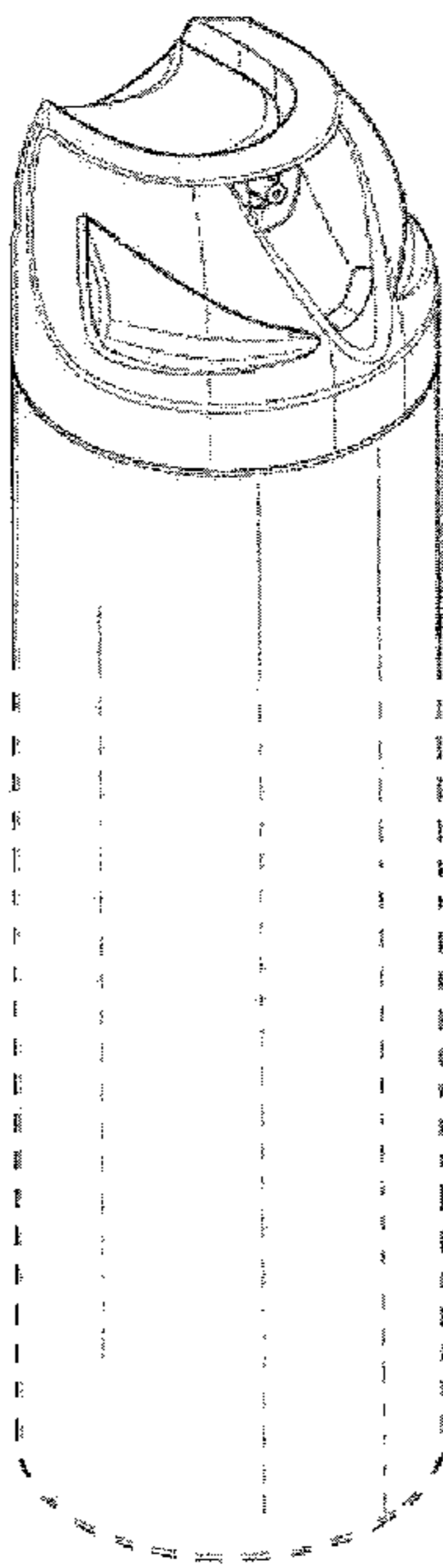
(57) **CLAIM**

The ornamental design for an combined aerosol canister and cap, as shown and described.

**DESCRIPTION**

FIG. 1 is a front and side perspective view of the combined aerosol canister and cap embodying my new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a right side elevational view thereof; FIG. 5 is a left side elevational view of thereof; FIG. 6 is a top plan view thereof; and, FIG. 7 is a bottom plan view thereof. The broken lines shown in FIGS. 8-12 are for illustrative purposes only, and form no part of the claimed design.

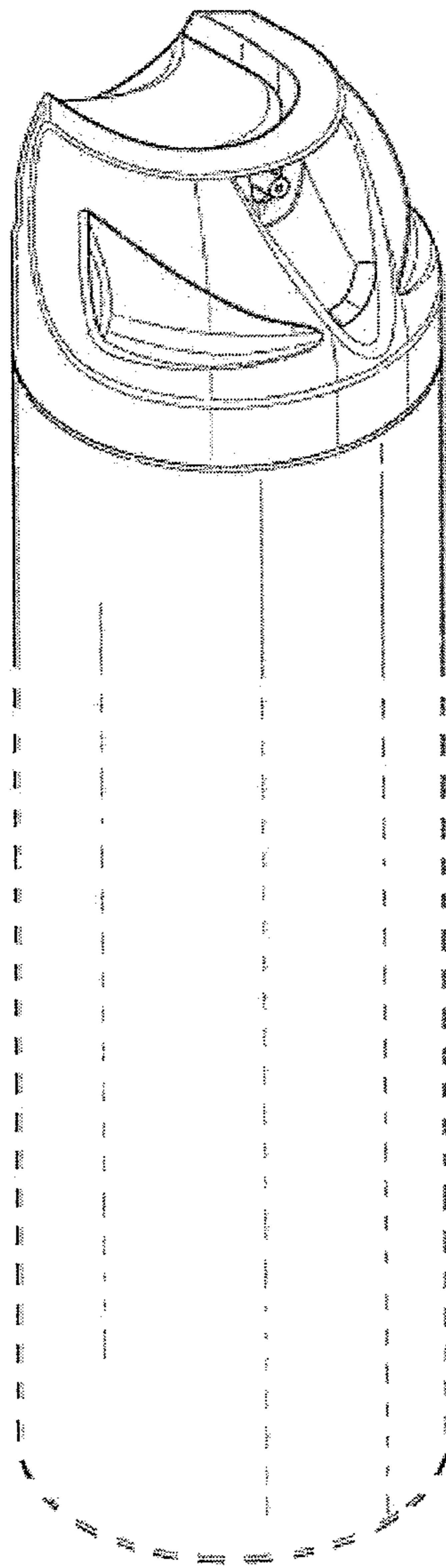

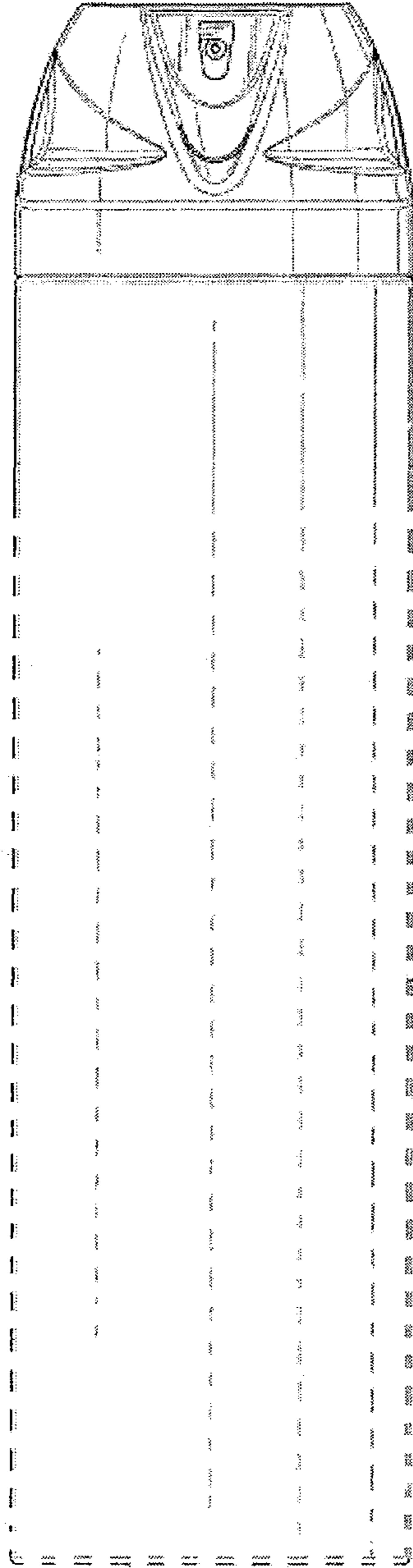

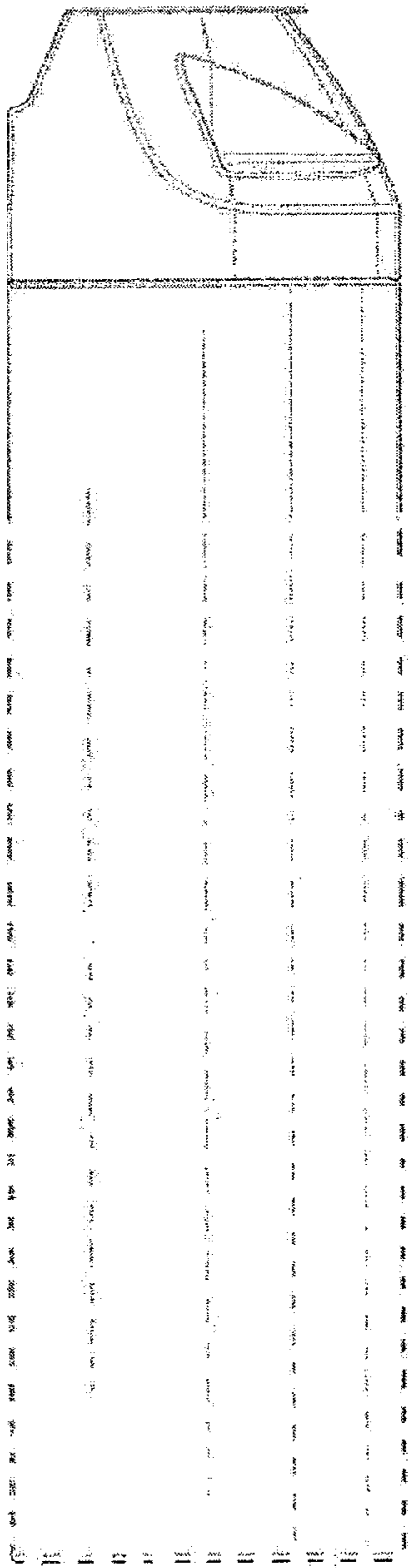

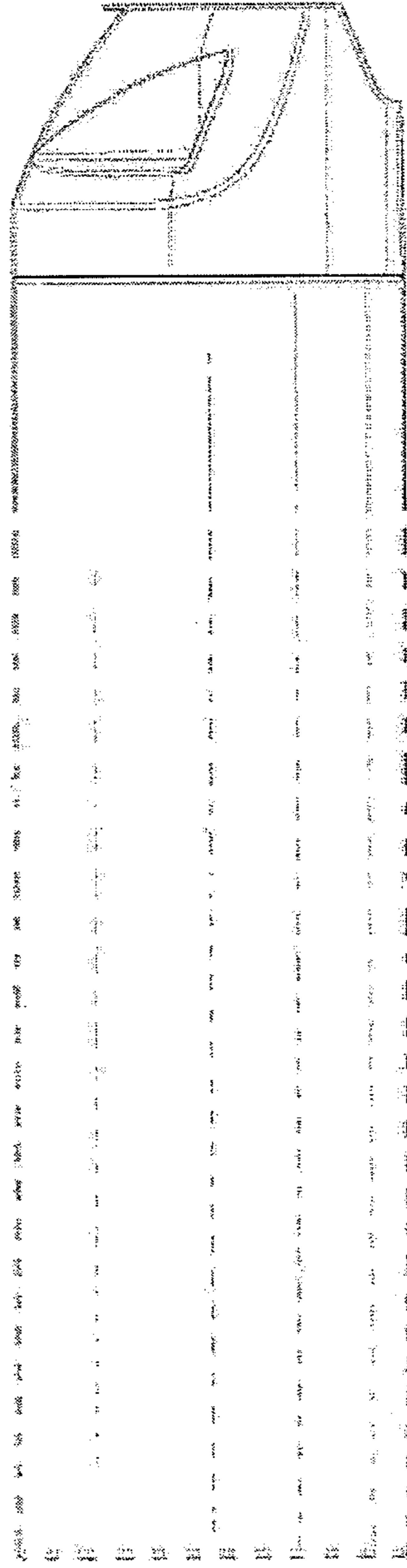

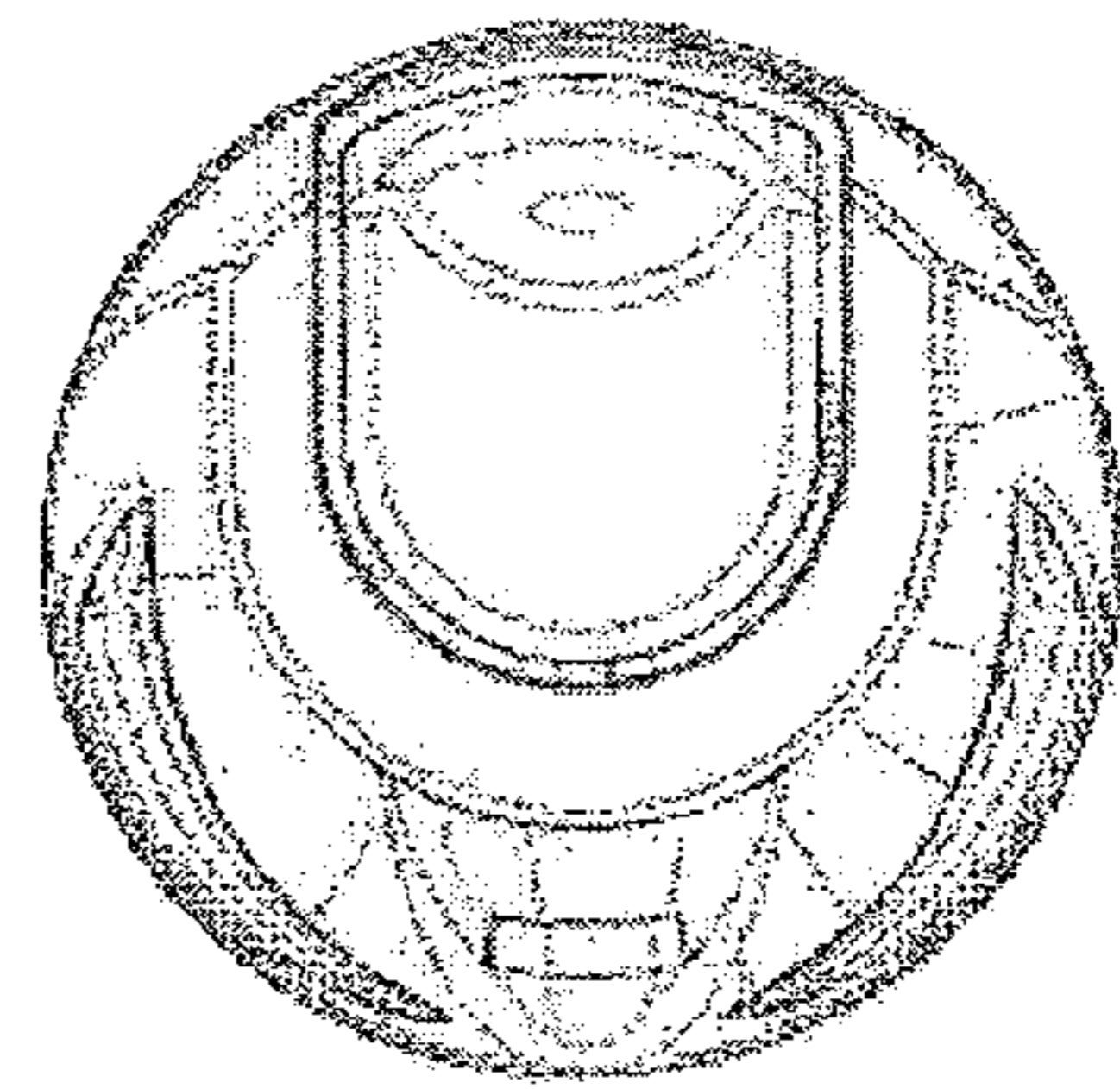

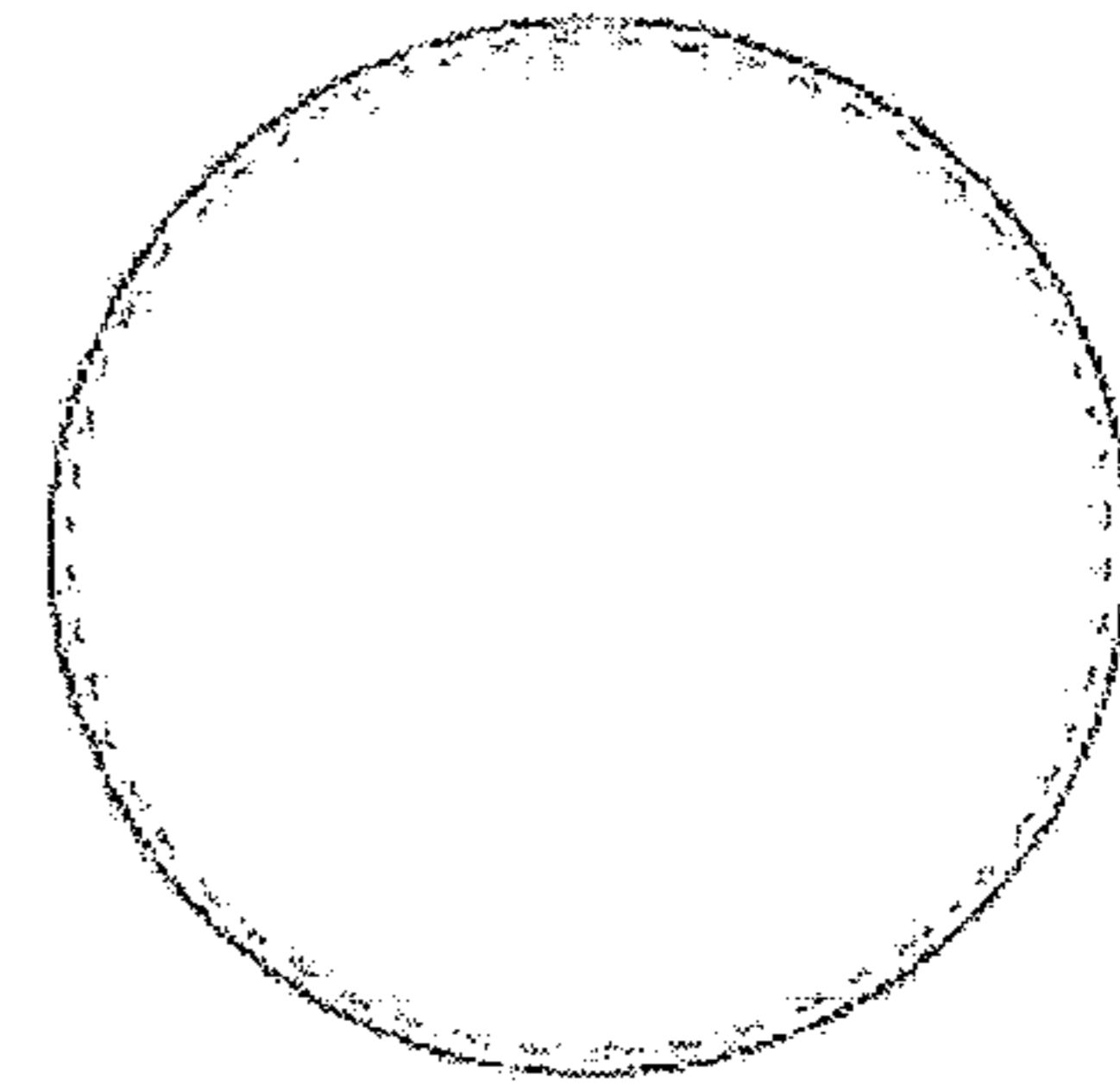
