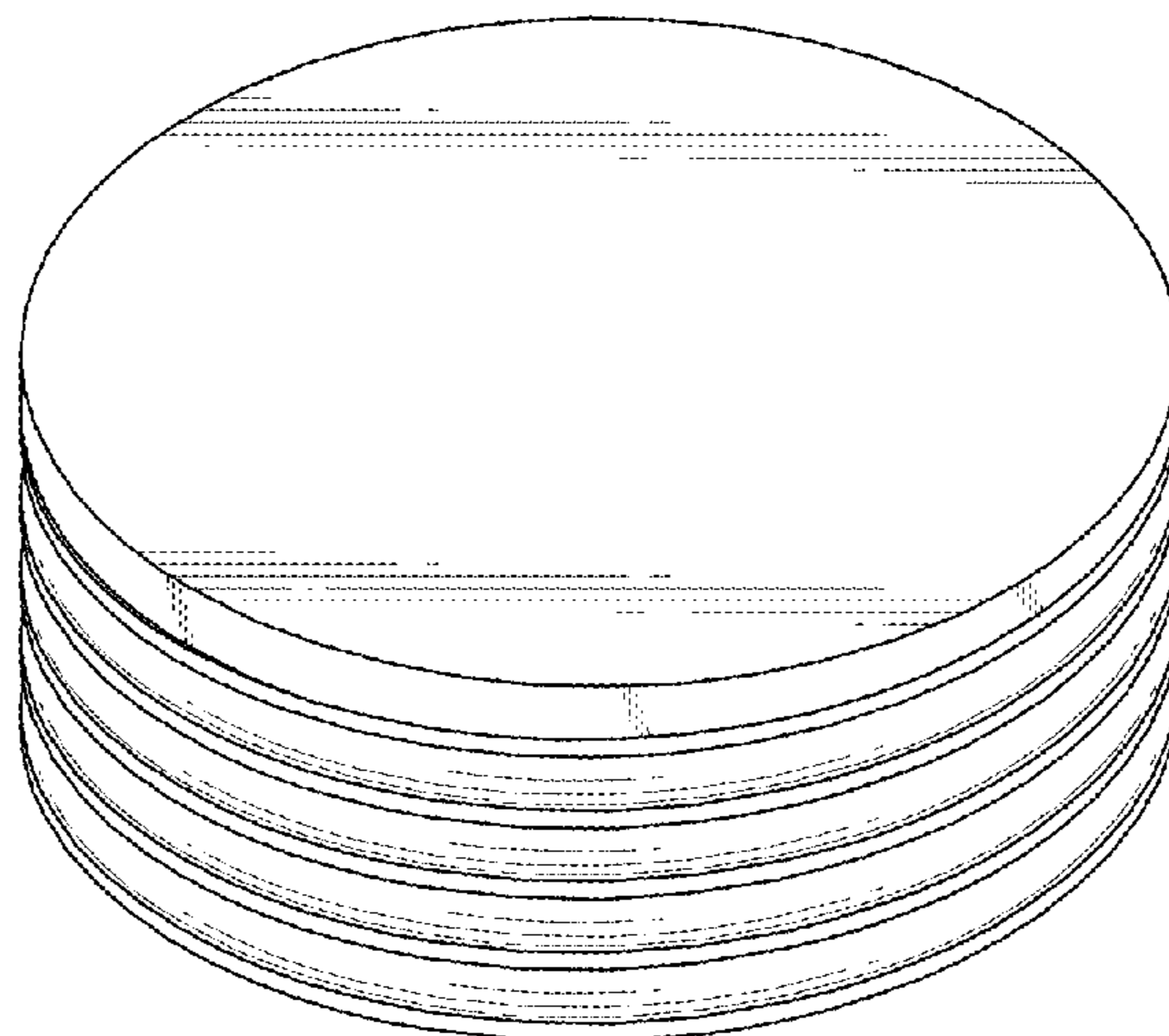
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a motor shell showing our new design.
FIG. 2 is a front elevational view of the motor shell.
FIG. 3 is a rear elevational view of the motor shell.
FIG. 4 is a left-side, elevational view of the motor shell.
FIG. 5 is a right-side, elevational view of the motor shell.
FIG. 6 is a top plan view of the motor shell.
FIG. 7 is a bottom plan view of the motor shell; and,
FIG. 8 is a cross-sectional view of the motor shell, taken along line 8-8 of FIG. 2.

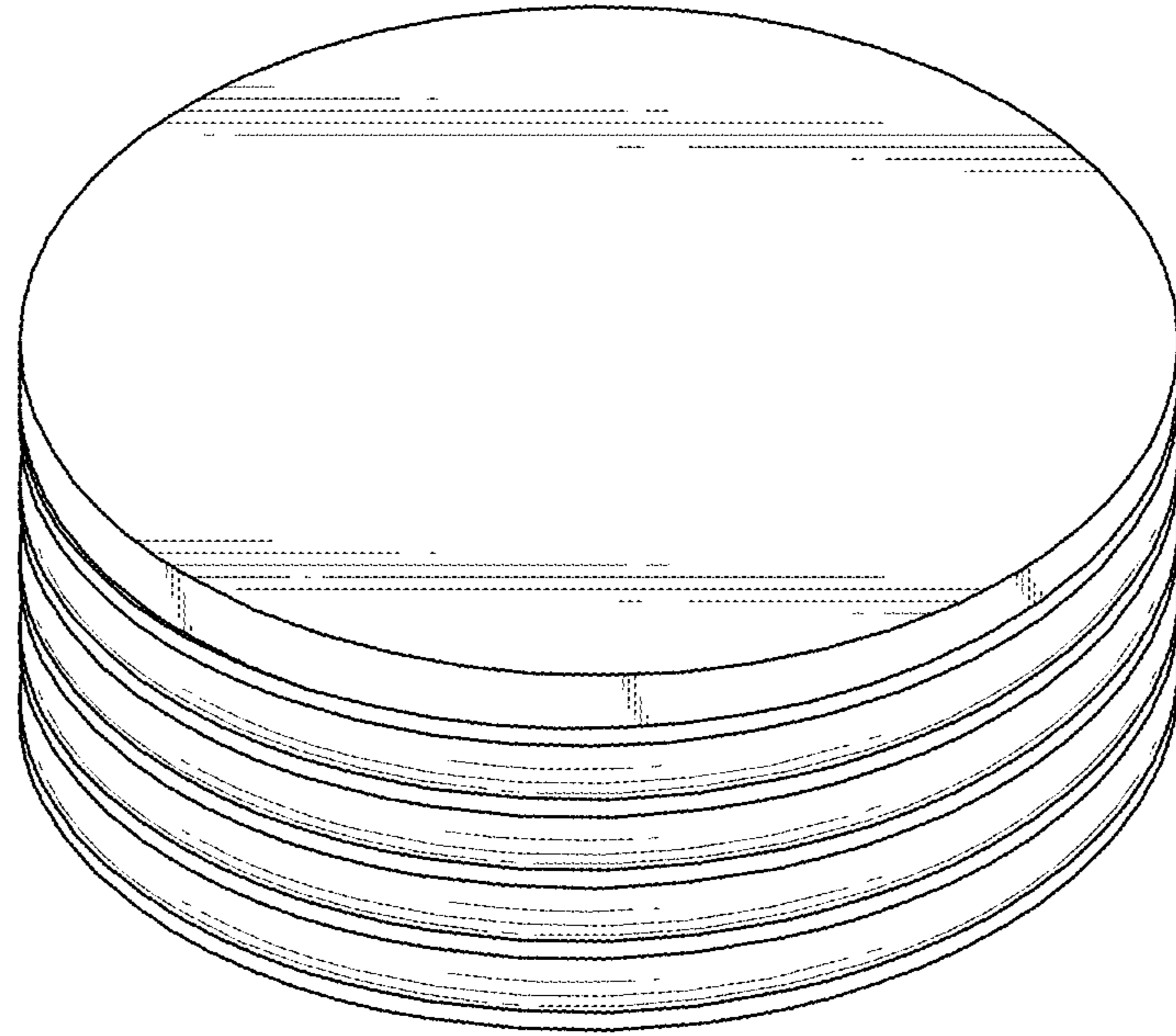

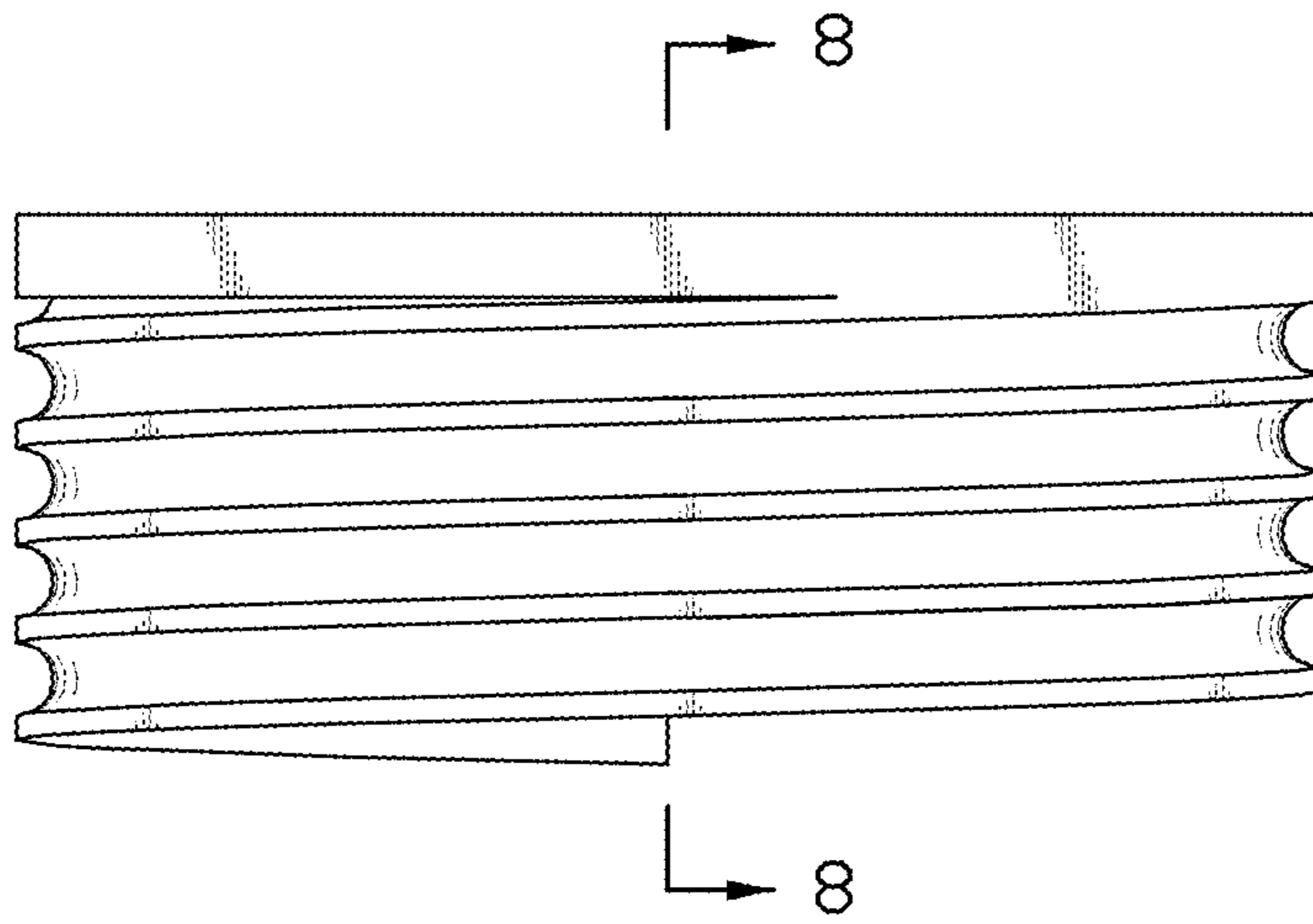

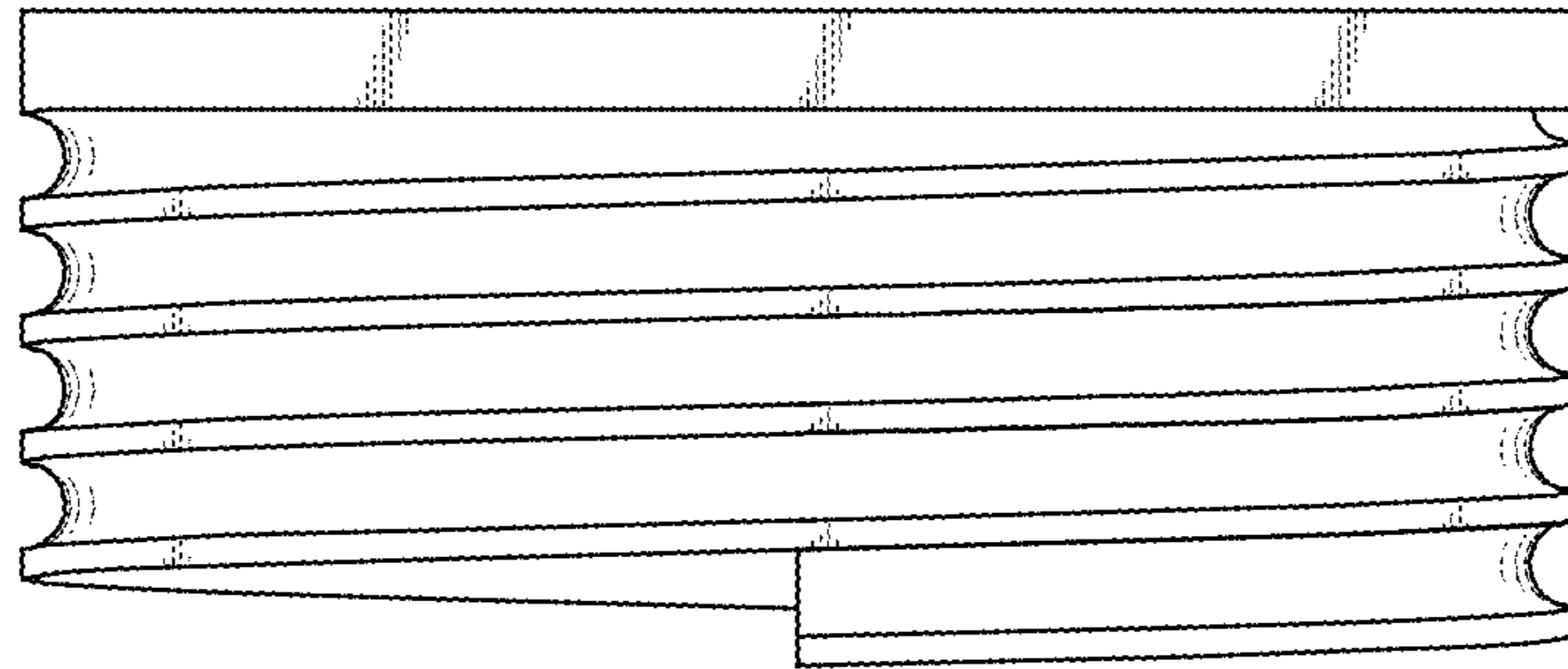

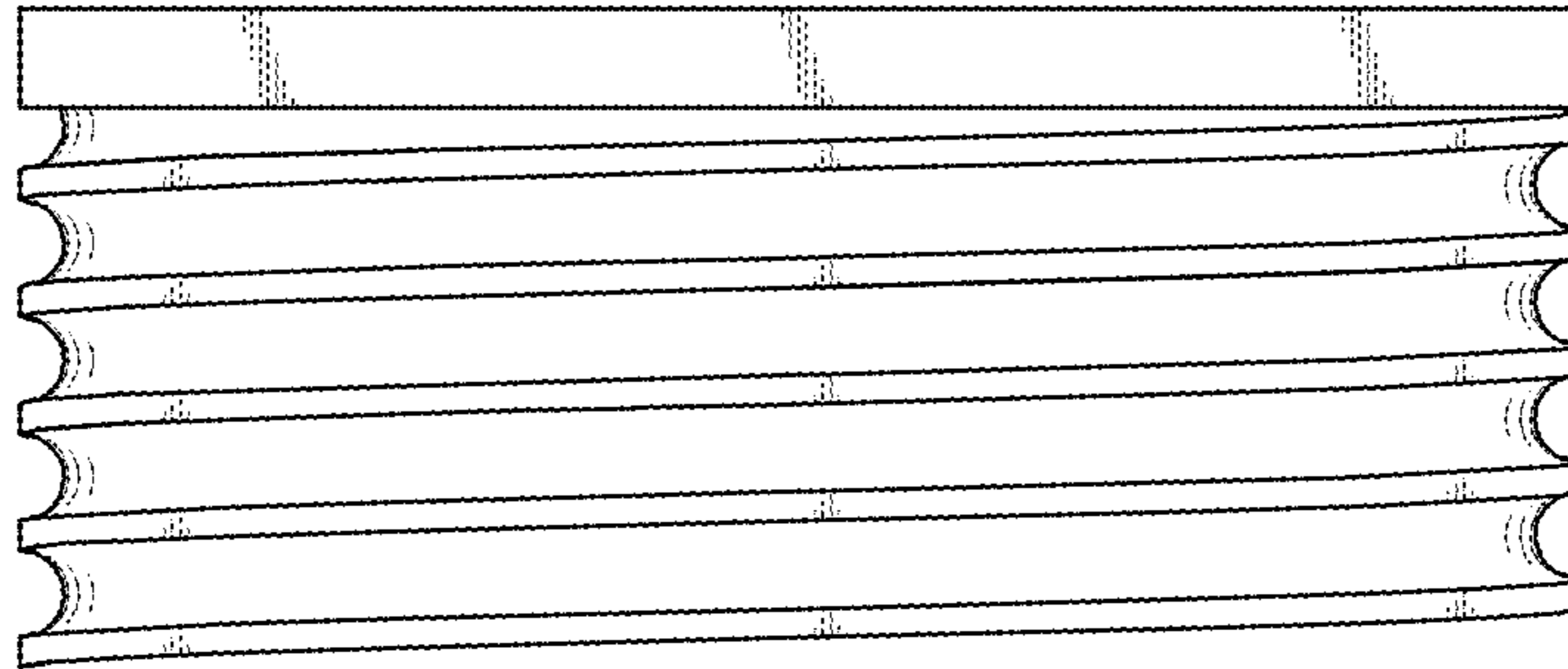

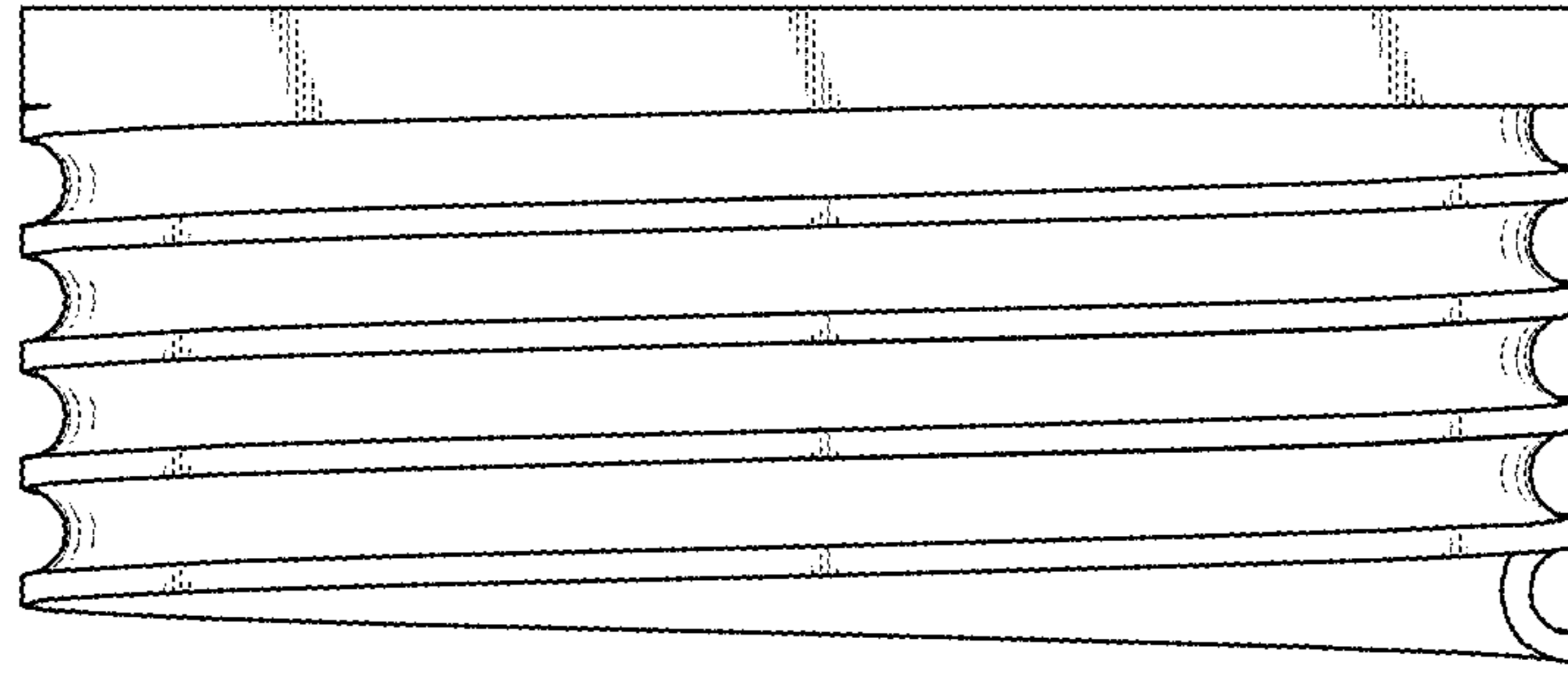

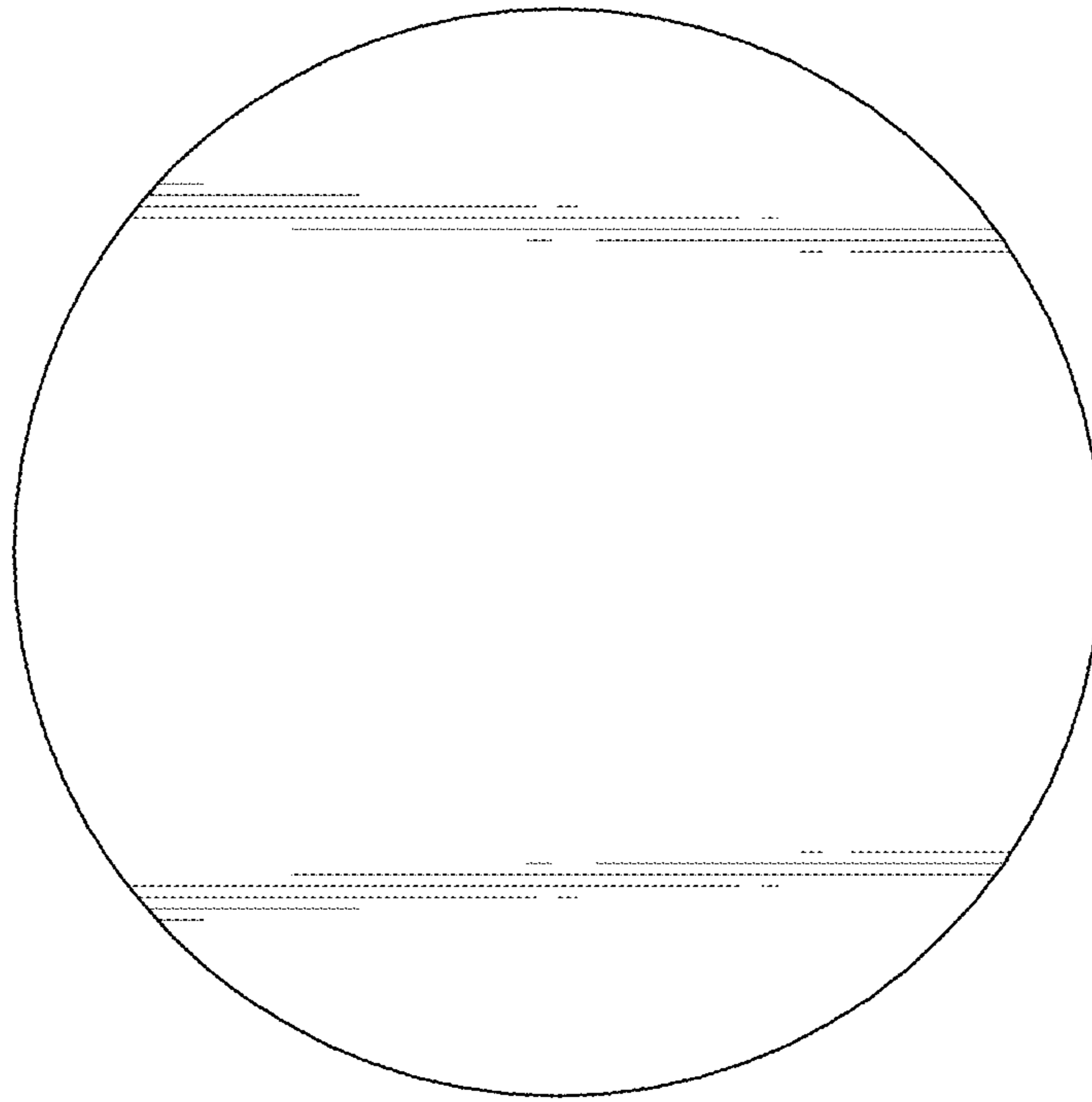

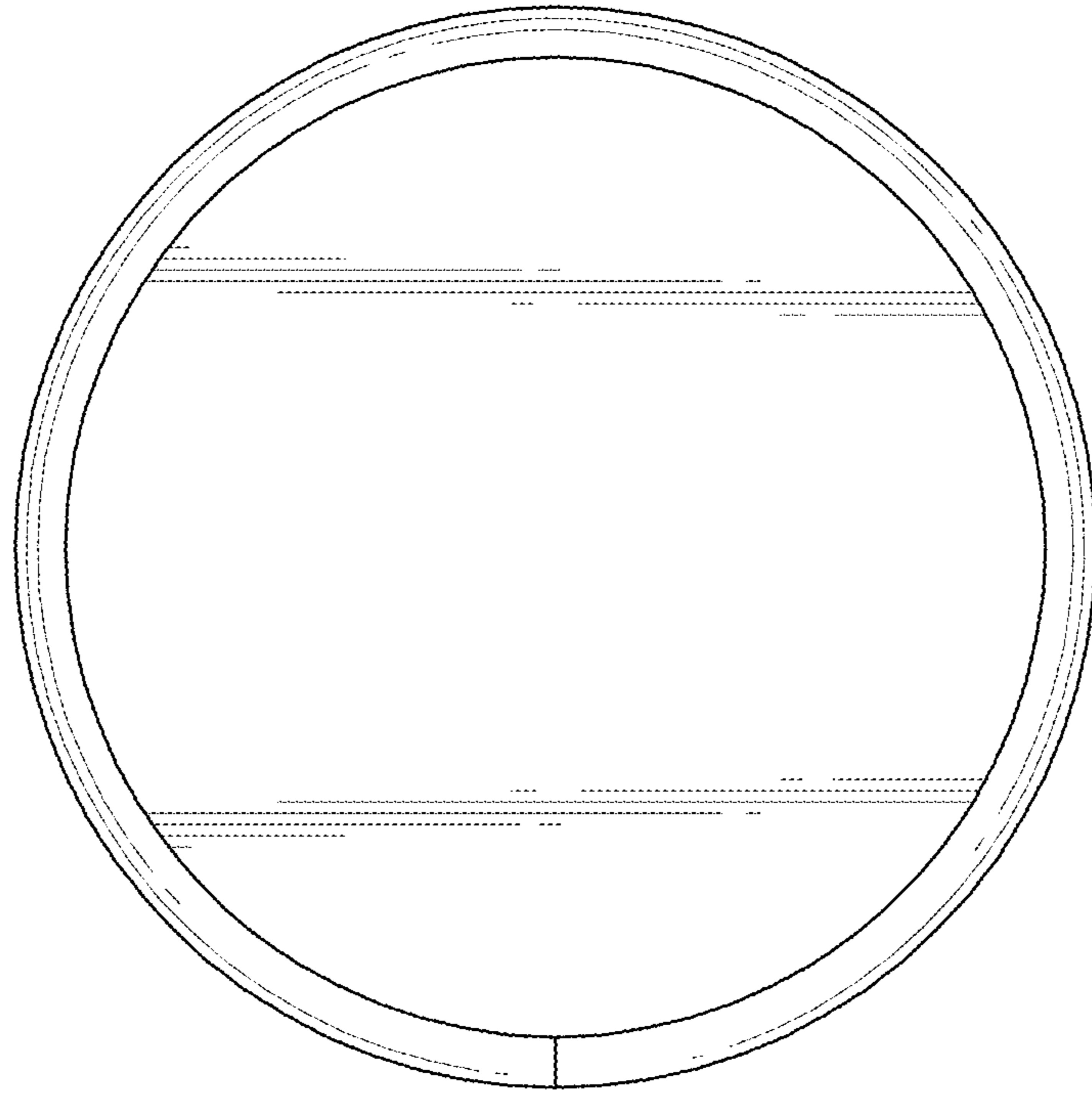

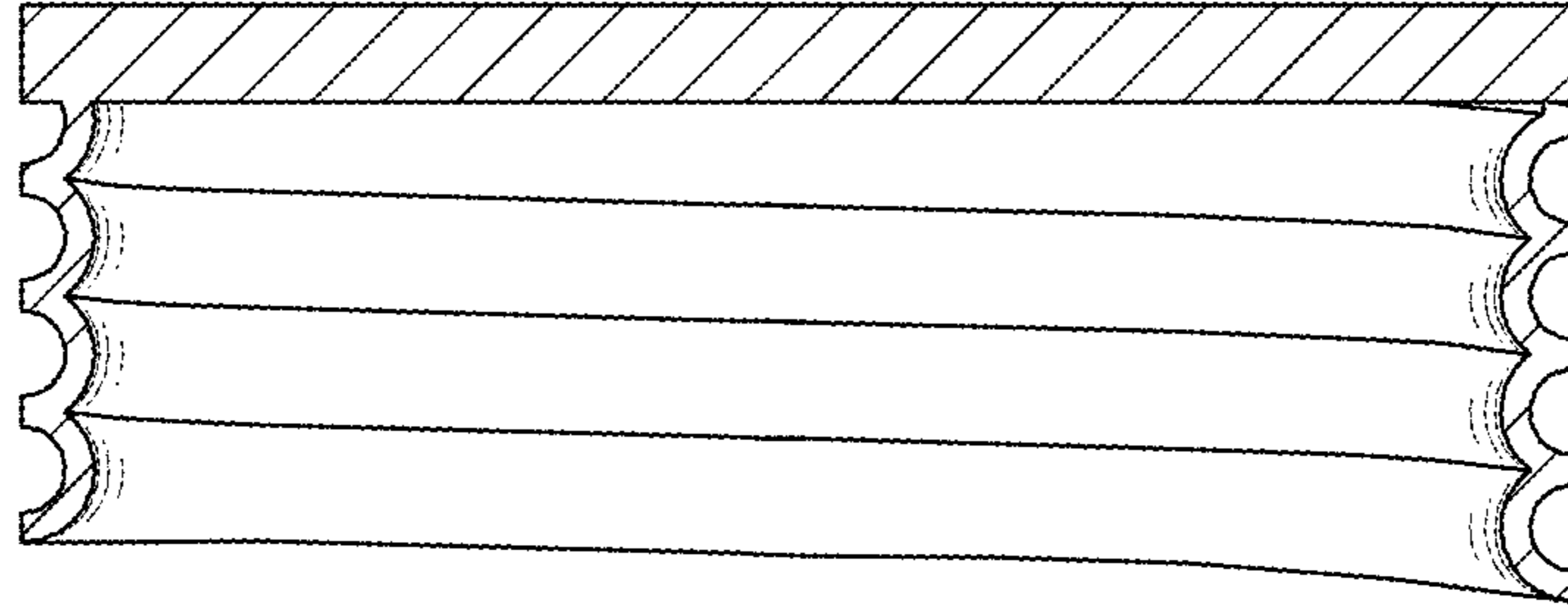
