(57) **CLAIM**

I claim the ornamental design for an audio enunciator cover frame, as shown and described.

DESCRIPTION

FIG. 1 is a first perspective view showing a first embodiment of my new design comprising an audio enunciator cover frame;

FIG. 2 is a second perspective view of the audio enunciator cover frame of FIG. 1, rotated clockwise ninety degrees;

FIG. 3 is a third perspective view of the audio enunciator cover frame of FIG. 2, rotated clockwise ninety degrees;

FIG. 4 is a fourth perspective view of the audio enunciator cover frame of FIG. 3, rotated clockwise ninety degrees;

FIG. 5 is a side elevational view of the audio enunciator cover frame of FIG. 1, the other side view being identical thereto;

FIG. 6 is a front elevational view of the audio enunciator cover frame of FIG. 1, the rear elevational view being identical thereto;

FIG. 7 is a top plan view of the audio enunciator cover frame of FIG. 1;

FIG. 8 is a bottom plan view of the audio enunciator cover frame of FIG. 1;

FIG. 9 is a first perspective view showing a second embodiment of my new design comprising an audio enunciator cover frame;

FIG. 10 is a second perspective view of the audio enunciator cover frame of FIG. 9, rotated clockwise ninety degrees;

FIG. 11 is a third perspective view of the audio enunciator cover frame of FIG. 10, rotated clockwise ninety degrees;

FIG. 12 is a fourth perspective view of the audio enunciator cover frame of FIG. 11, rotated clockwise ninety degrees;

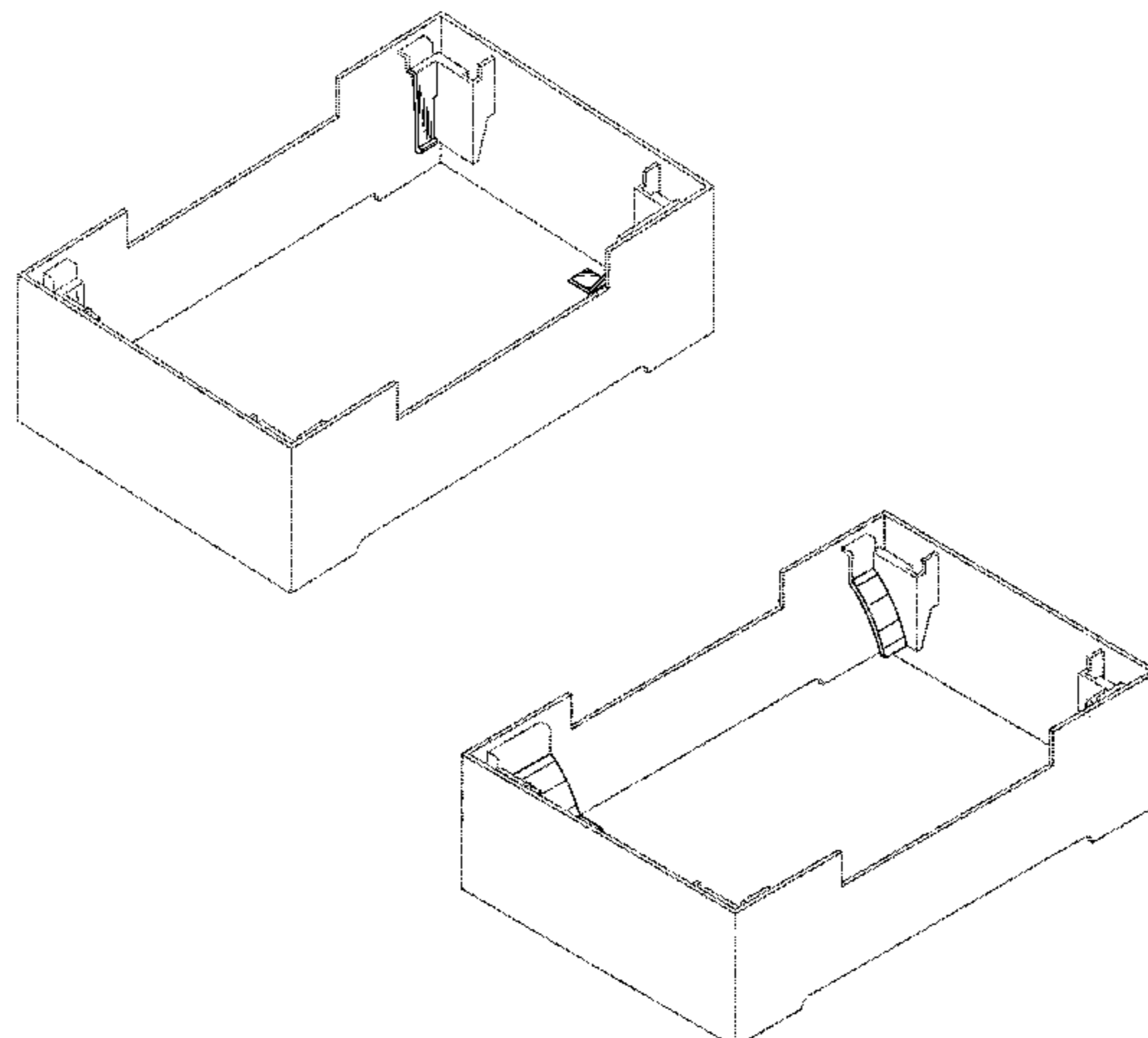


FIG. 13 is a side elevational view of the audio enunciator cover frame of FIG. 9, the other side view being identical thereto;

FIG. 23 is a top plan view of the audio enunciator cover frame of FIG. 17; and,

FIG. 24 is a bottom plan view of the audio enunciator cover frame of FIG. 17.

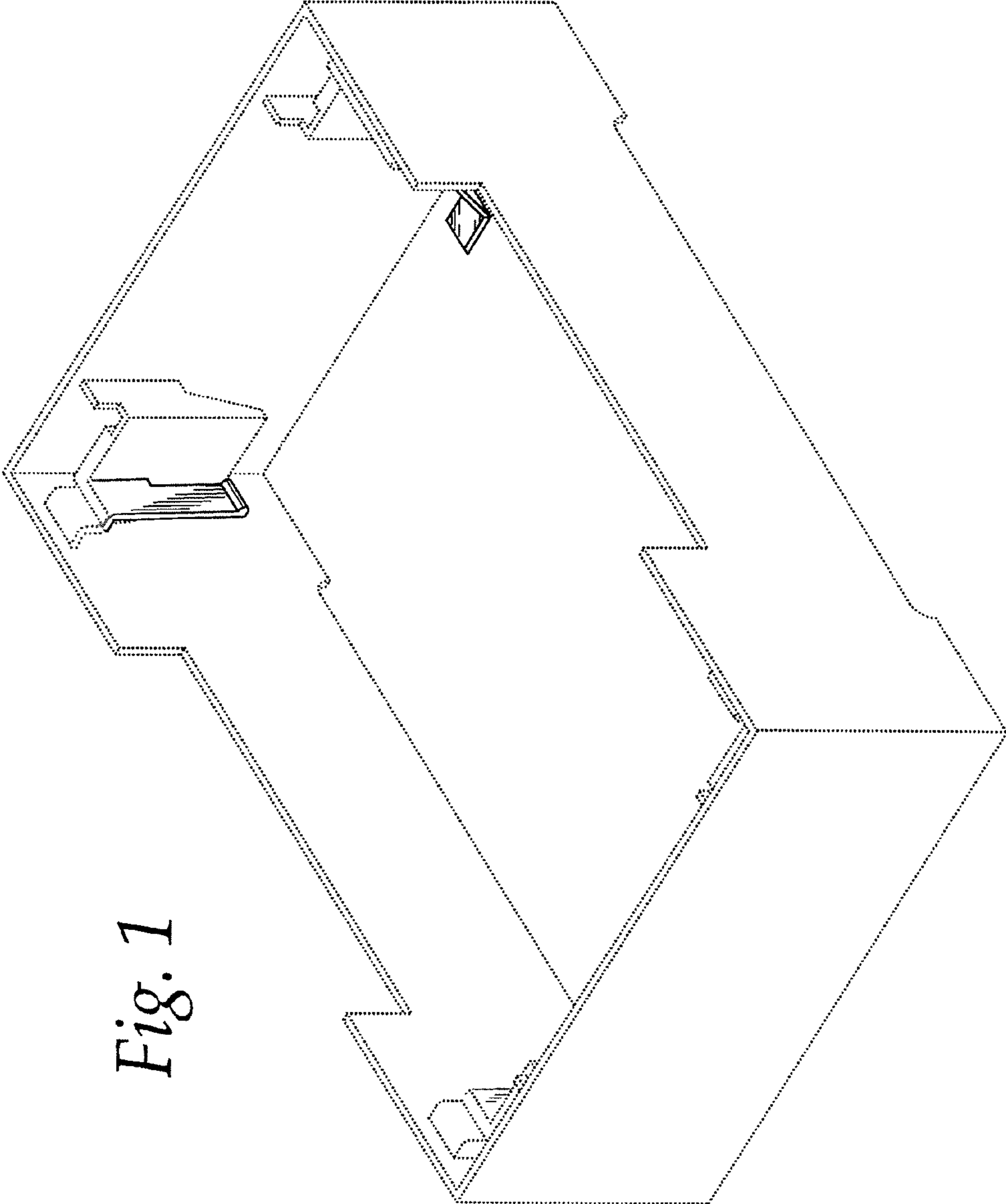

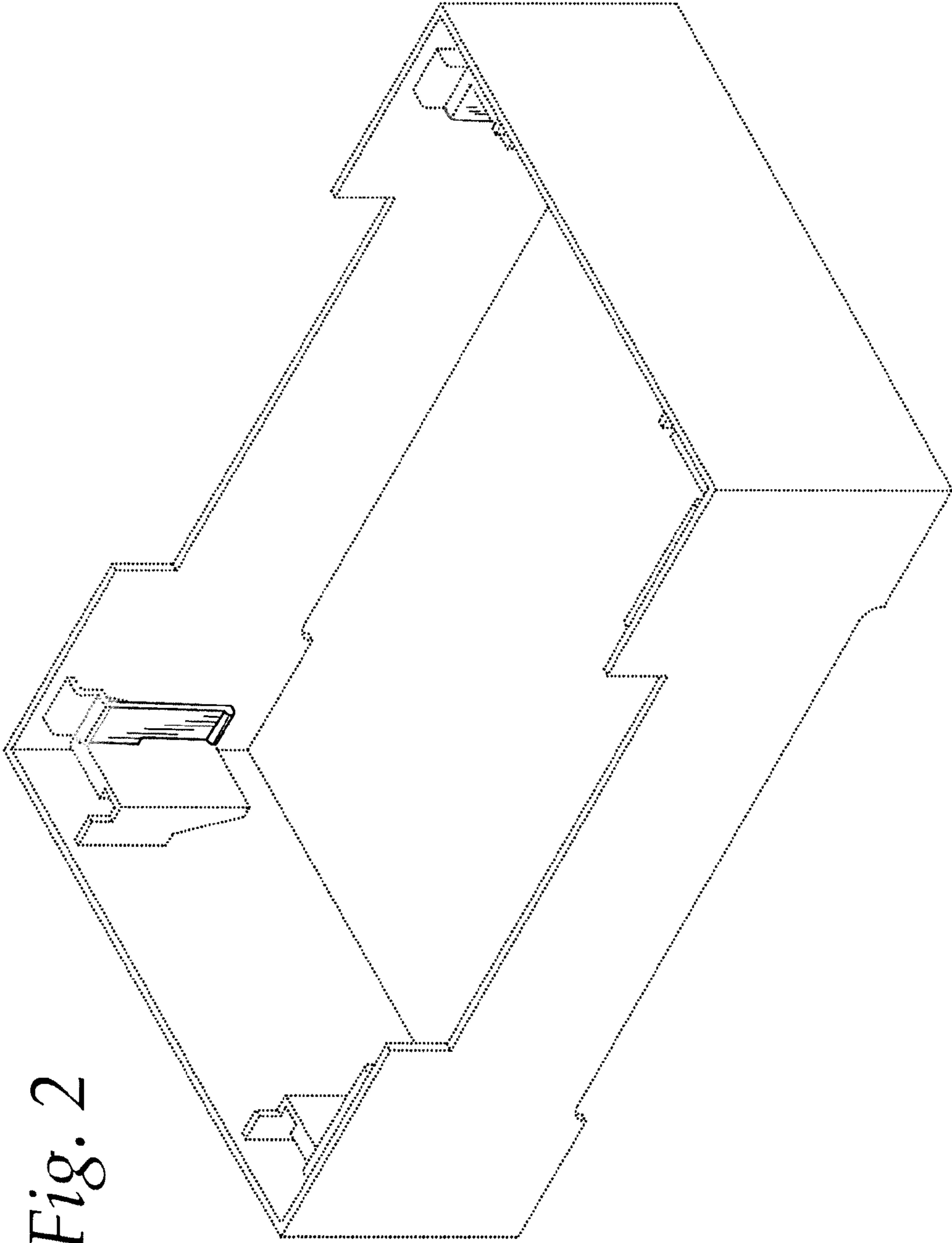

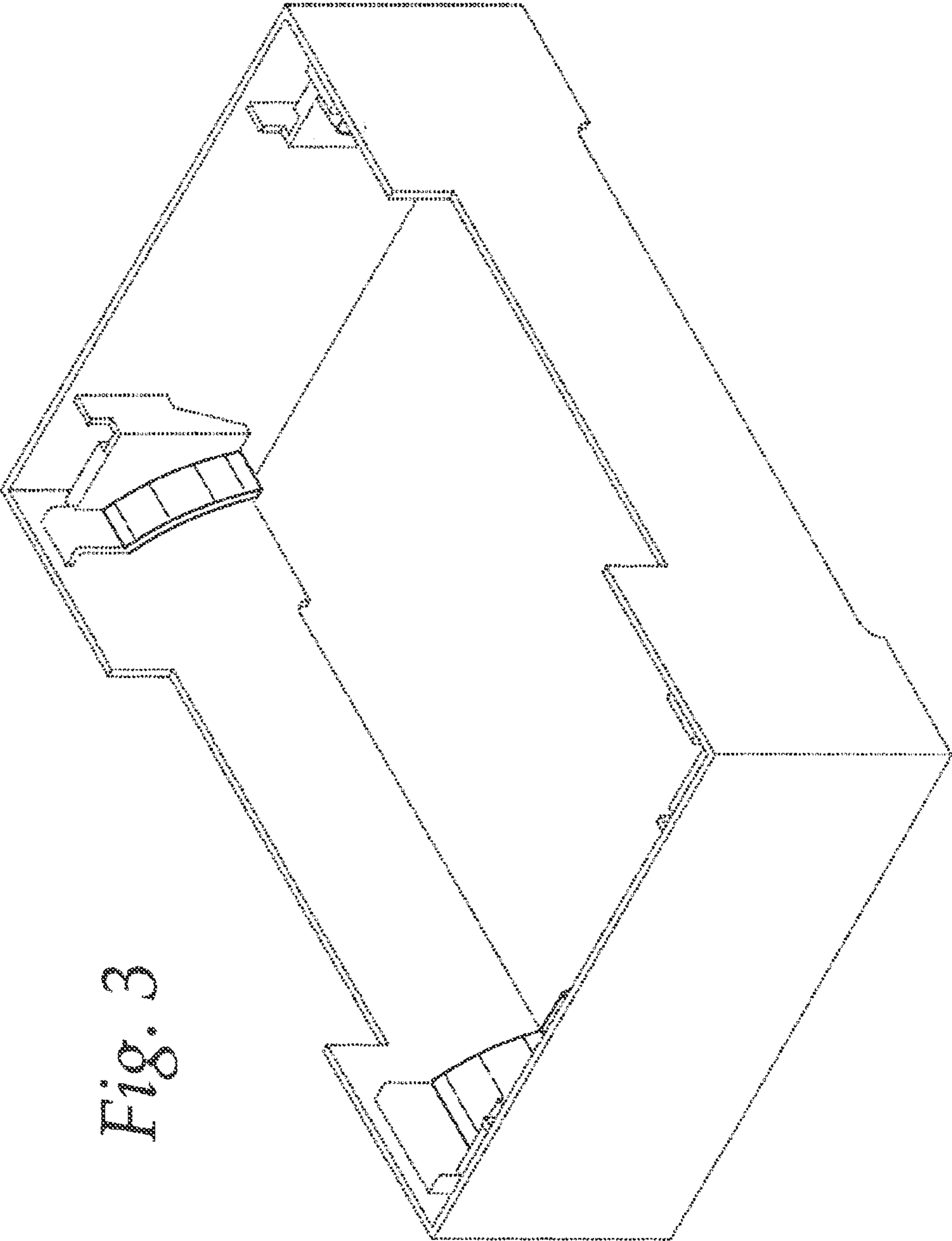
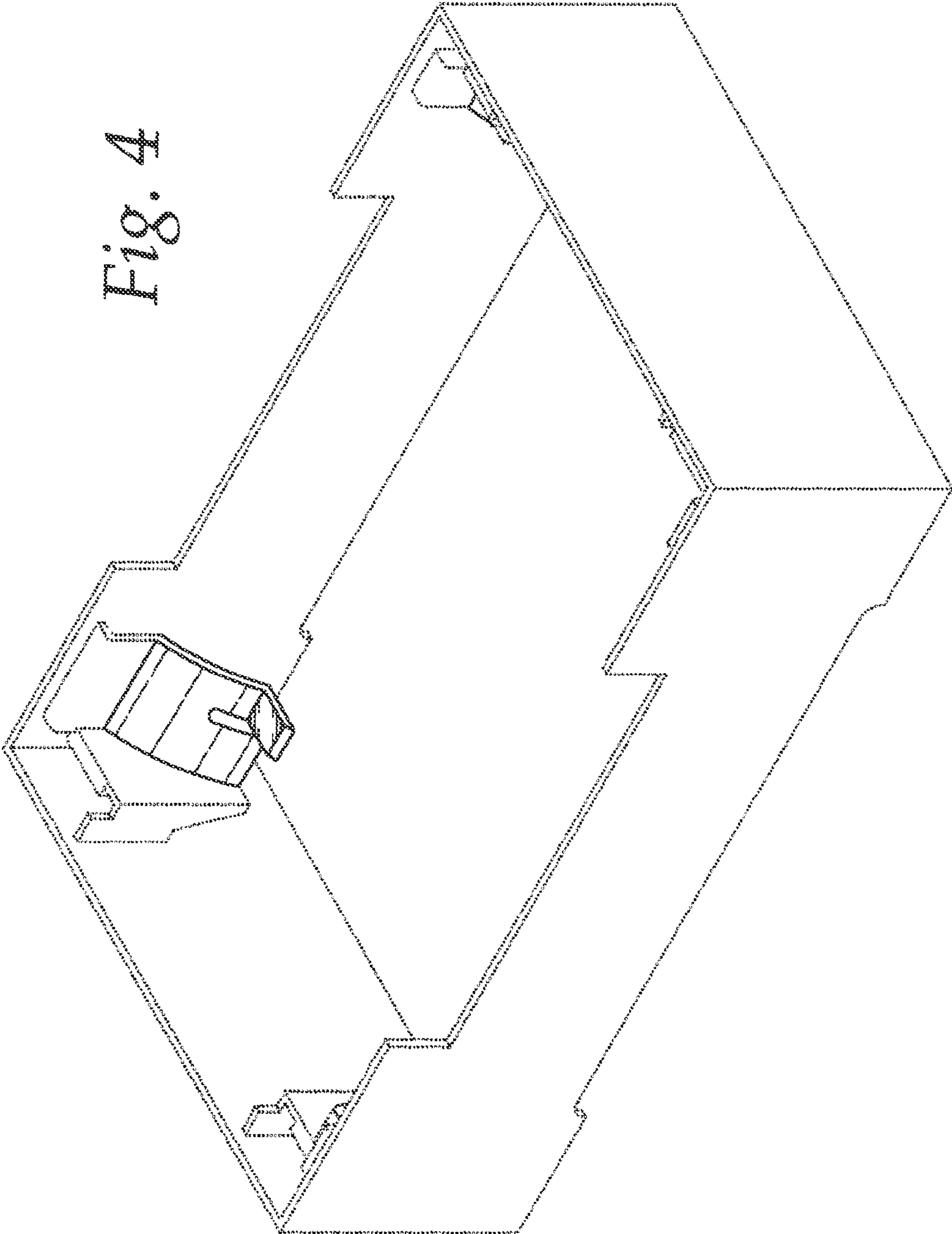

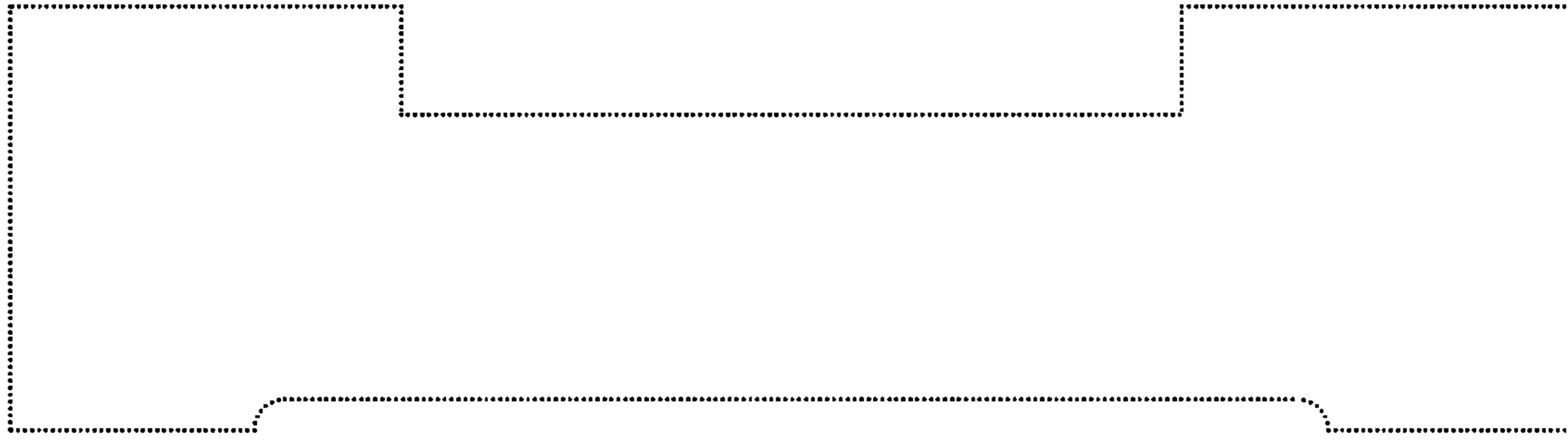

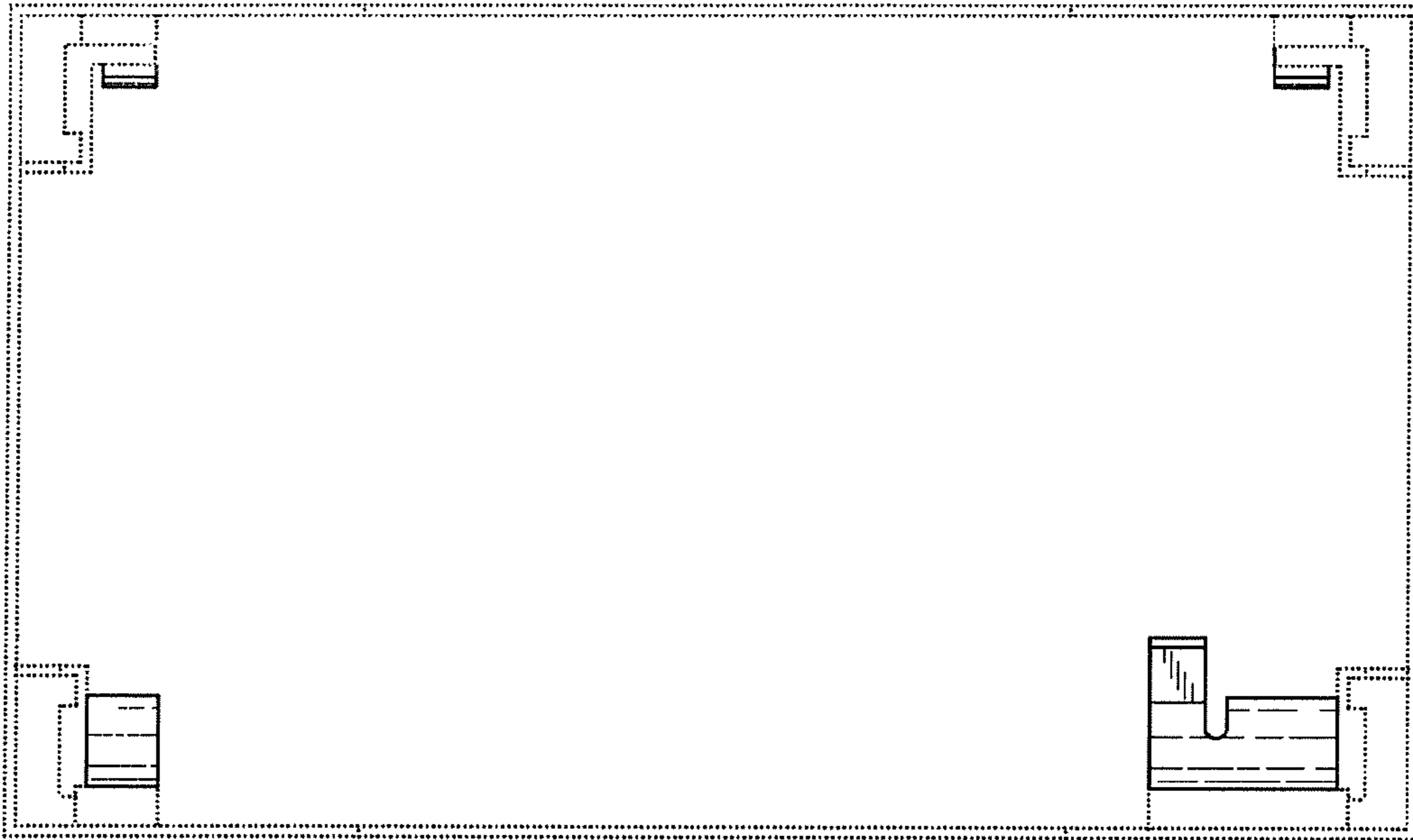

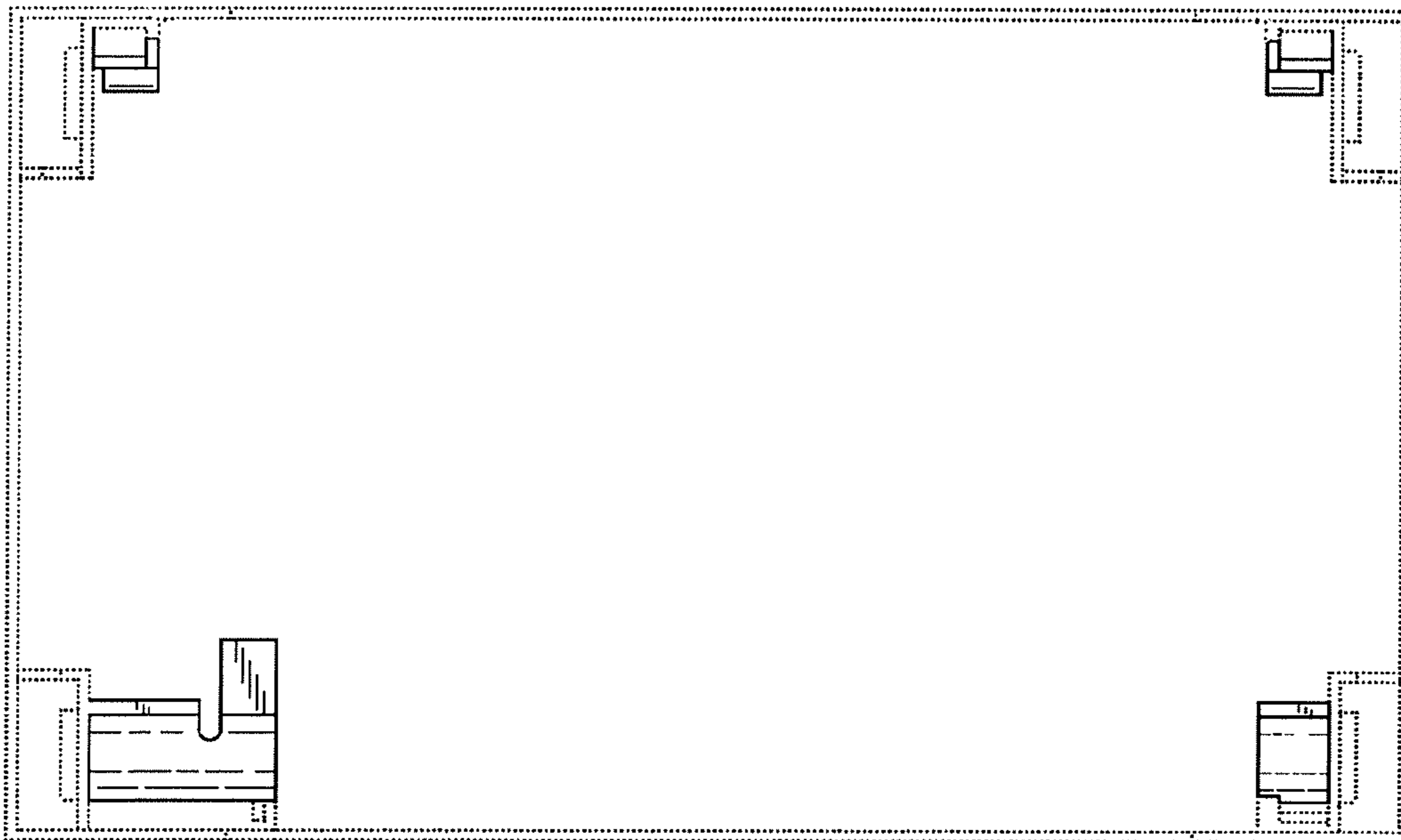

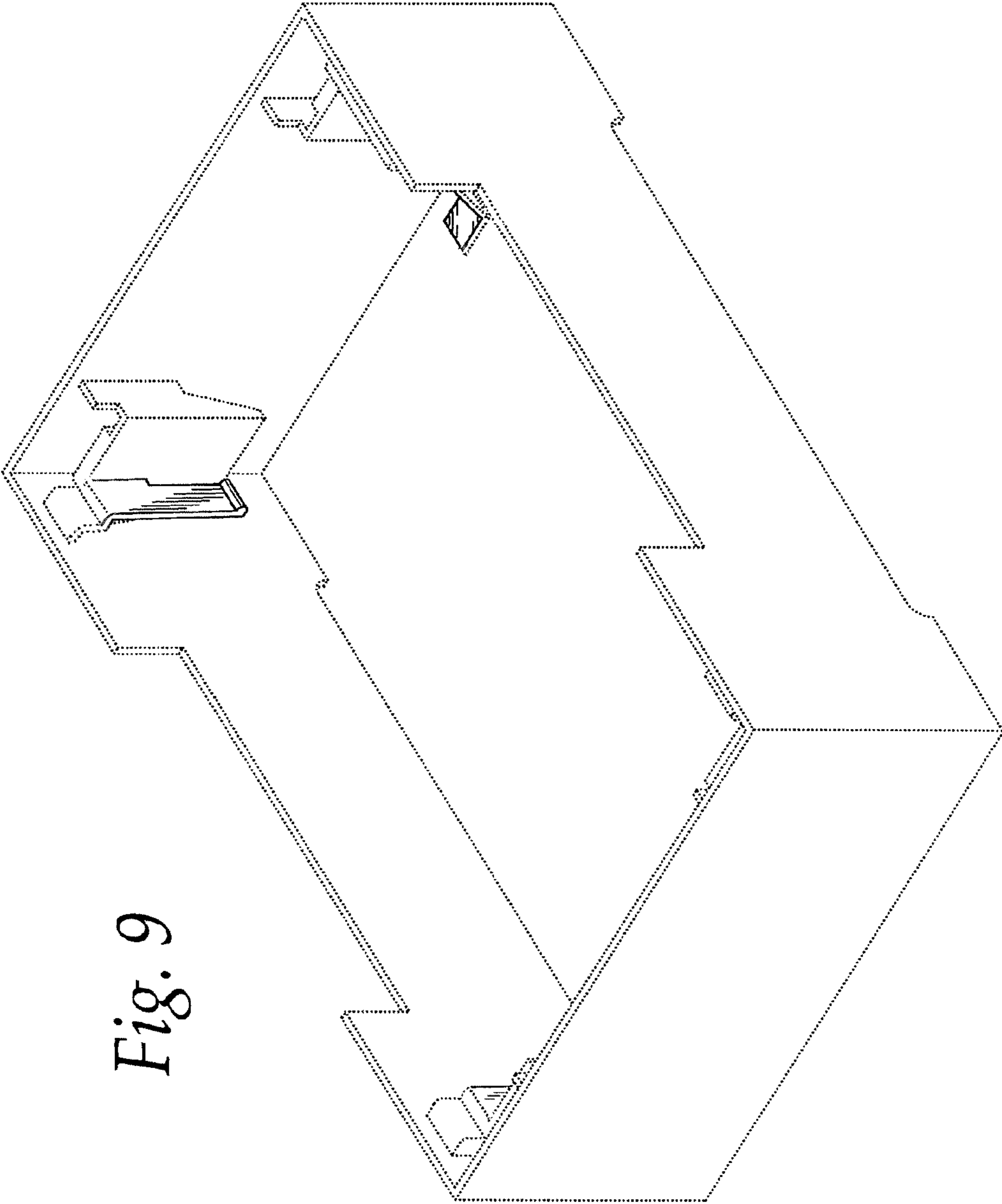

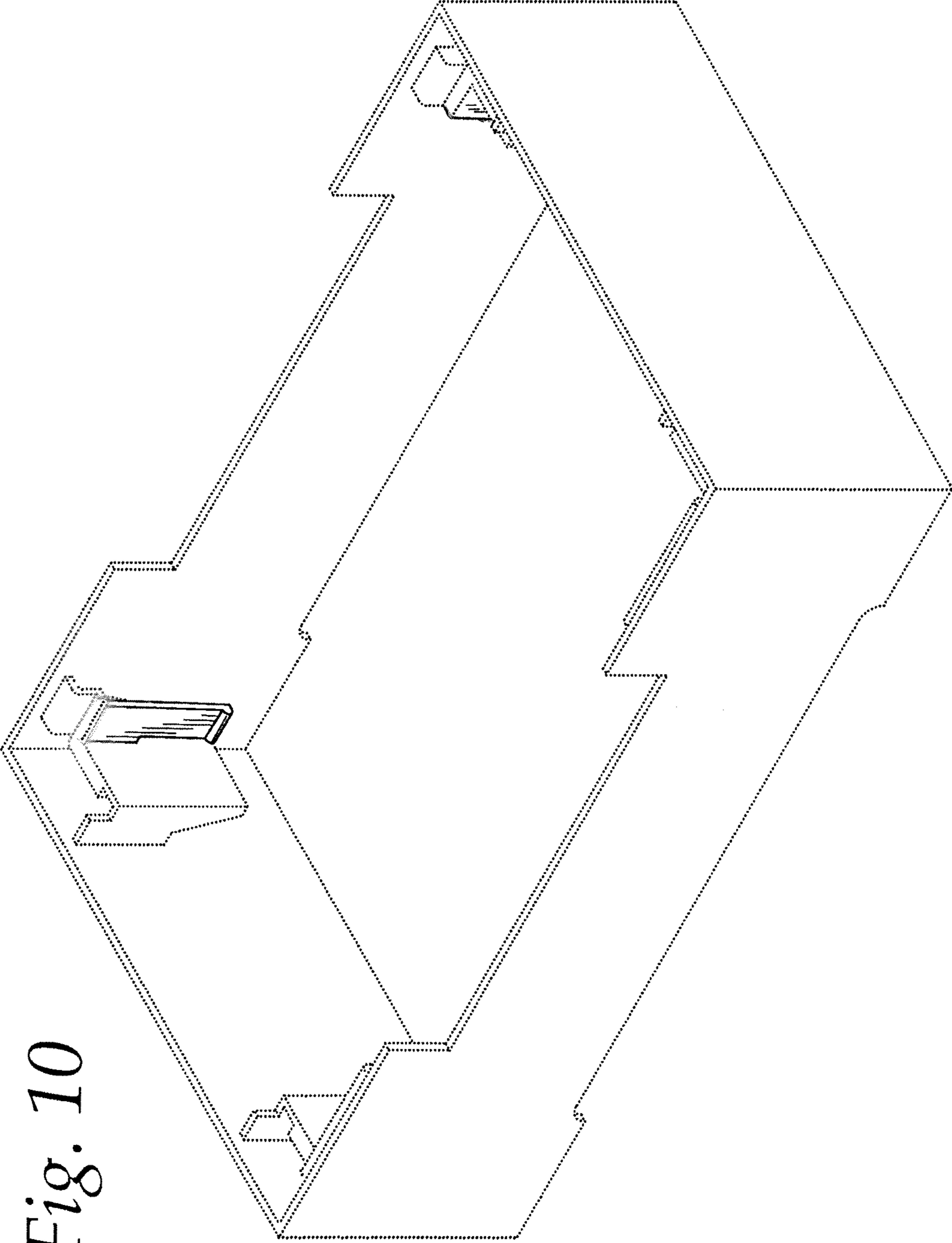

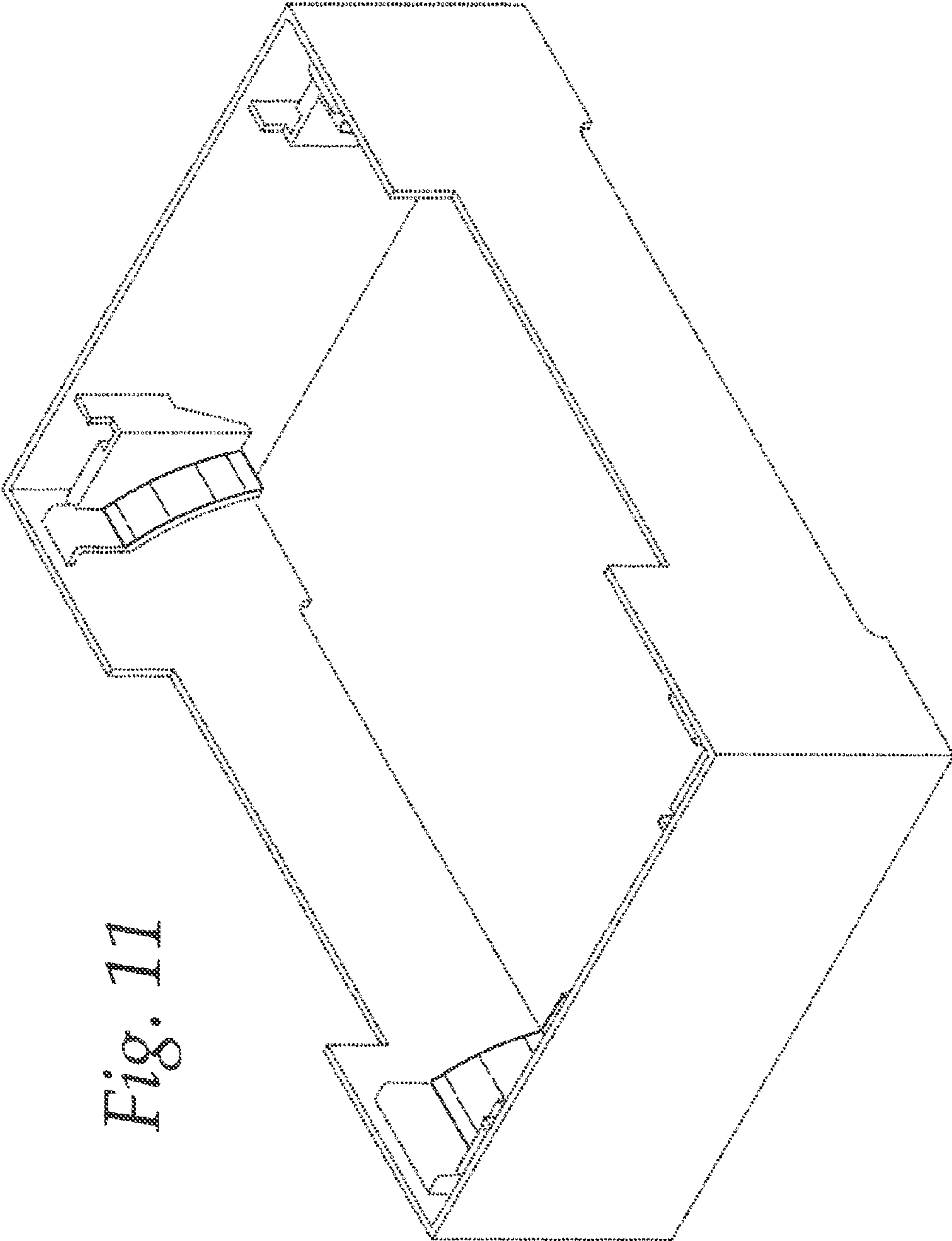
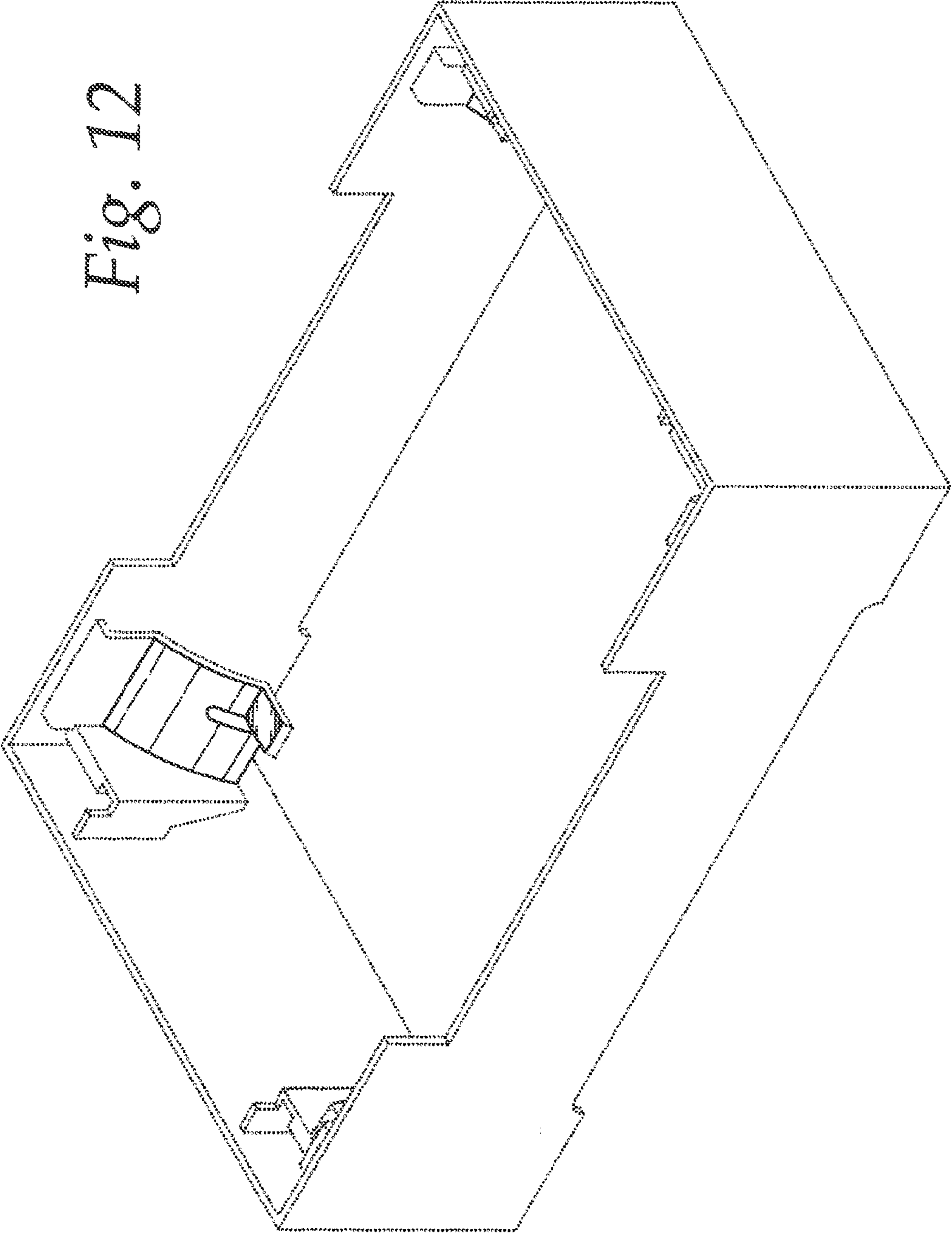

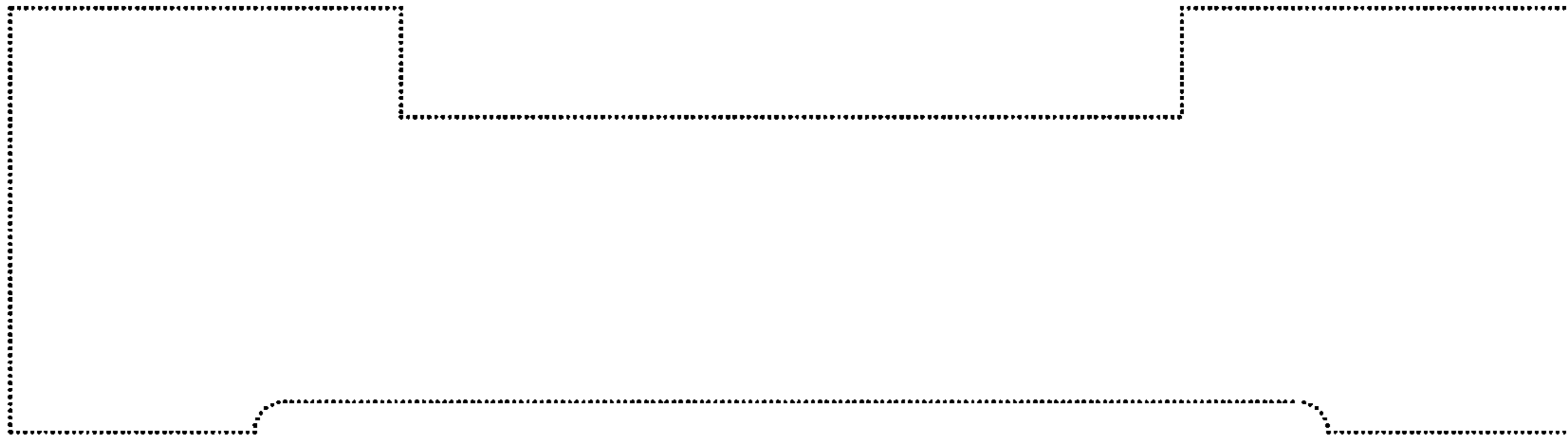

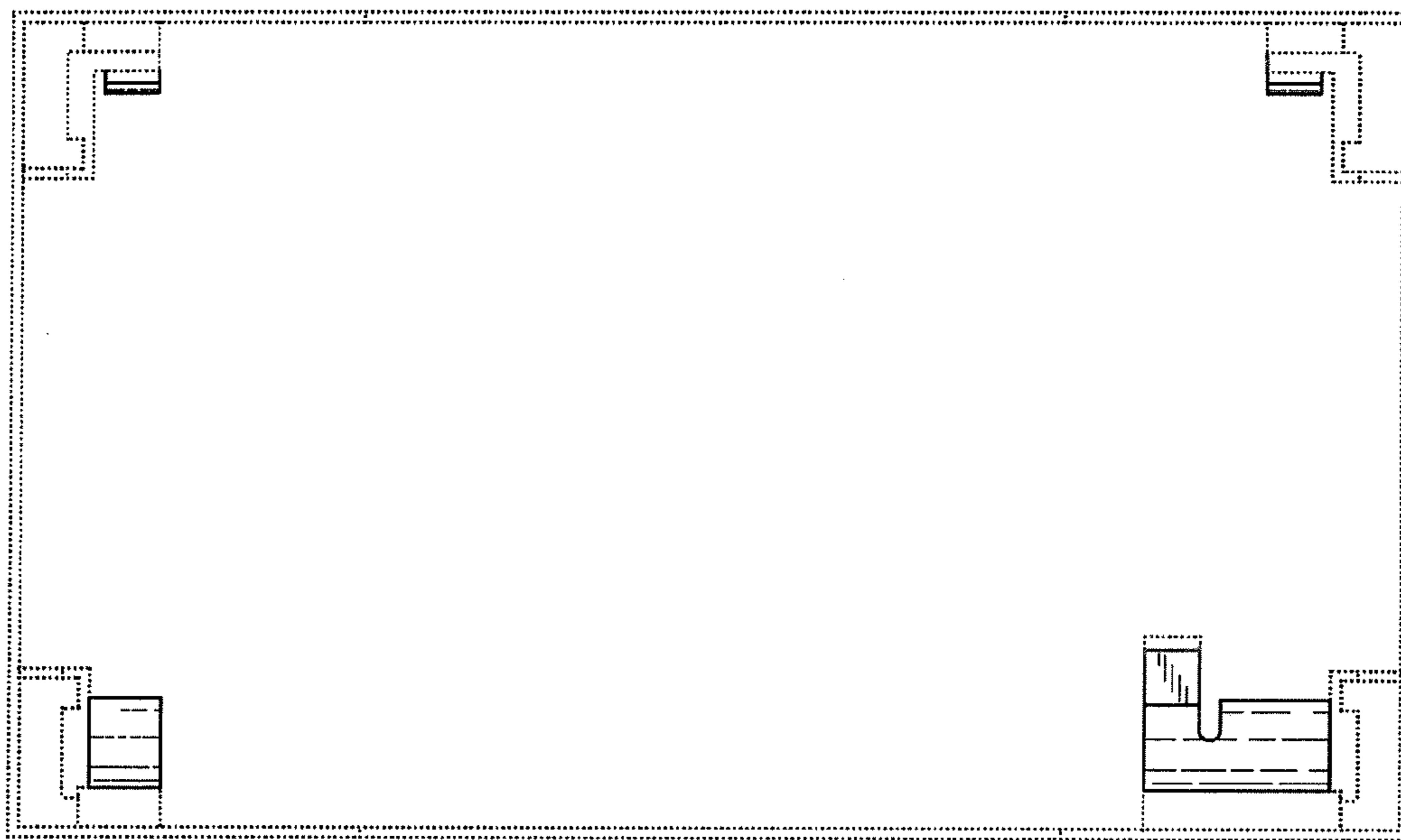

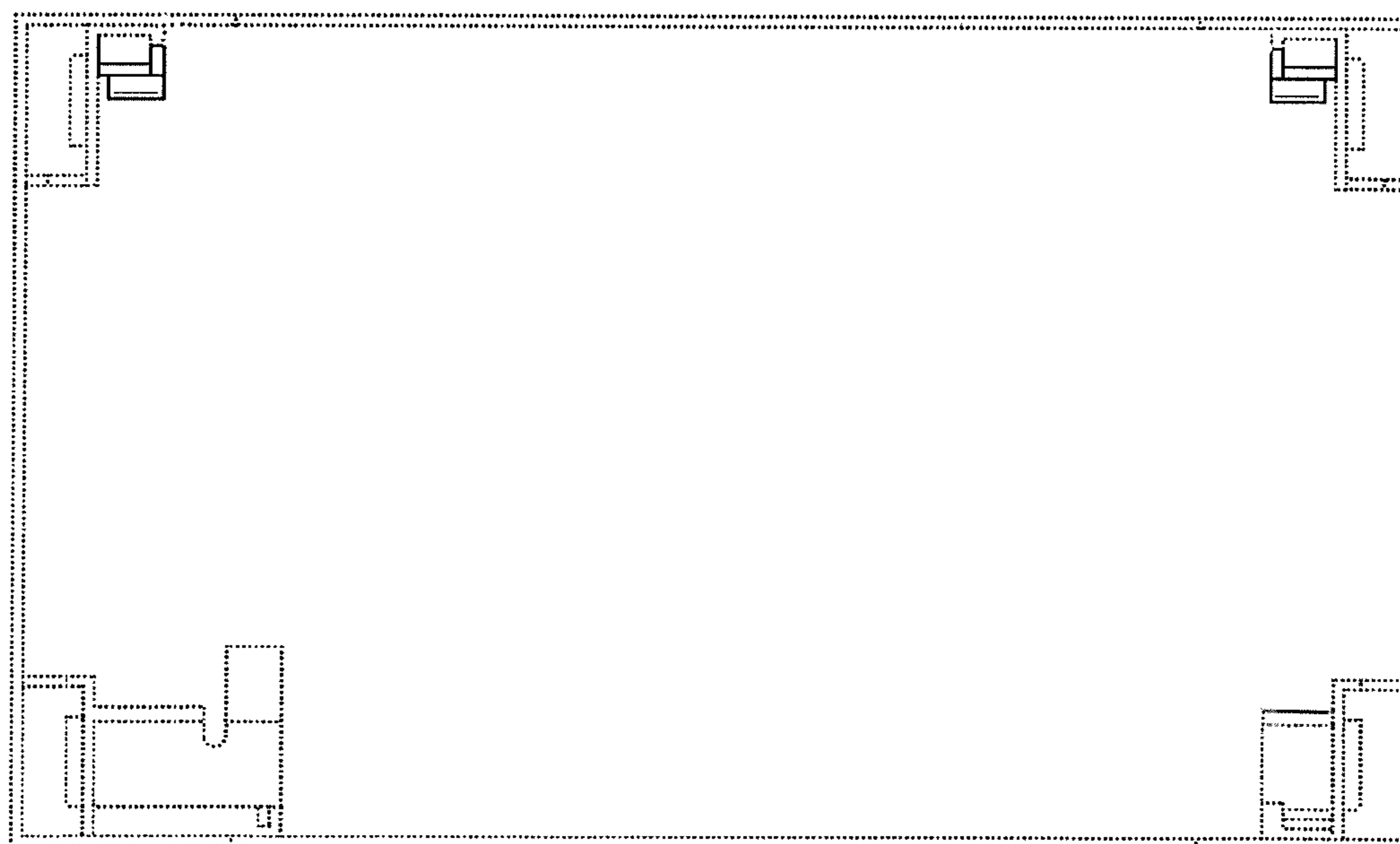

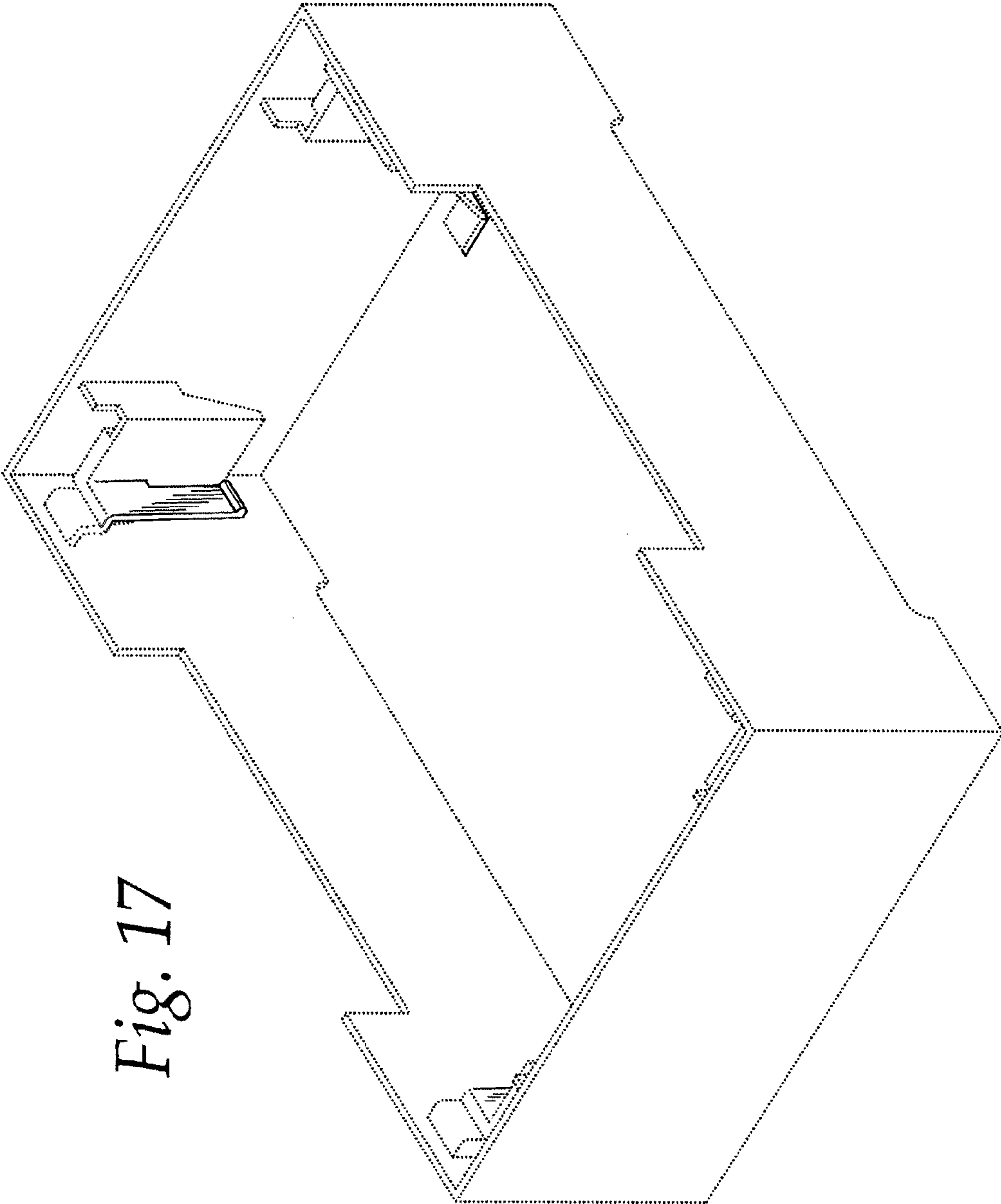

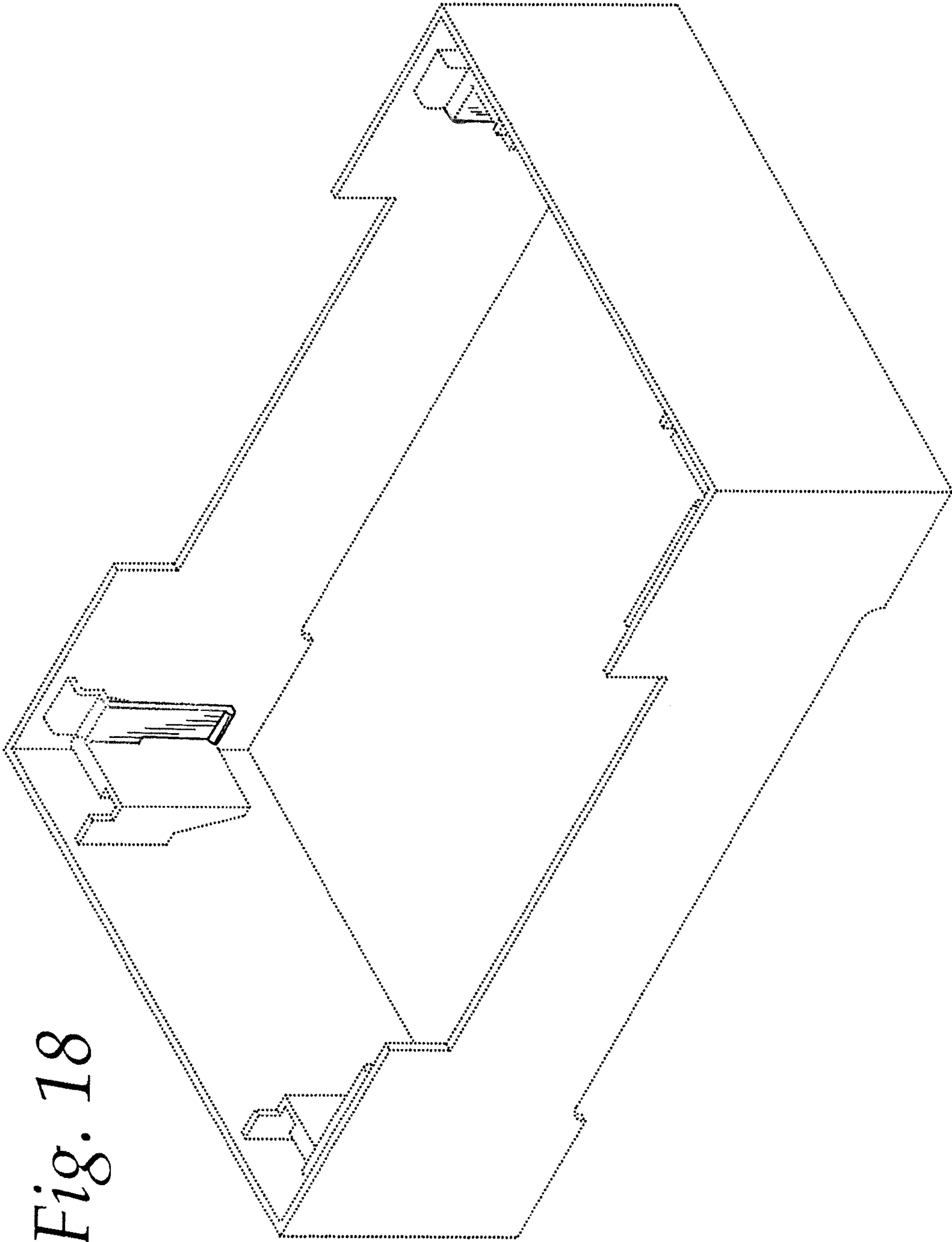

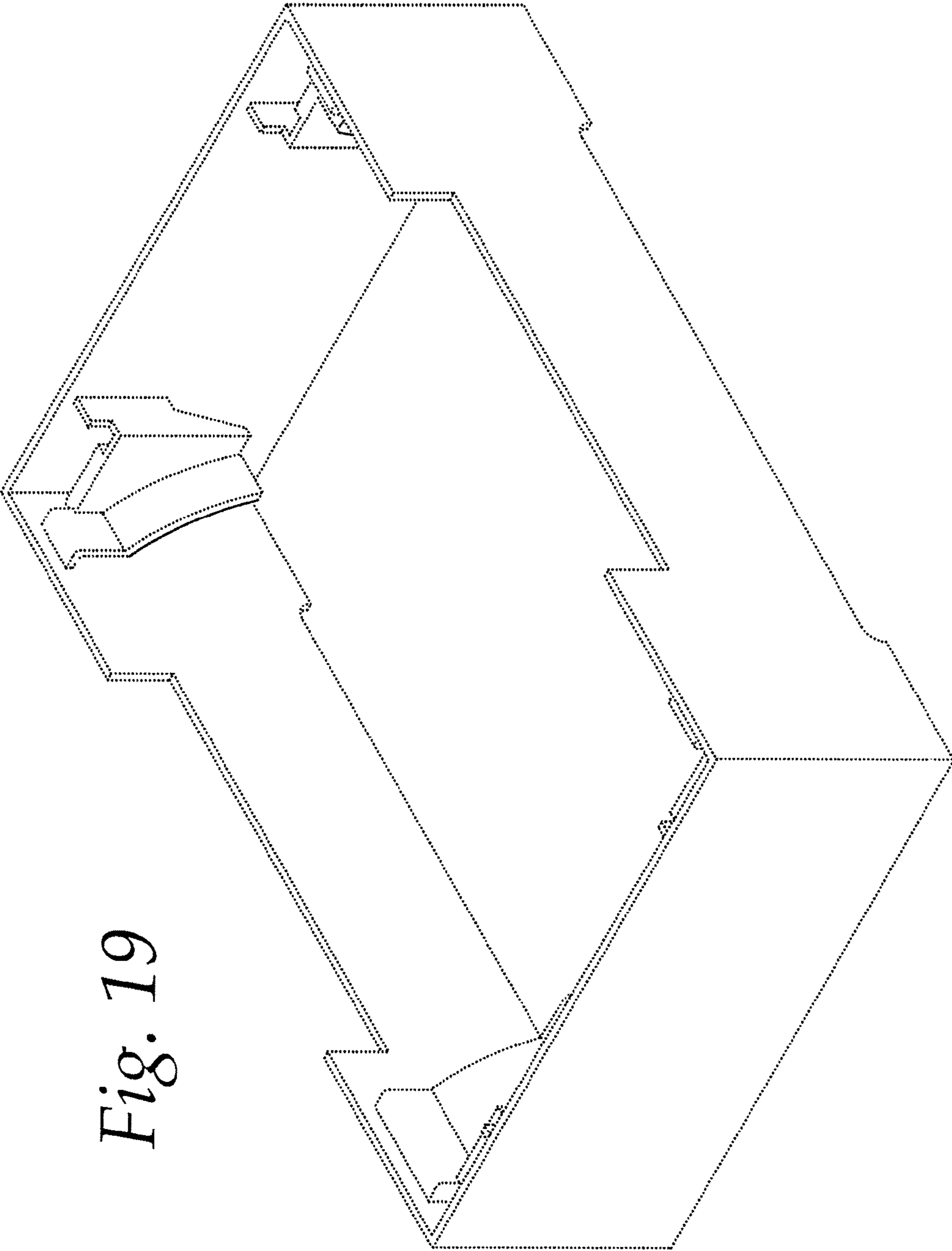
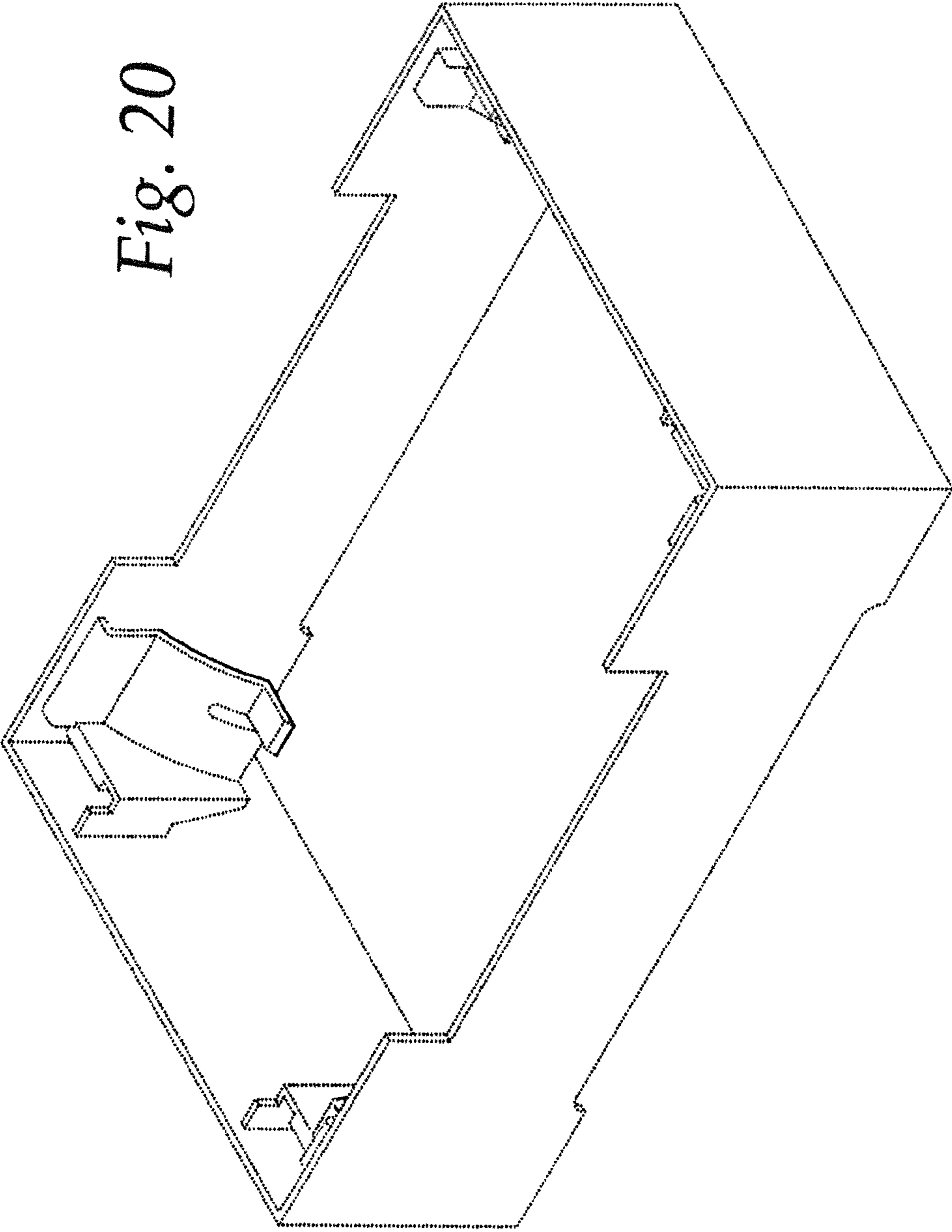

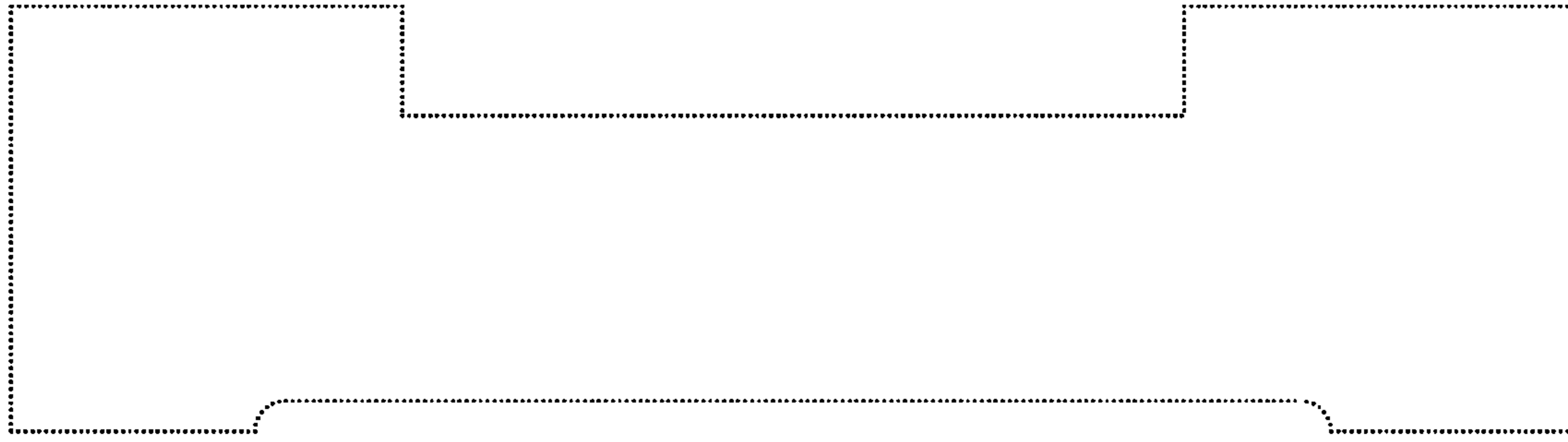

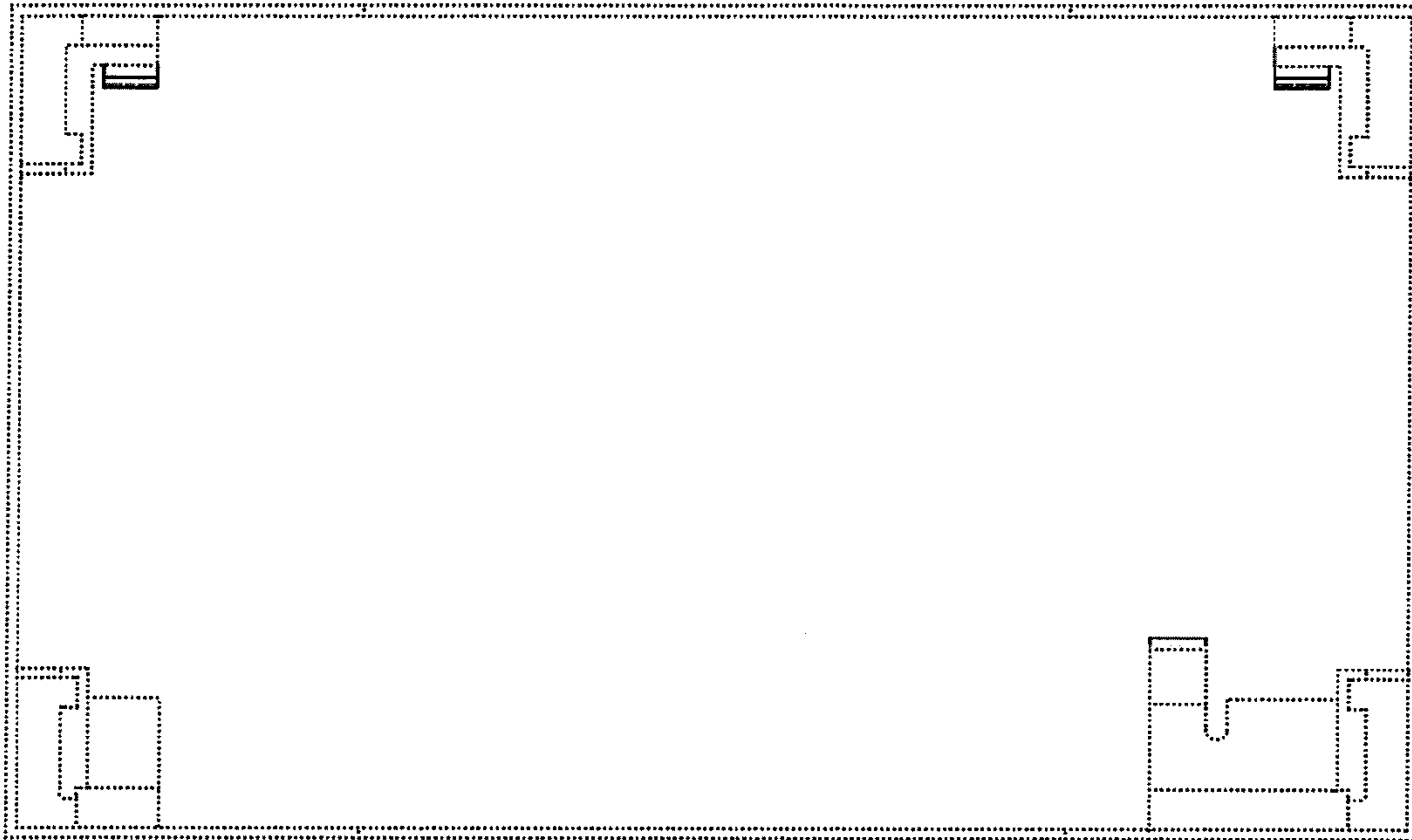

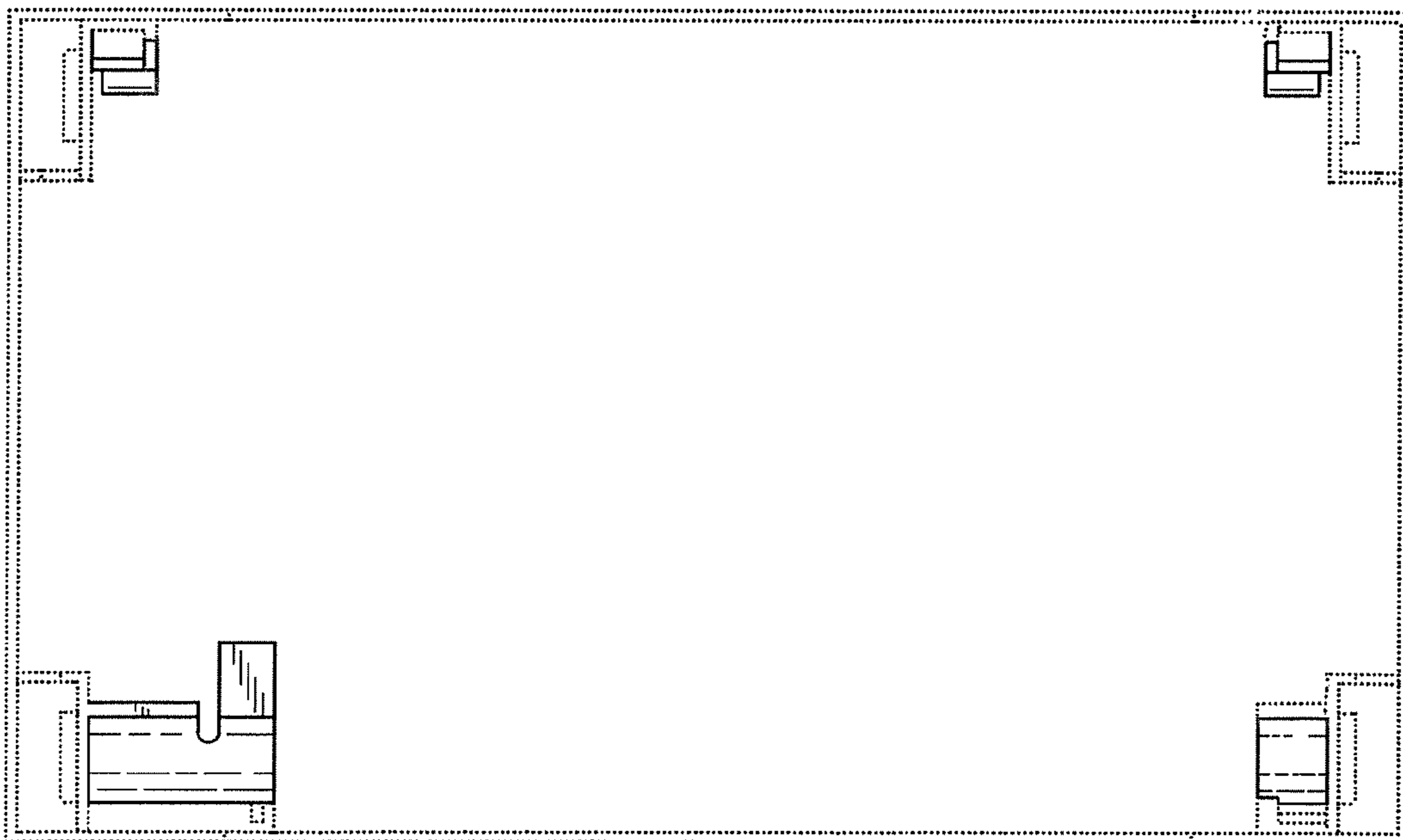
