(57) **CLAIM**

The ornamental design for a portable audio mixer dock, as shown and described.

DESCRIPTION

FIG. 1 is an isometric view of the design of the present application taken from above, with a computing device shown in broken line docked with the portable audio mixer dock;

FIG. 2 is a bottom isometric view of the design of FIG. 1;

FIG. 3 is a top view of the design of FIG. 1;

FIG. 4 is a bottom view of the design of FIG. 1;

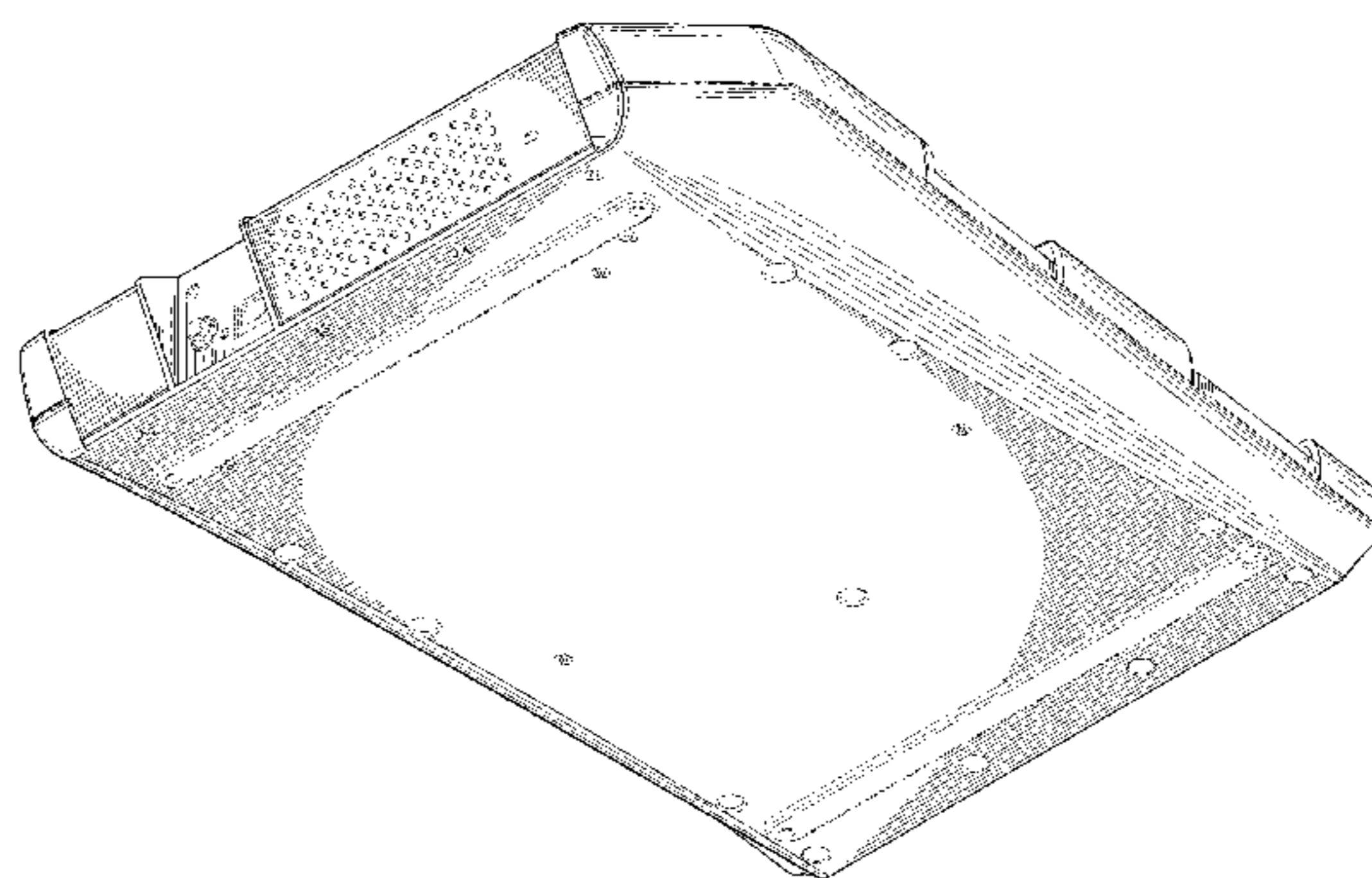
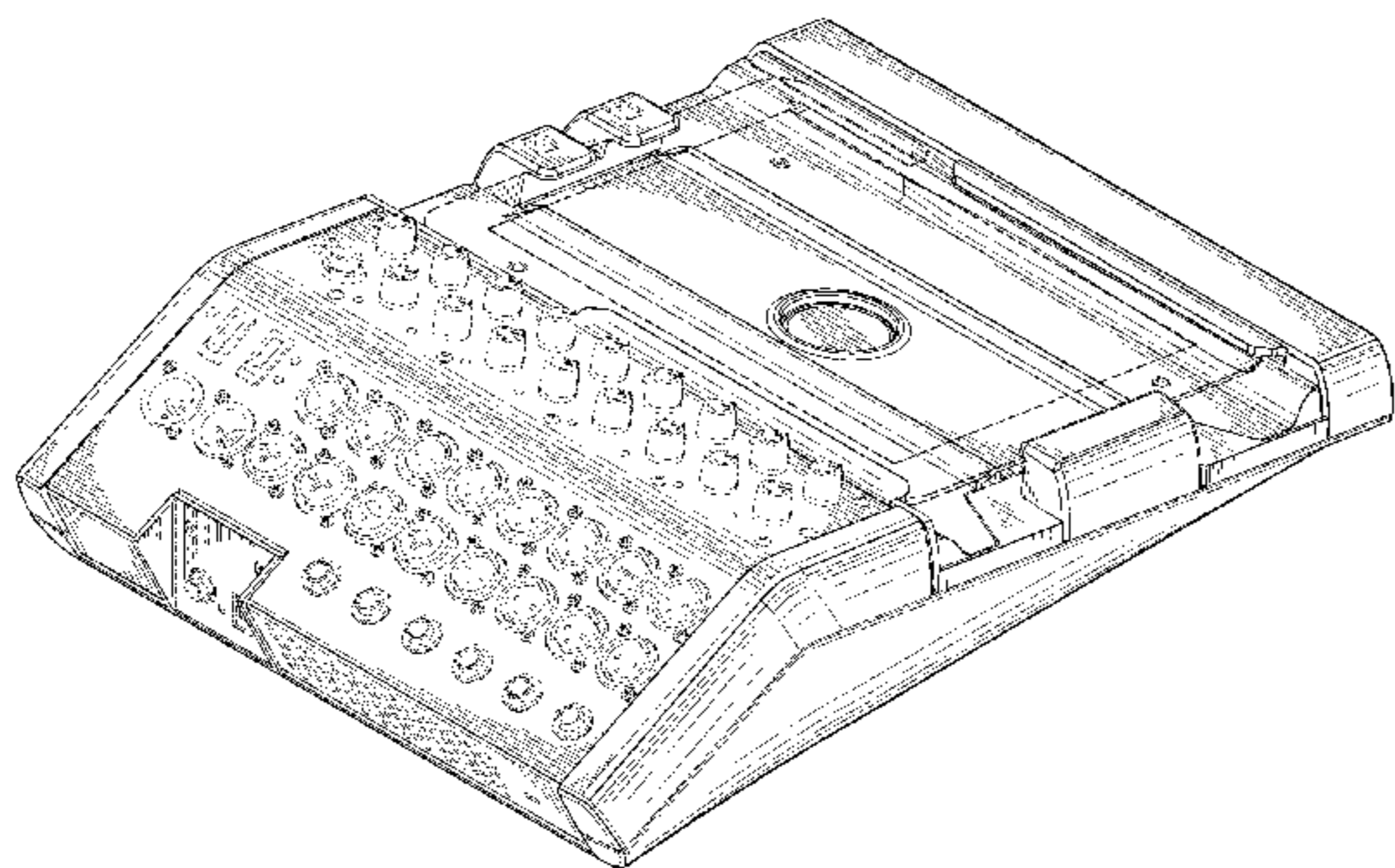
FIG. 5 is an end view of the design of FIG. 1;

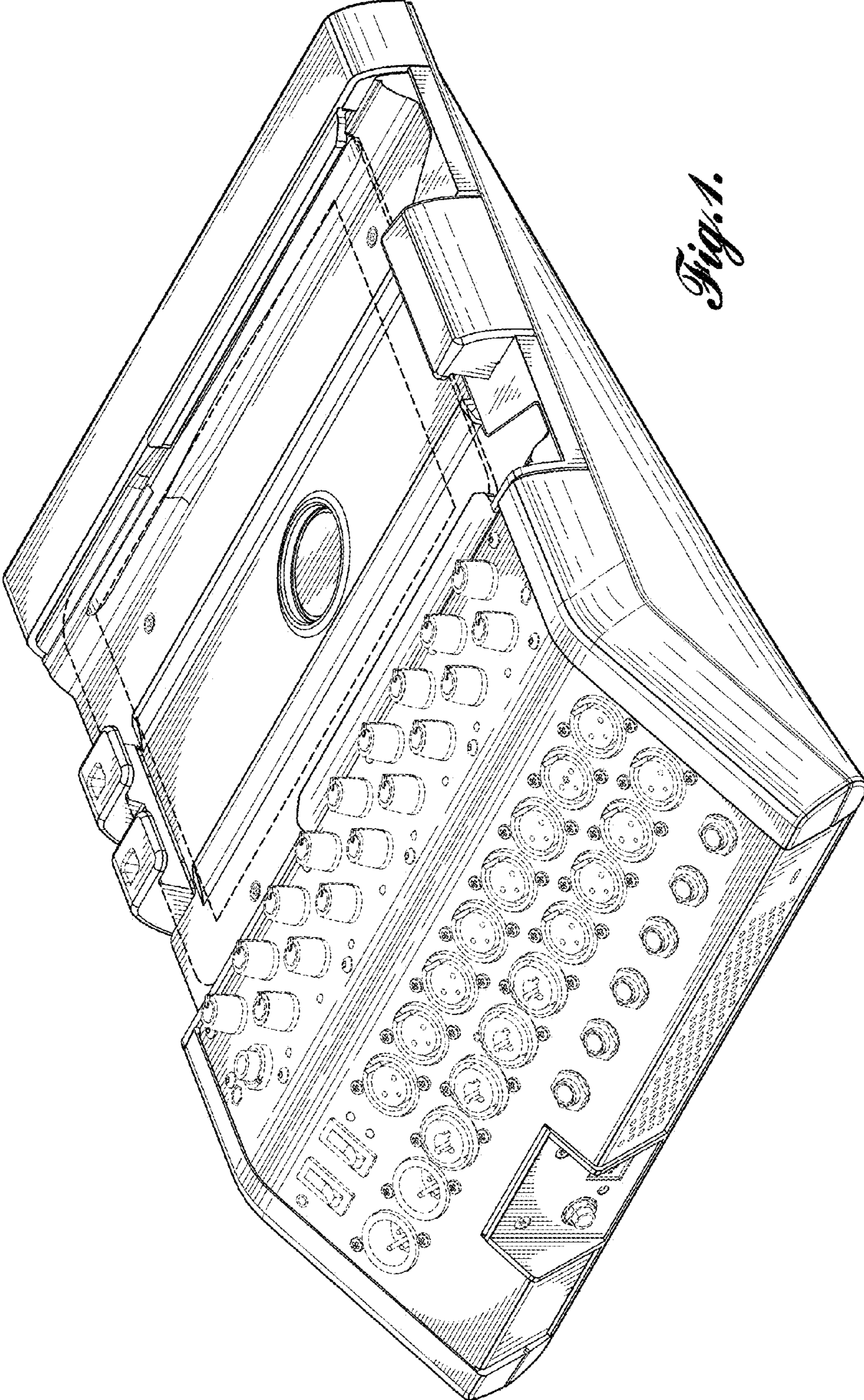

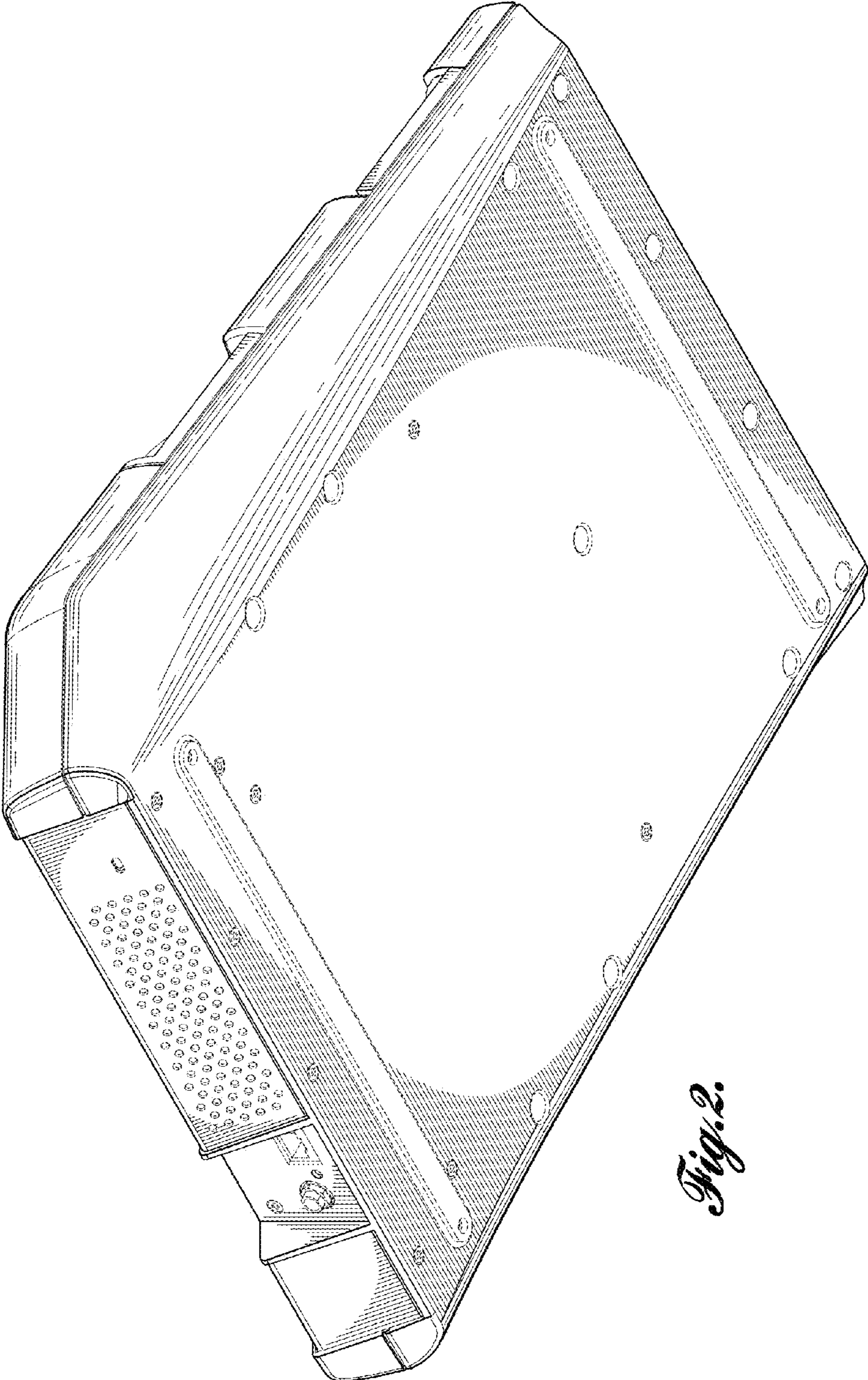

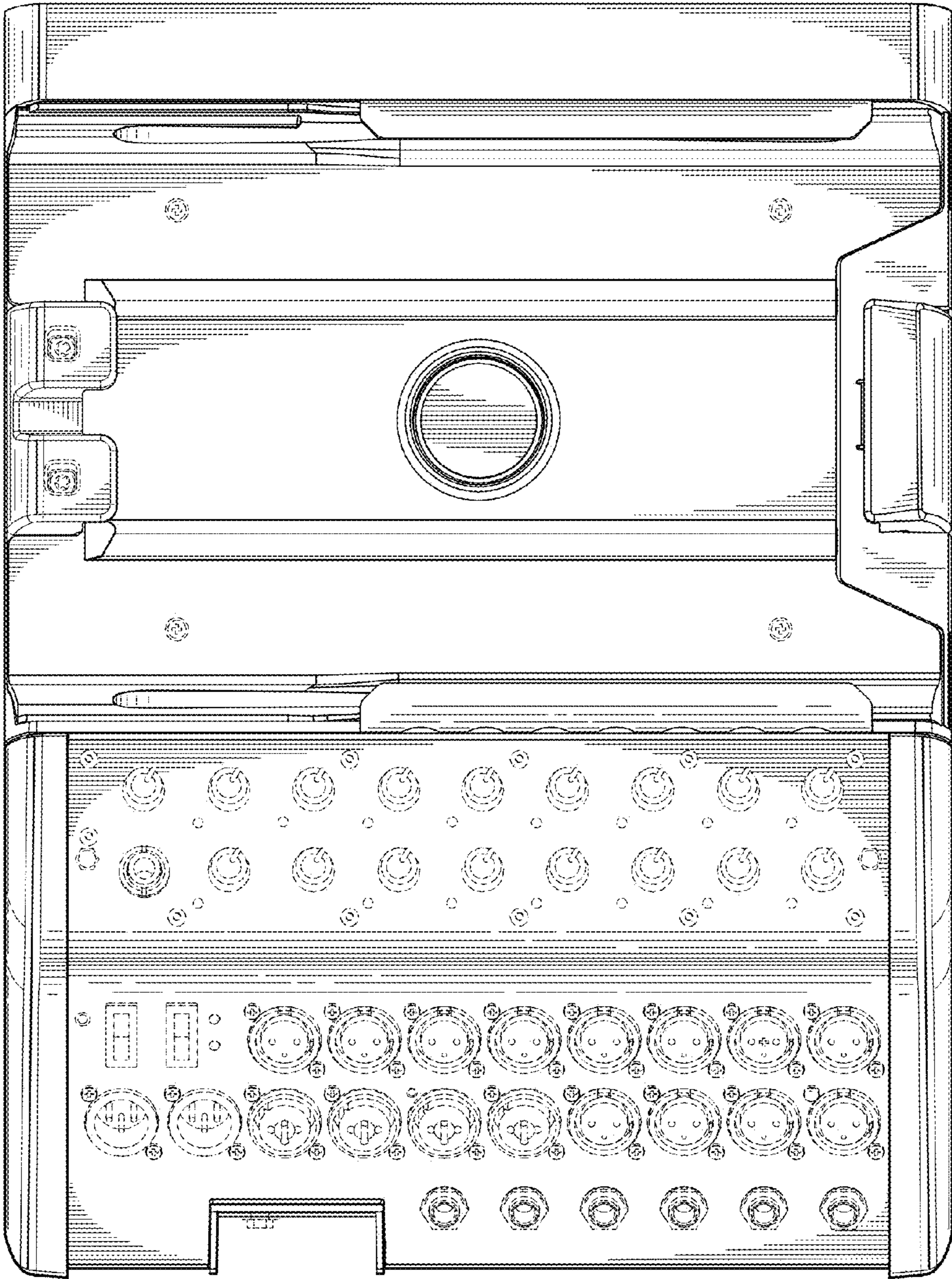

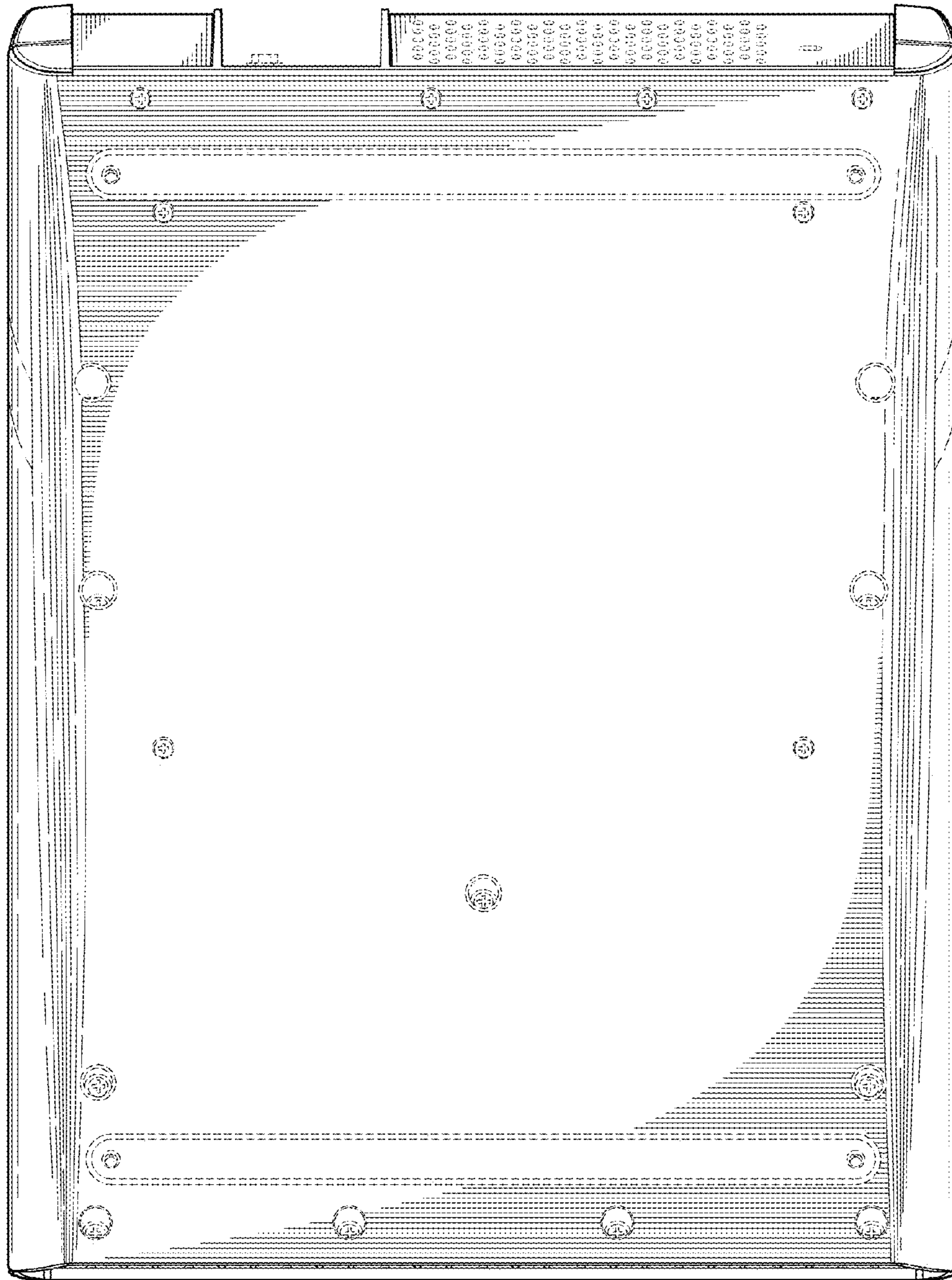

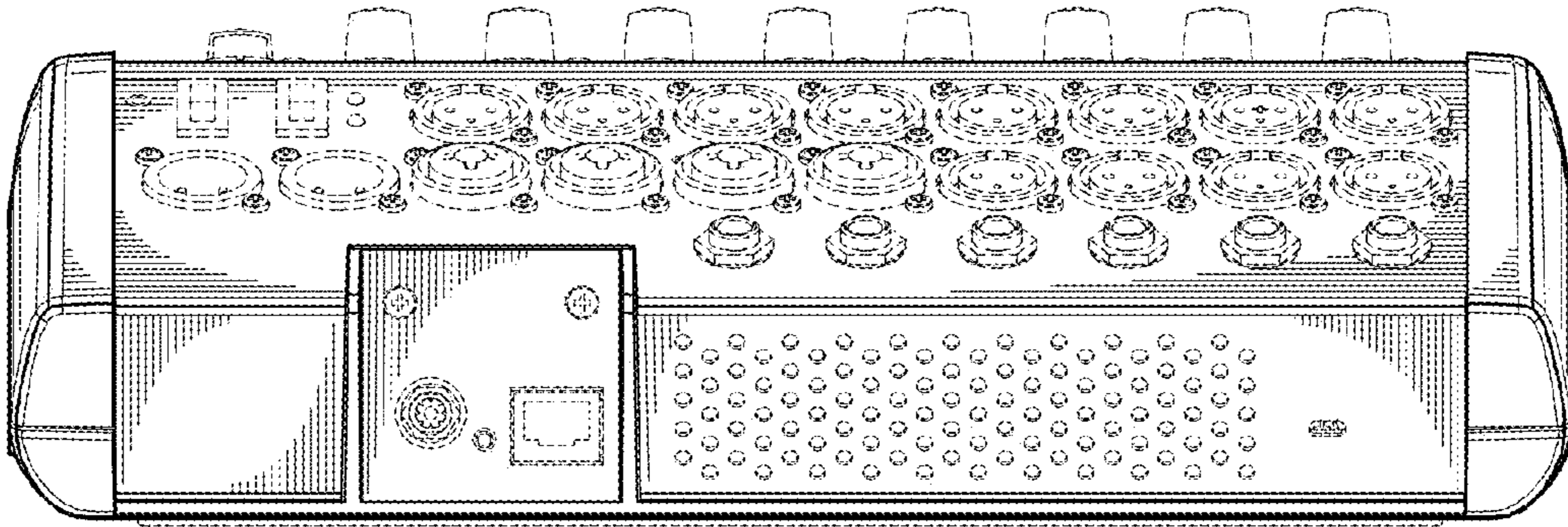

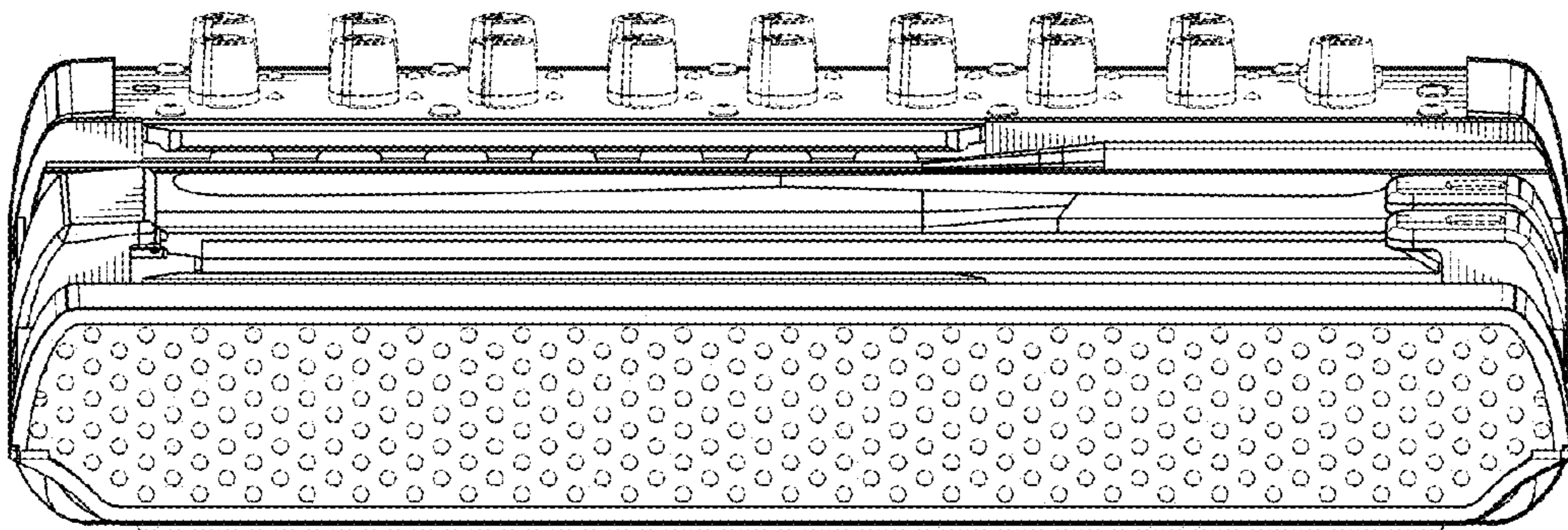

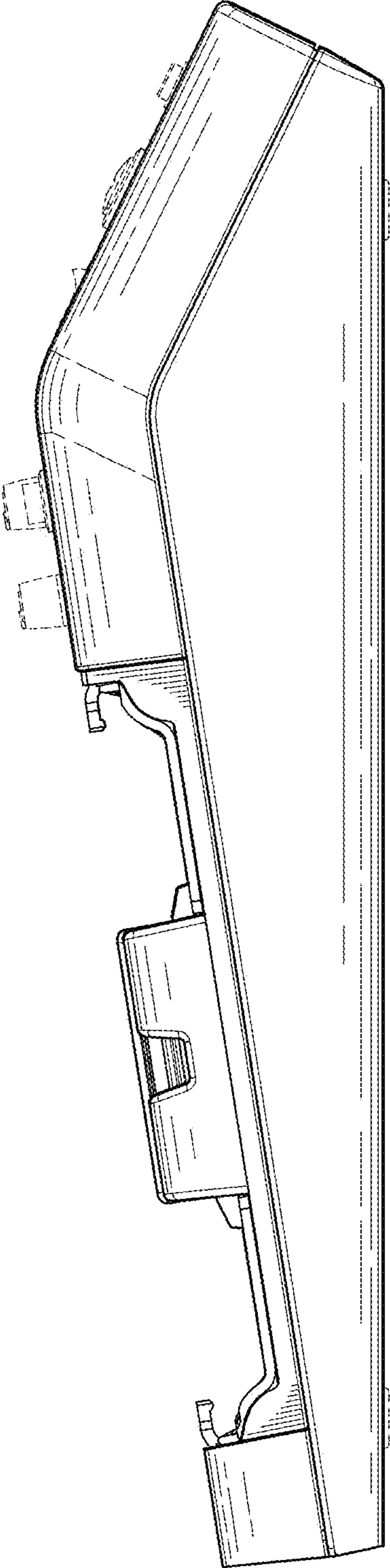
