(57) **CLAIM**

The ornamental design for a portion of a display screen with an icon, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a first embodiment of a portion of a display screen with an icon showing my new design.

FIG. 2 is a front view of a second embodiment of a portion of a display screen with an icon showing my new design.

FIG. 3 is a front view of a third embodiment of a portion of a display screen with an icon showing my new design; and,

FIG. 4 is a front view of a fourth embodiment of a portion of a display screen with an icon showing my new design.

The outer dot dash dot broken line in each of the four figures represents the portion of a display panel or screen and the boundaries of the claim. The broken line forms no part of the portion of a display panel or screen with an icon.








