(57) **CLAIM**

The ornamental design for a laser processing machine, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the front, top and right side of a laser processing machine showing our new design; FIG. 2 is a perspective view of the rear, top and left side thereof;

FIG. 3 is a front view thereof;

FIG. 4 is a rear view thereof;

FIG. 5 is a left side view thereof;

FIG. 6 is a right side view thereof;

FIG. 7 is a top view thereof;

FIG. 8 is a bottom view thereof; and,

FIG. 9 is a right side view of a laser processing machine showing a state where a door is open.

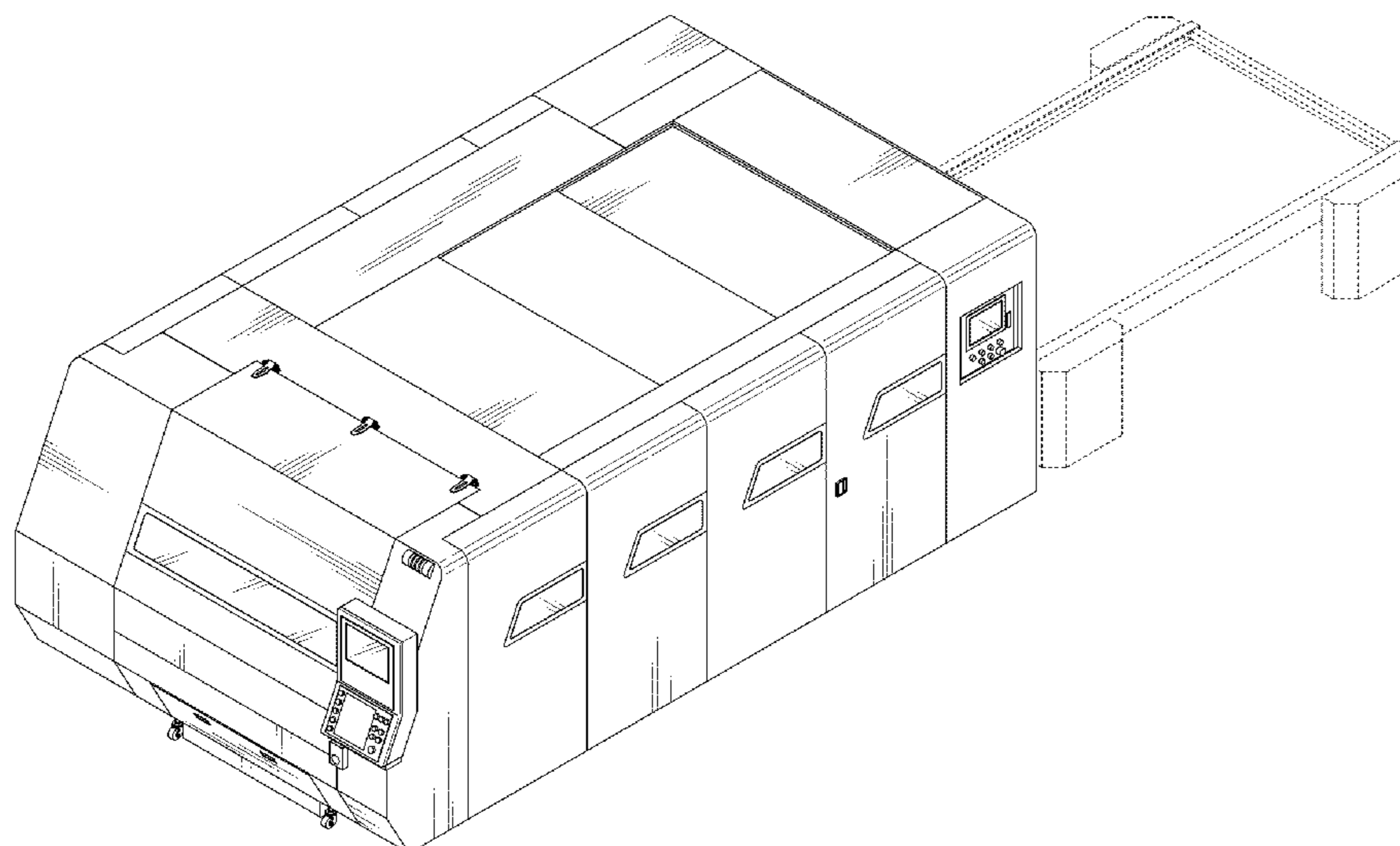
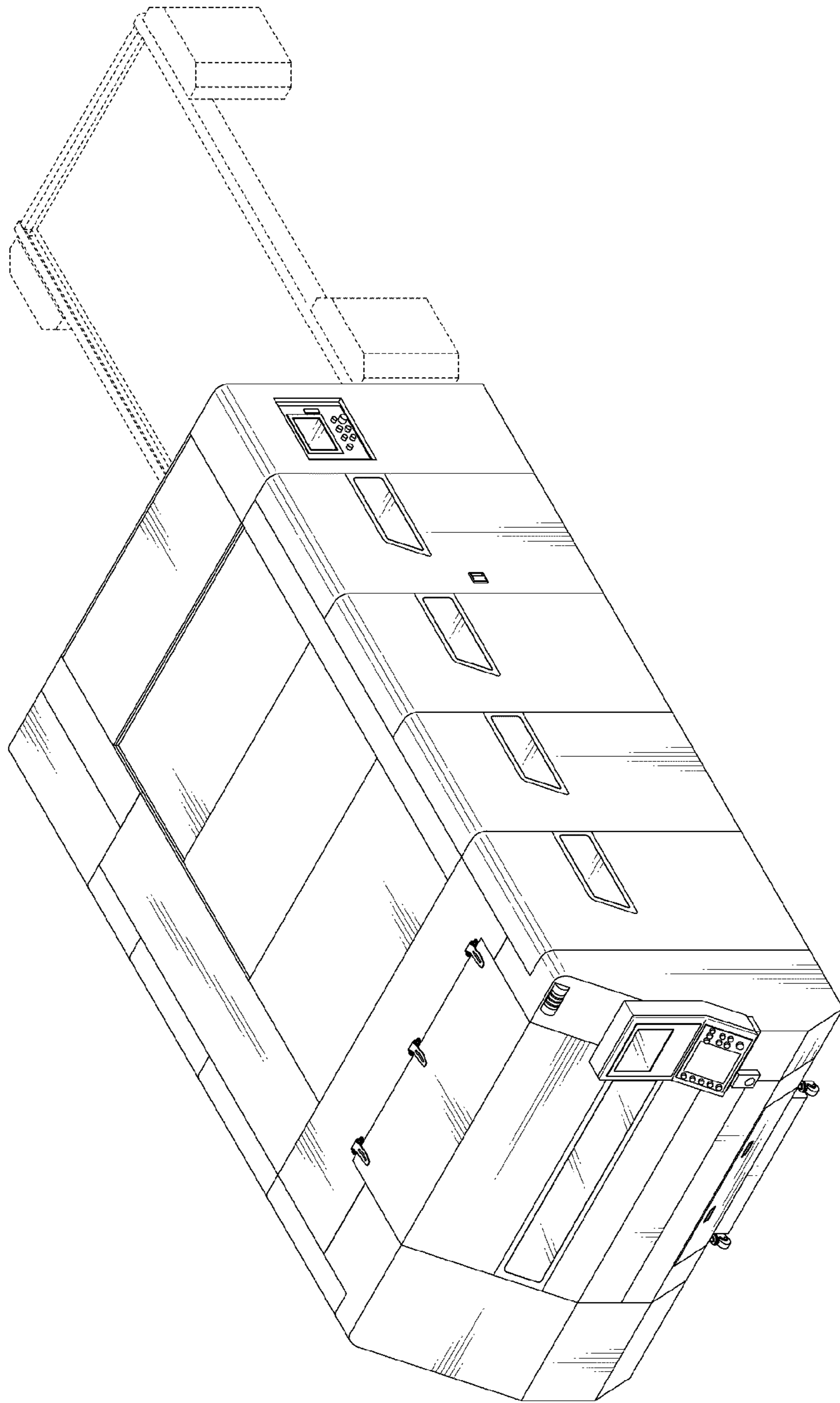

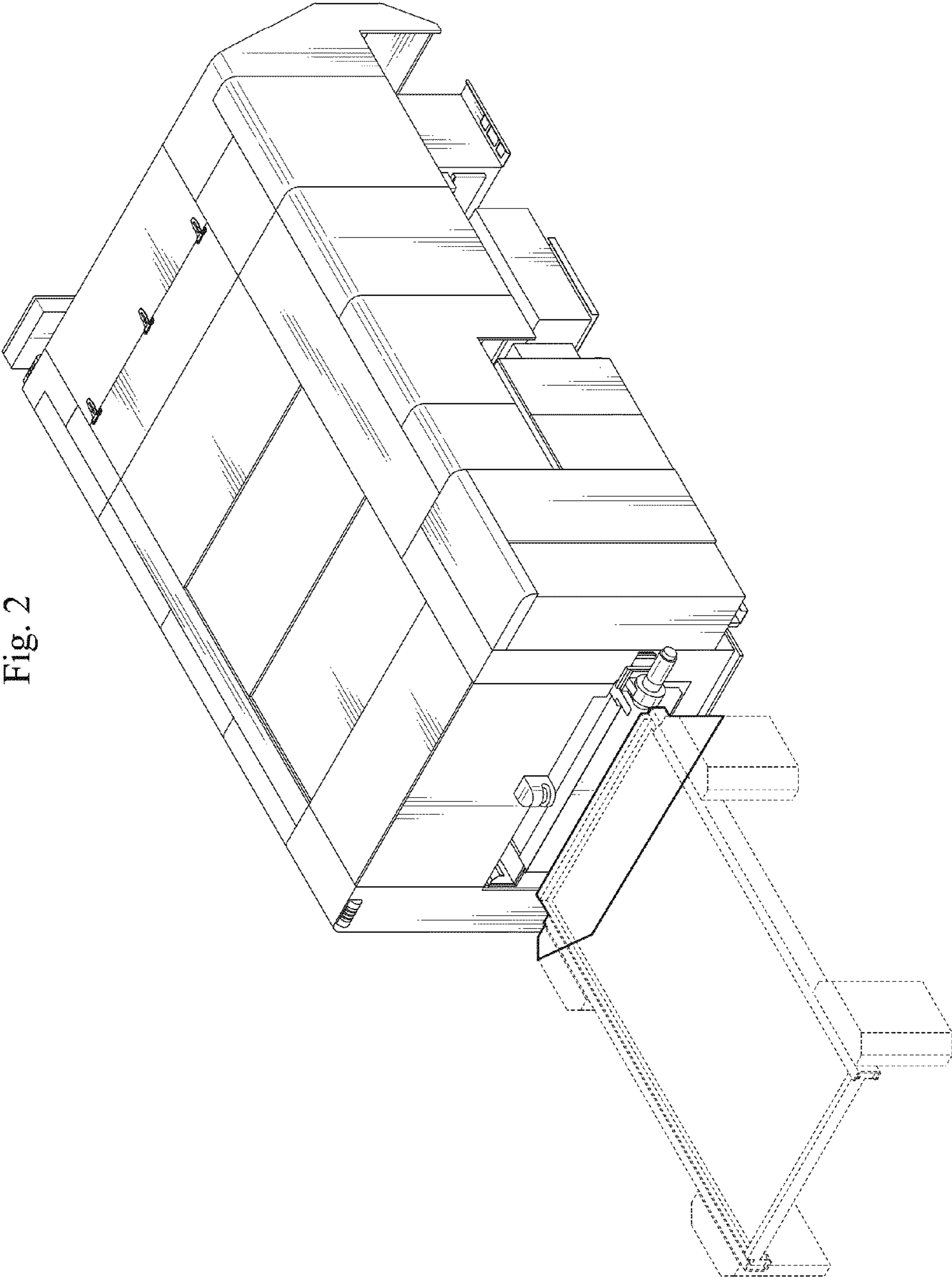

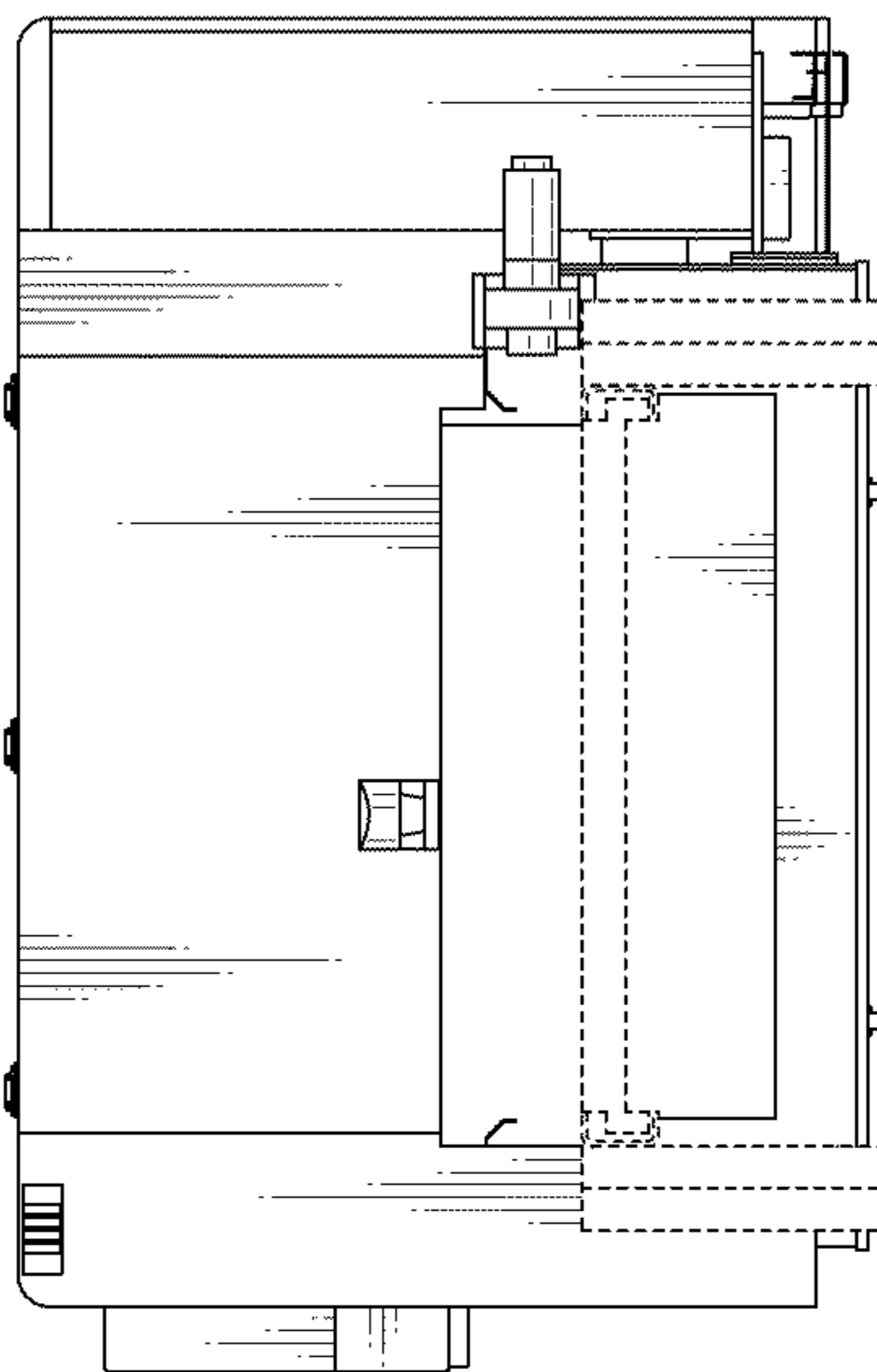

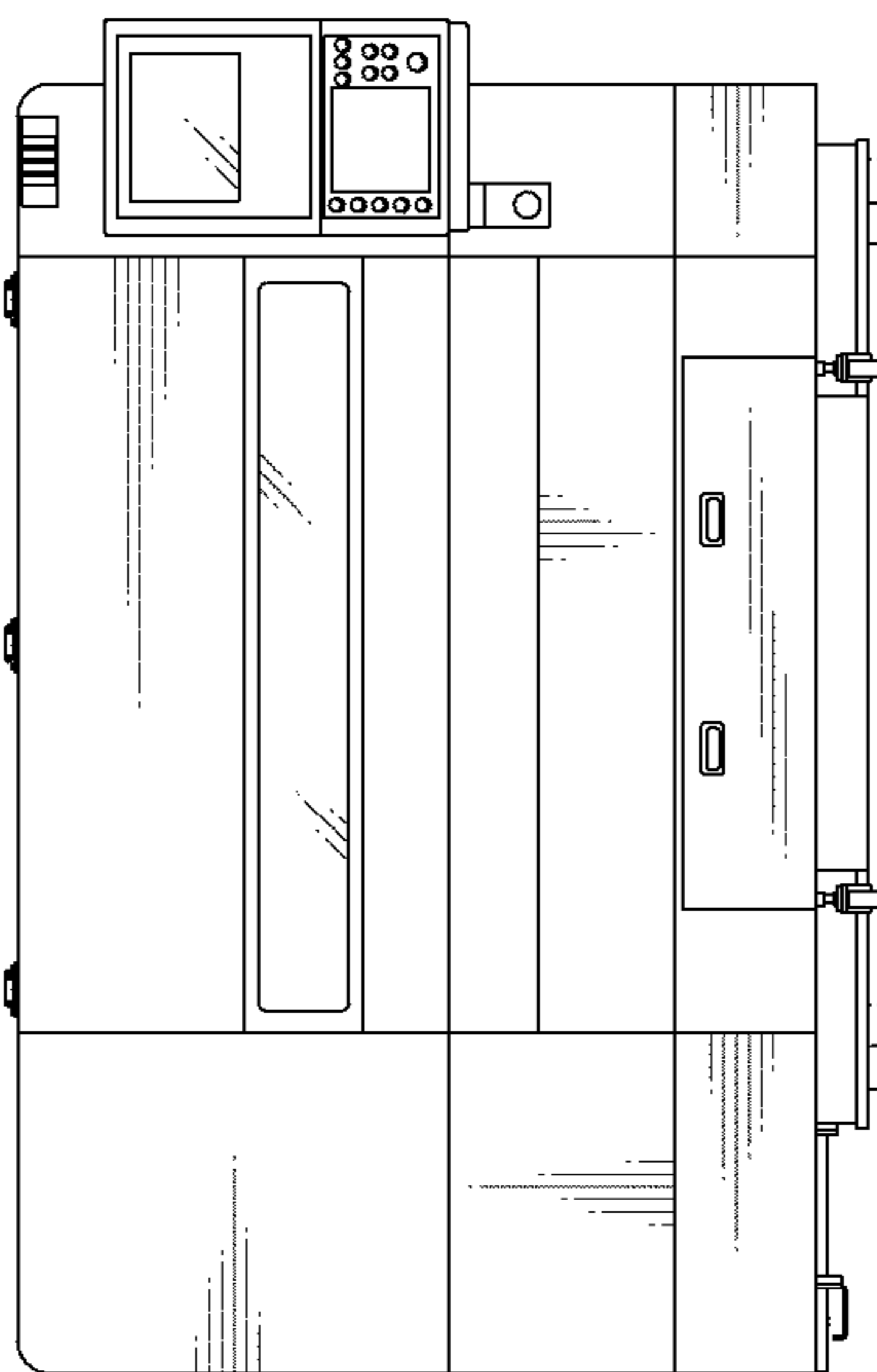

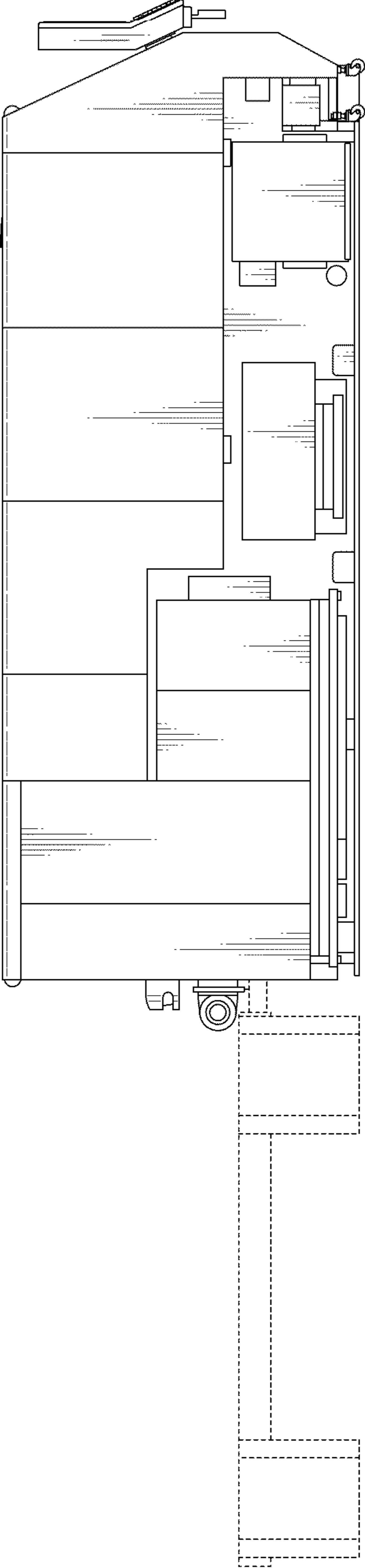

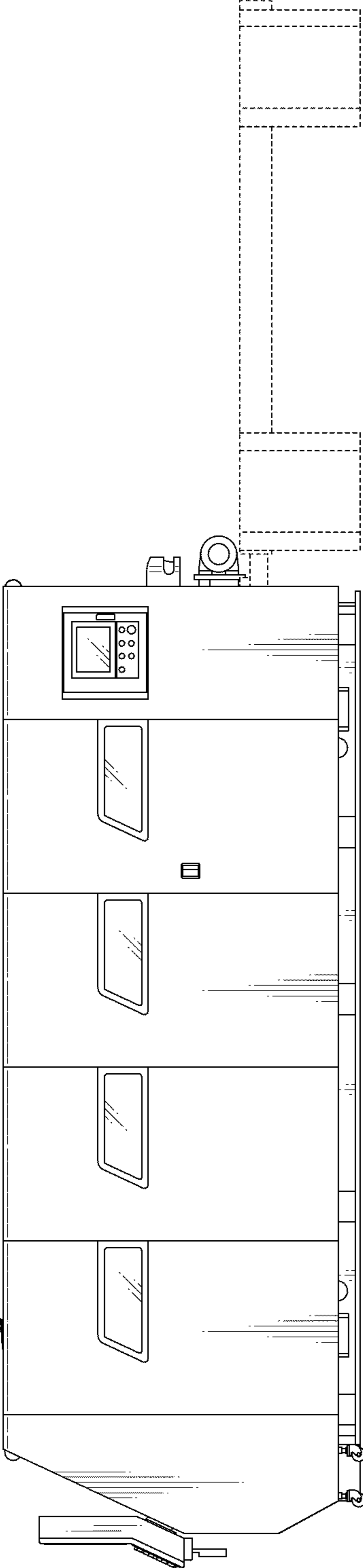

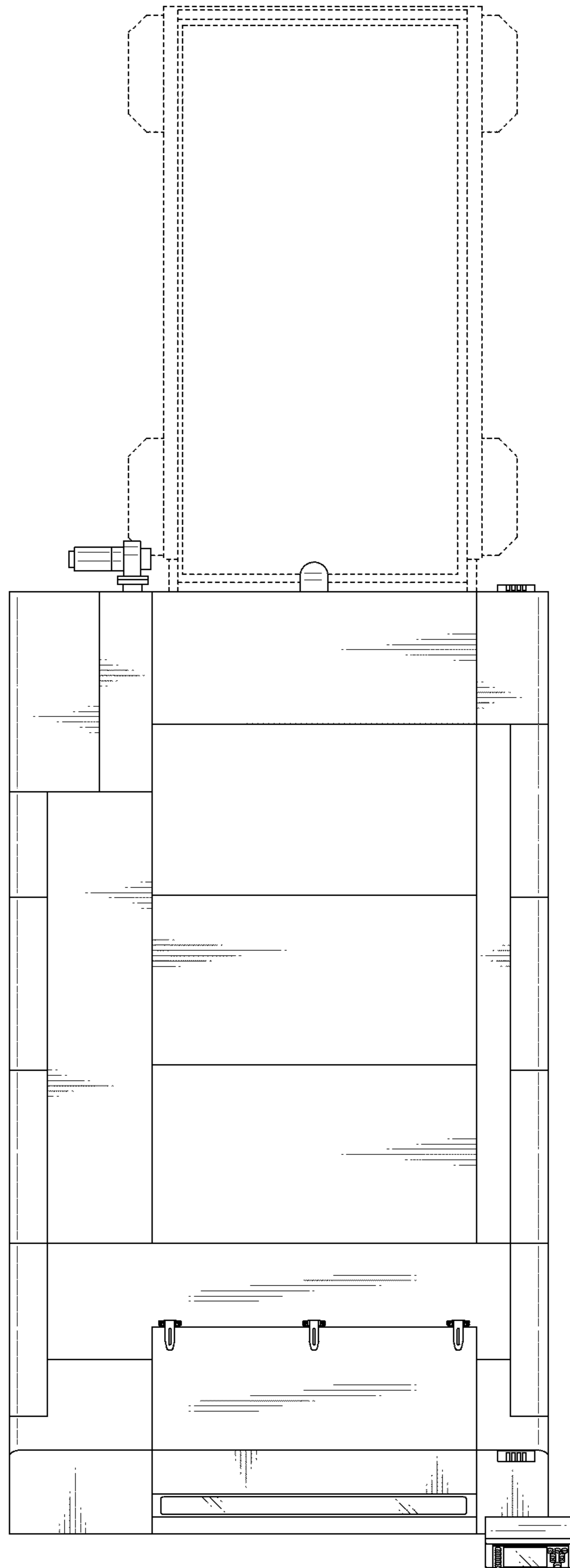

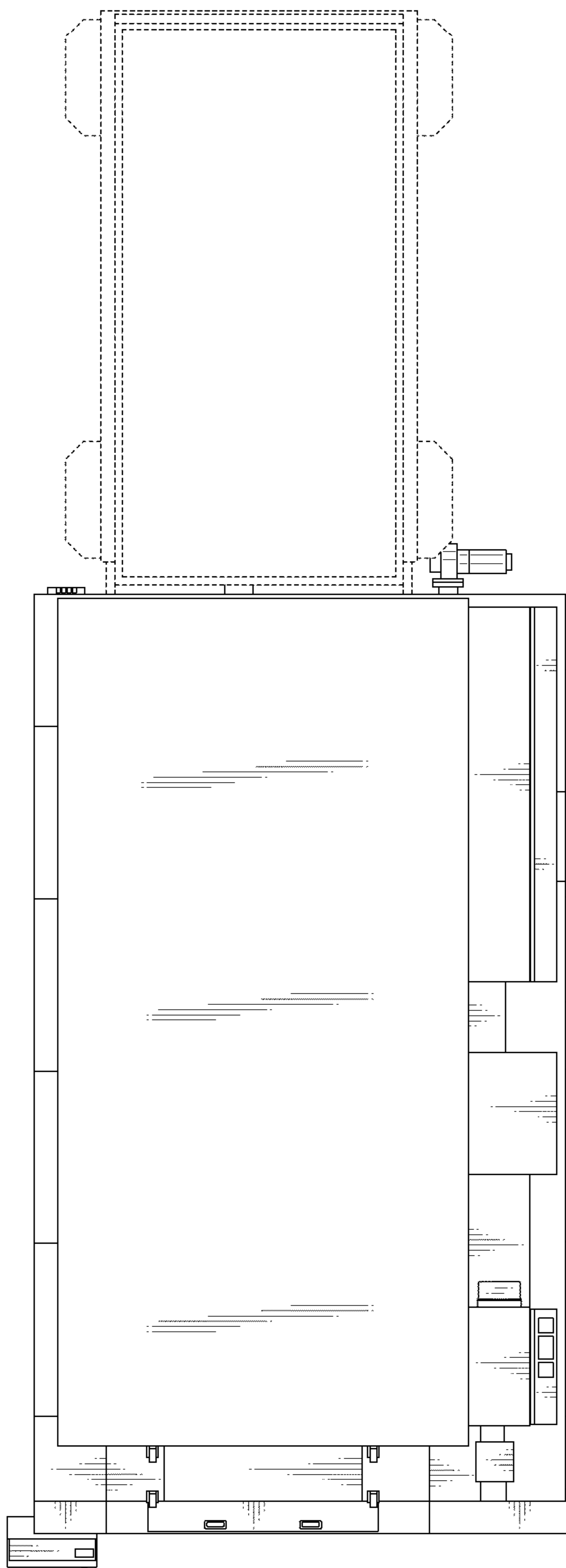
