The ornamental design for a reverse vending machine, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a first embodiment of a vending machine module;

FIG. 2 is a rear perspective view of the vending machine module in FIG. 1;

FIG. 3 is a bottom view of the vending machine module in FIG. 1;

FIG. 6 is a second side view of the vending machine module in FIG. 1;

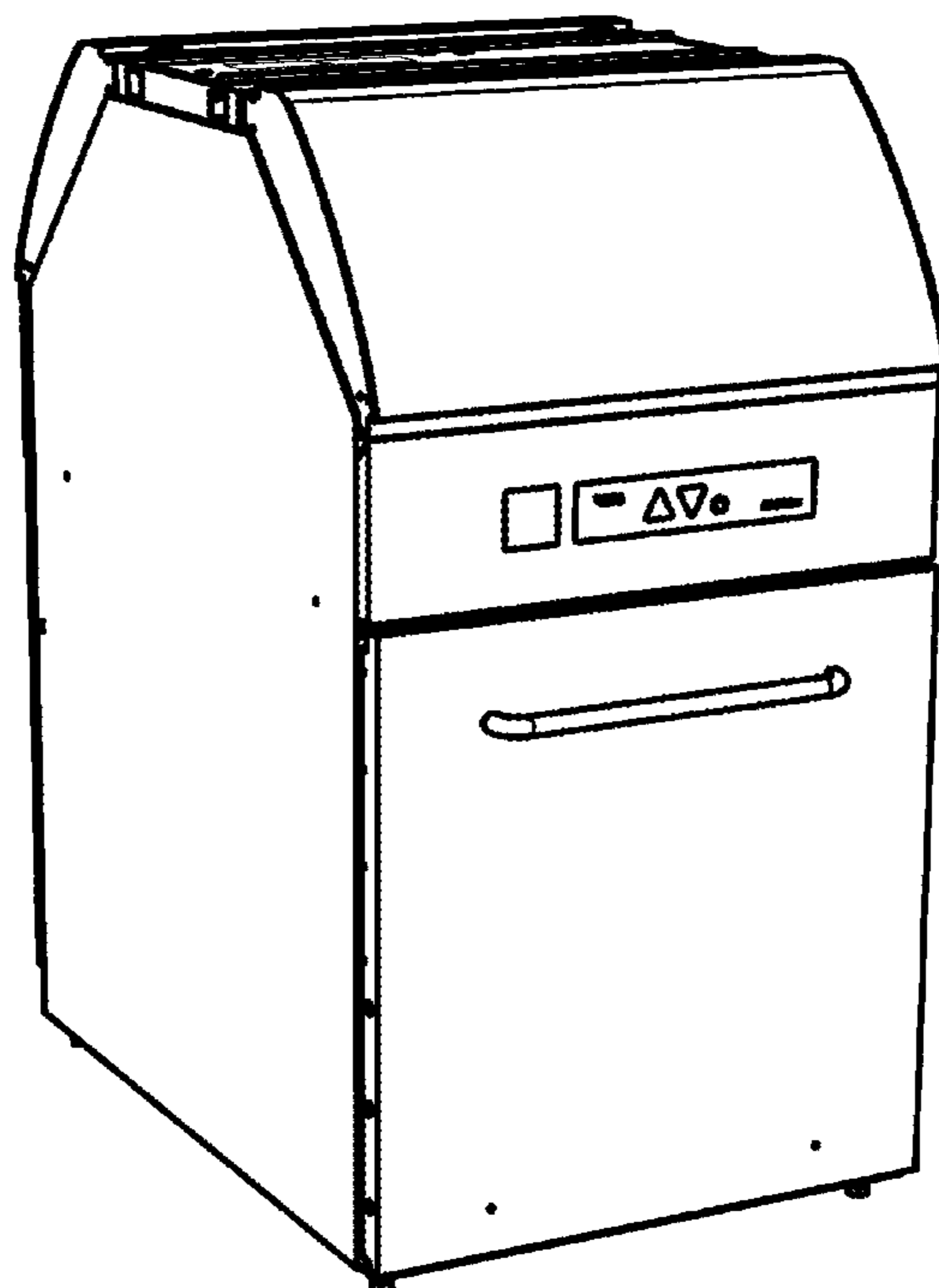
FIG. 7 is a rear view of the vending machine module in FIG. 1; and,

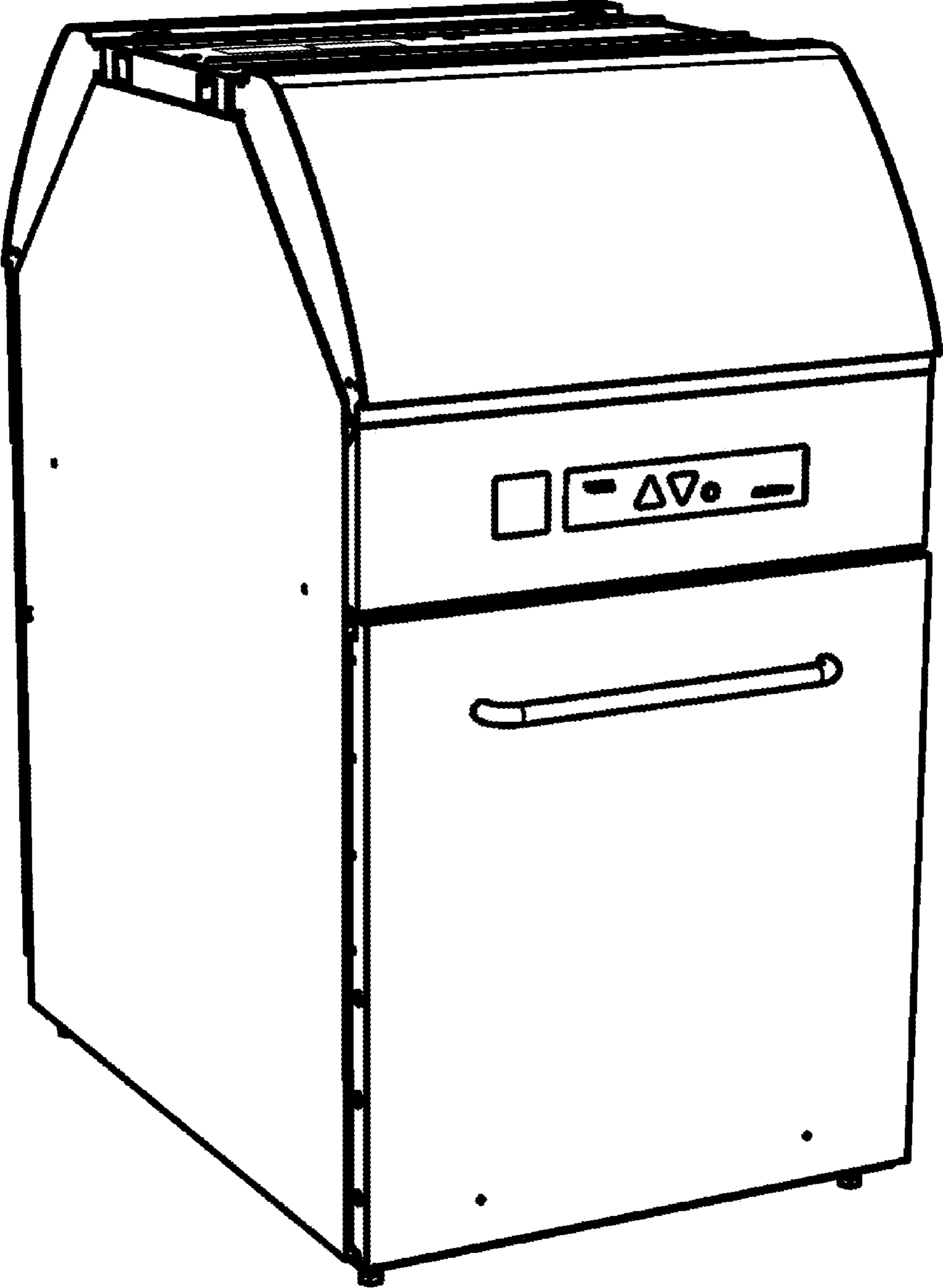
FIG. 8 is a top view of the vending machine module in FIG. 1.

The claimed design as shown and described above relates to reverse vending systems for handling the return of deposit beverage containers.

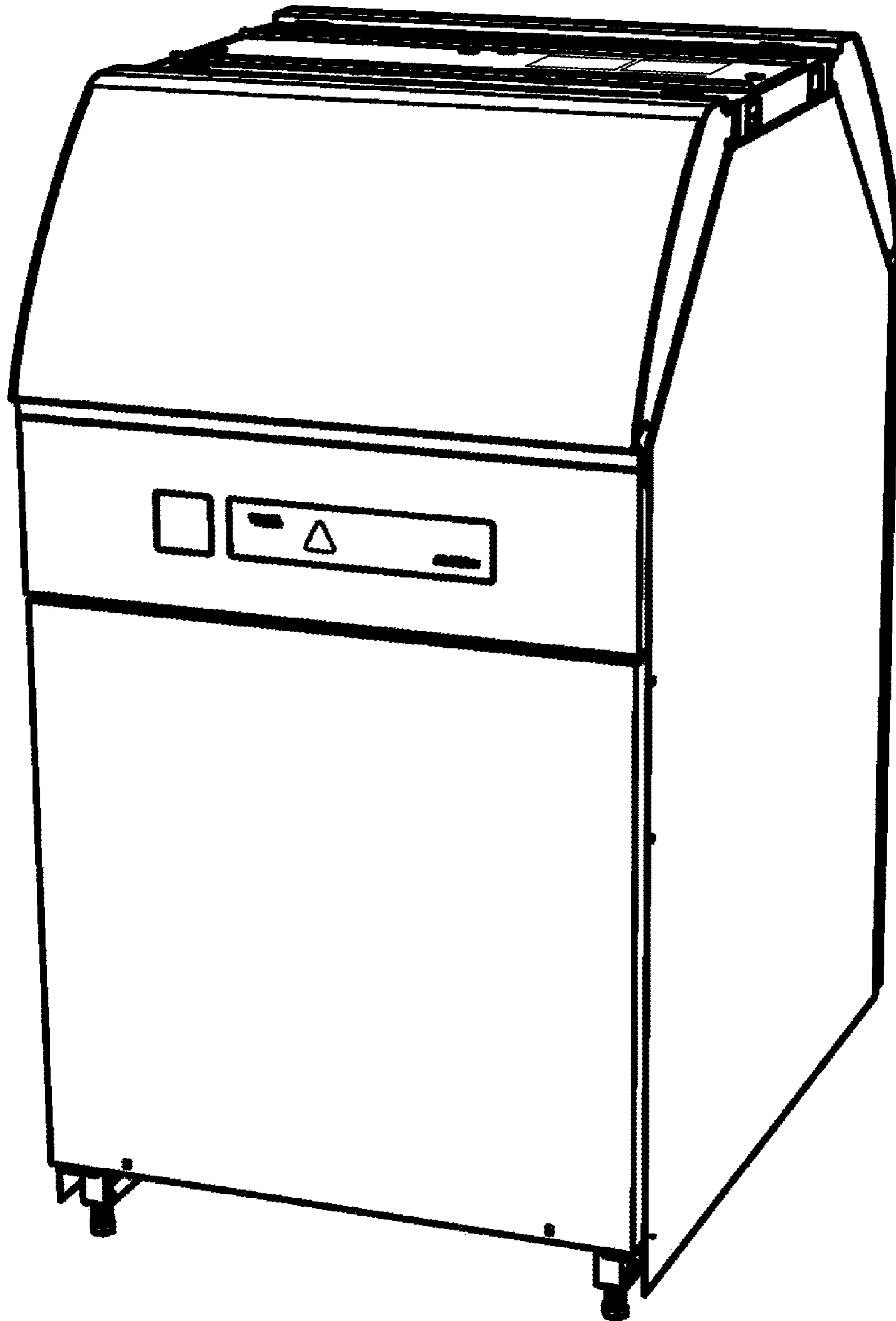
The broken lines depict environmental subject matter only and form no part of the claimed design.

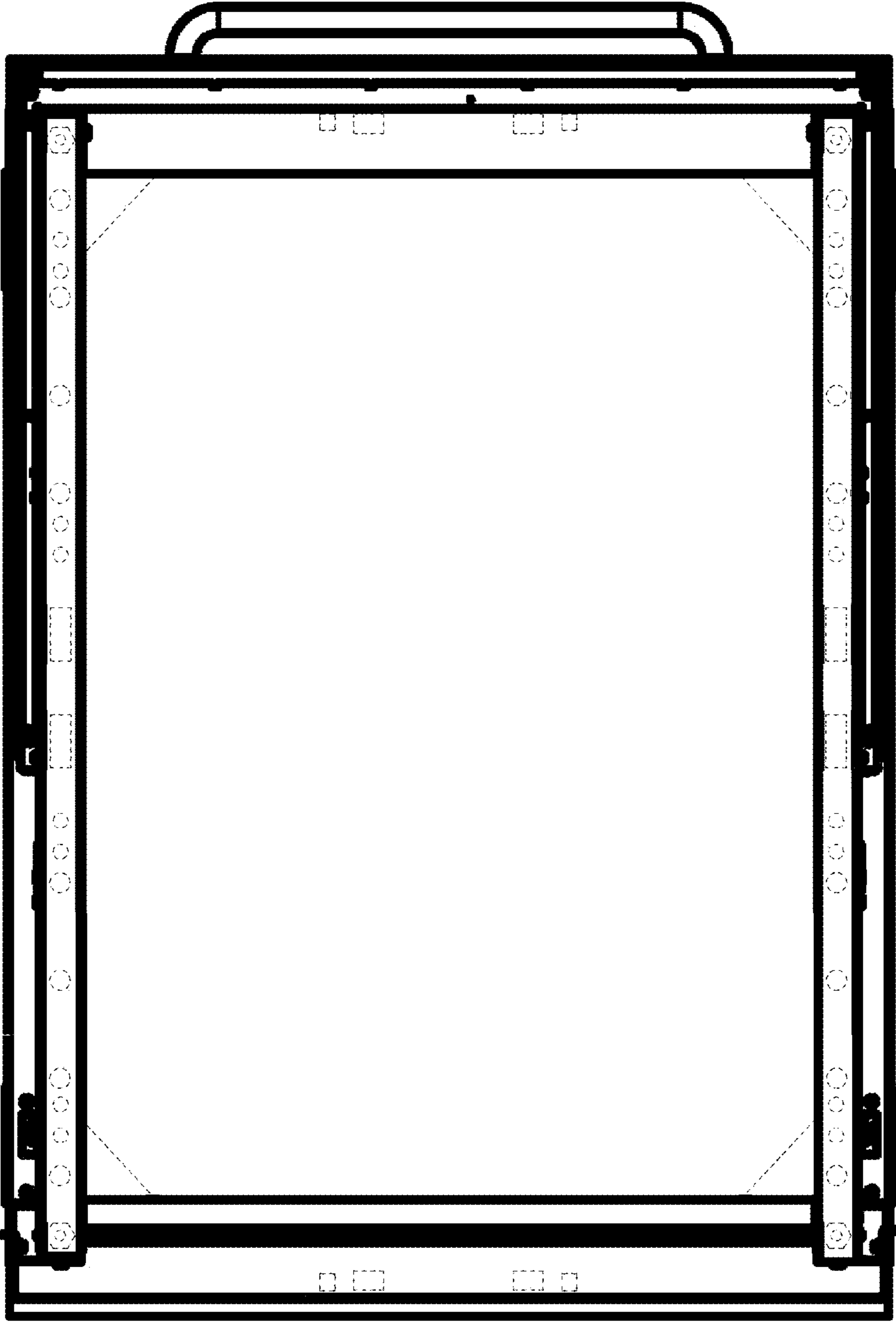




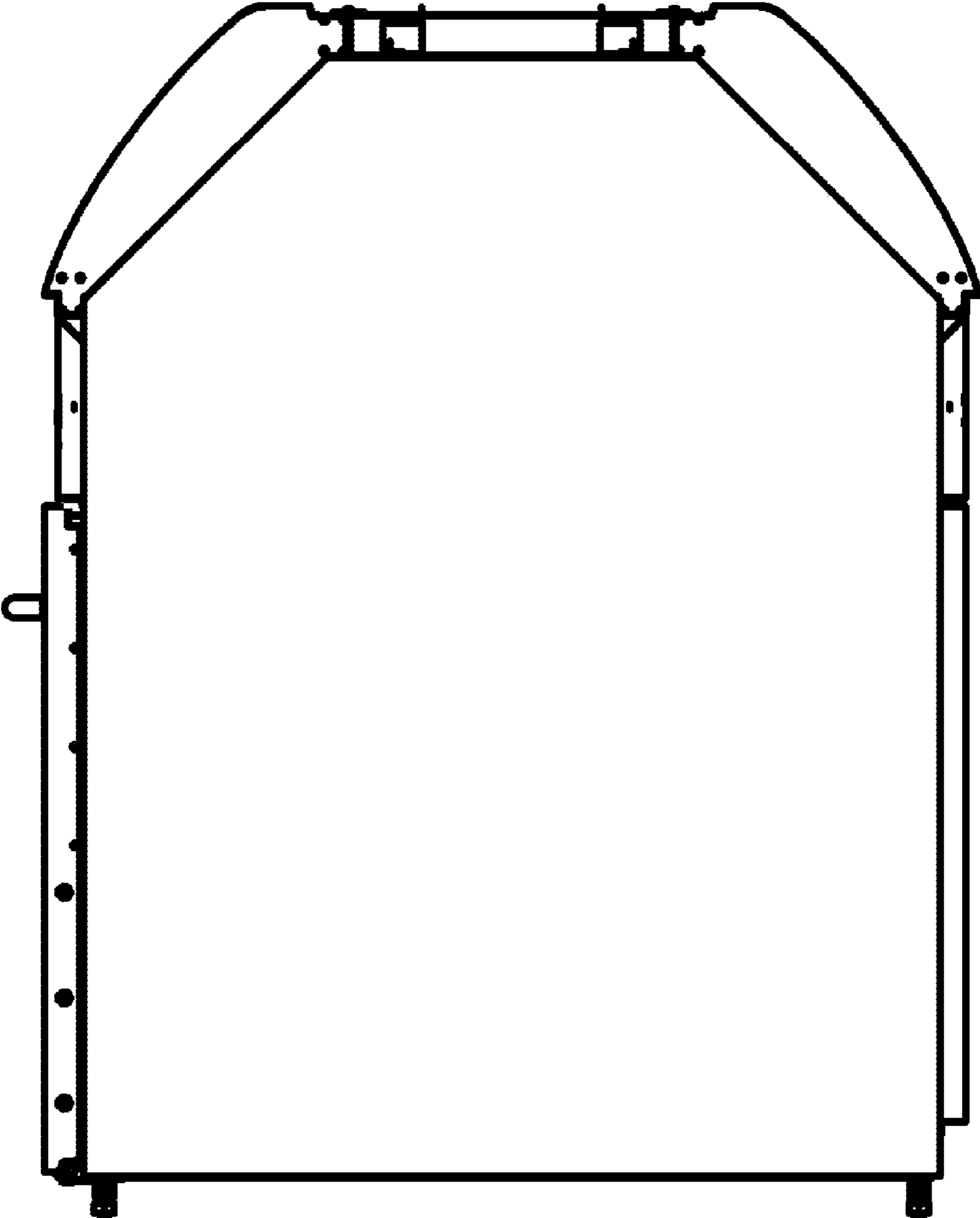

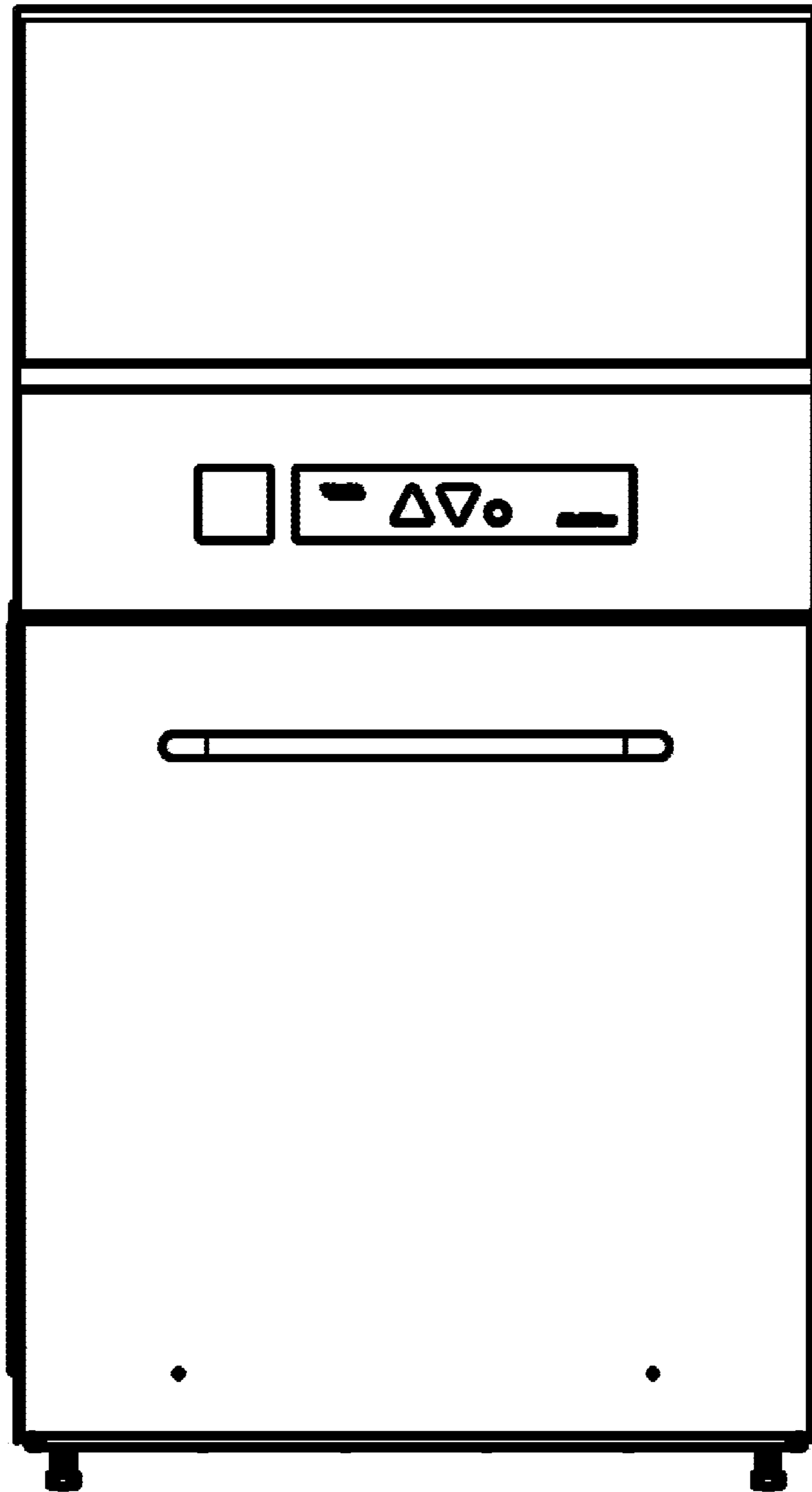

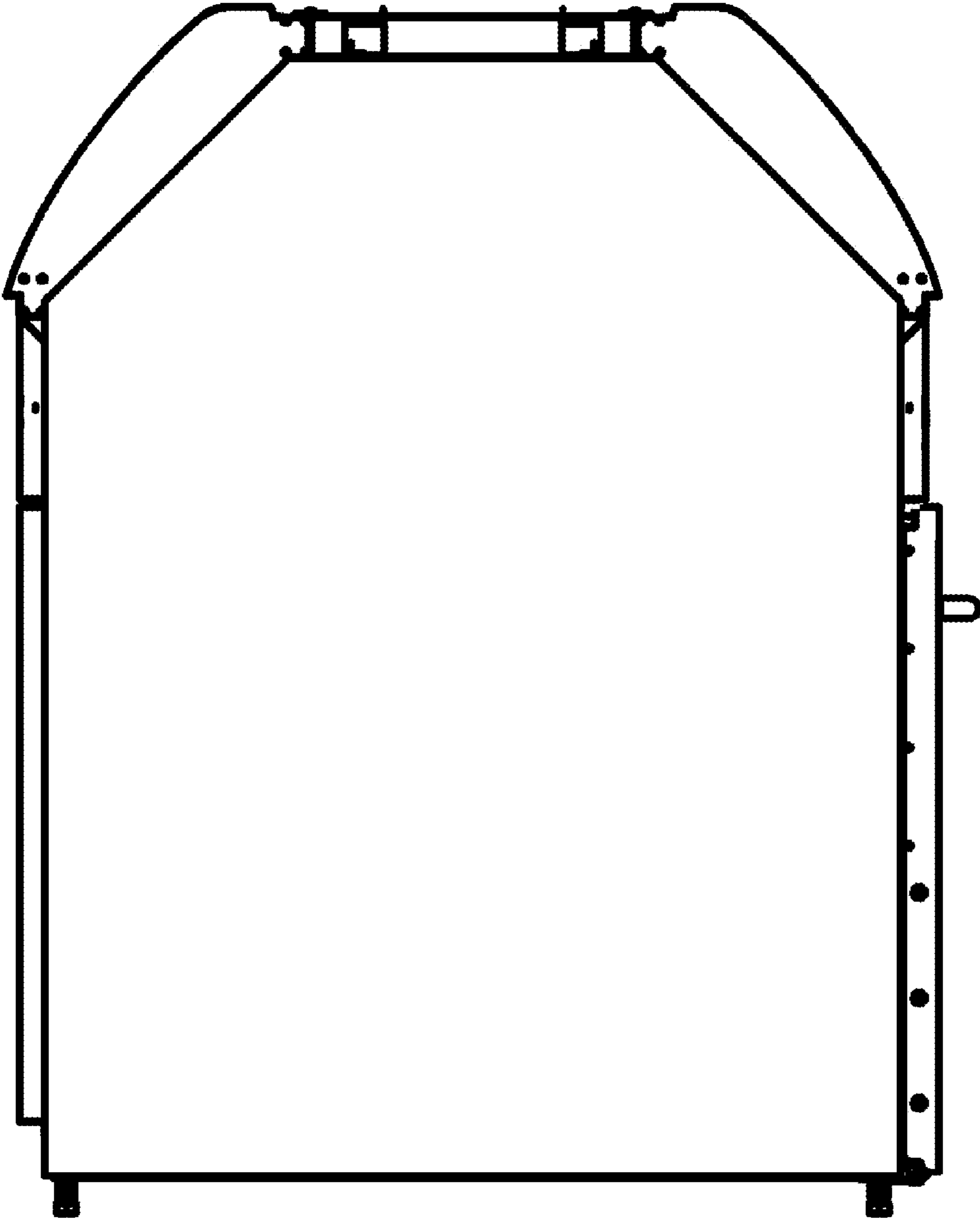

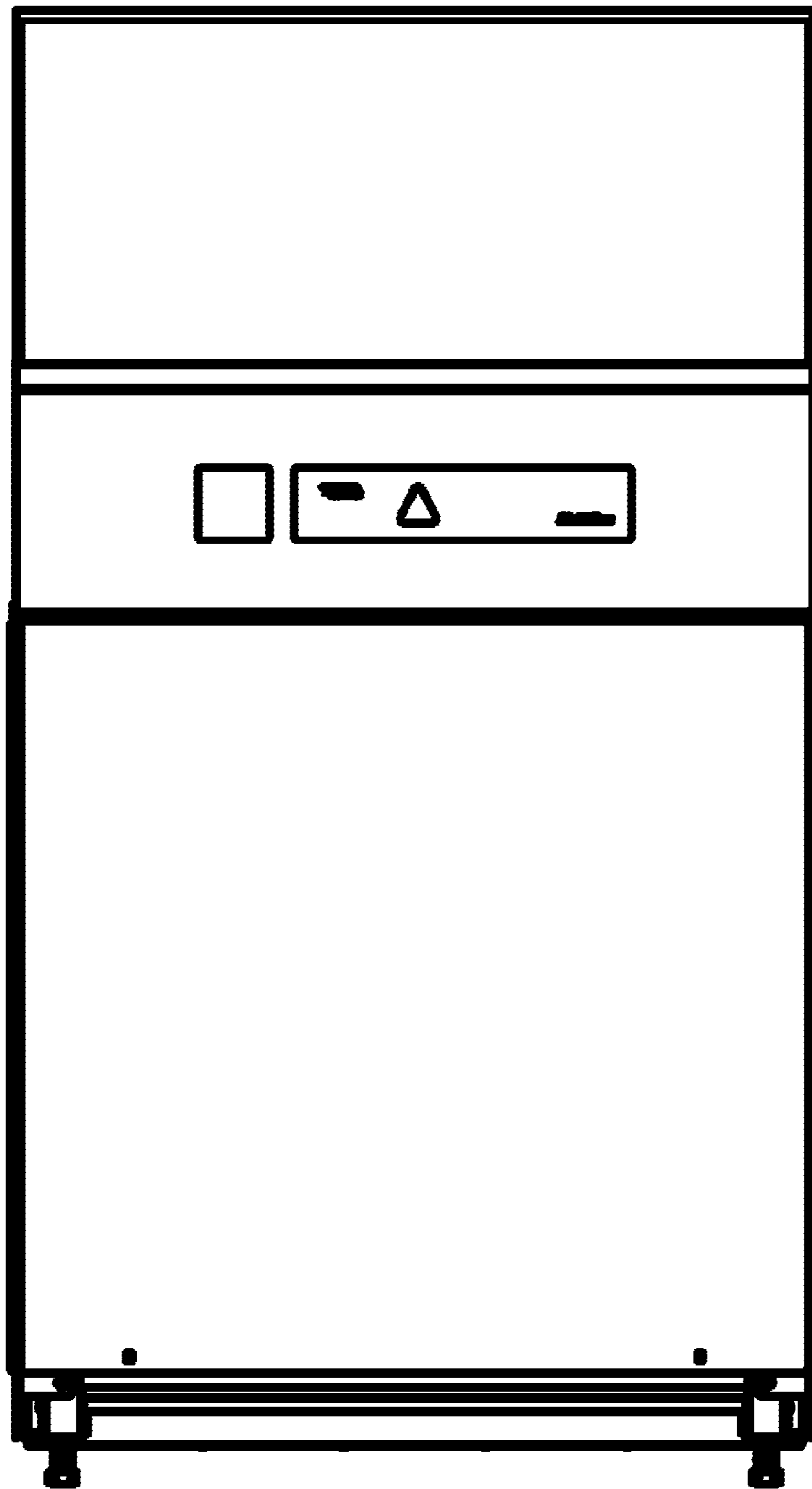

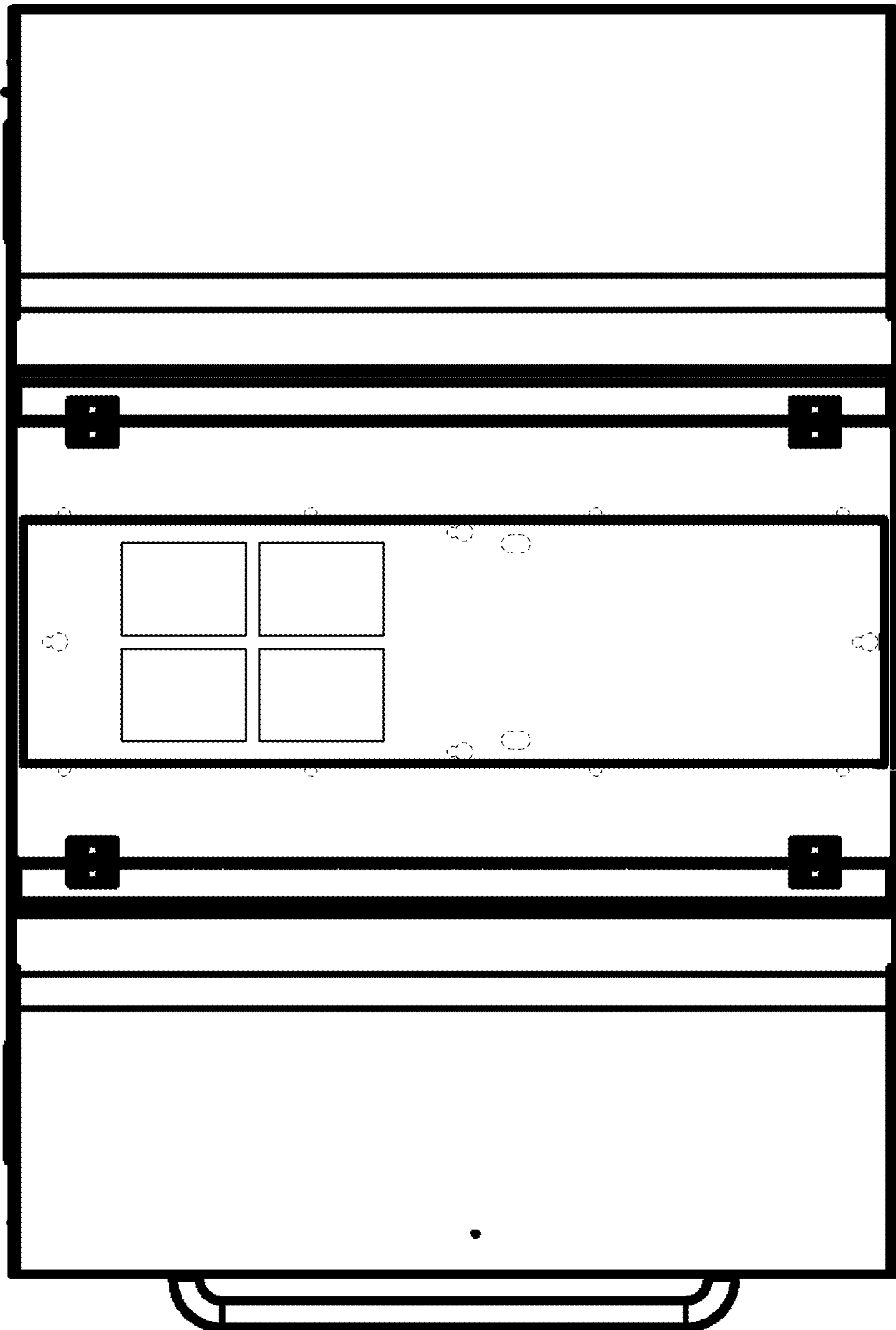
