The ornamental design for an air cleaner, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of an air cleaner showing our new design.

FIG. 2 is a front elevational view thereof.

FIG. 3 is a rear elevational view thereof.

FIG. 4 is a right side elevational view thereof, the left side being a mirror image thereof.

FIG. 5 is a top plan view thereof.

FIG. 6 is a bottom plan view thereof; and,

FIG. 7 is an enlarged perspective view of a portion thereof.

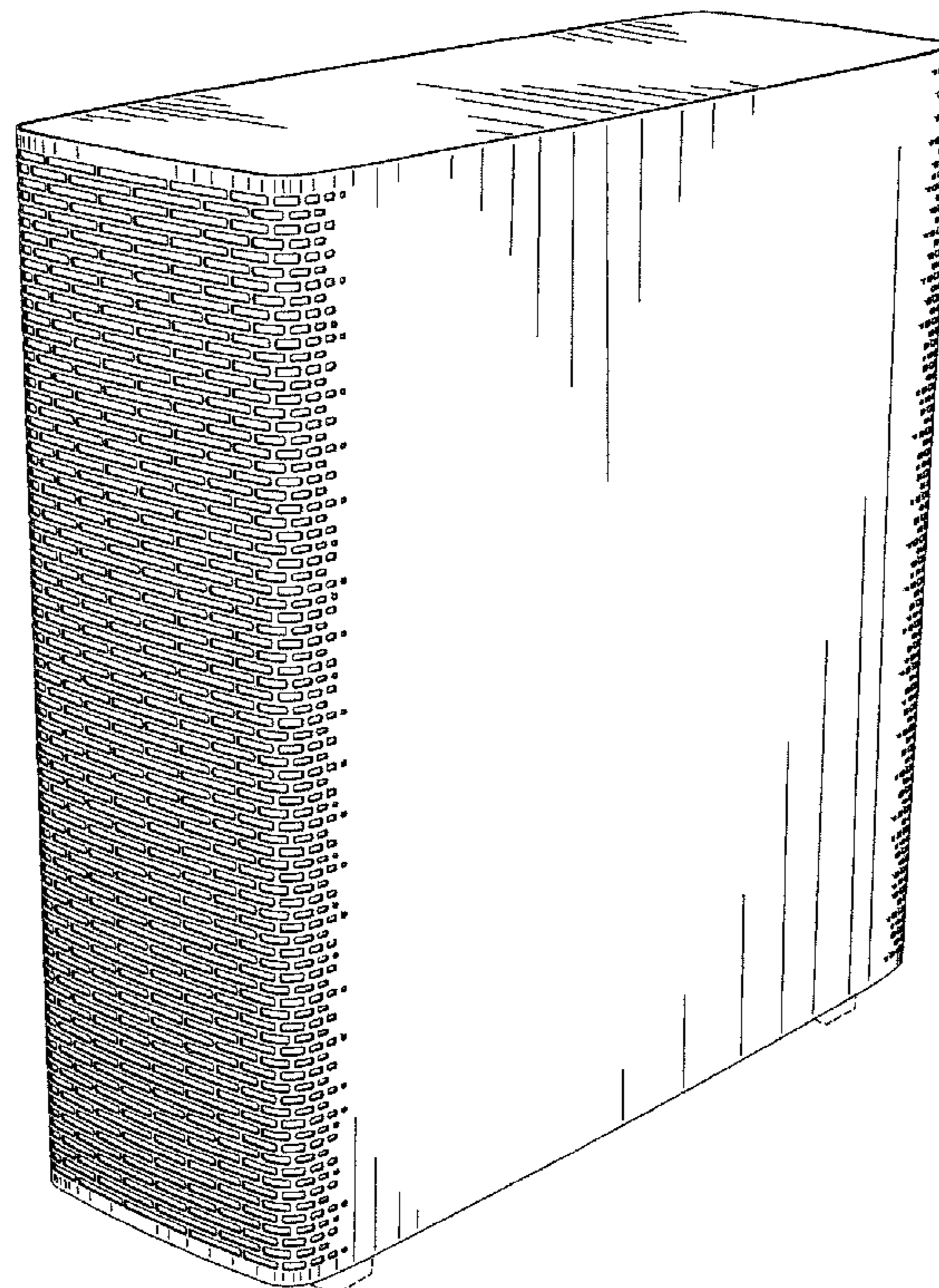
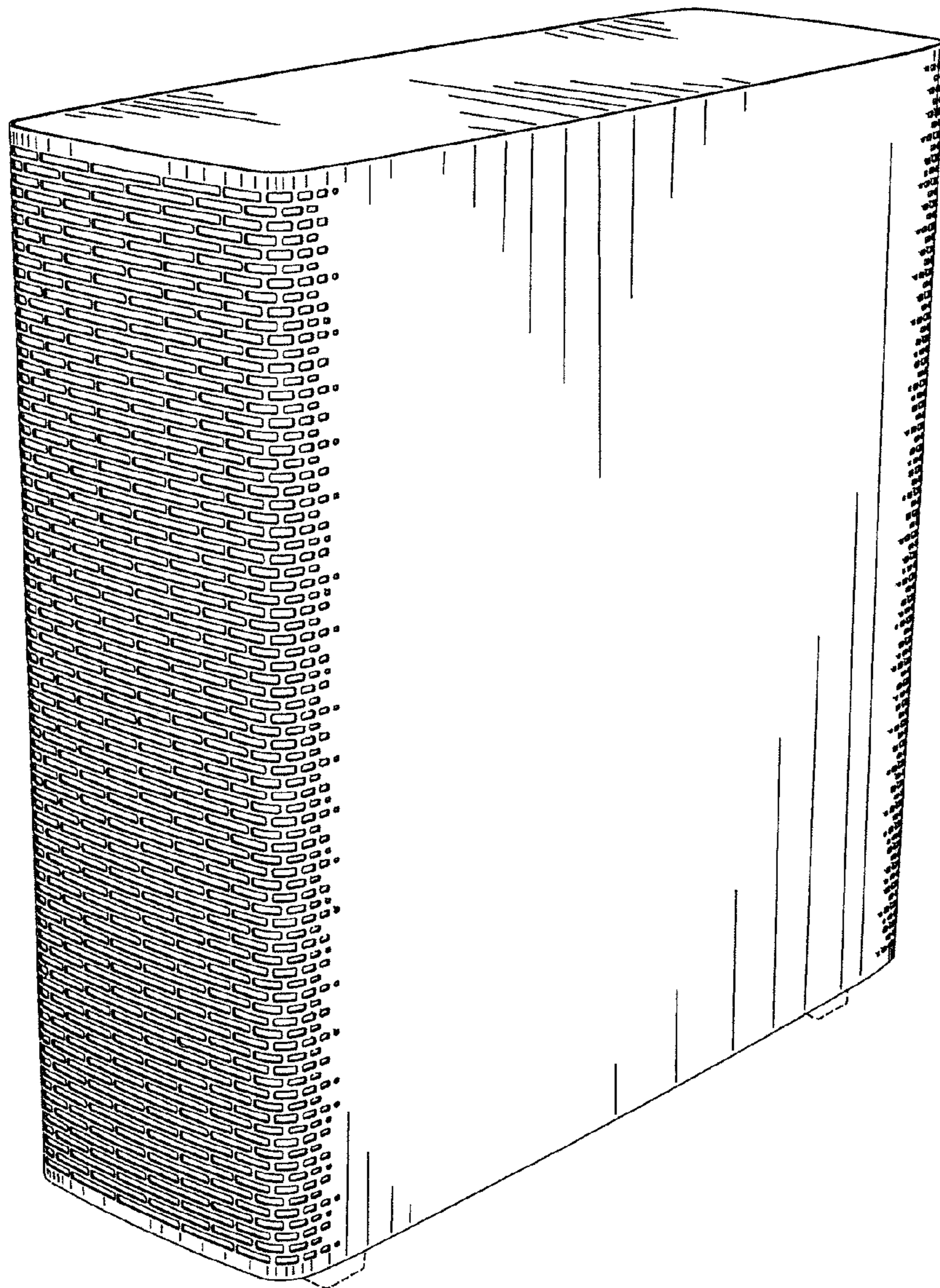

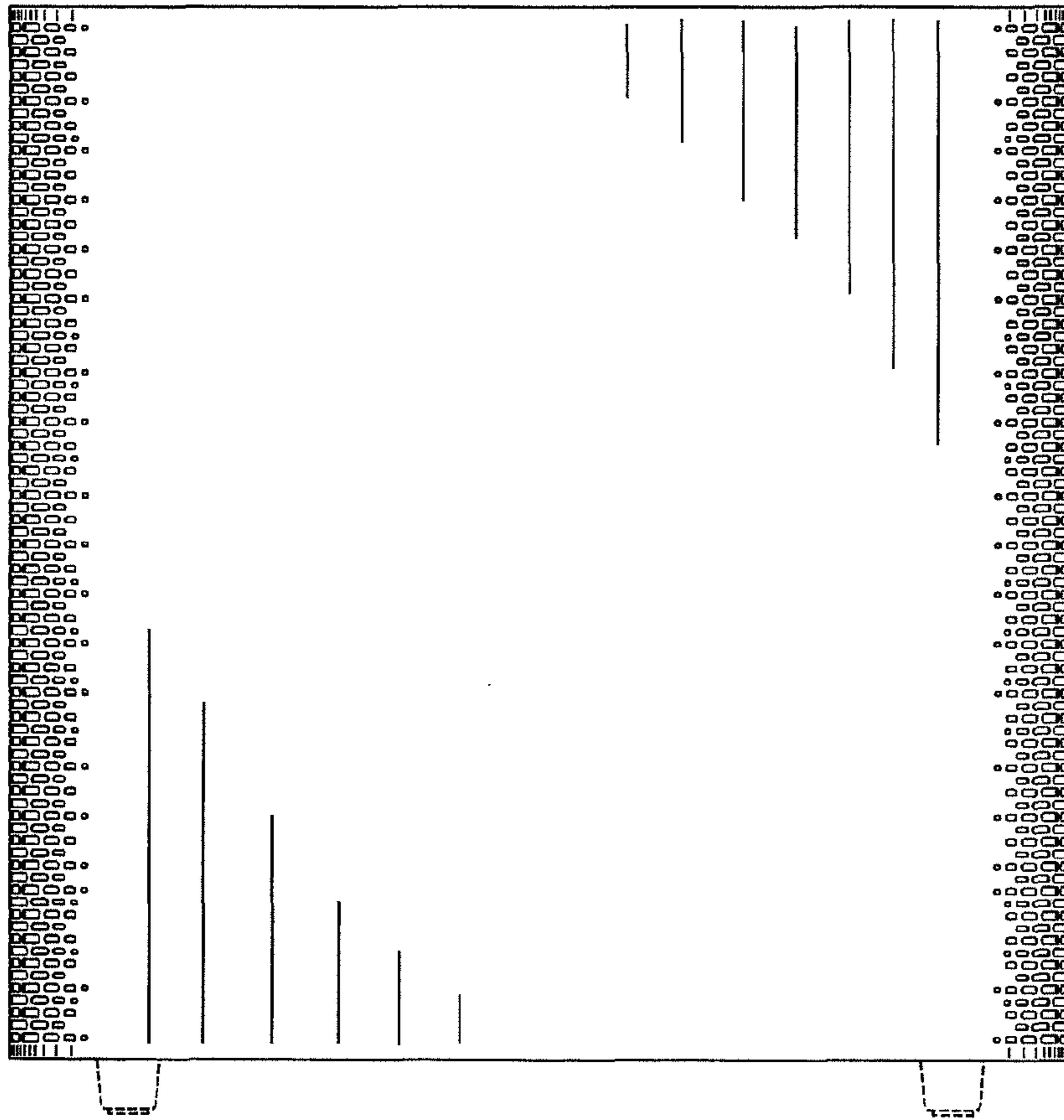

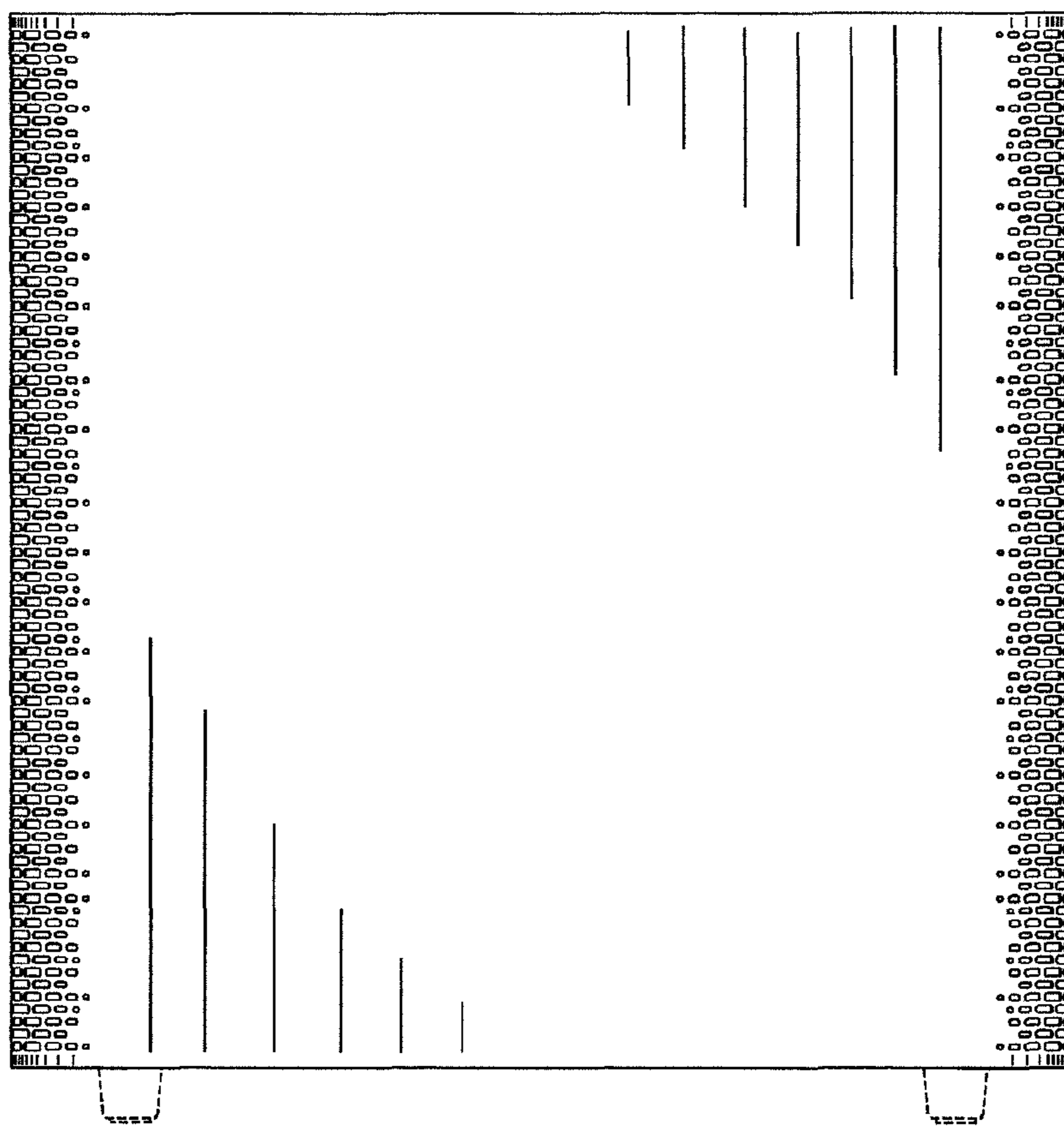

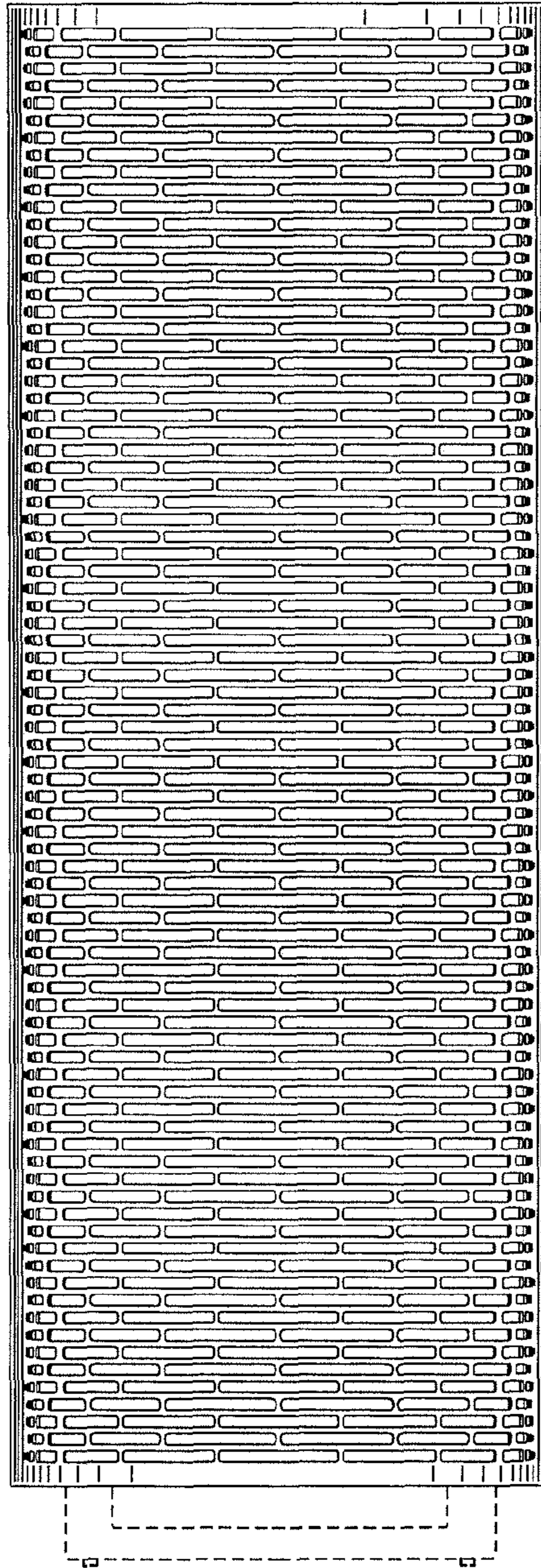

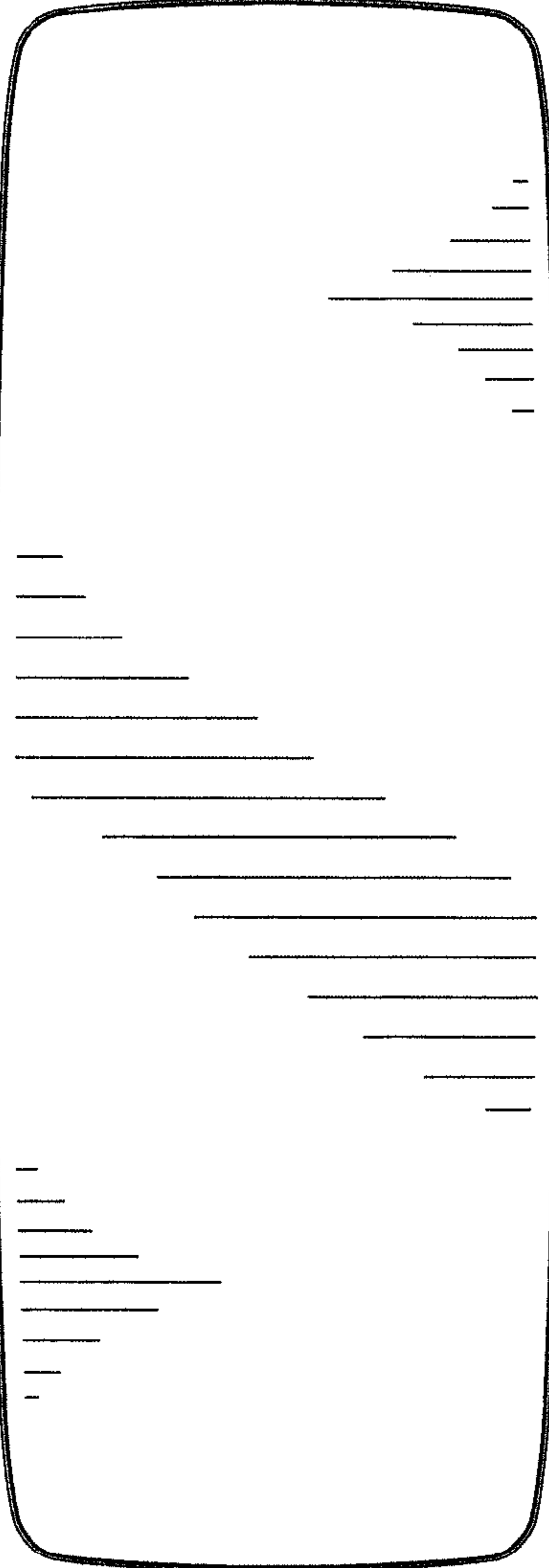

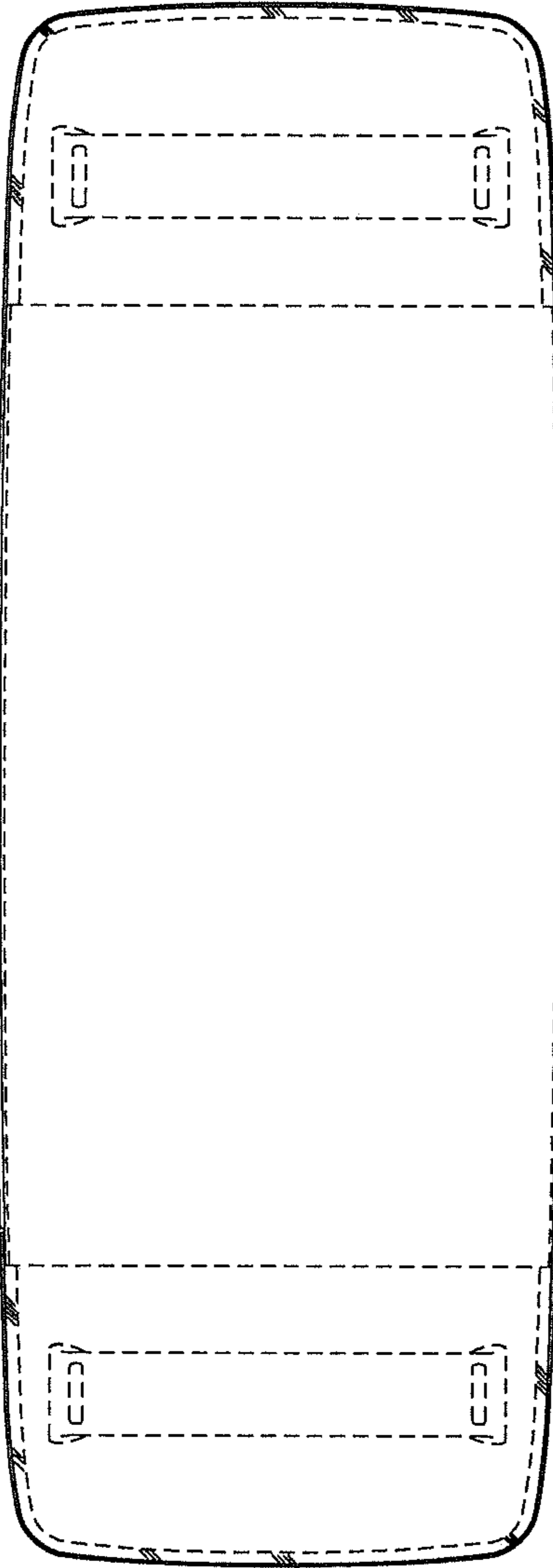
