(57) **CLAIM**

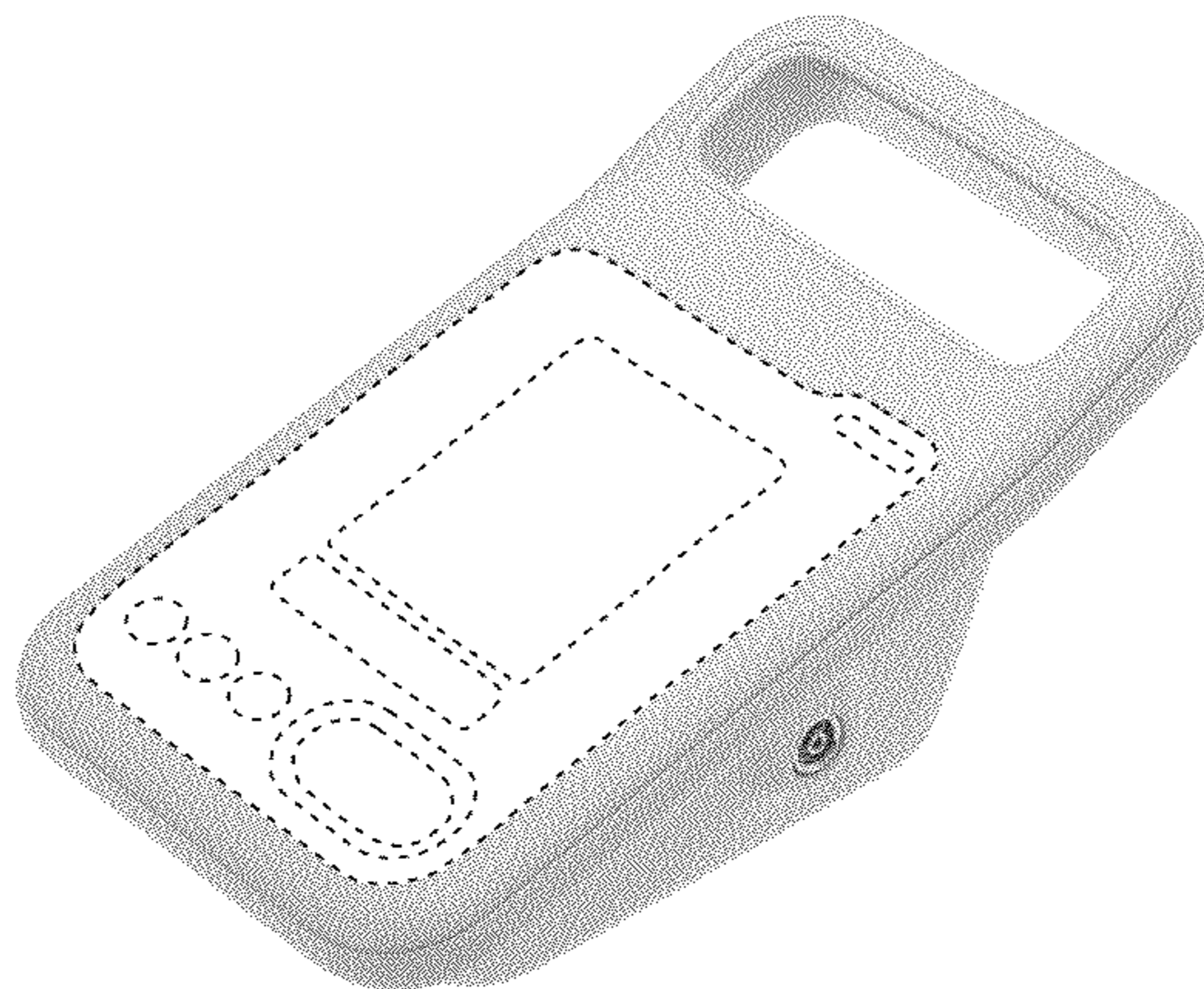
The ornamental design for a sphygmomanometer, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, top, and right side perspective view of a sphygmomanometer showing our new design;  
FIG. 2 is a rear, bottom, and left side perspective view thereof;  
FIG. 3 is a front view thereof;  
FIG. 4 is a rear view thereof;  
FIG. 5 is a top view thereof;  
FIG. 6 is a bottom view thereof;  
FIG. 7 is a right side view thereof; and,  
FIG. 8 is a left side view thereof.

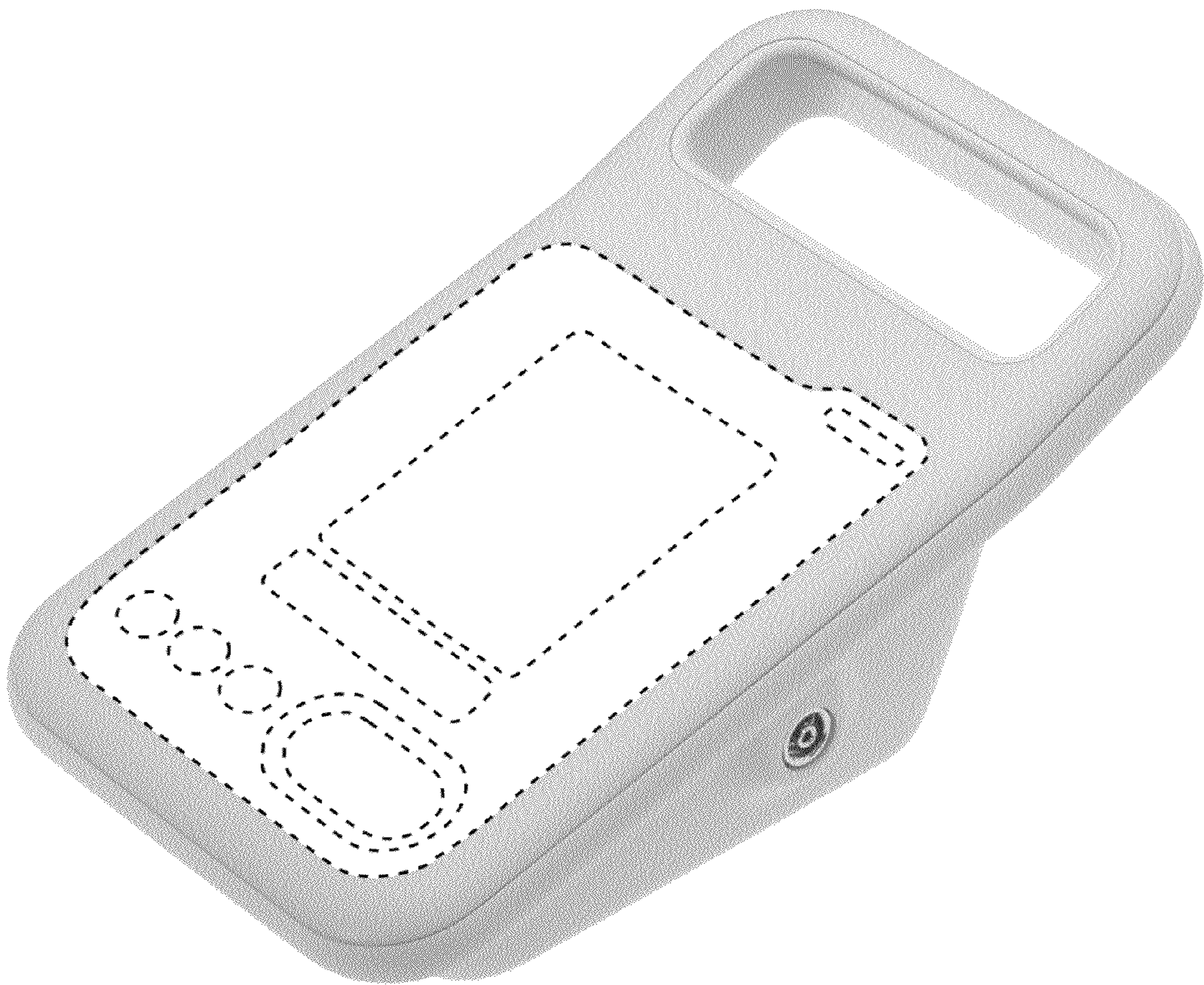

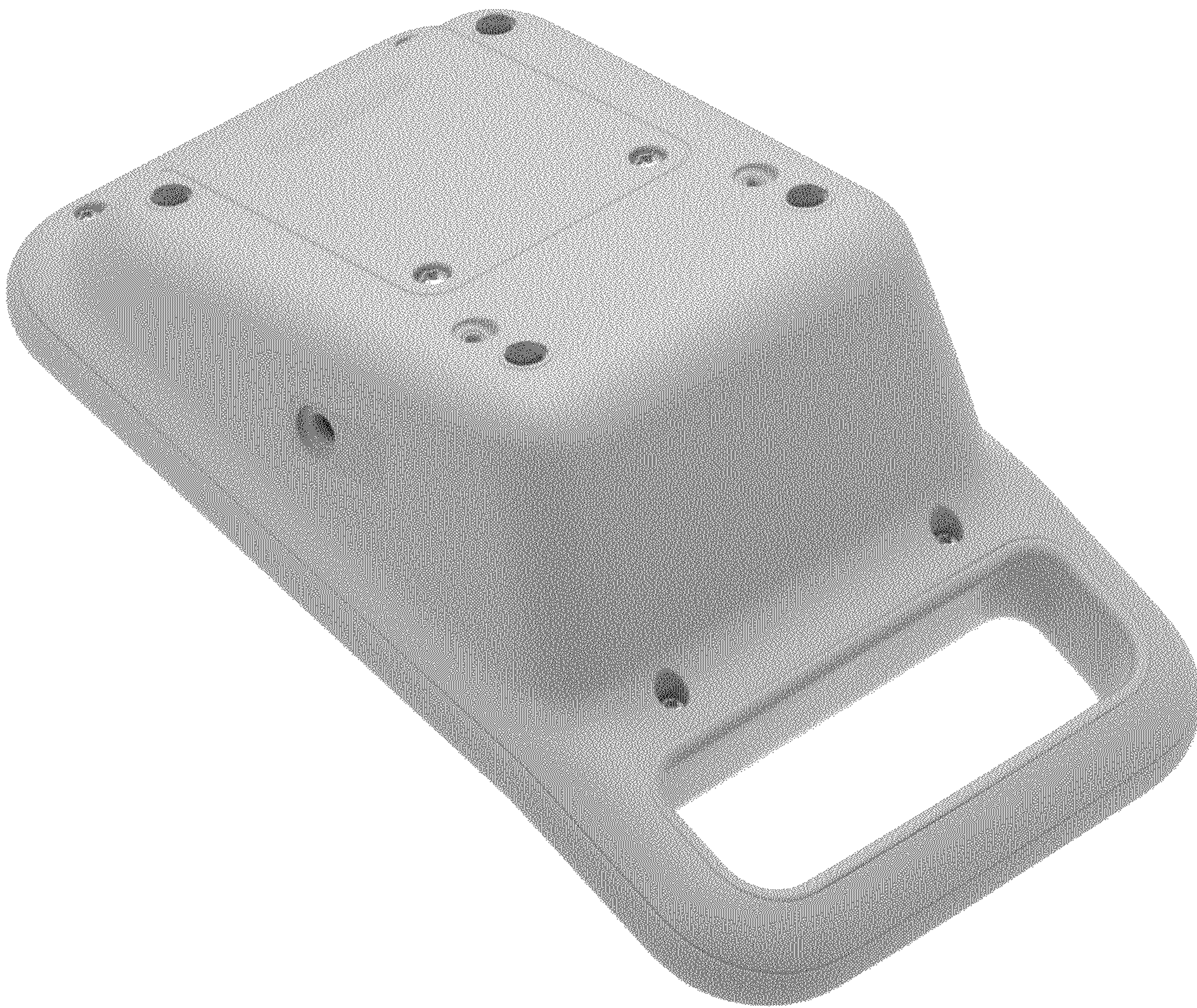

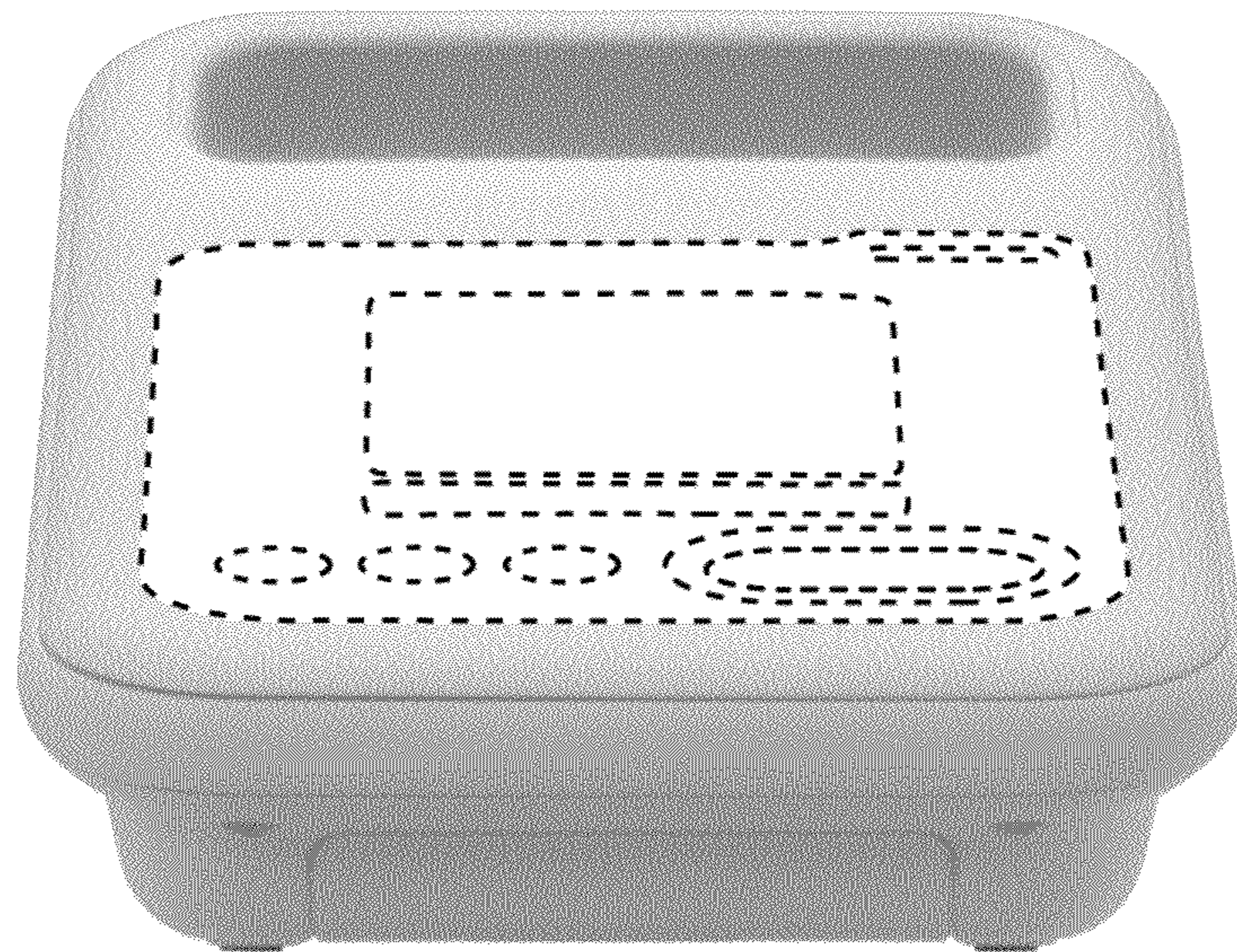

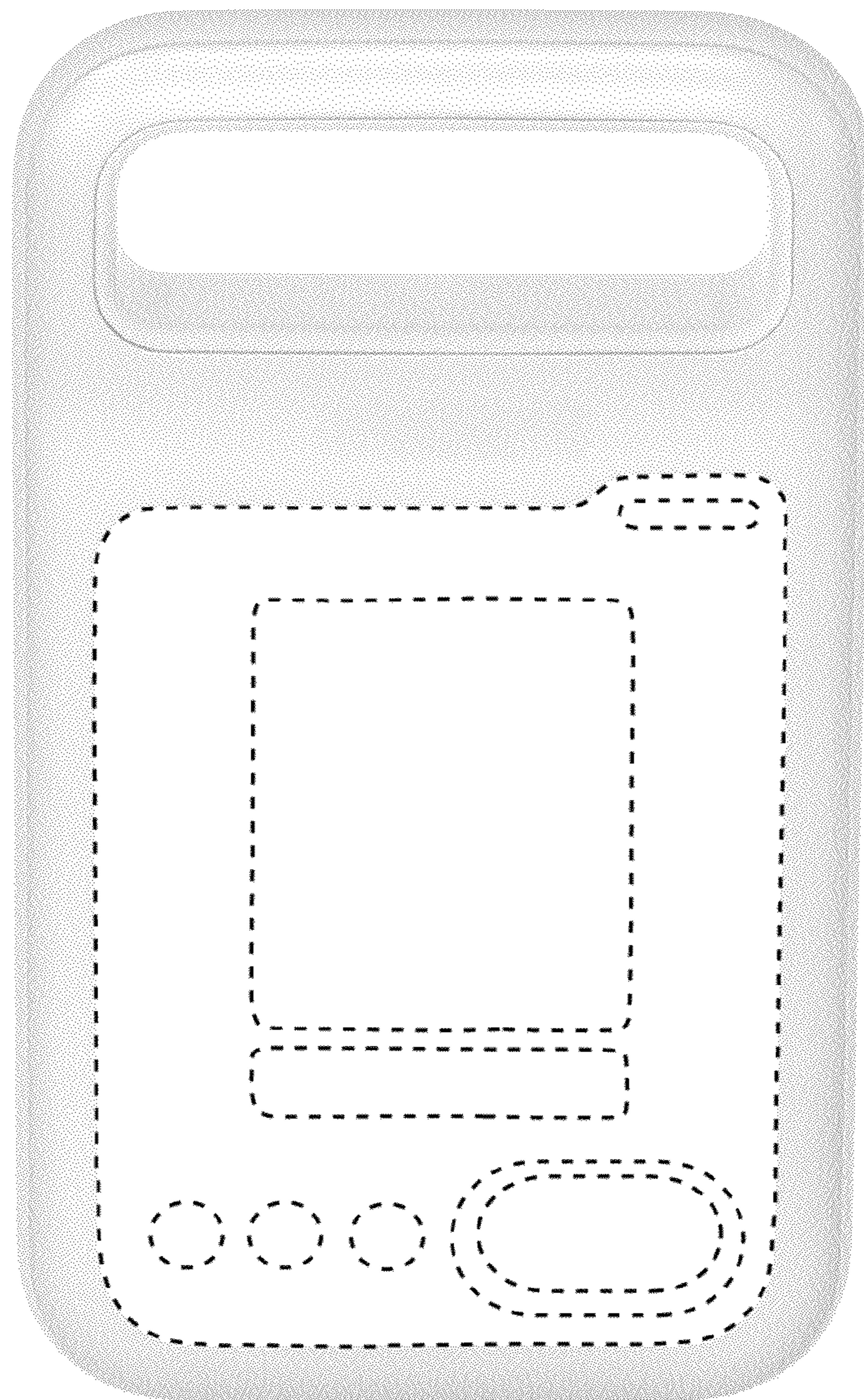
