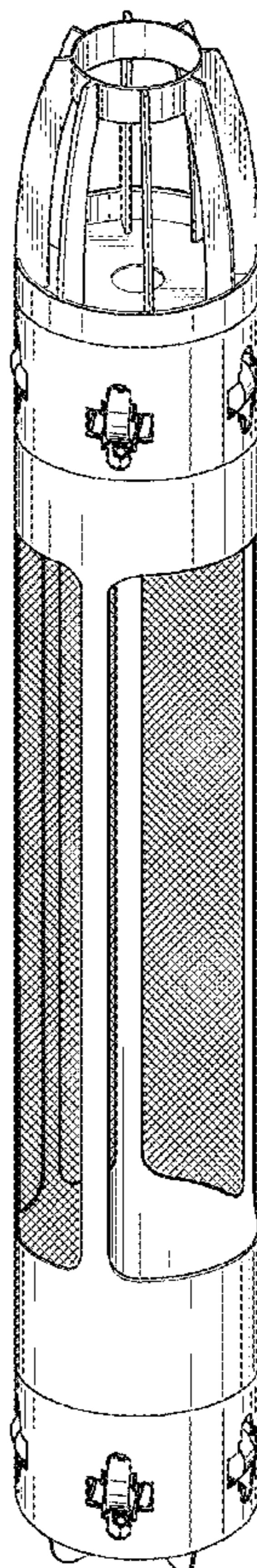
(57) **CLAIM**

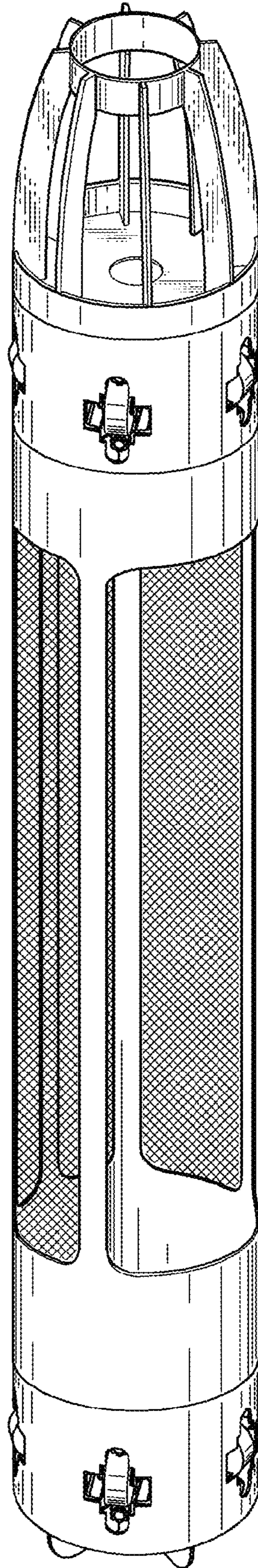
The ornamental design of a mine shaft rescue capsule design, as shown and described.

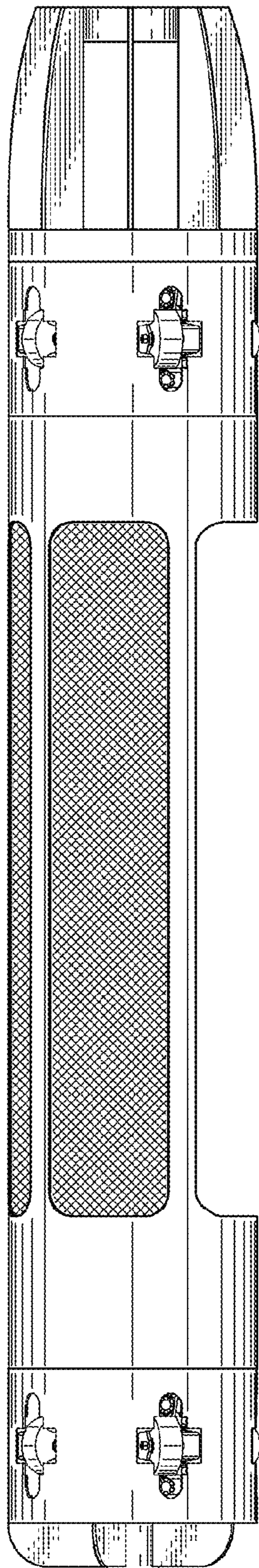

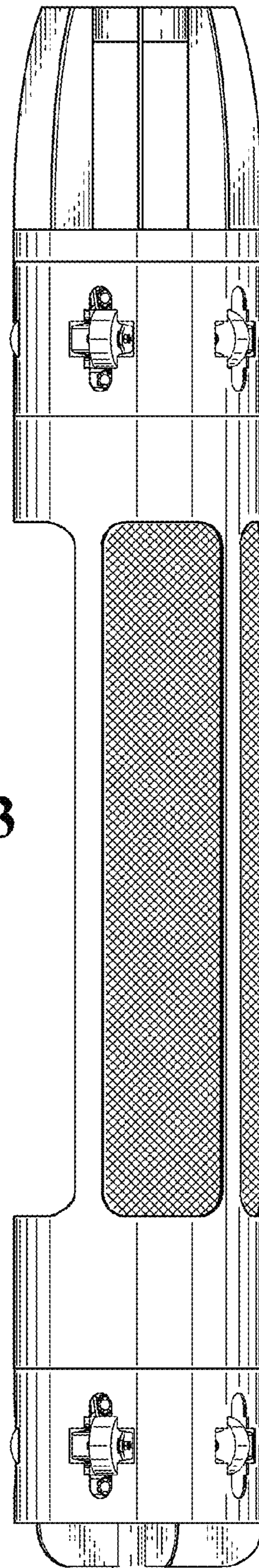

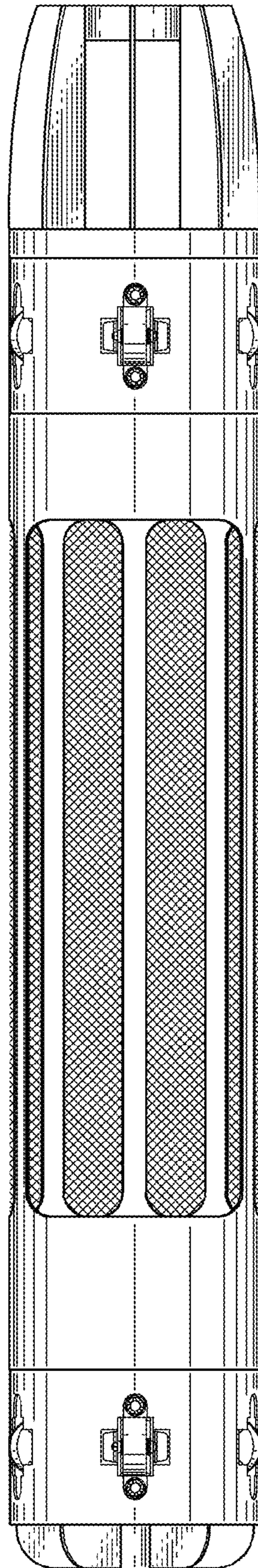
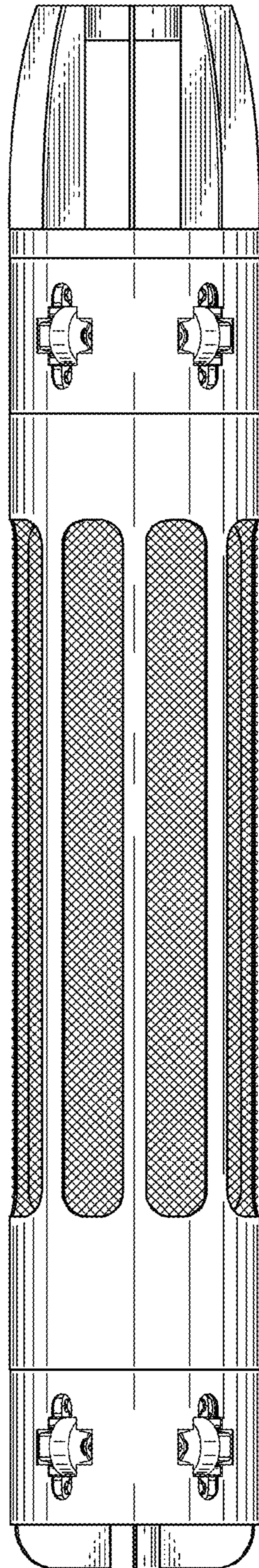
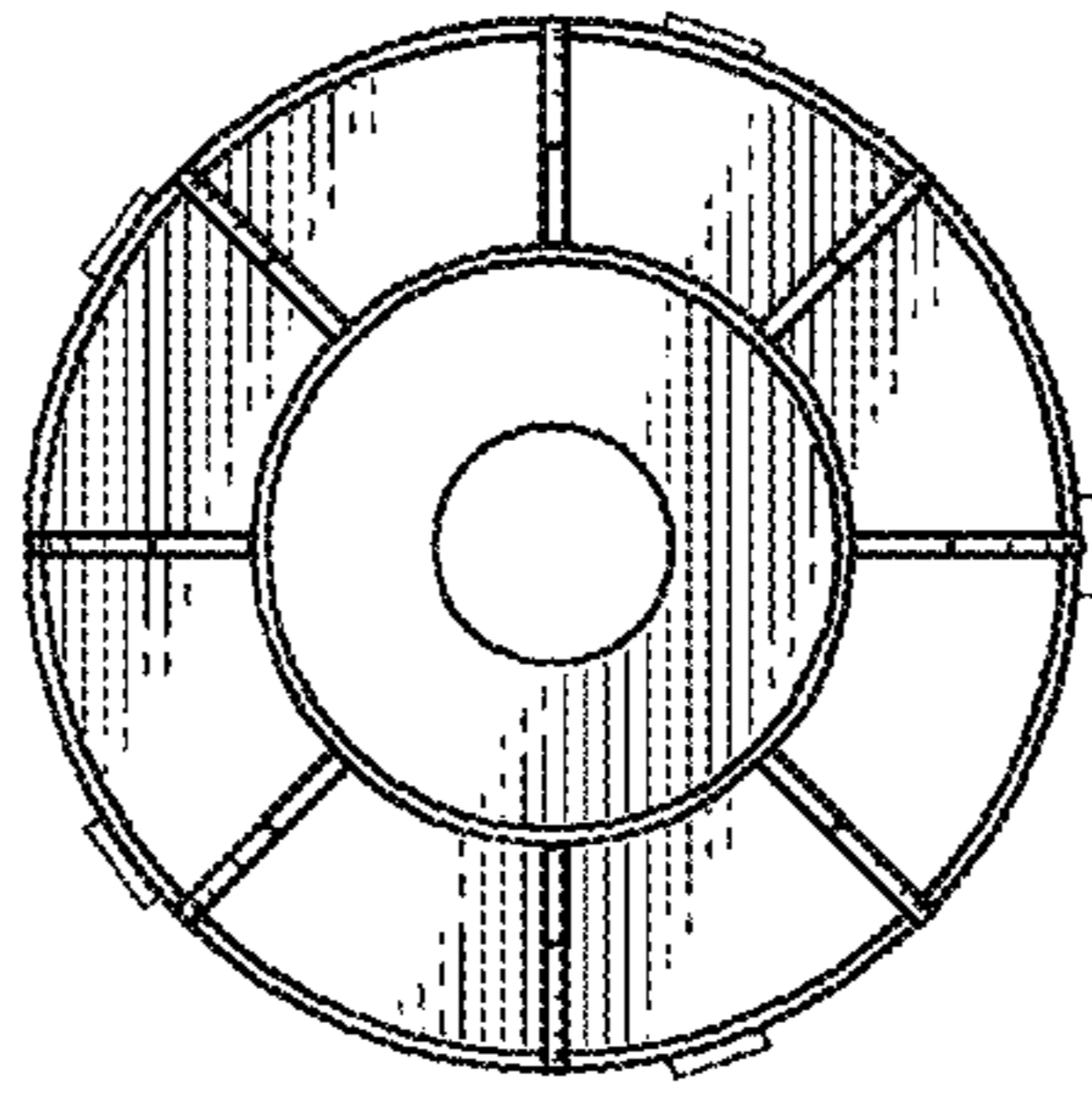
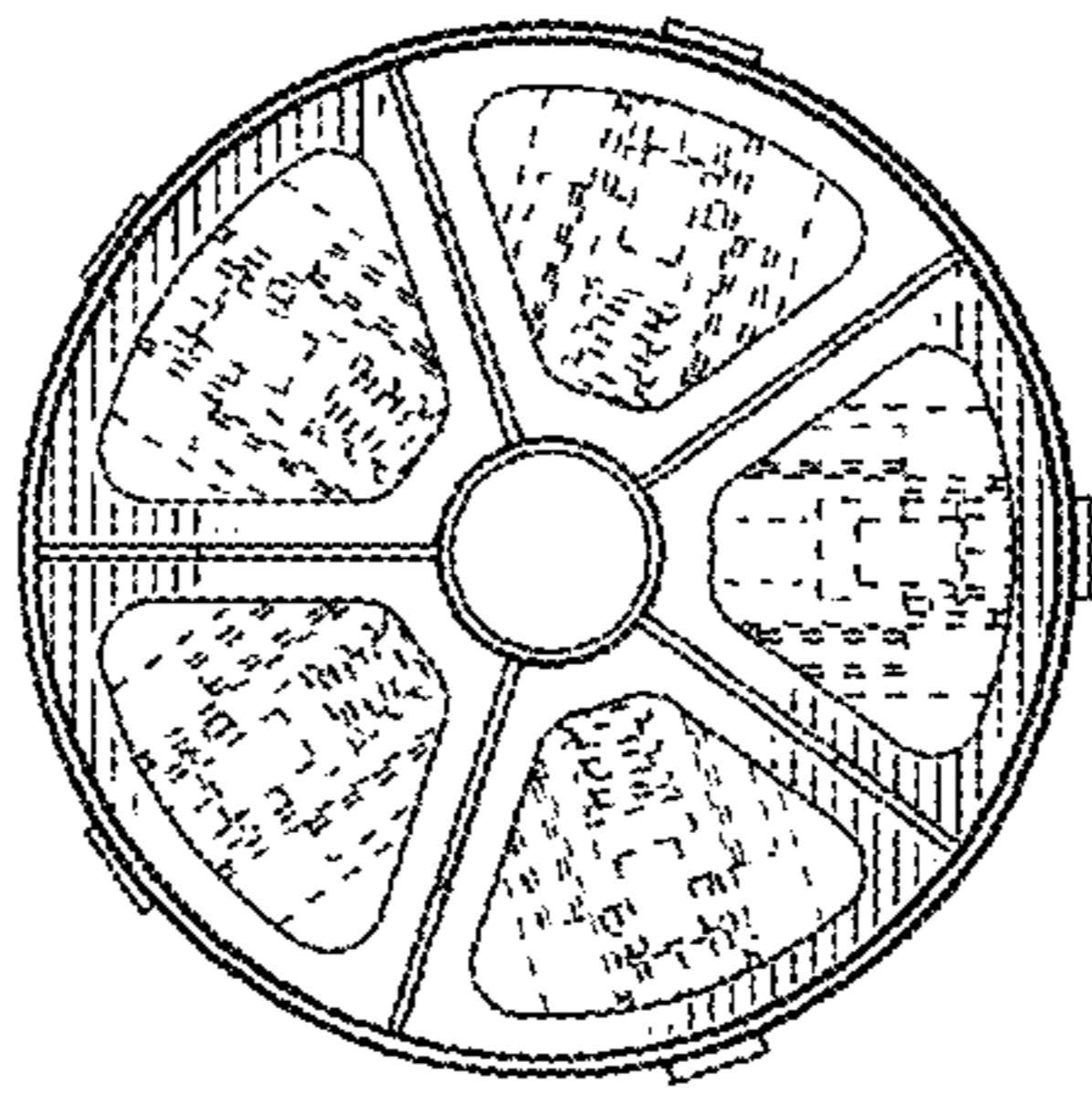
