**DESCRIPTION**

FIG. 1 is a front perspective view of our design;

FIG. 5 is a bottom elevational view;

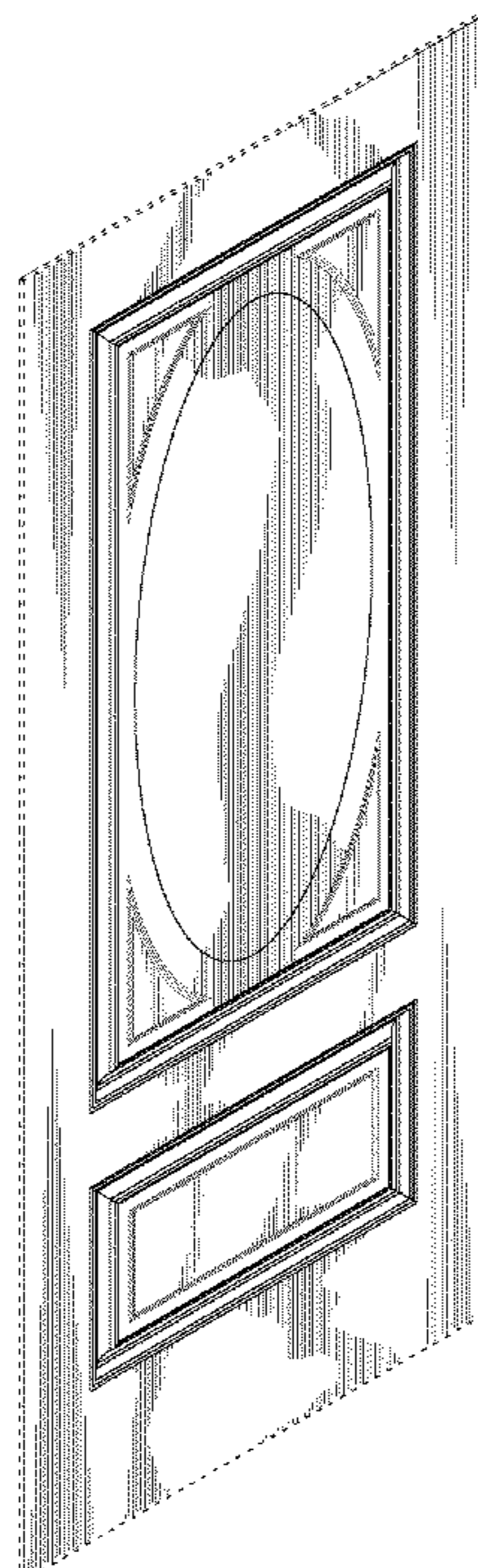

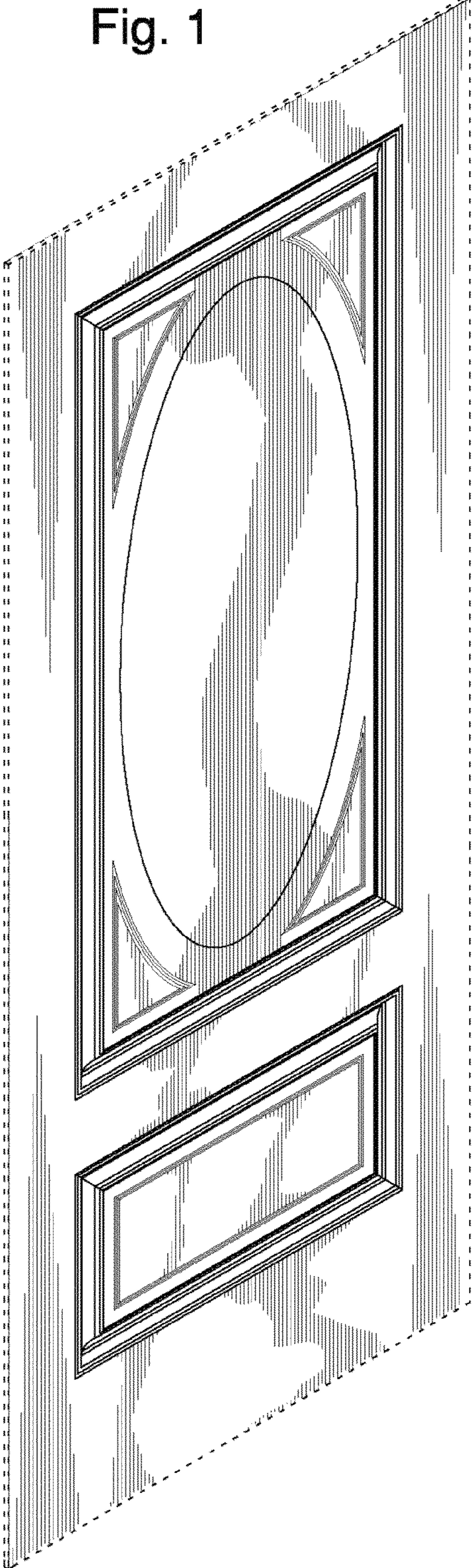

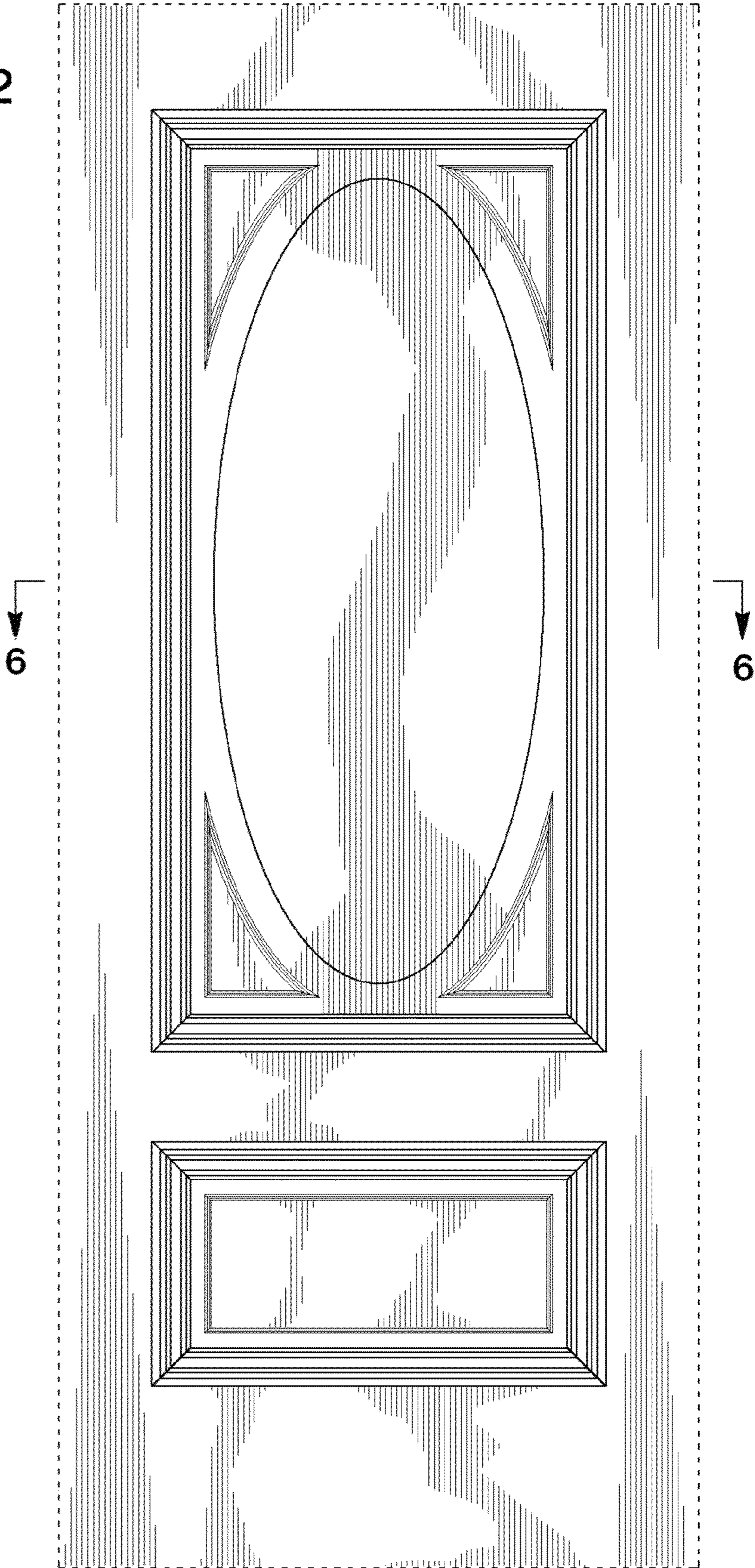

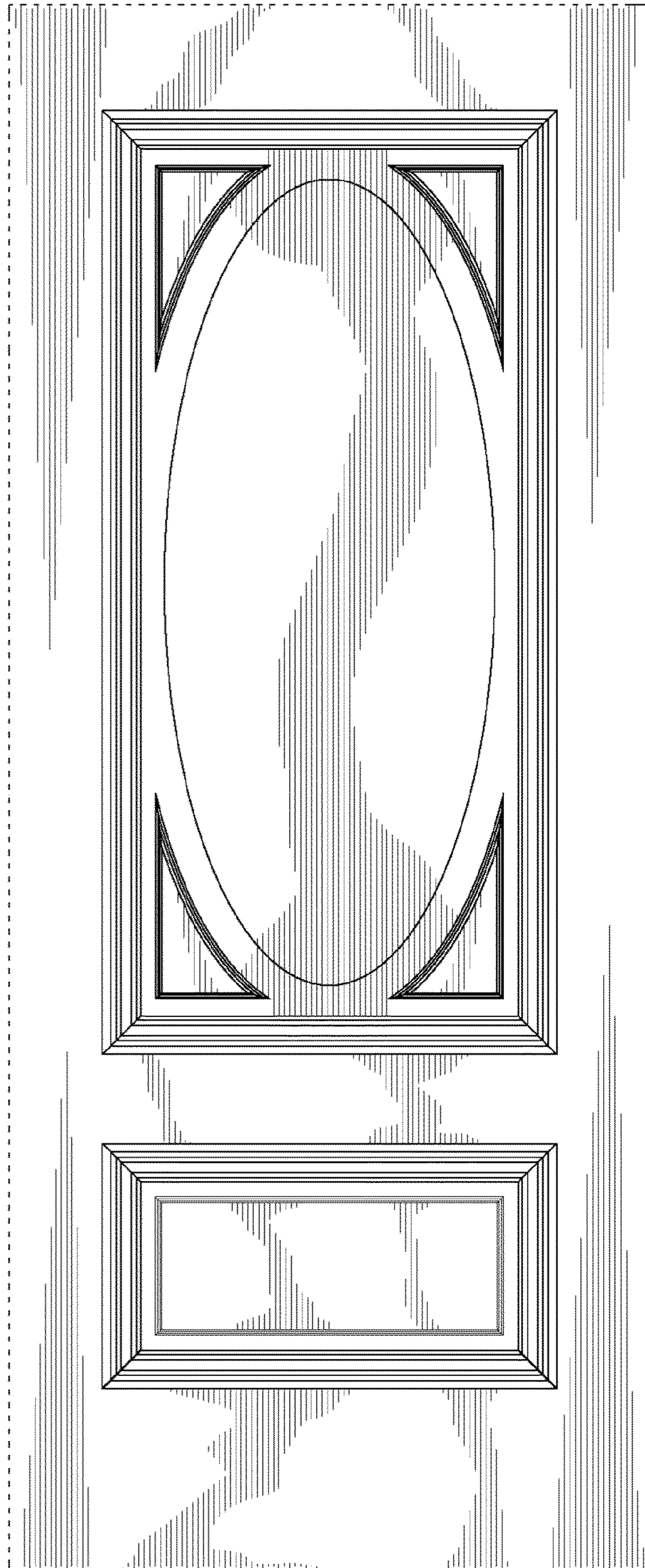

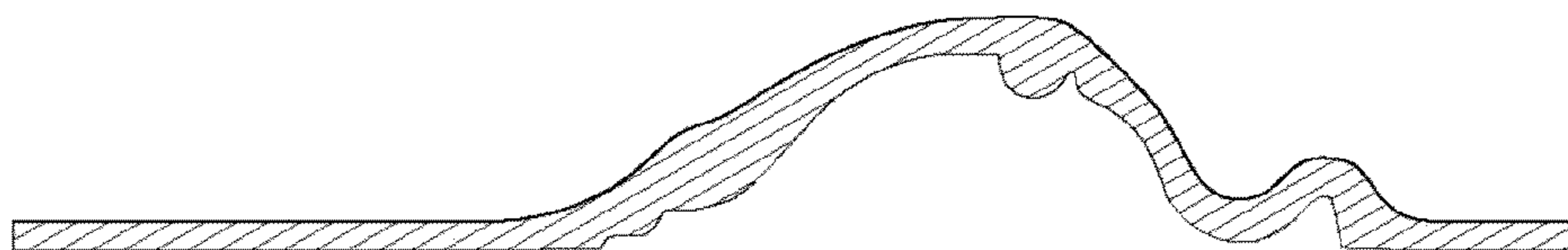
