DESCRIPTION

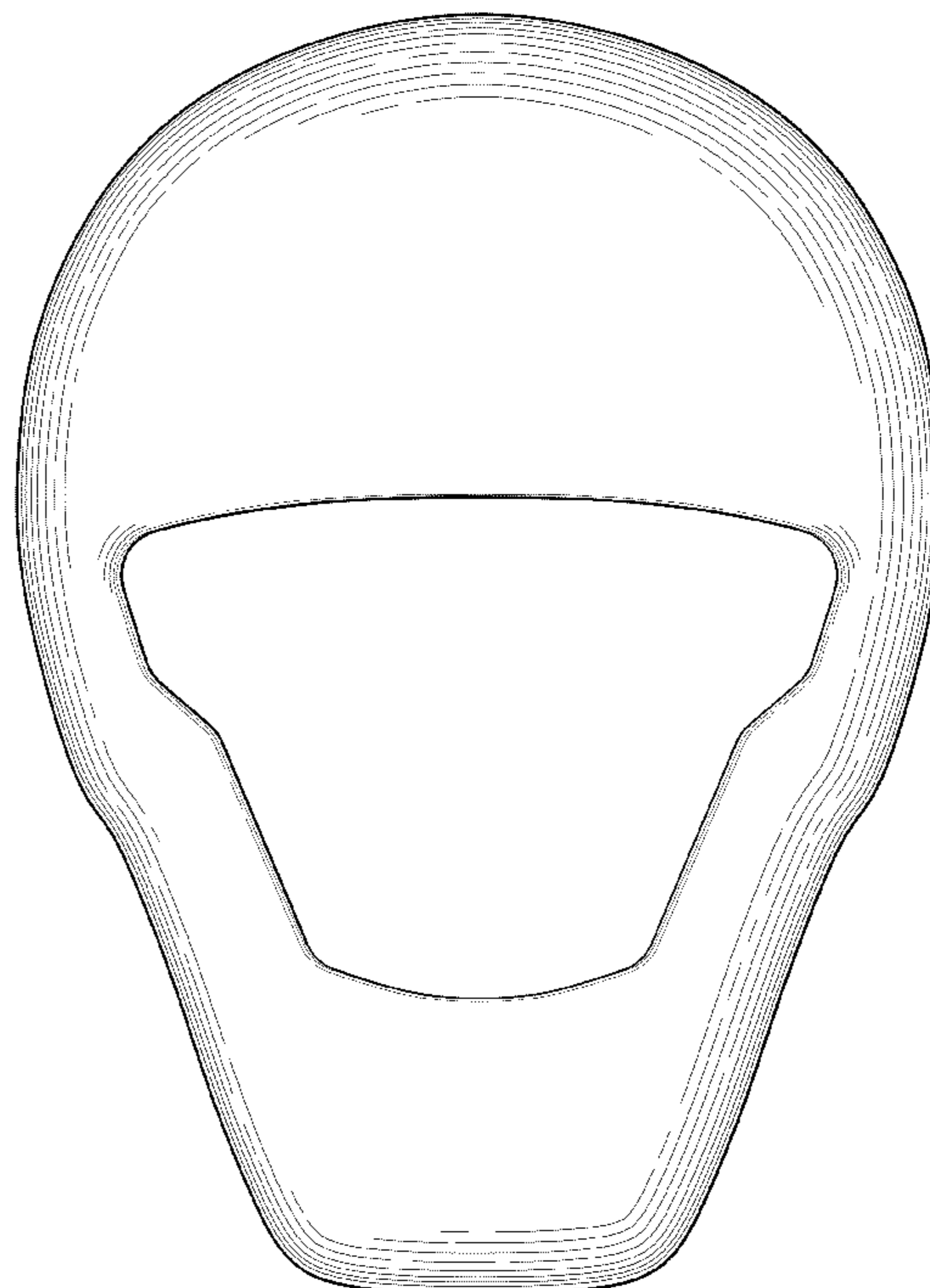
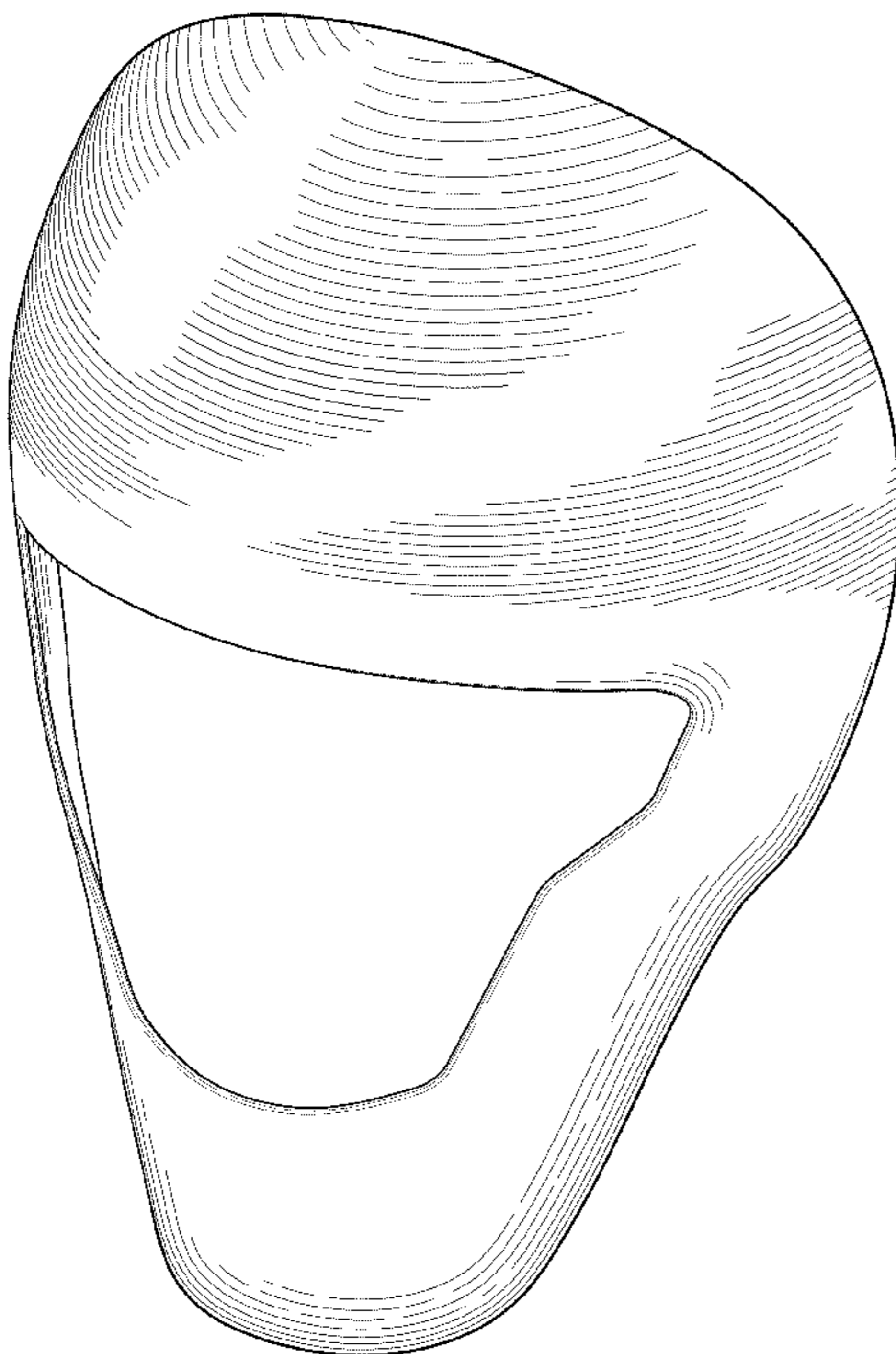
FIG. 1 is a perspective view of a sports fan novelty mask showing my new design, with a mask cage shown in broken lines that is not a part of the design;

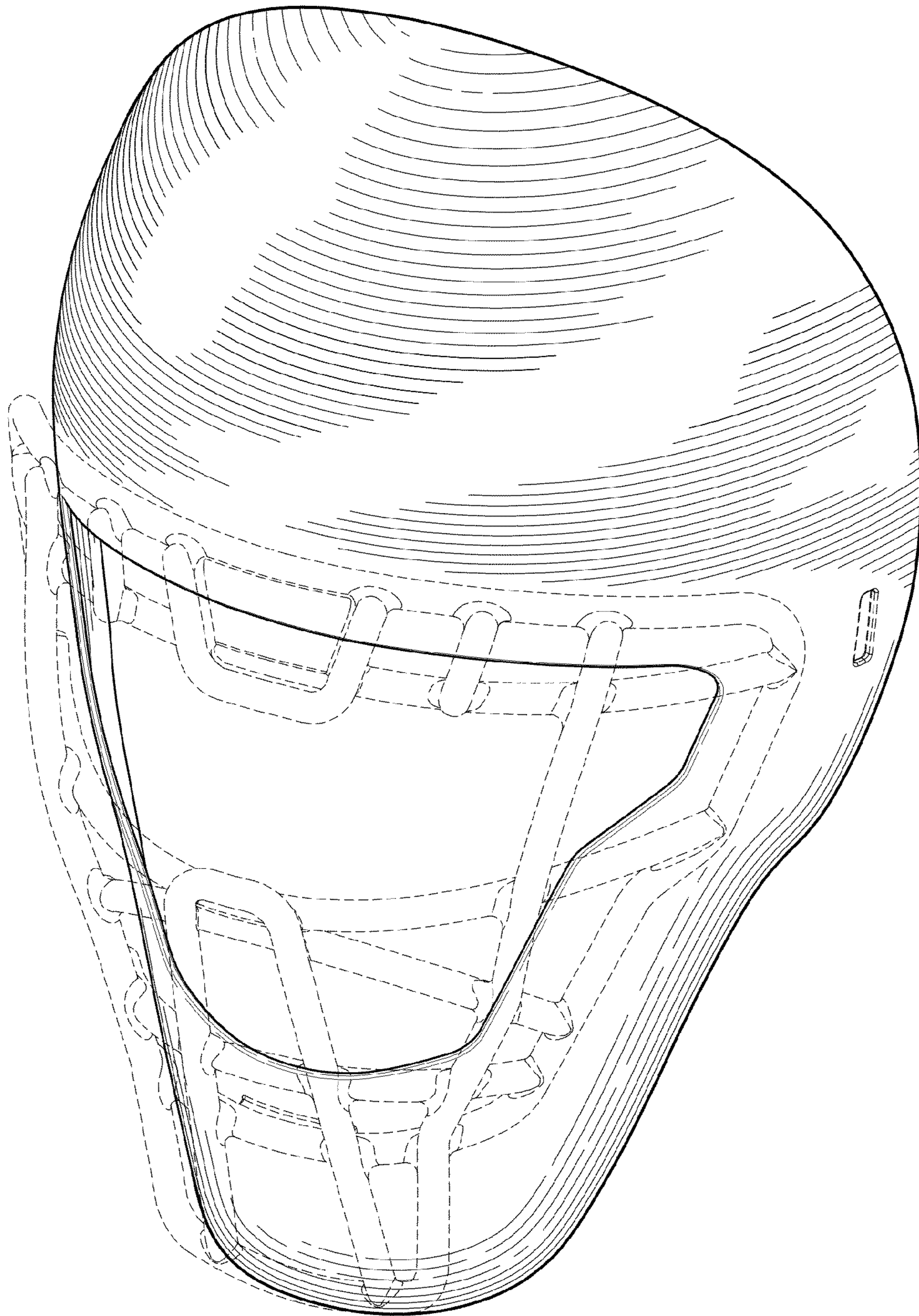

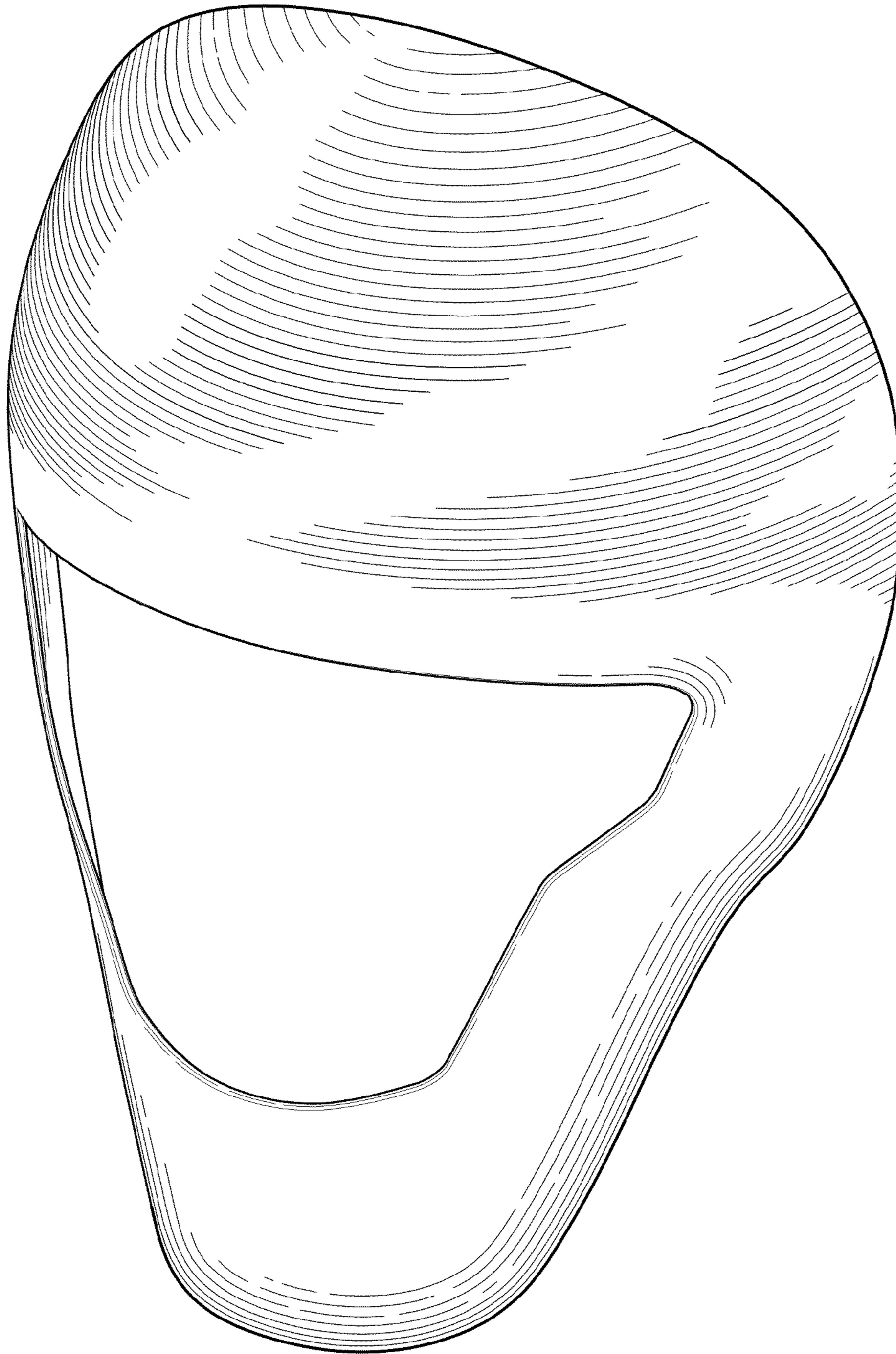

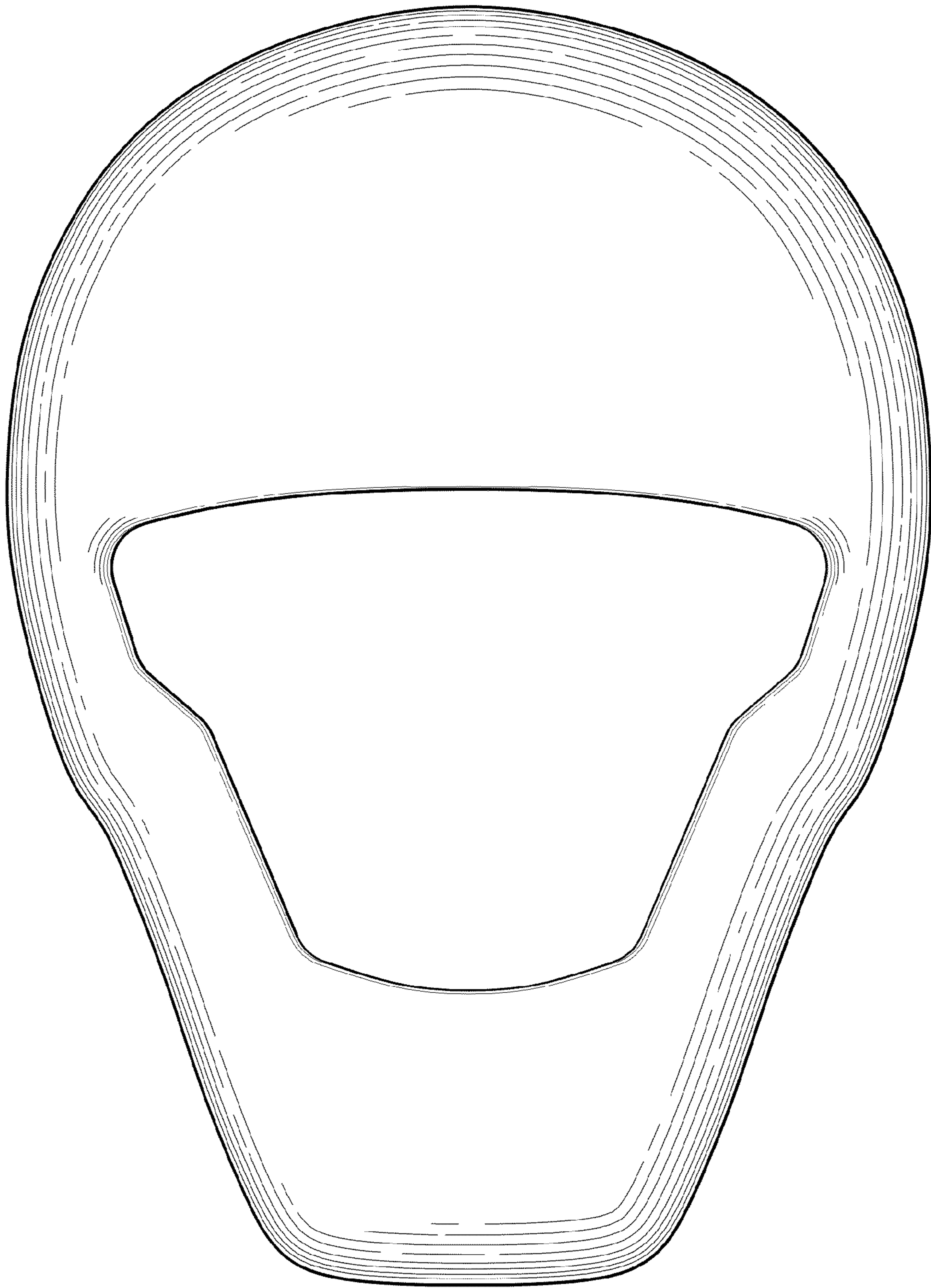

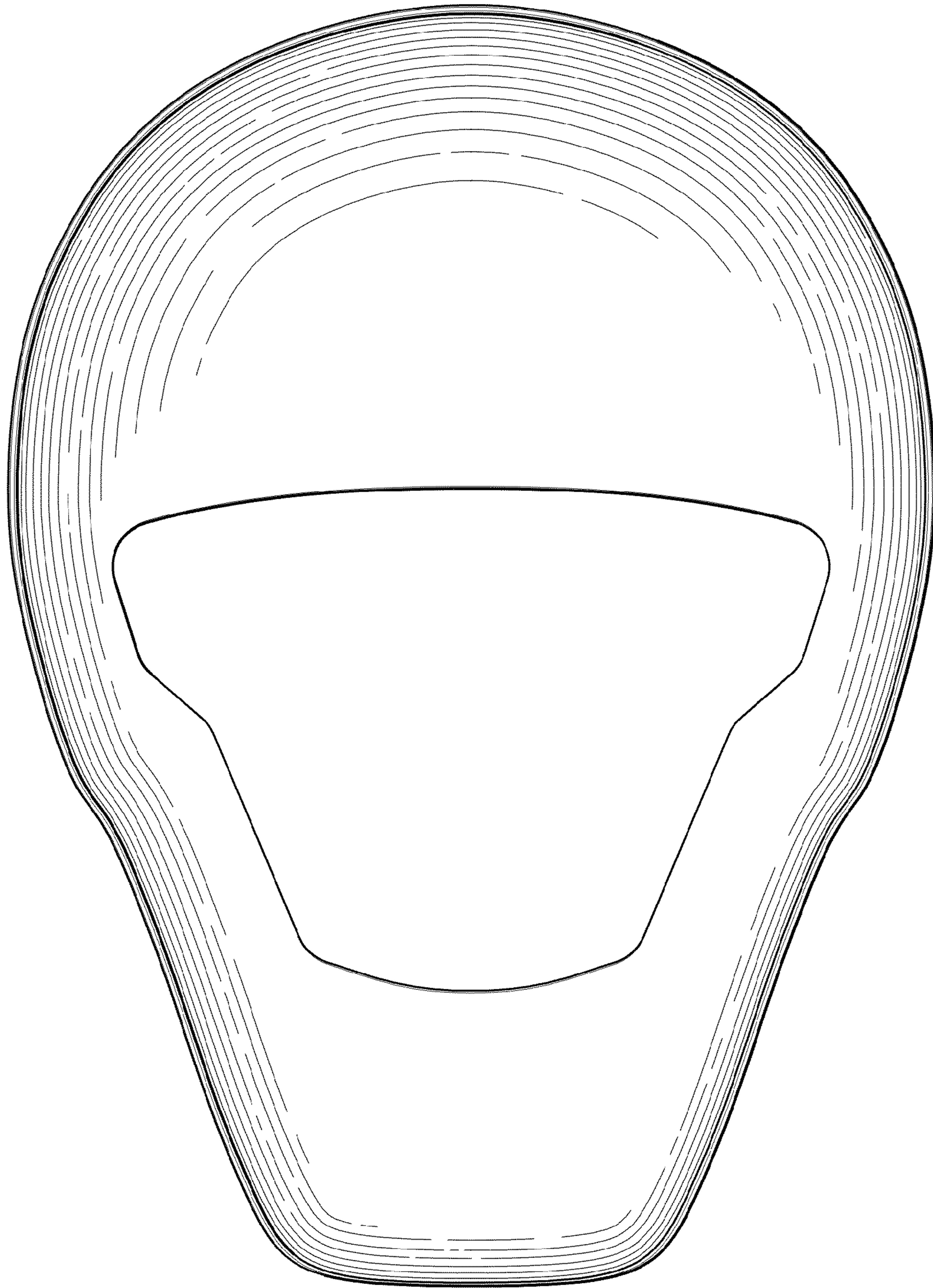

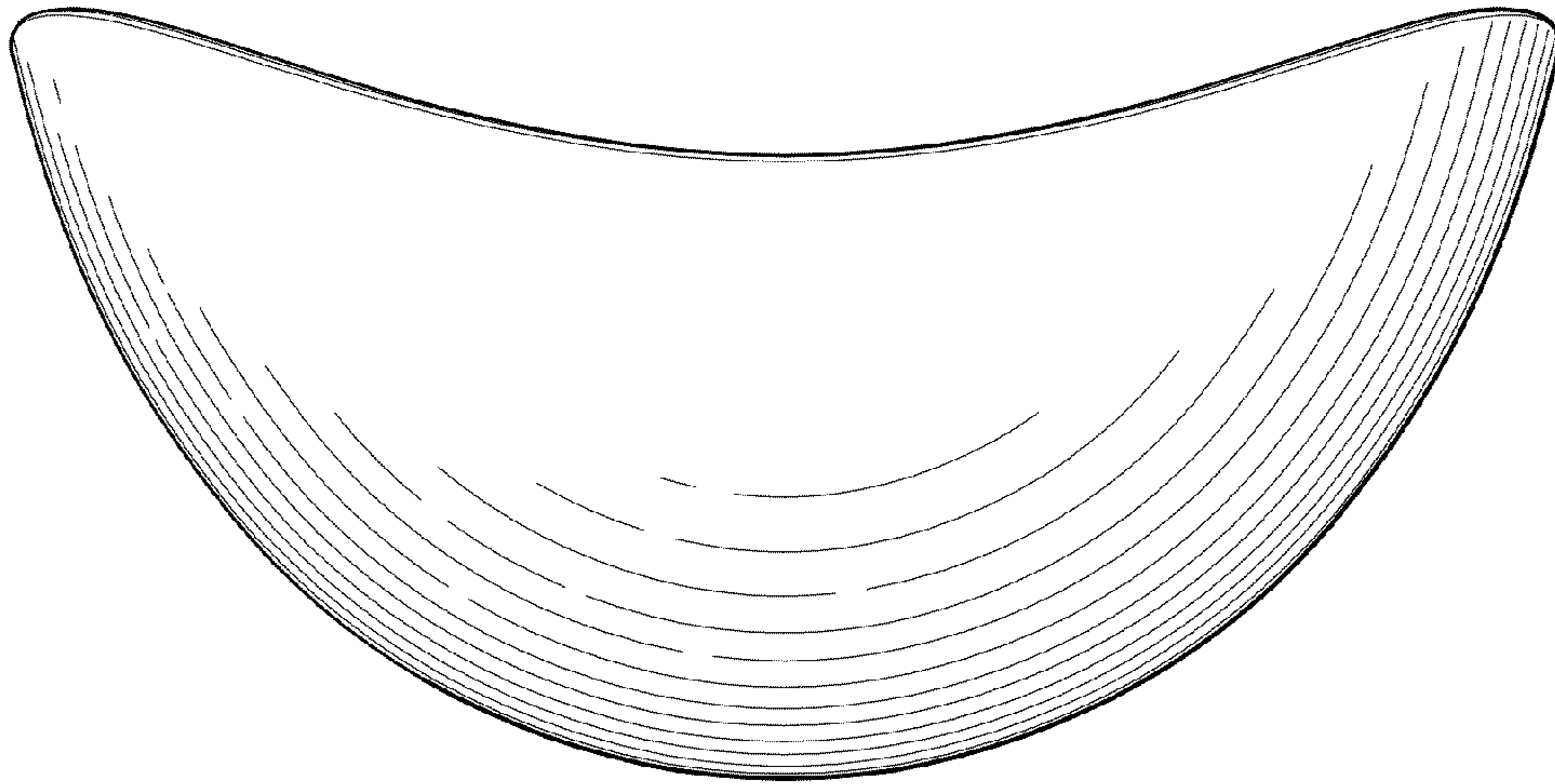

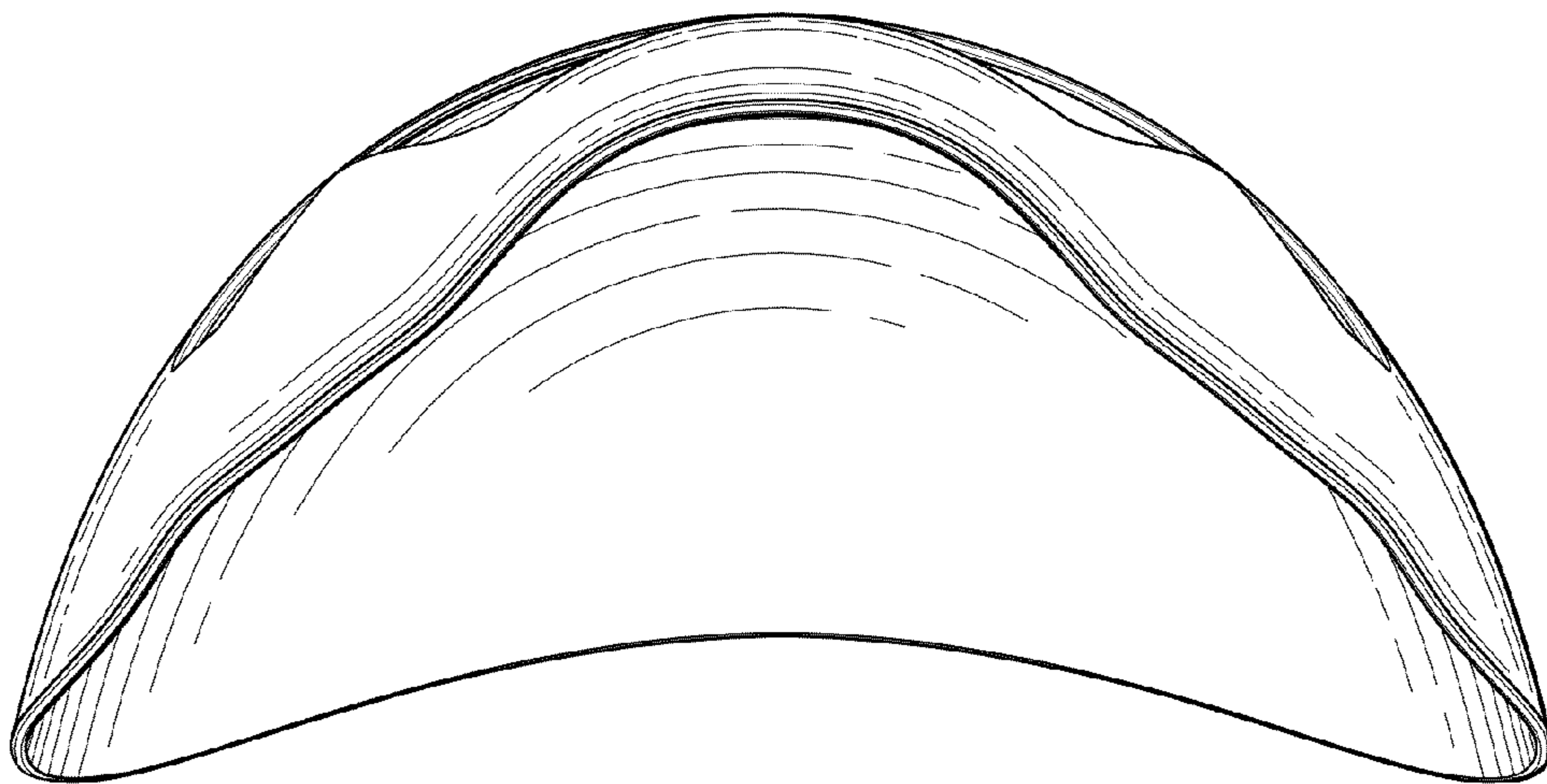

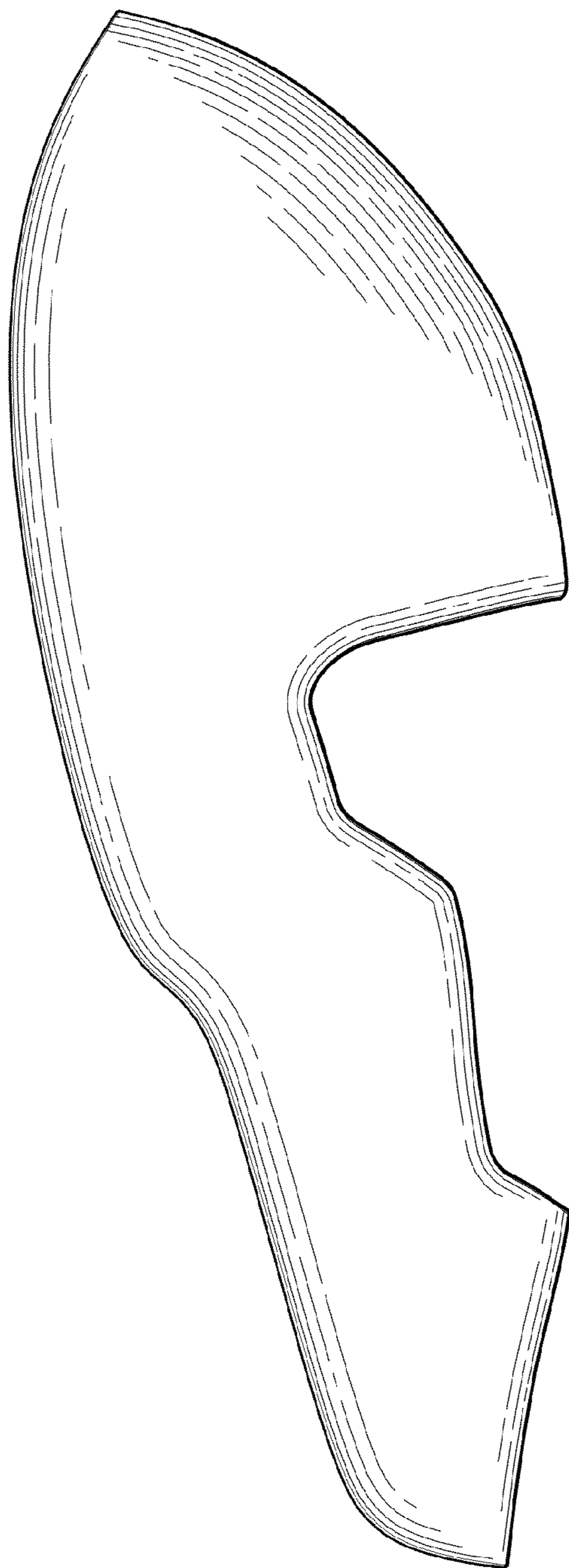

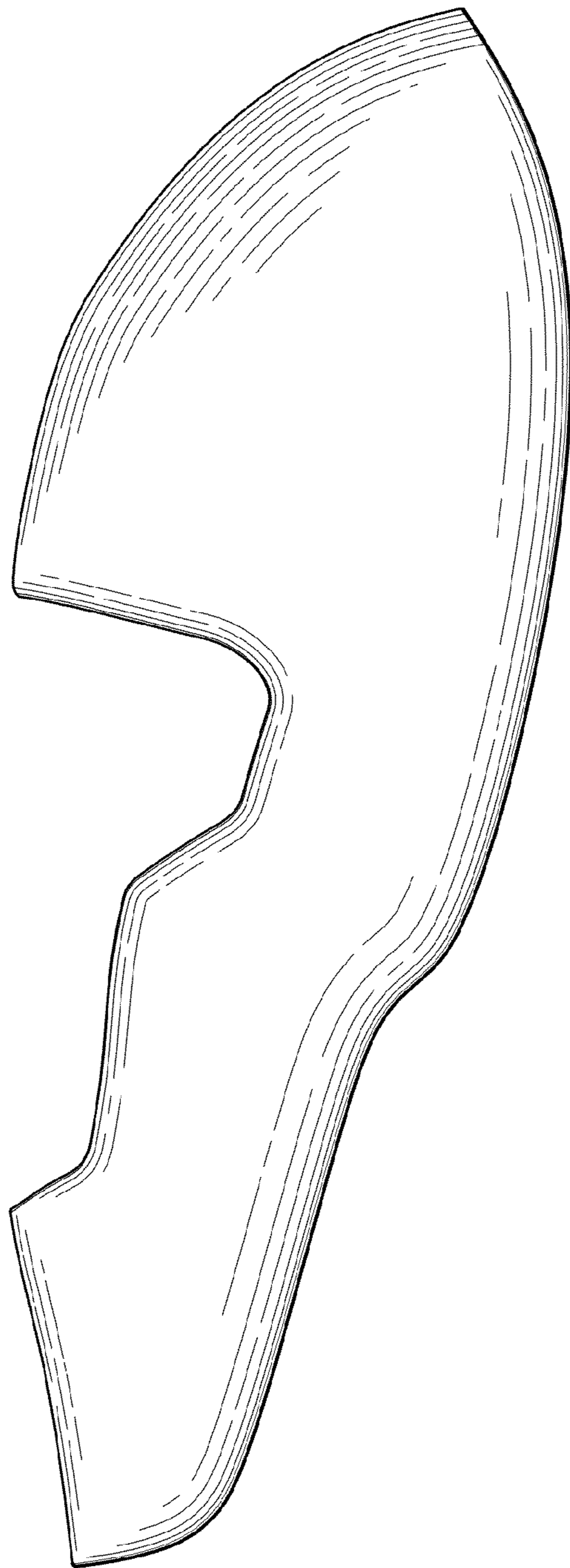
