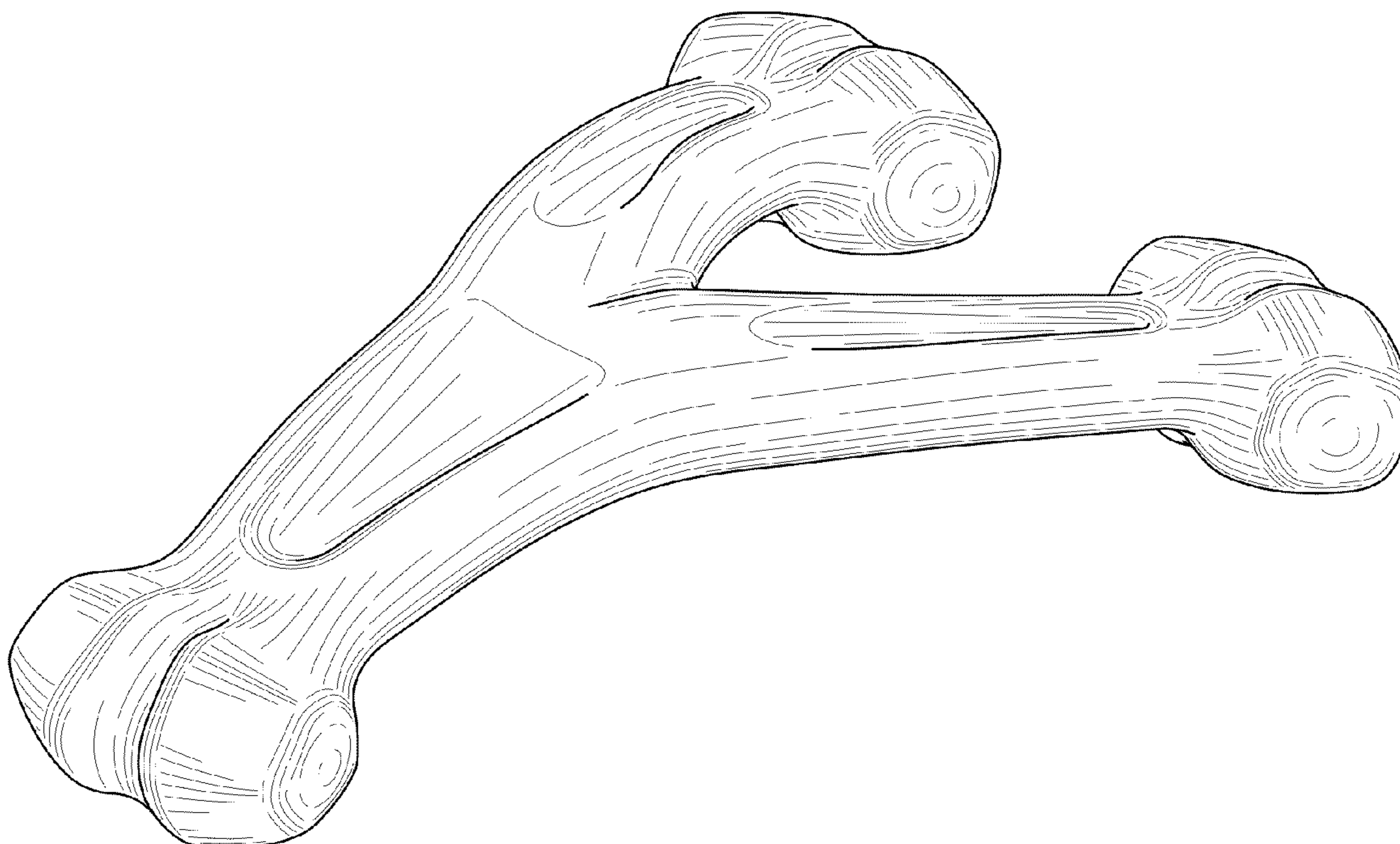
(57) **CLAIM**
The ornamental design for a pet chew, as shown and described.

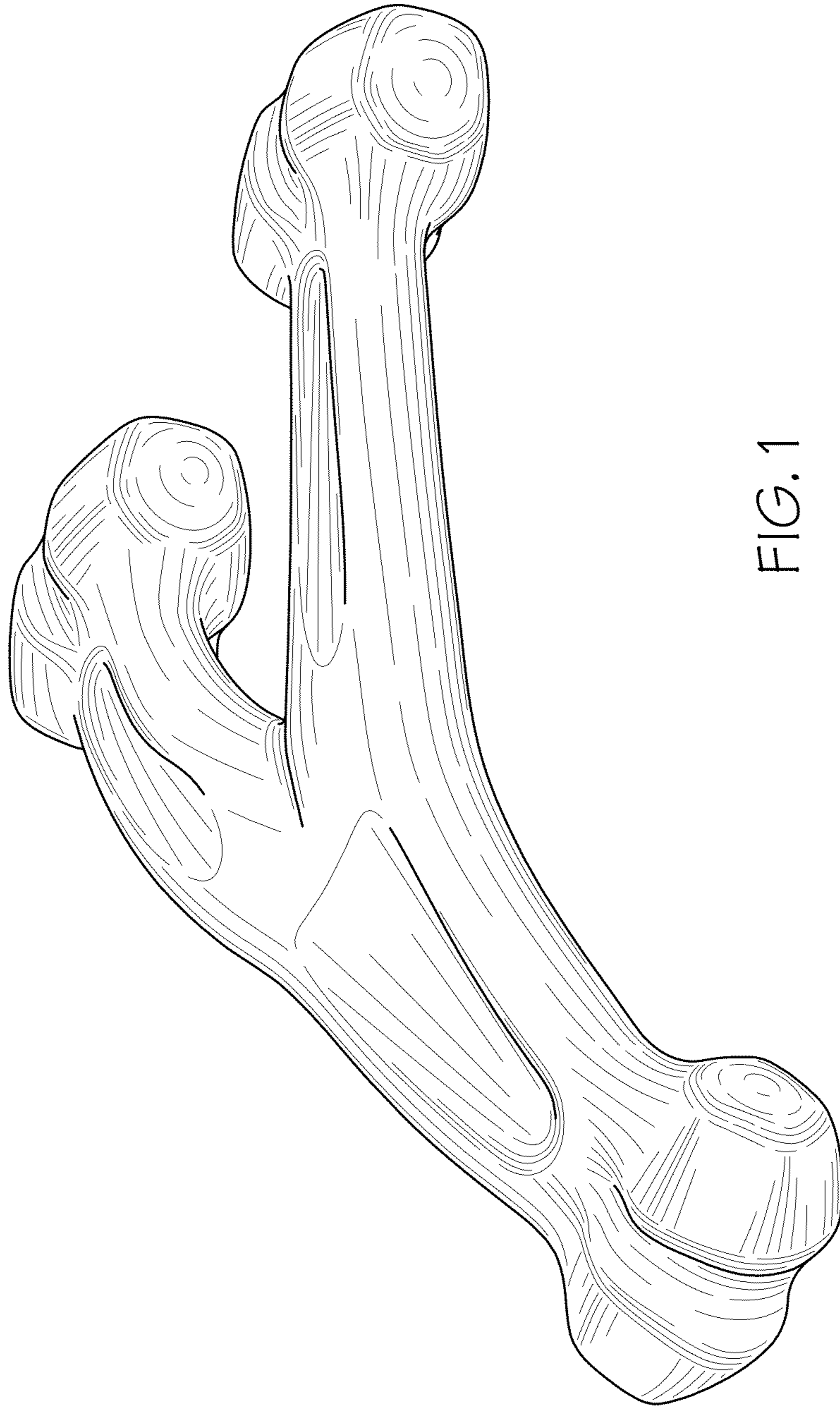
DESCRIPTION

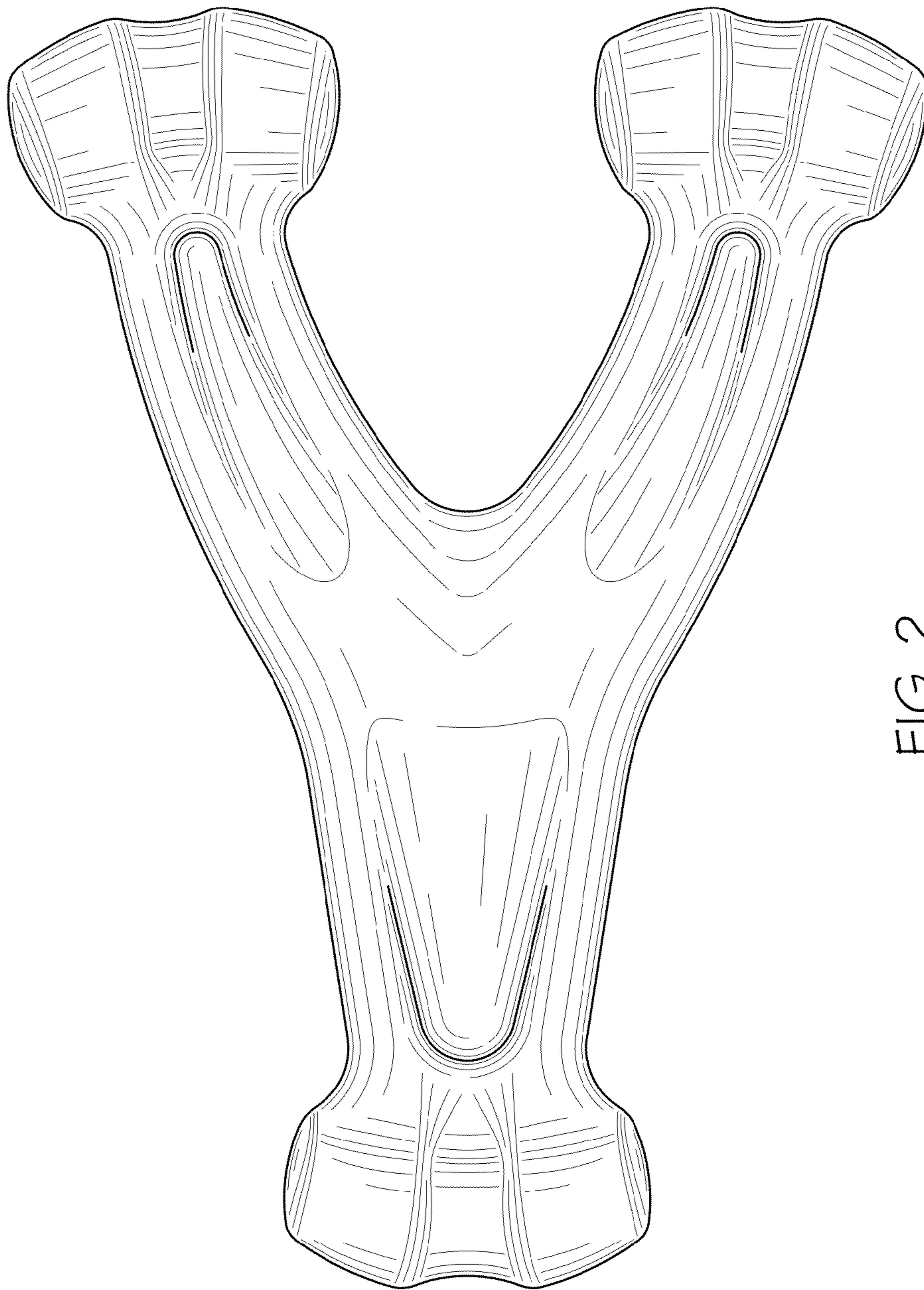

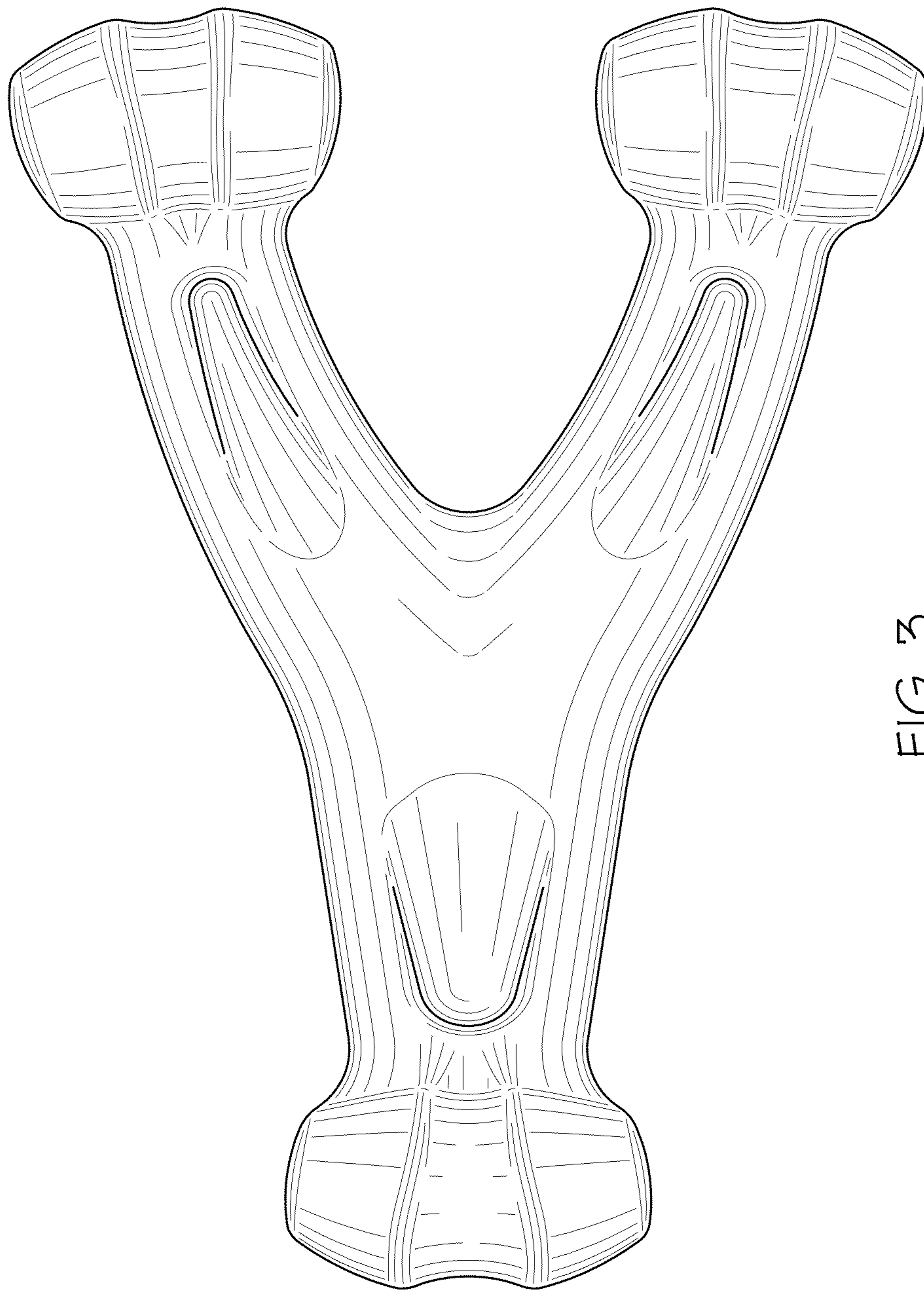

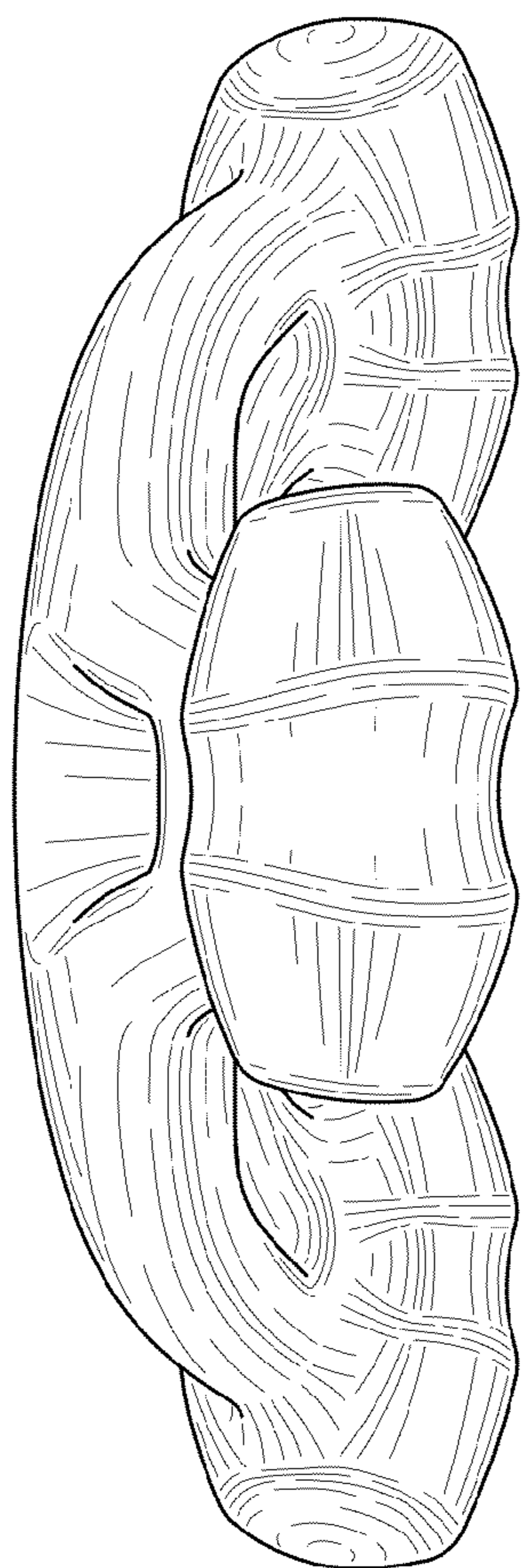

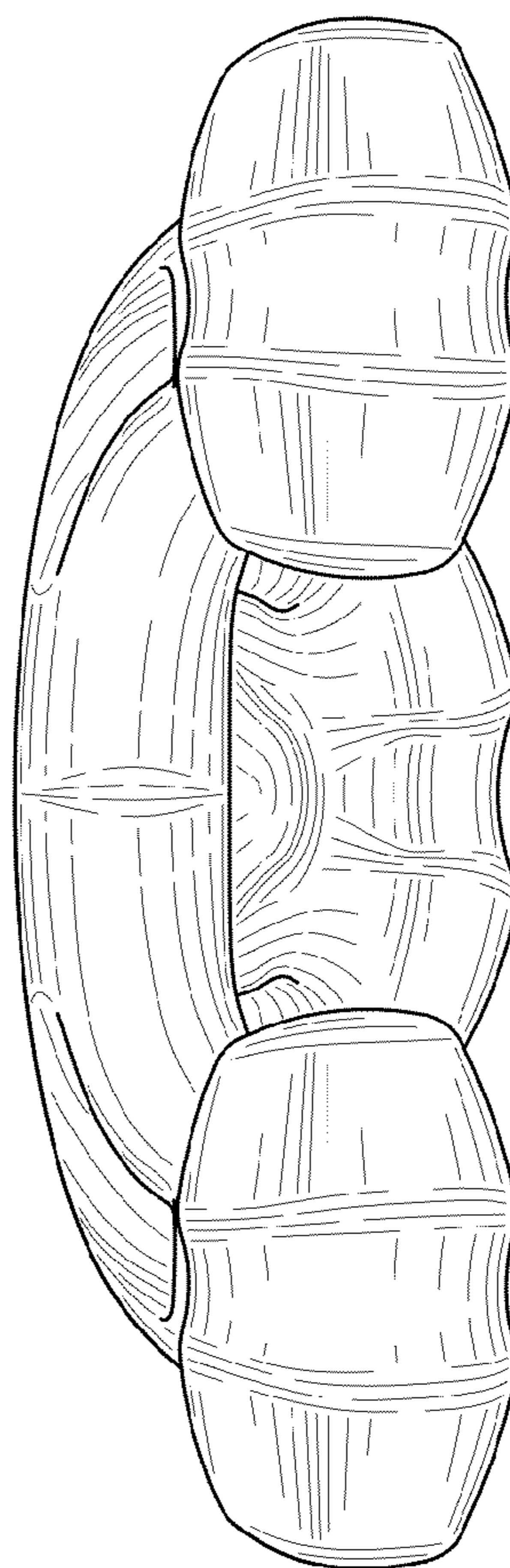
