**DESCRIPTION**

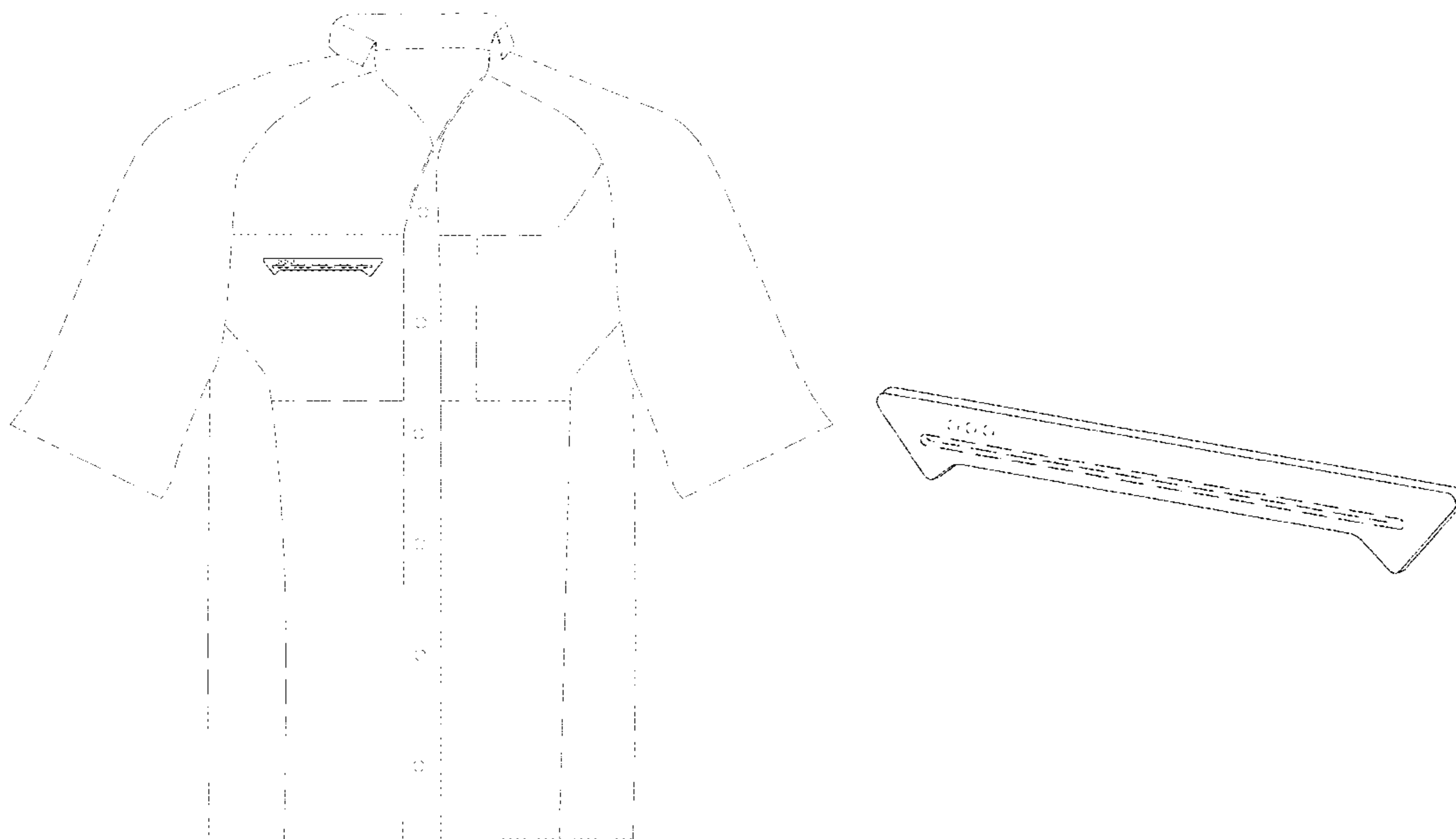
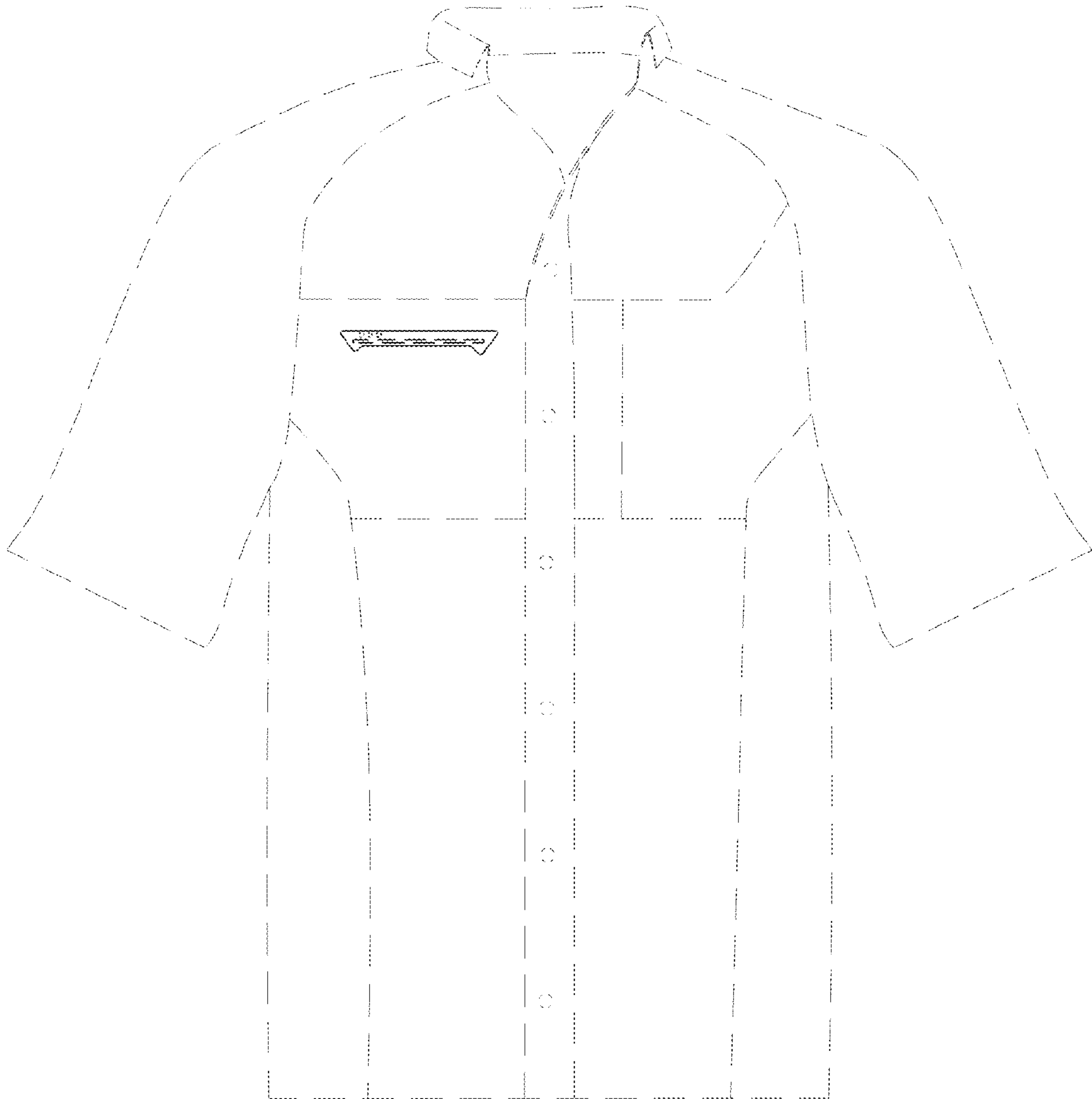

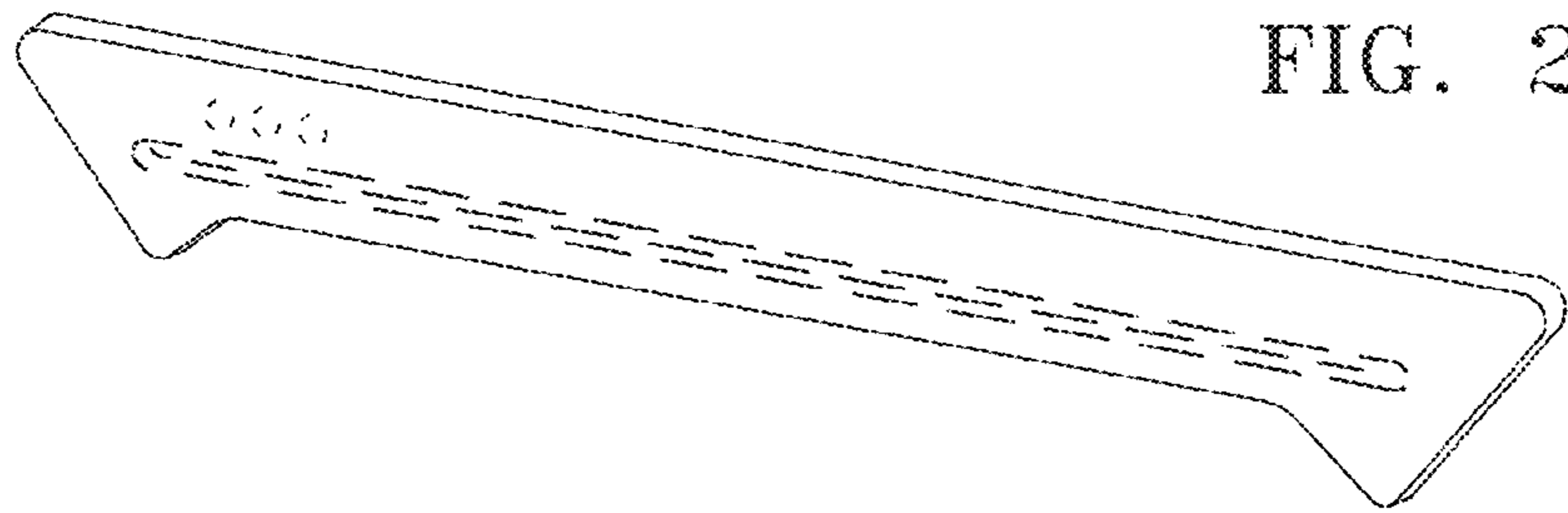

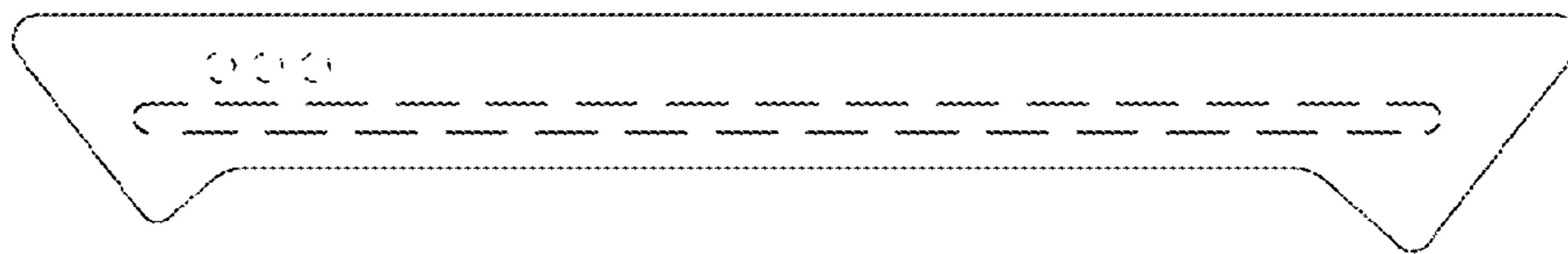

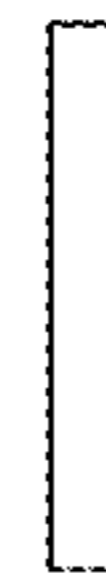

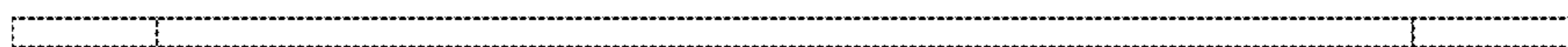

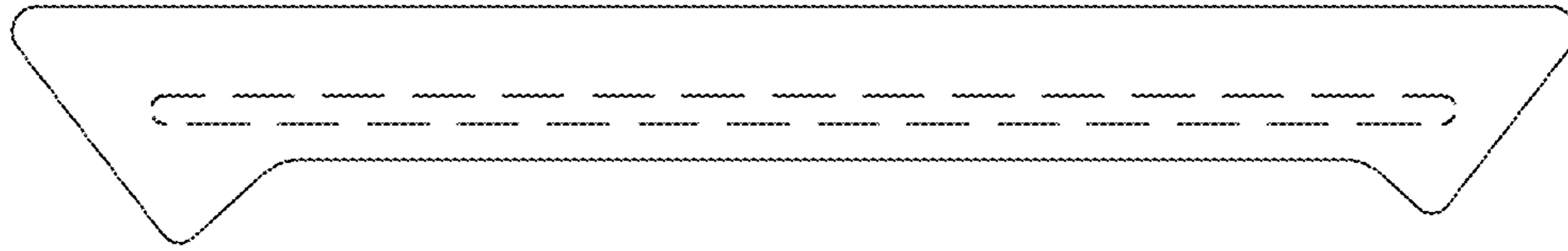
