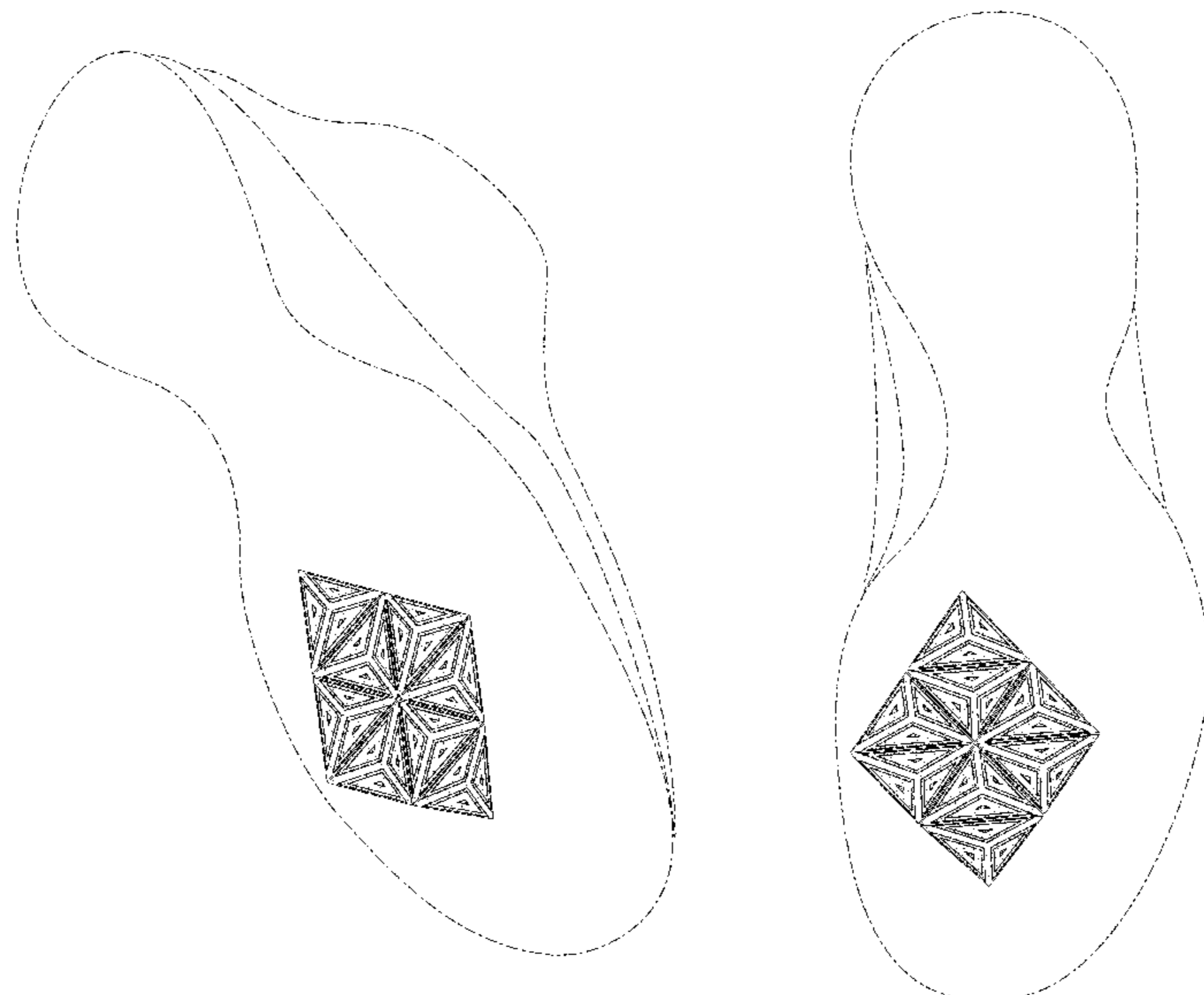
(57) **CLAIM**

The ornamental design for a shoe outsole, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a shoe outsole showing my new design;
 FIG. 2 is a plan view thereof;
 FIG. 3 is a rear perspective view thereof;
 FIG. 4 is an enlarged front perspective view of the claimed region in FIGS. 1-3 shown in isolation;
 FIG. 5 is a plan view thereof; and,
 FIG. 6 is a rear perspective view thereof.
 The broken lines showing the remainder of the shoe in FIGS. 1-3 are for environmental purposes only and form no part of the claimed design.

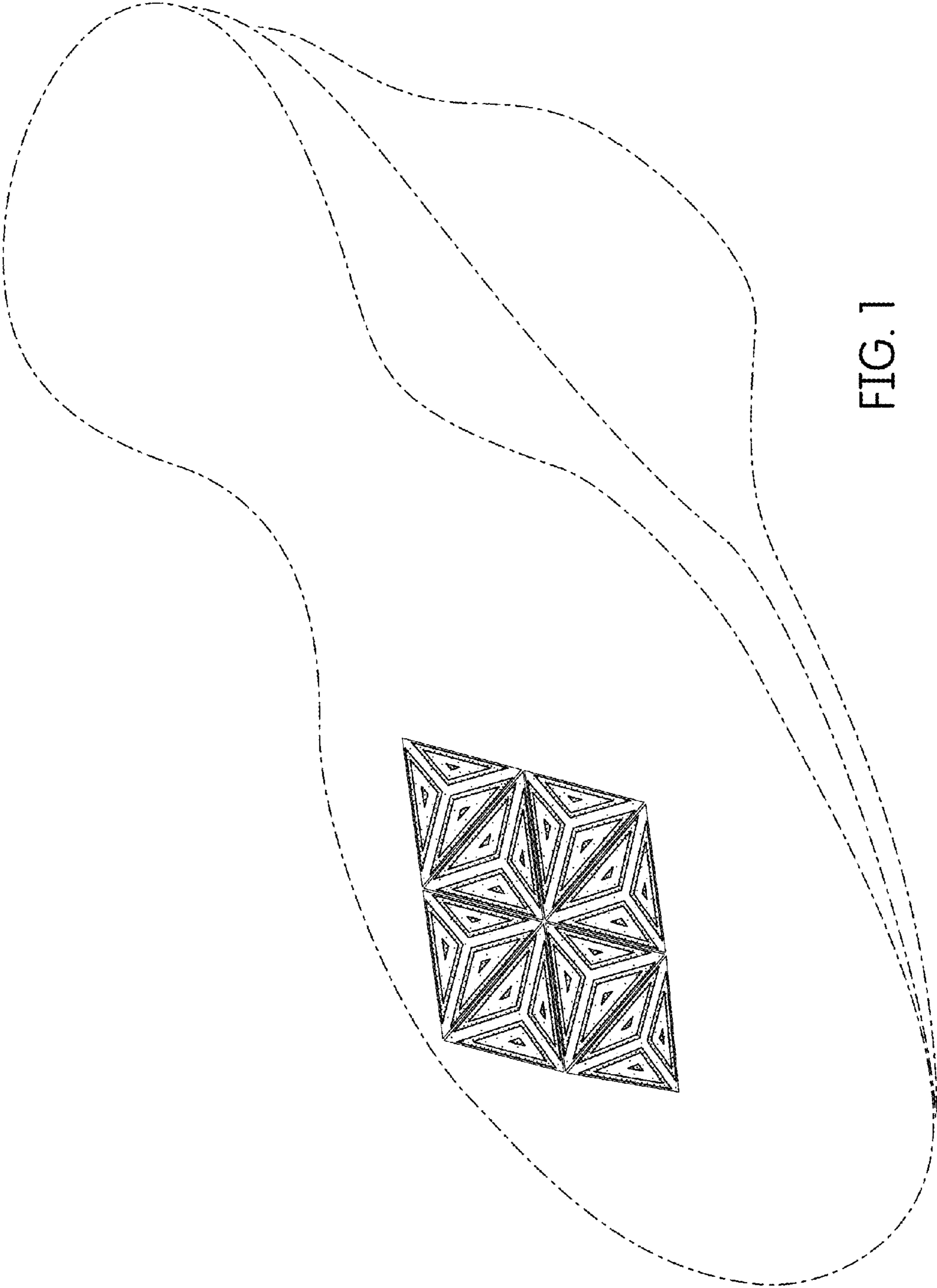

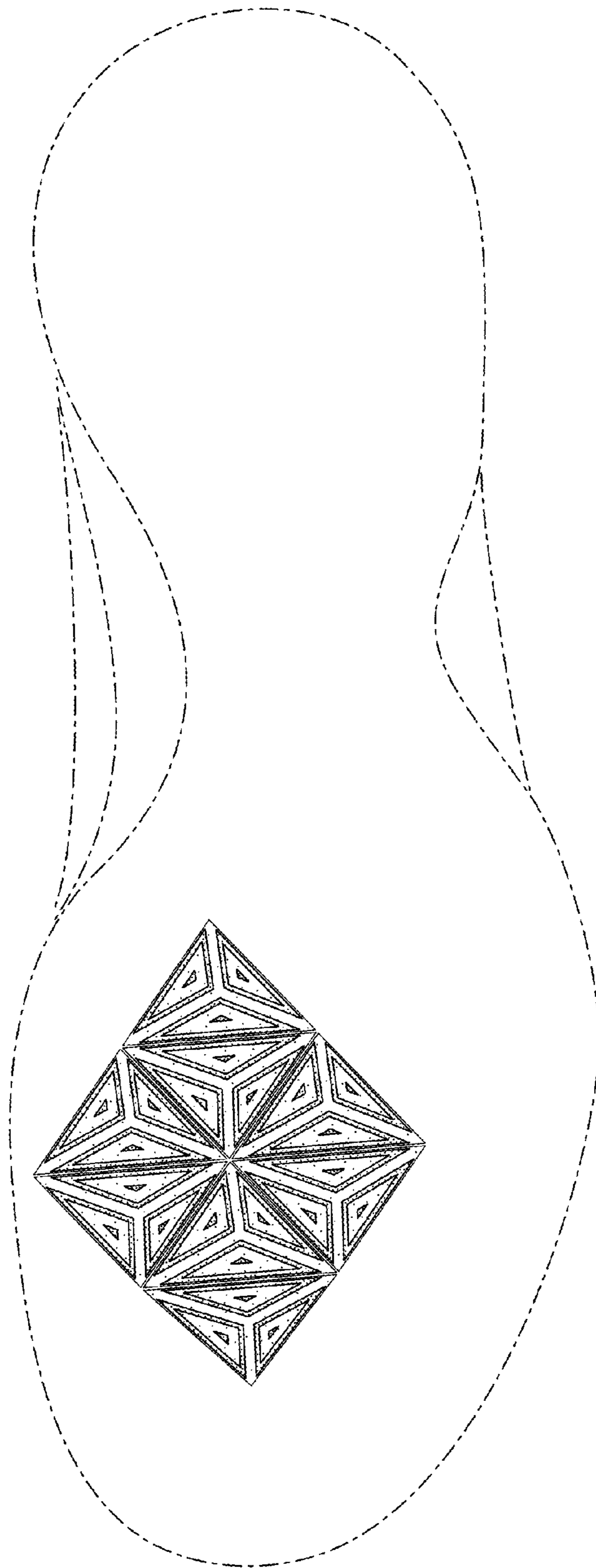

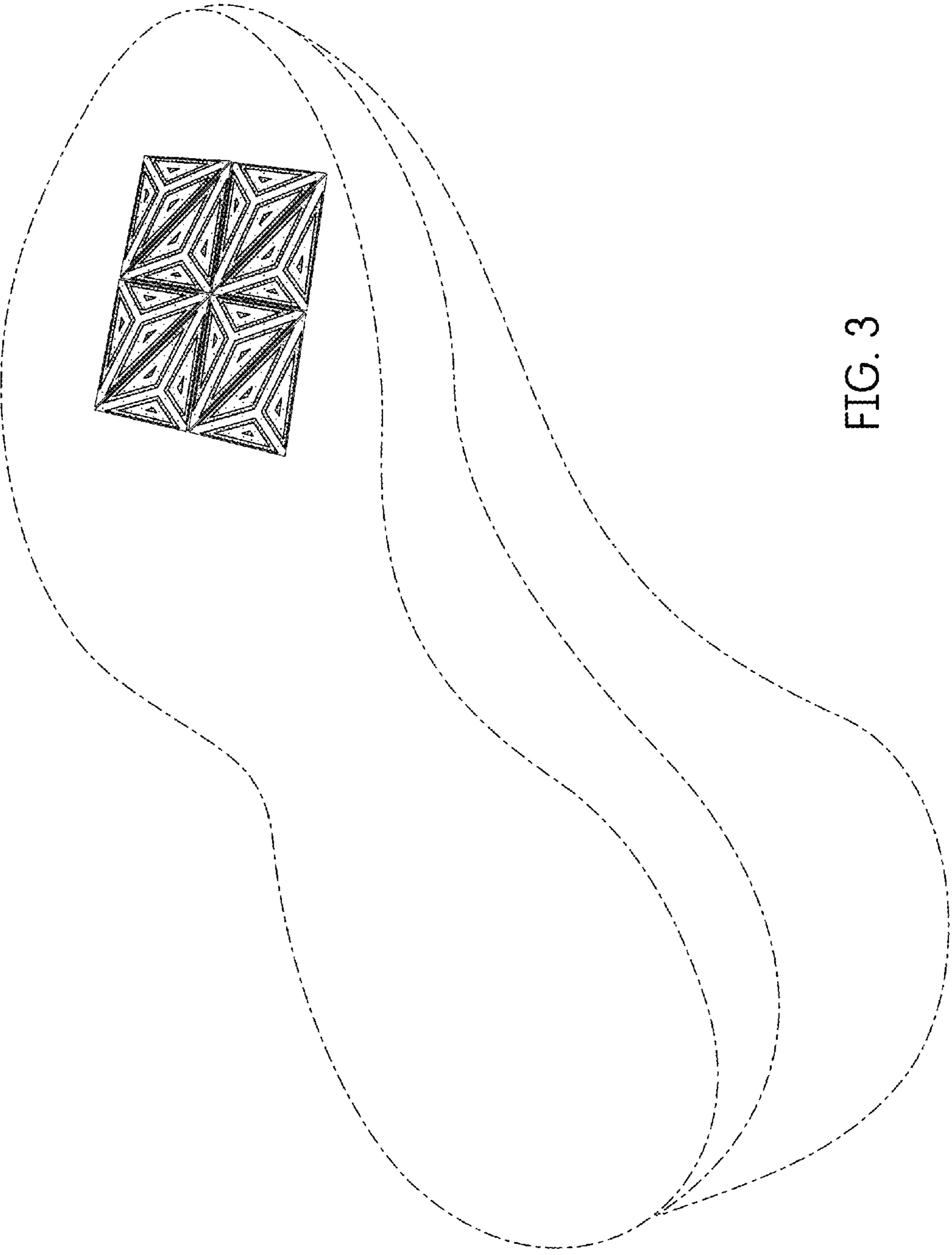

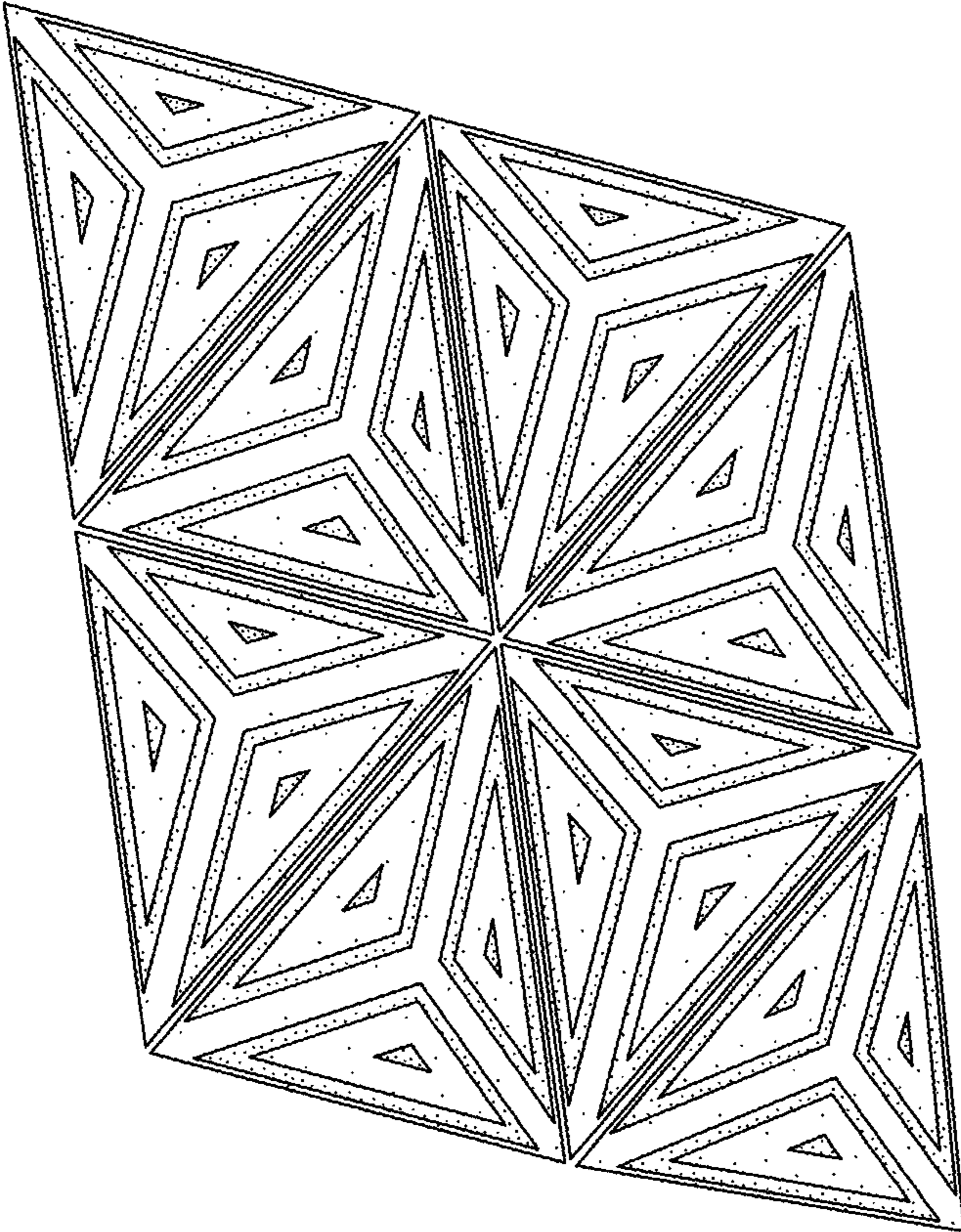

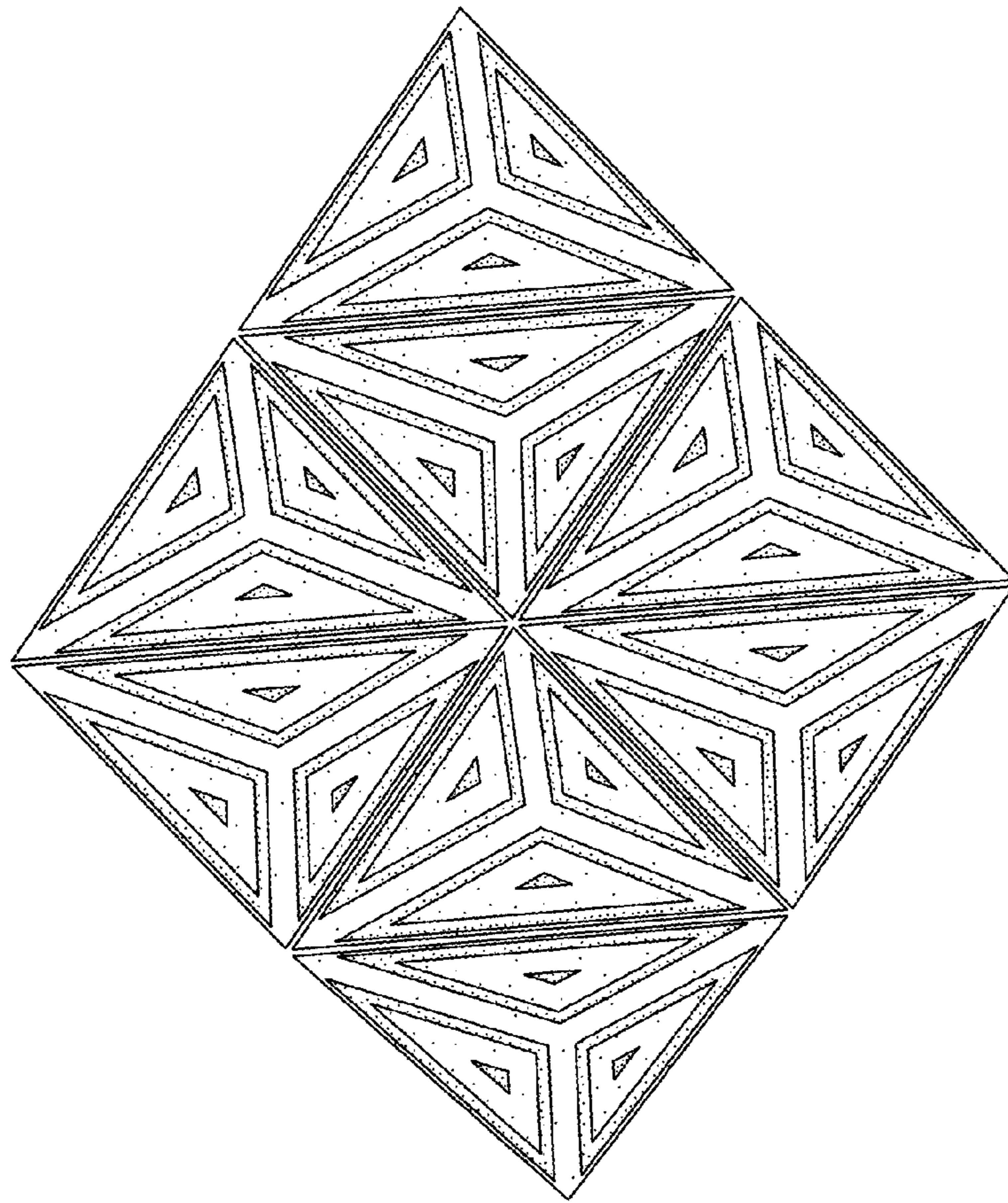

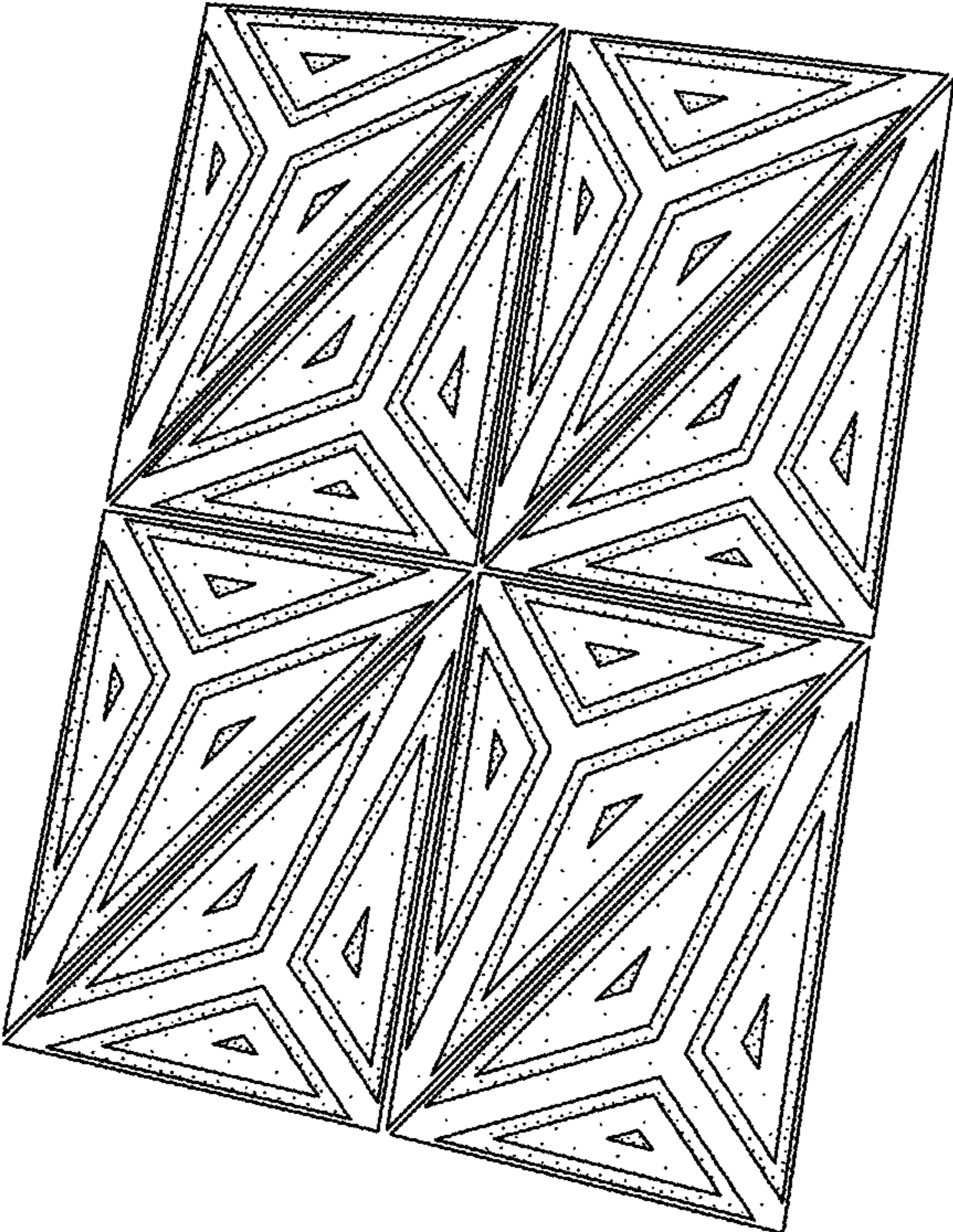
