(57) **CLAIM**

We claim the ornamental design for a handle for a fastener driver, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a handle for a fastener driver according to an embodiment of the invention.

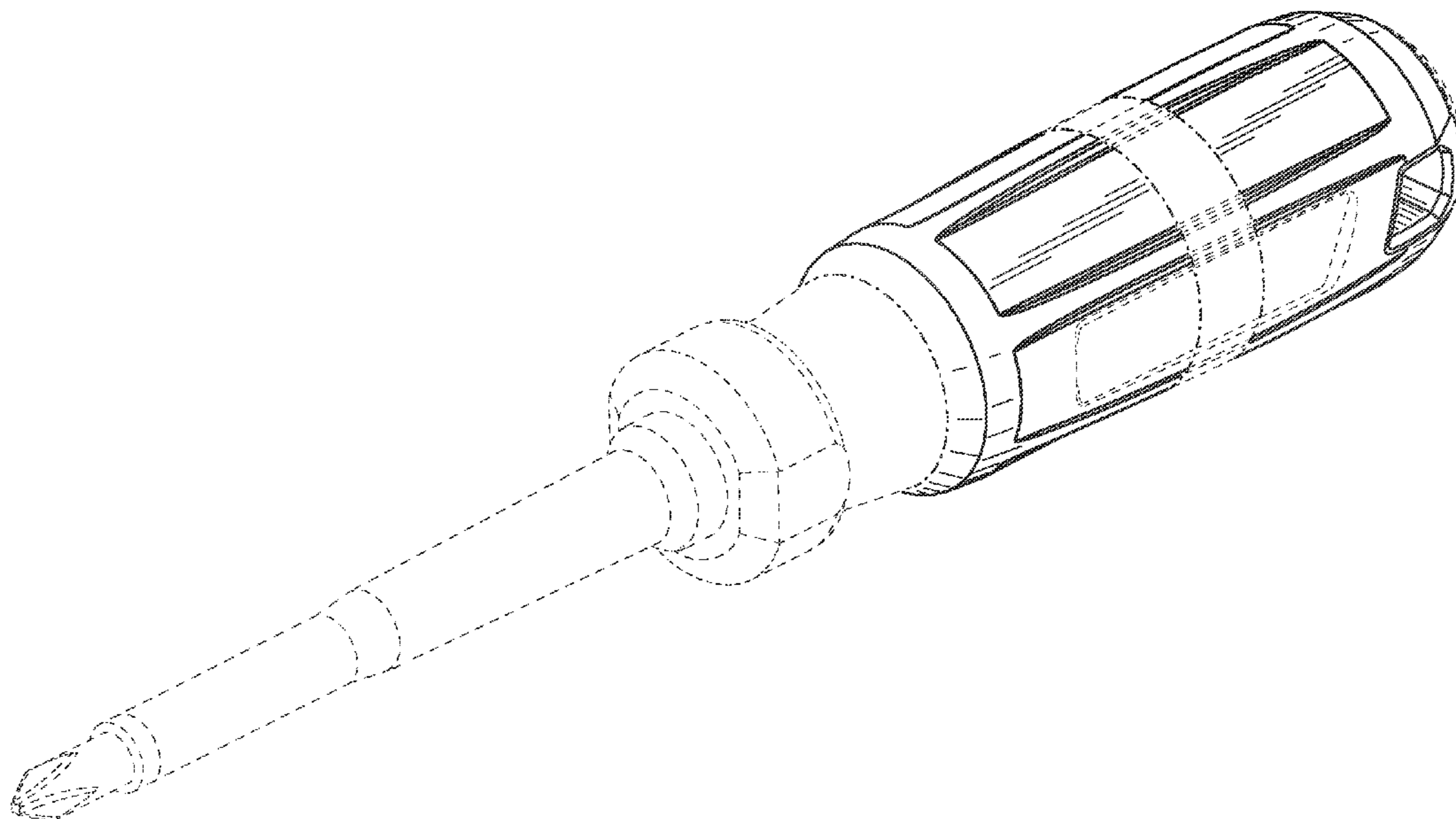
FIG. 2 is a first side view of the handle shown in FIG. 1.

FIG. 3 is a second side view of the handle shown in FIG. 1; and,

FIG. 4 is a bottom end view of the handle shown in FIG. 1.

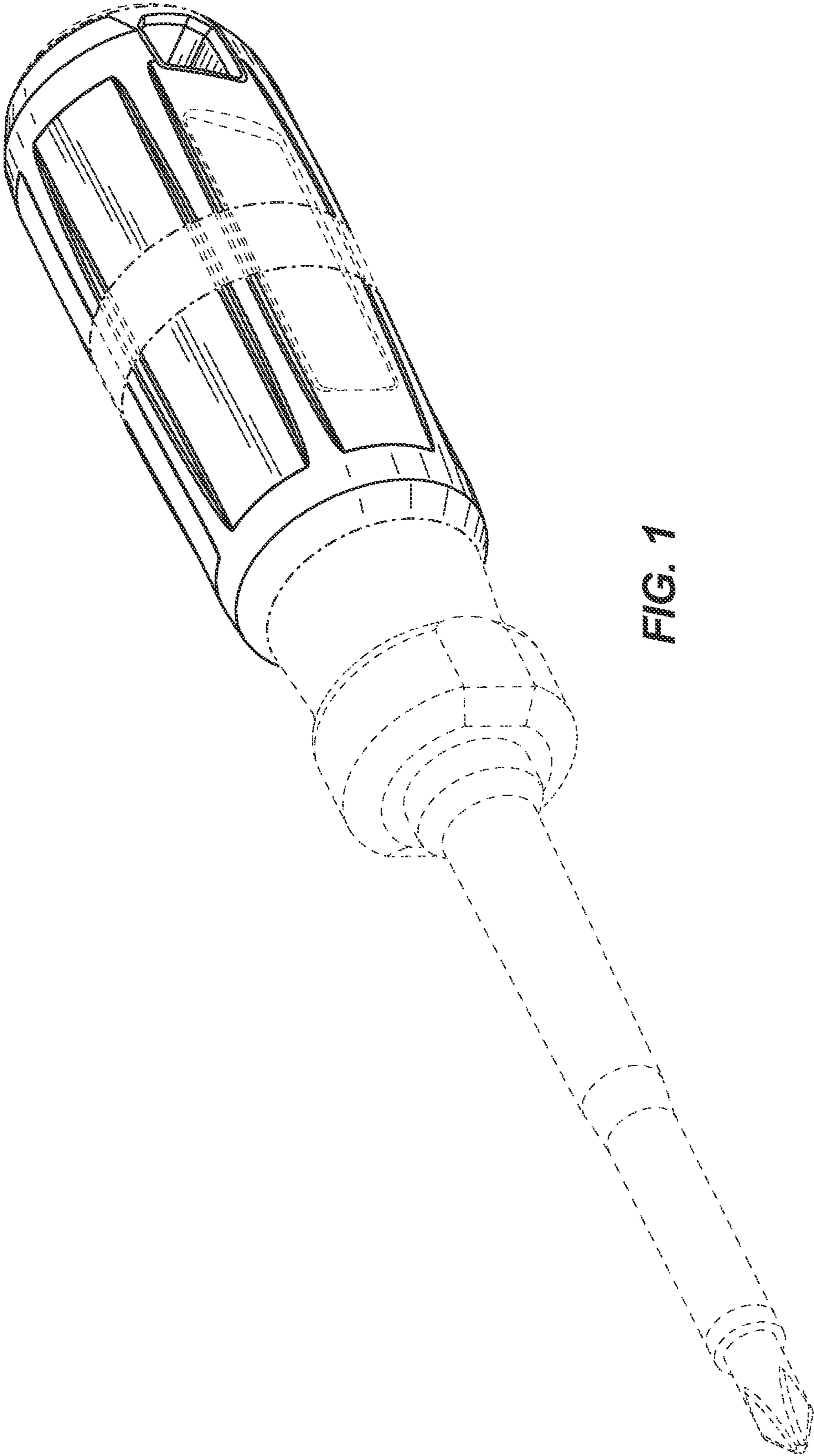

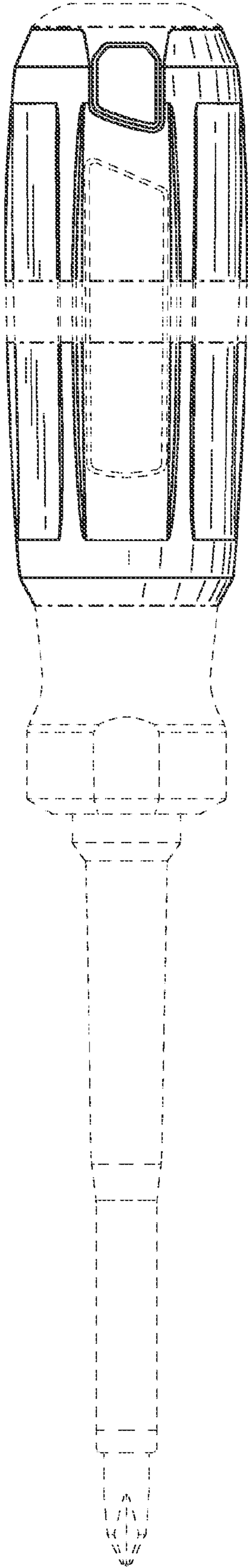

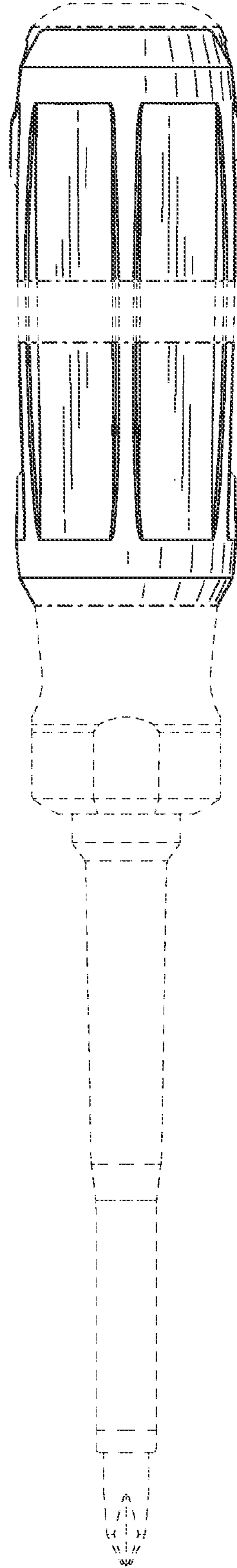

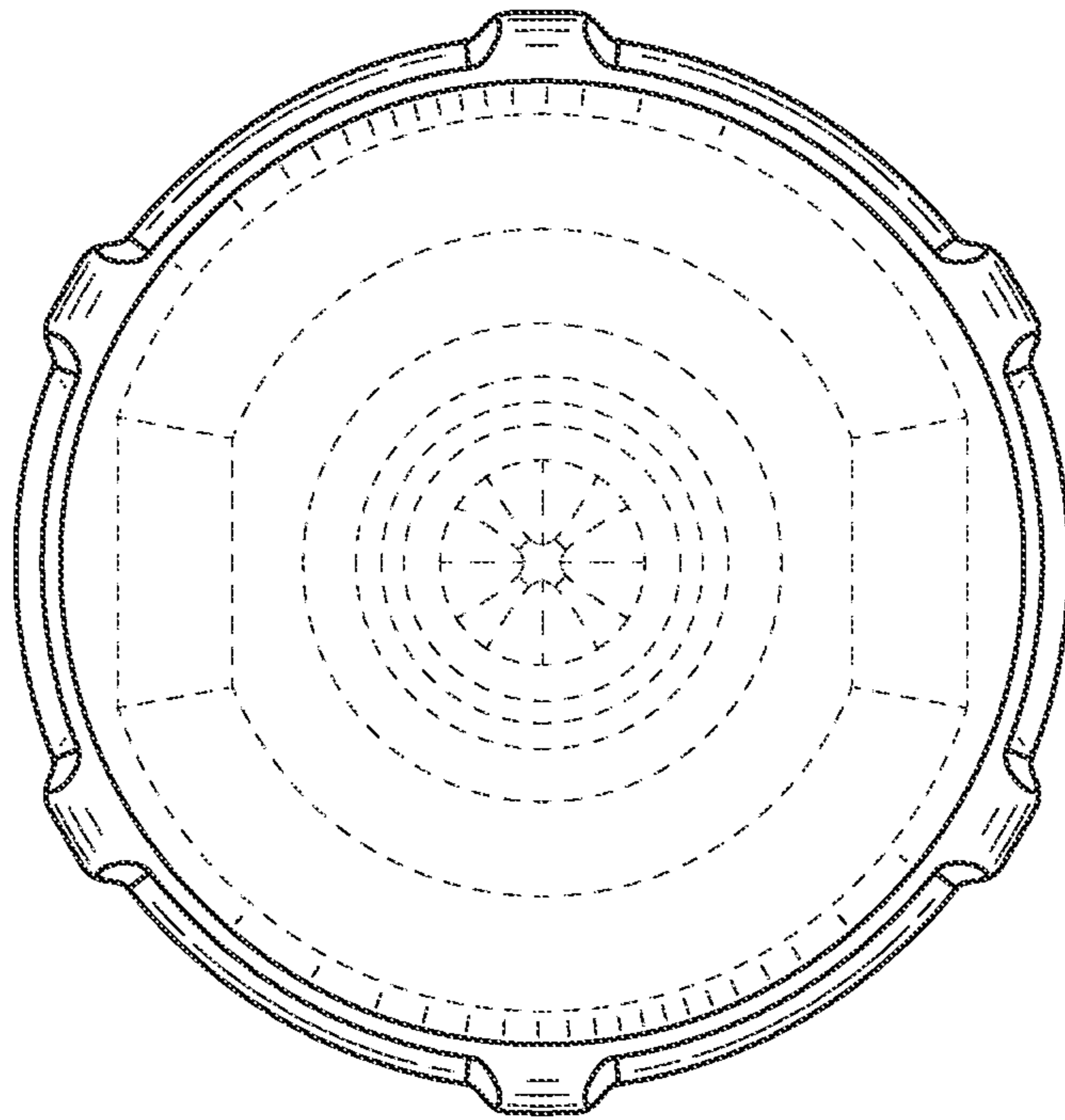
