(57) **CLAIM**

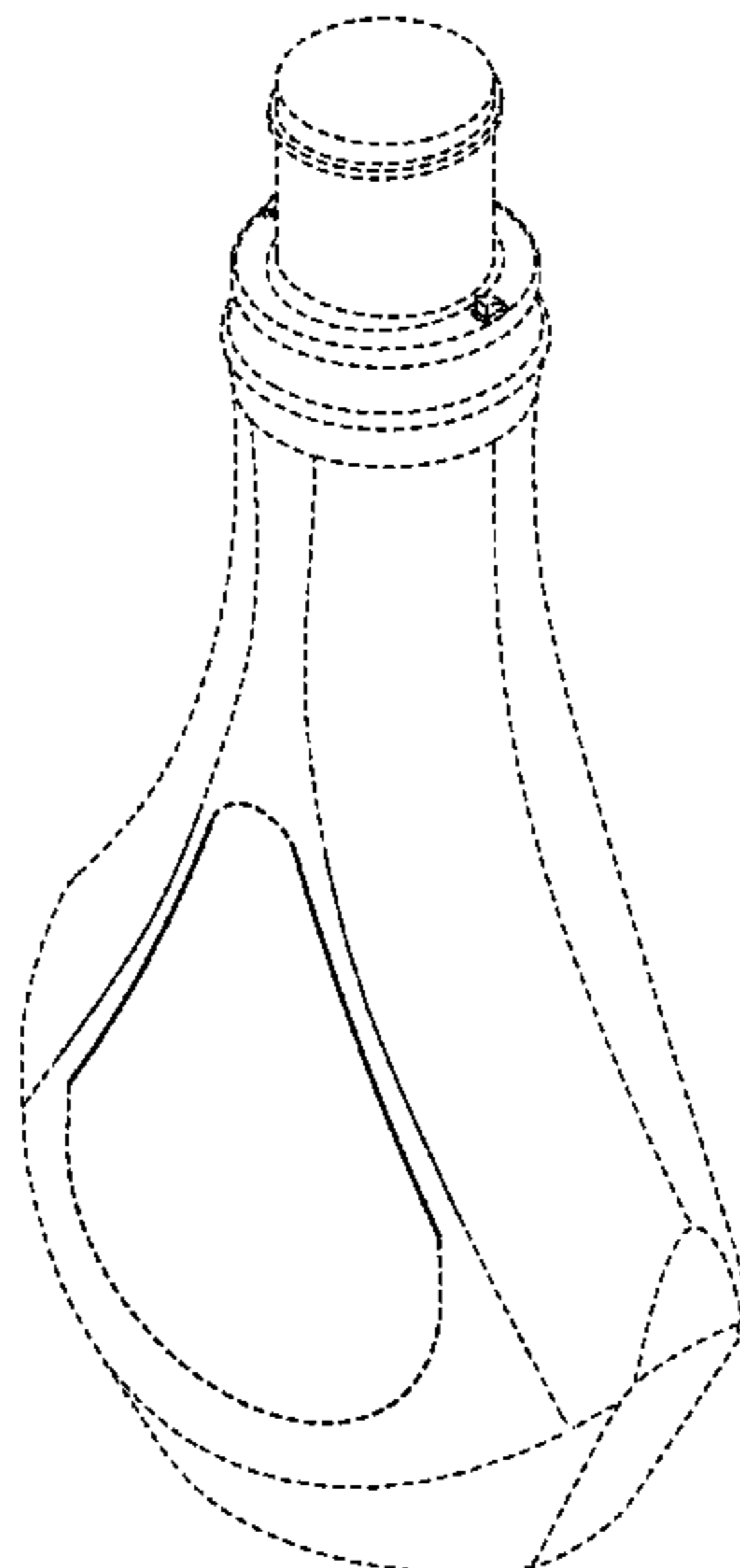
The ornamental design for a combined container and label thereof, as shown and described.

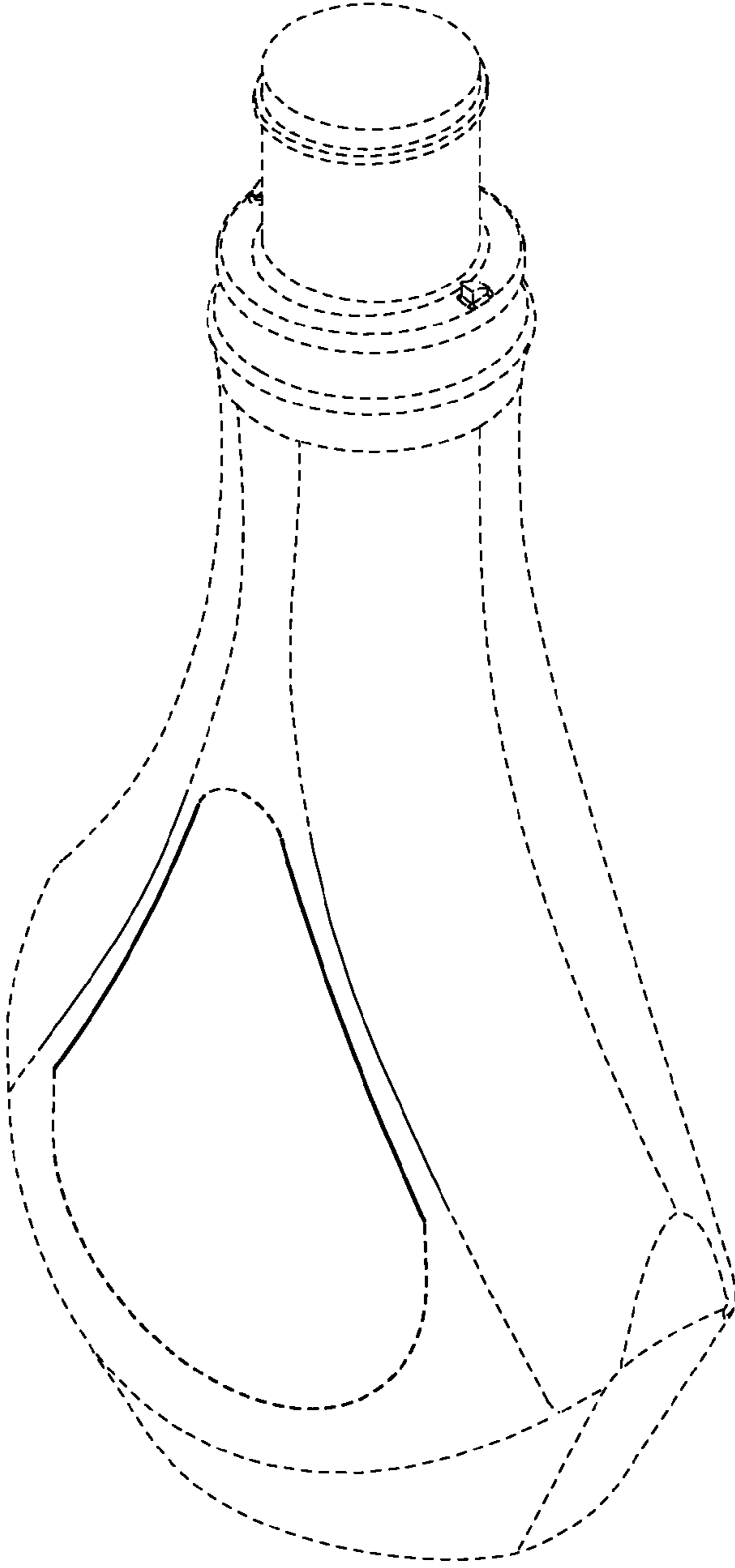

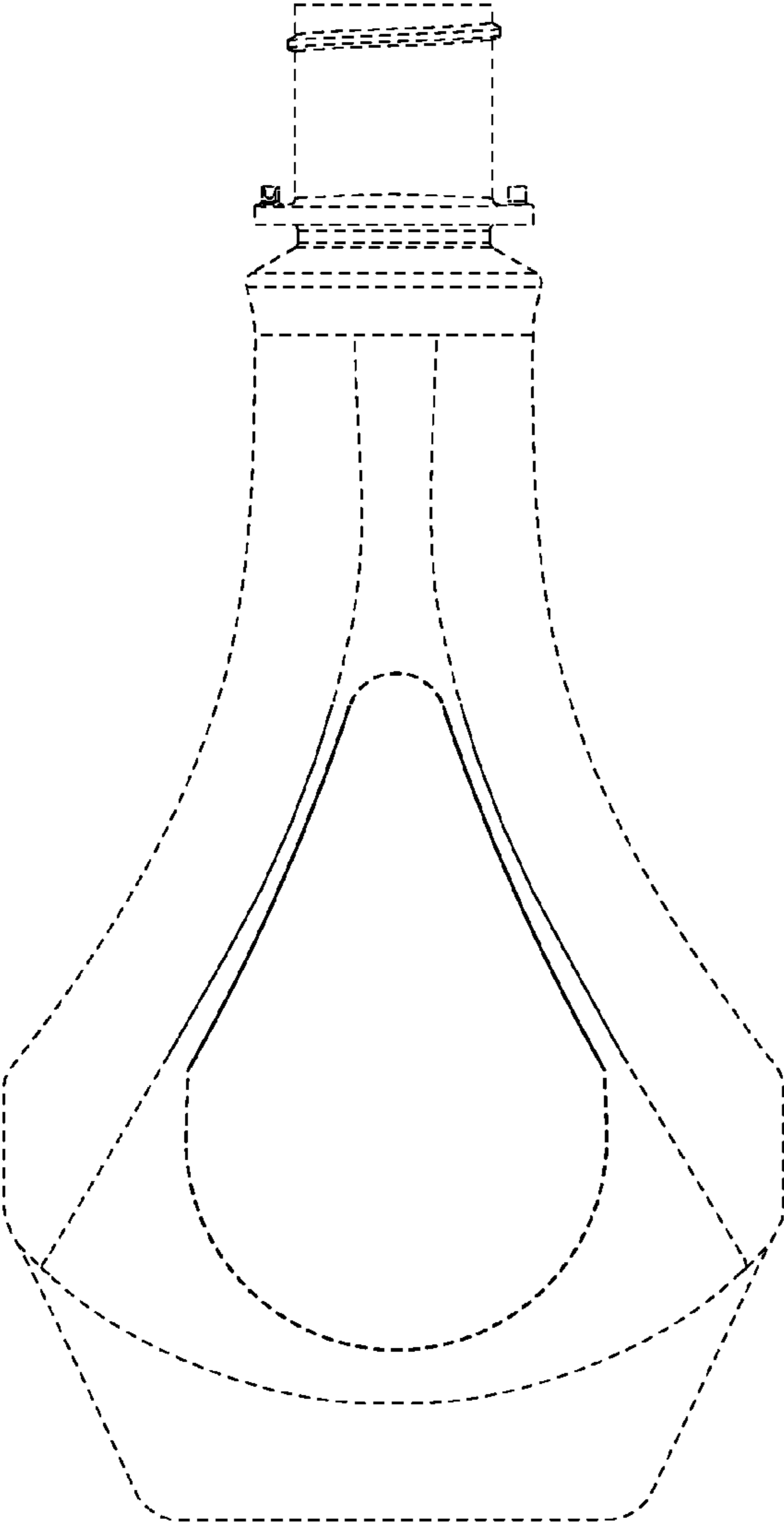

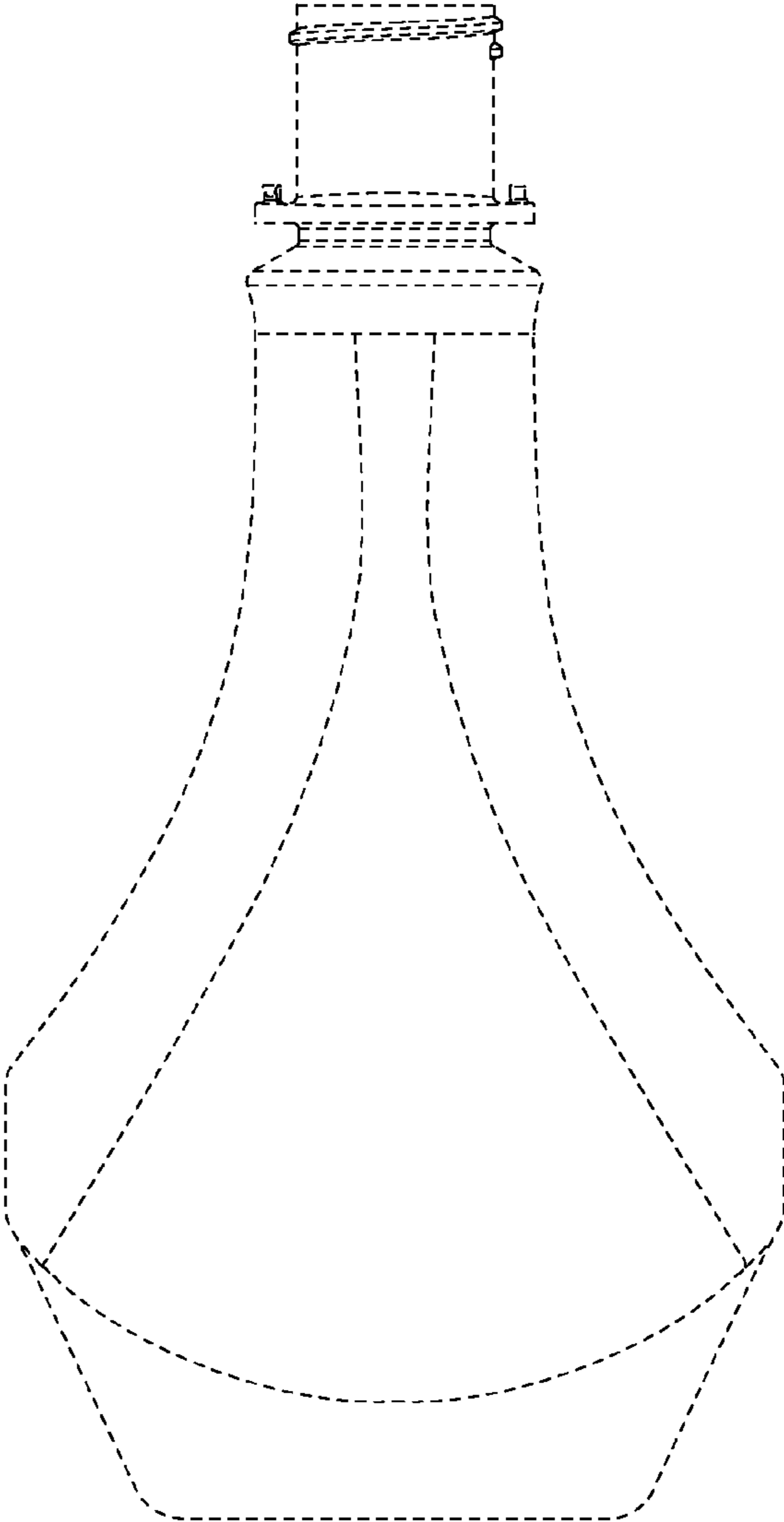

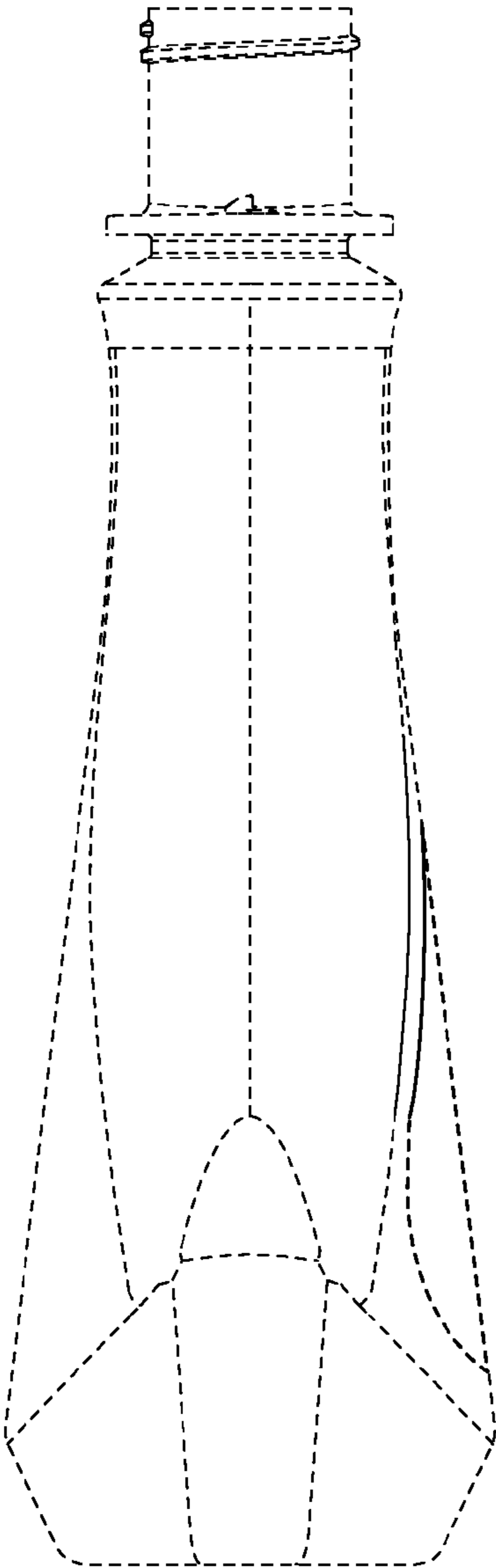

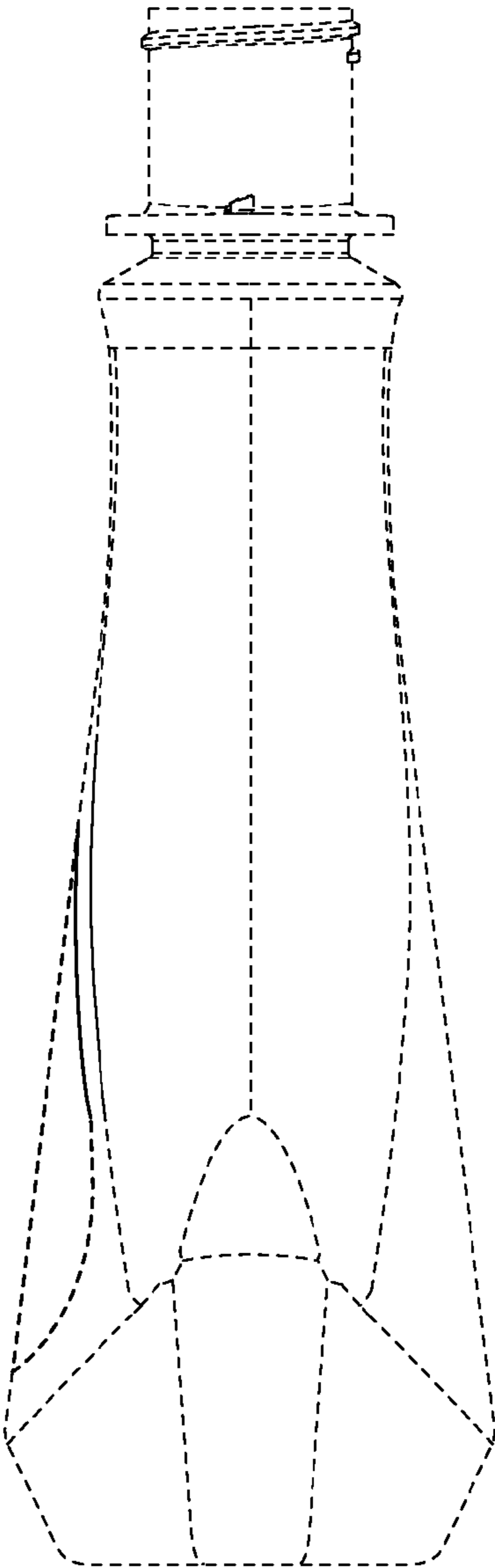

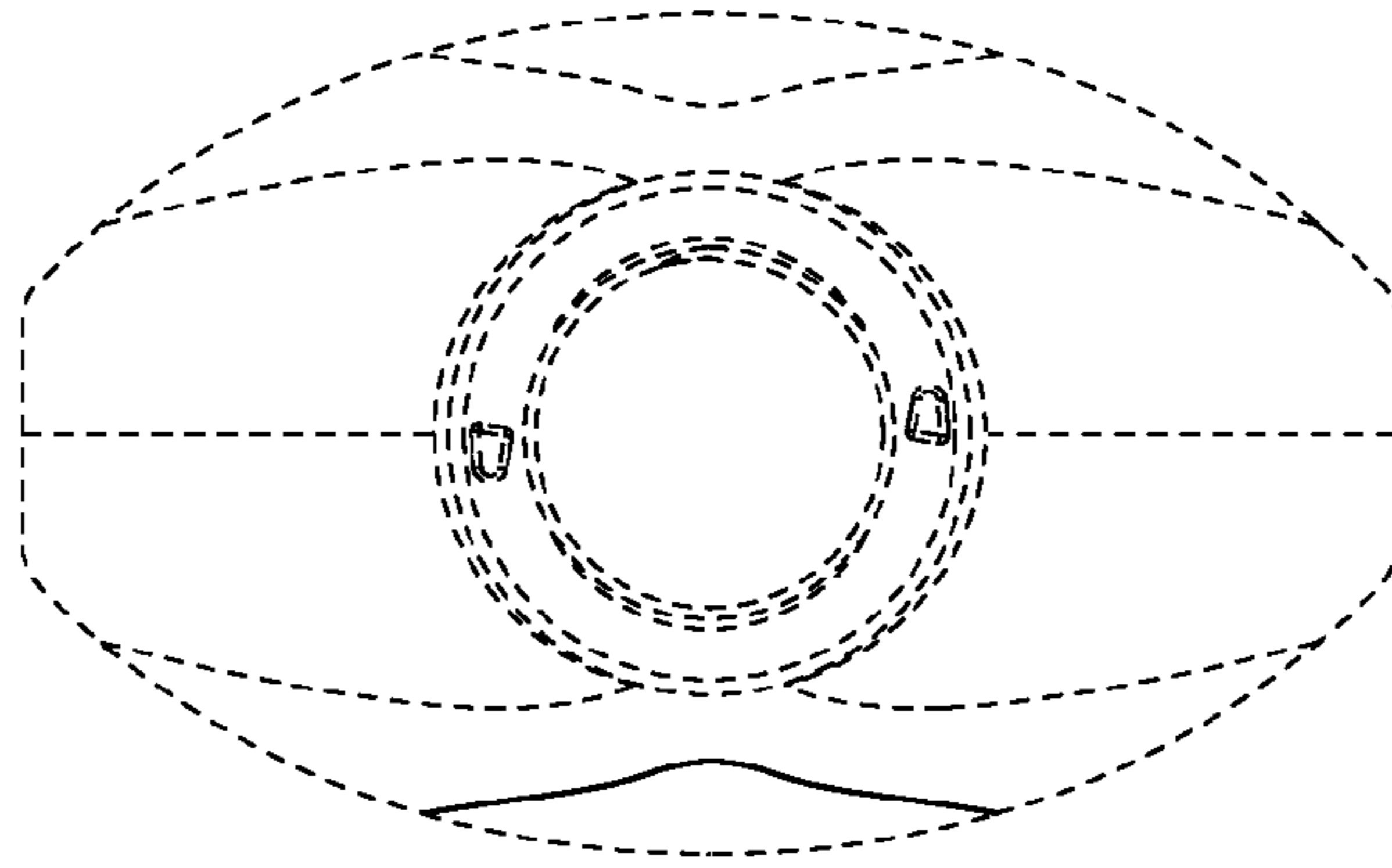

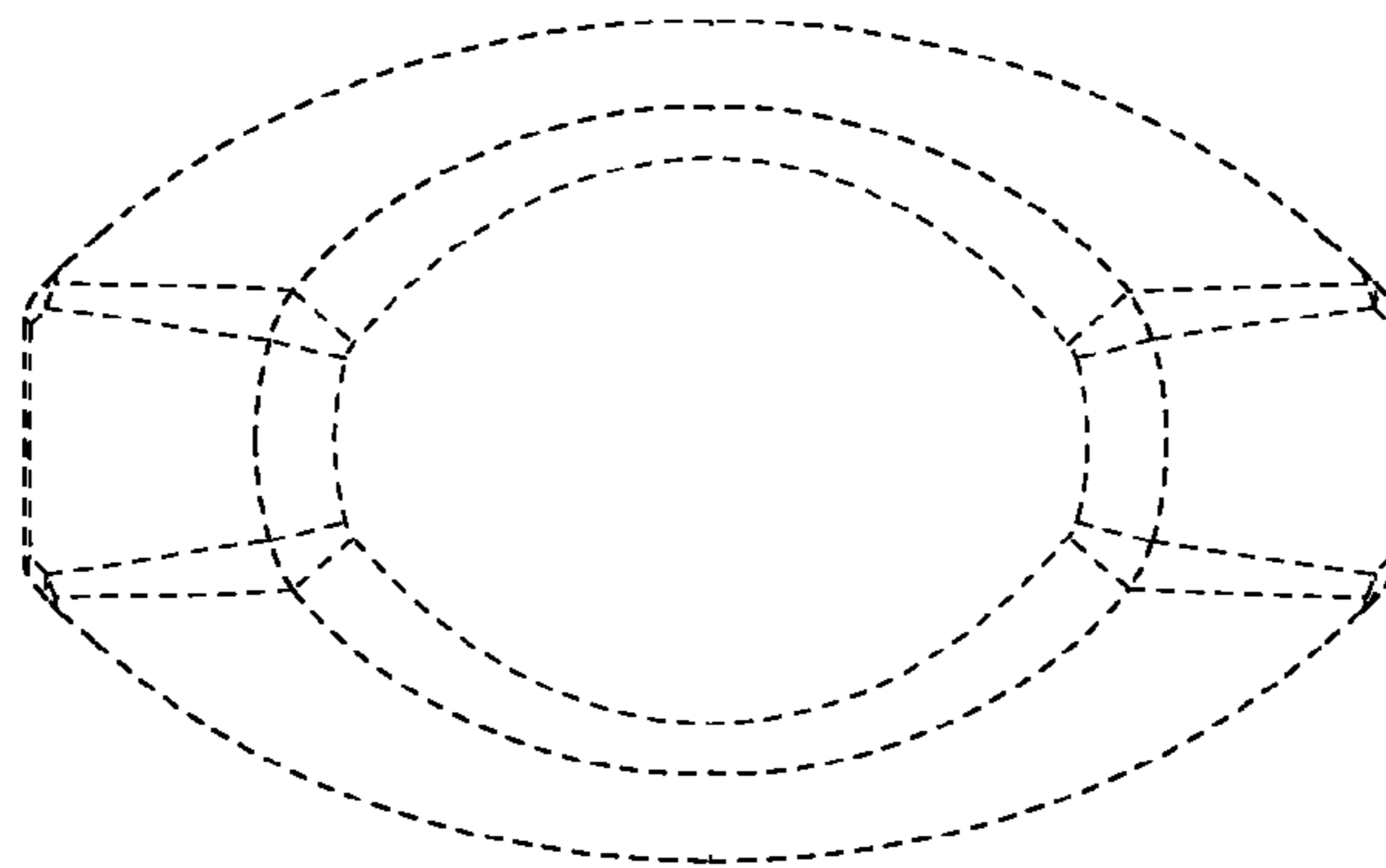
