DESCRIPTION

FIG. 1 is a front perspective view of a side body for an automobile showing our new design;

FIG. 2 is a right side thereof;

FIG. 3 is a left side view thereof;

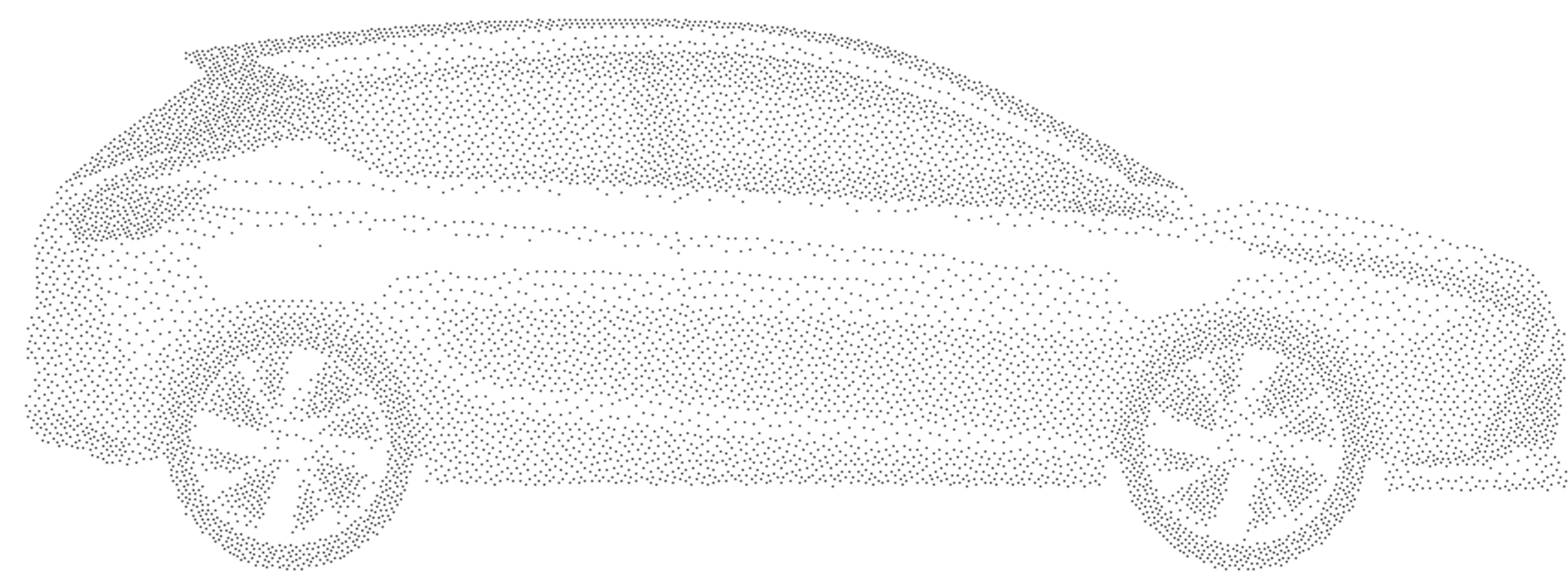
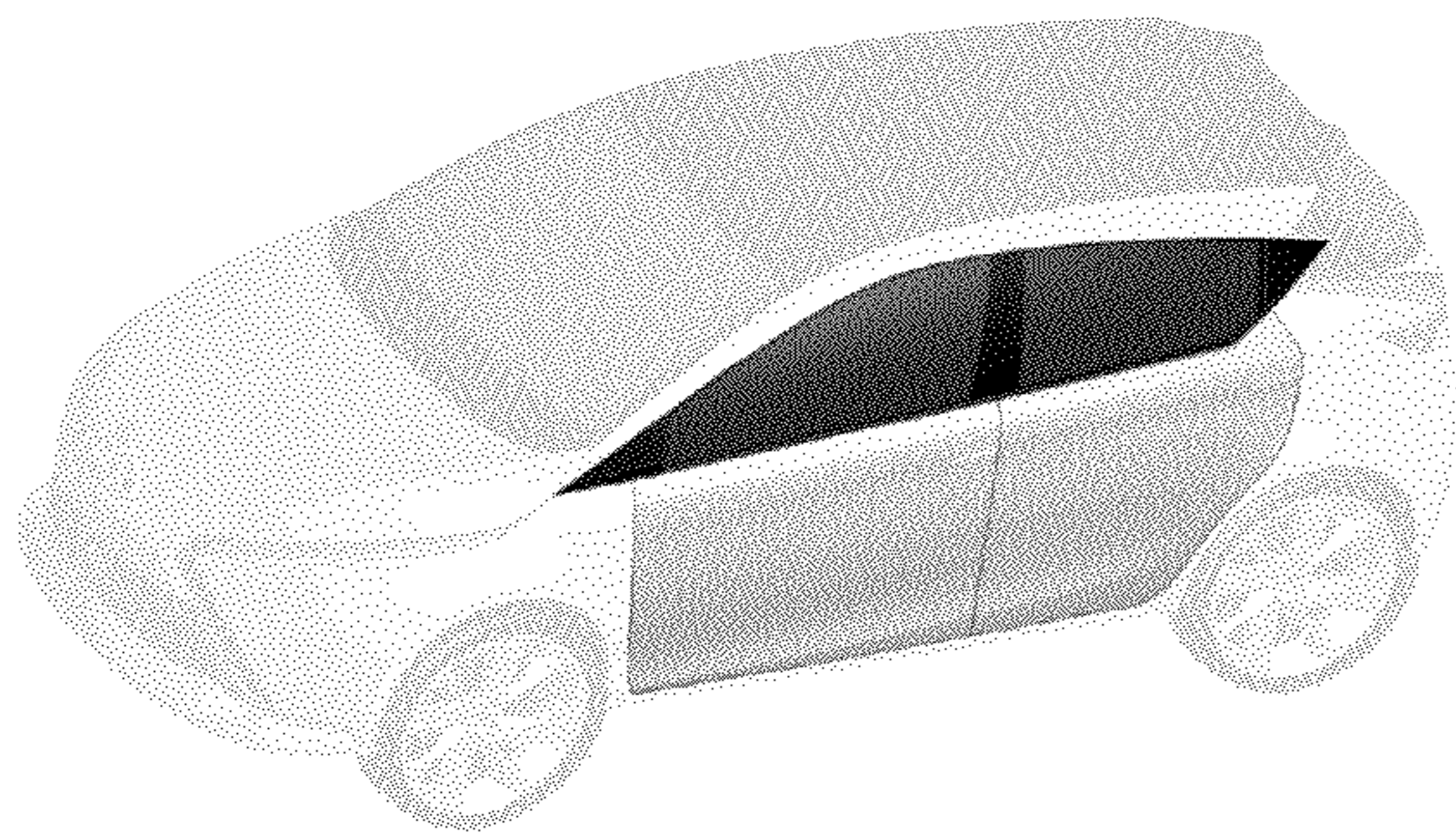
FIG. 4 is a top view thereof;

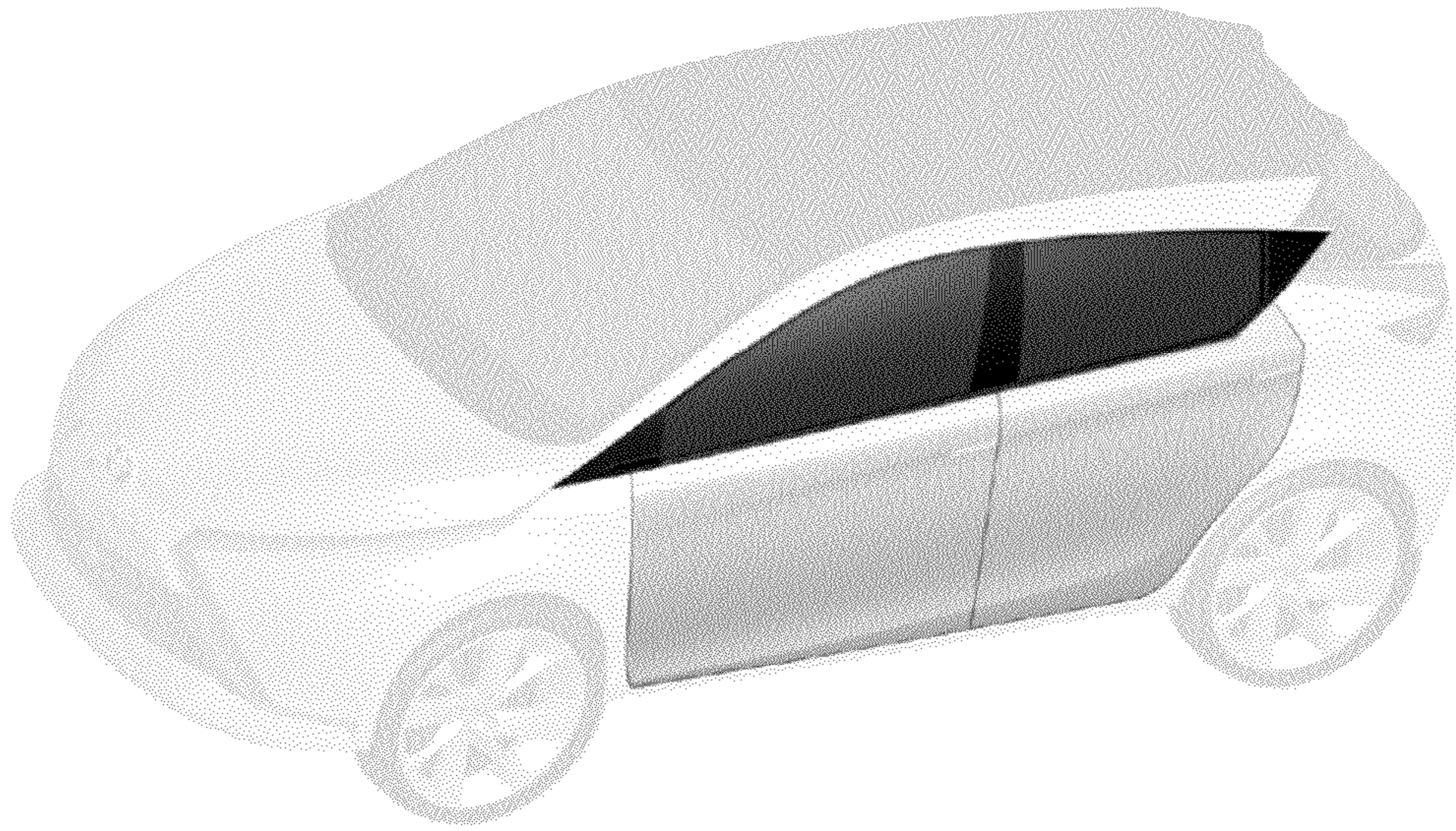

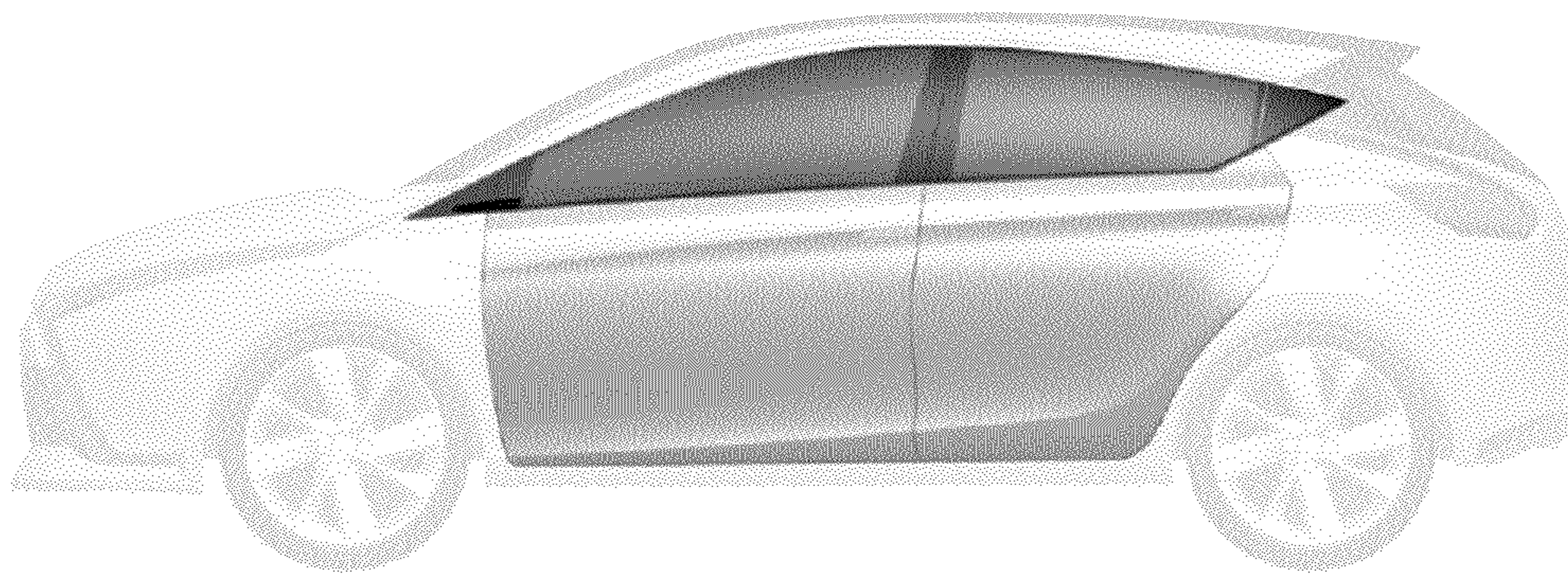

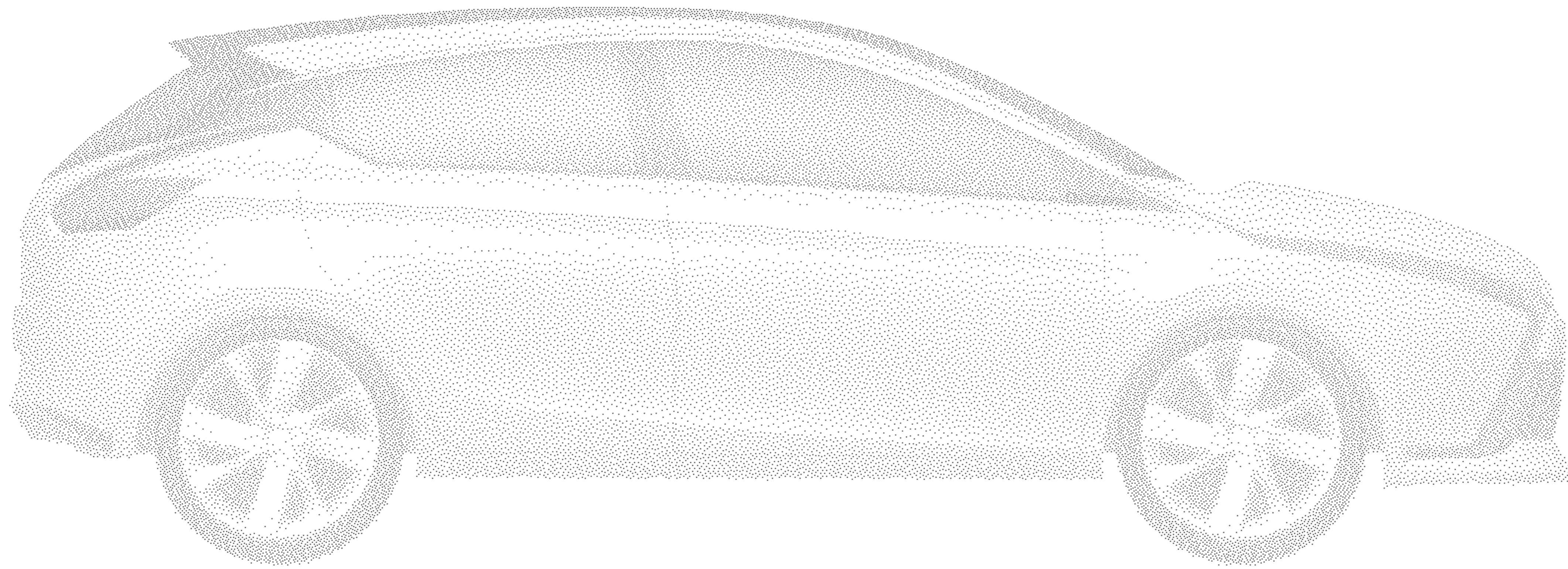

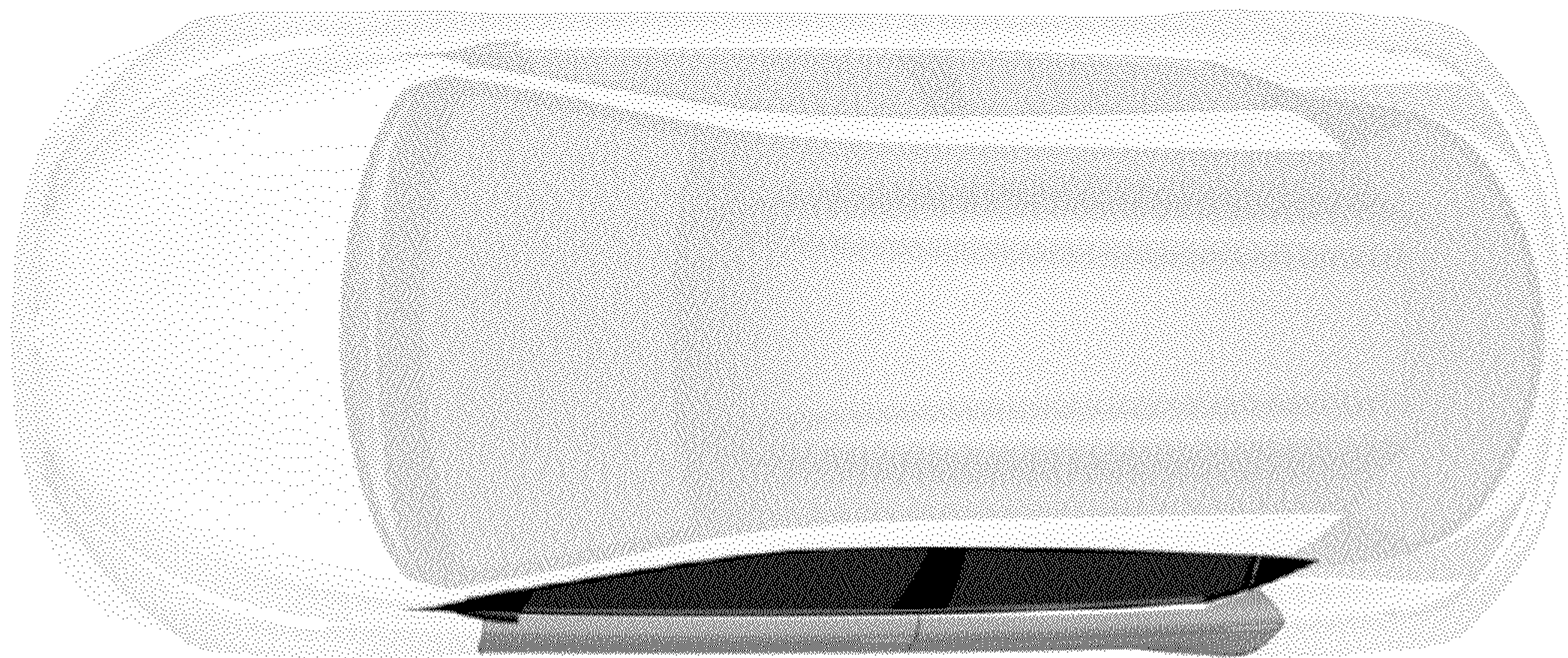

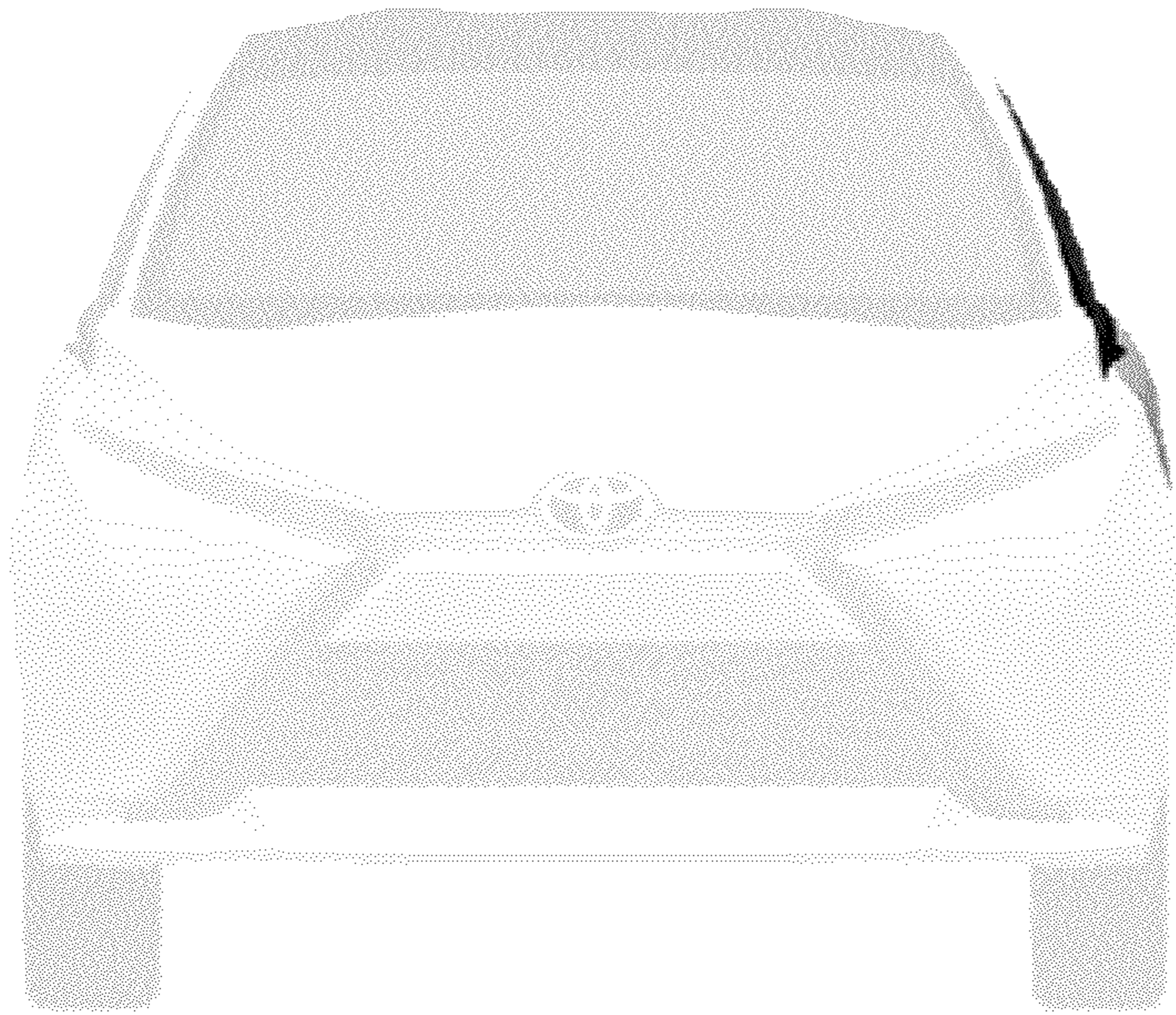

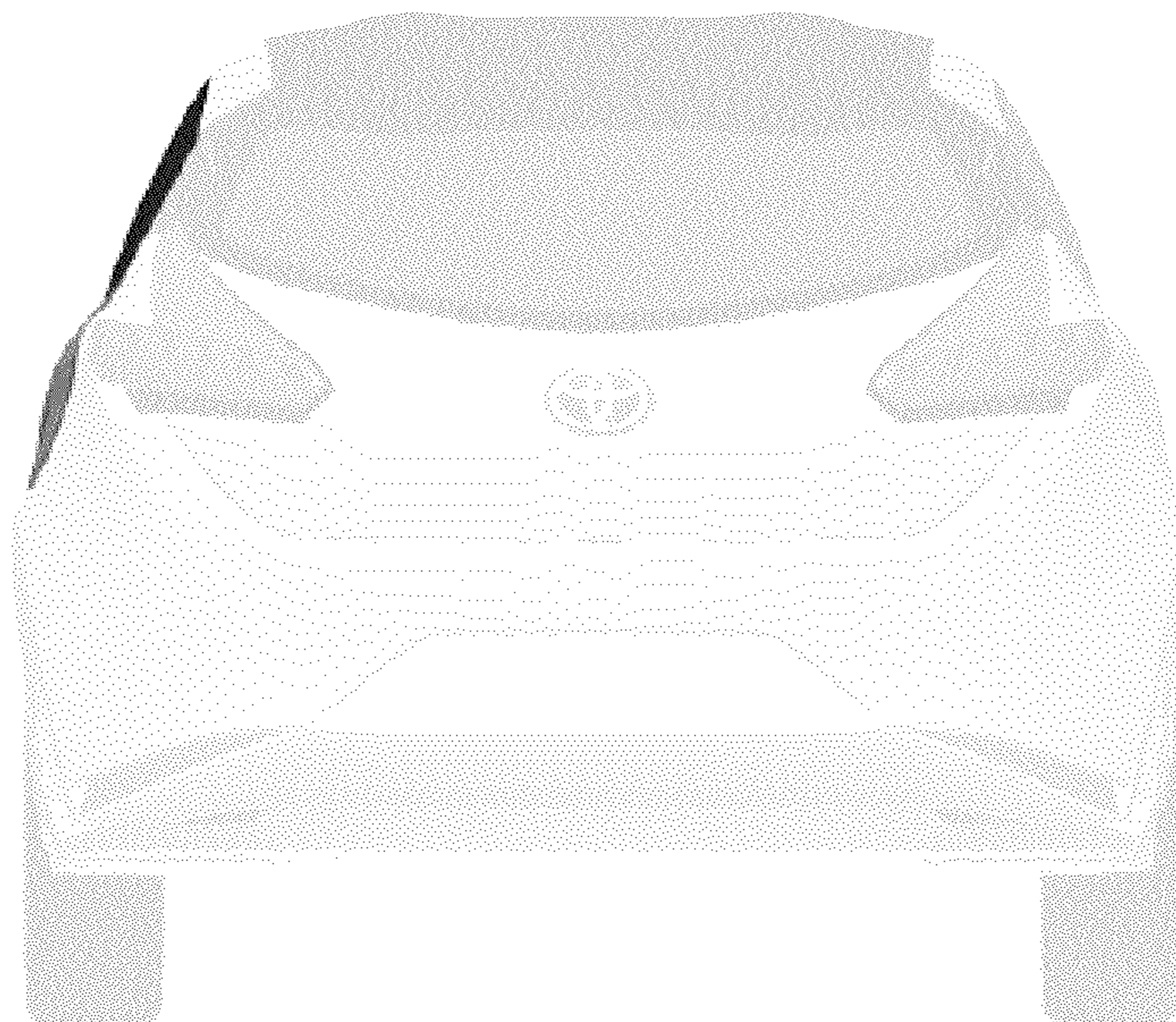
