FIG. 2 depicts a front view thereof.

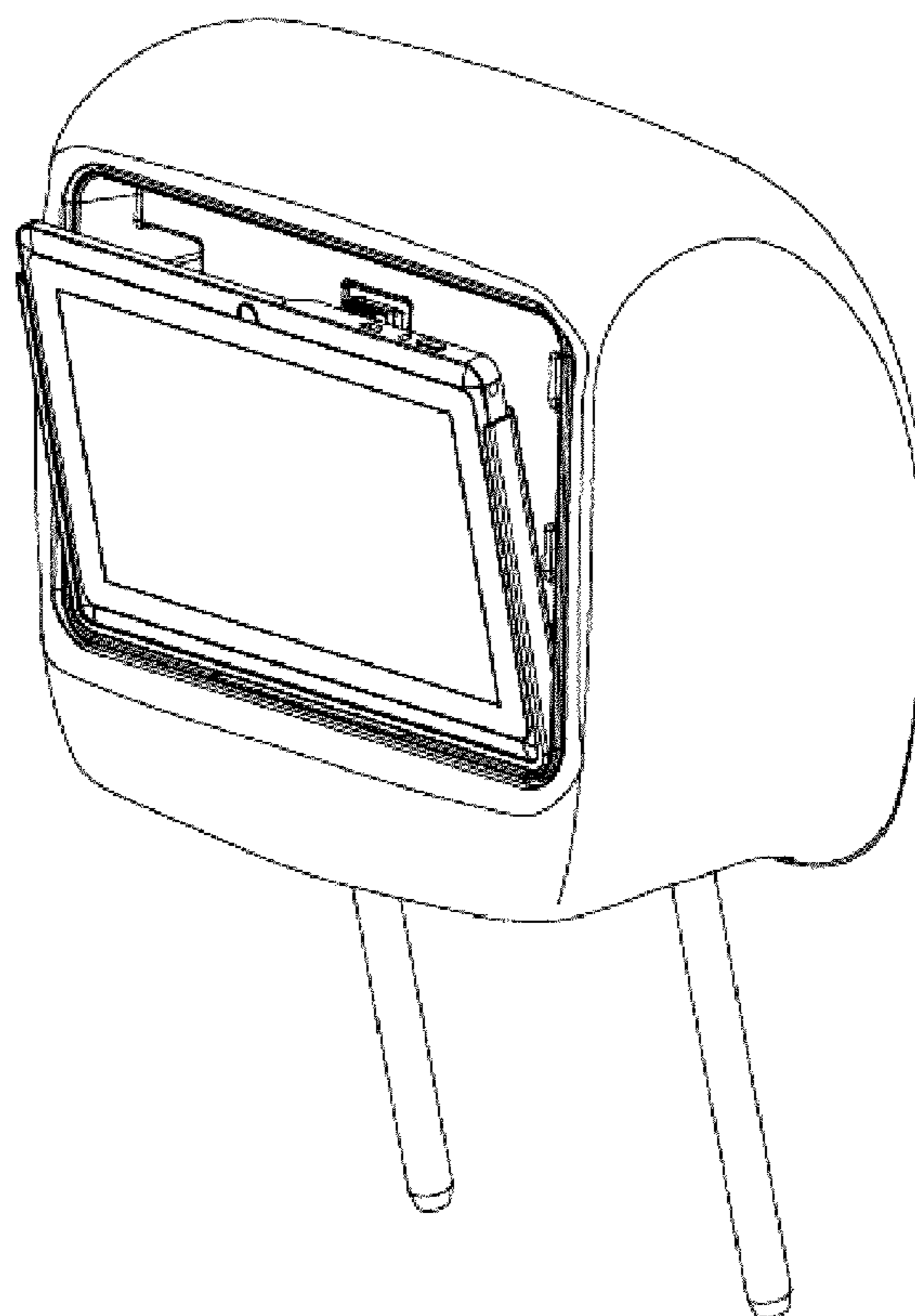
FIG. 3 depicts a right side view thereof.

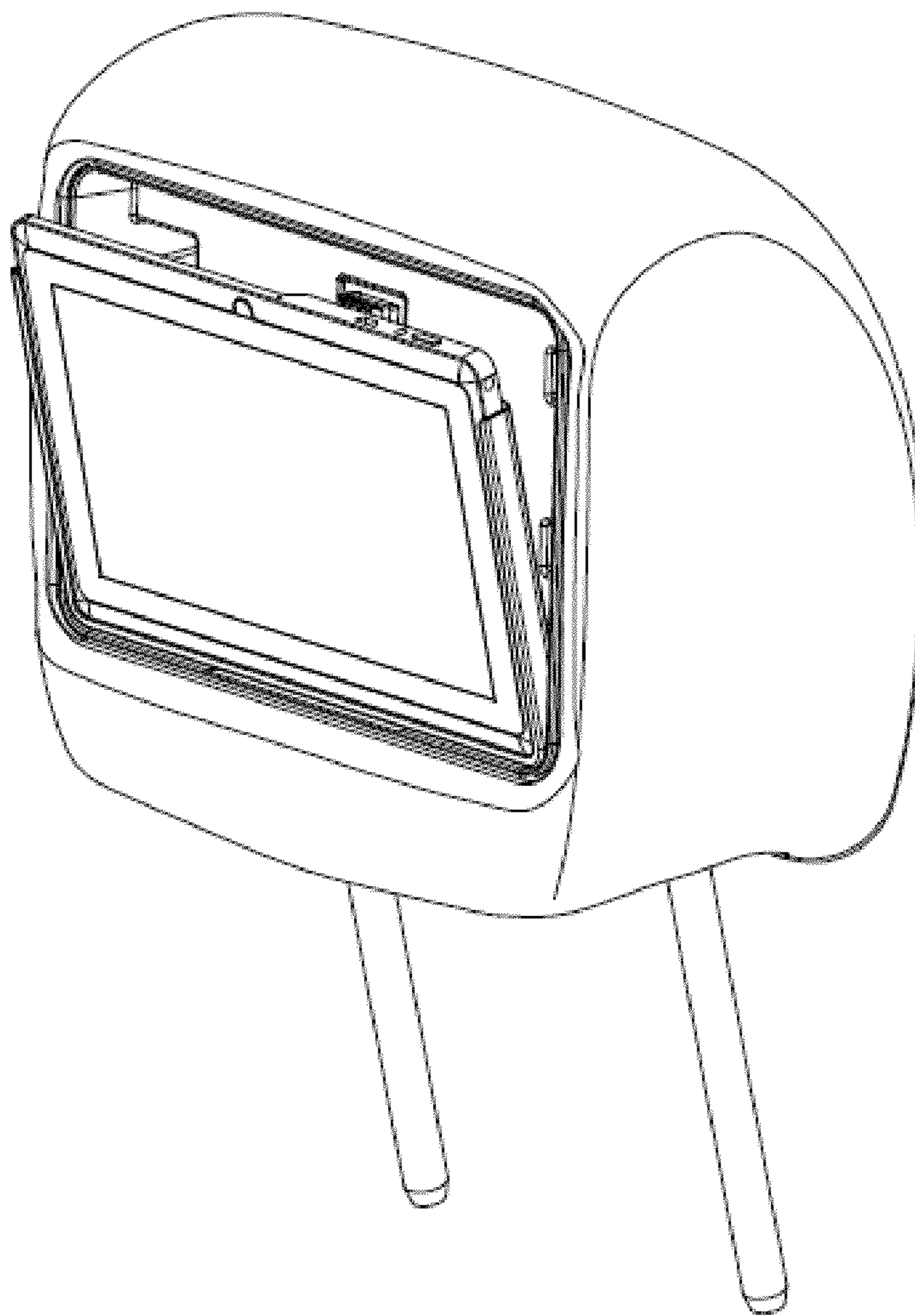

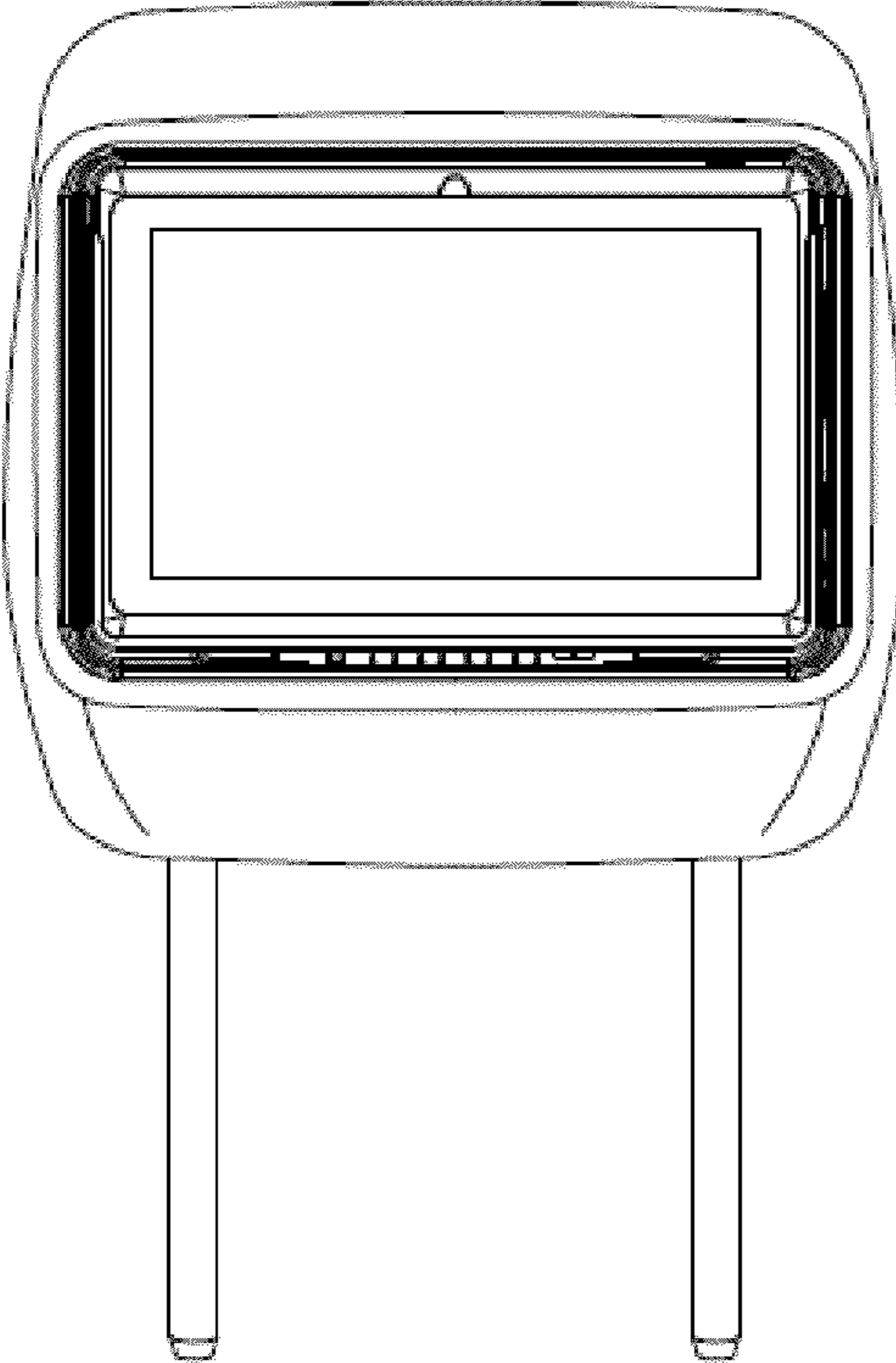

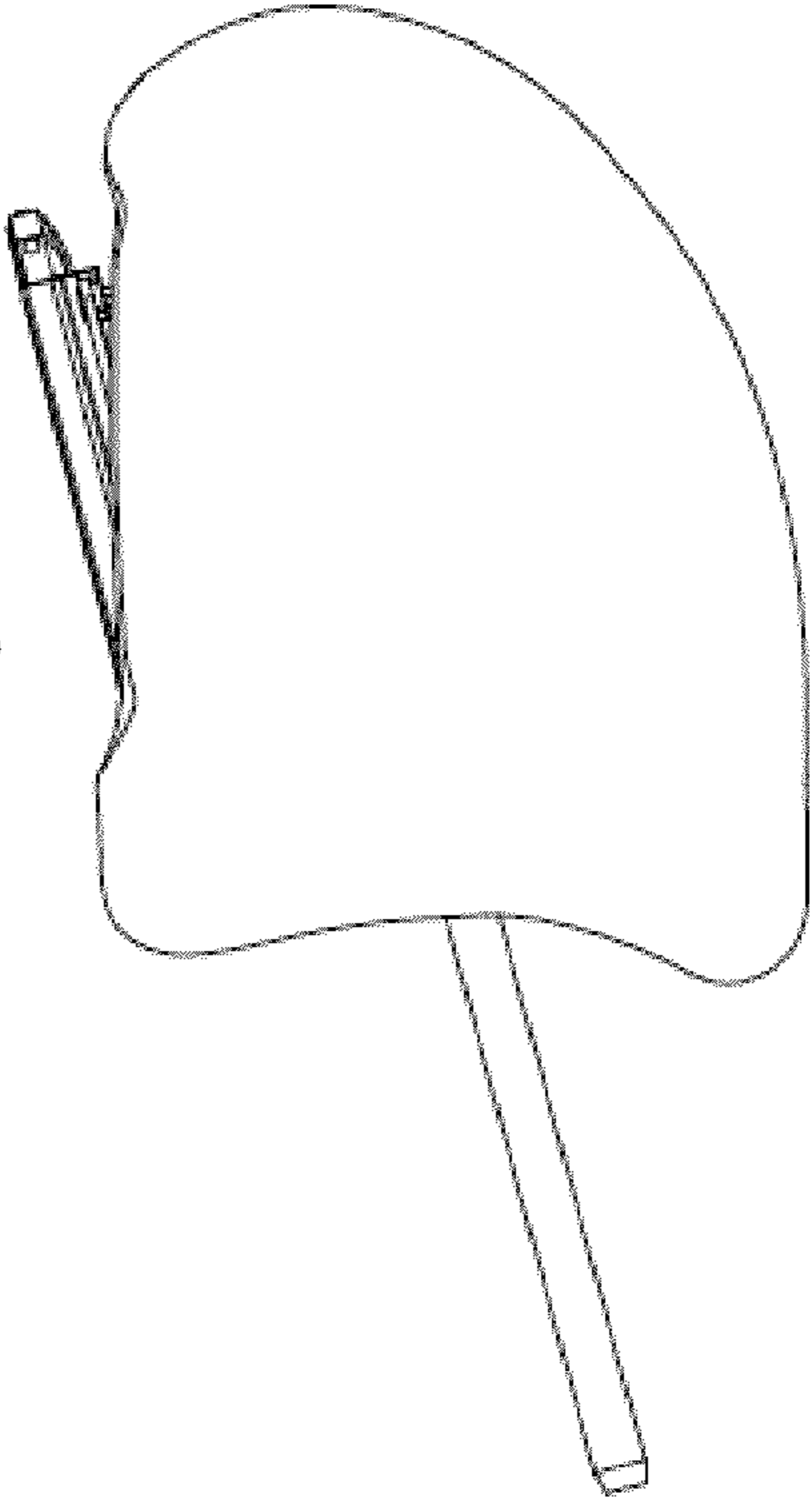

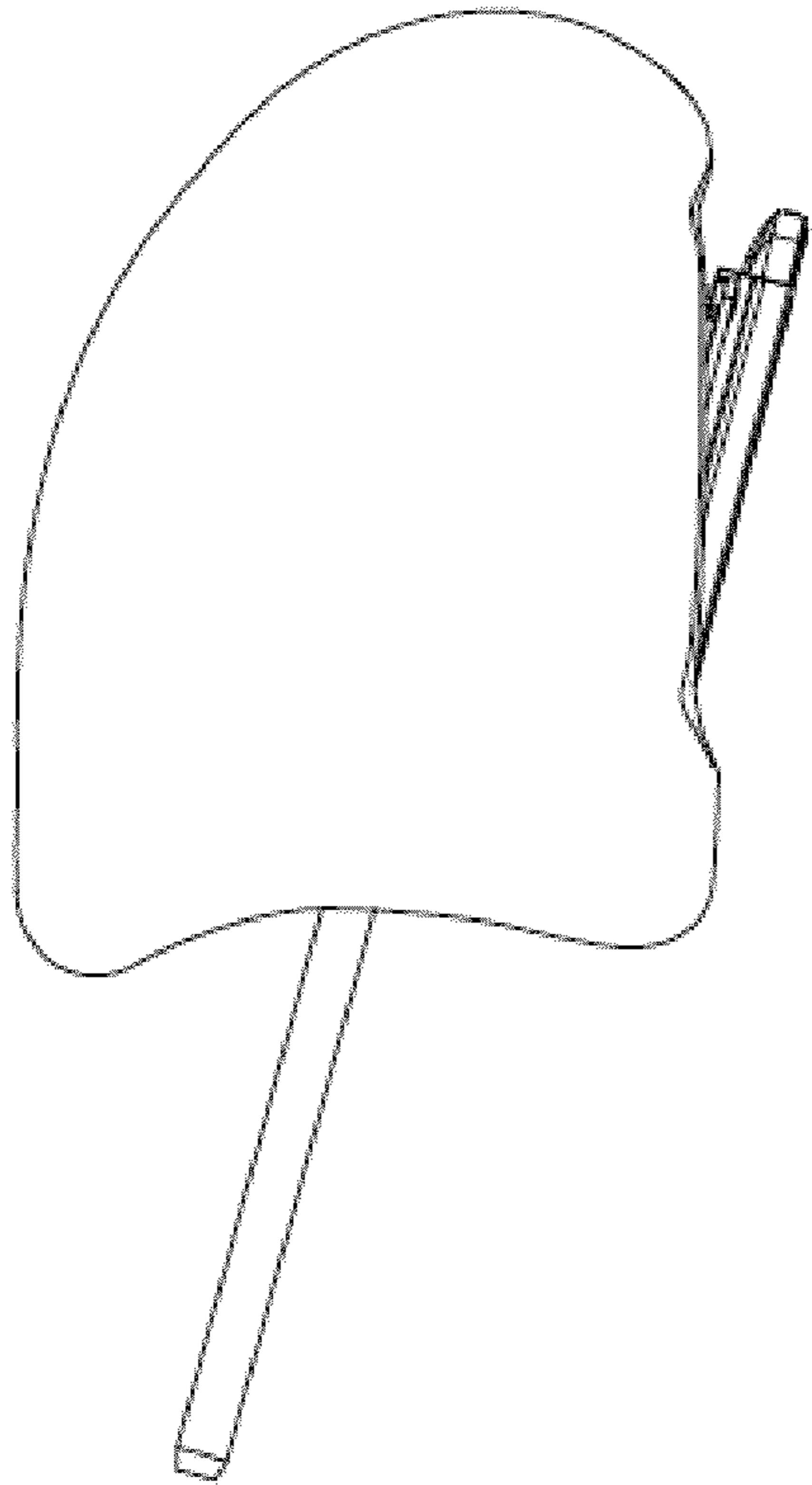

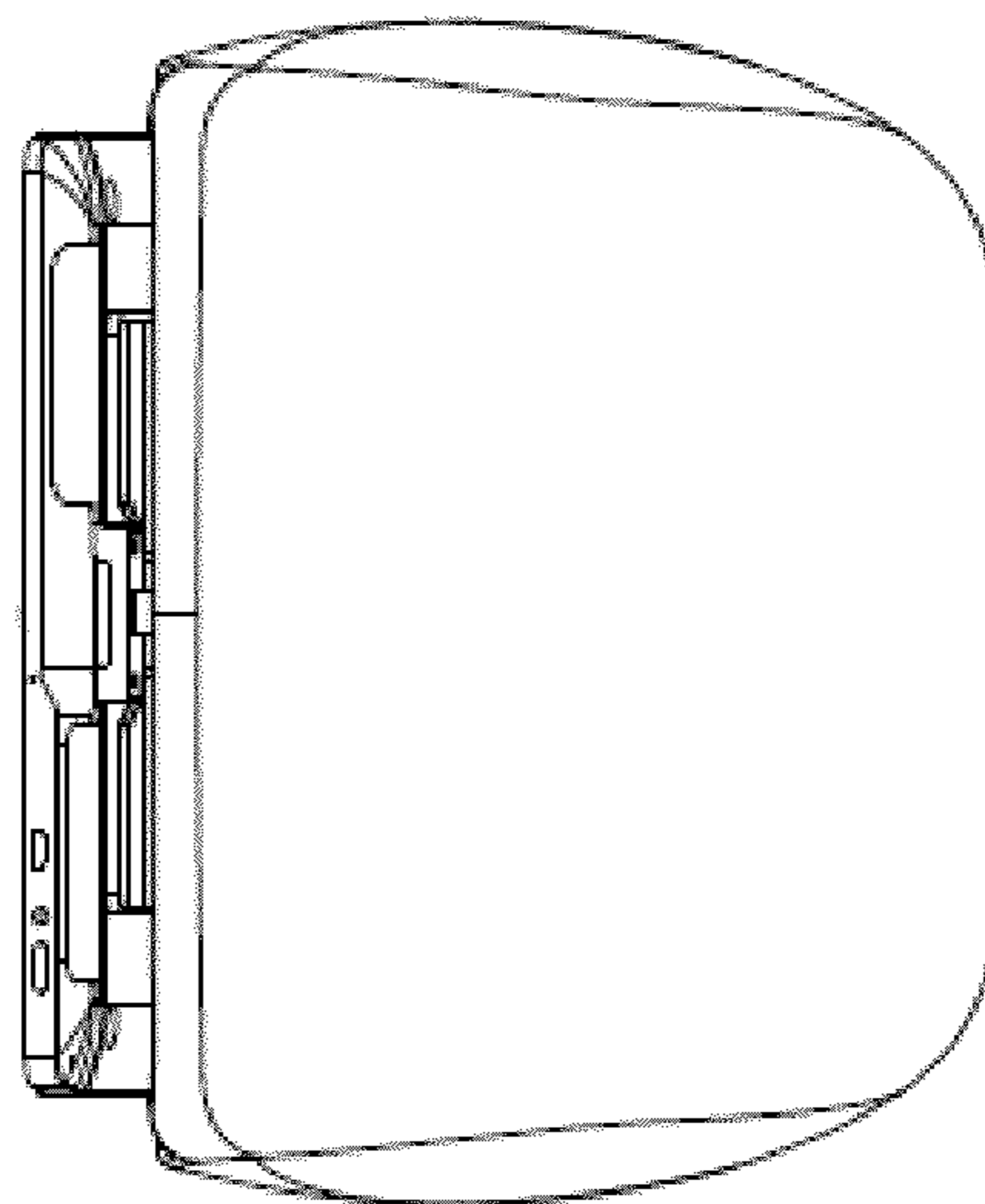

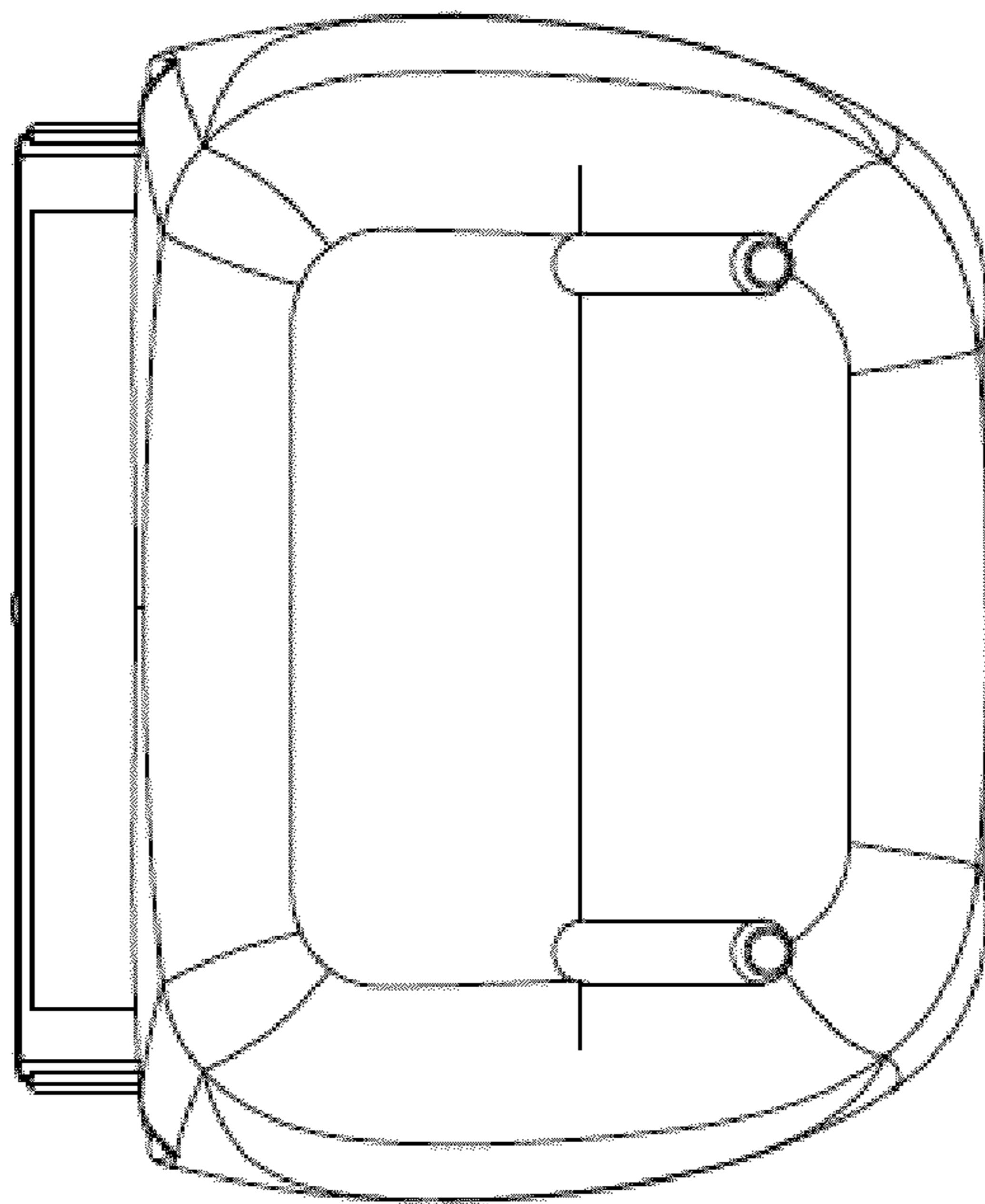
