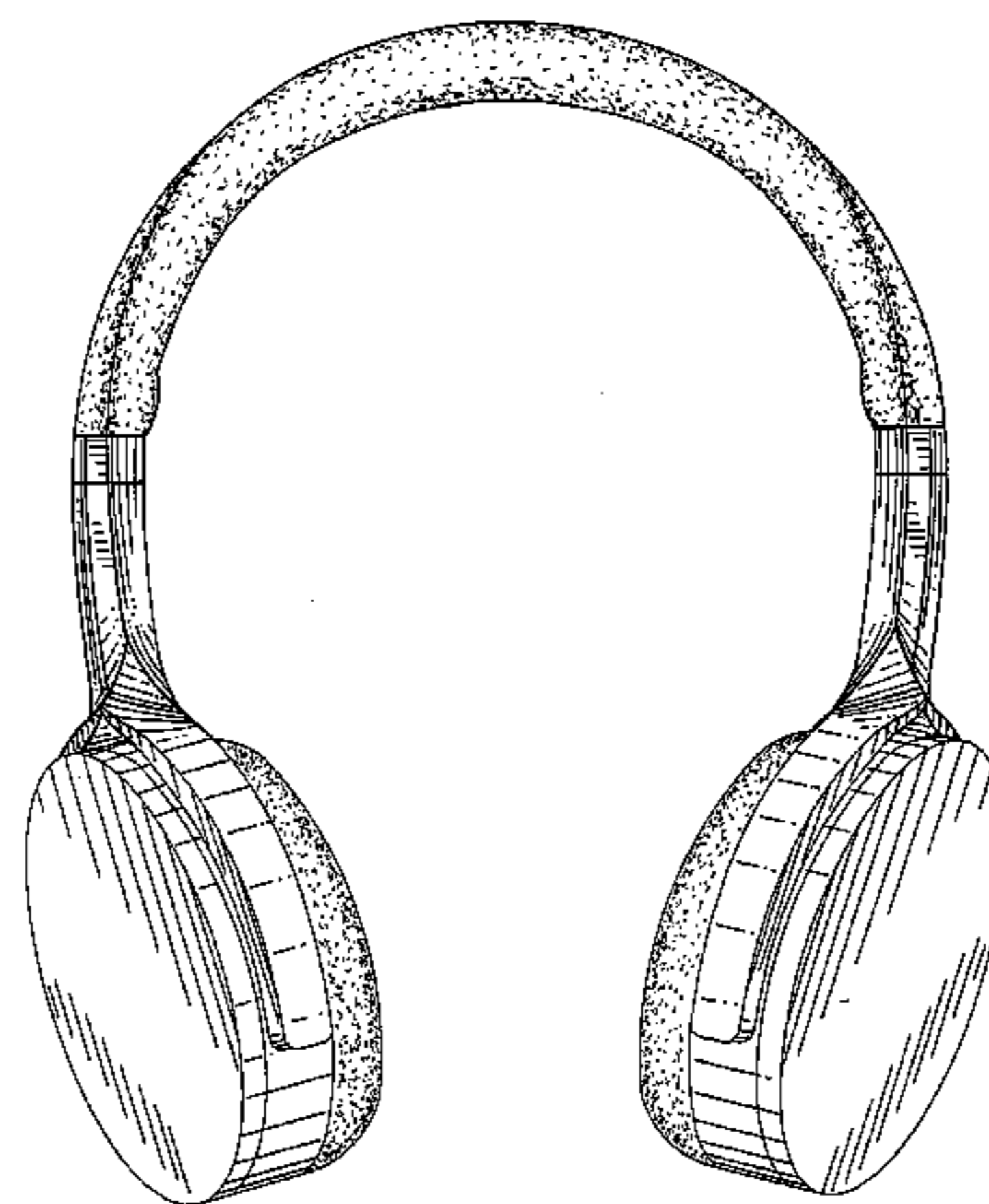
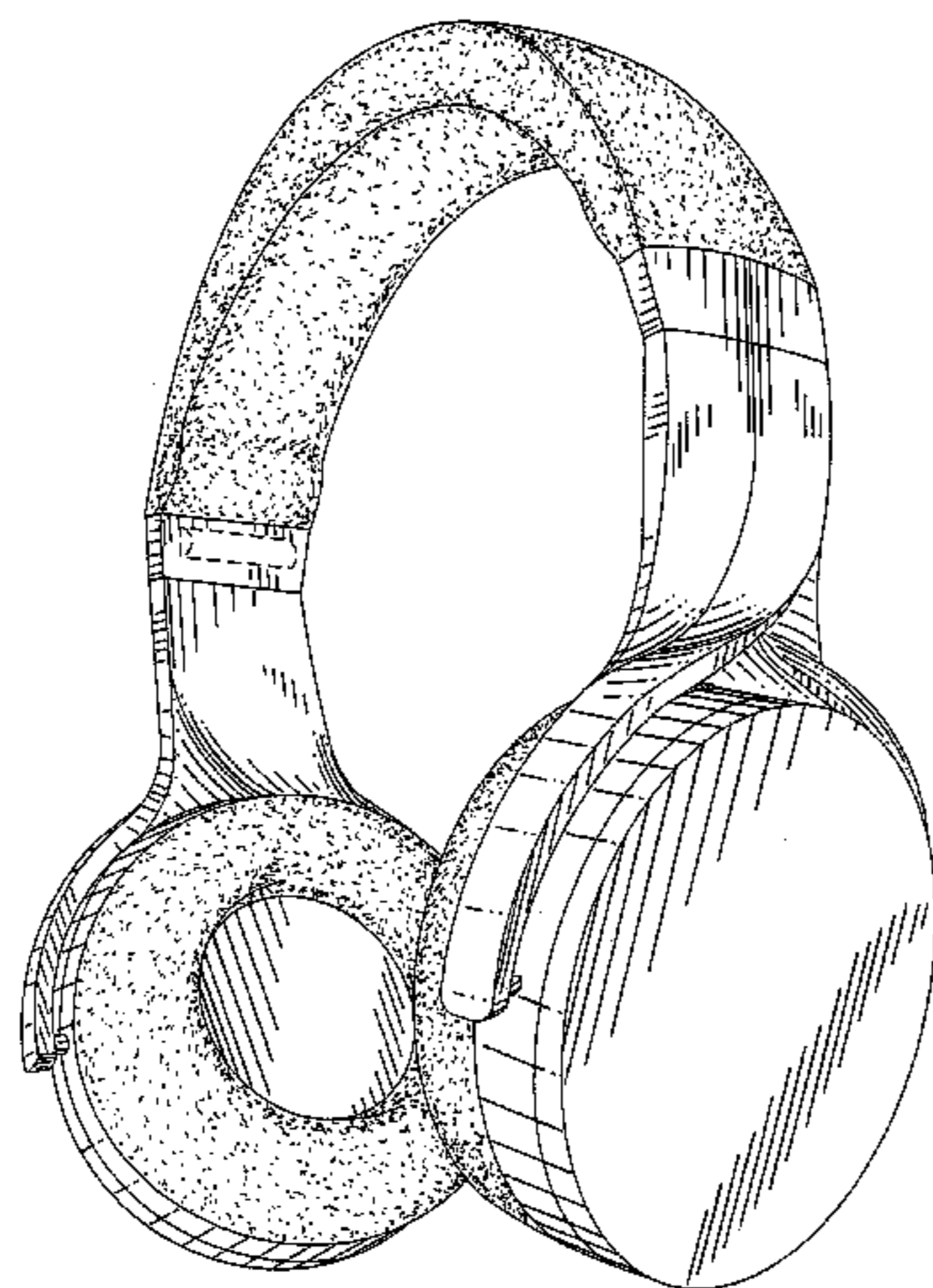
(57) **CLAIM**

The ornamental design for a headphone, as shown and described.

DESCRIPTION

FIG. 1 is the front and the right side perspective view of the headphone showing our new design; FIG. 2 is a top plan view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a left side elevational view thereof, the right side elevational view being a mirror image; FIG. 5 is a rear elevational view thereof; and, FIG. 6 is a bottom plan view thereof. The broken lines in FIGS. 1 and 3 showing swiveling hinges are for illustrative purpose only and form no part of the claimed design.

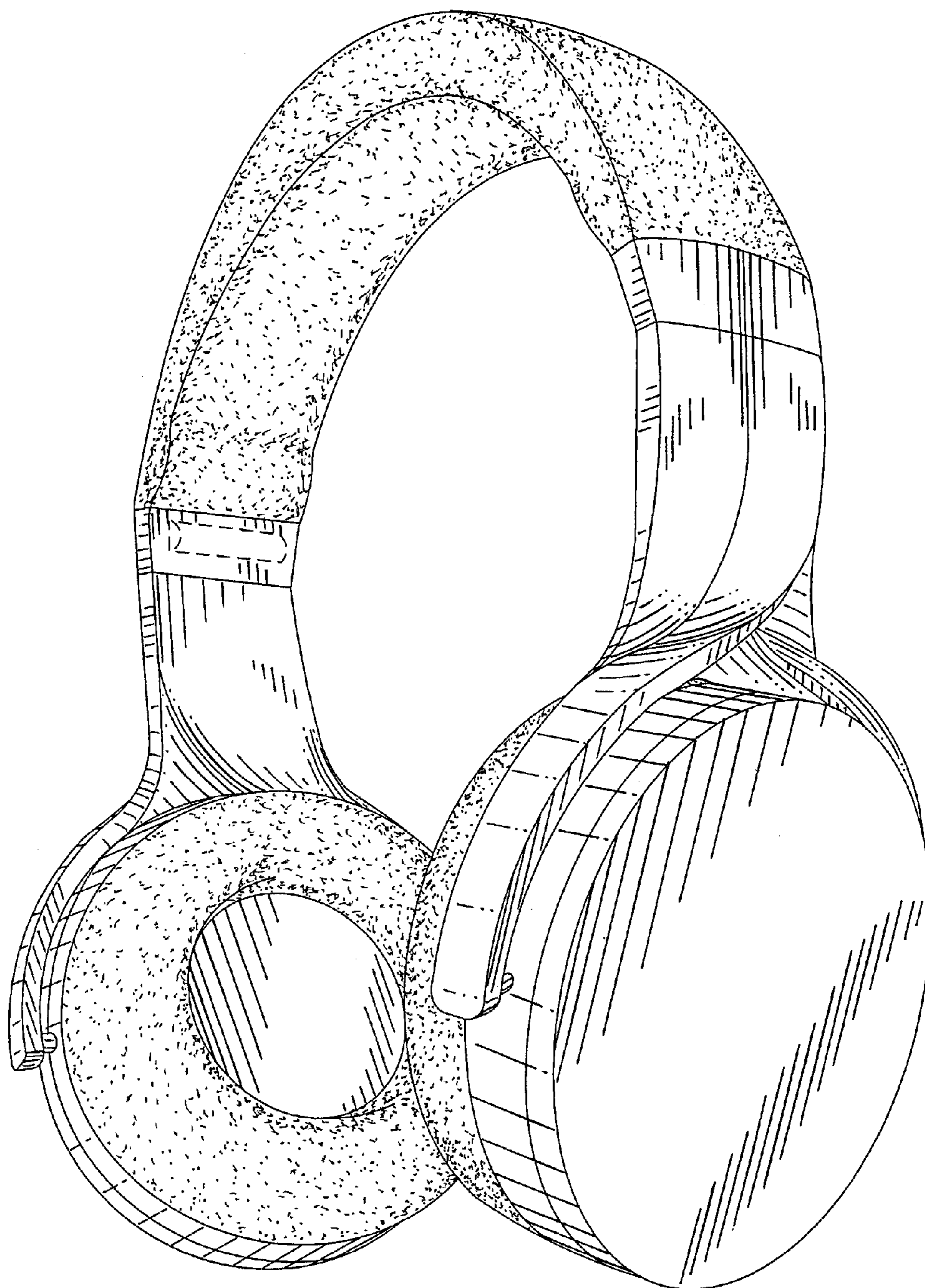

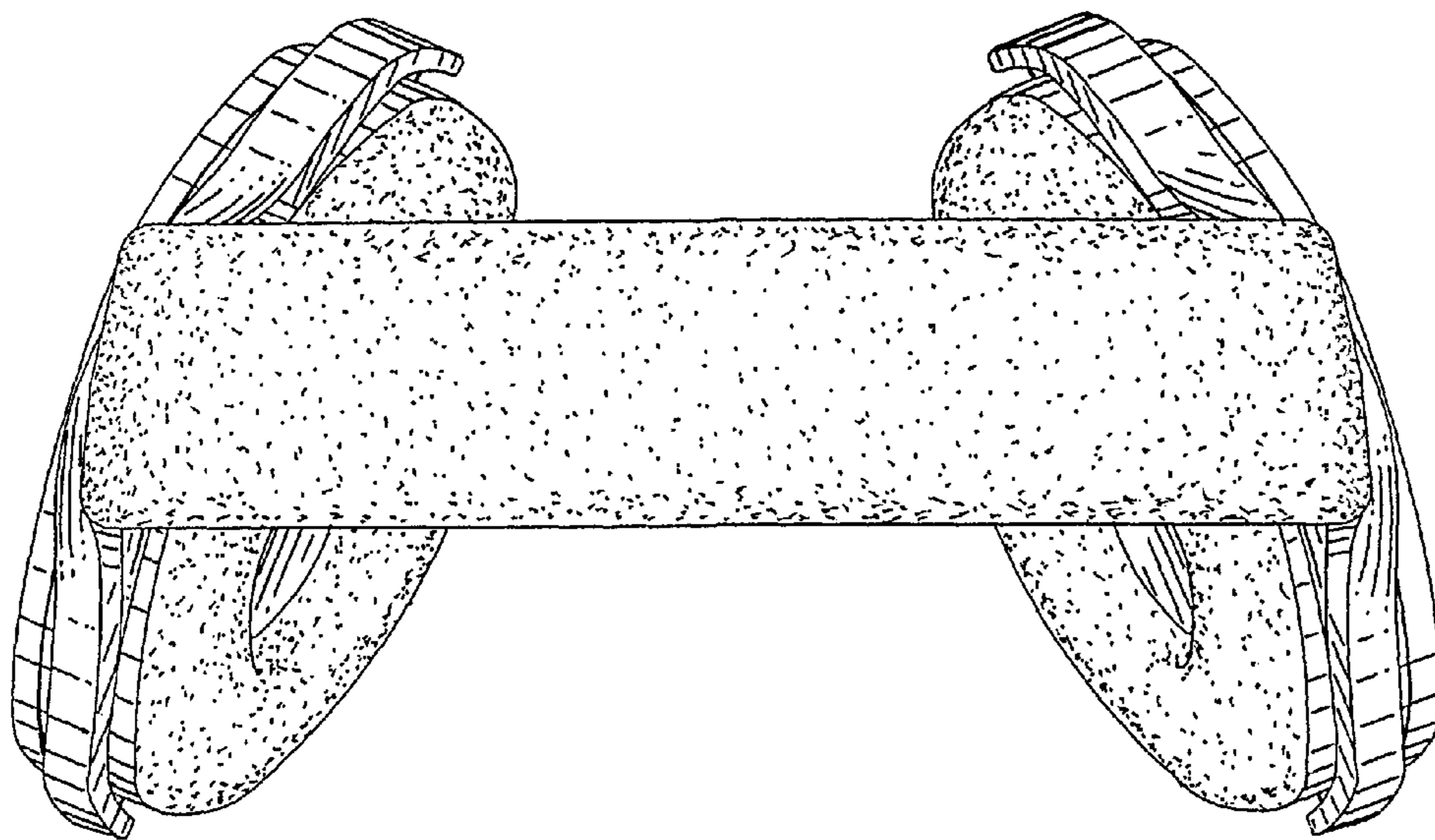

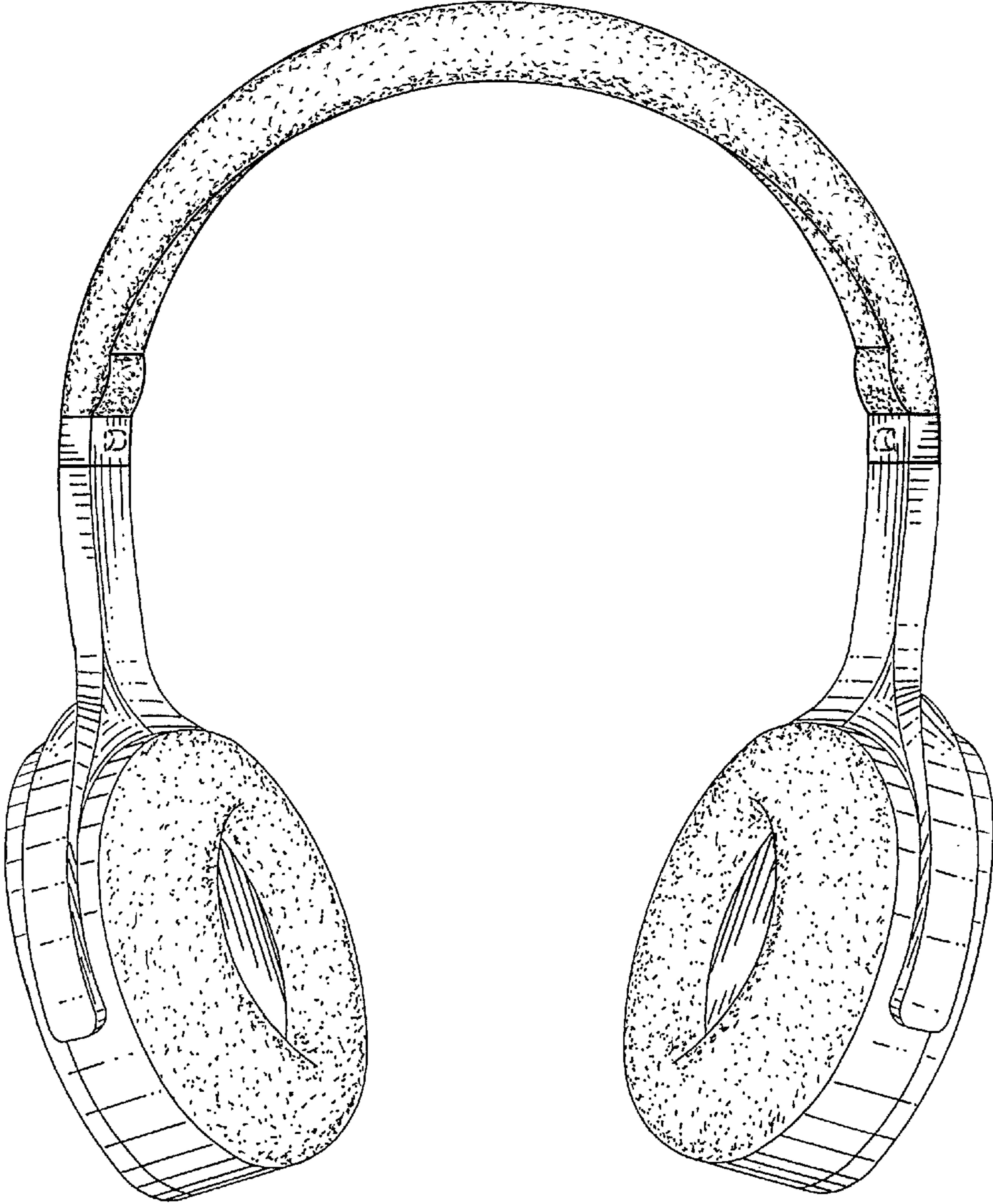

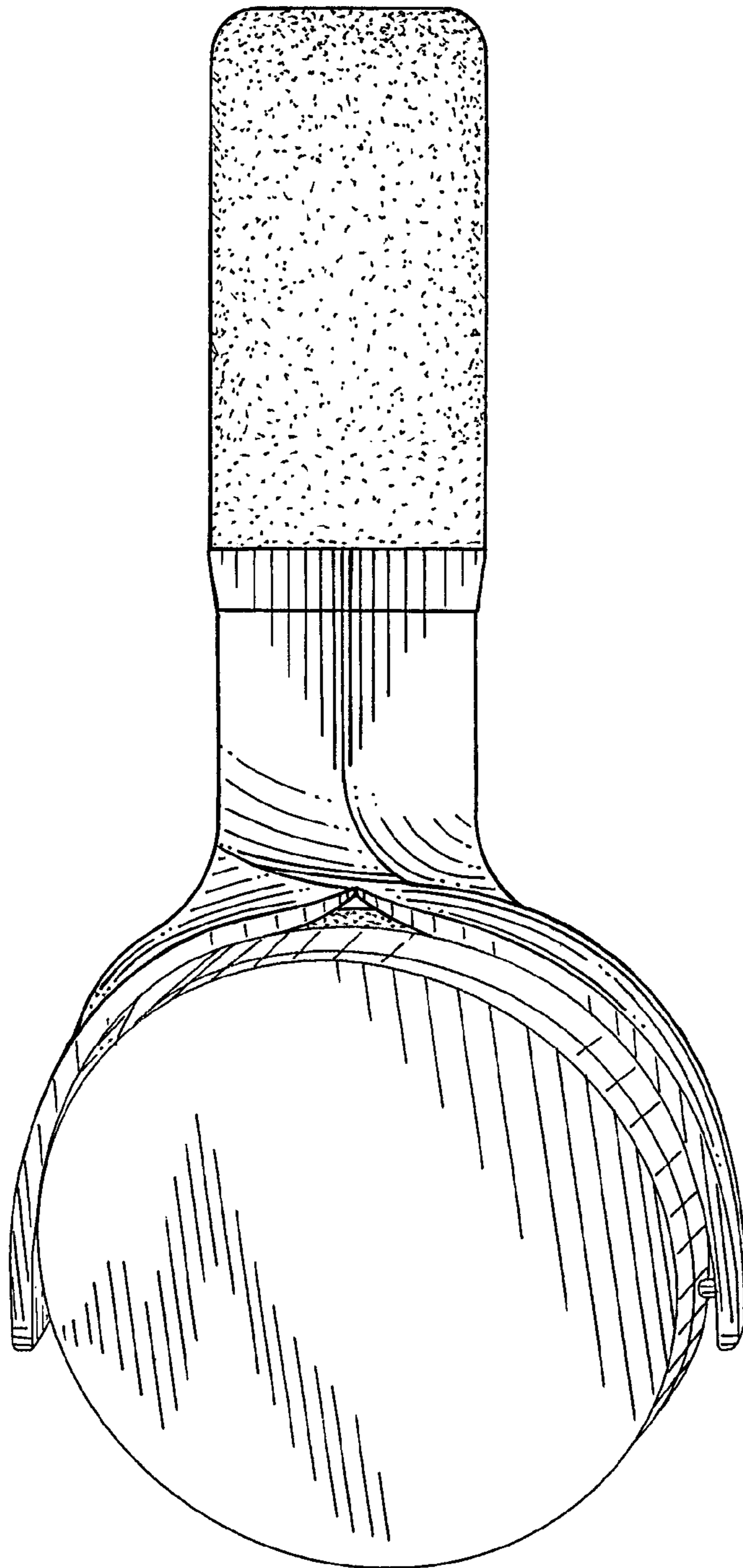

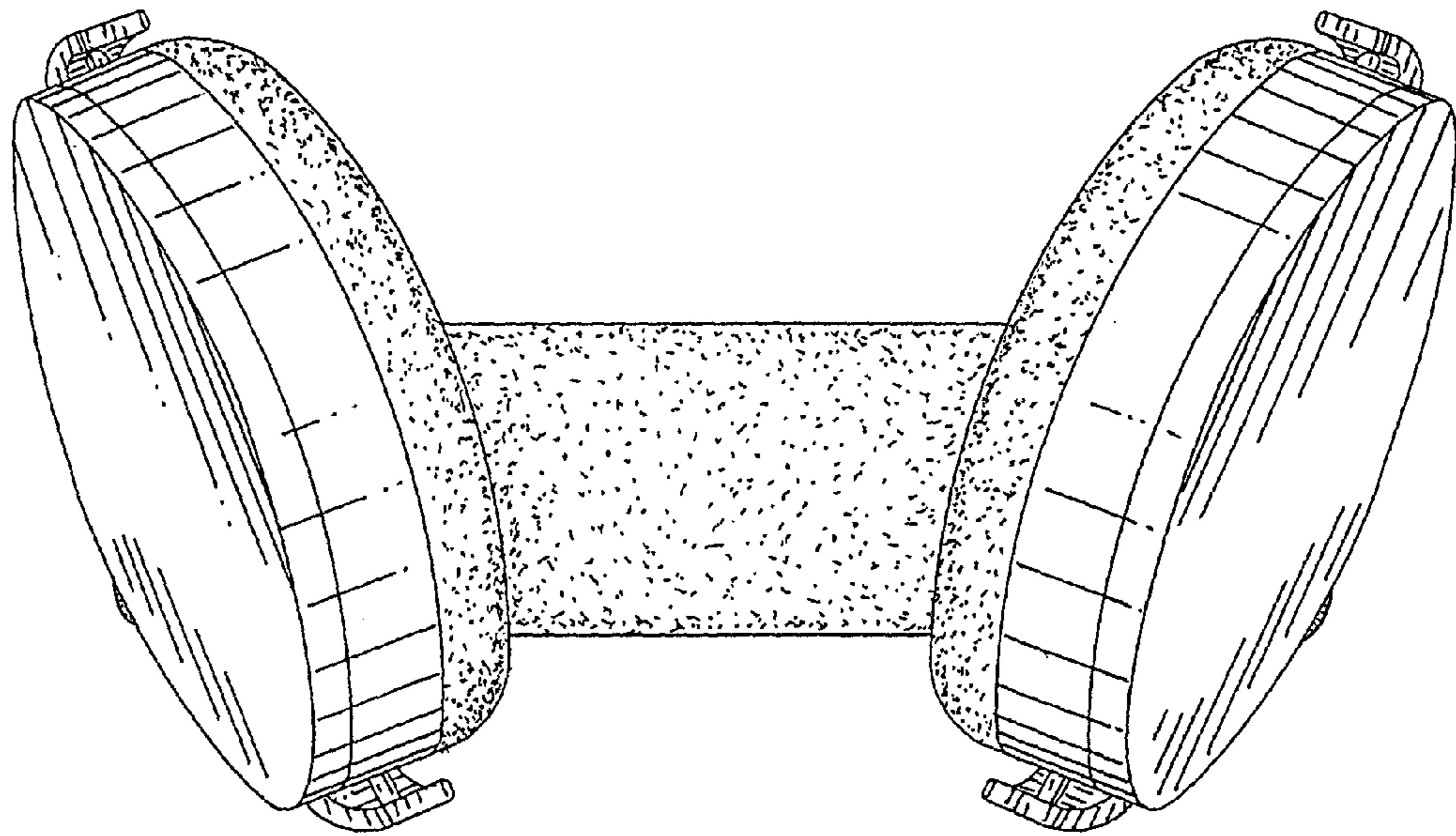
