(57) **CLAIM**

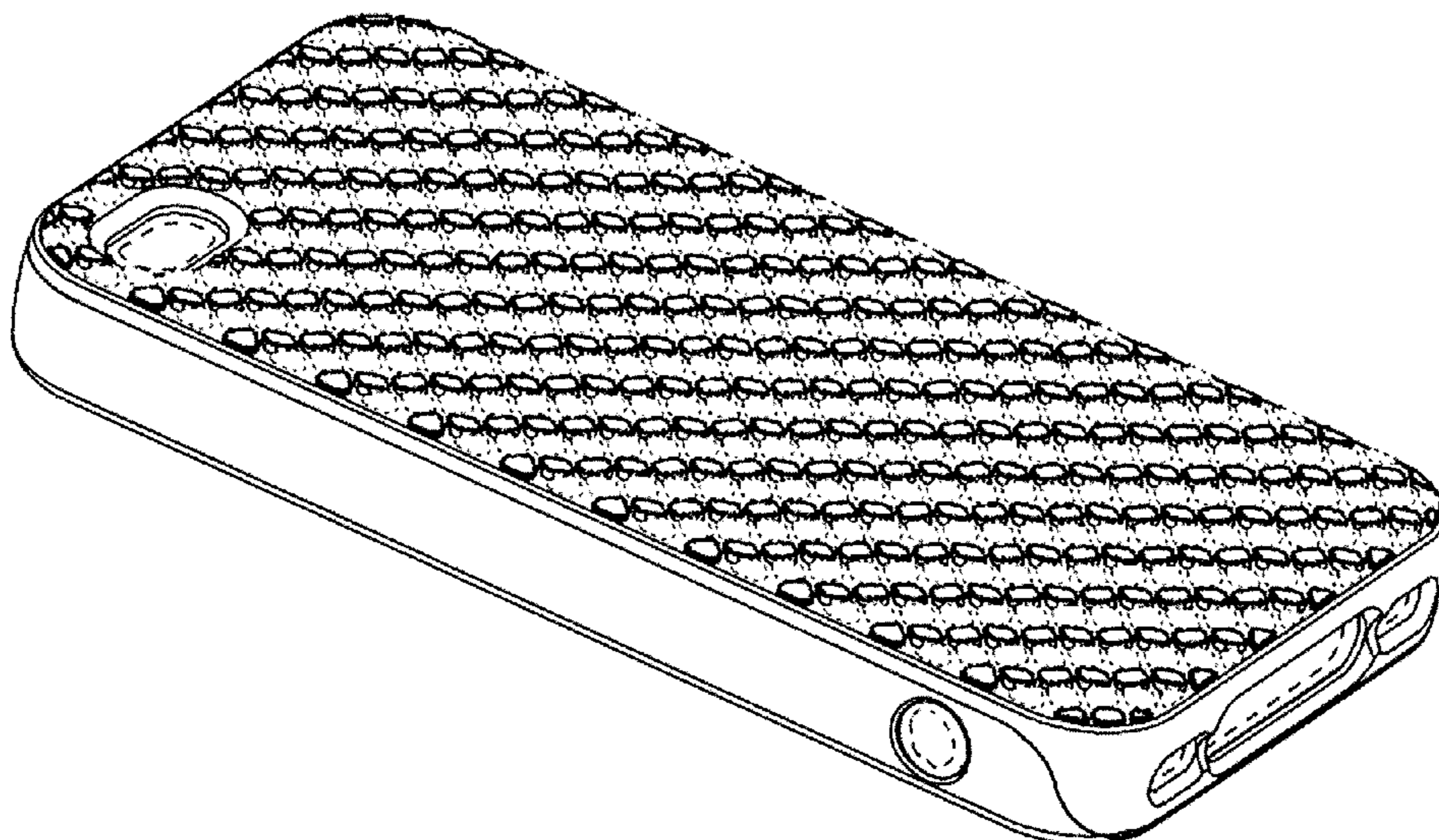
The ornamental design for a protective casing for portable handheld electronic device, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of the protective casing for portable handheld electronic device;  
FIG. 2 is a rear perspective view thereof;  
FIG. 3 is a front elevation view thereof;  
FIG. 4 is a rear elevation view thereof;  
FIG. 5 is a right elevation view thereof;  
FIG. 6 is a left elevation view thereof;  
FIG. 7 is a top plan view thereof; and,  
FIG. 8 is a bottom plan view thereof.

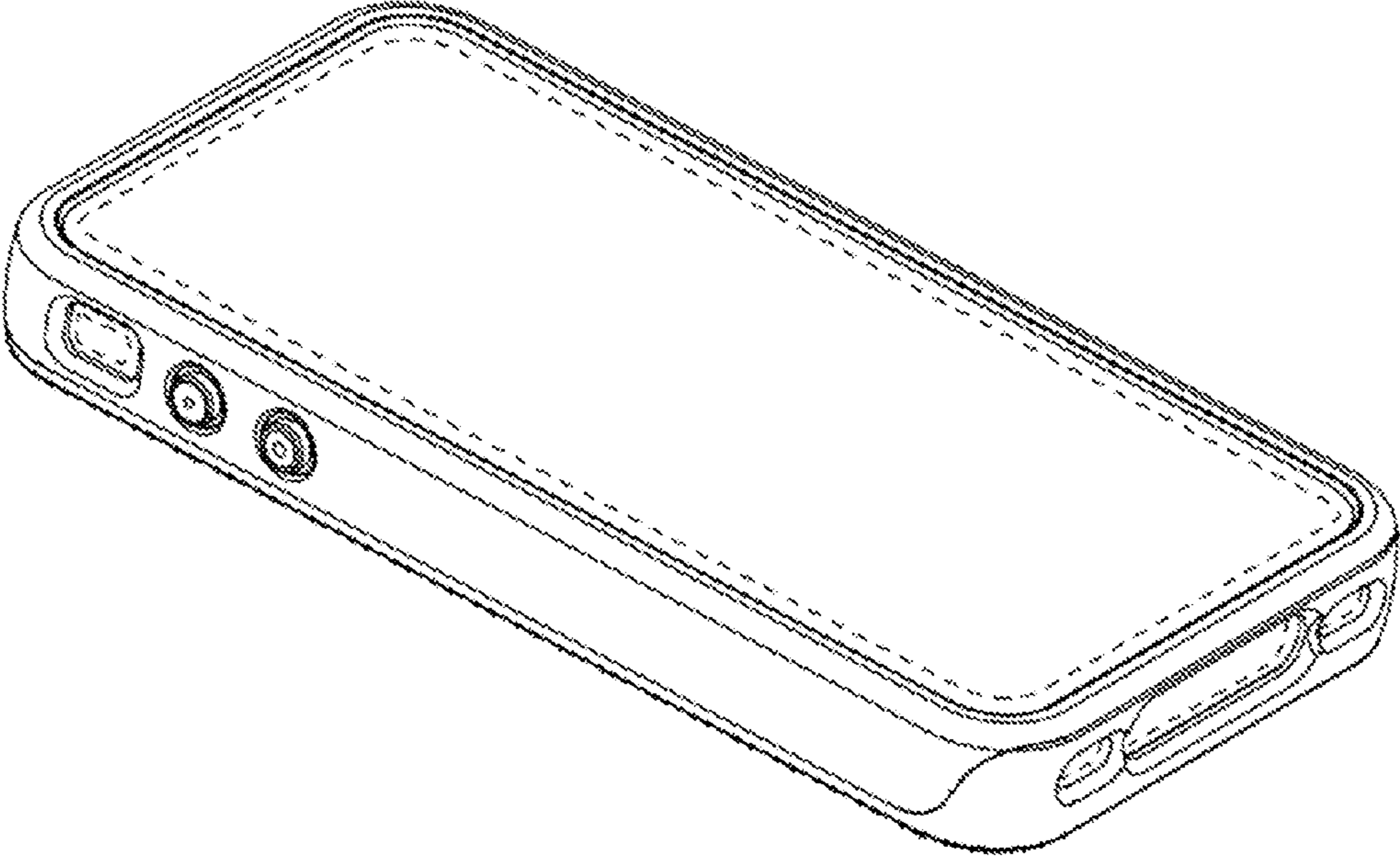

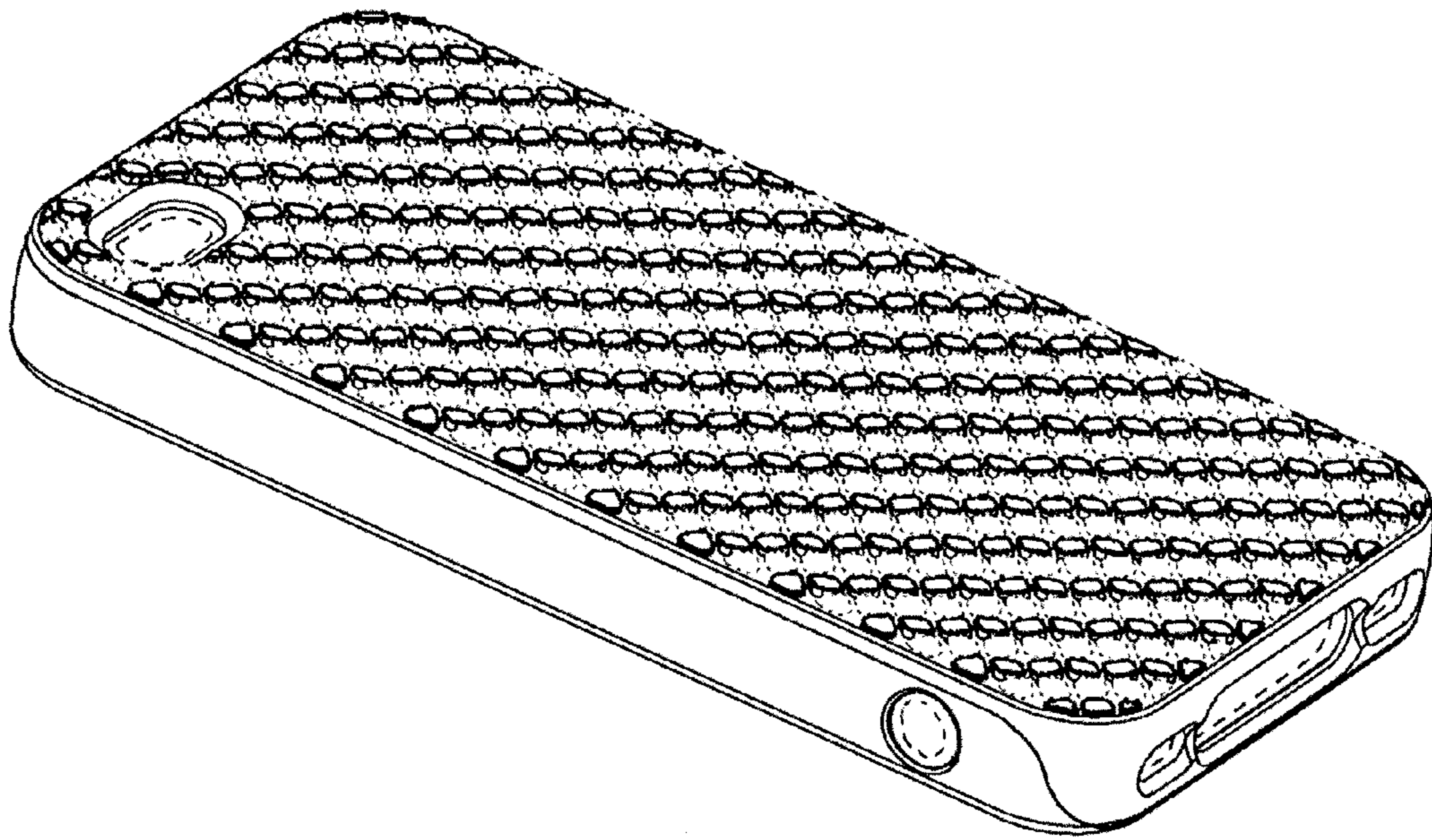

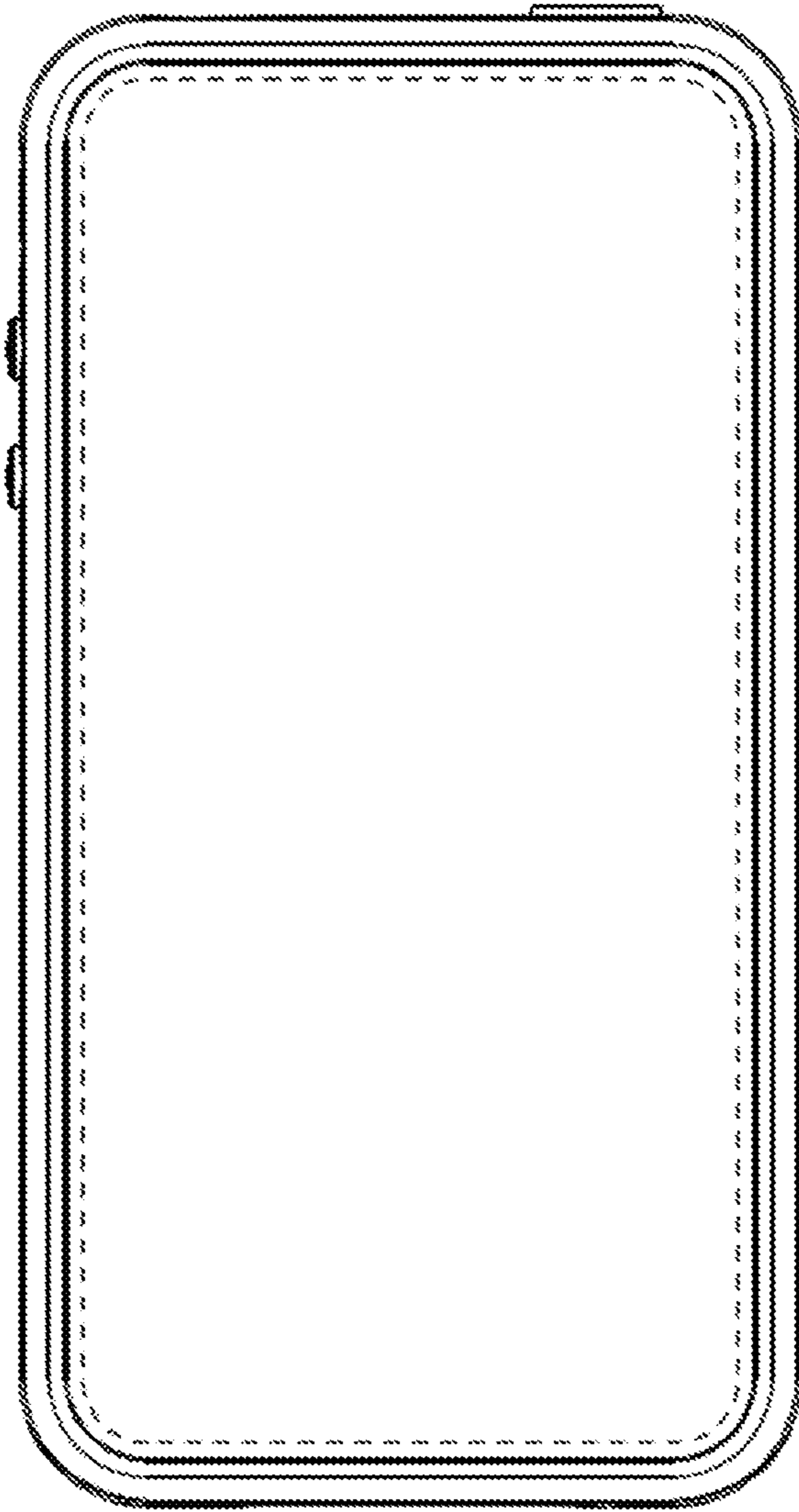

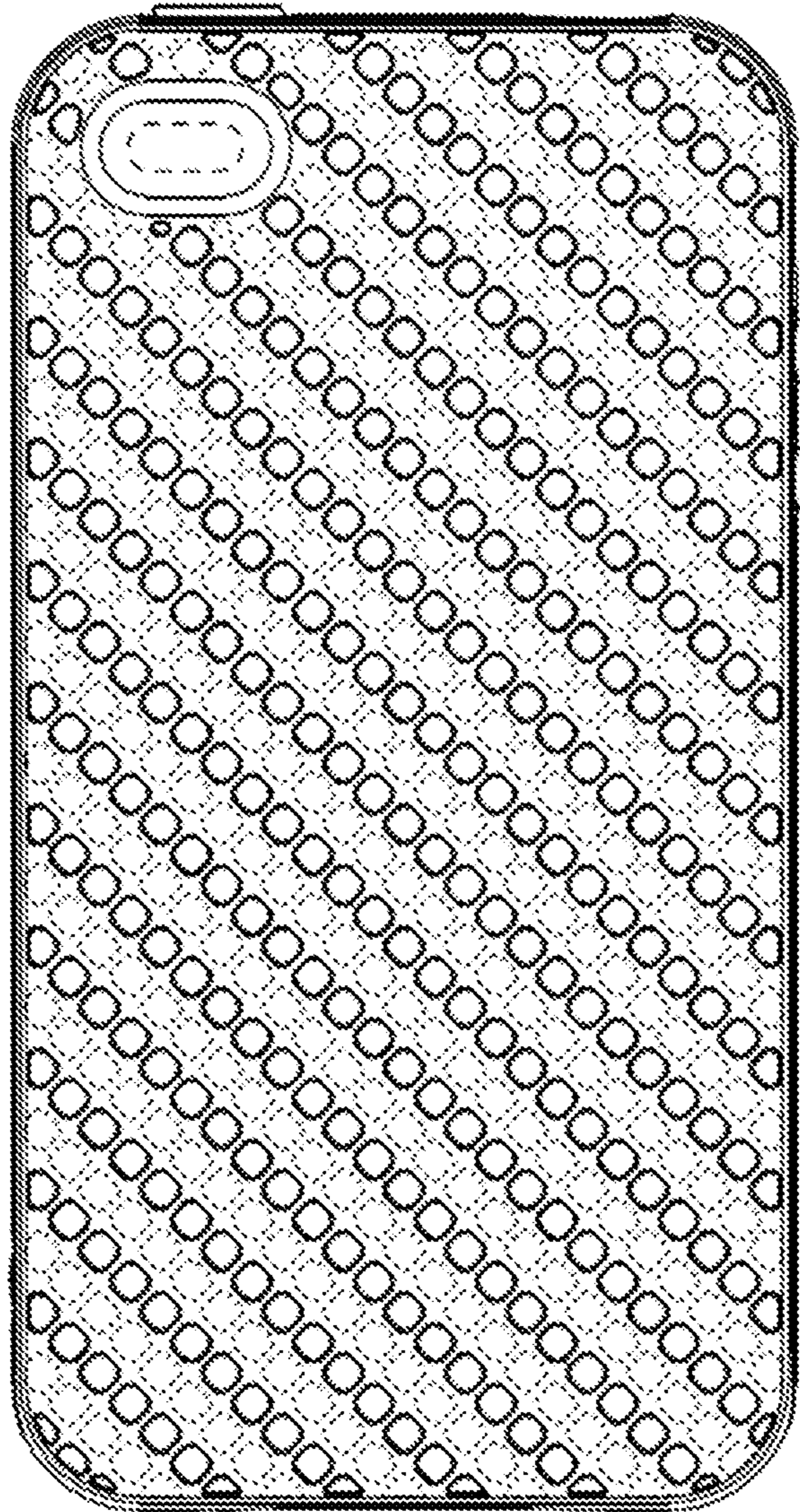

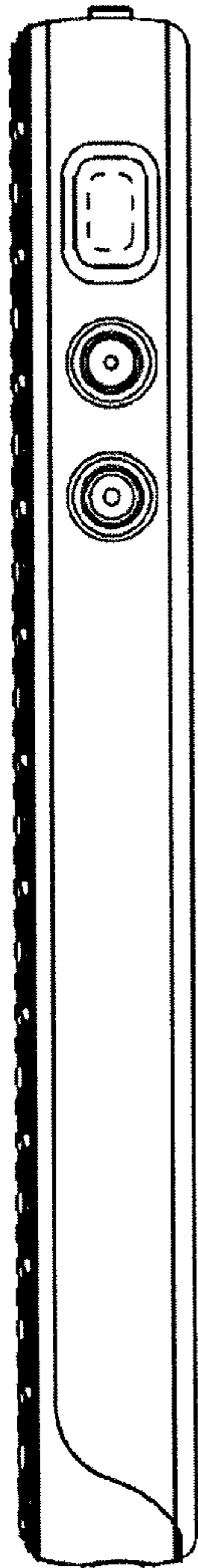

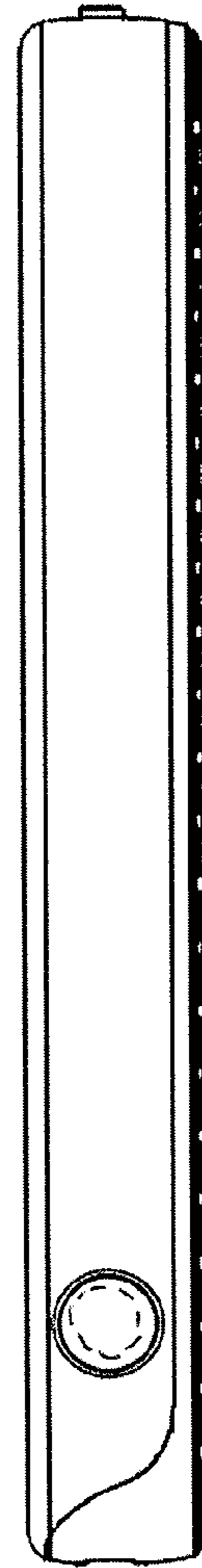

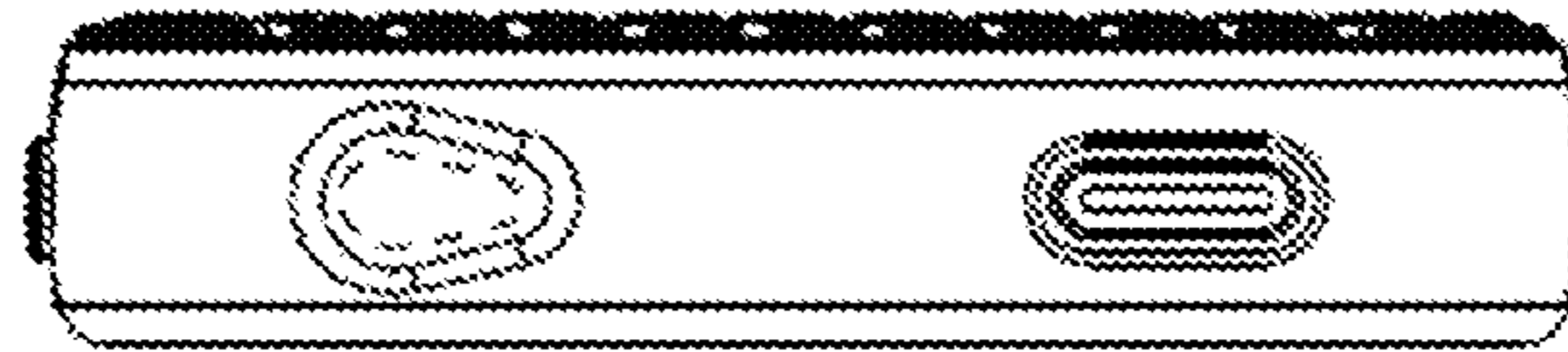
