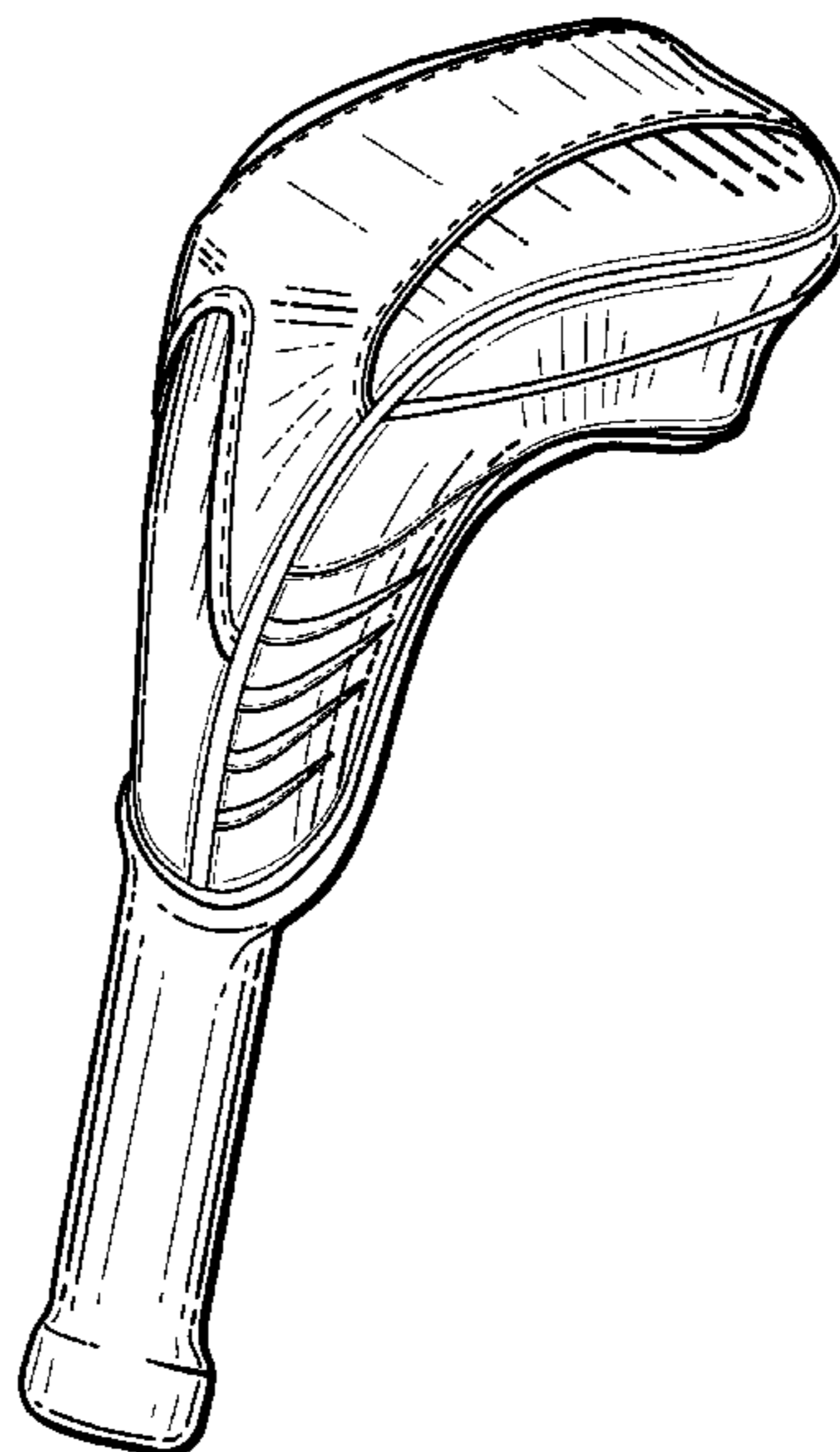

**DESCRIPTION**

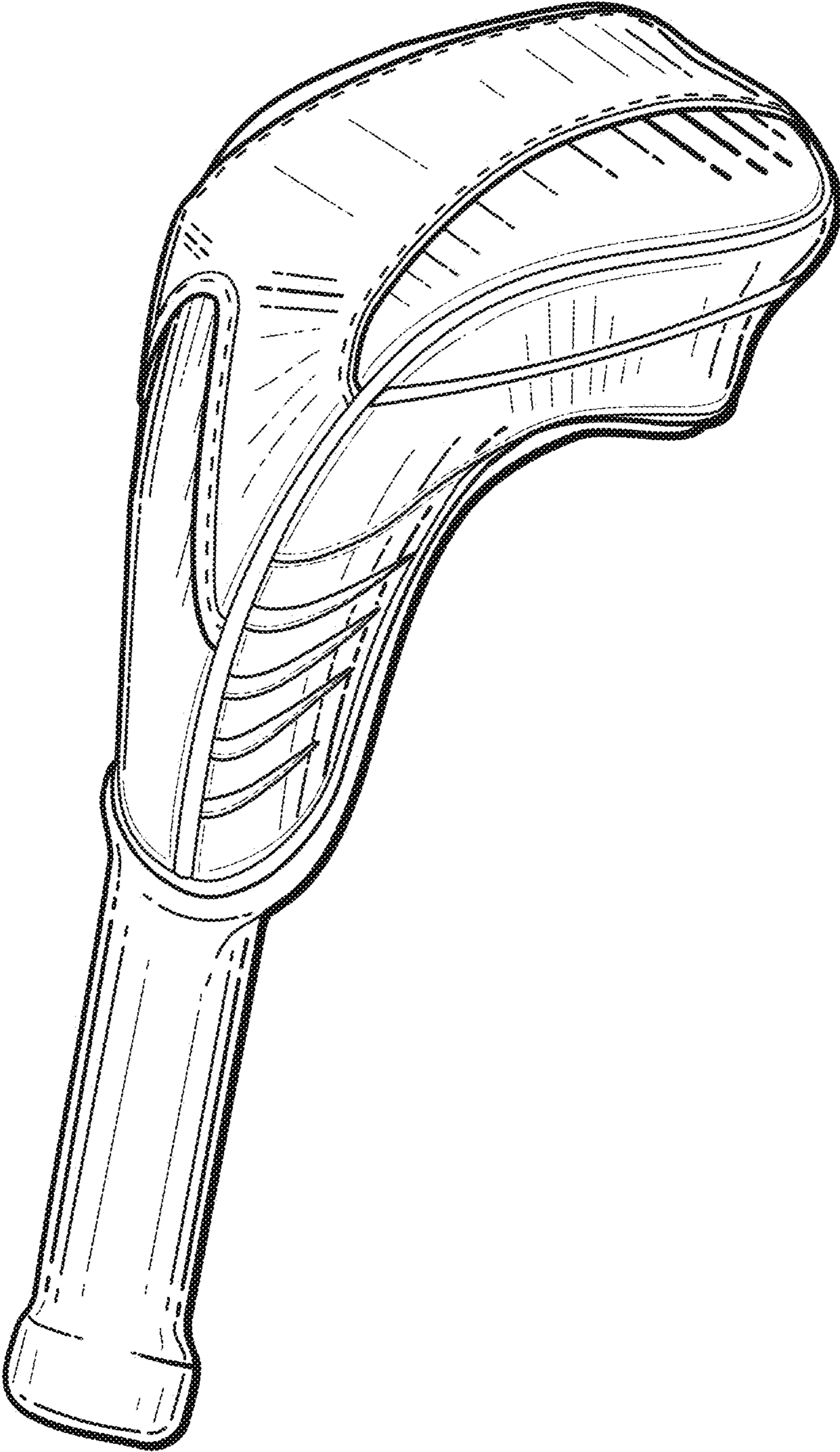

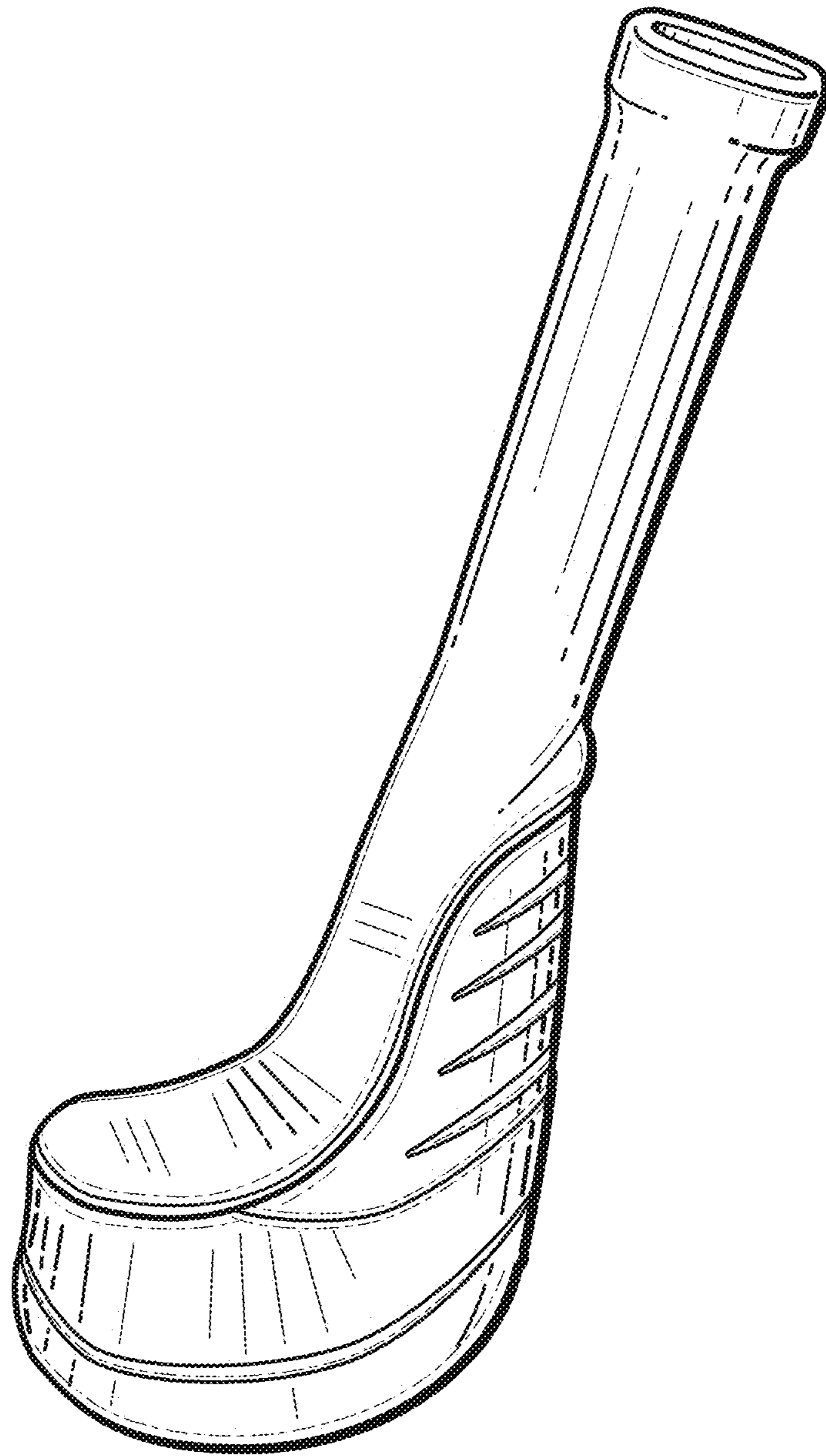

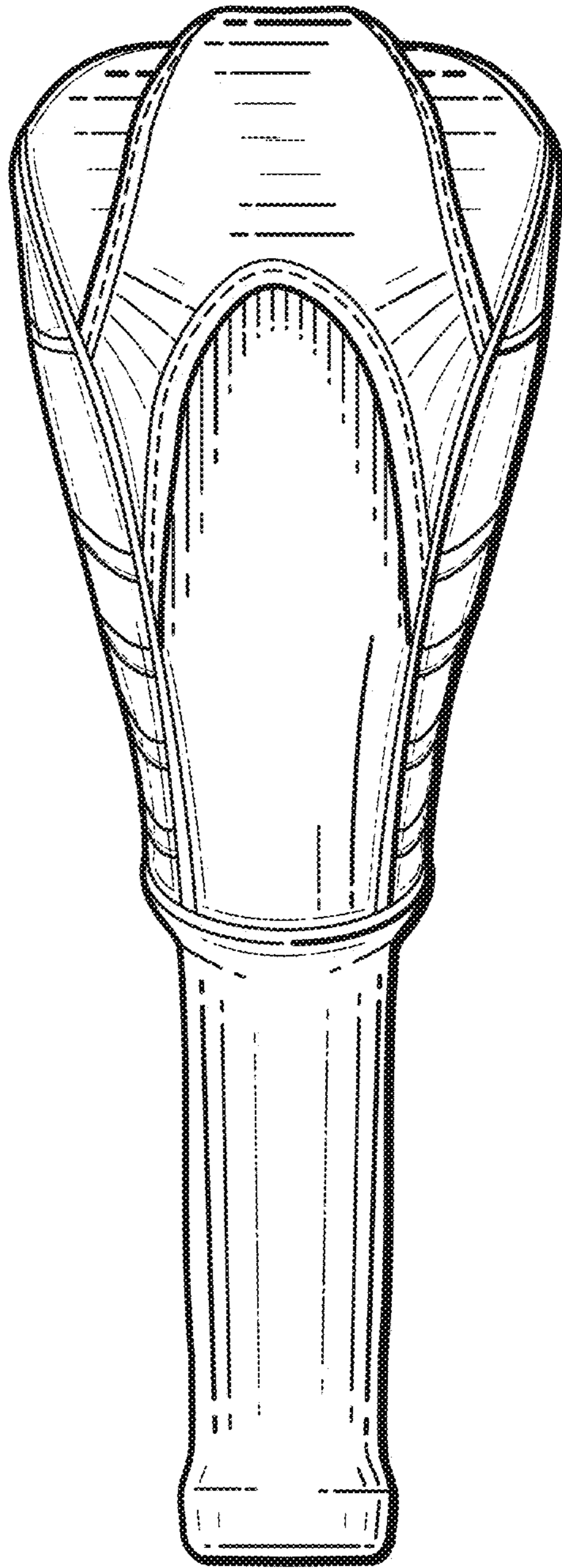

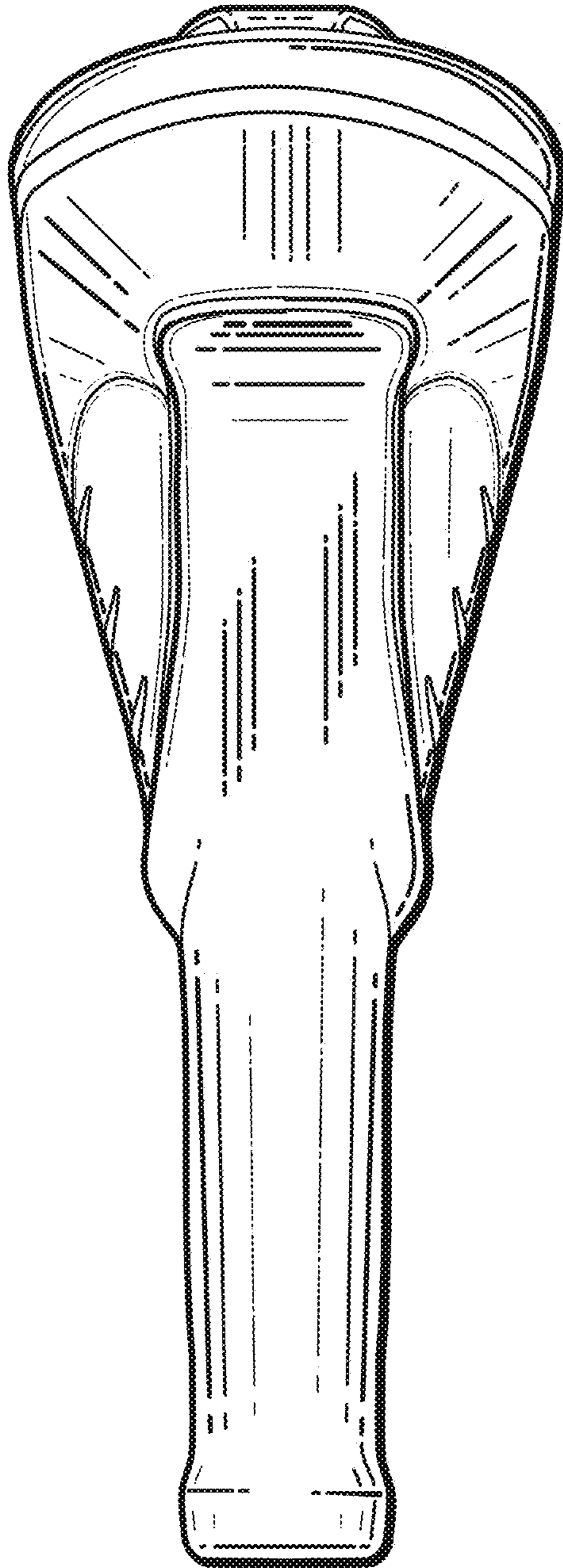

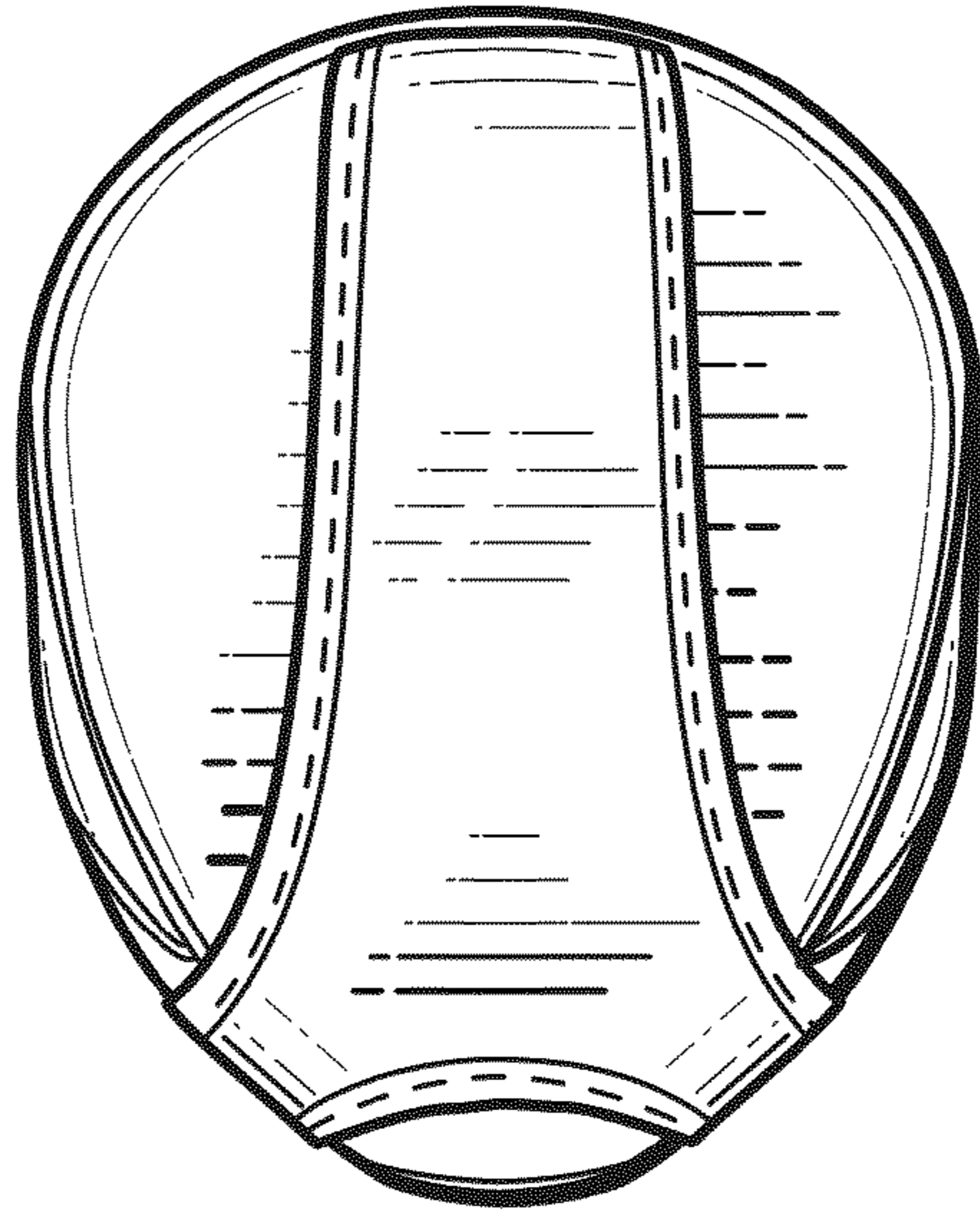

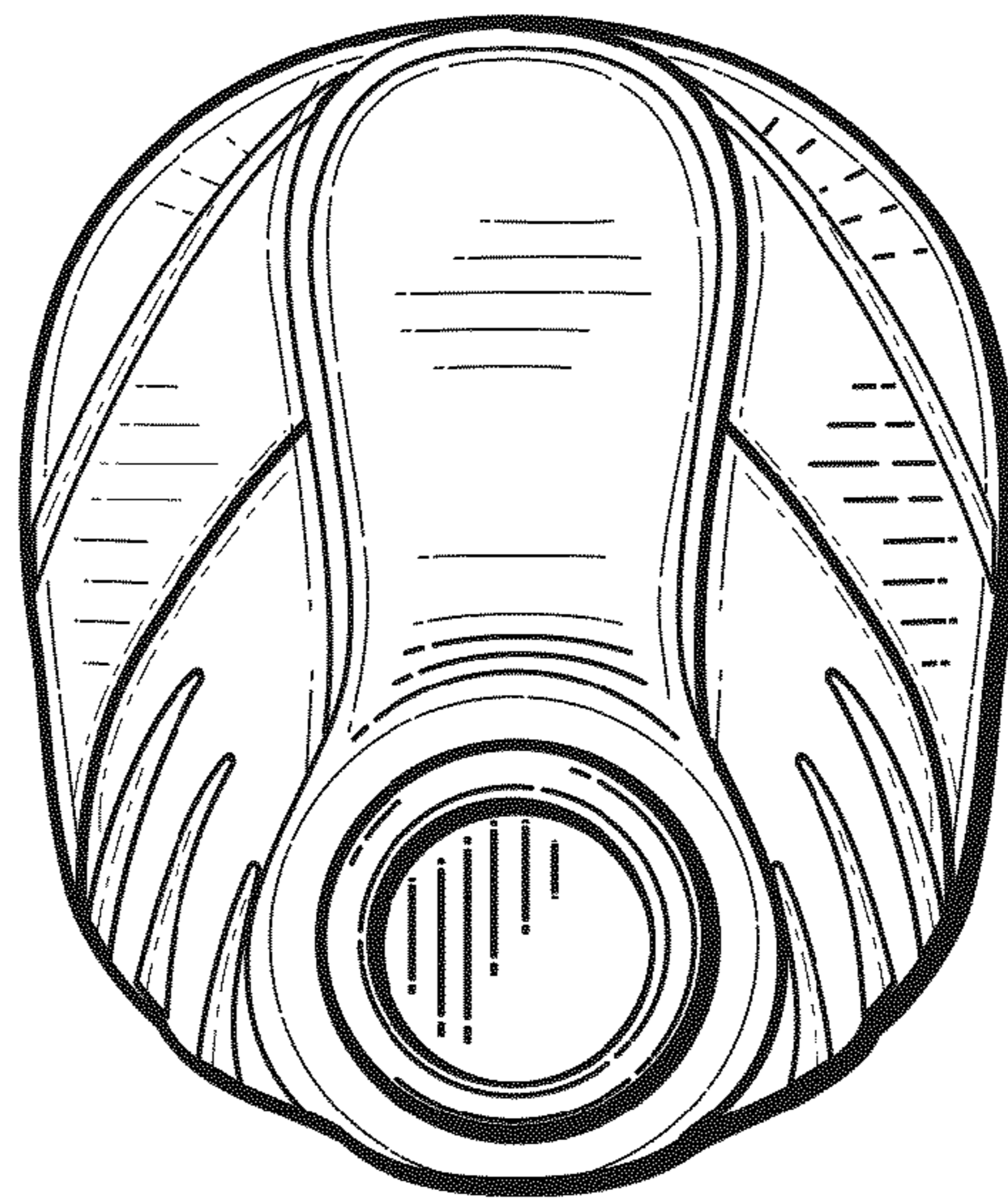

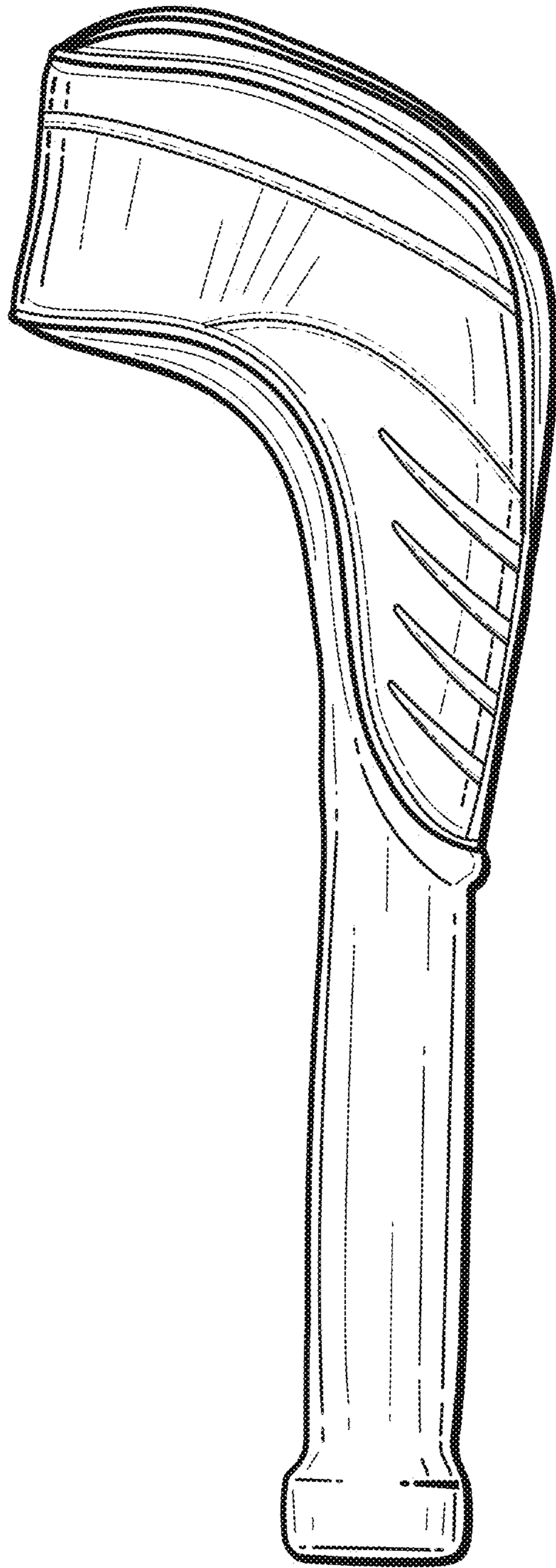

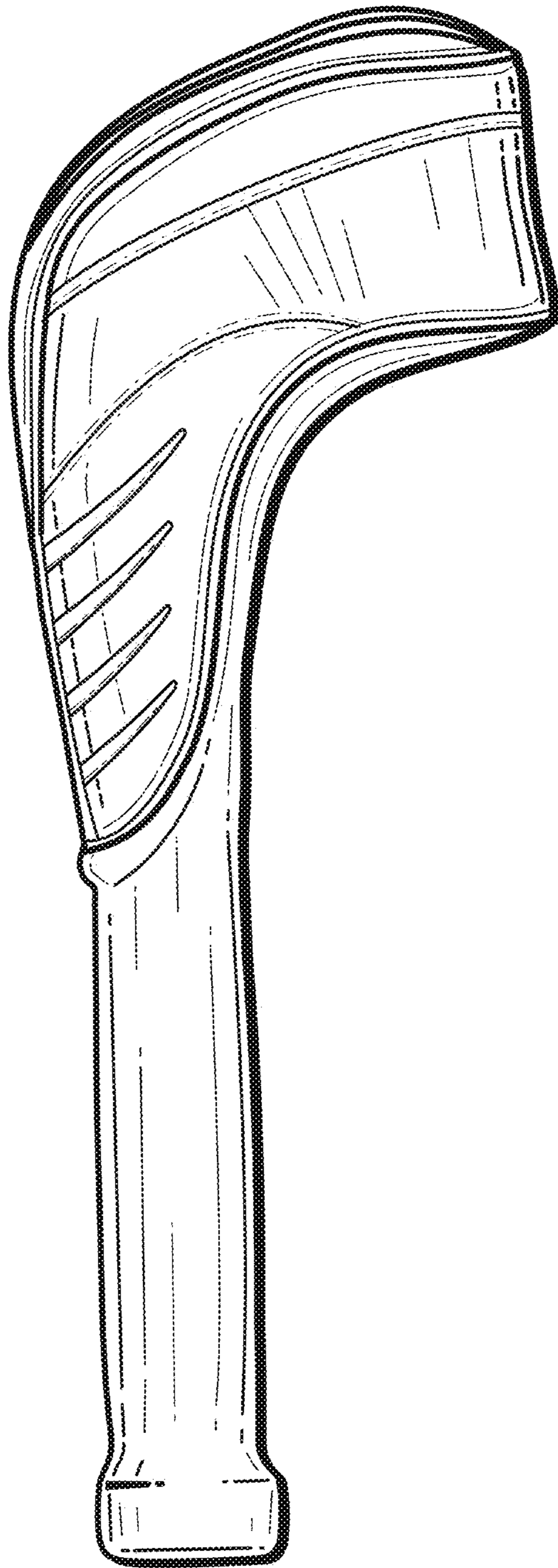
