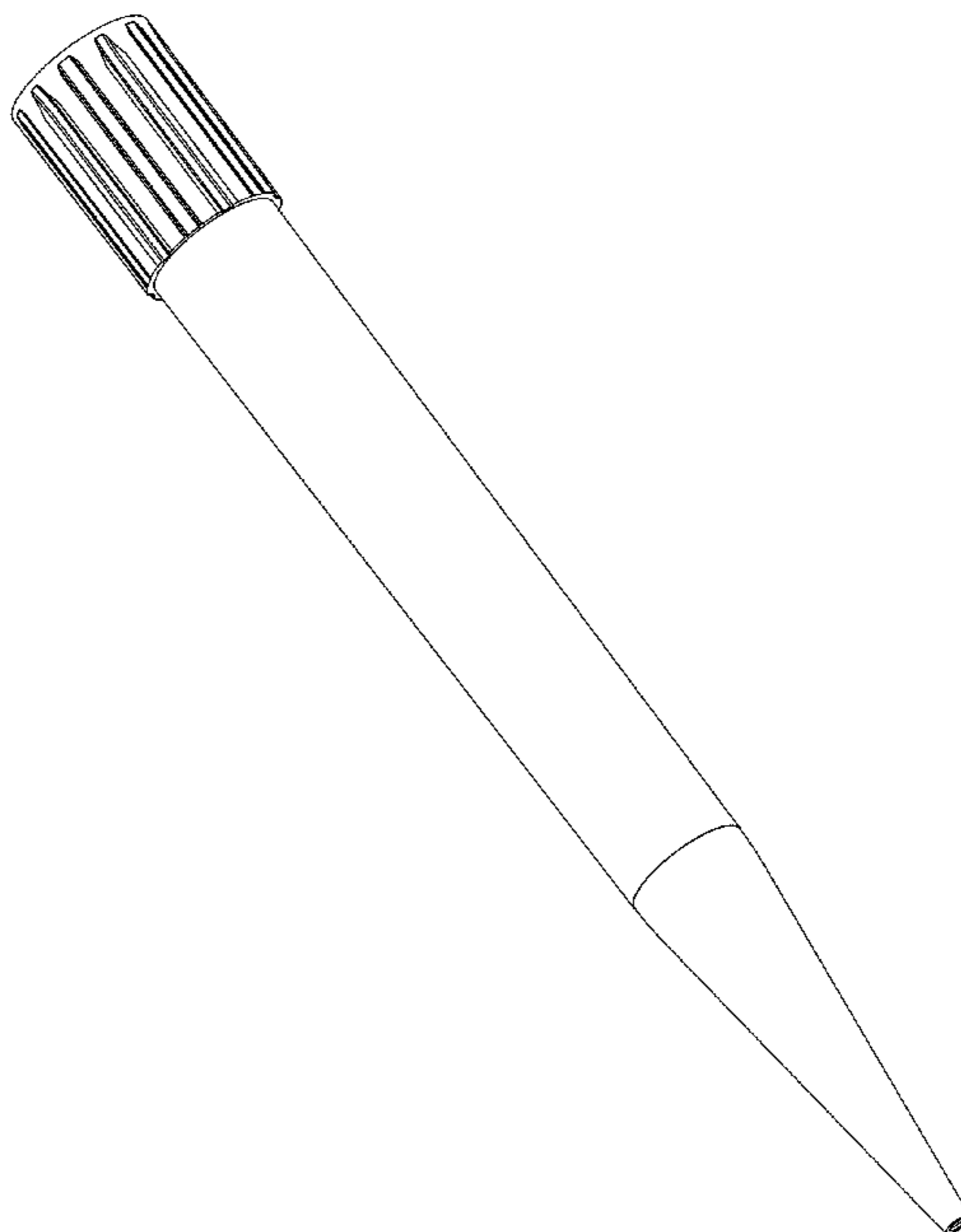
(57) **CLAIM**

The ornamental design for a pipette tip, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an embodiment of a pipette tip; FIG. 2 is a front view thereof; FIG. 3 is a side view thereof; FIG. 4 is a top view thereof; FIG. 5 is a bottom view thereof; FIG. 6 is a side view thereof with a broken line indicating a vertical cross-section; FIG. 7 is a cross-section view taken along the broken line 7-7 shown in FIG. 6; FIG. 8 is an enlarged cross-section view of the pipette tip region indicated by a broken line circle in FIG. 7; FIG. 9 is a side view thereof with broken lines indicating horizontal cross-sections; FIG. 10 is a cross-section view taken along broken line 10-10; FIG. 11 is a cross-section view taken along broken line 11-11; and, FIG. 12 is a cross-section view taken along broken line 12-12. The broken lines are included for the purposes of illustrating unclaimed portions of the pipette tip and form no part of the claimed design.

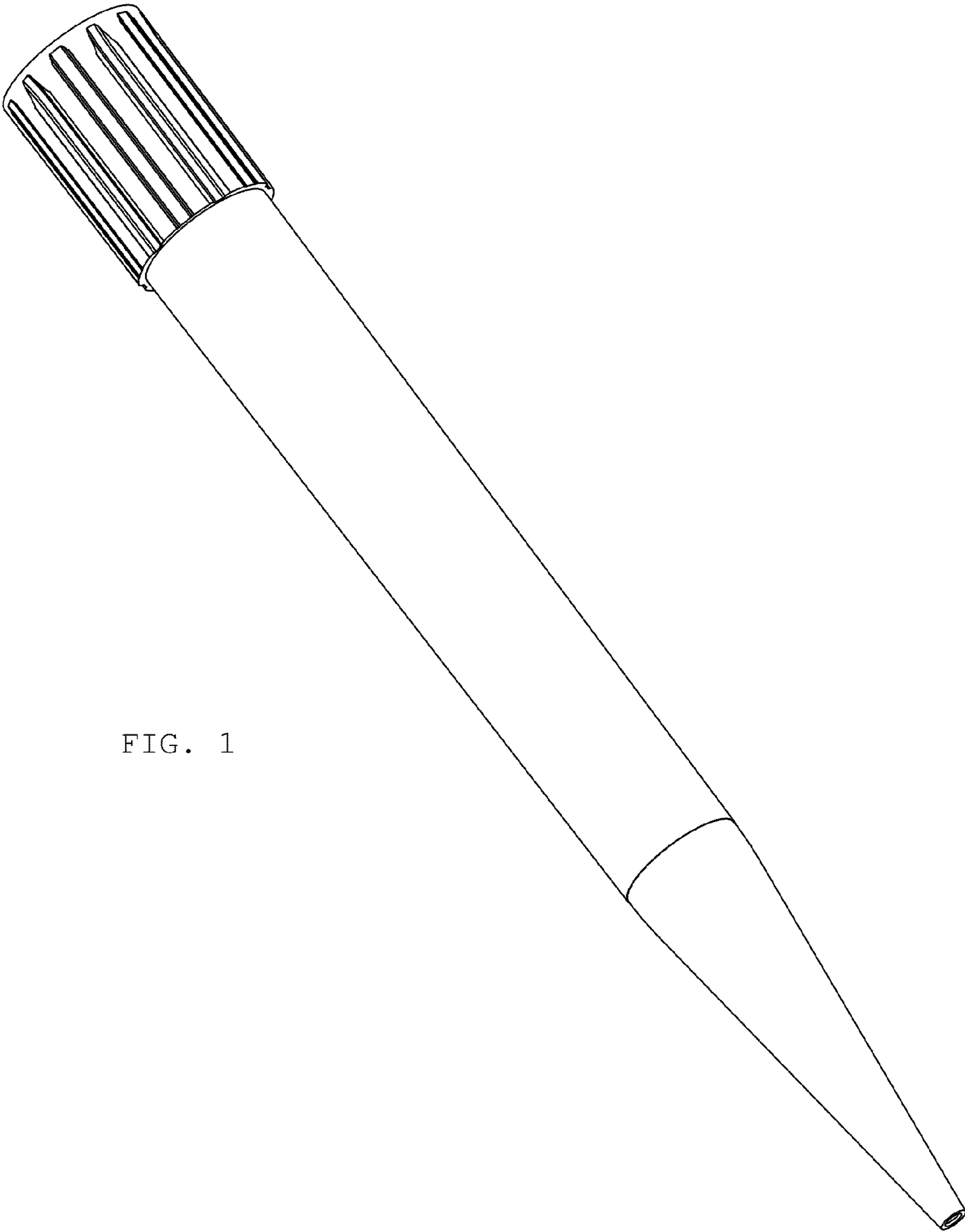

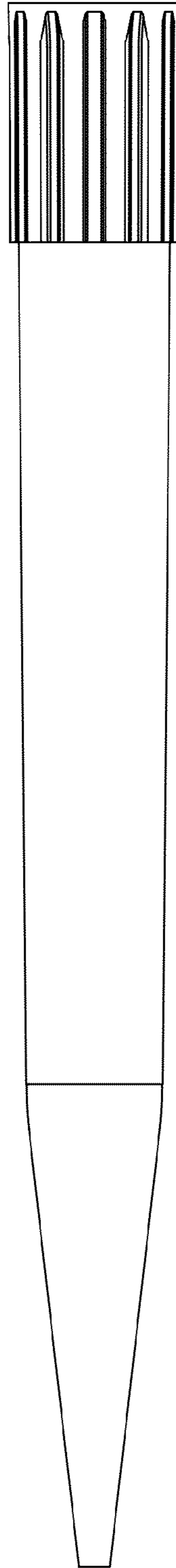

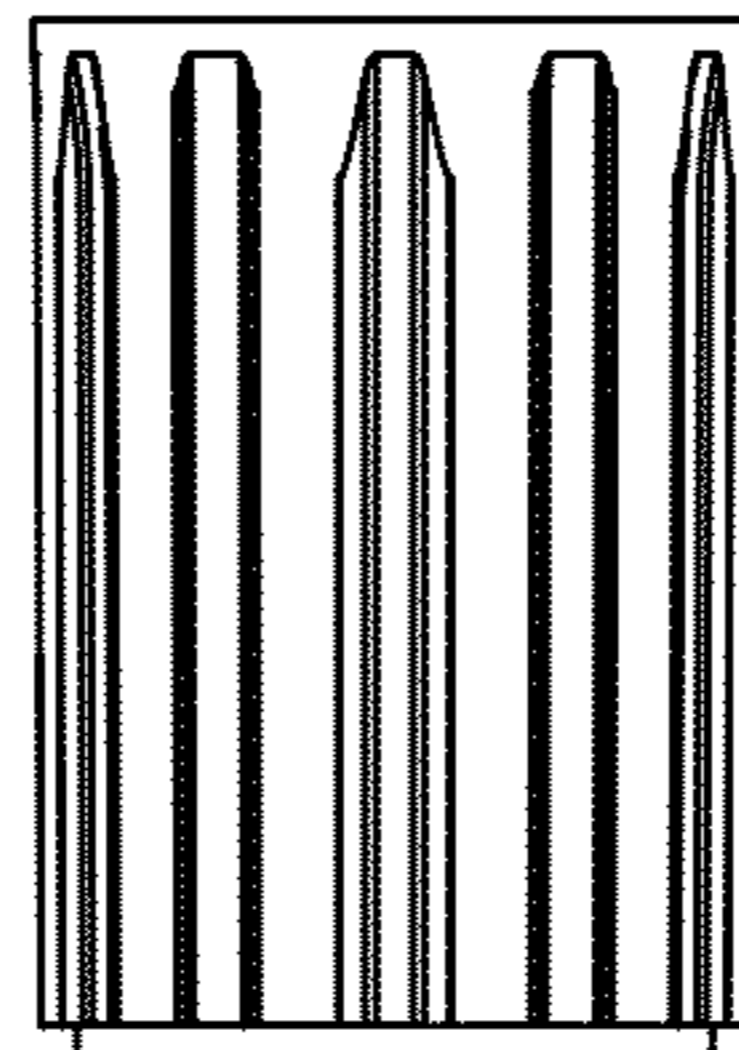
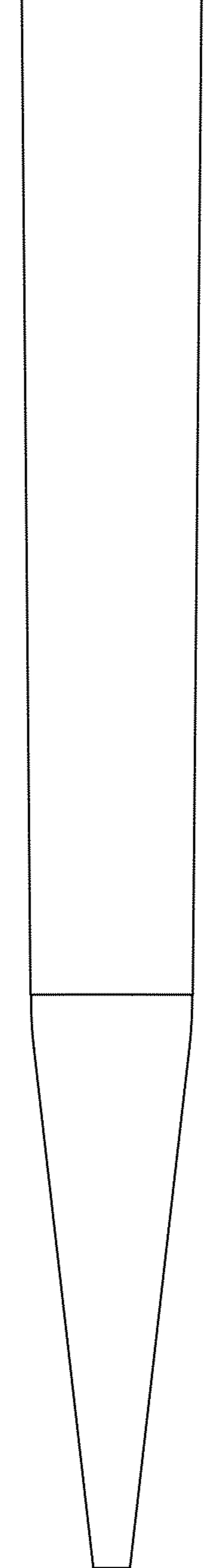

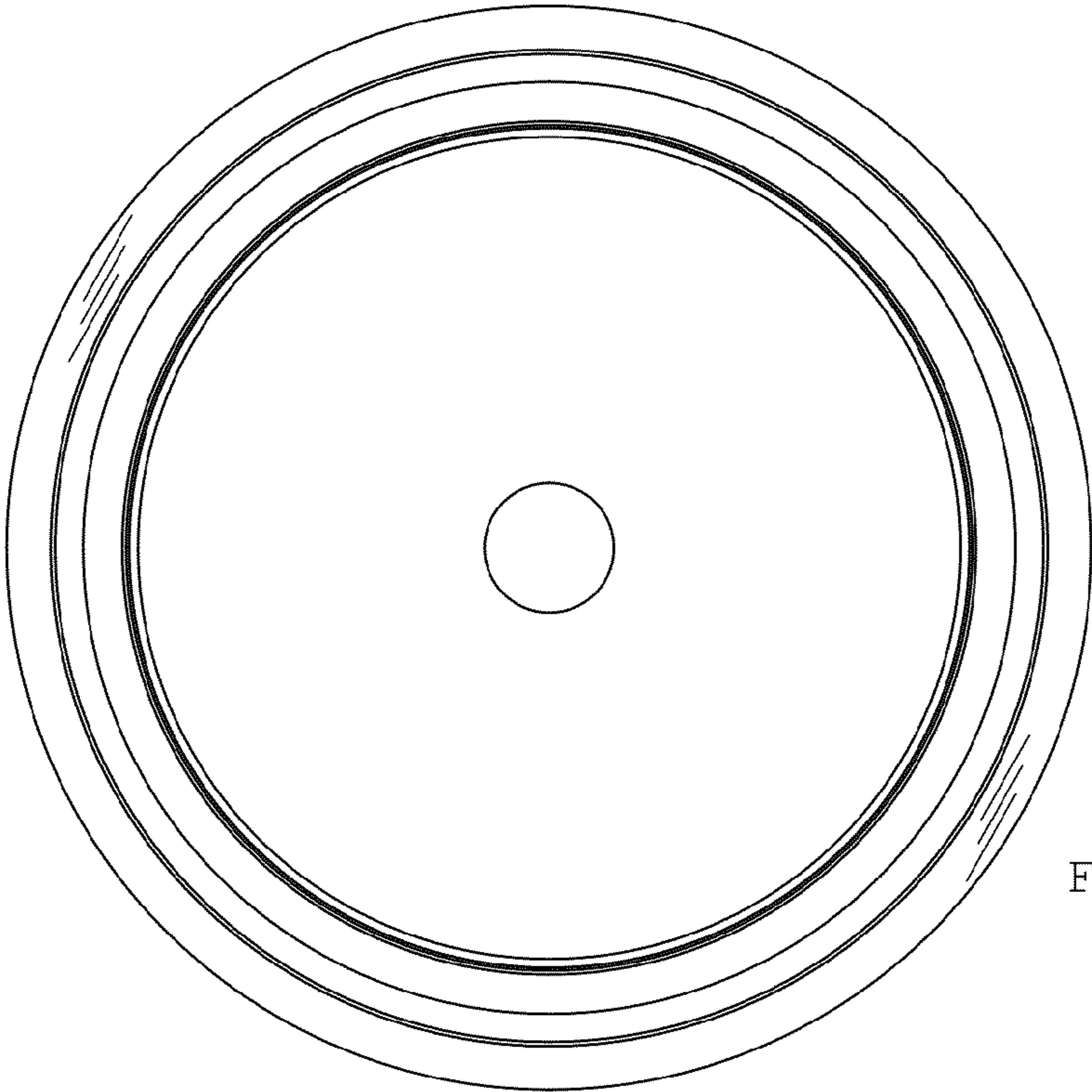

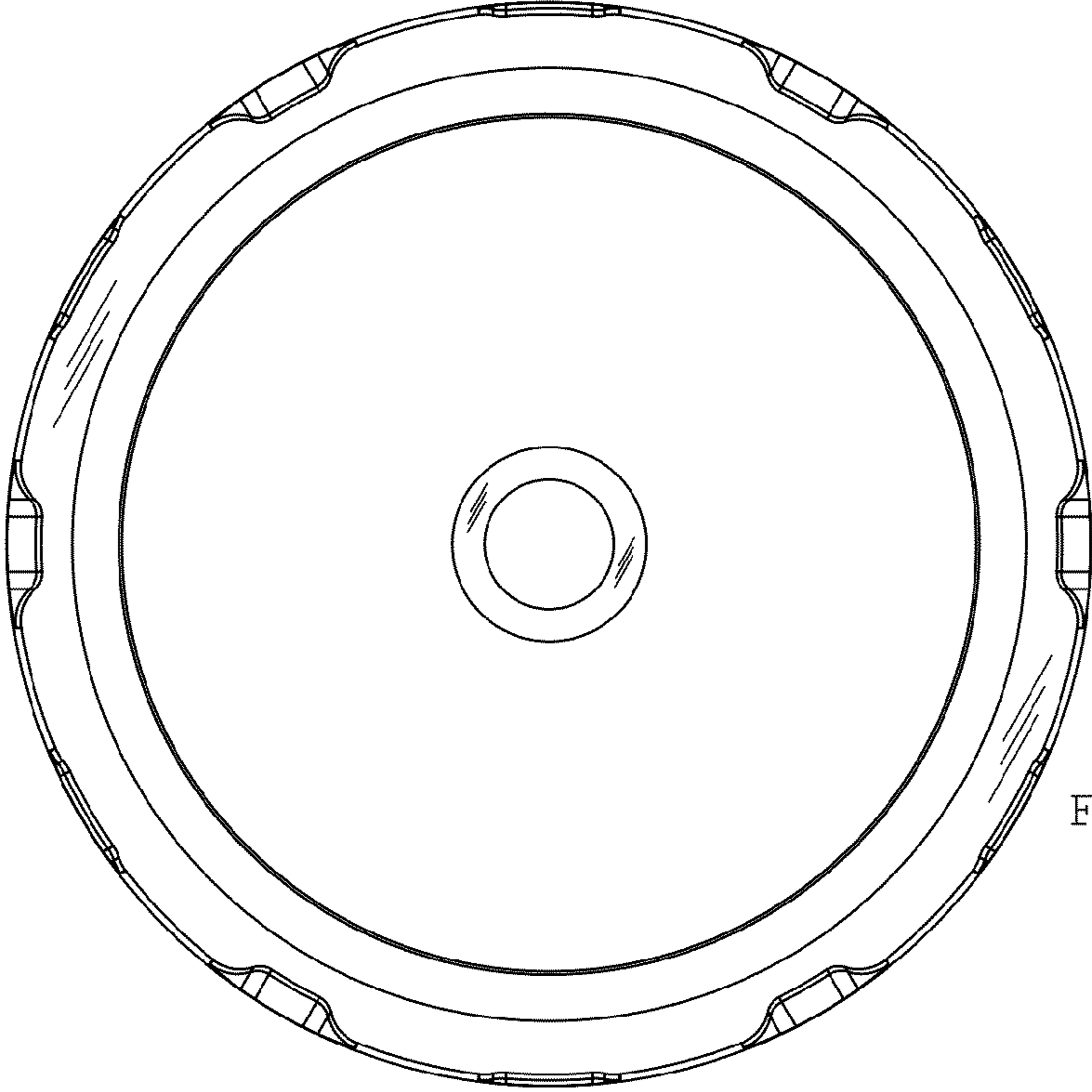
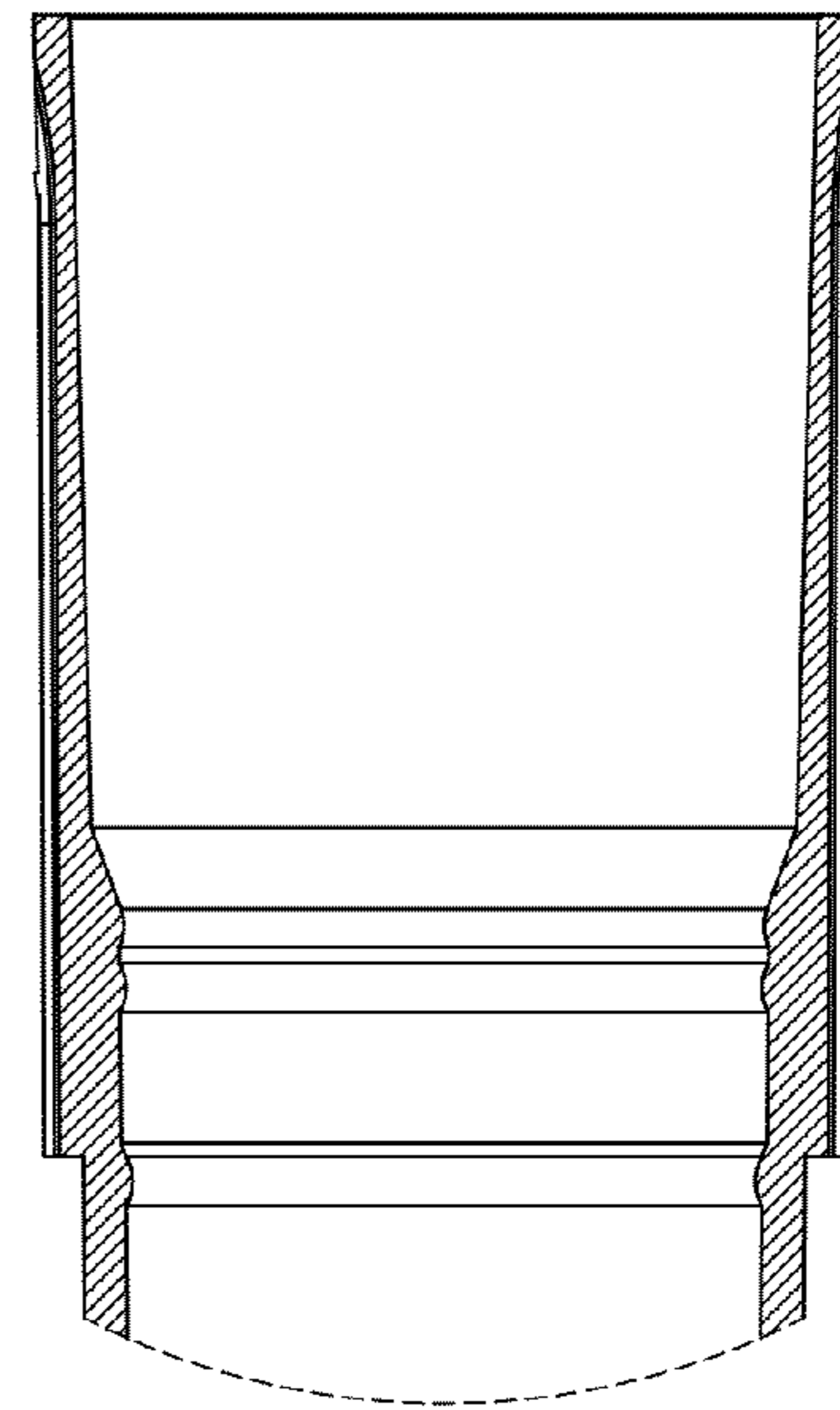
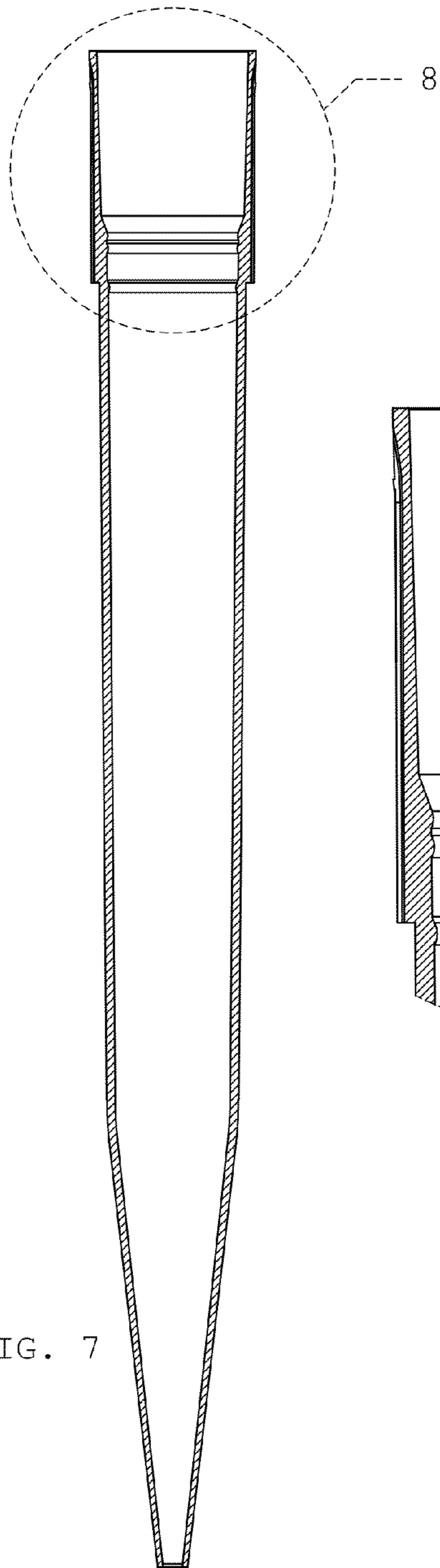
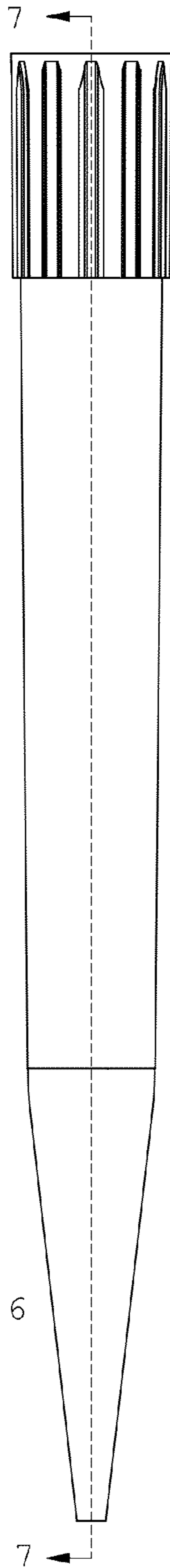

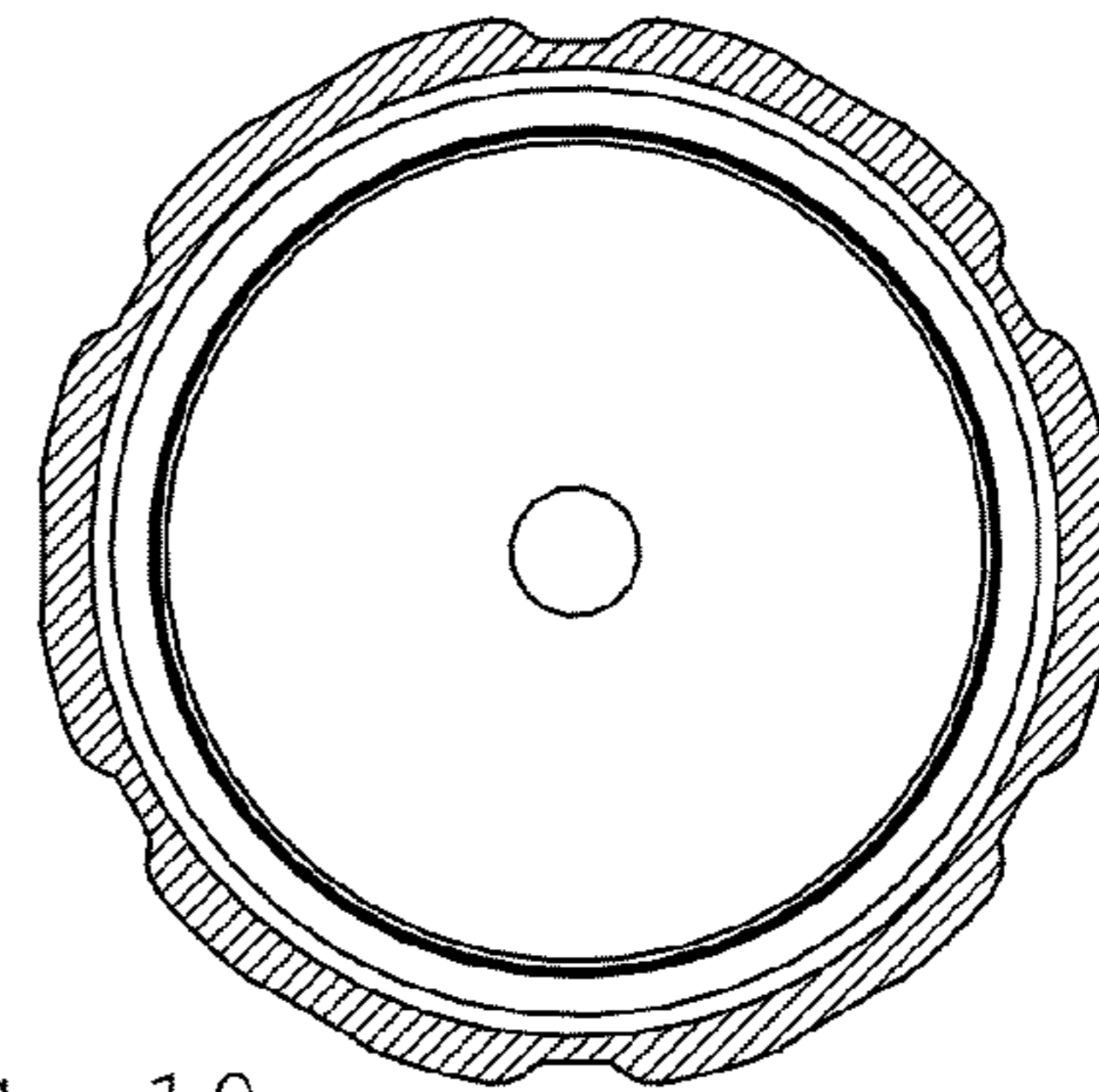
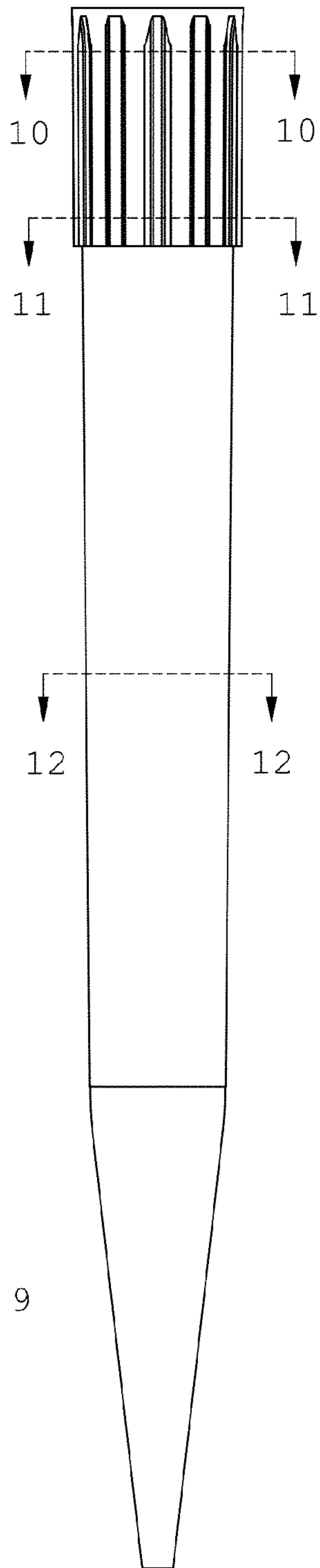

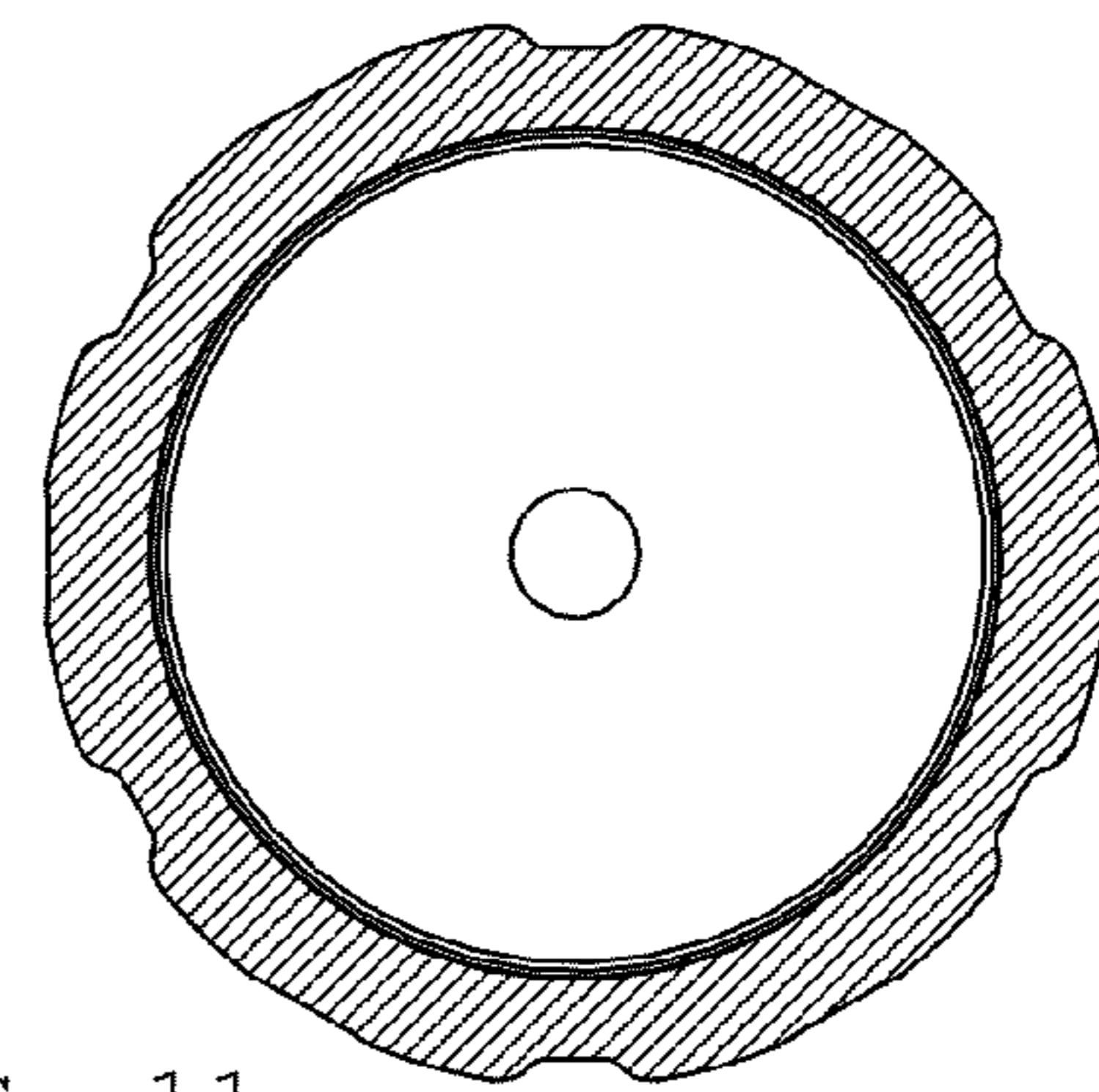

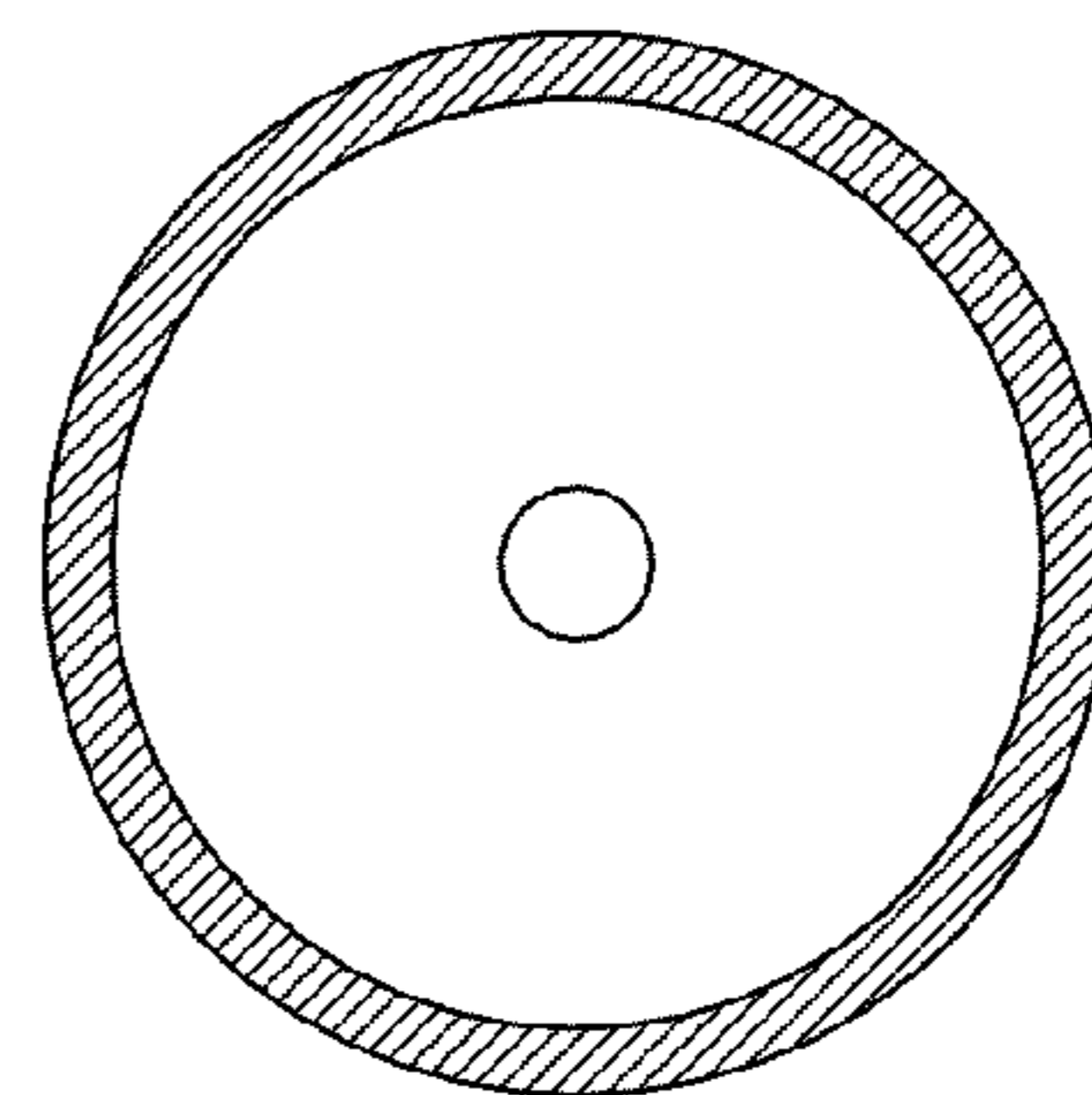
