DESCRIPTION

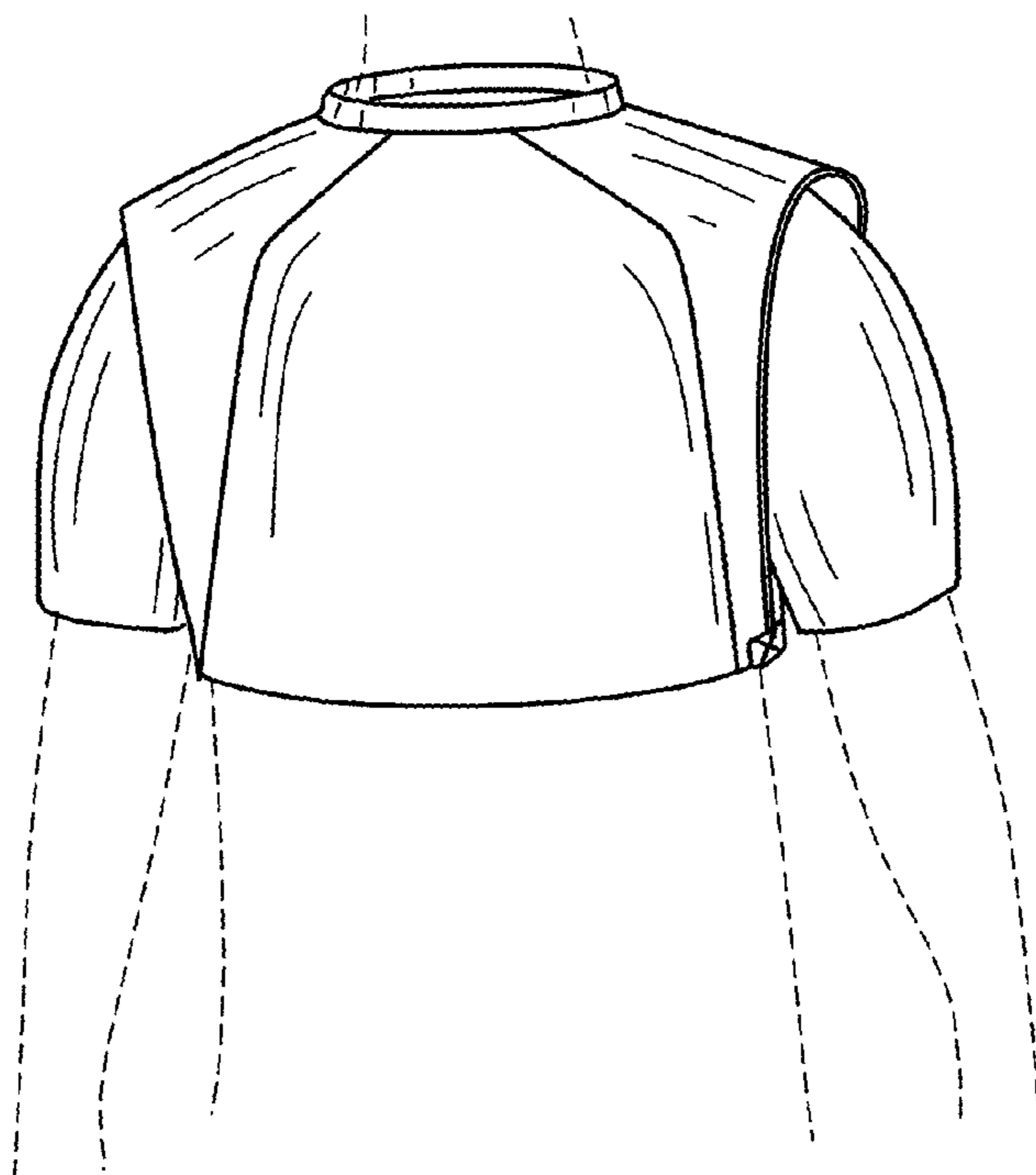
FIG. 1 is a perspective view of a fencing jersey, showing my new design;

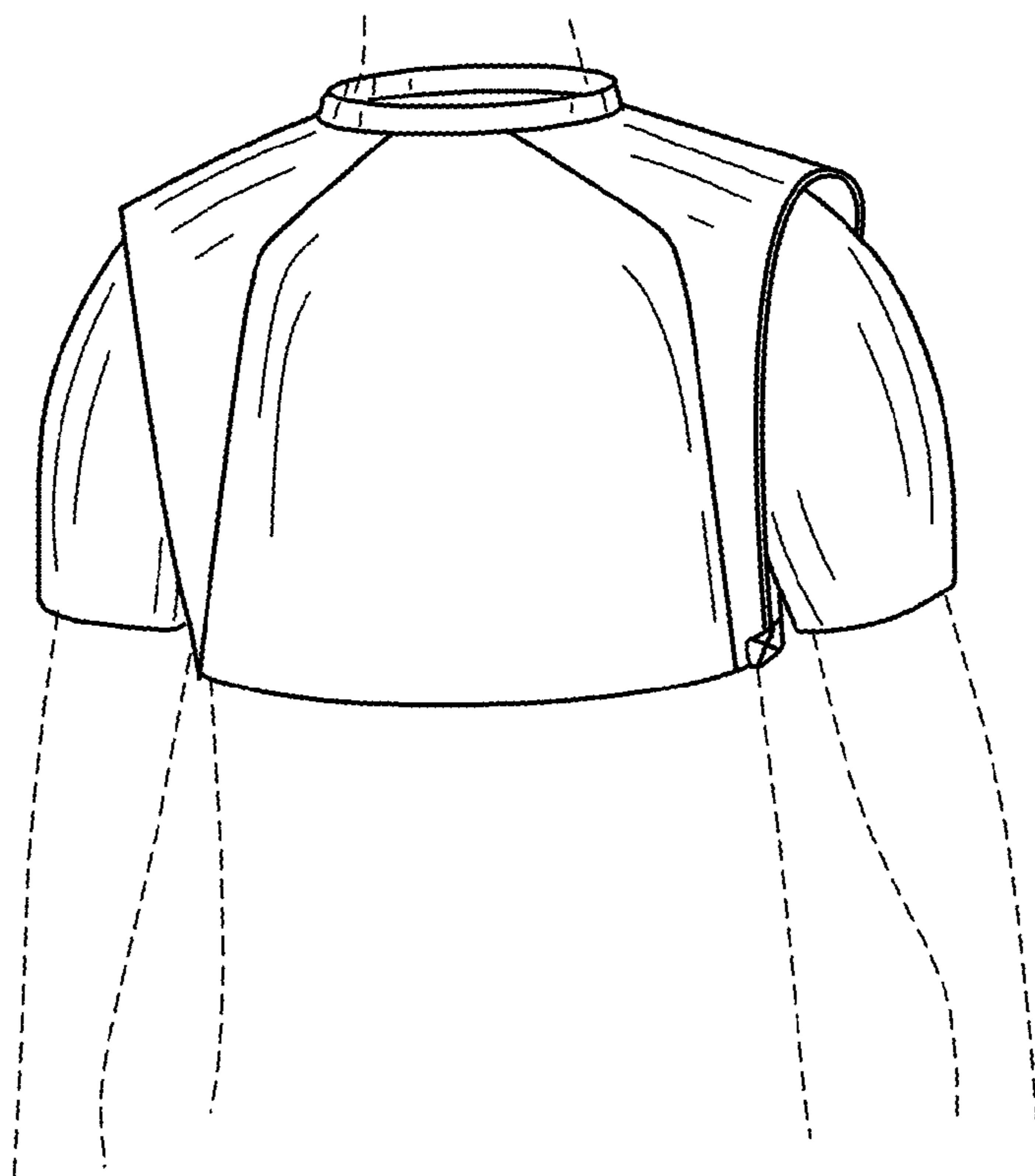

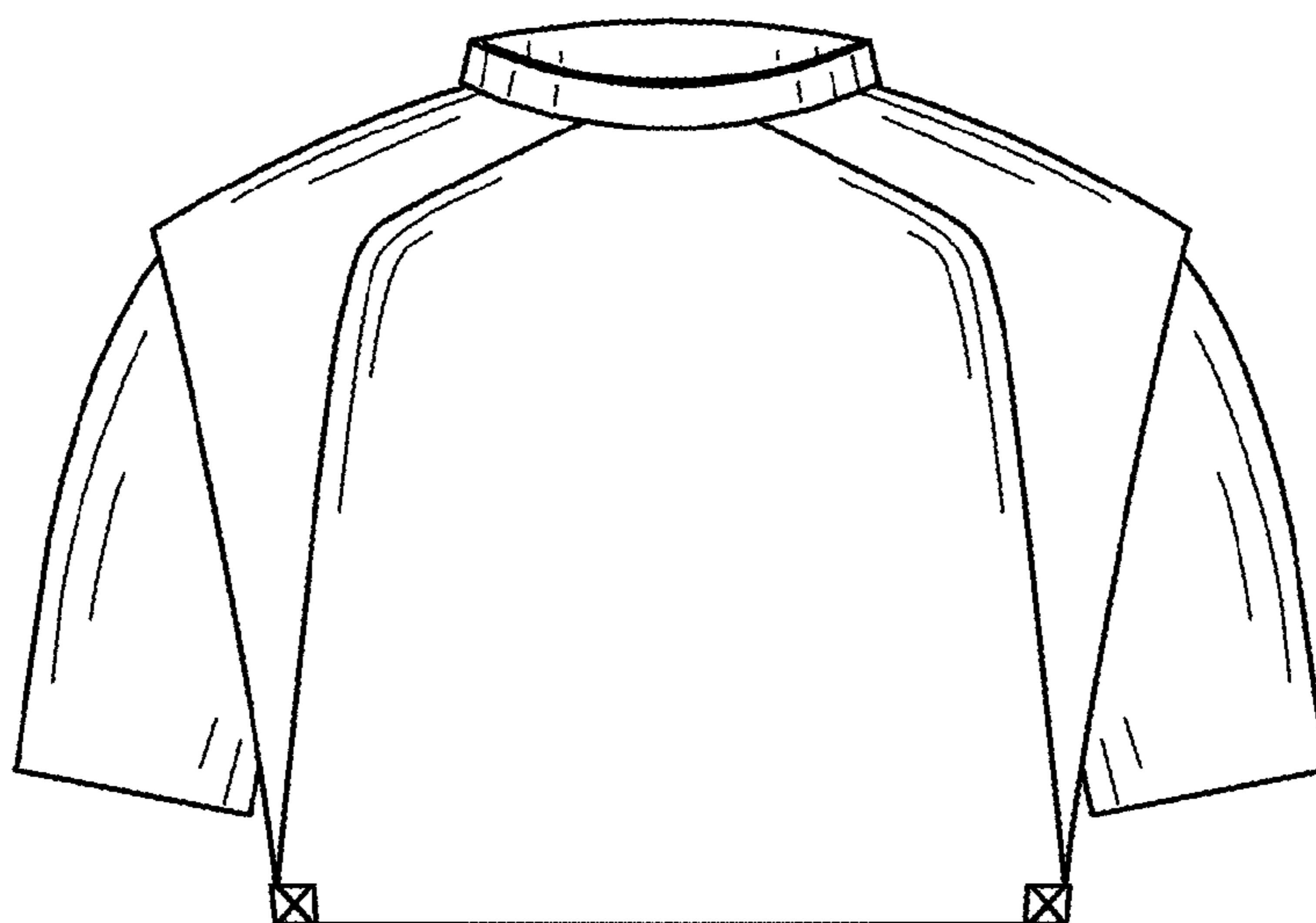

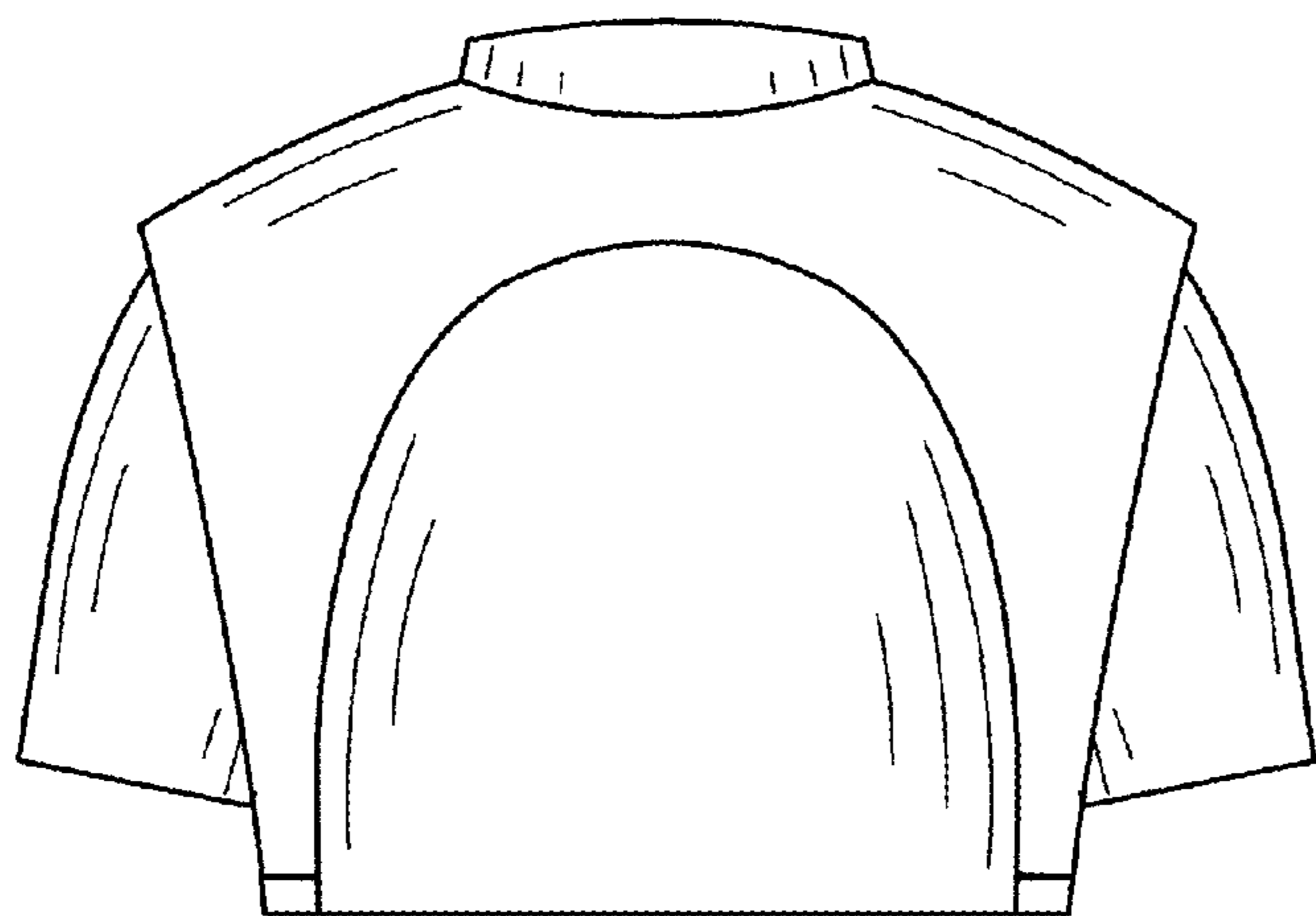

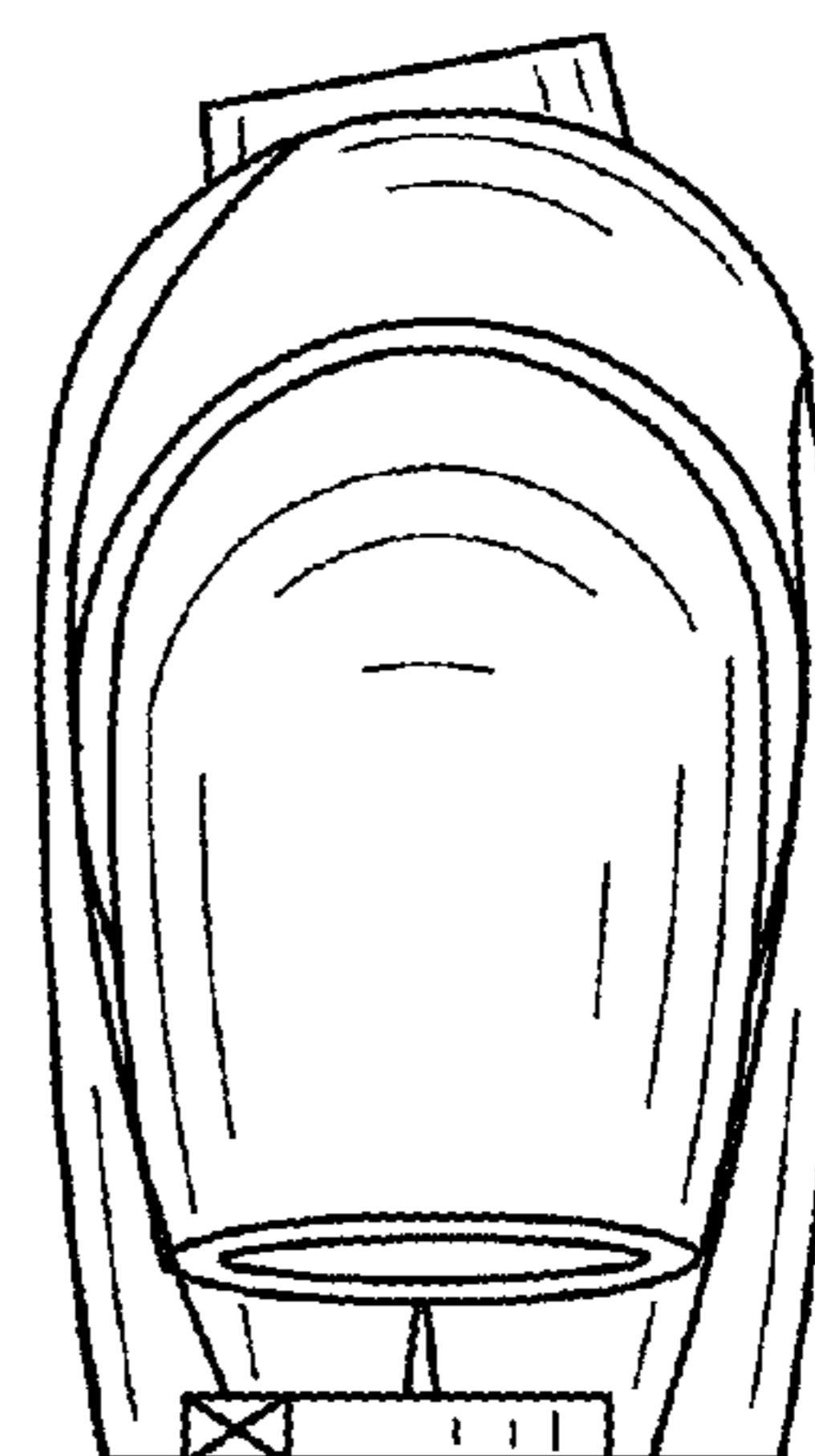

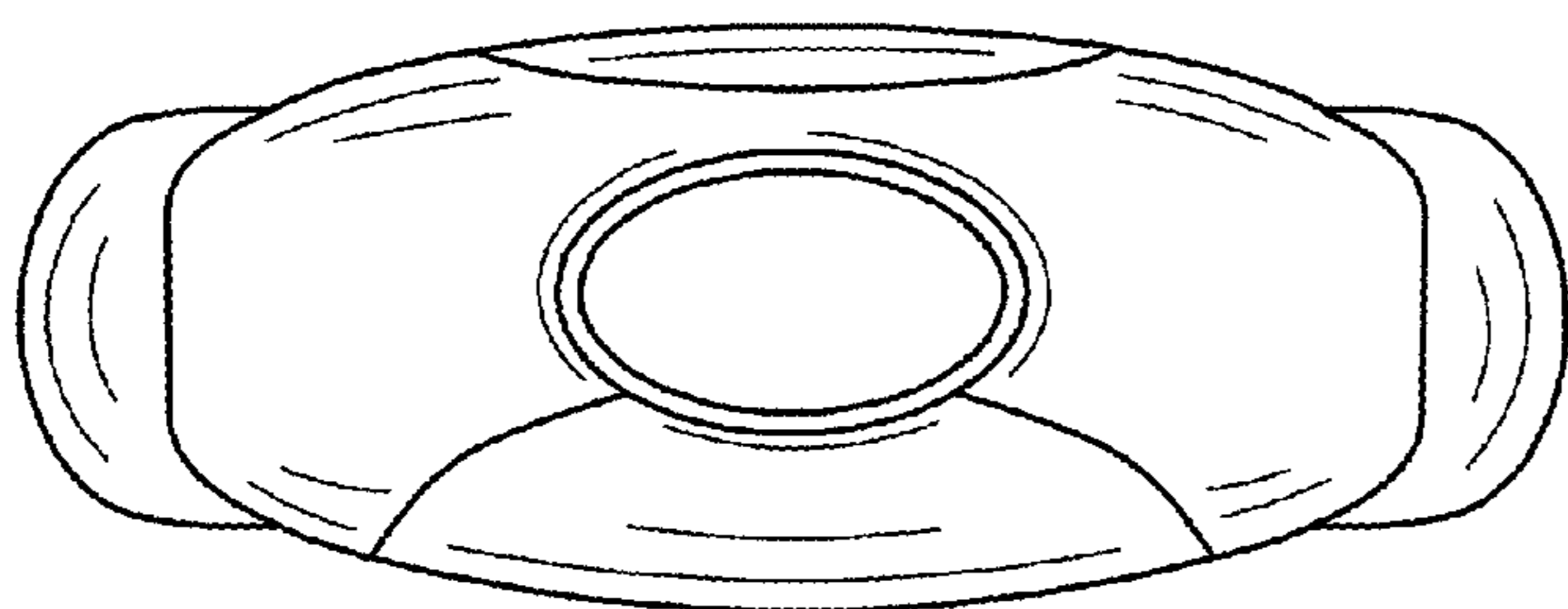

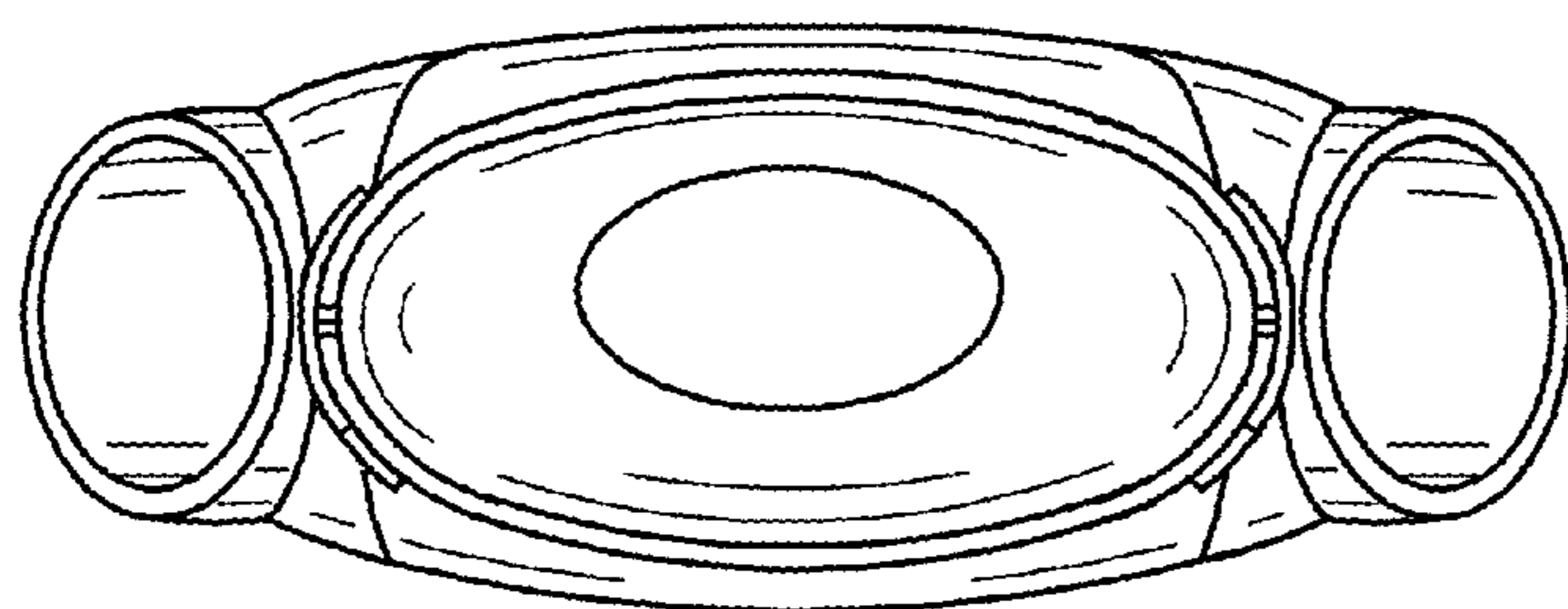
