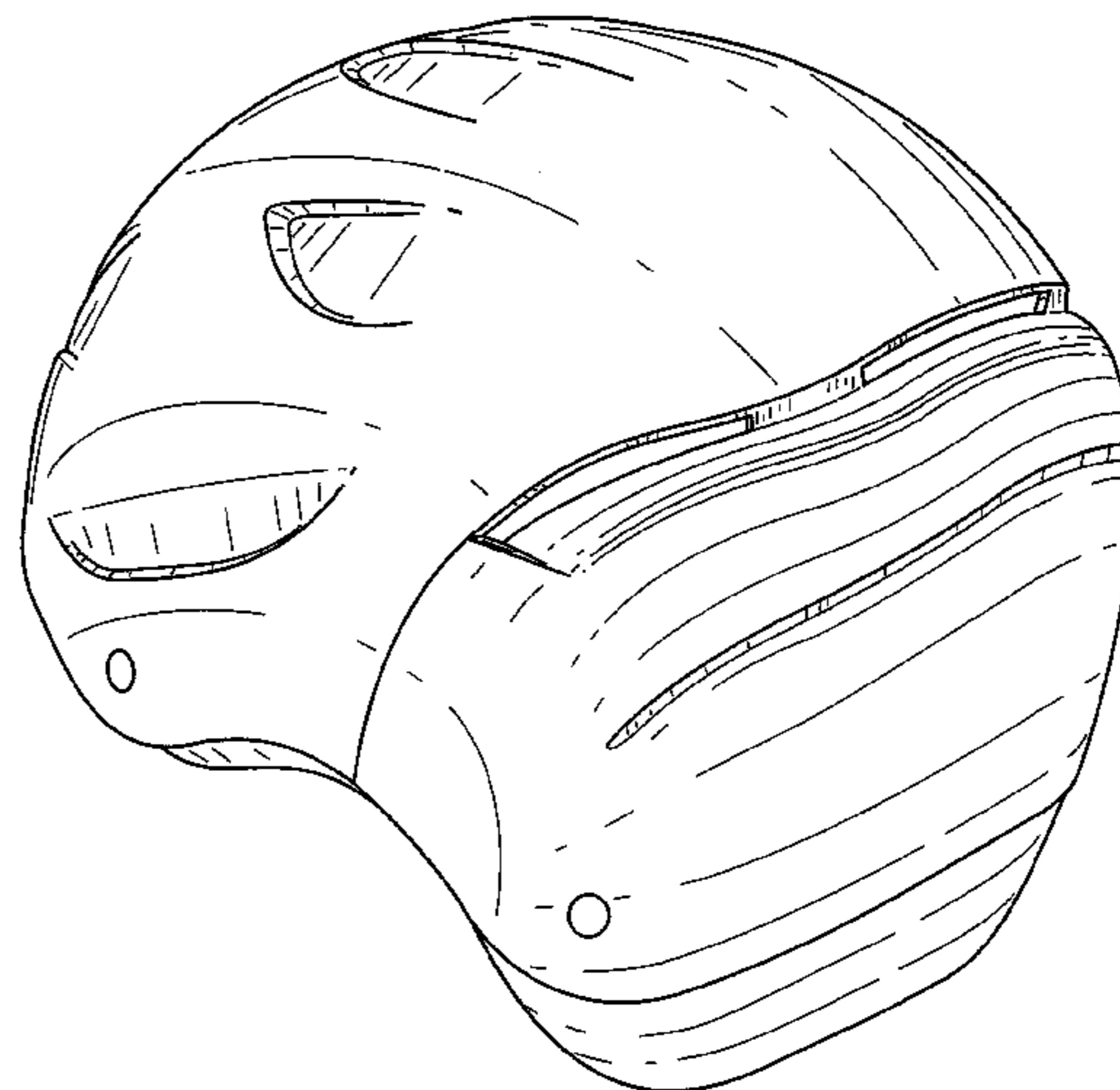
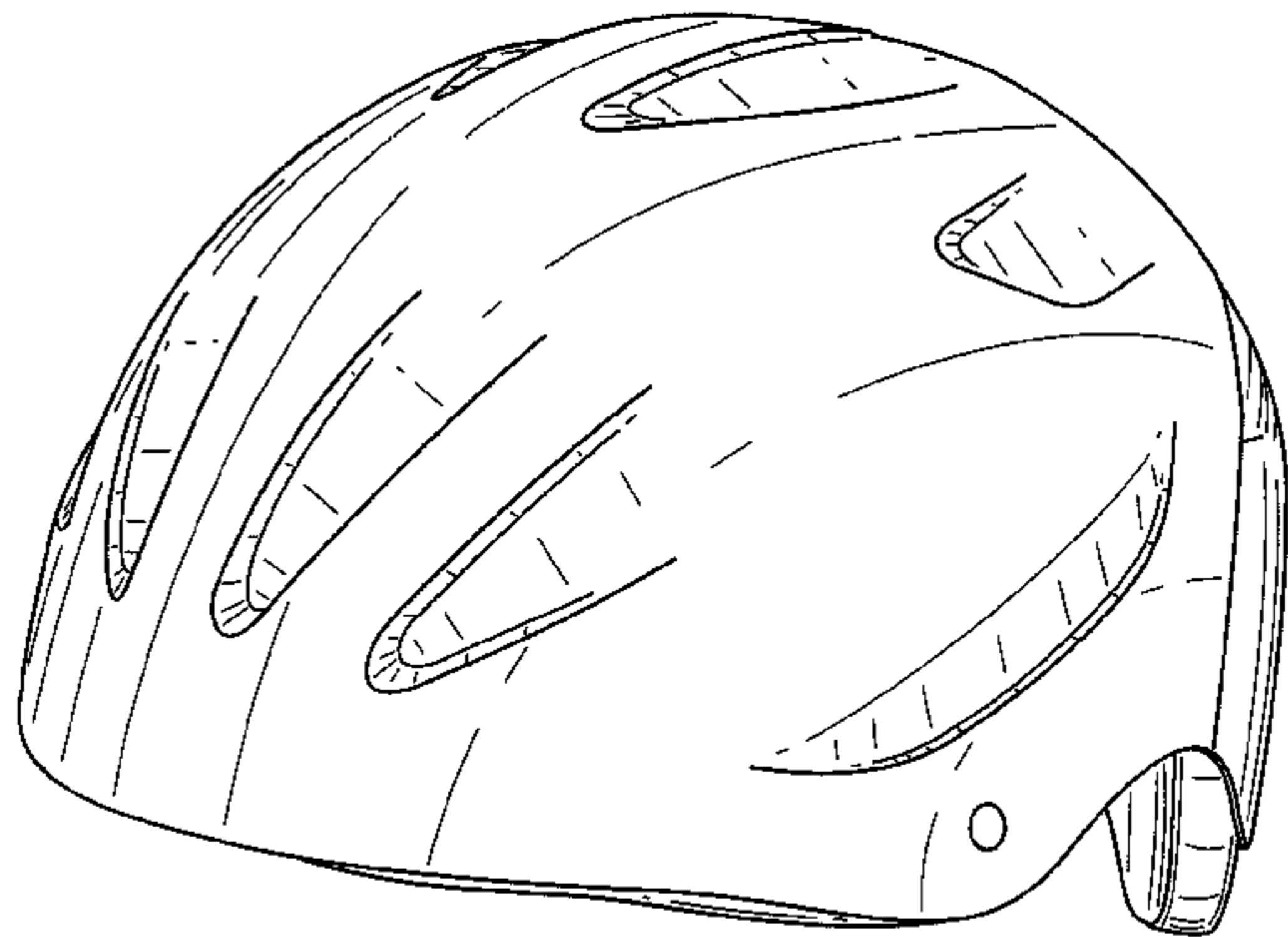
(57) **CLAIM**

The ornamental design for a safety helmet, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a safety helmet showing my new design;  
FIG. 2 is a rear elevation view thereof;

FIG. 4 is a right side view thereof;  
FIG. 5 is a top plan view thereof;  
FIG. 6 is a bottom plan view thereof;

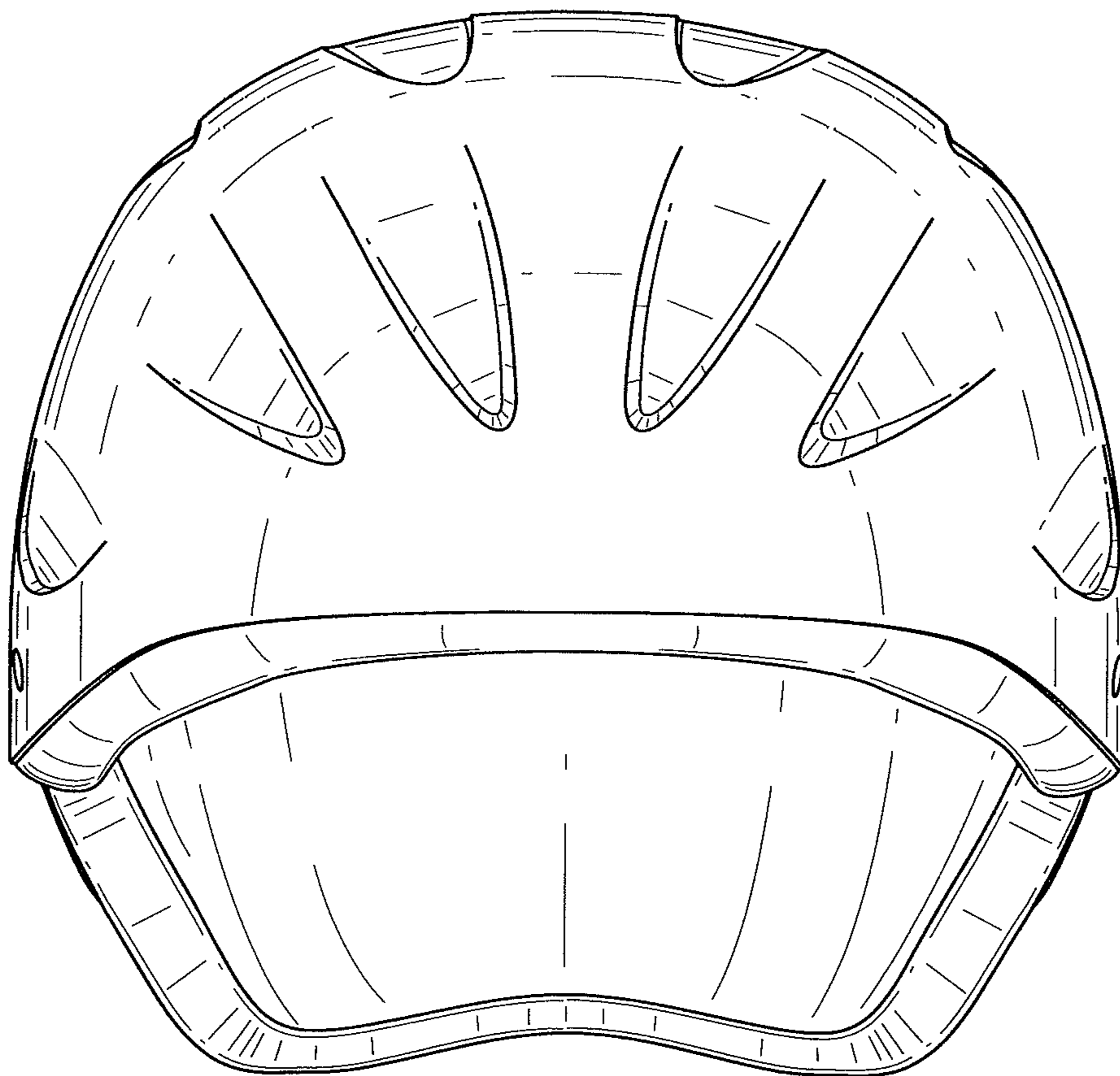

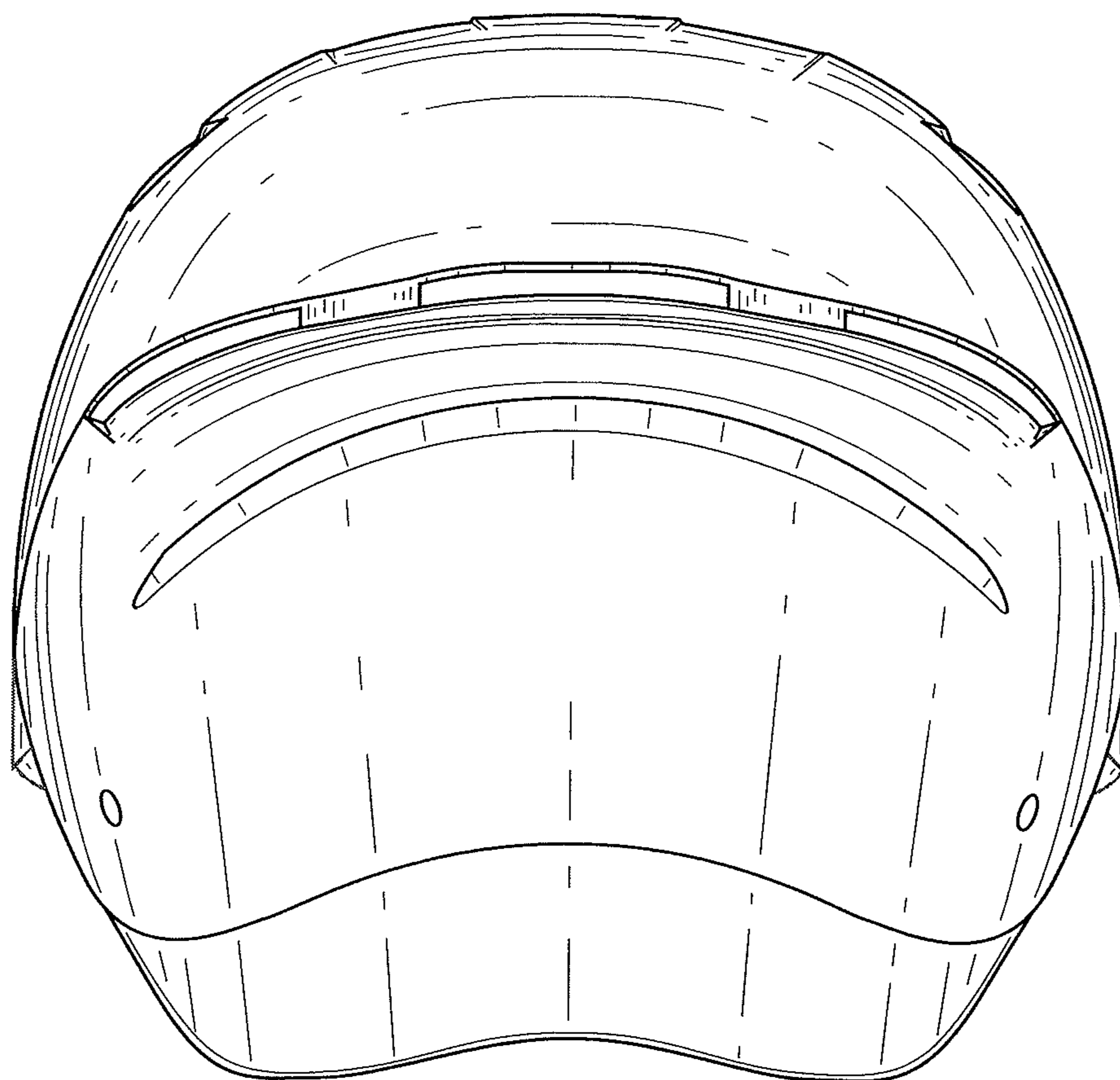

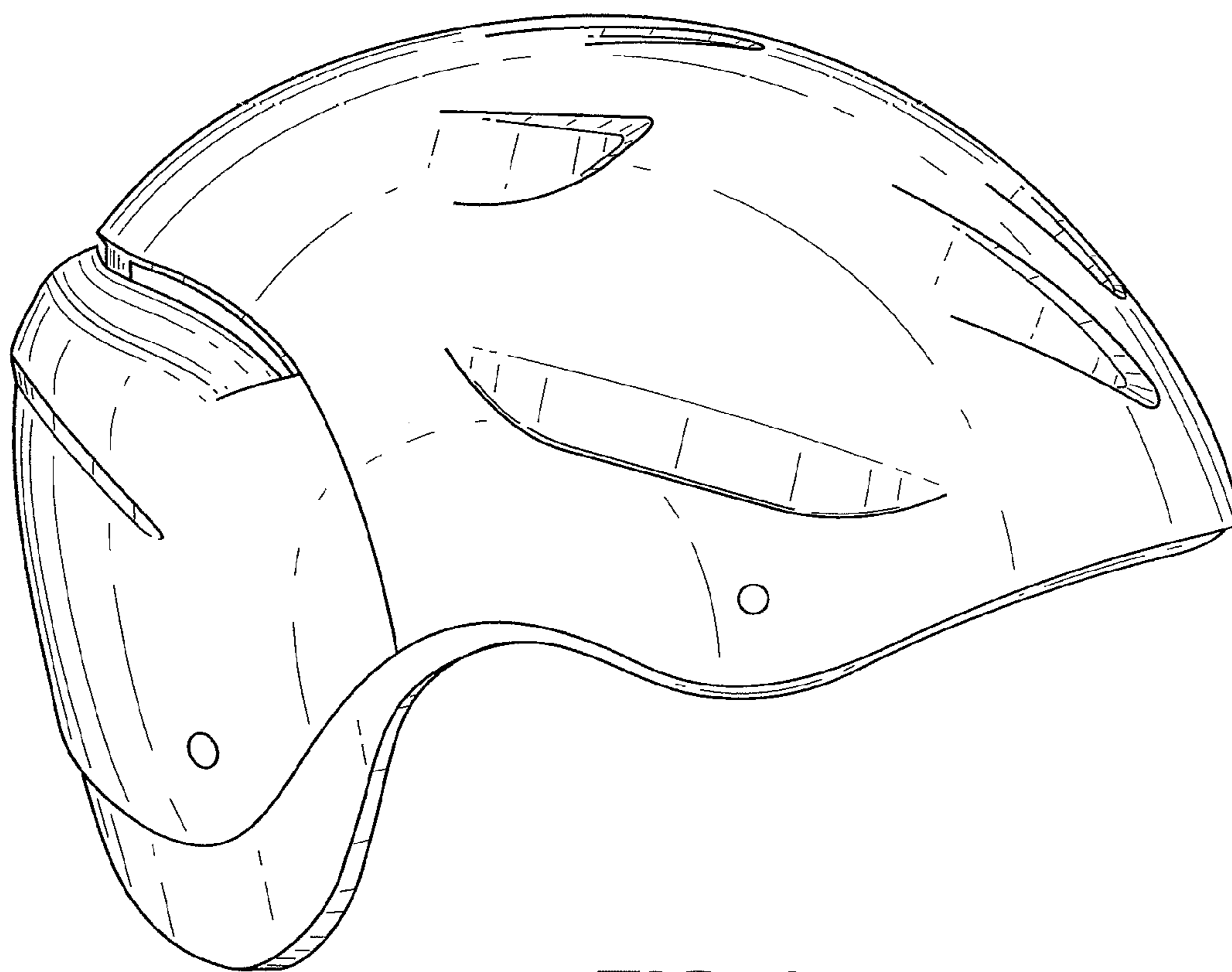

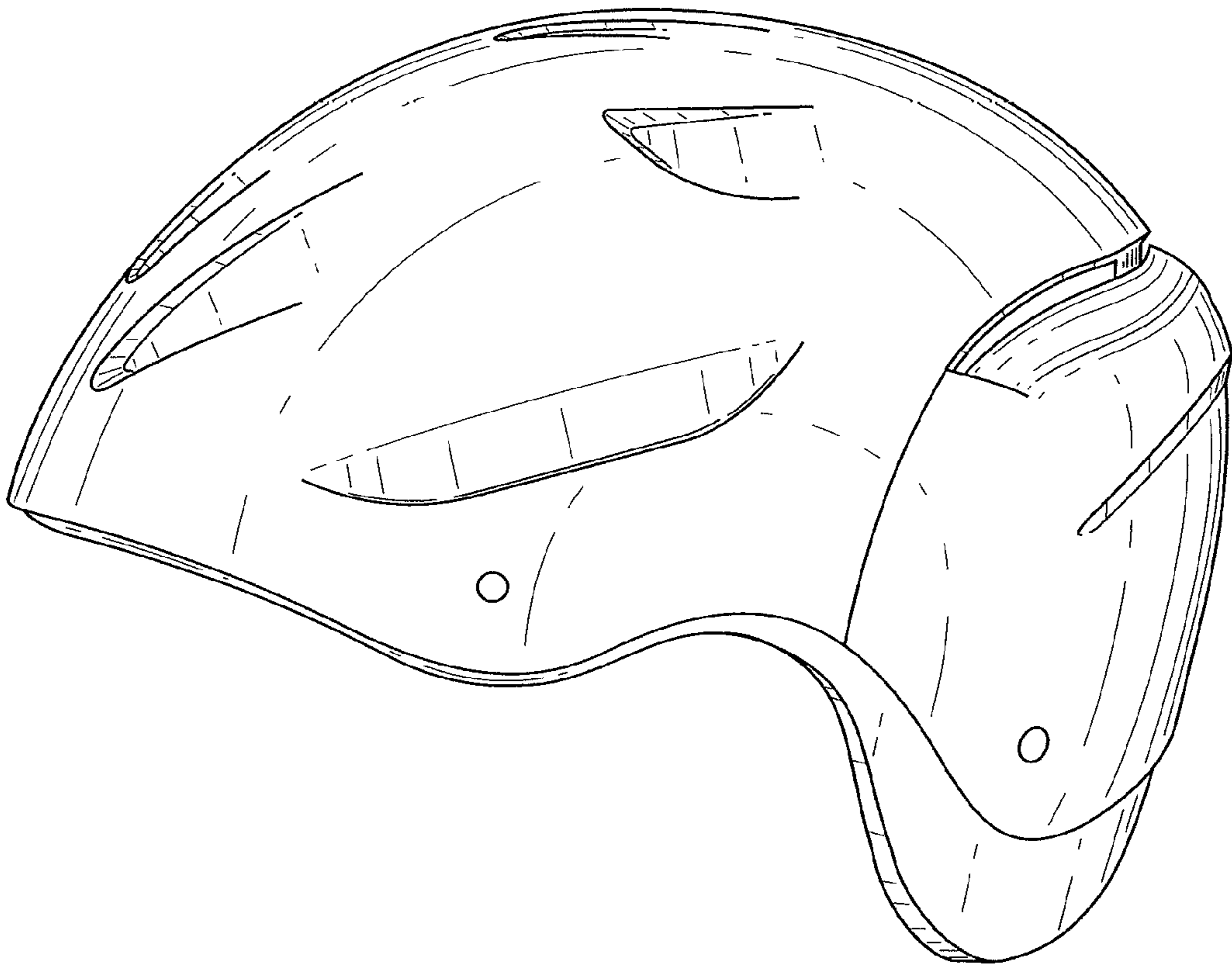

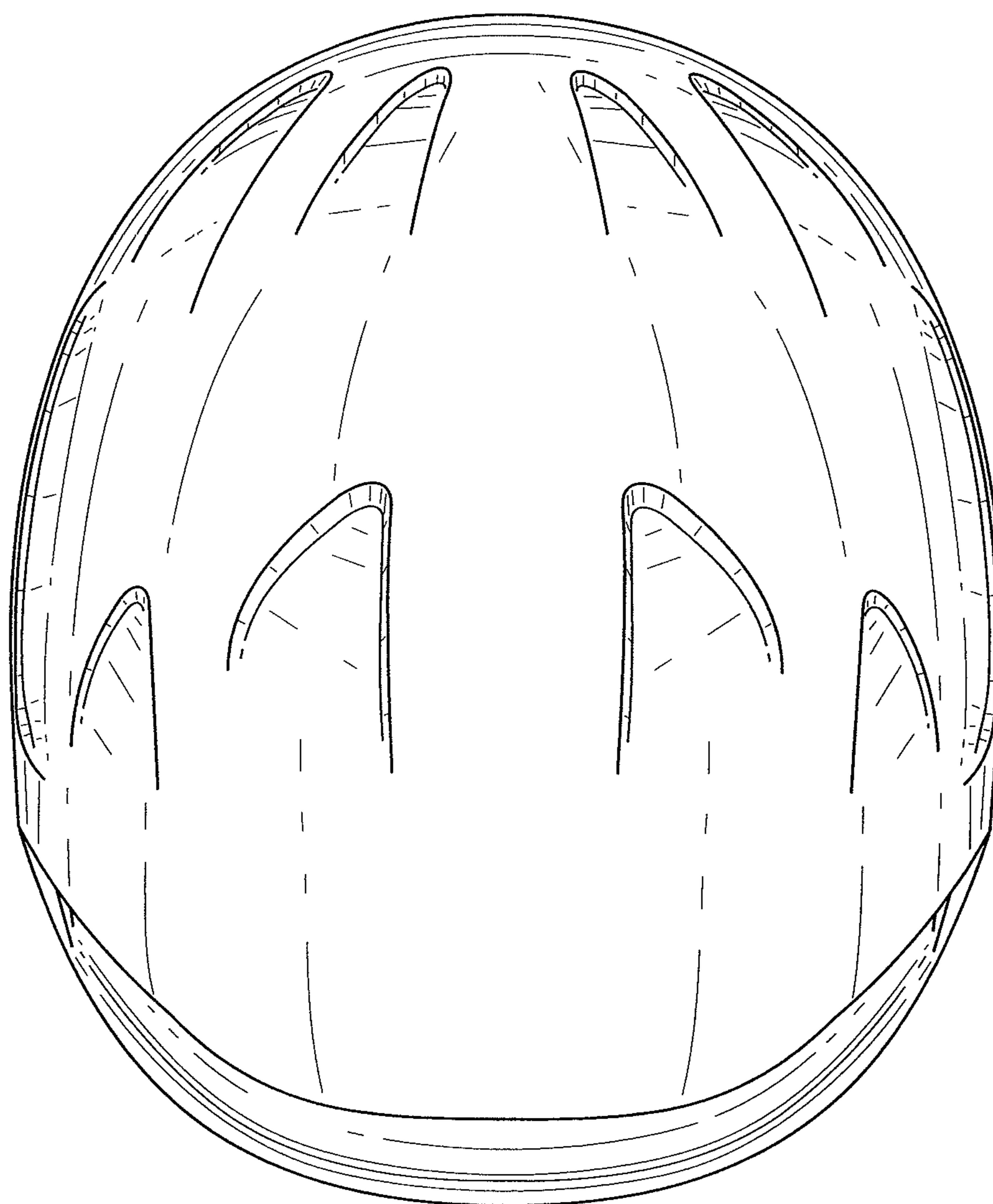

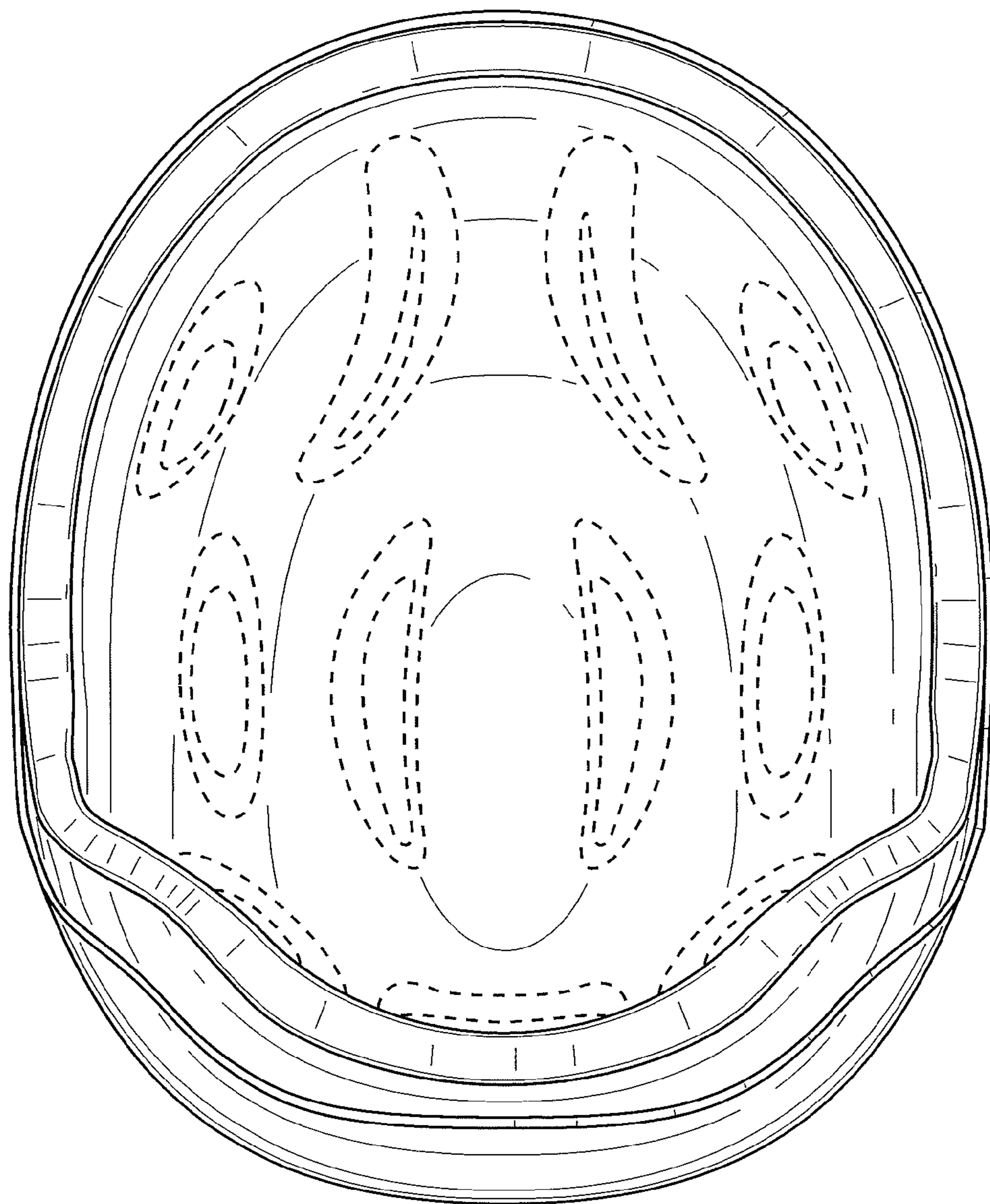

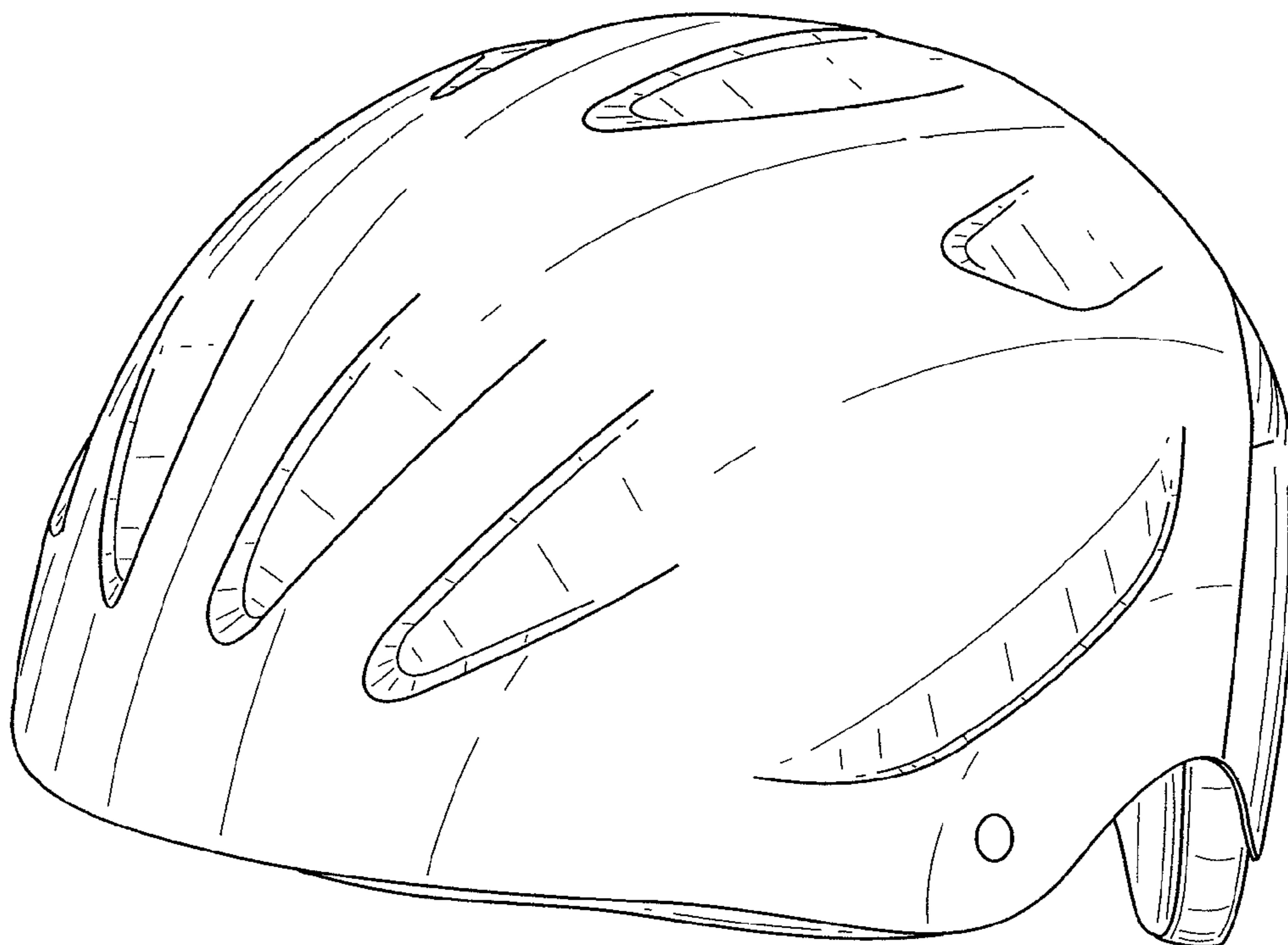

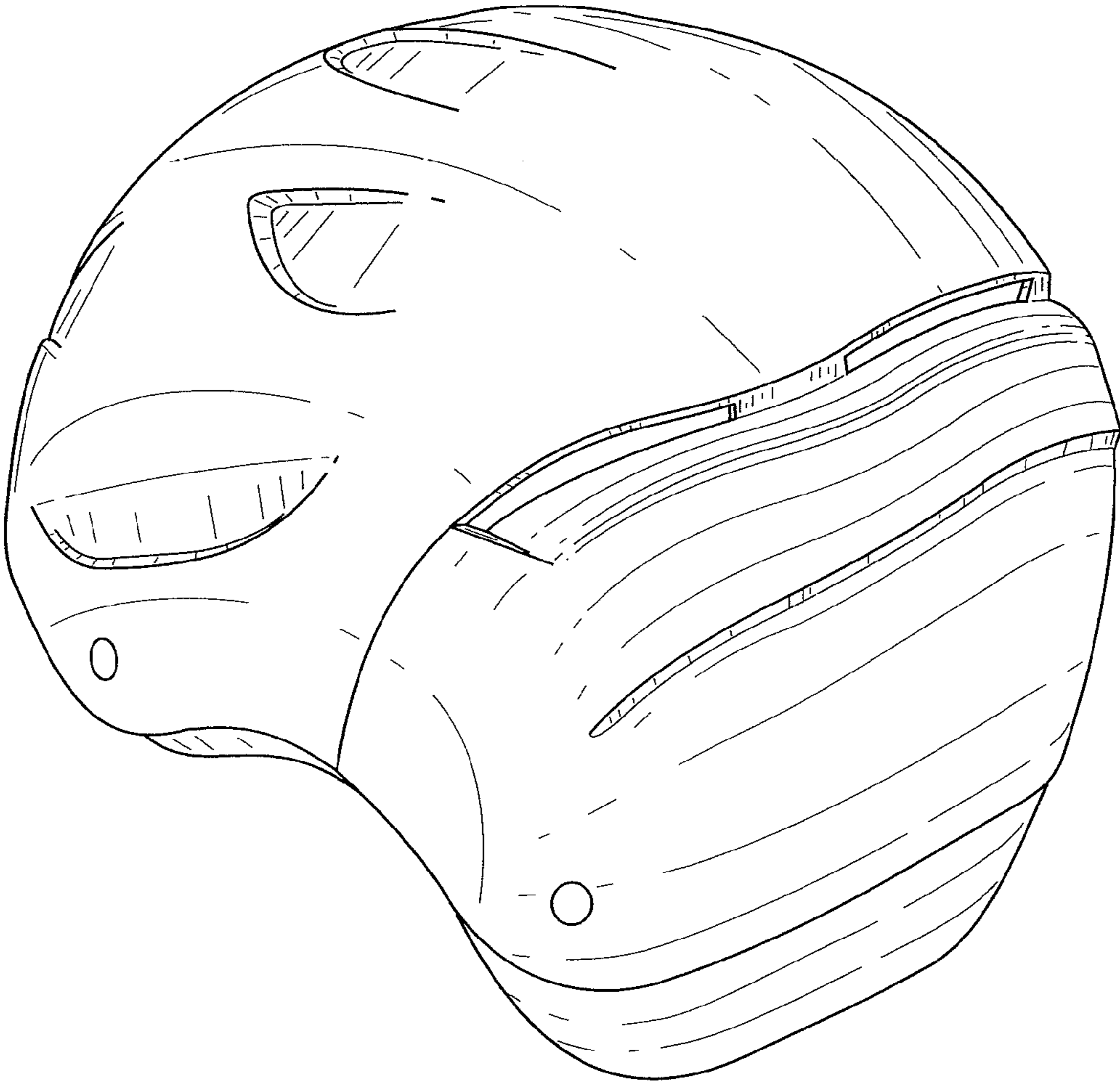
