FIG. 4 is a rear elevation view of the blower.

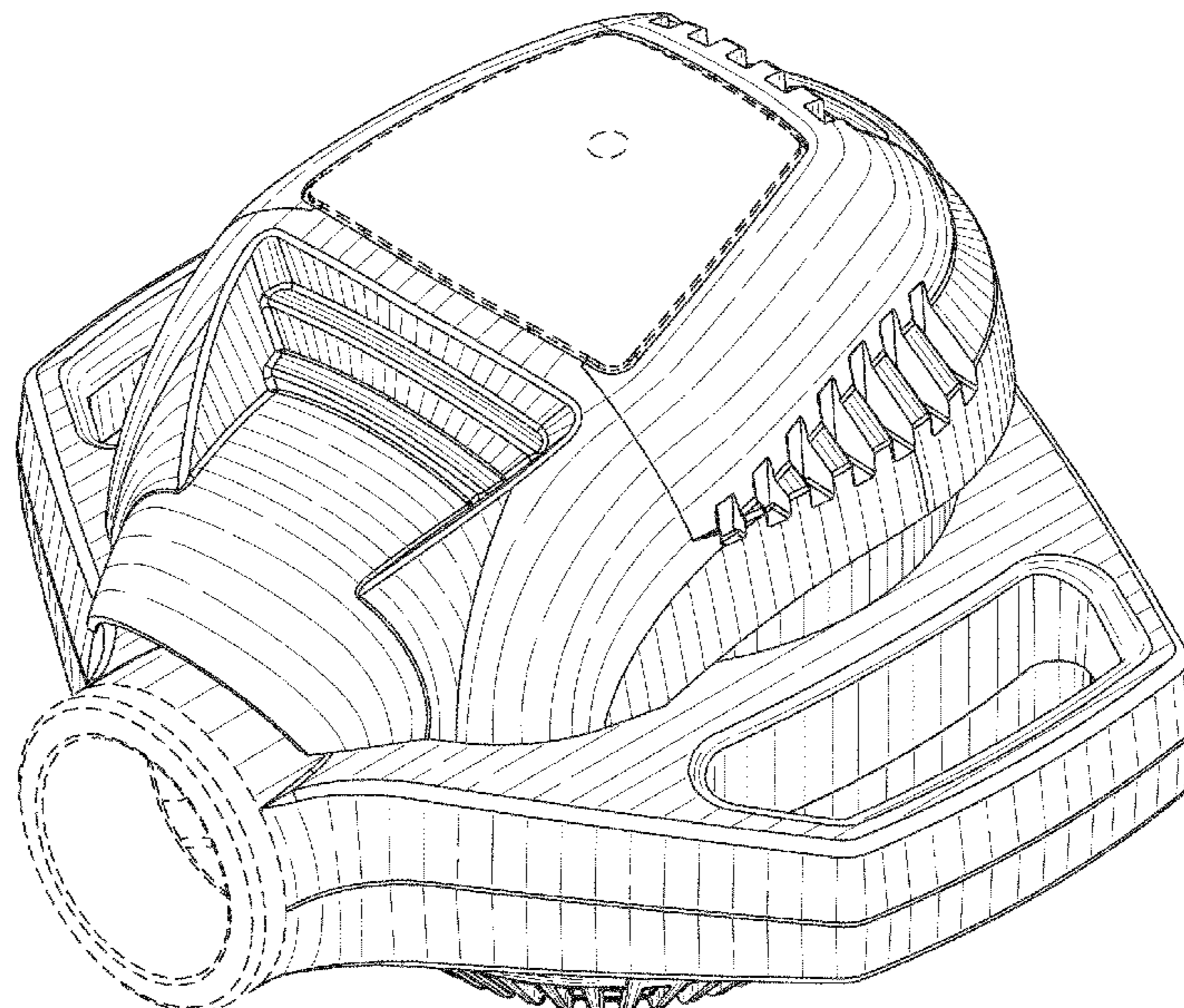
FIG. 5 is a left-side elevation view of the blower.

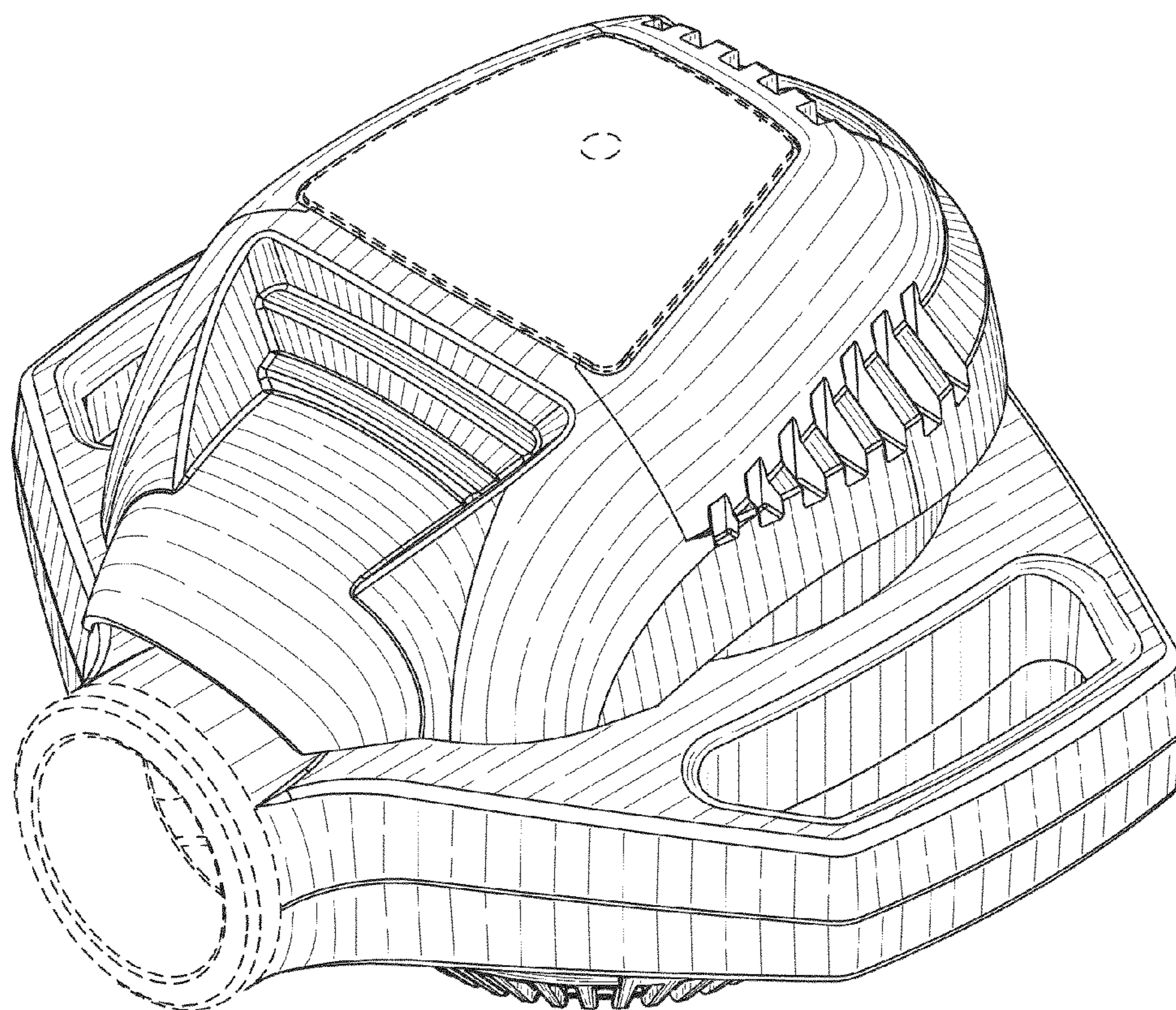
FIG. 6 is a top plan view of the blower; and,

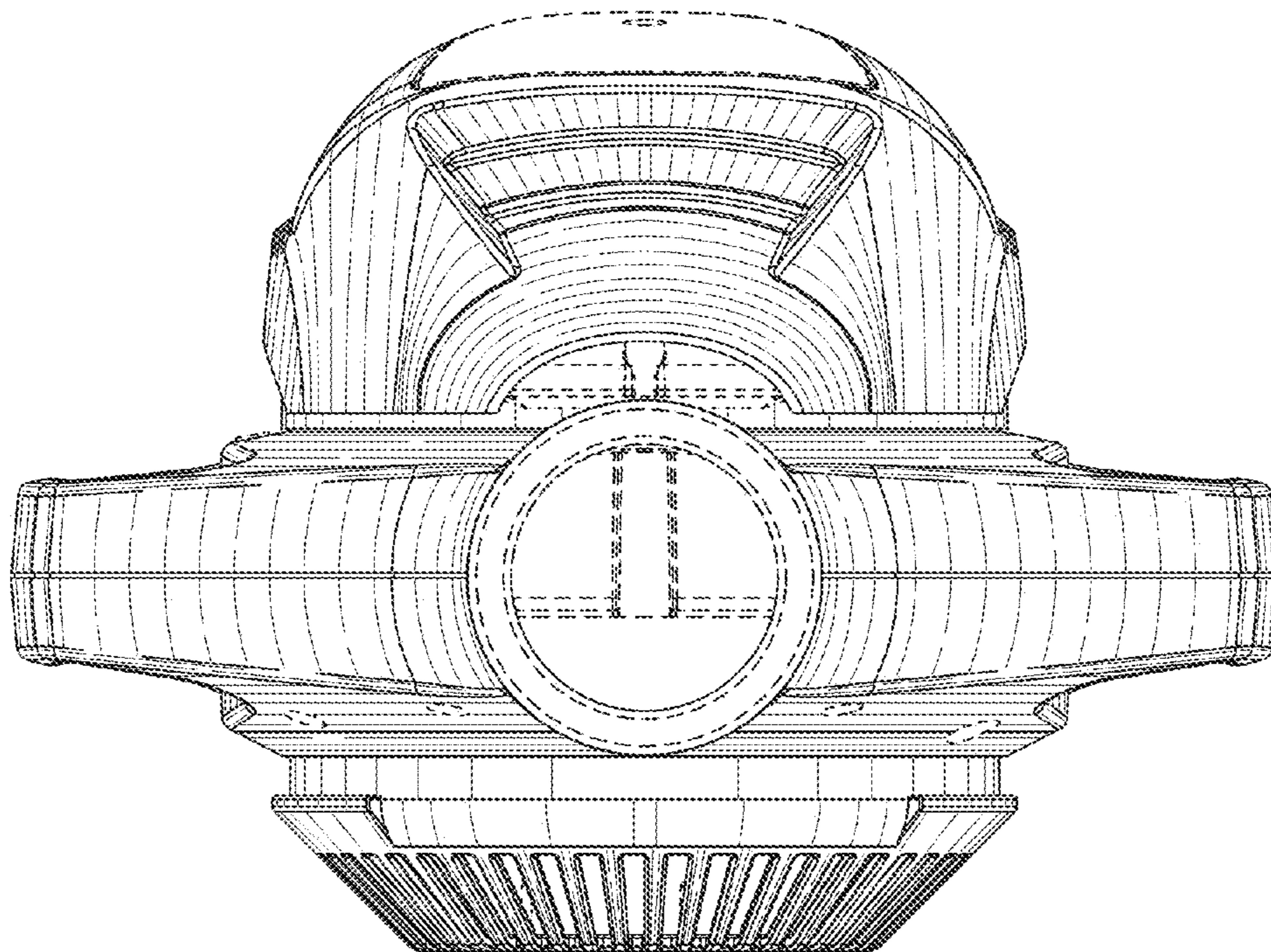

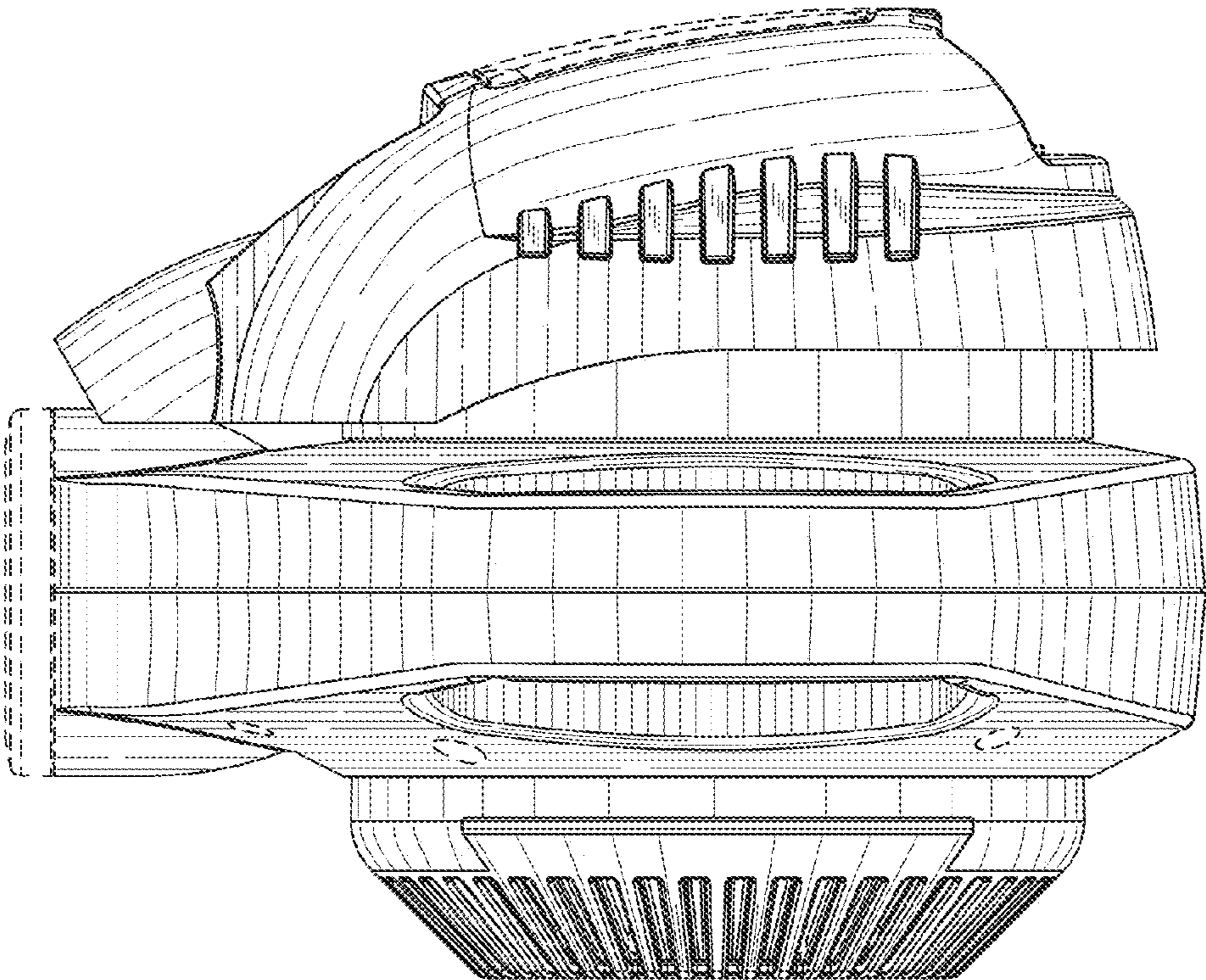

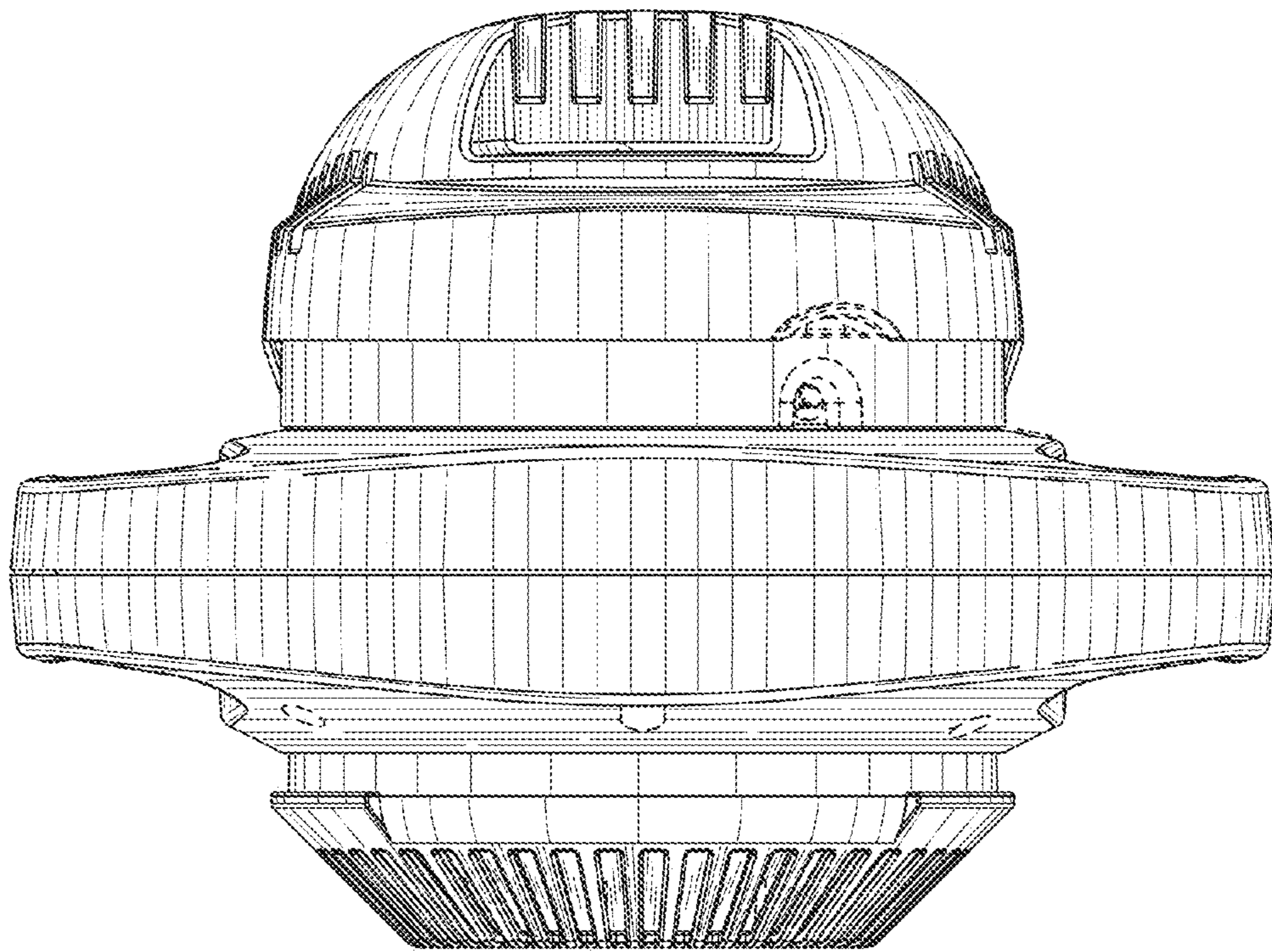

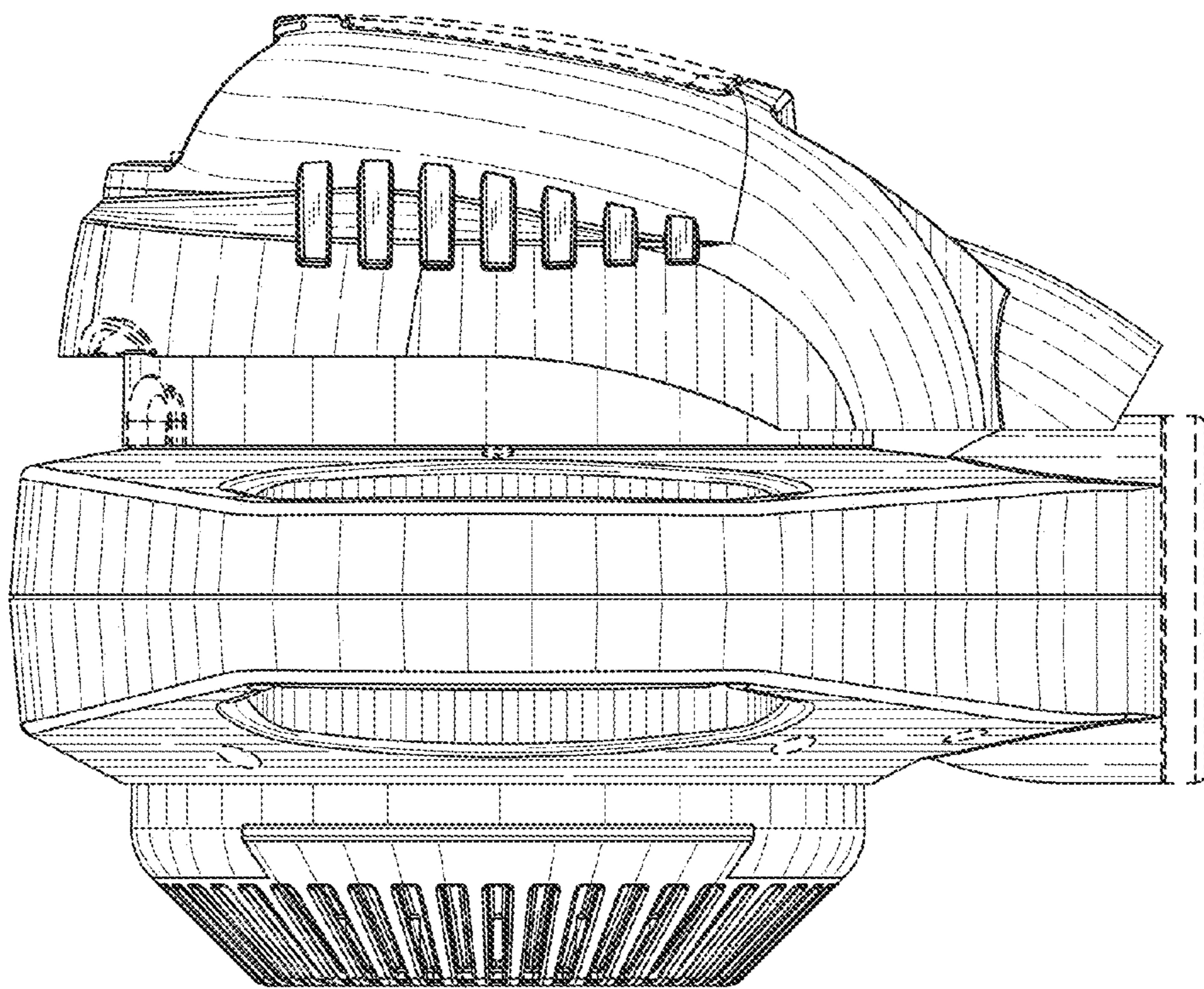

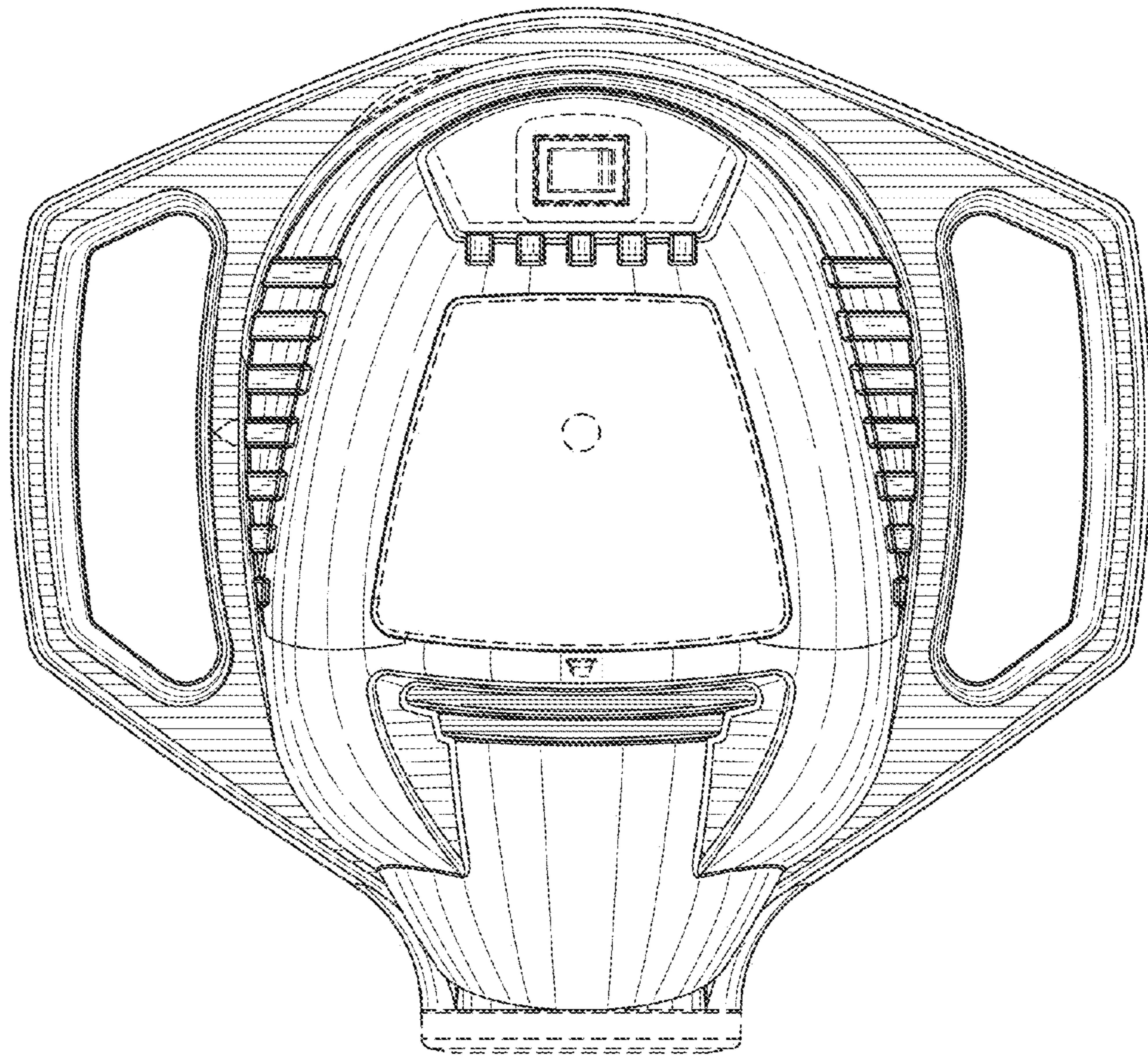

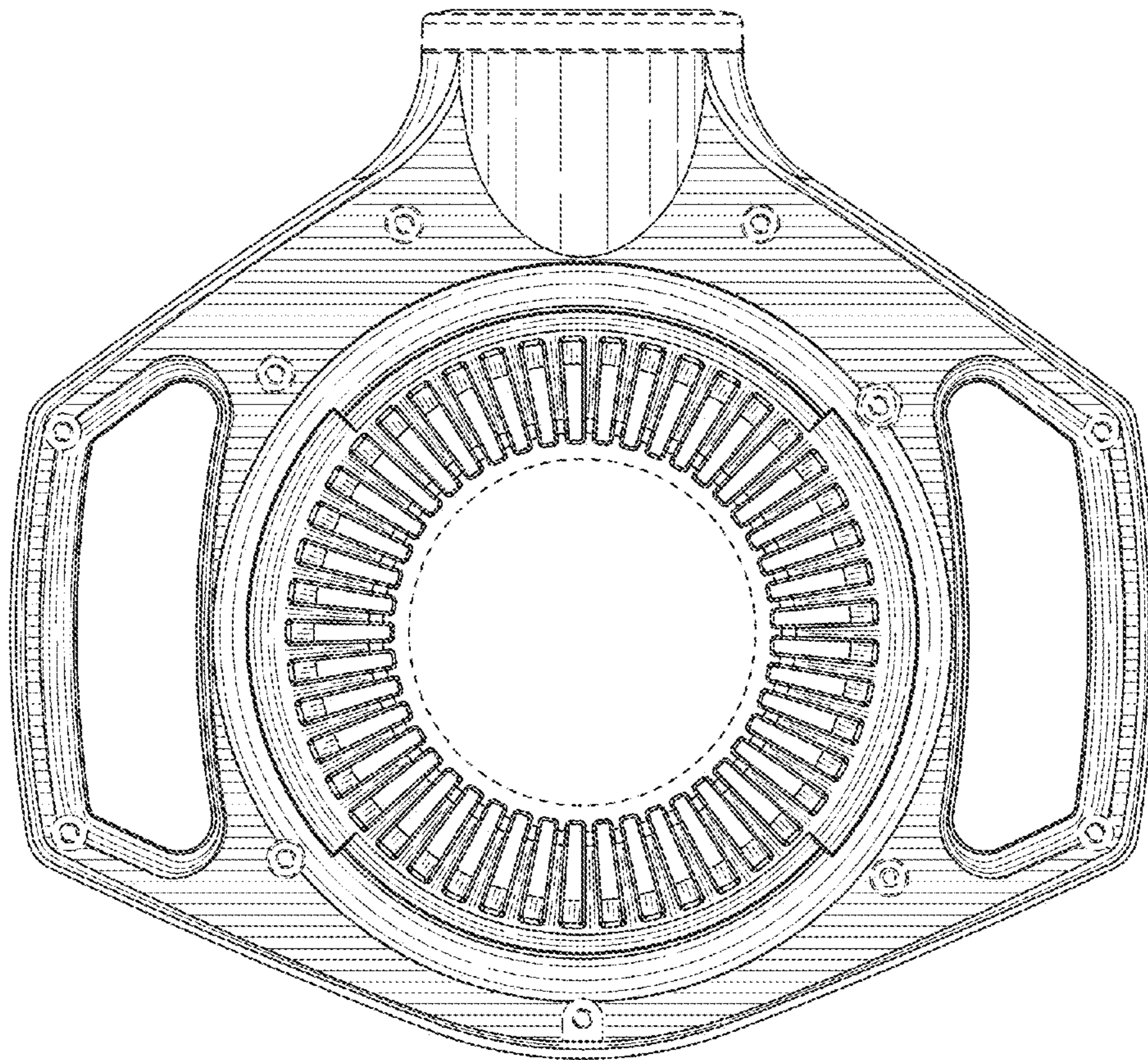
