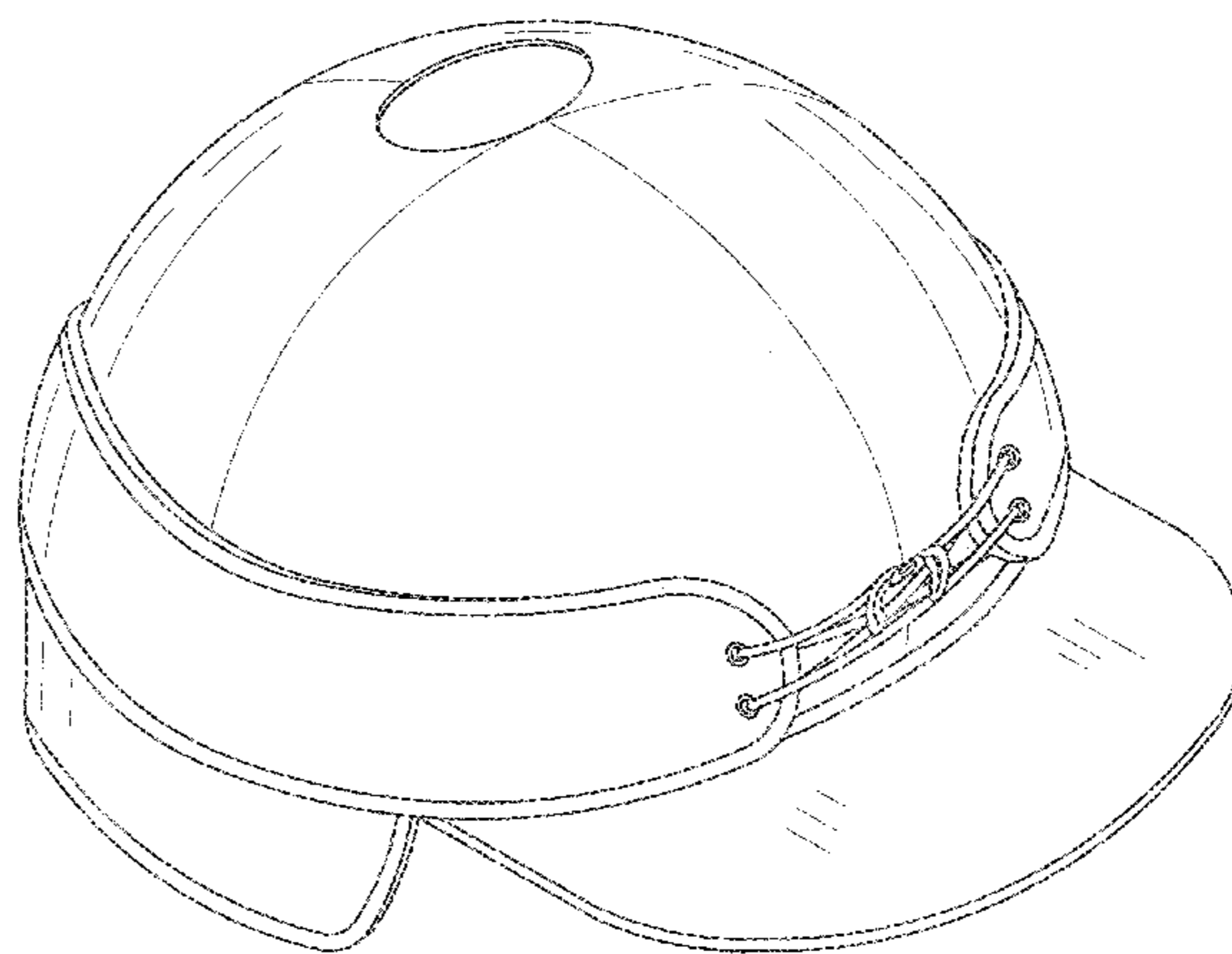
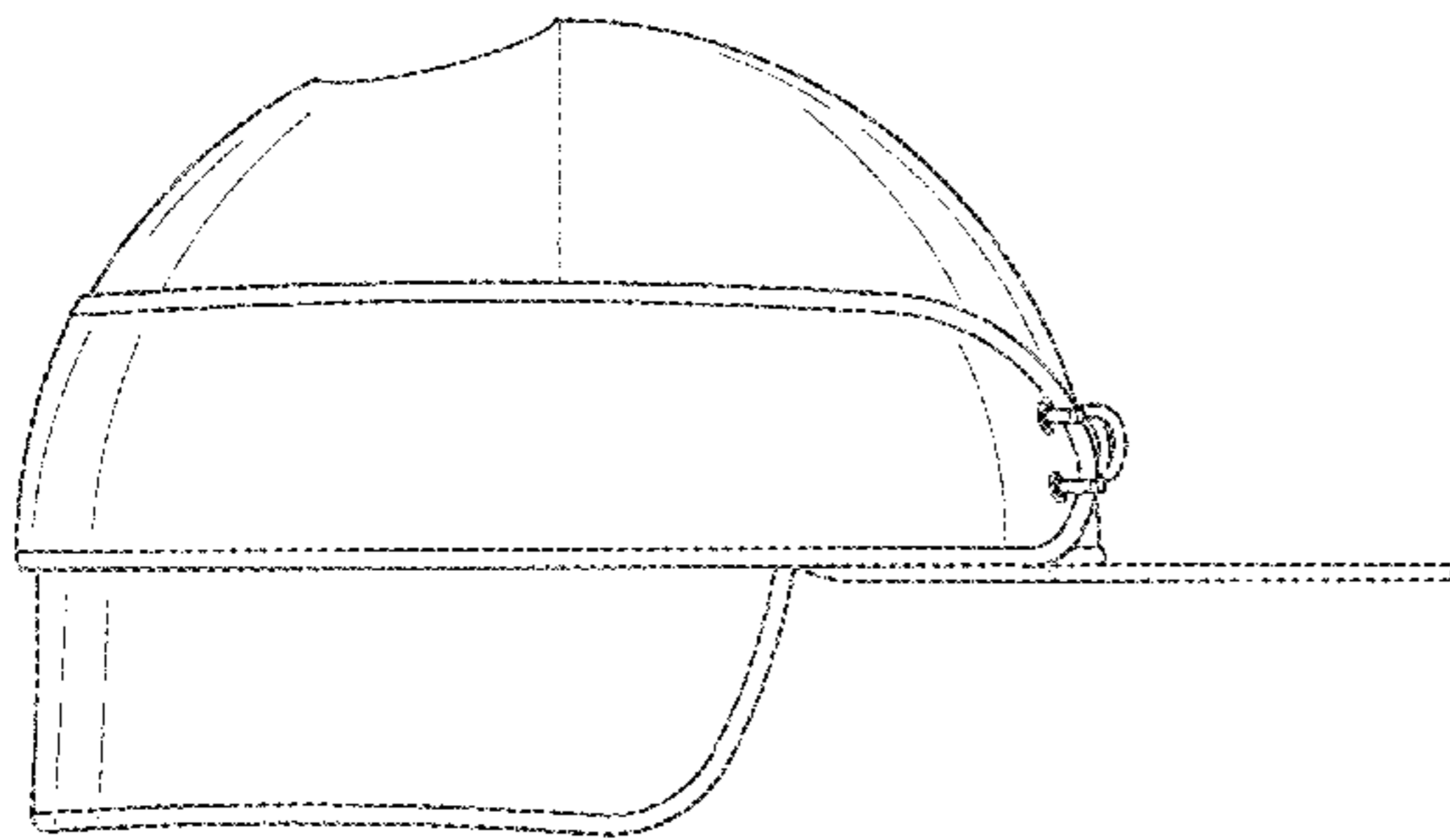
(57) **CLAIM**

The ornamental design for a ponytail accessible railroad hat, as shown and described.

DESCRIPTION

FIG. 1 is a side elevation view of a ponytail accessible railroad hat showing my new design;

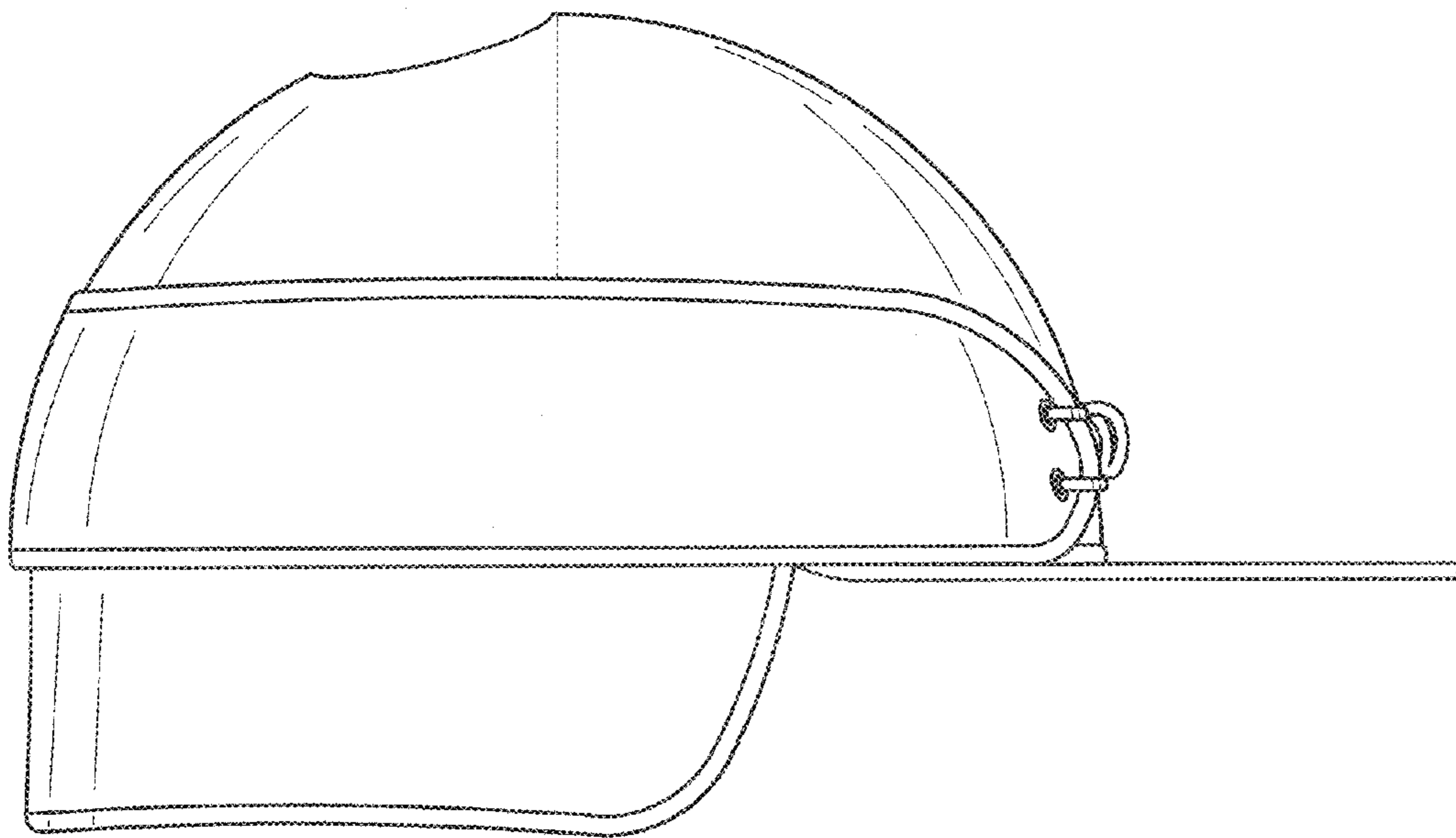

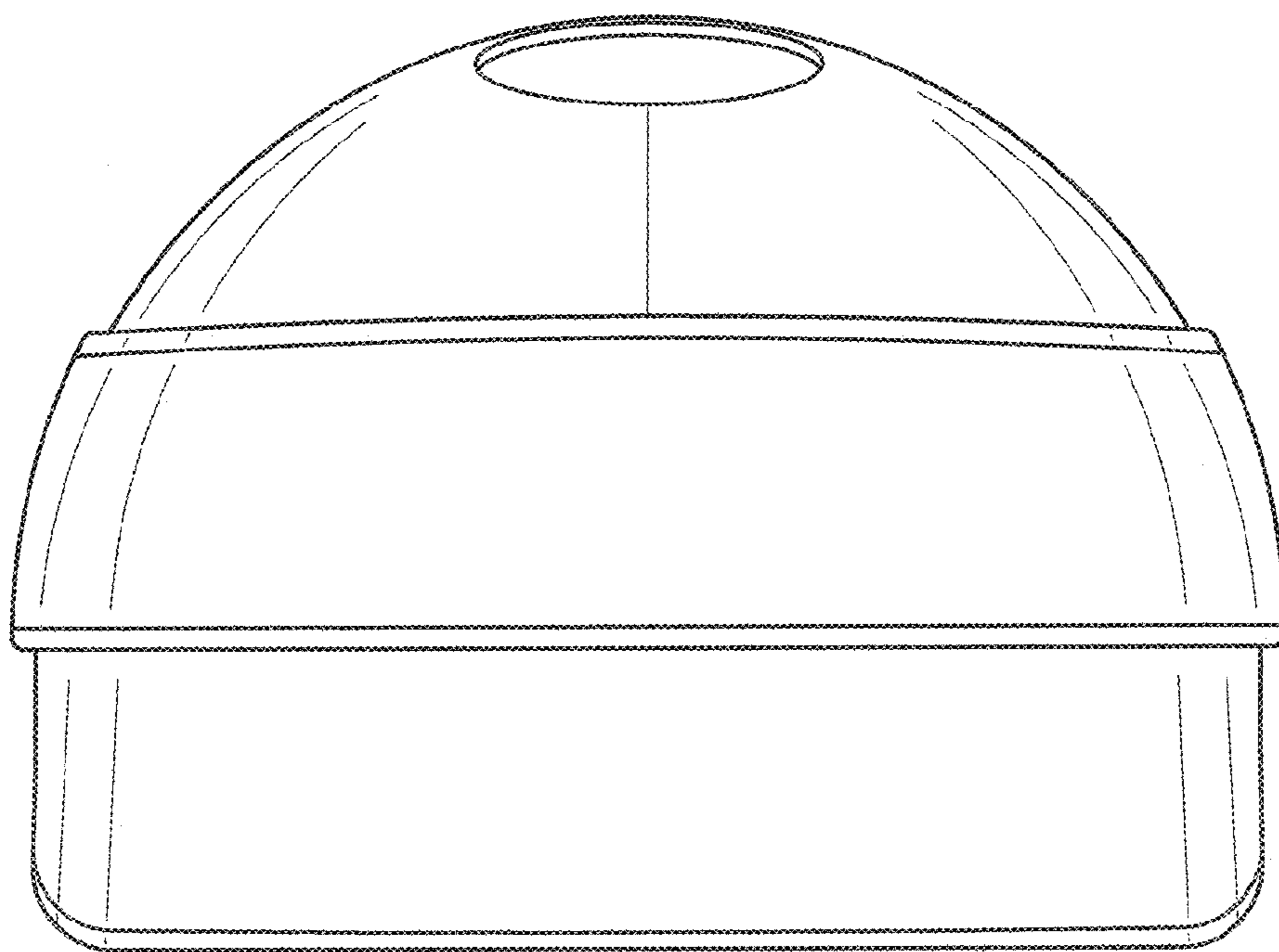

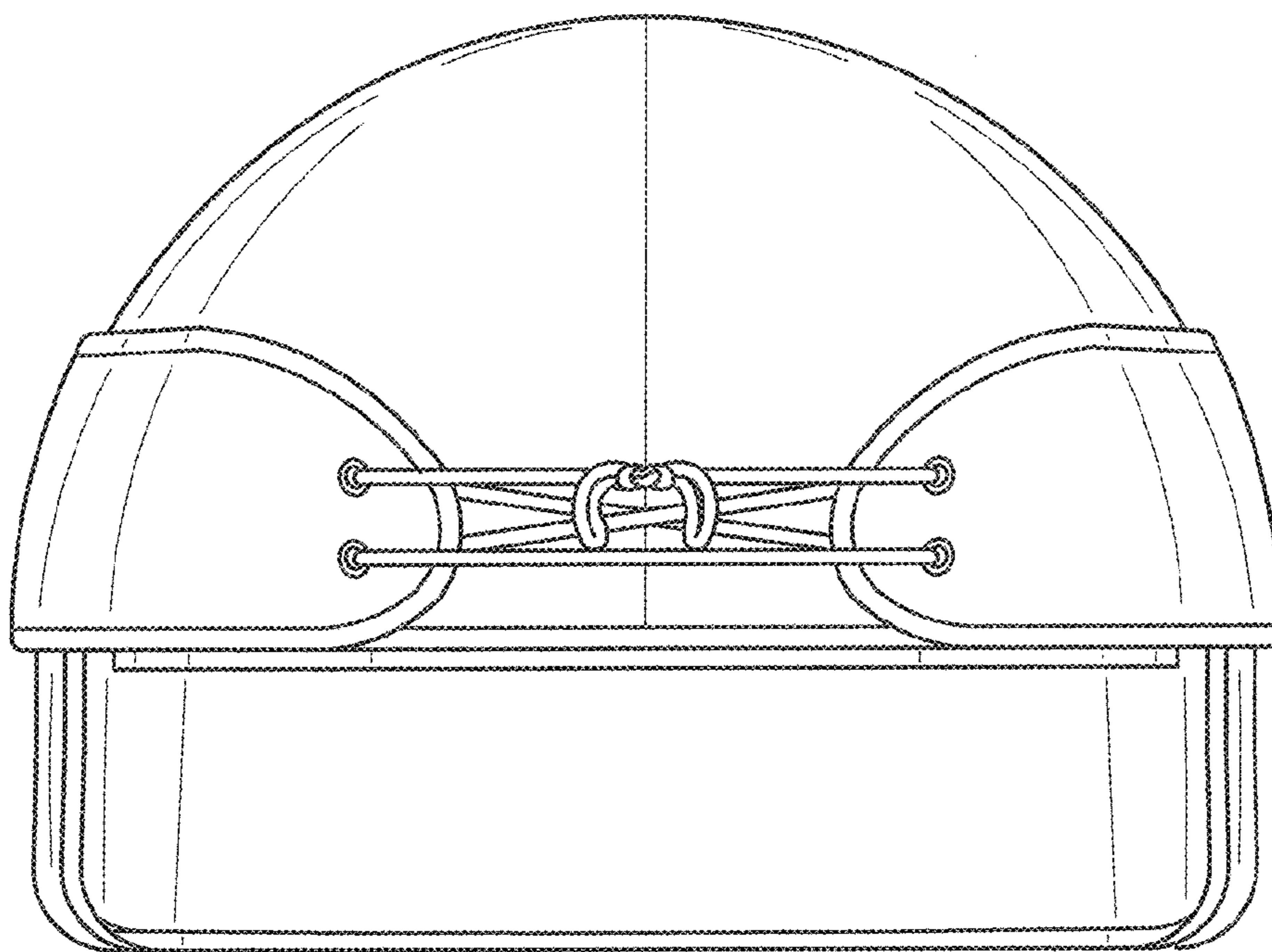

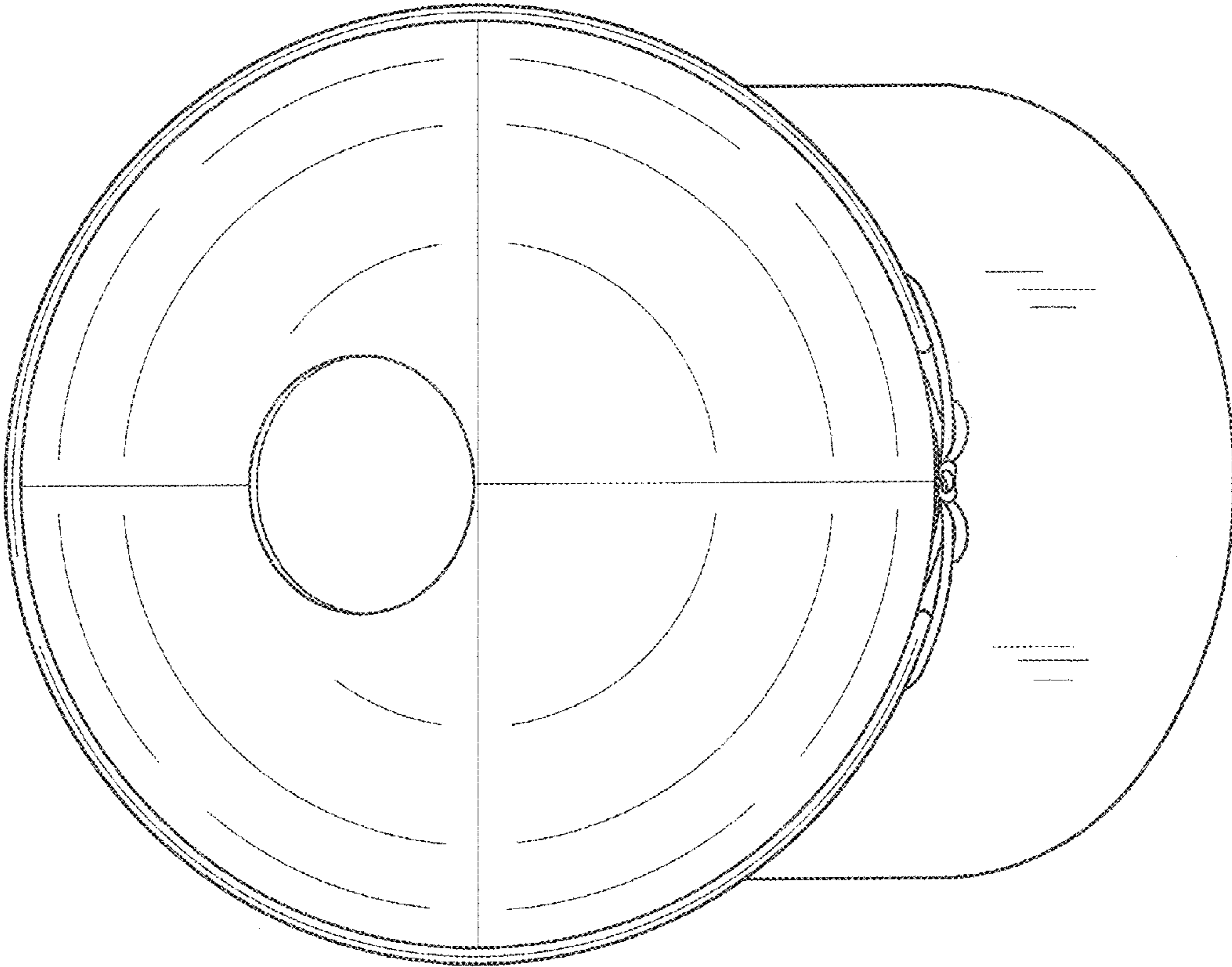

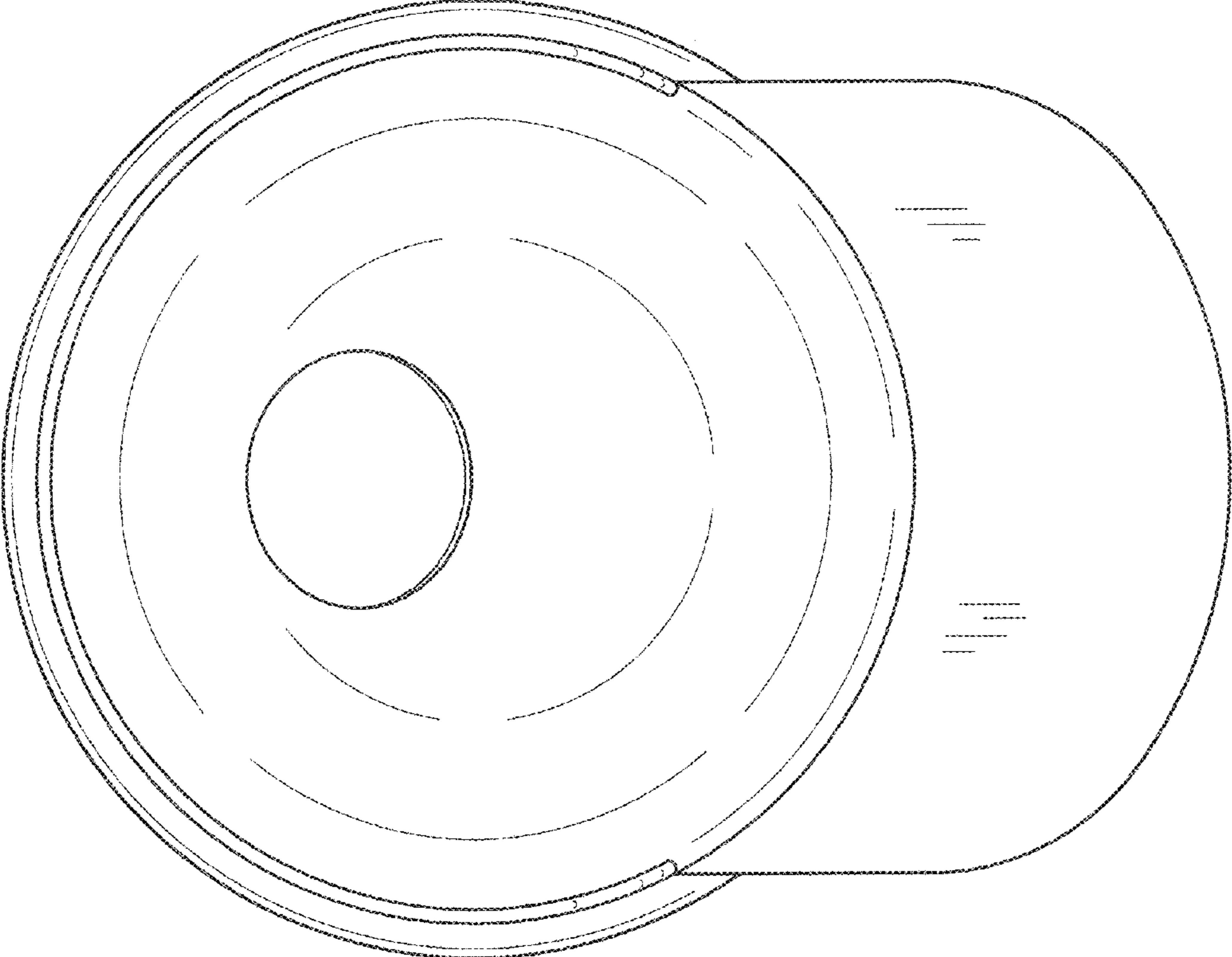

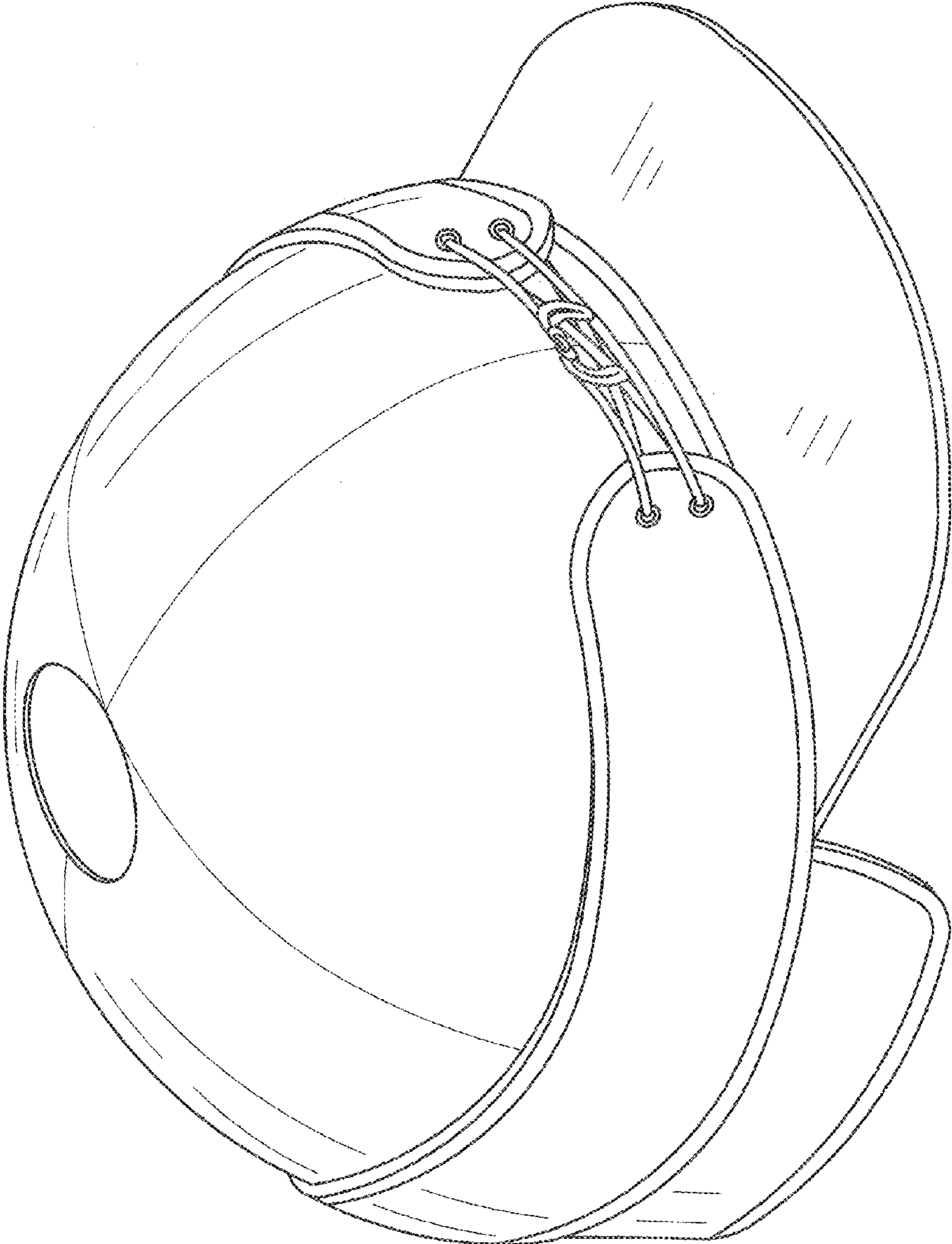

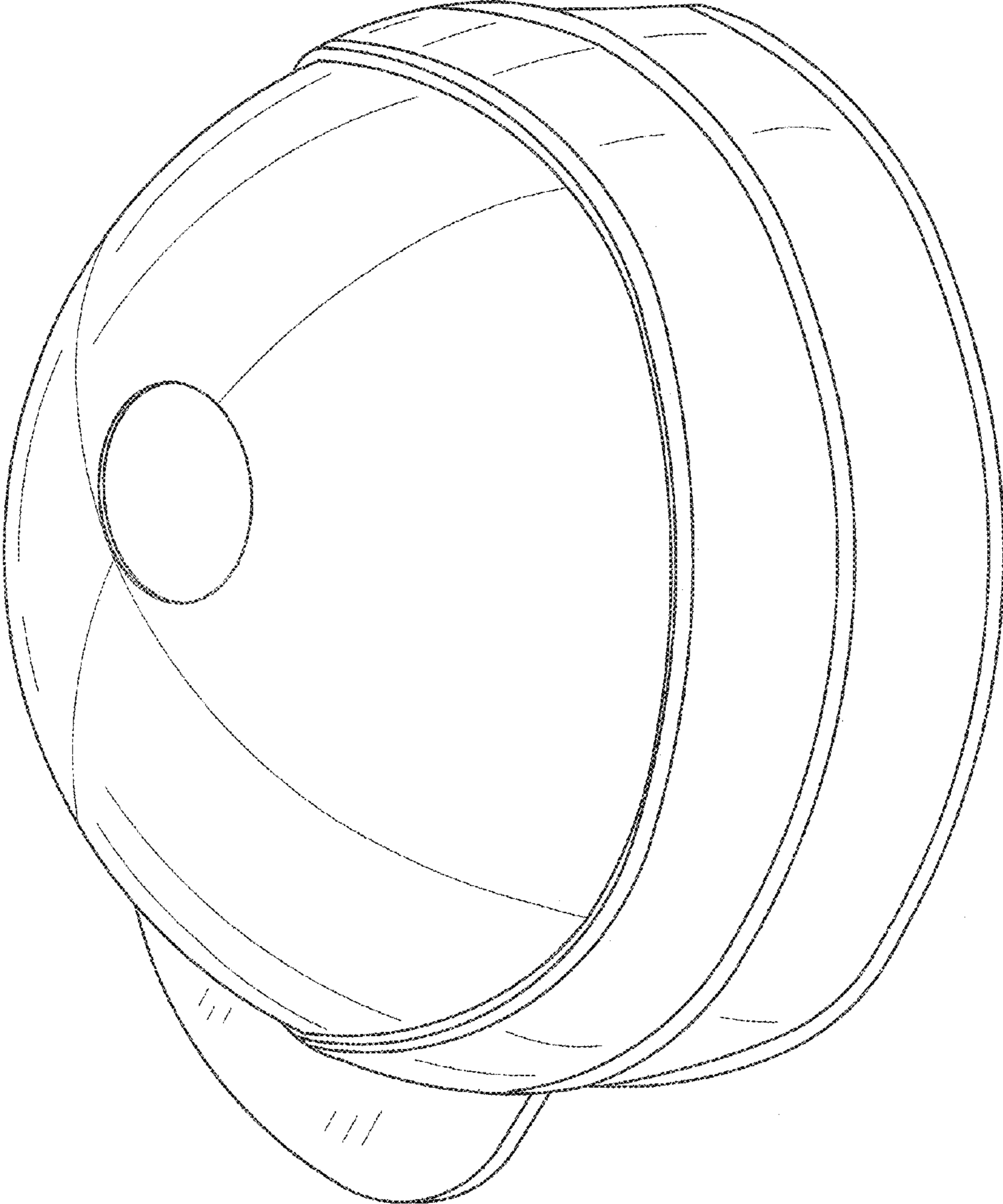
