FIG. 5 is a back view.

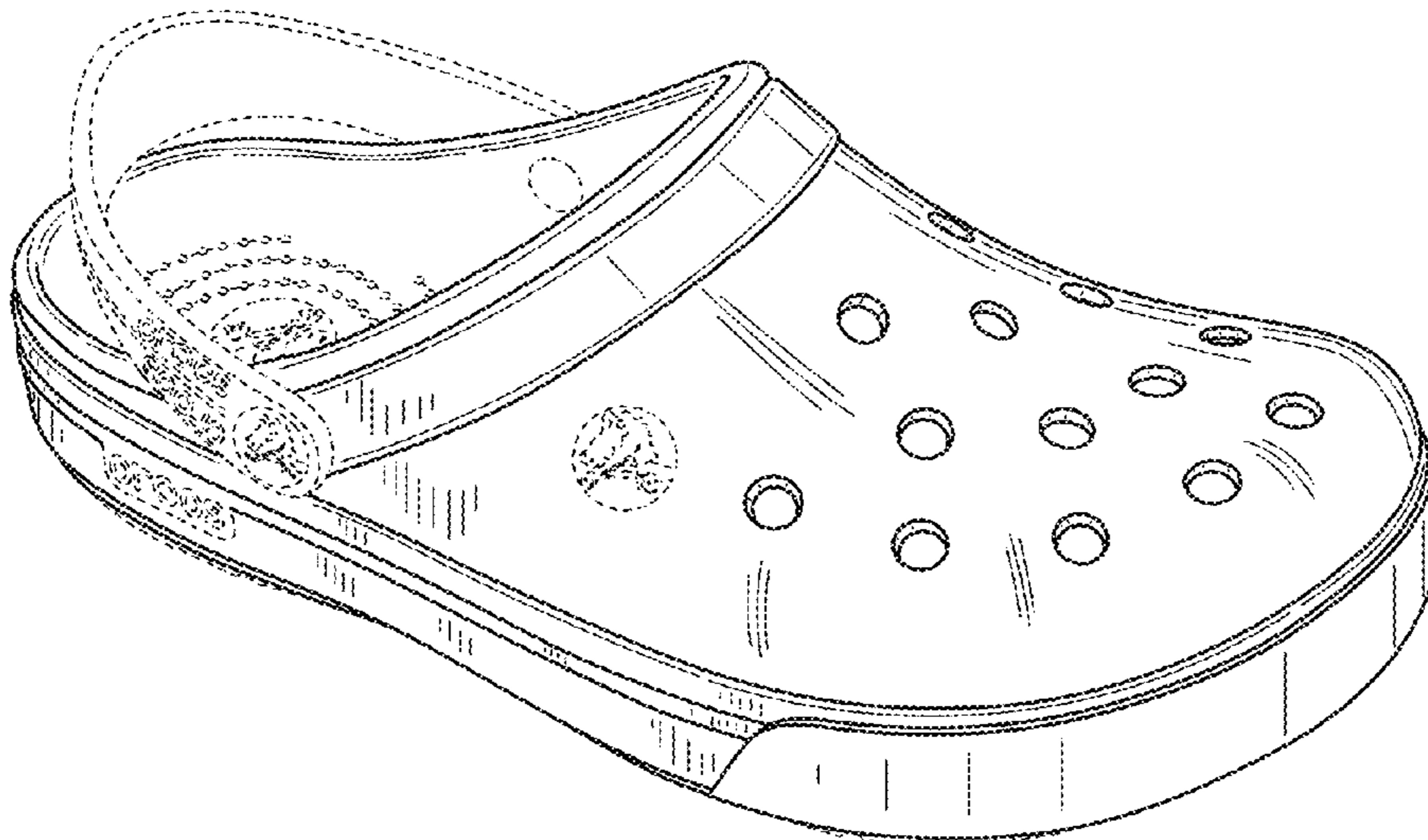
FIG. 6 is a top view; and,

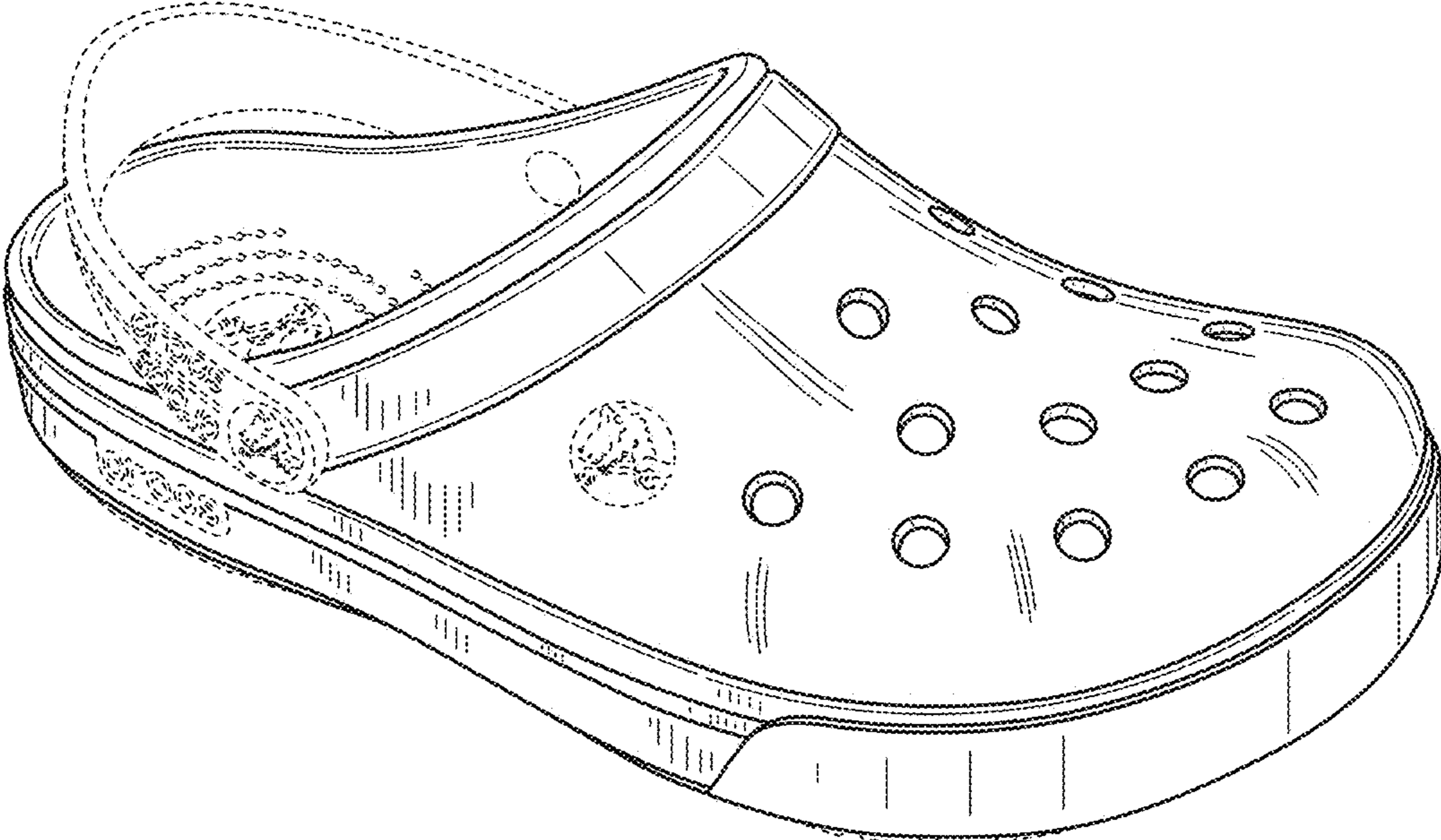

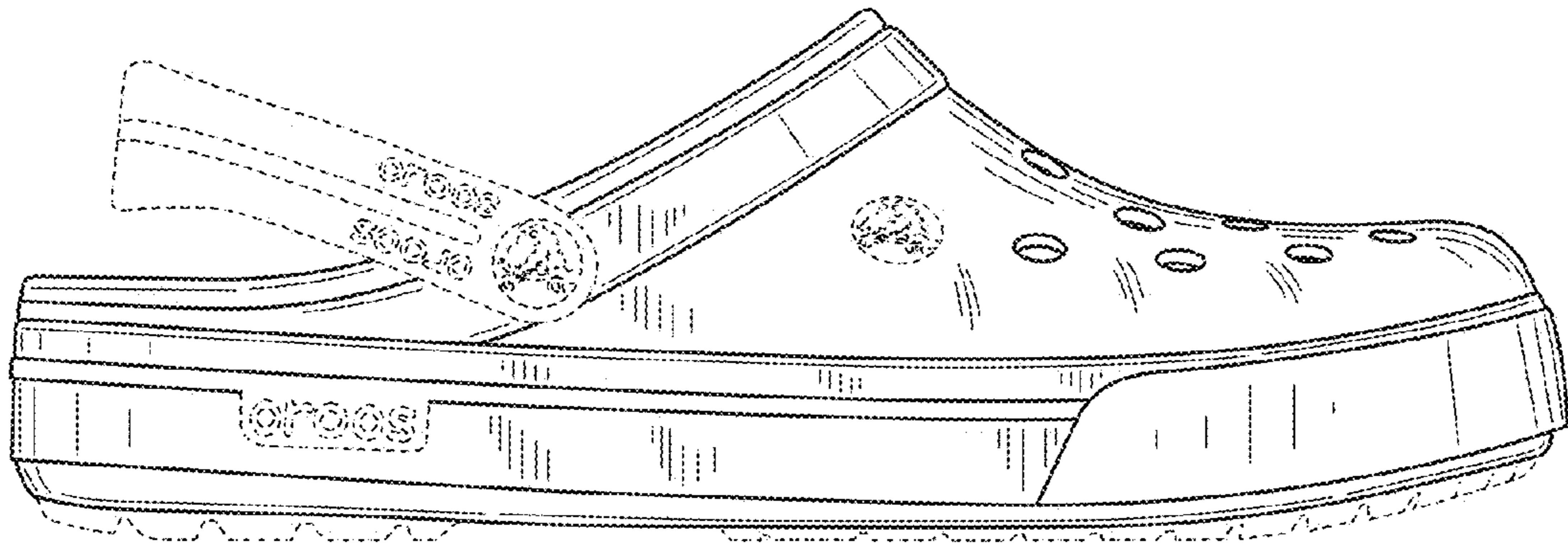

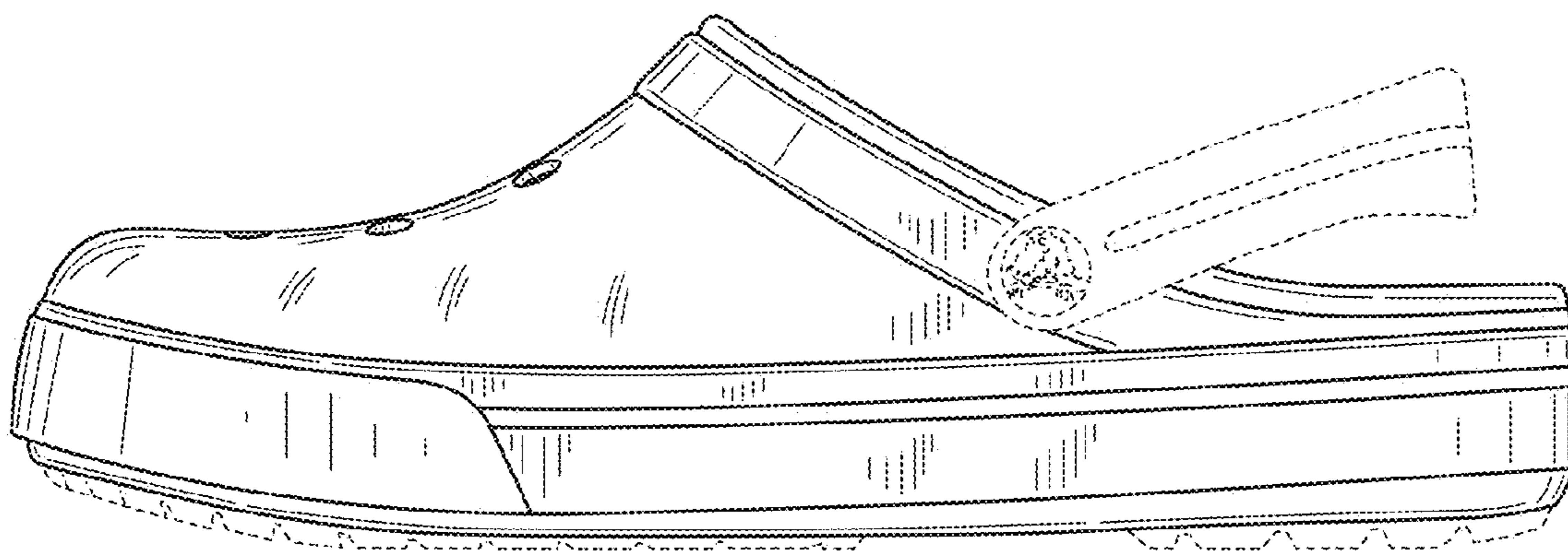

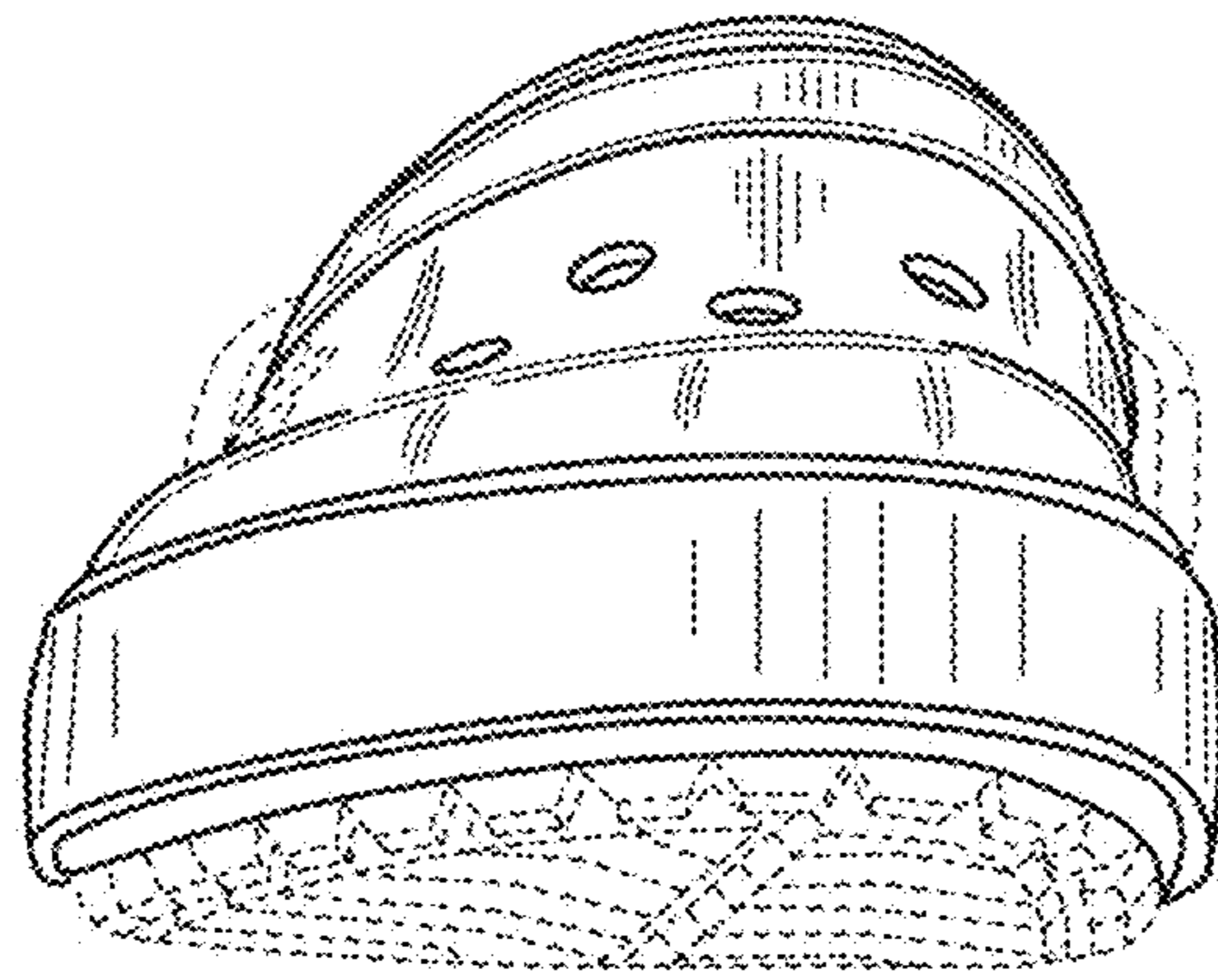

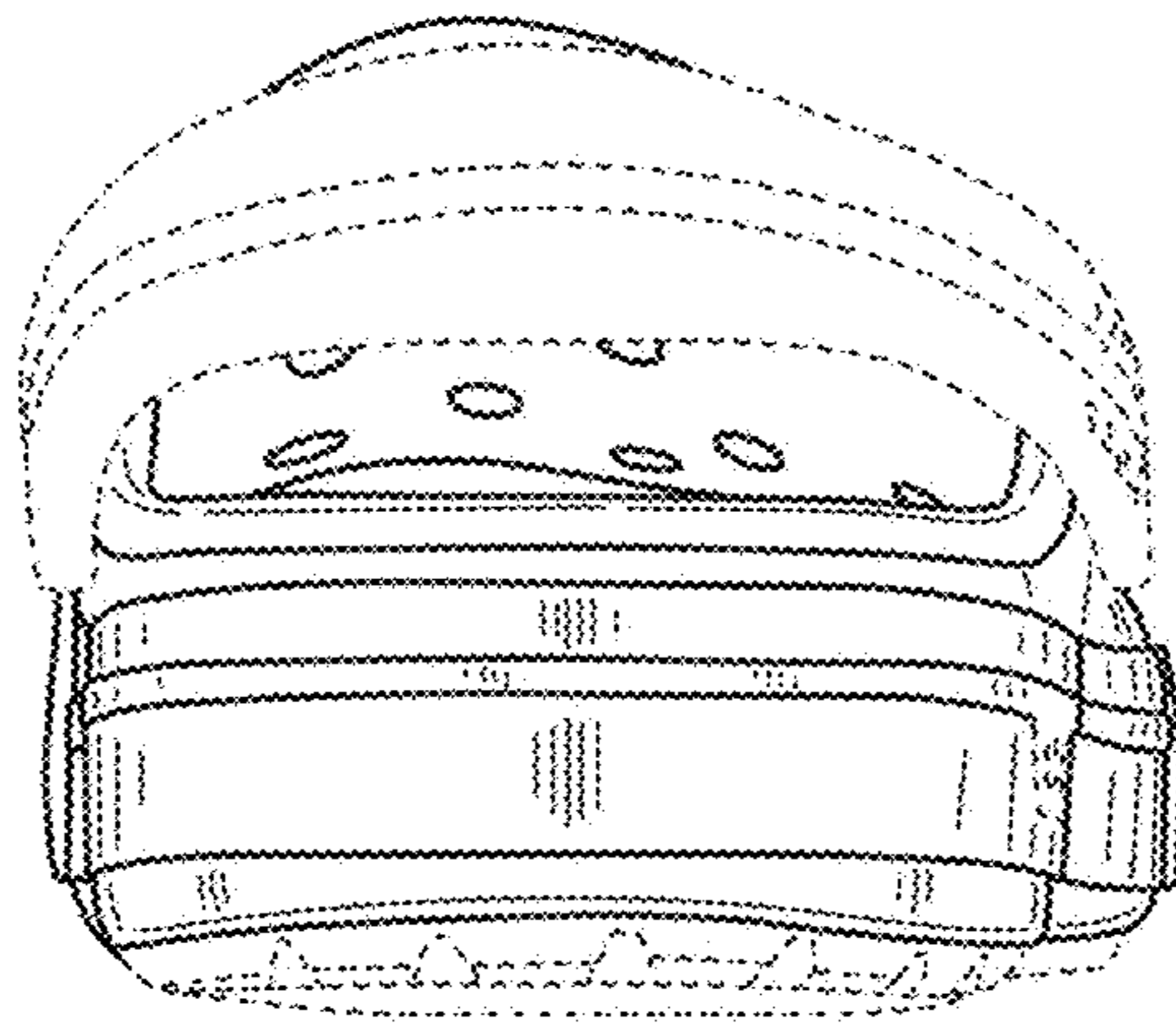

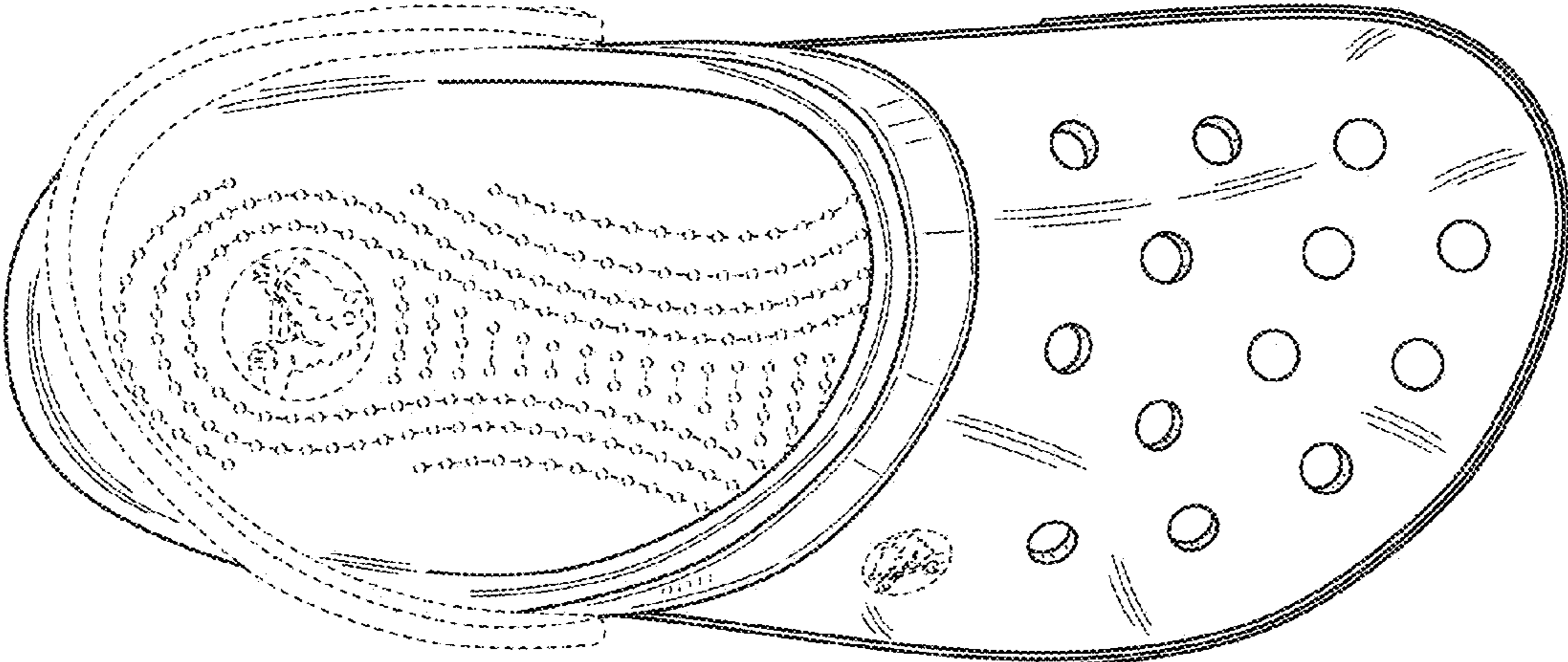

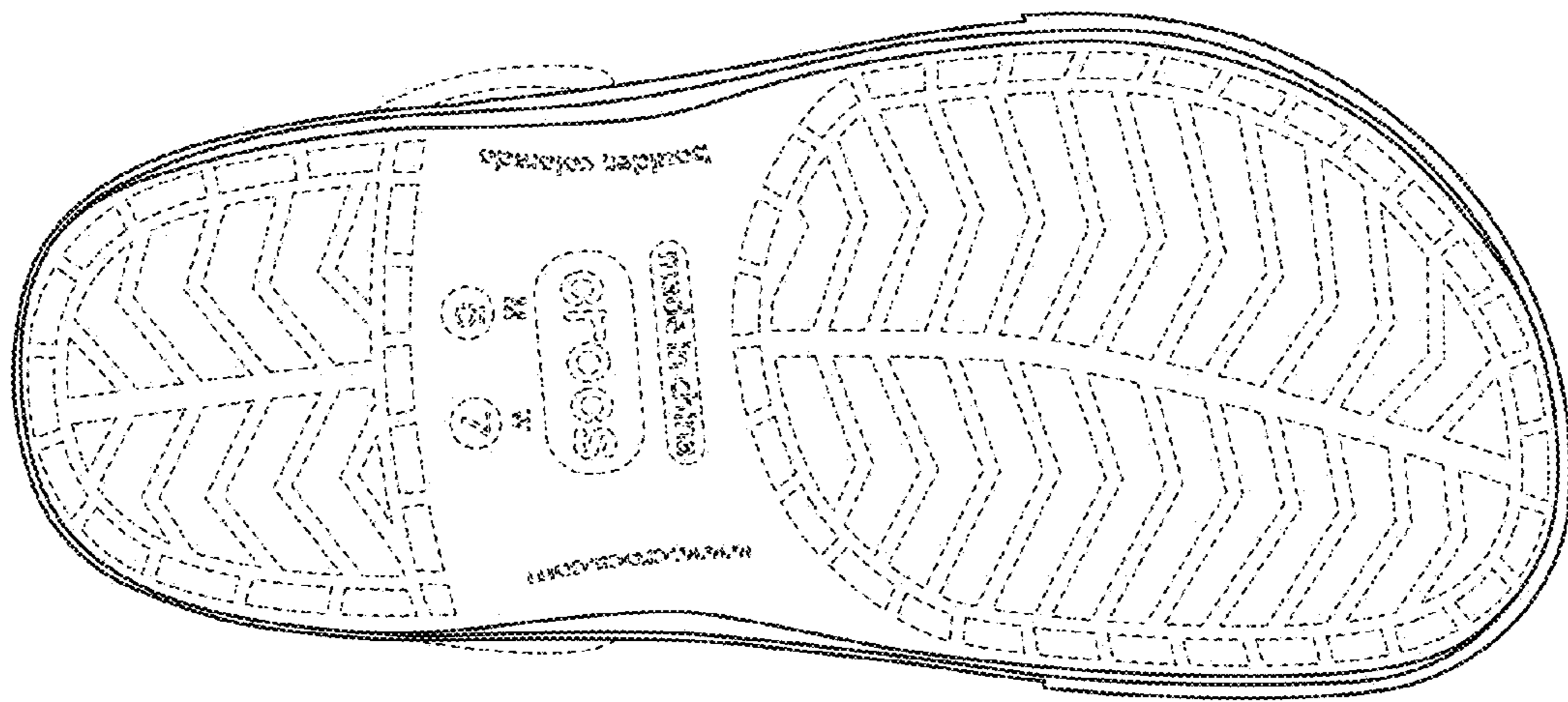
