(57) **CLAIM**

The ornamental design for a wall-mounted easel and display, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the wall-mounted easel and display, illustrating my new design;

FIG. 2 is a front elevational view of the wall-mounted easel and display;

FIG. 3 is a side elevational view of the wall-mounted easel and display, the two sides being mirror images of one another;

FIG. 4 is a top plan view of the wall-mounted easel and display;

FIG. 5 is a bottom plan view of the wall-mounted easel and display; and,

FIG. 6 is a front elevational view of the wall-mounted easel and display with two adjacent wall-mounted easels and displays.

In the drawing figures, the broken lines immediately adjacent the shaded areas represent the bounds of the claimed design, while all other broken lines are directed to environment and are for illustrative purposes only; the broken lines form no part of the claimed design. Additionally, the rear face of the wall-mounted easel and display is flat, unornamented, and forms no part of the claimed design.

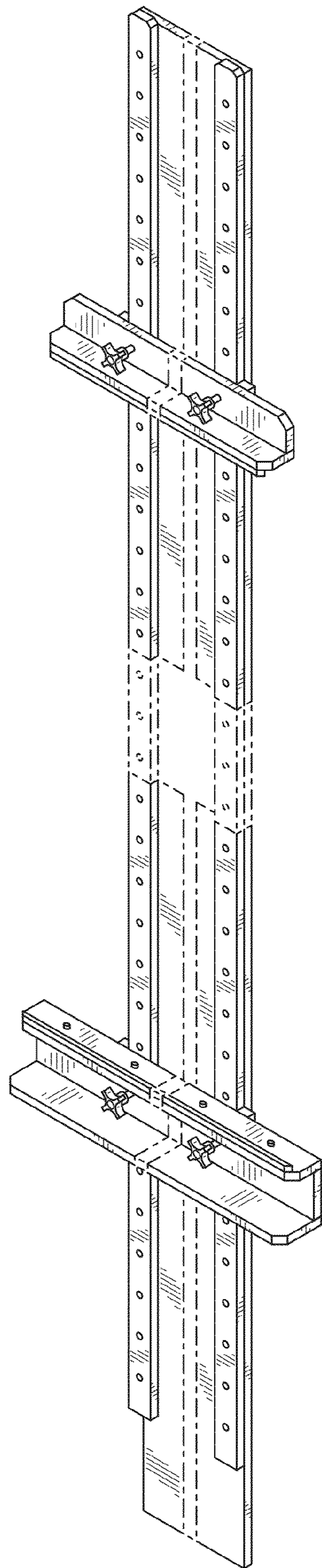

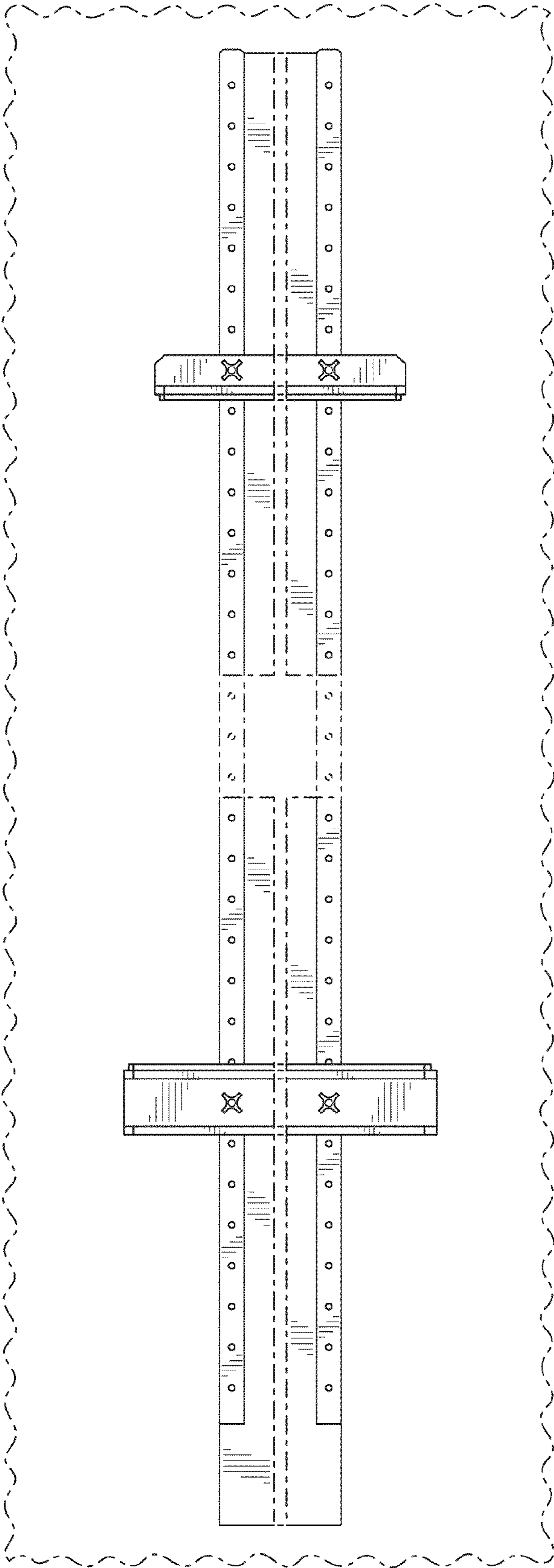

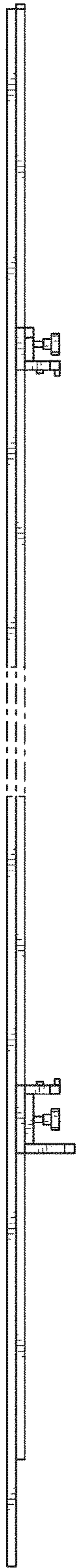

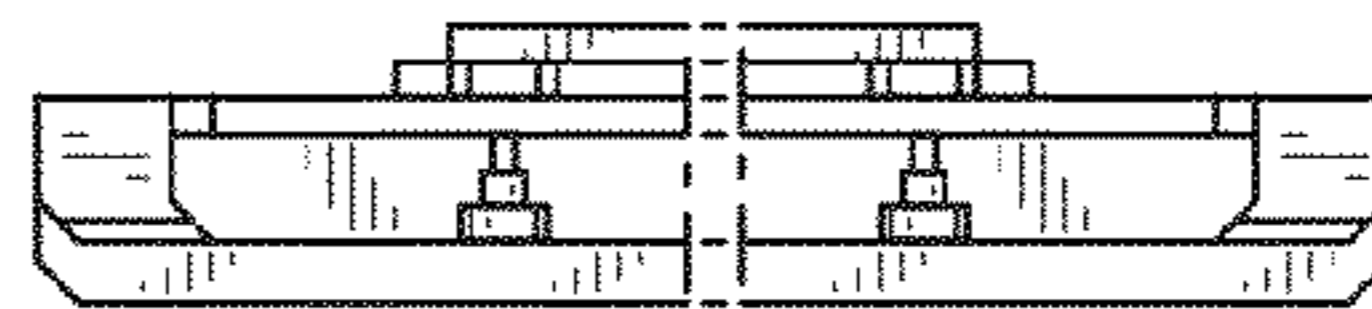

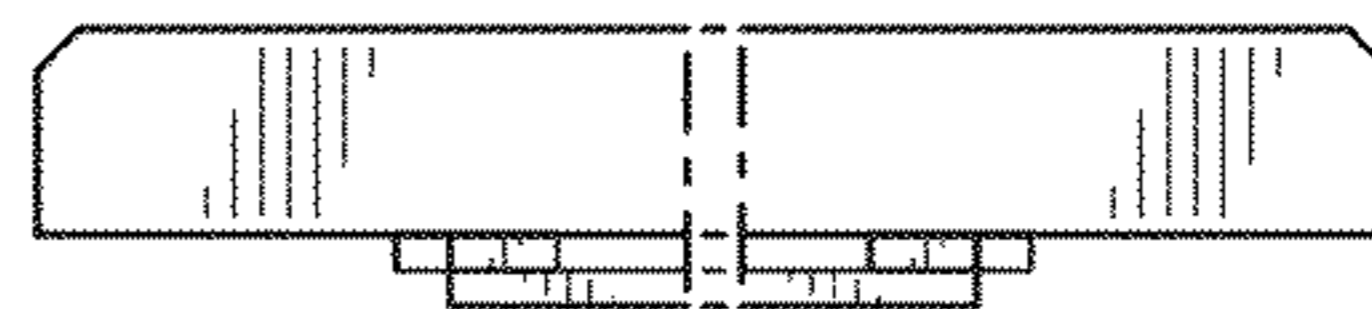

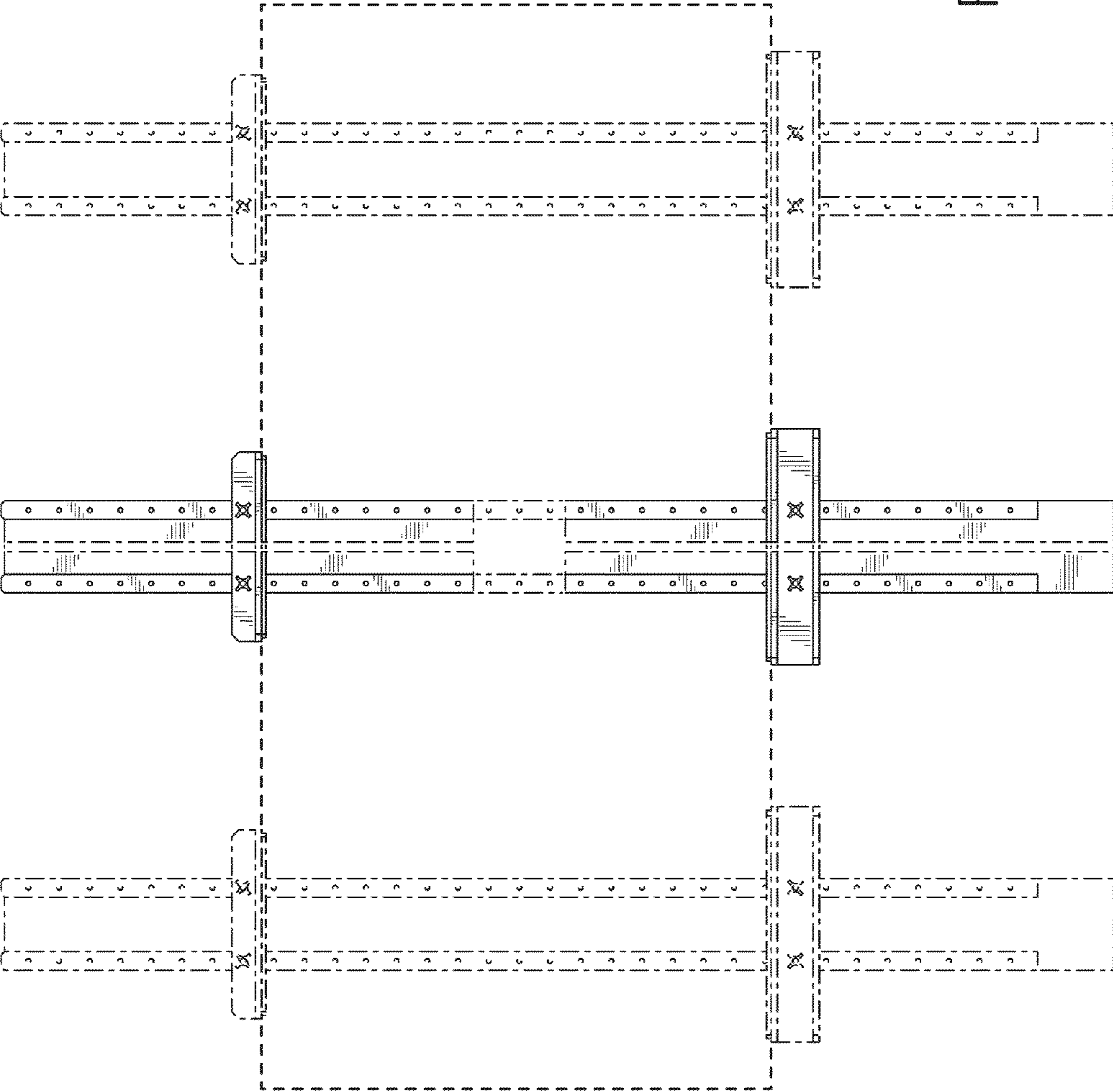
