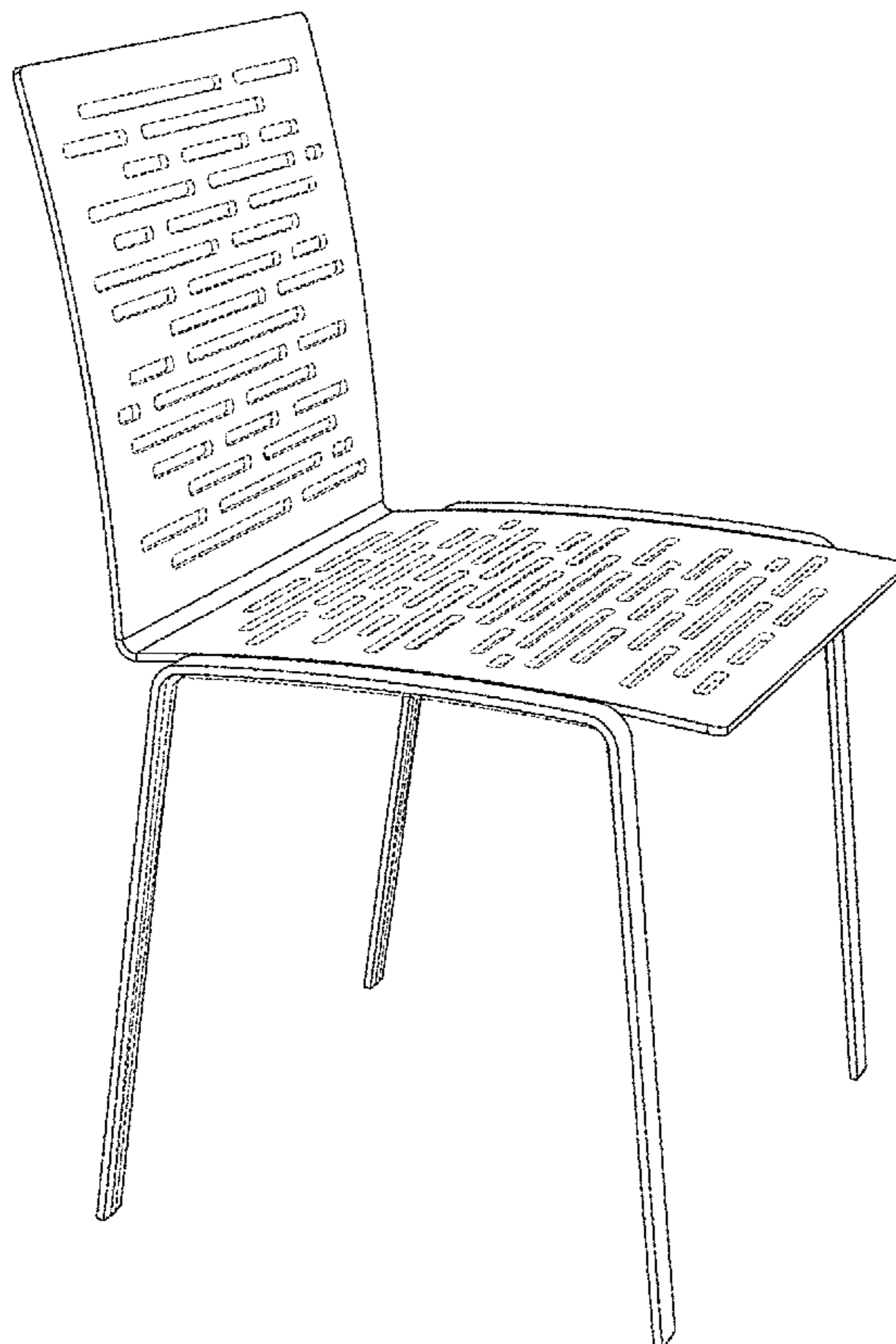
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front view of a chair constructed in accordance with an embodiment of the present invention; FIG. 2 is a top view of the chair of FIG. 1; FIG. 3 is a back view of the chair of FIG. 1; FIG. 4 is a bottom view of the chair of FIG. 1; FIG. 5 is a side view of the chair of FIG. 1; and, FIG. 6 is a perspective view of the chair of FIG. 1. The elements delineated in dashed lines form no part of the claimed design of a chair.

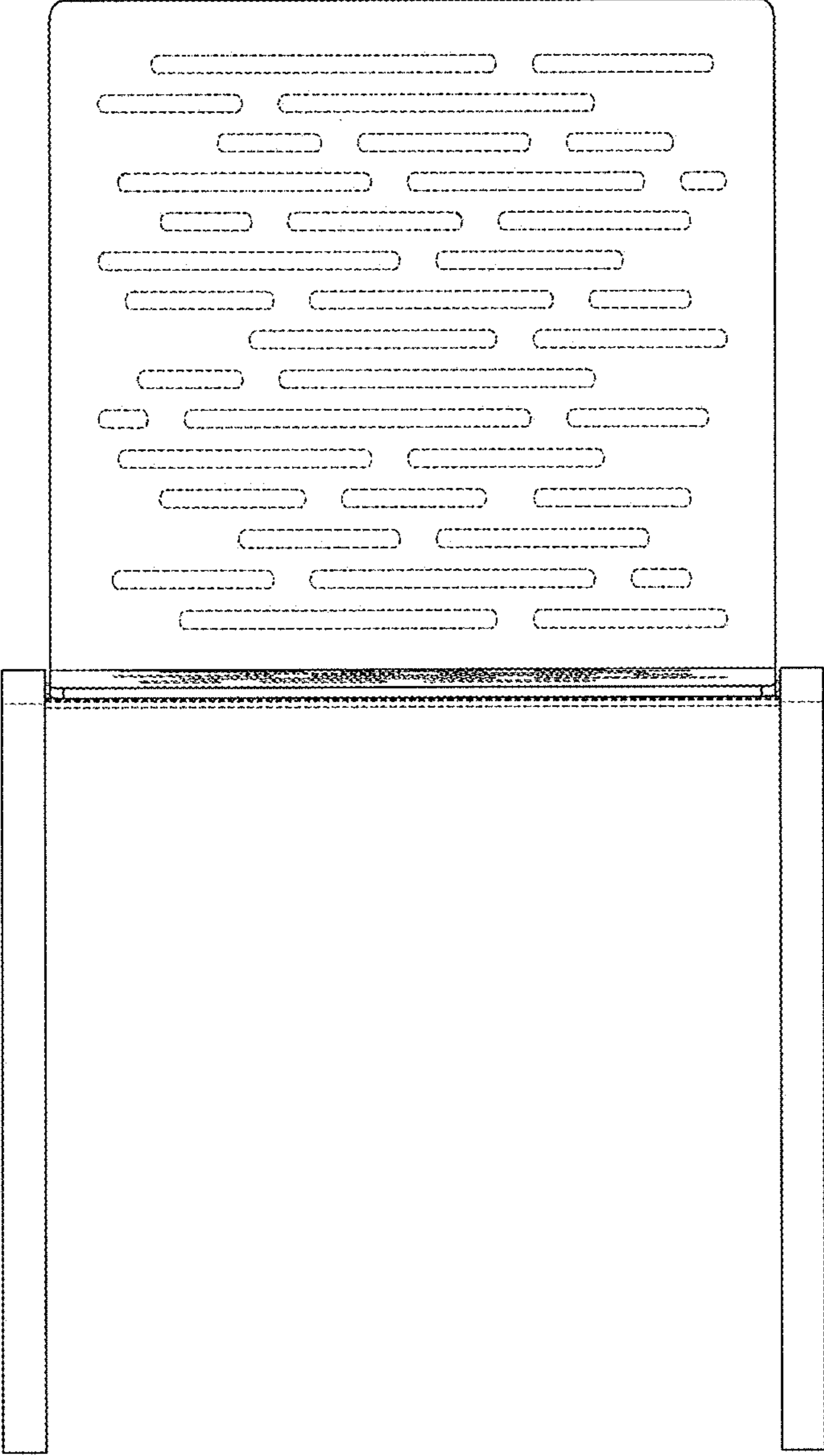

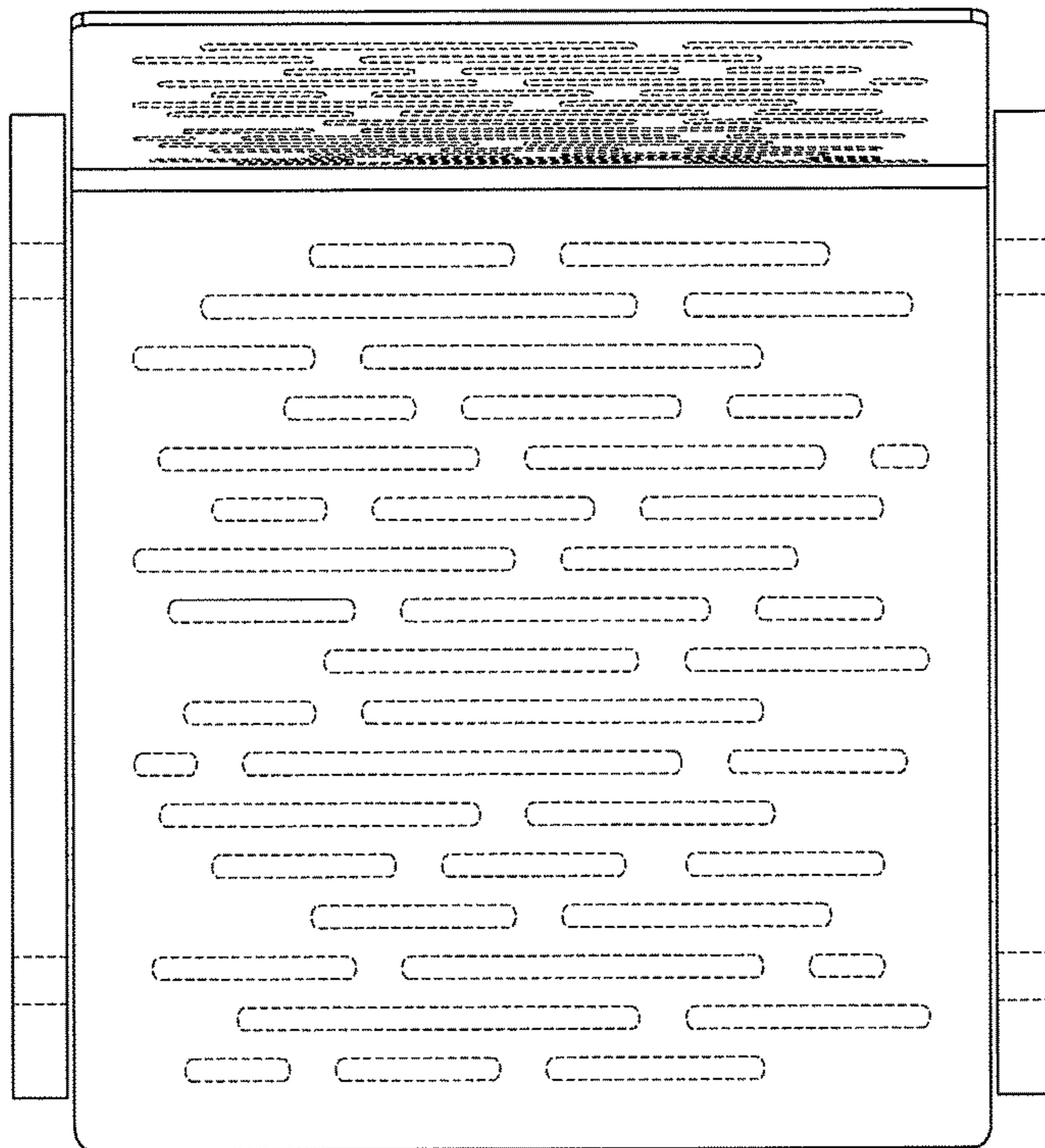

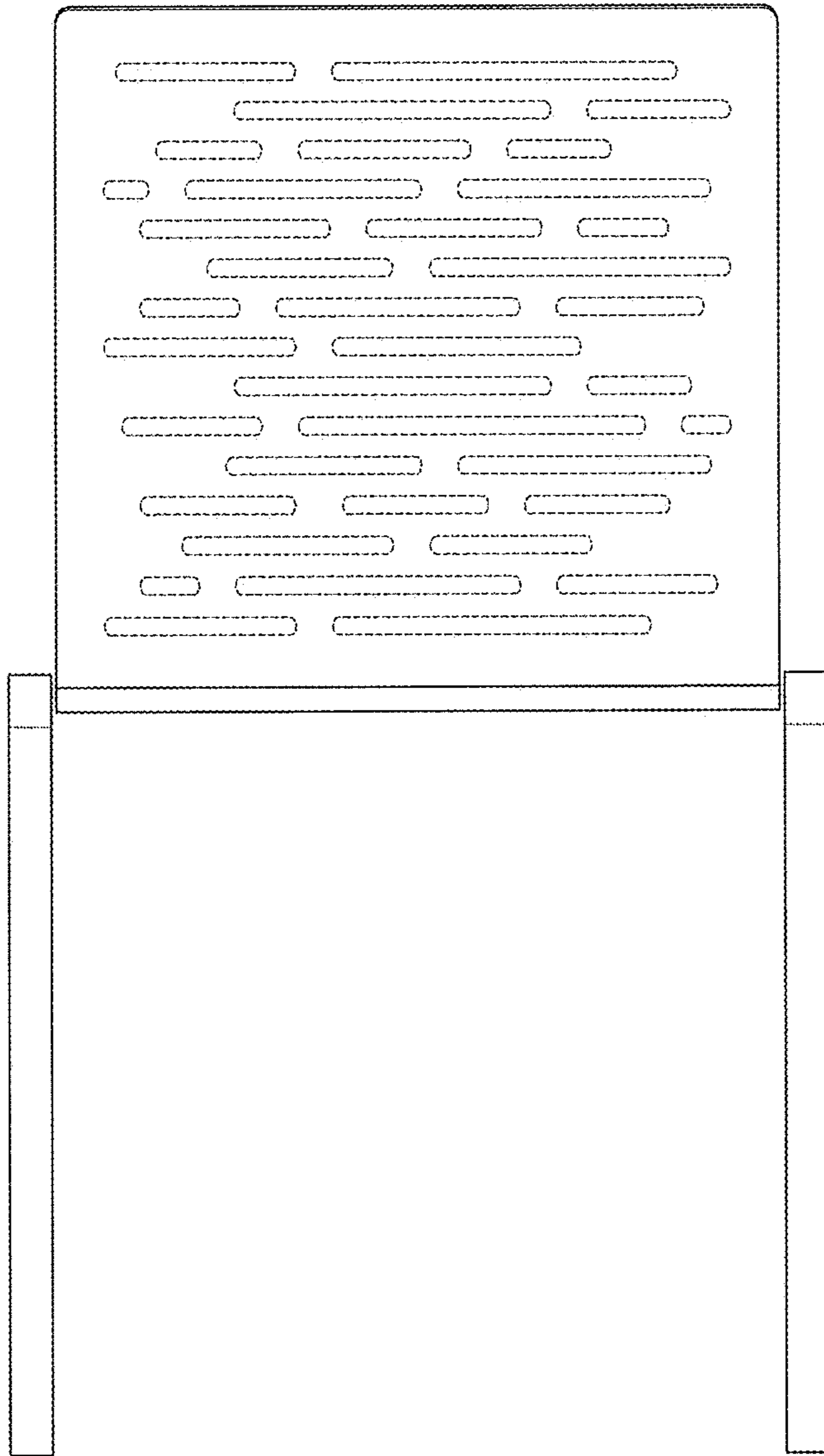

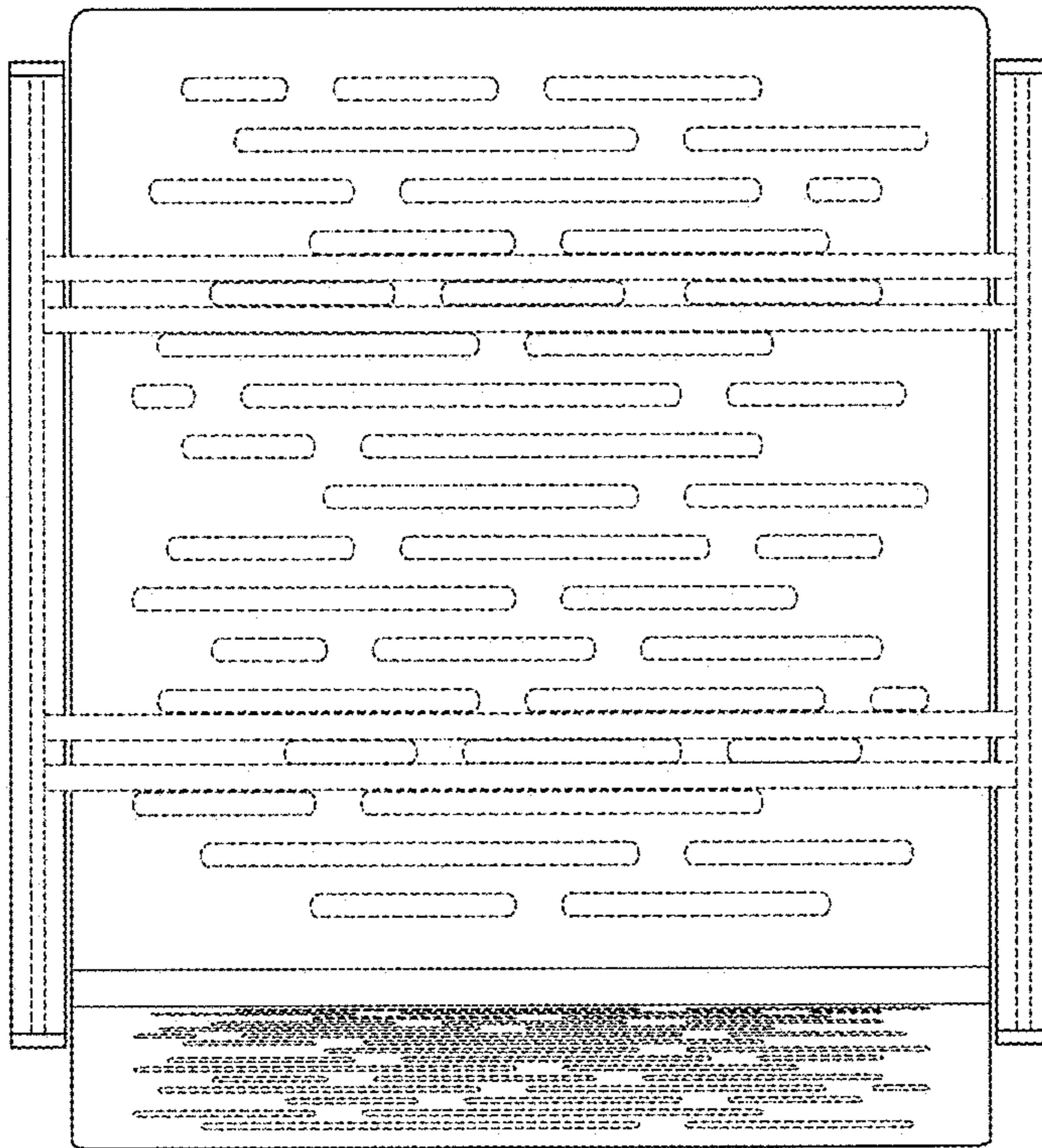

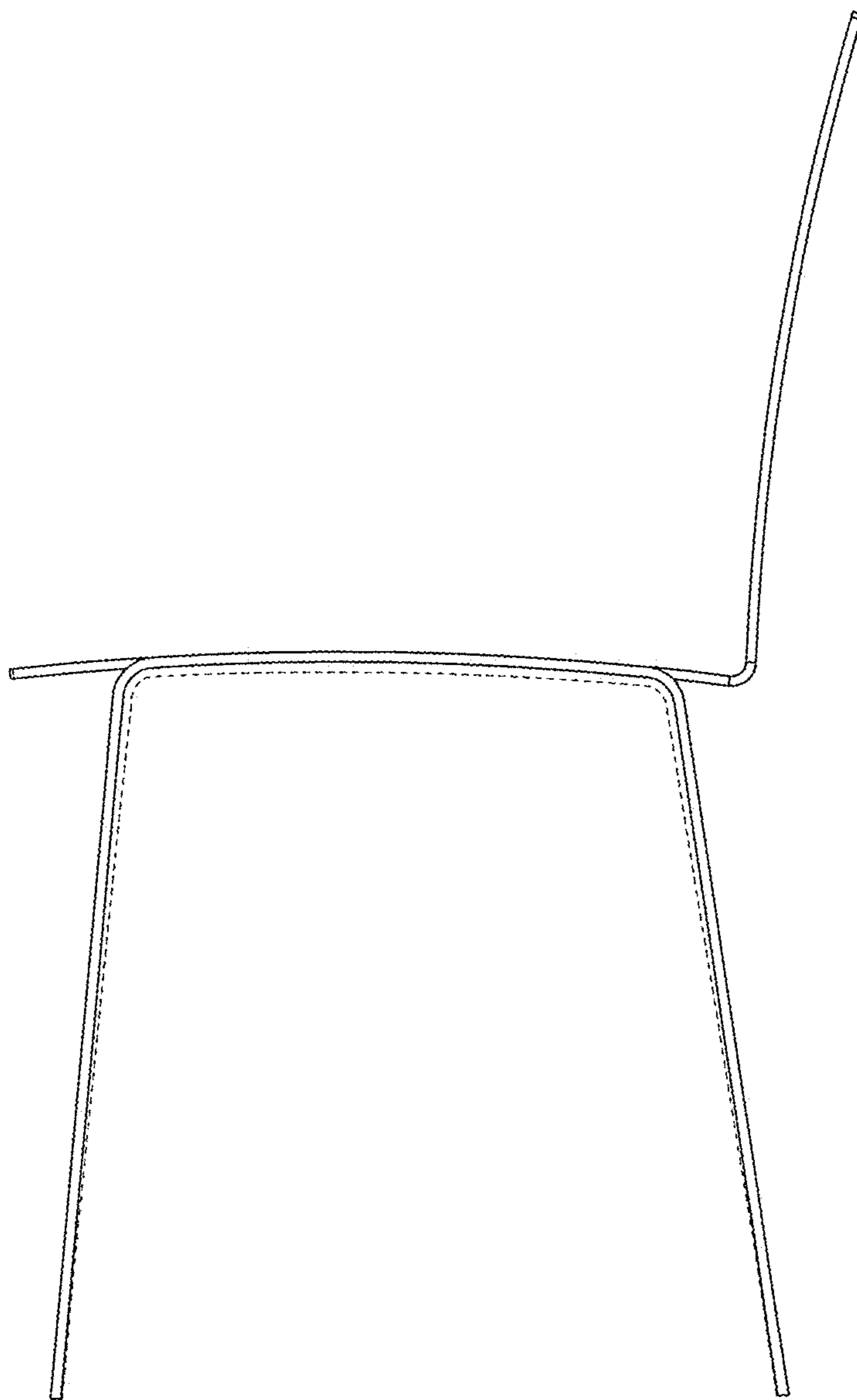

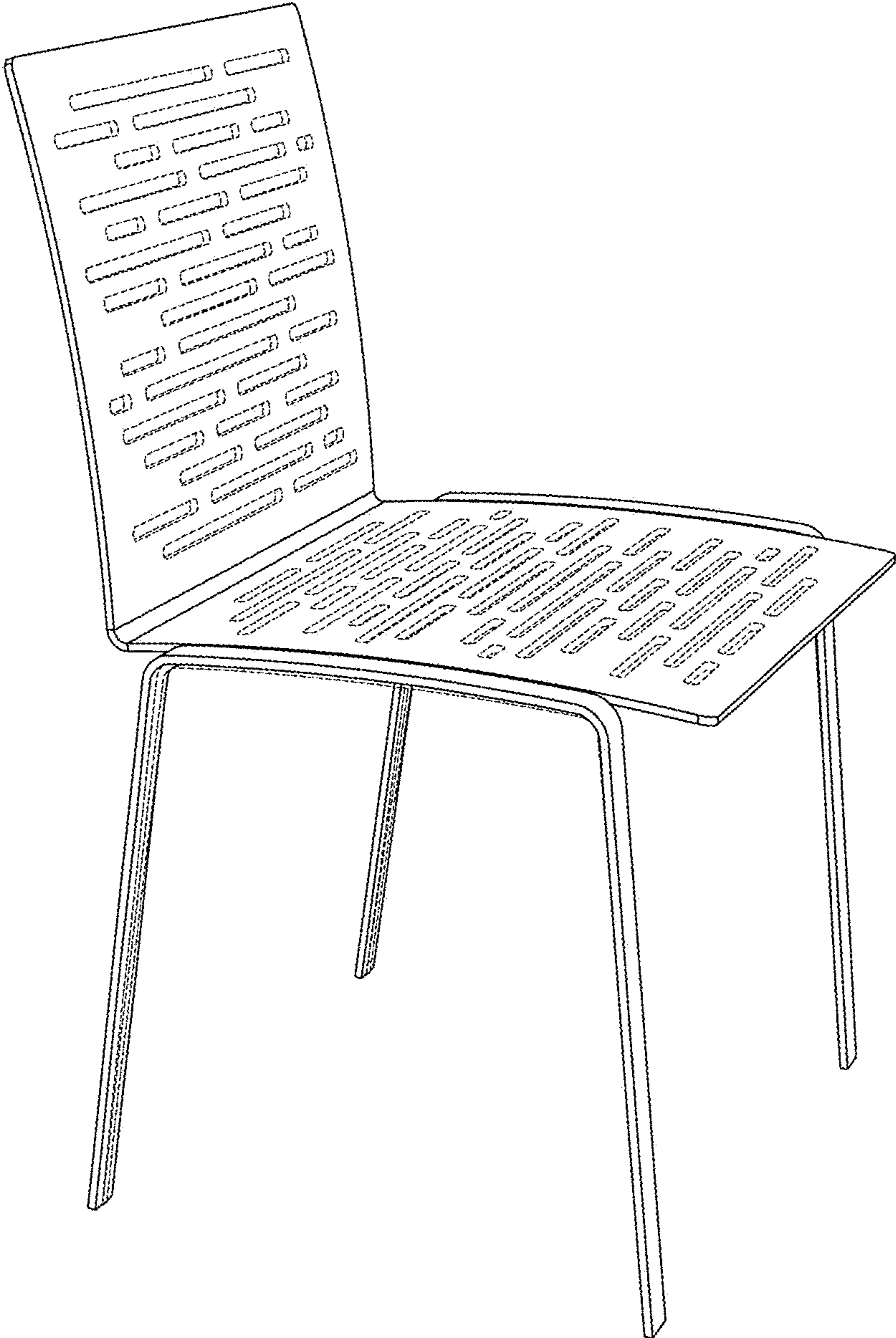
