DESCRIPTION

FIG. 11 is a right view thereof;

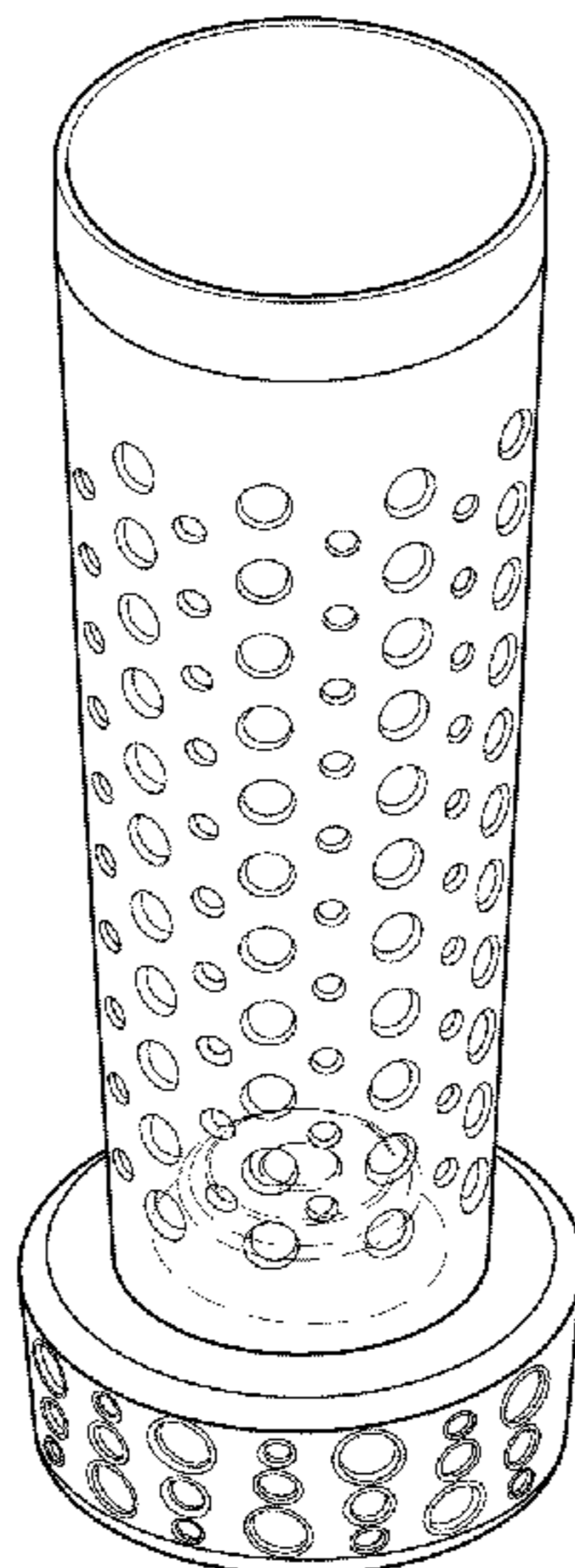
FIG. 12 is a left view thereof;

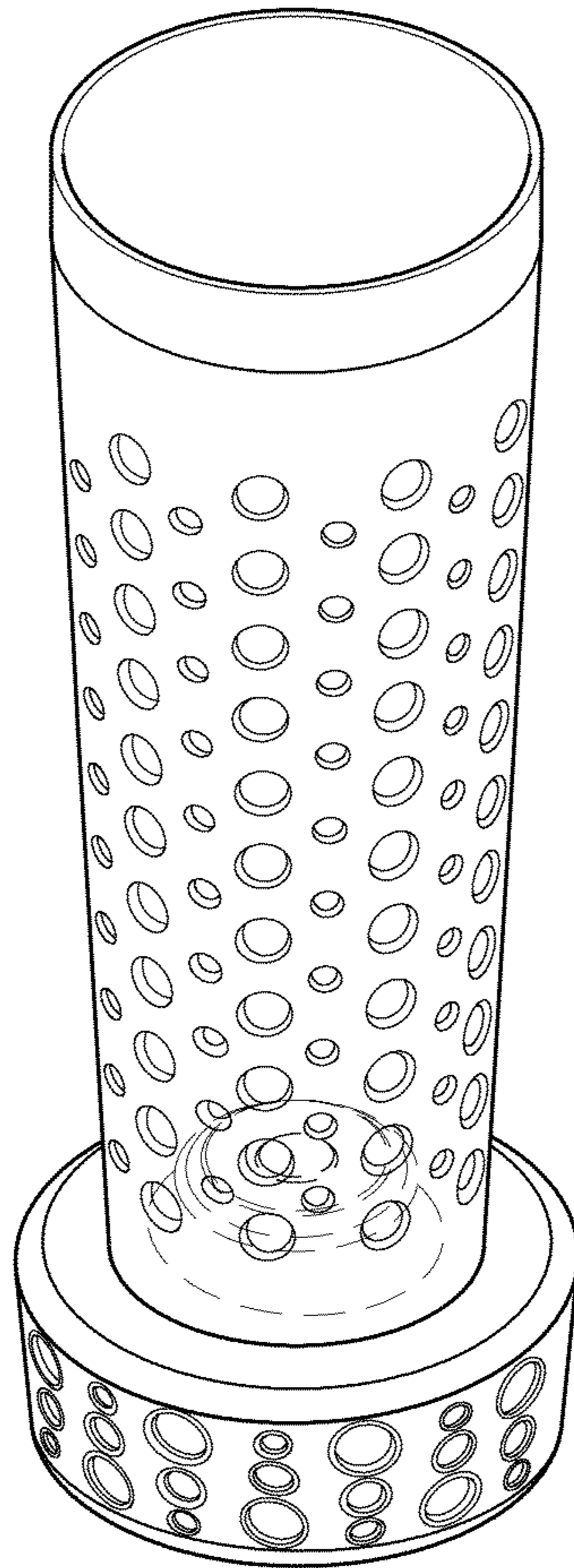

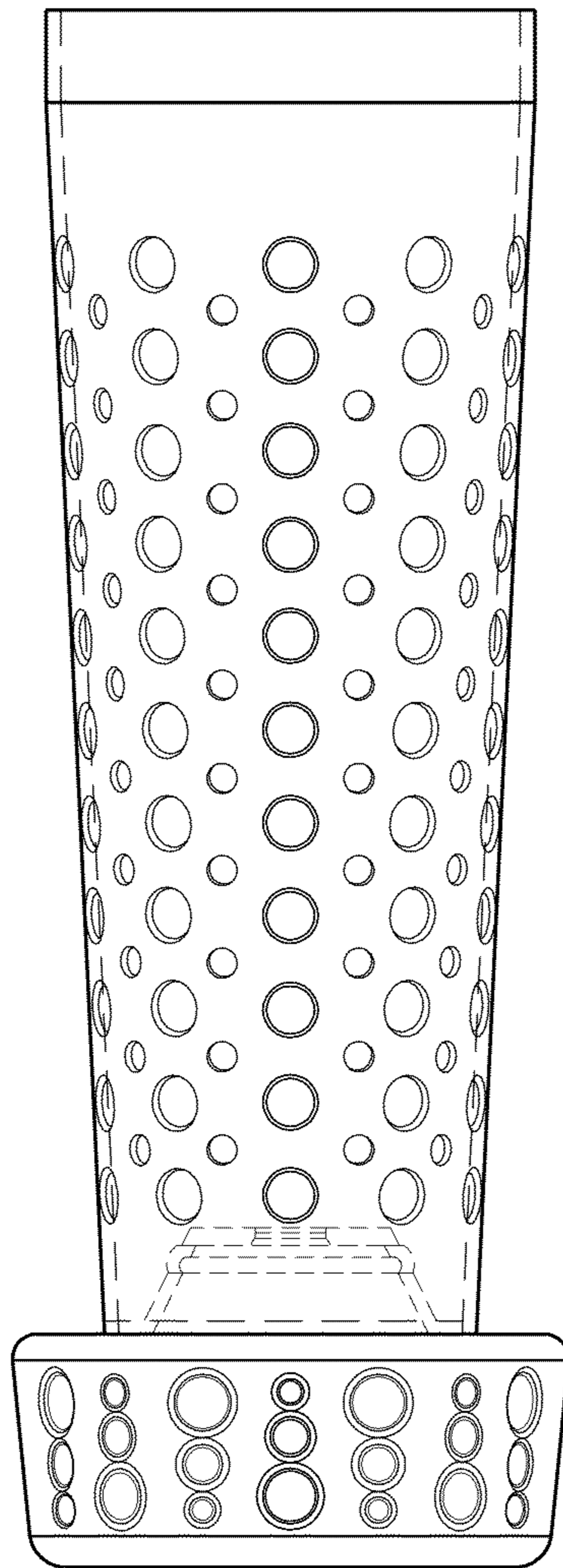

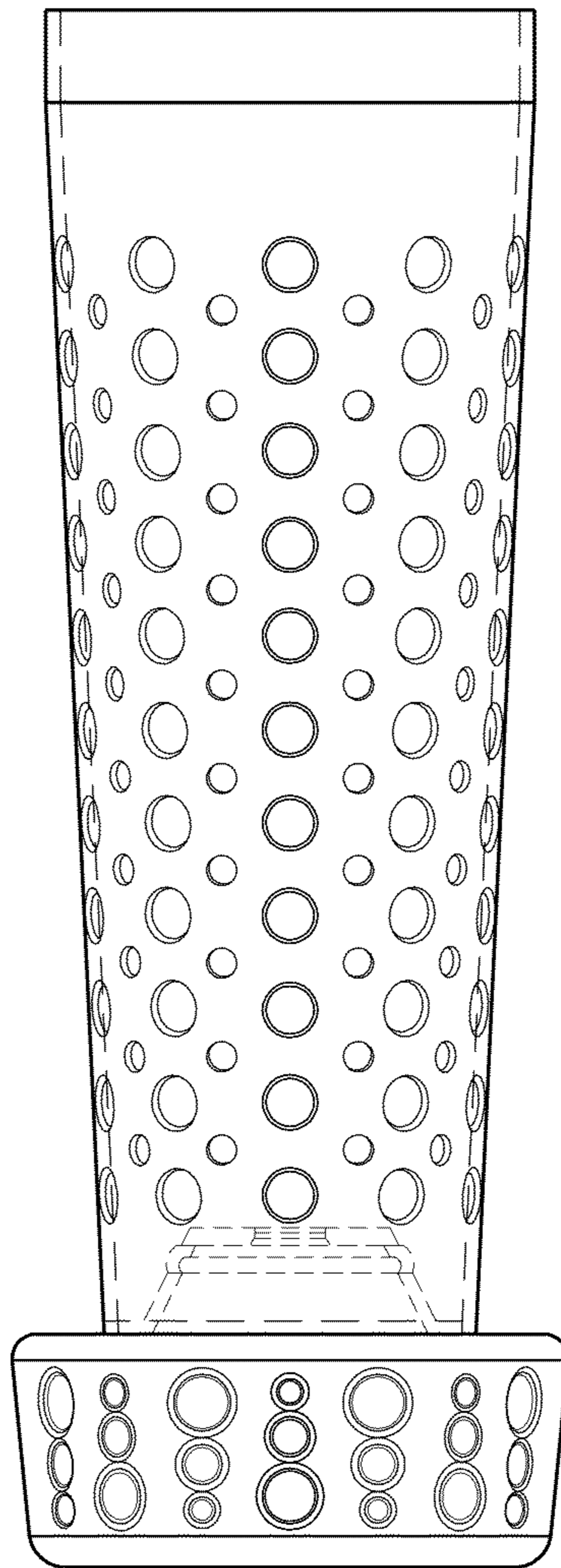

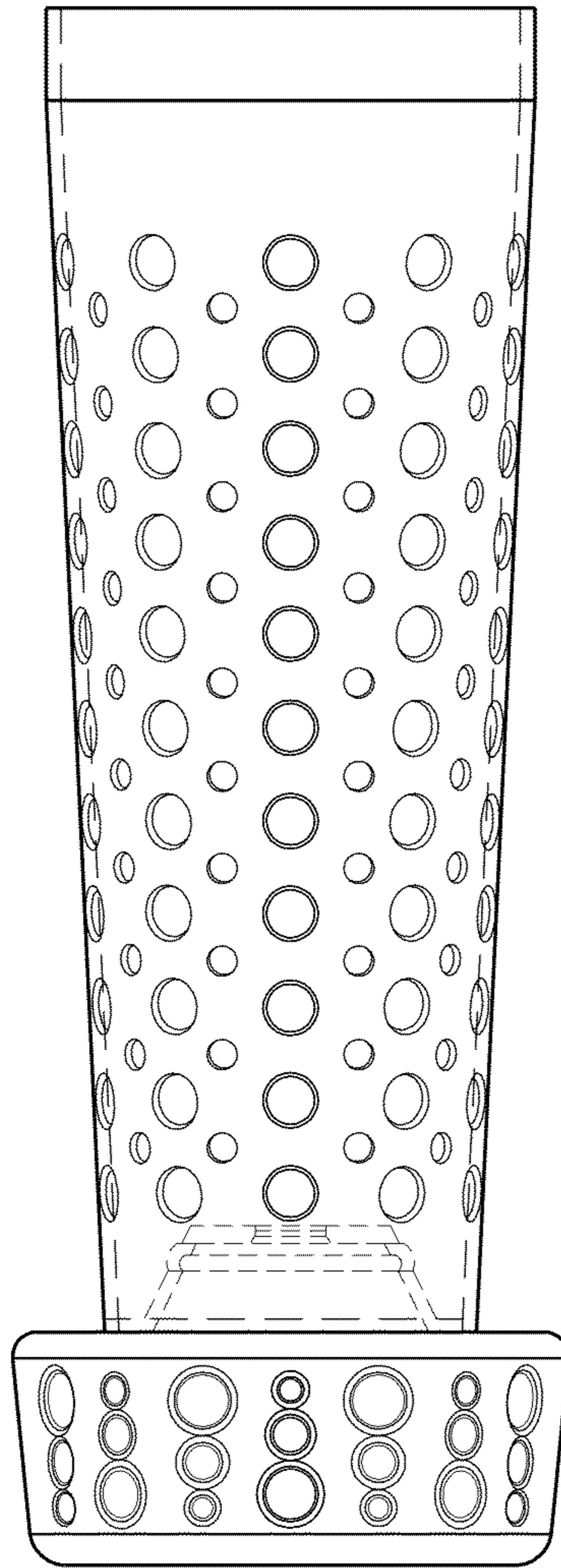

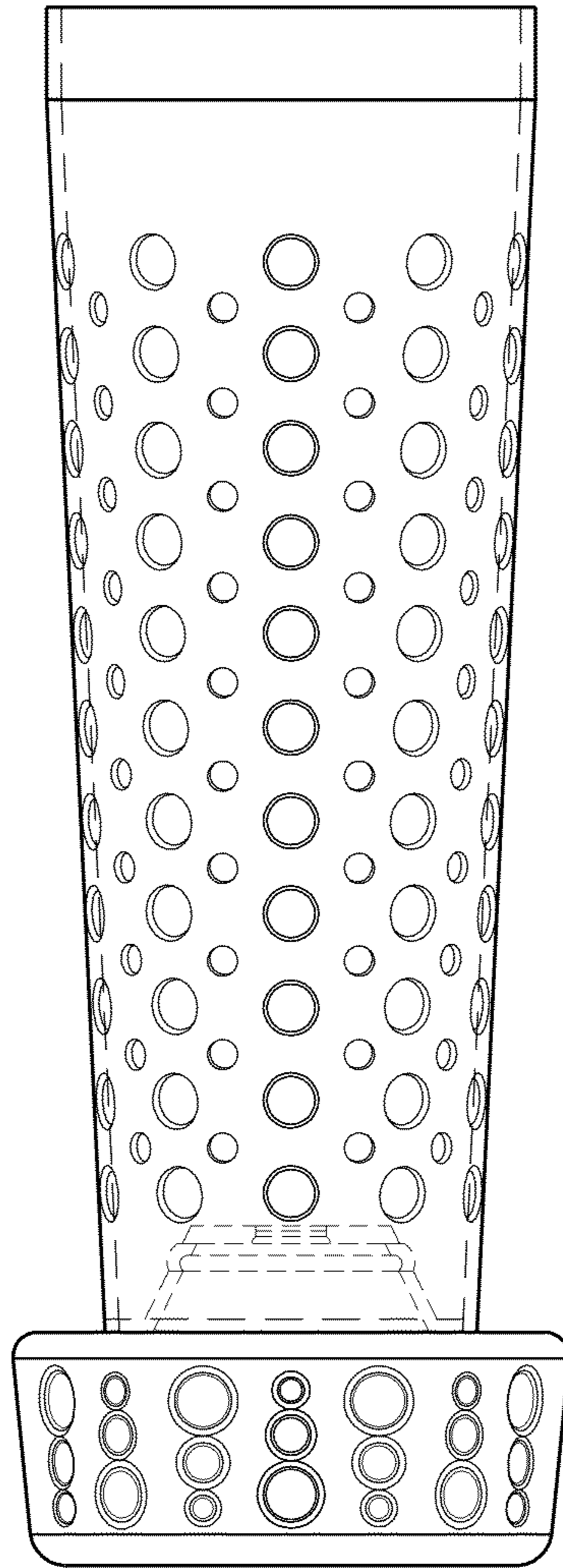

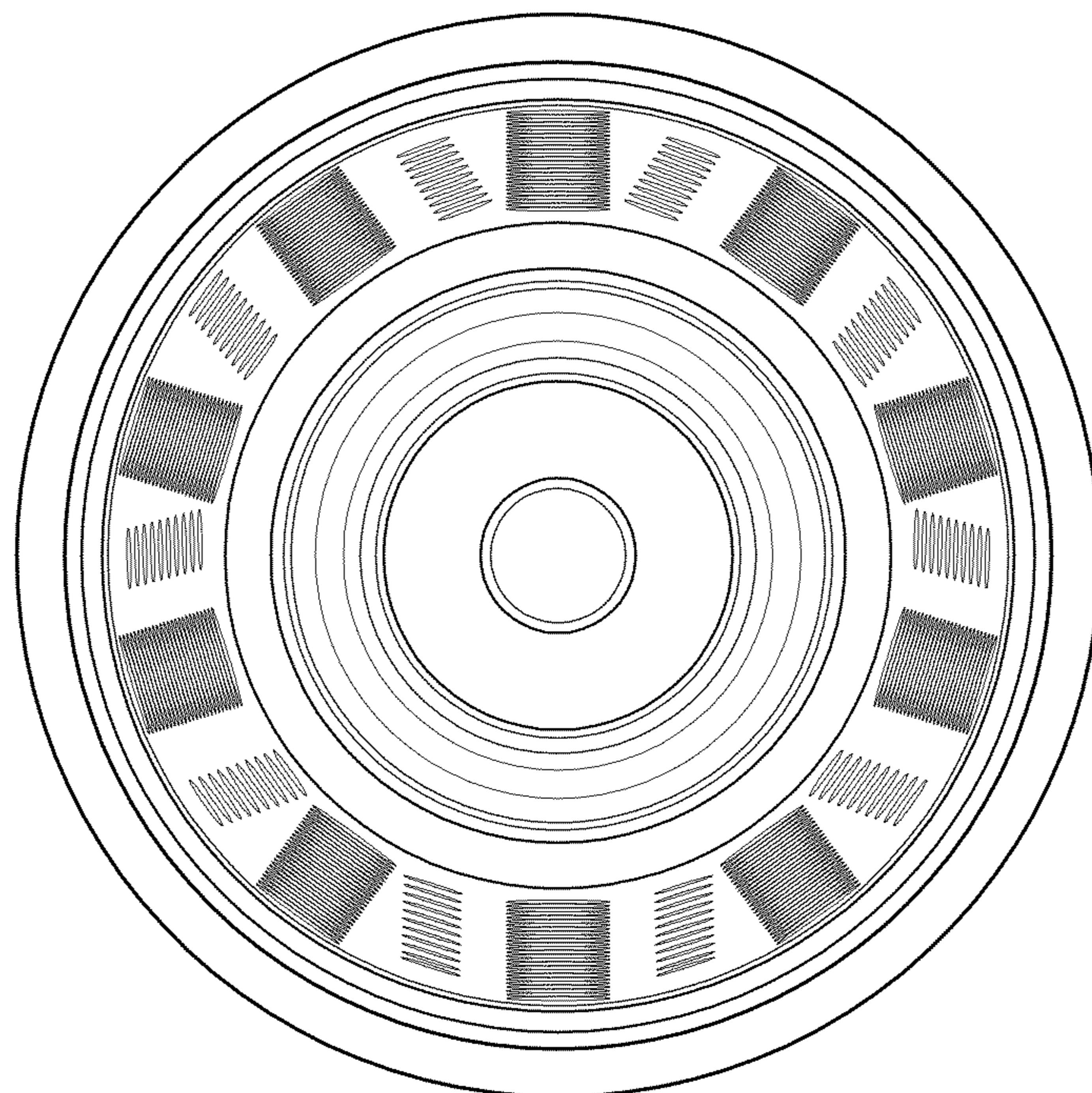

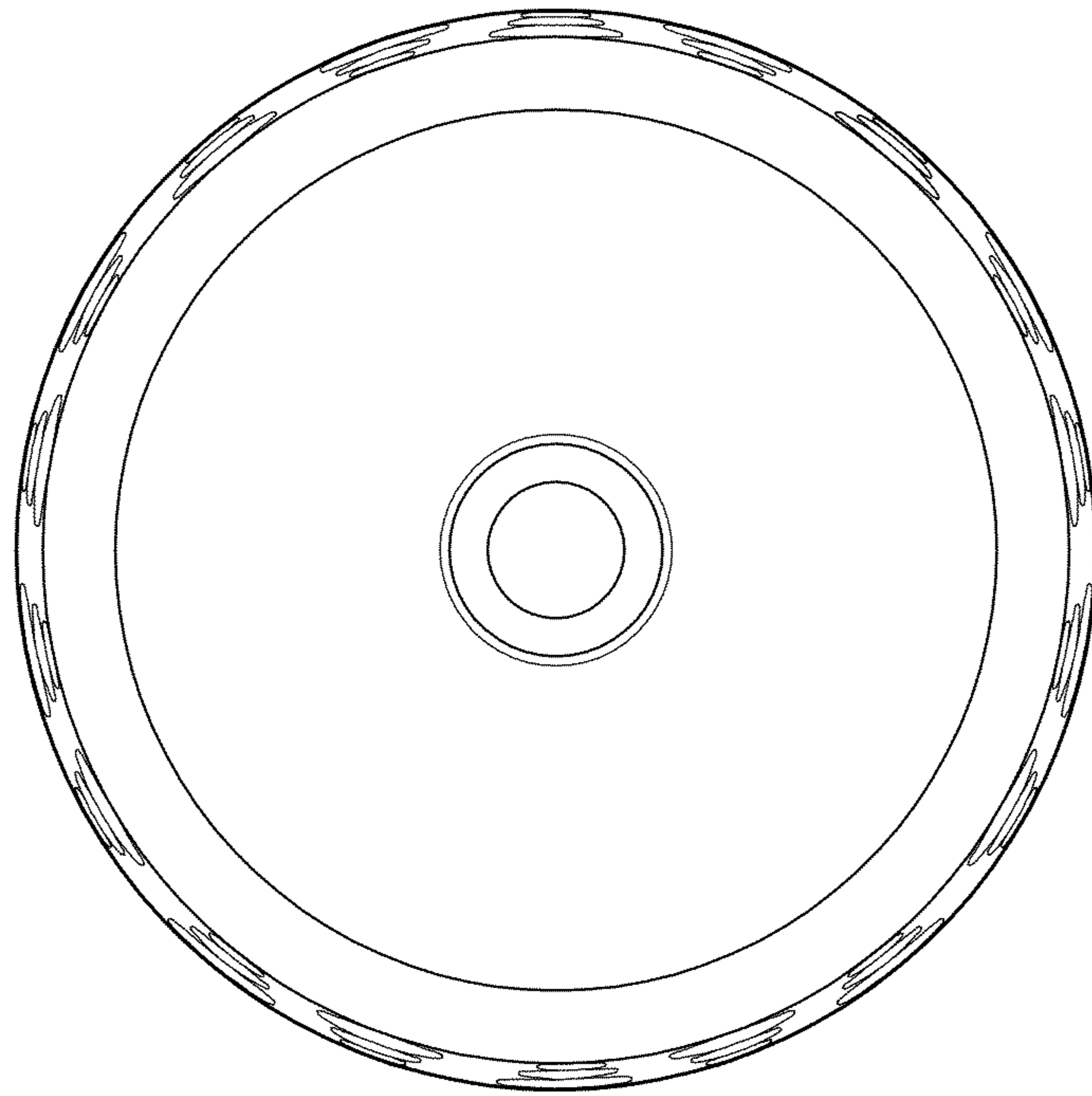

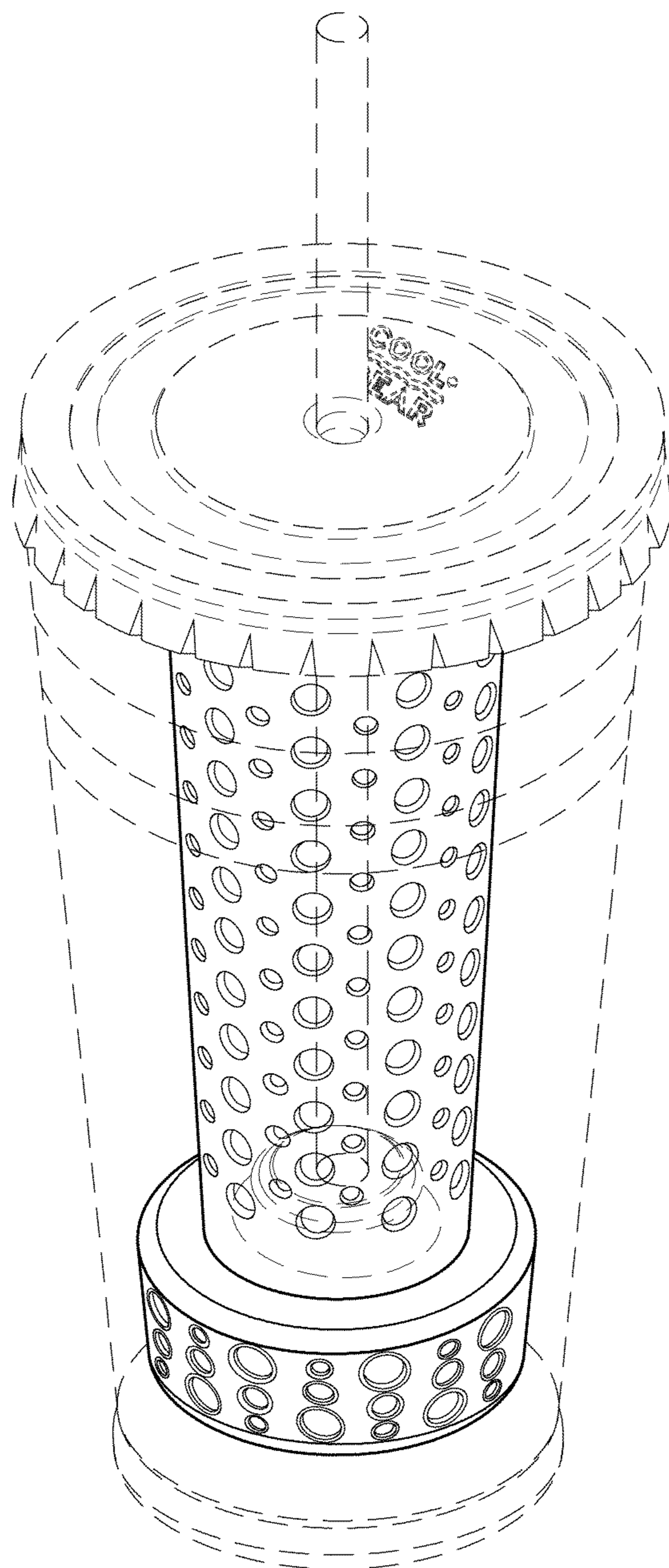

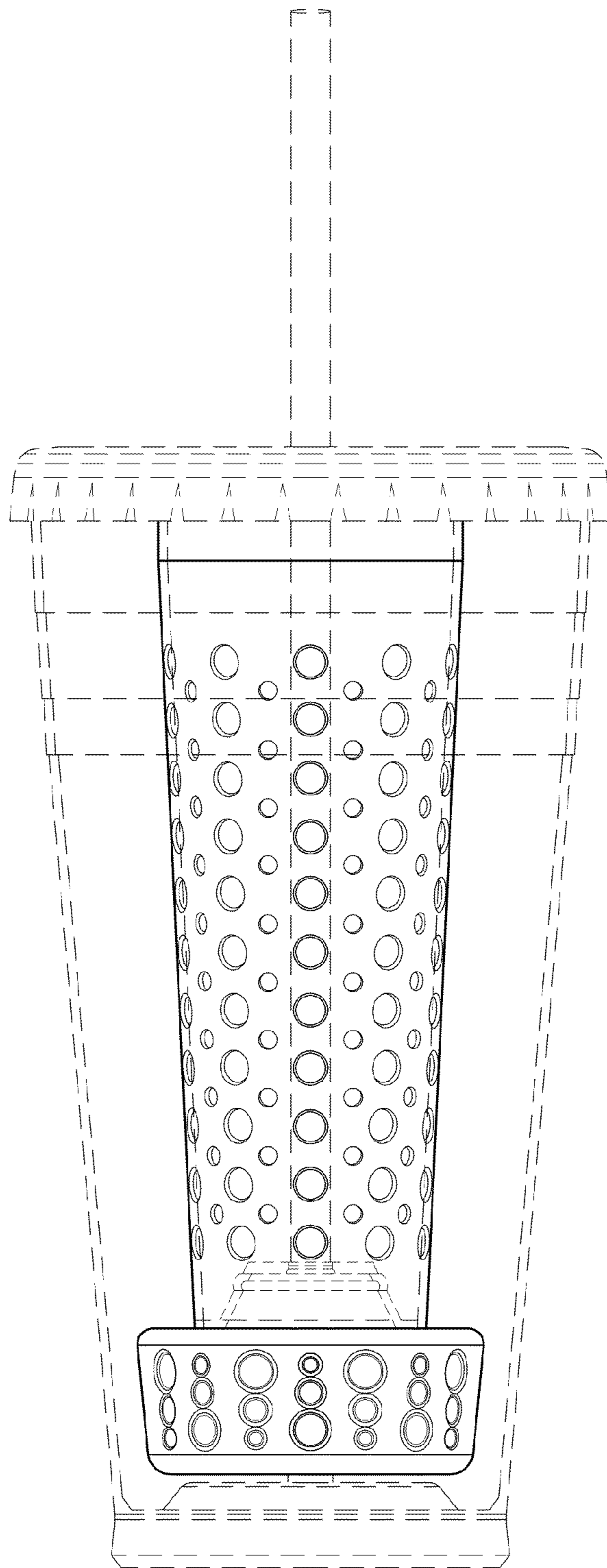

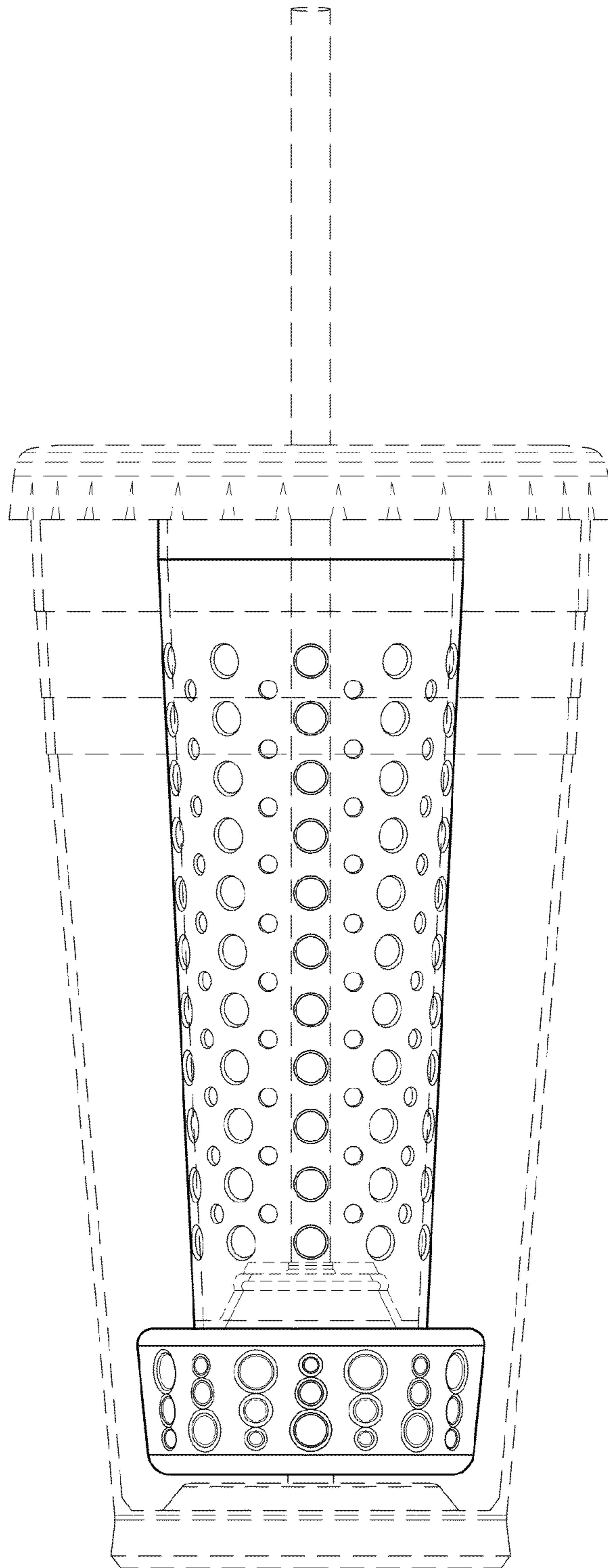

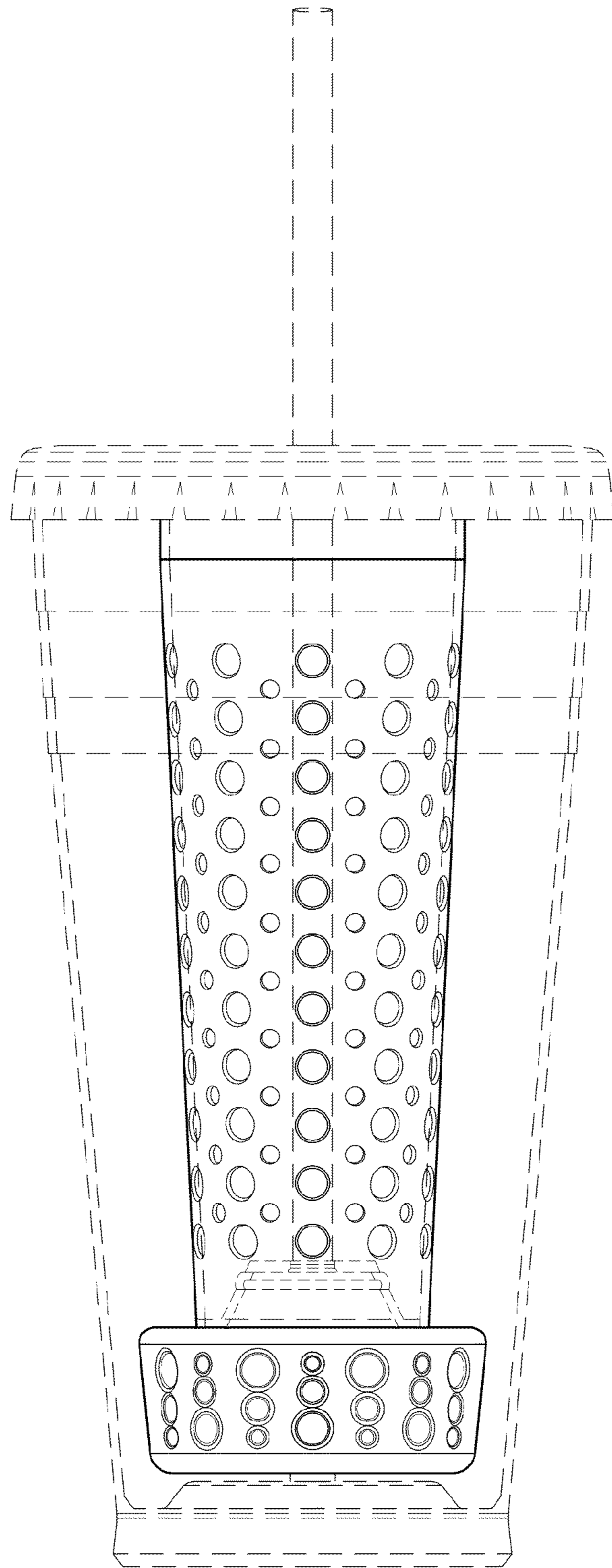

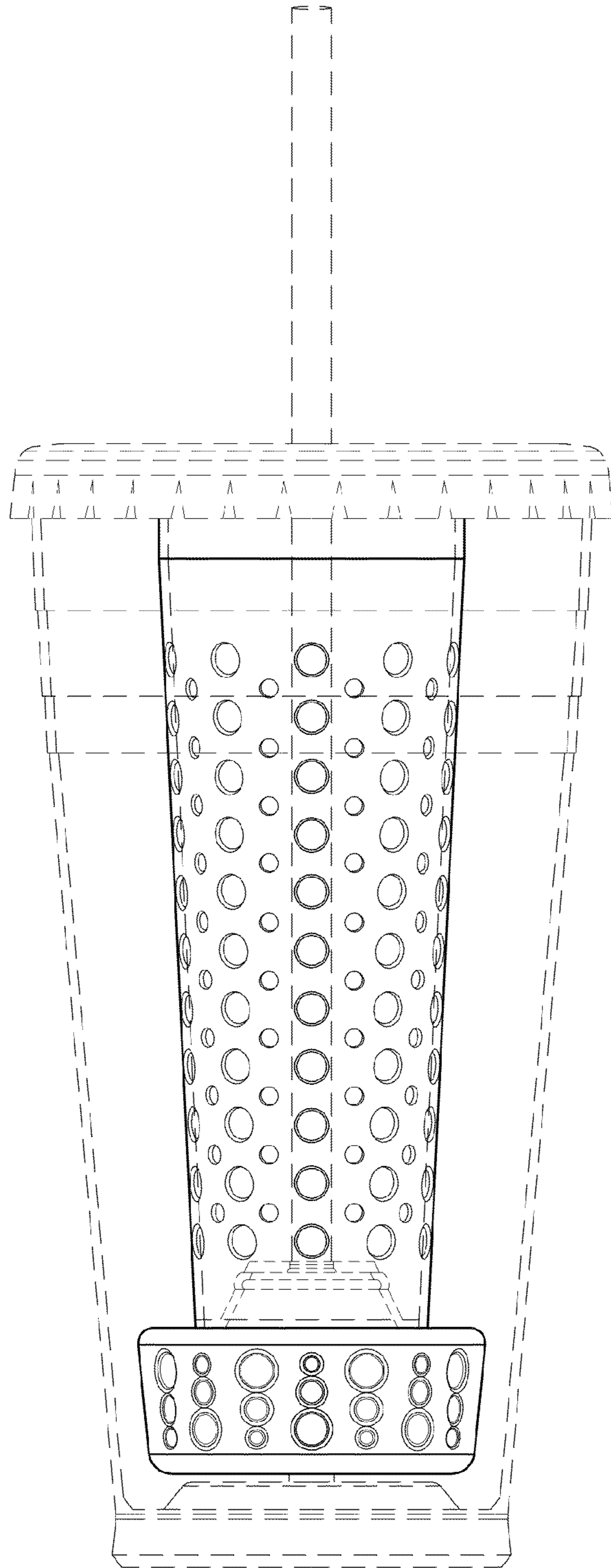

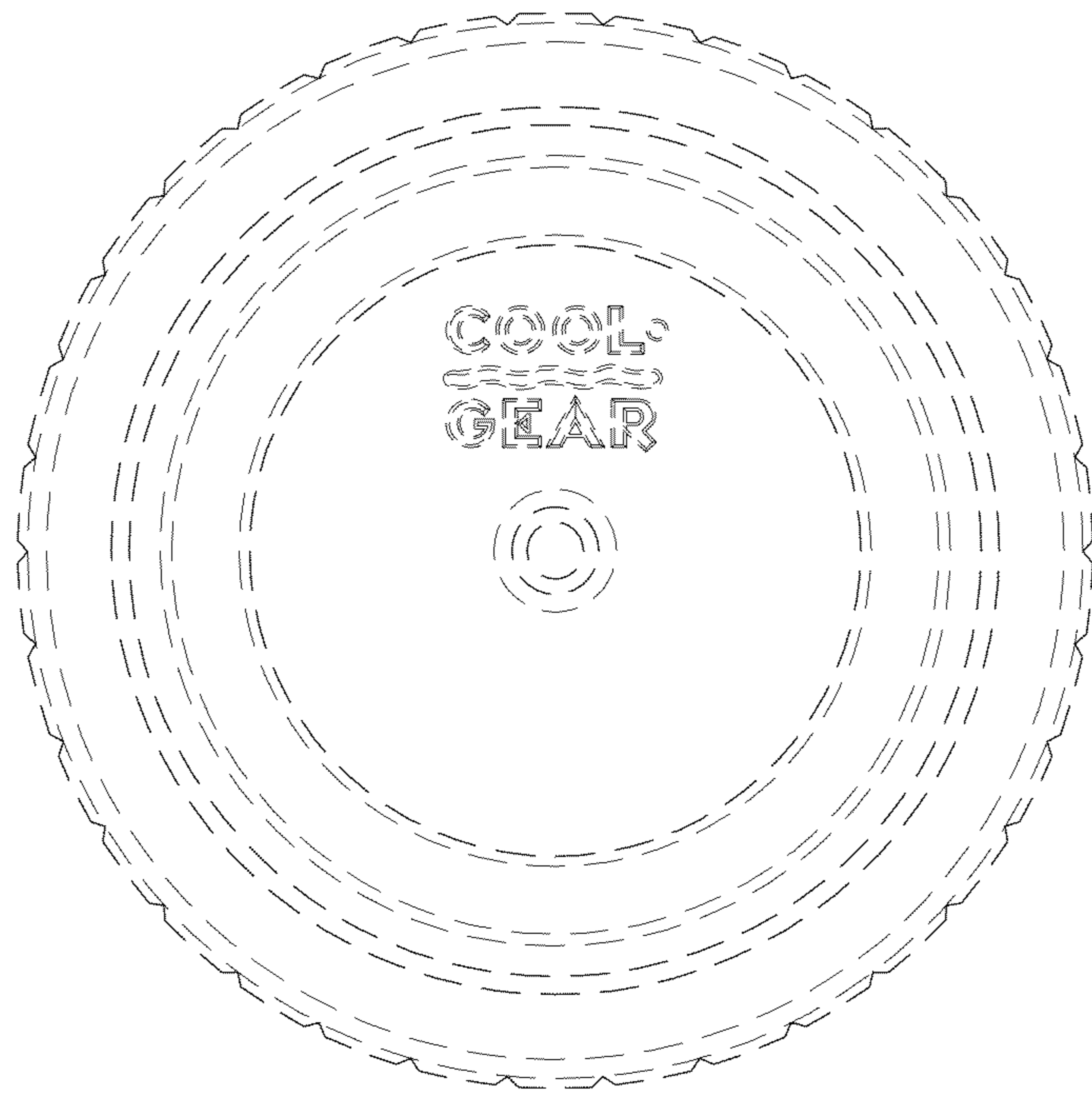

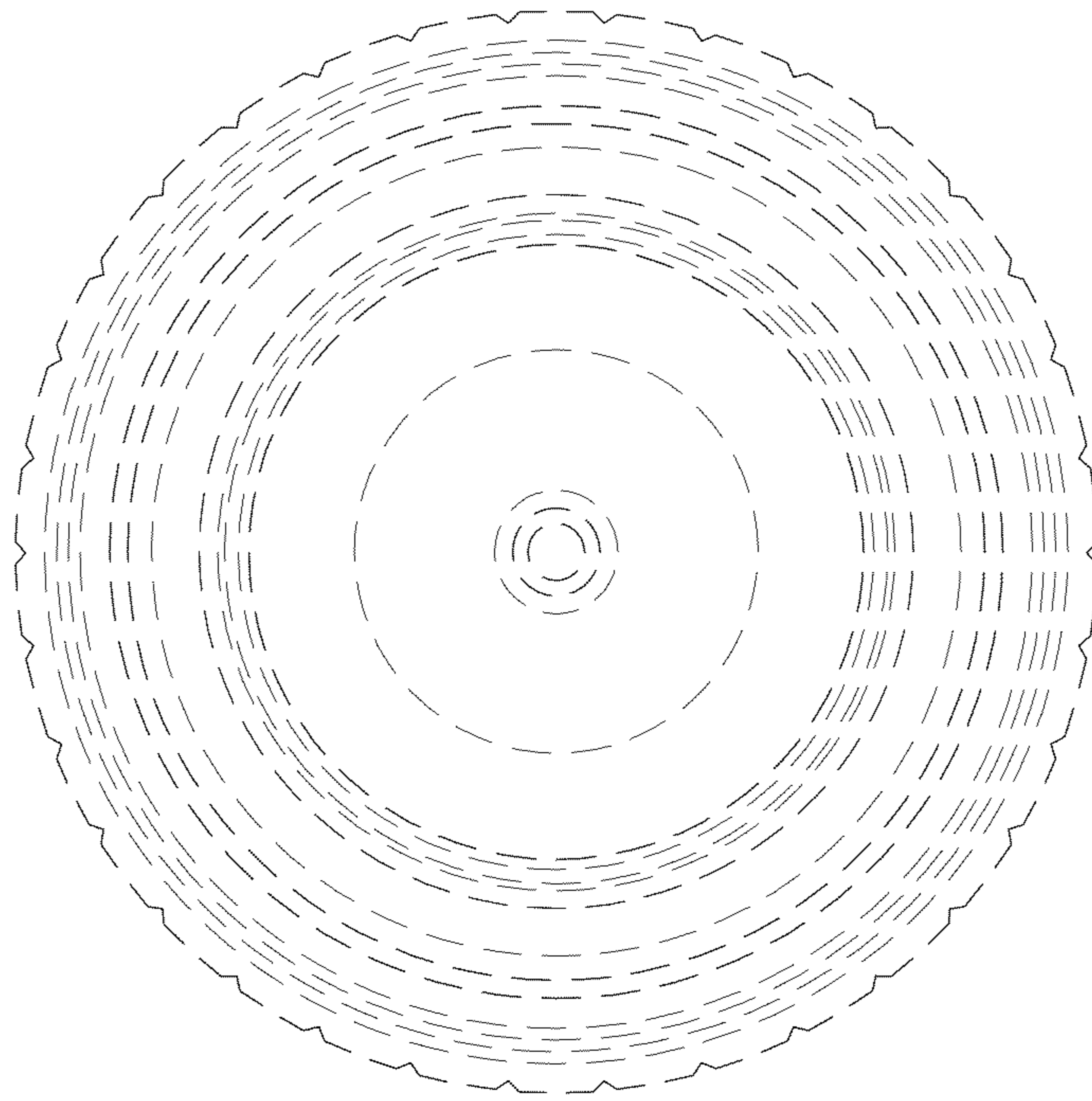
