The ornamental design for a container opener, as shown and described.

**DESCRIPTION**

FIG. 1 is a top view of a container opener showing my new design.

FIG. 2 is a bottom view of the container opener.

FIG. 3 is a left side view of the container opener, the right side view being identical thereto.

FIG. 4 is a front view of the container opener, the back view being identical thereto; and,

FIG. 5 is a cross-sectional view taken along line 5-5 of FIG. 1.

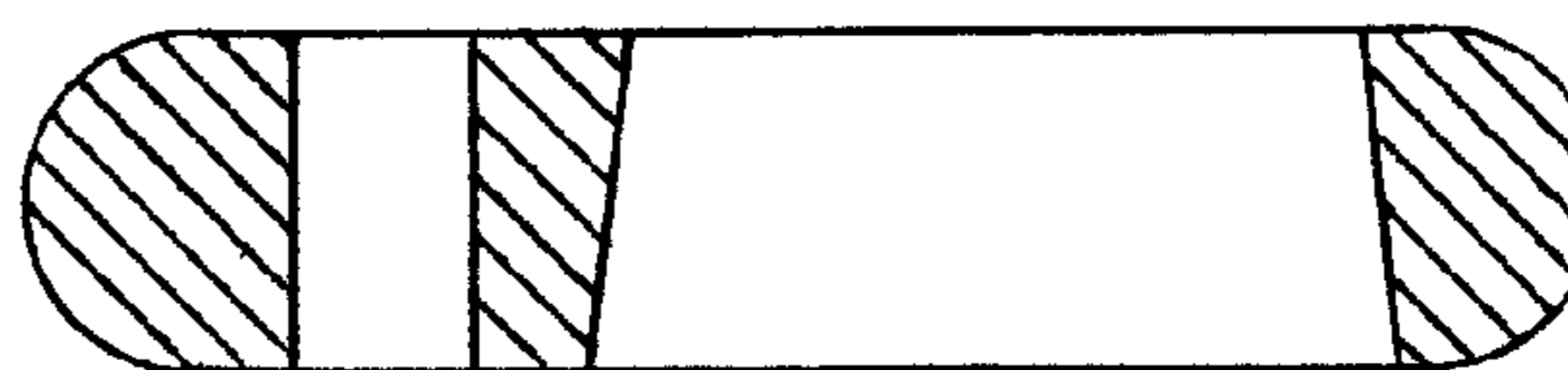
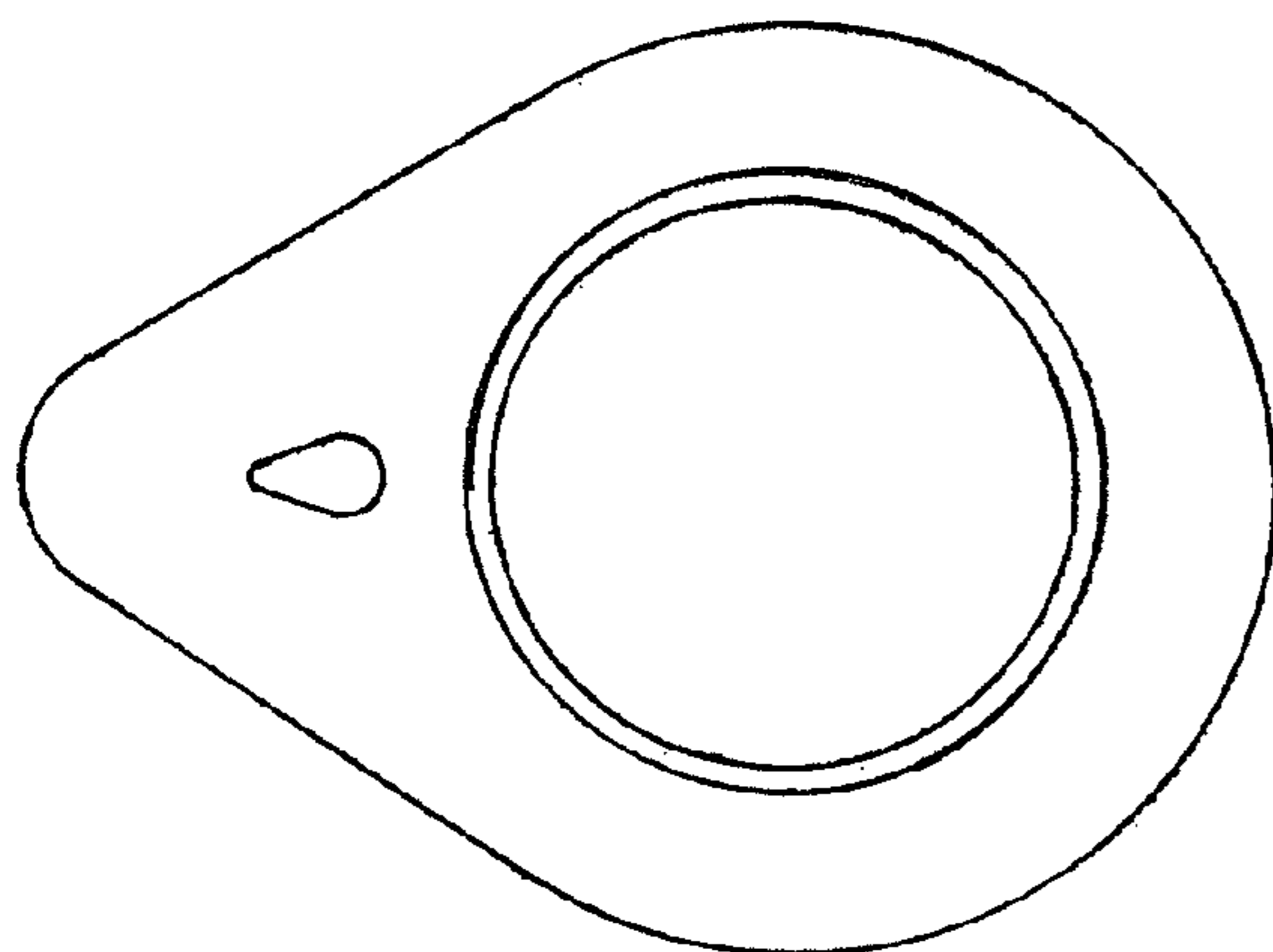

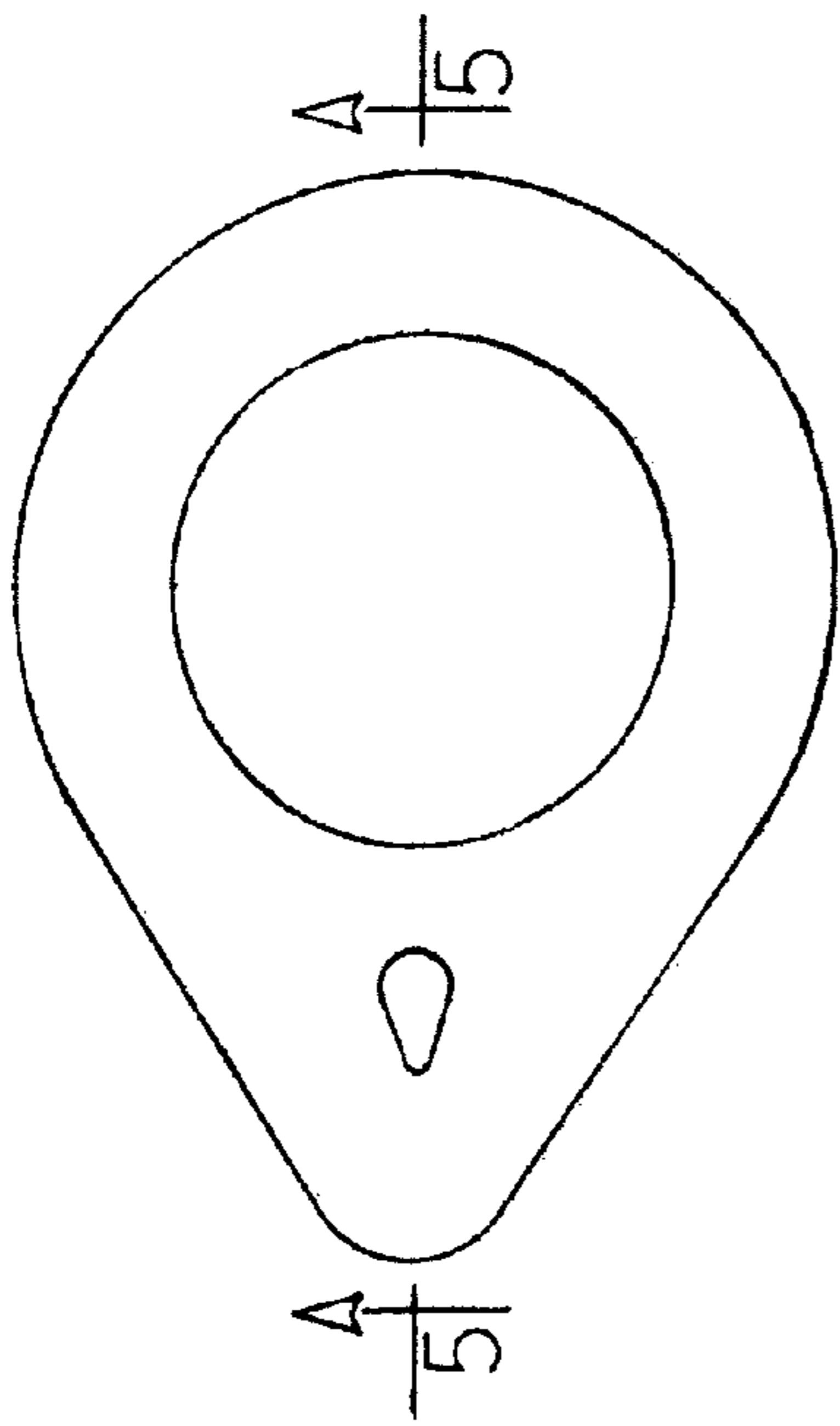

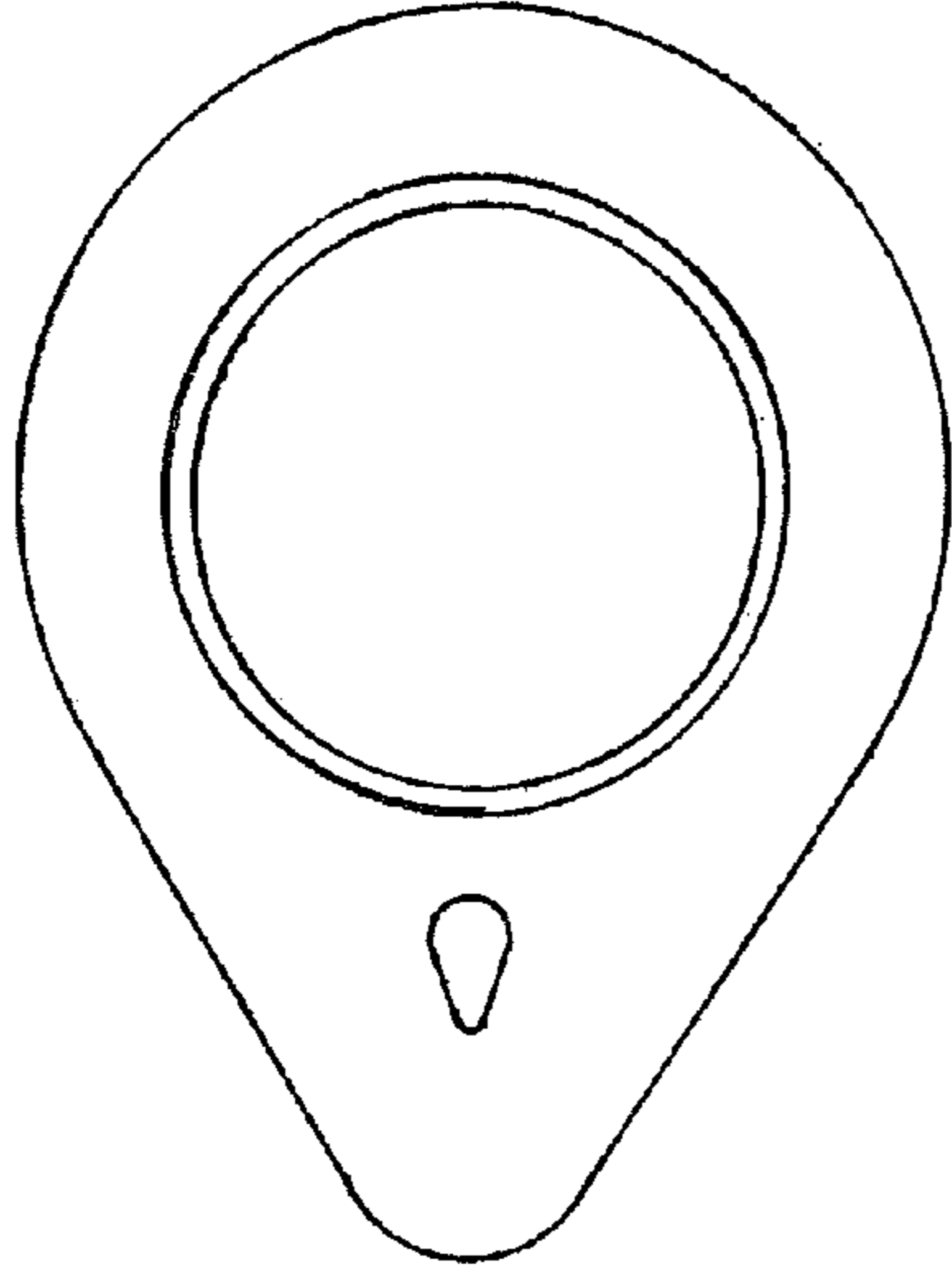

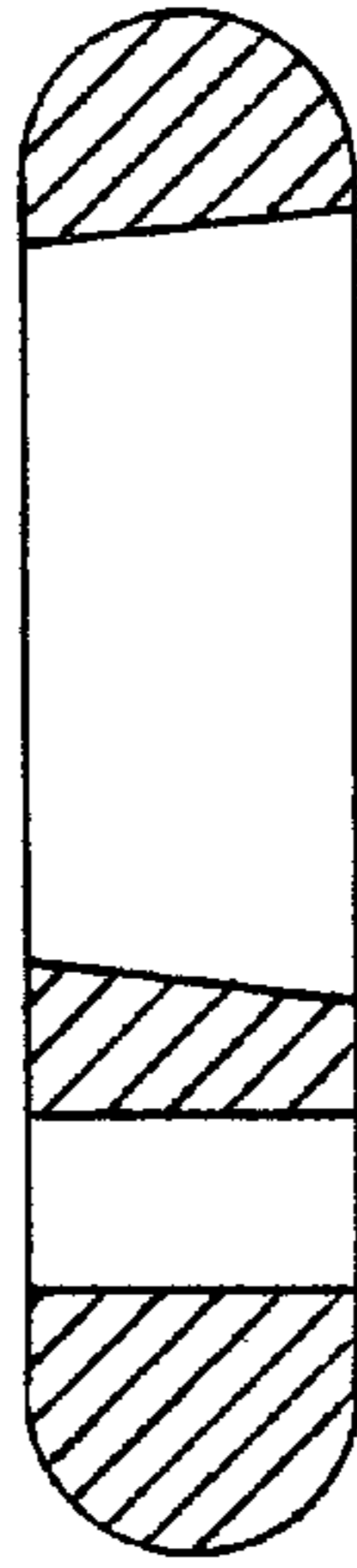
