FIG. 4 is a front elevation view thereof;

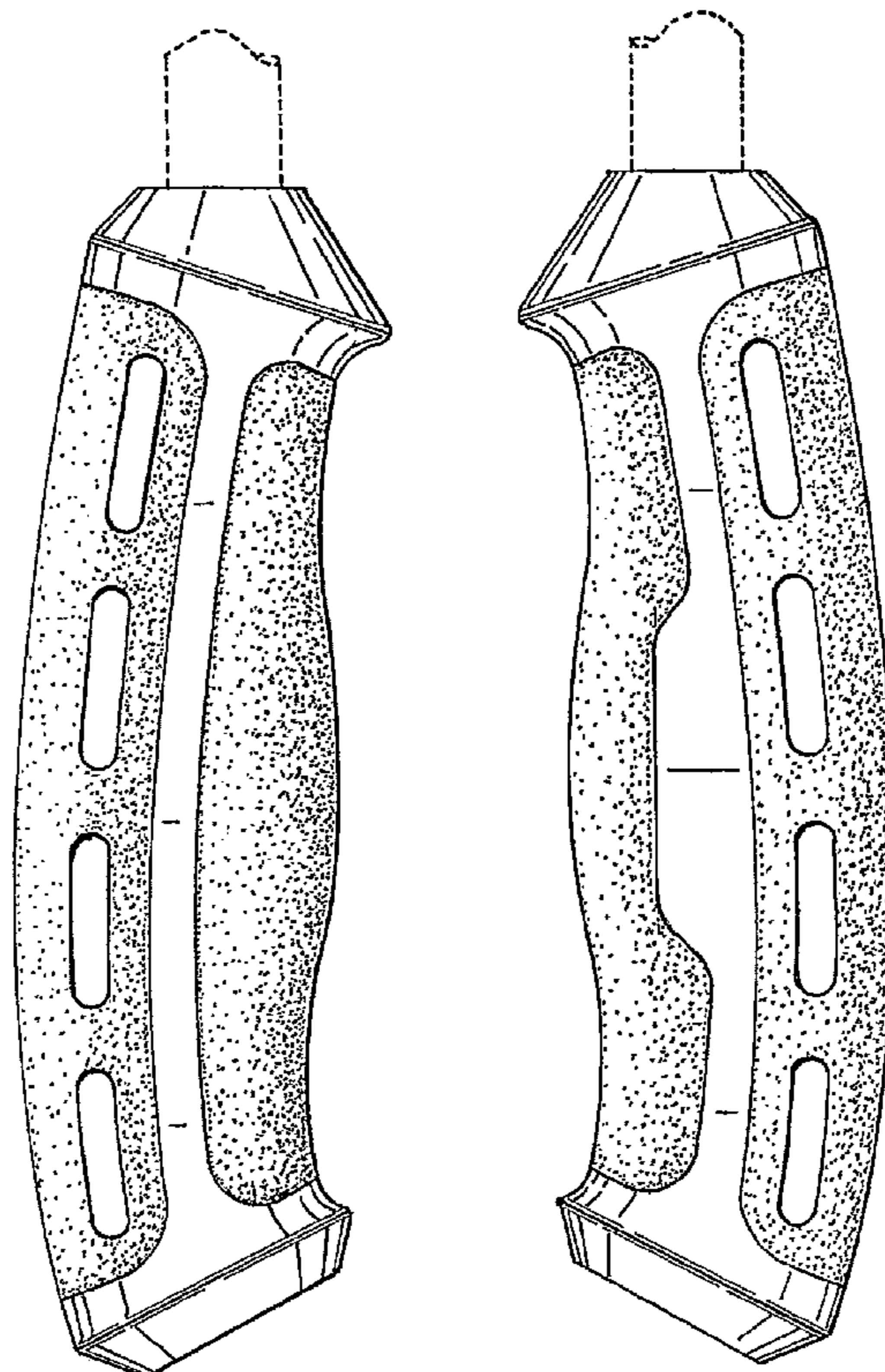
FIG. 5 is a right side elevation view thereof;

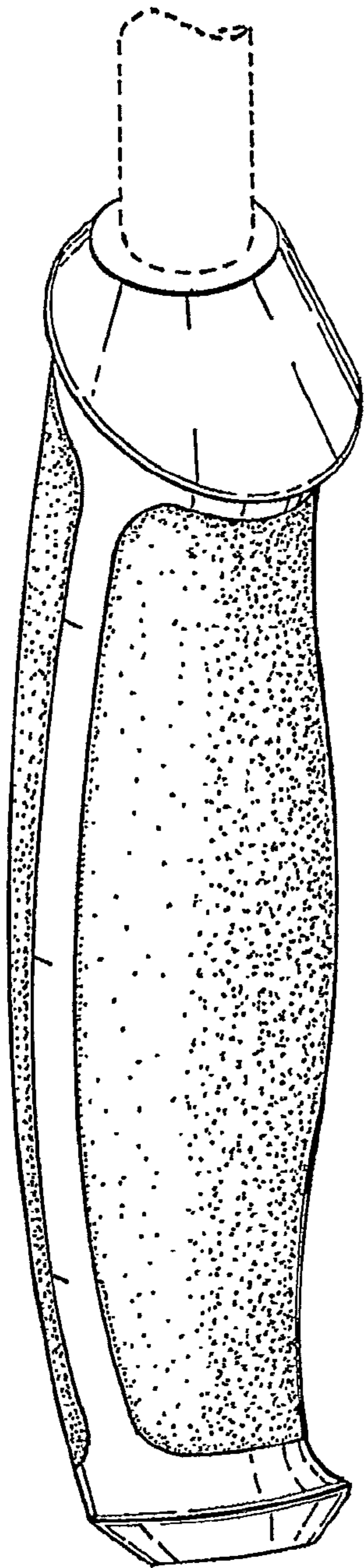
FIG. 6 is a top plan view thereof; and,

The broken line showing of a partial shaft for attachment to an object, such as an umbrella, is for illustrative purposes only and forms no part of the claimed design.

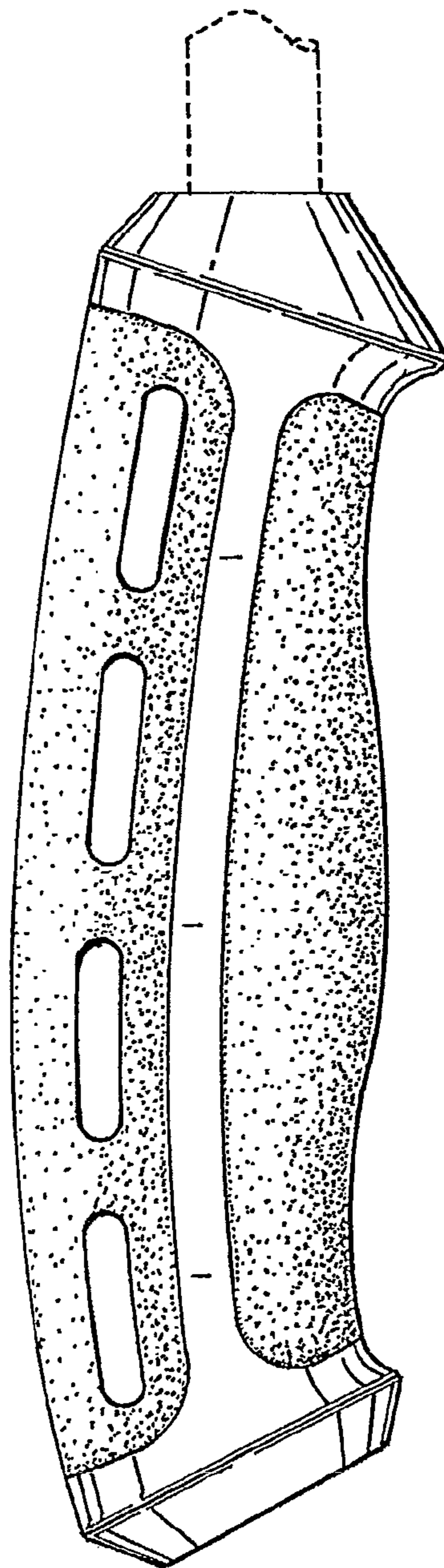

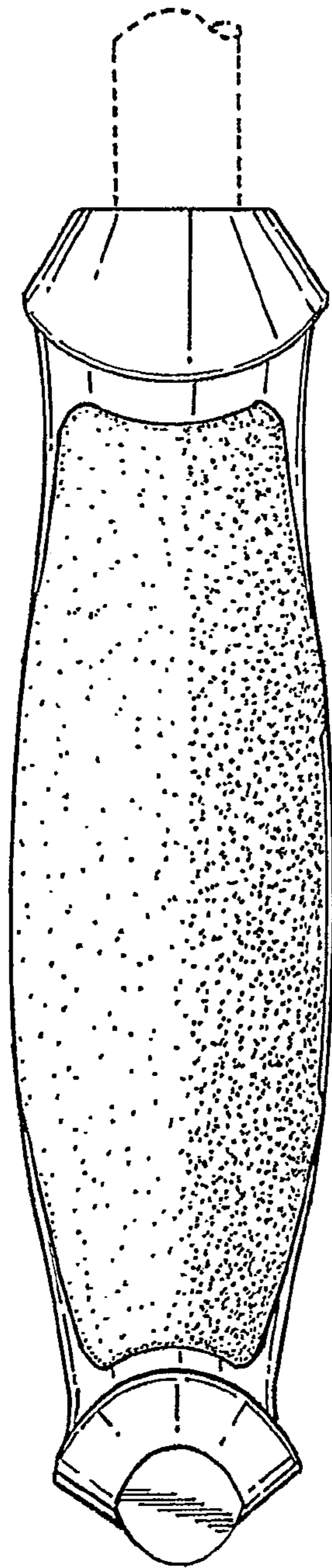

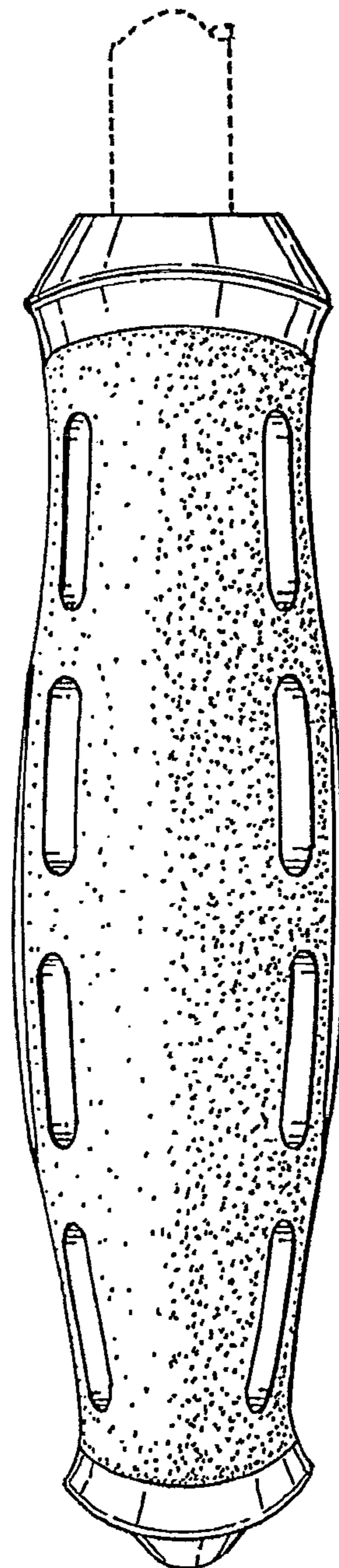

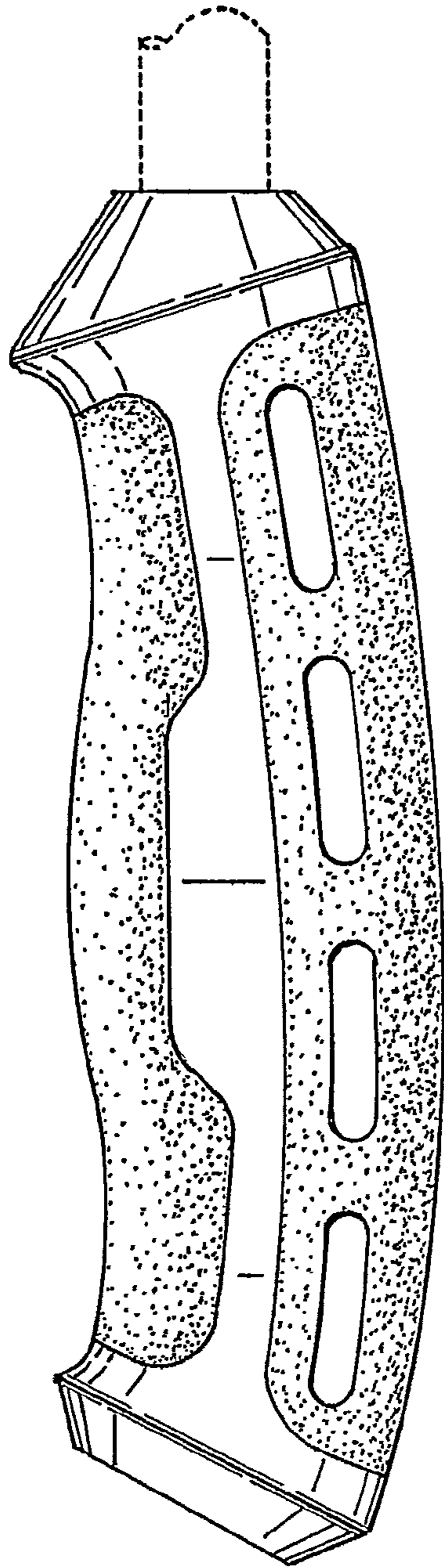




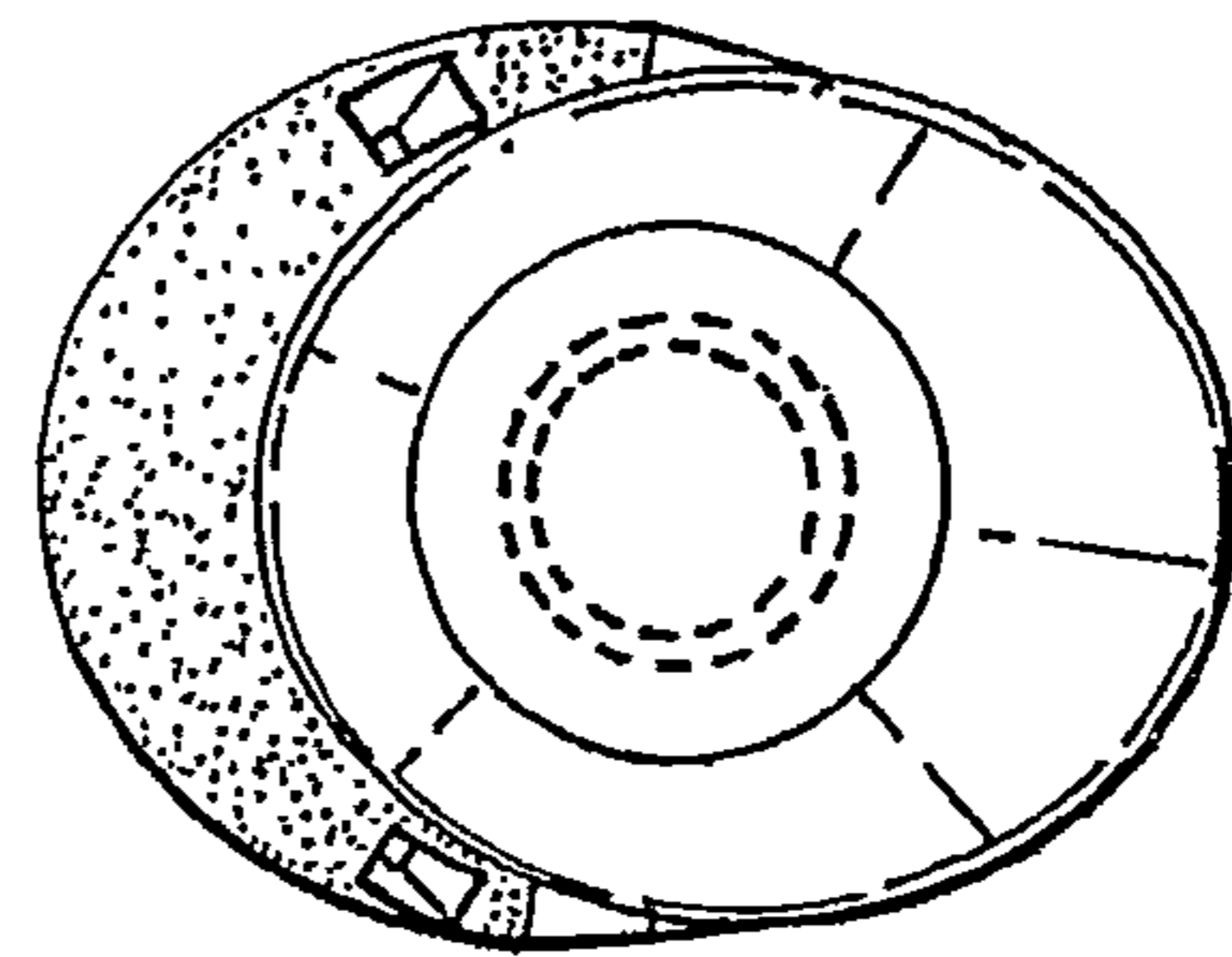

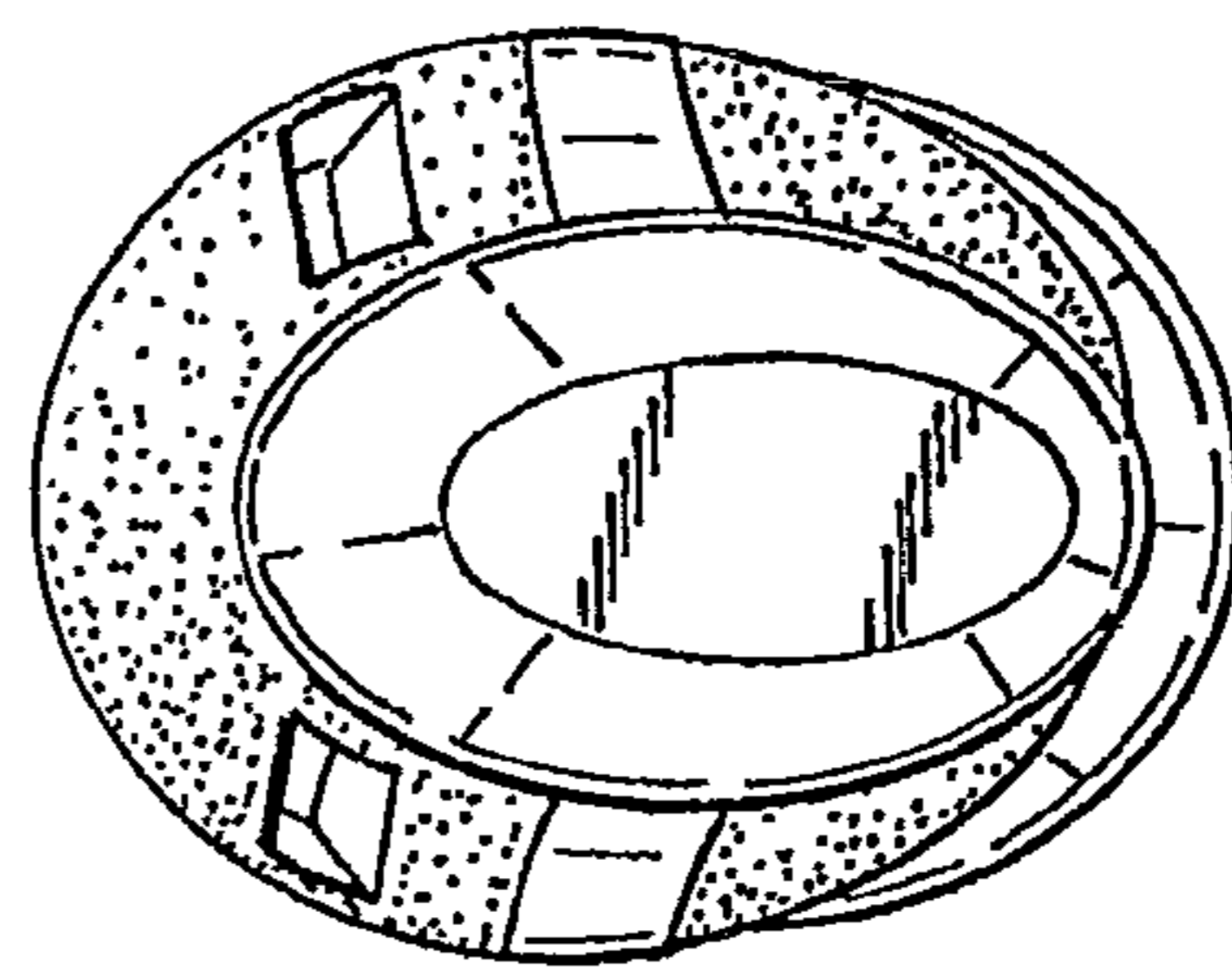
