FIG. 1 is a top plan view of the container of the claimed design;

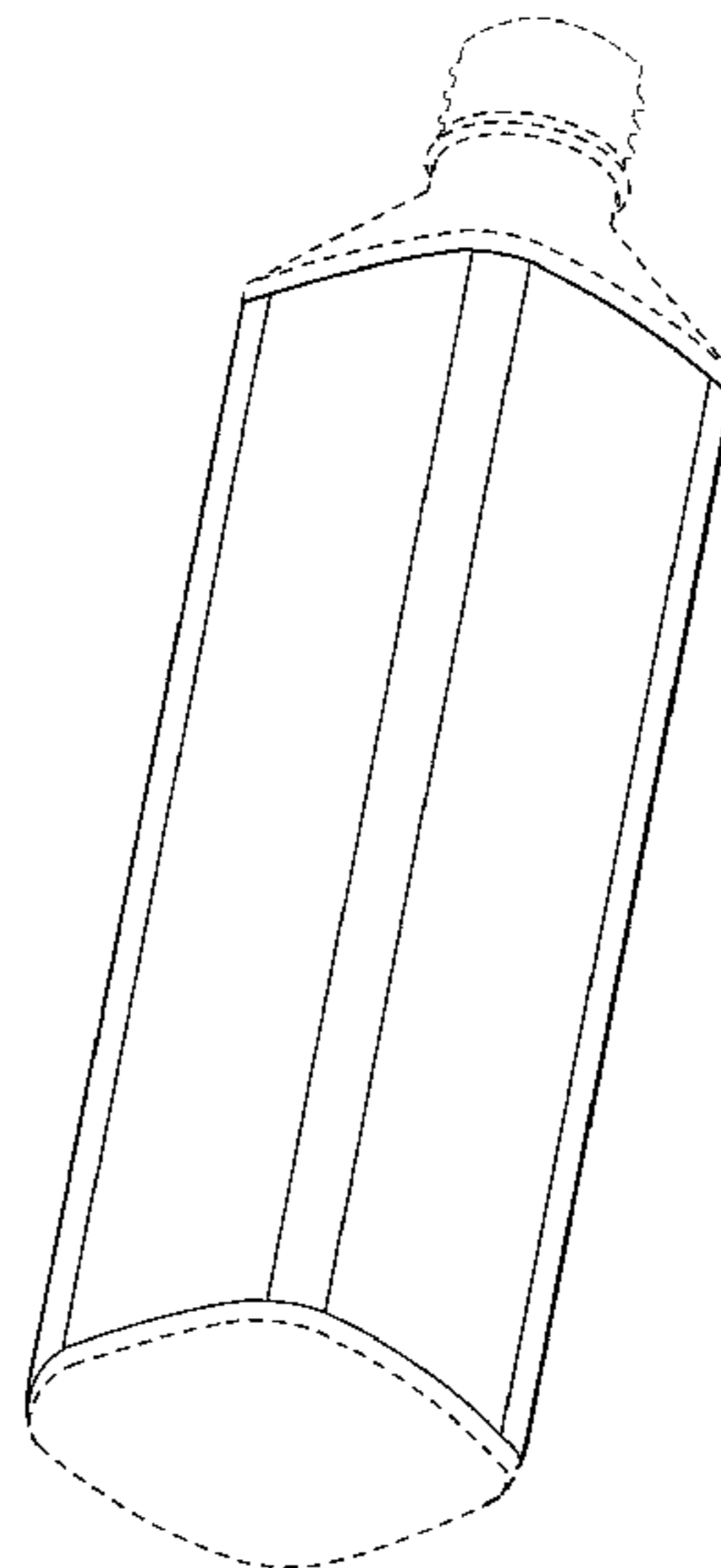
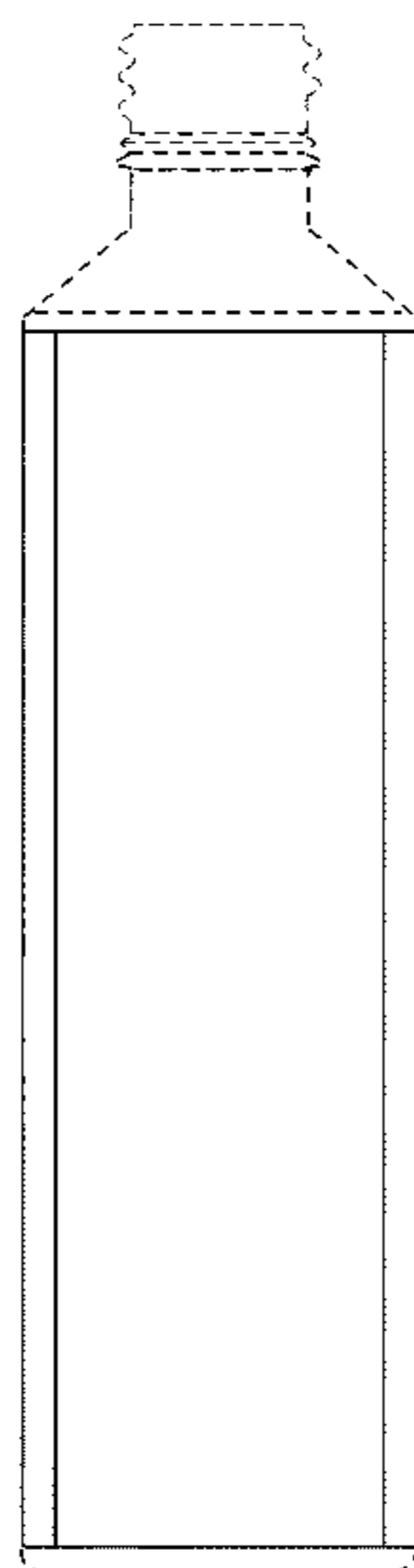
FIG. 2 is a bottom plan view thereof;

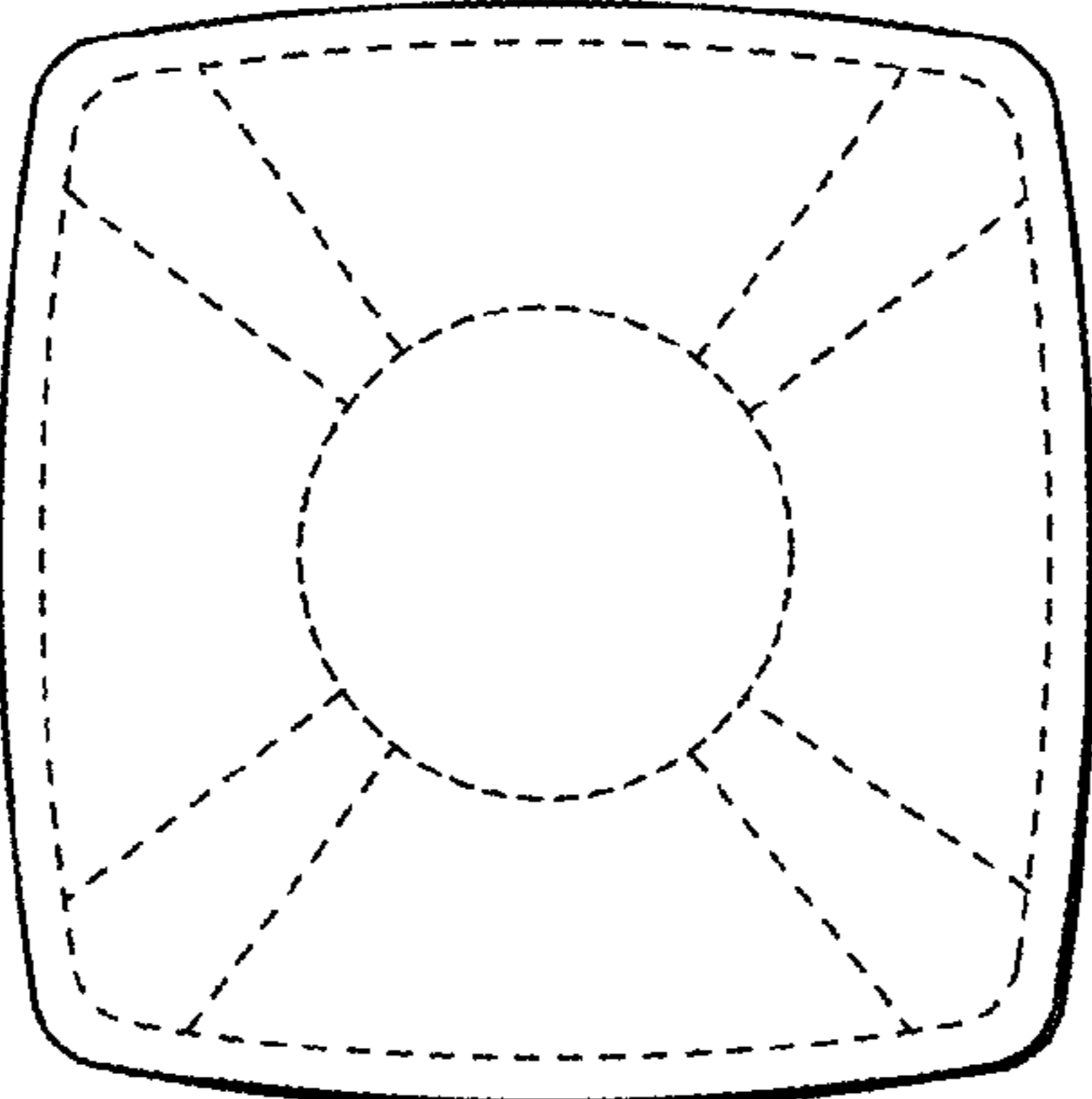

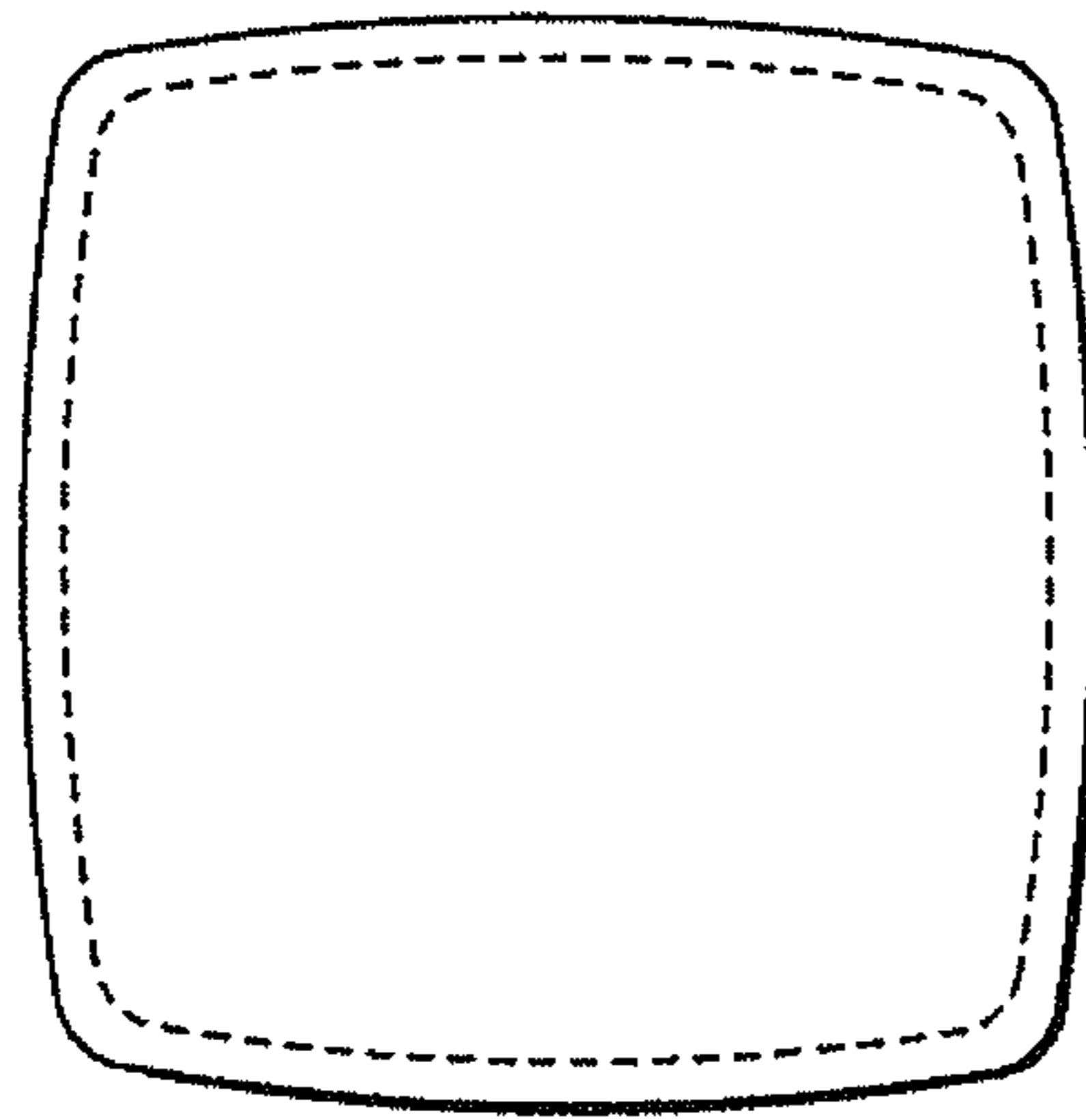

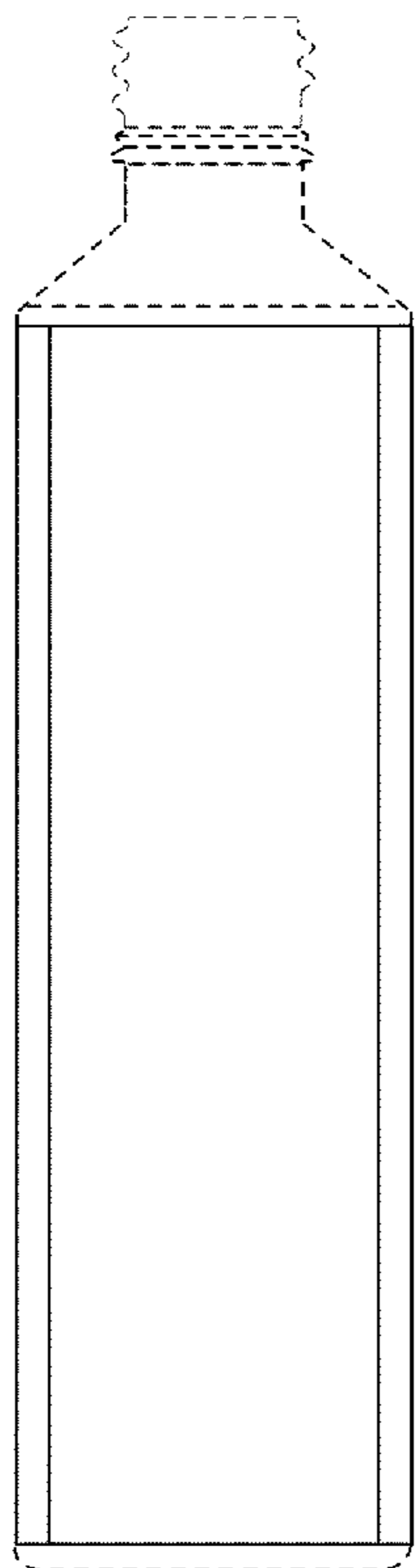

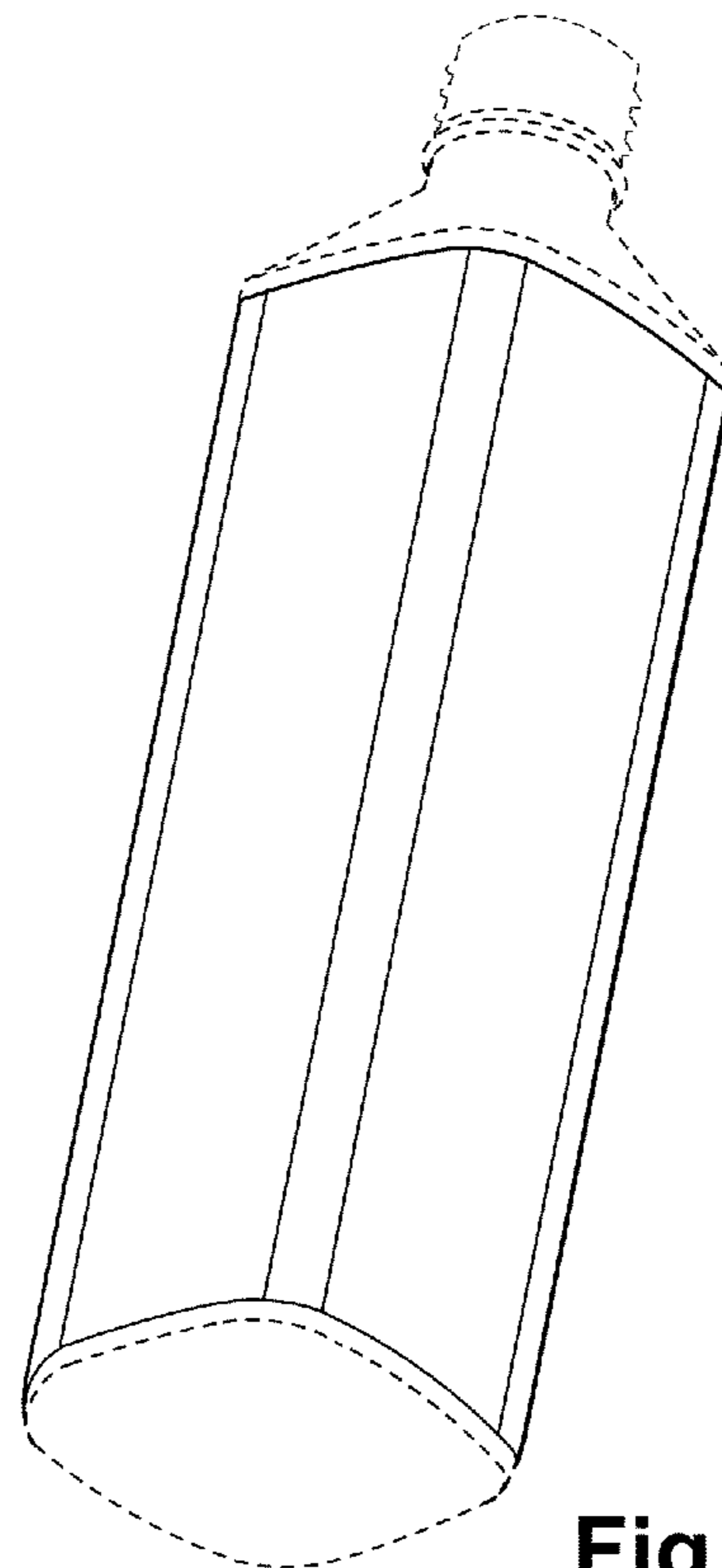
