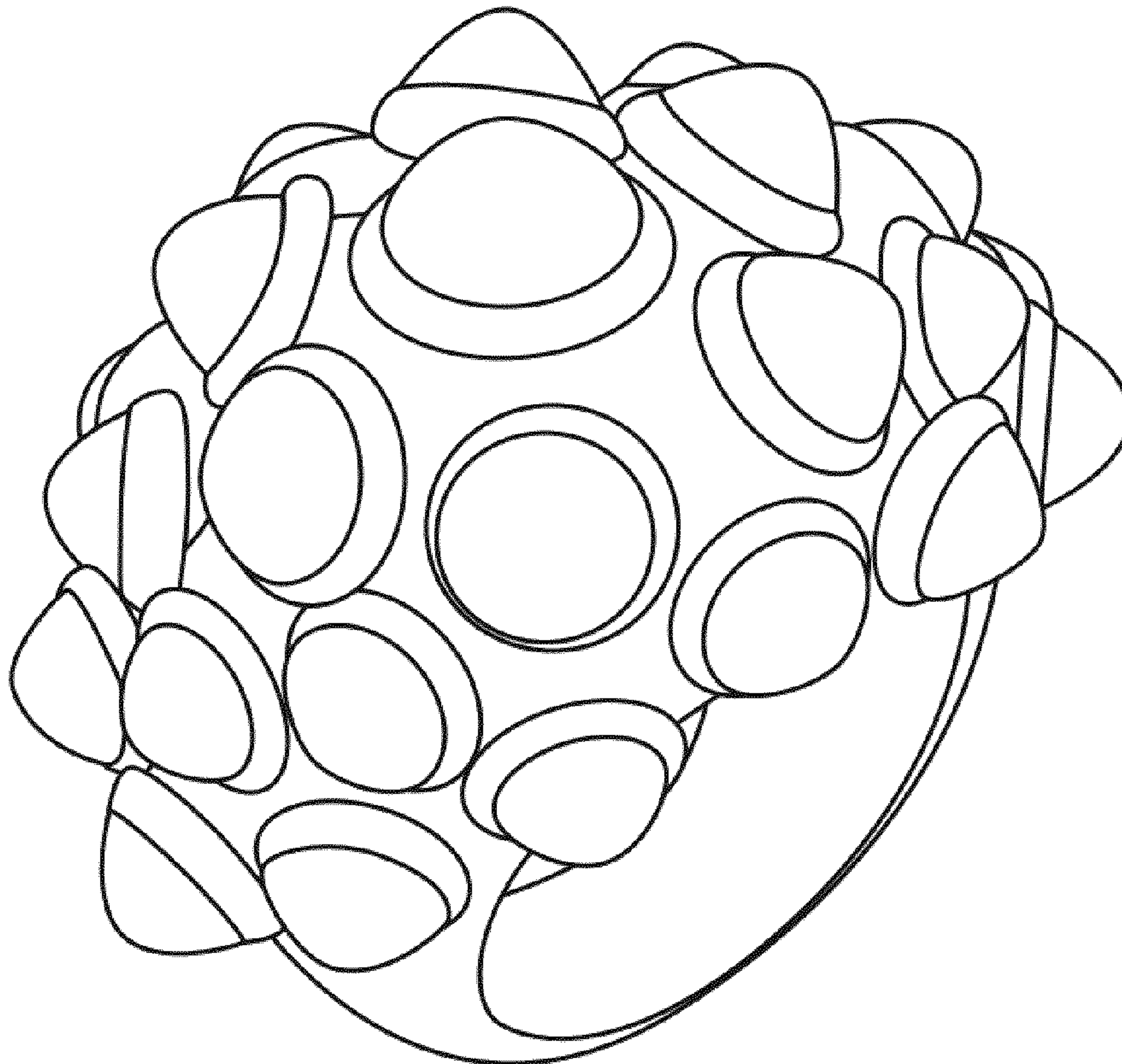
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a top view of the ring of the present invention.

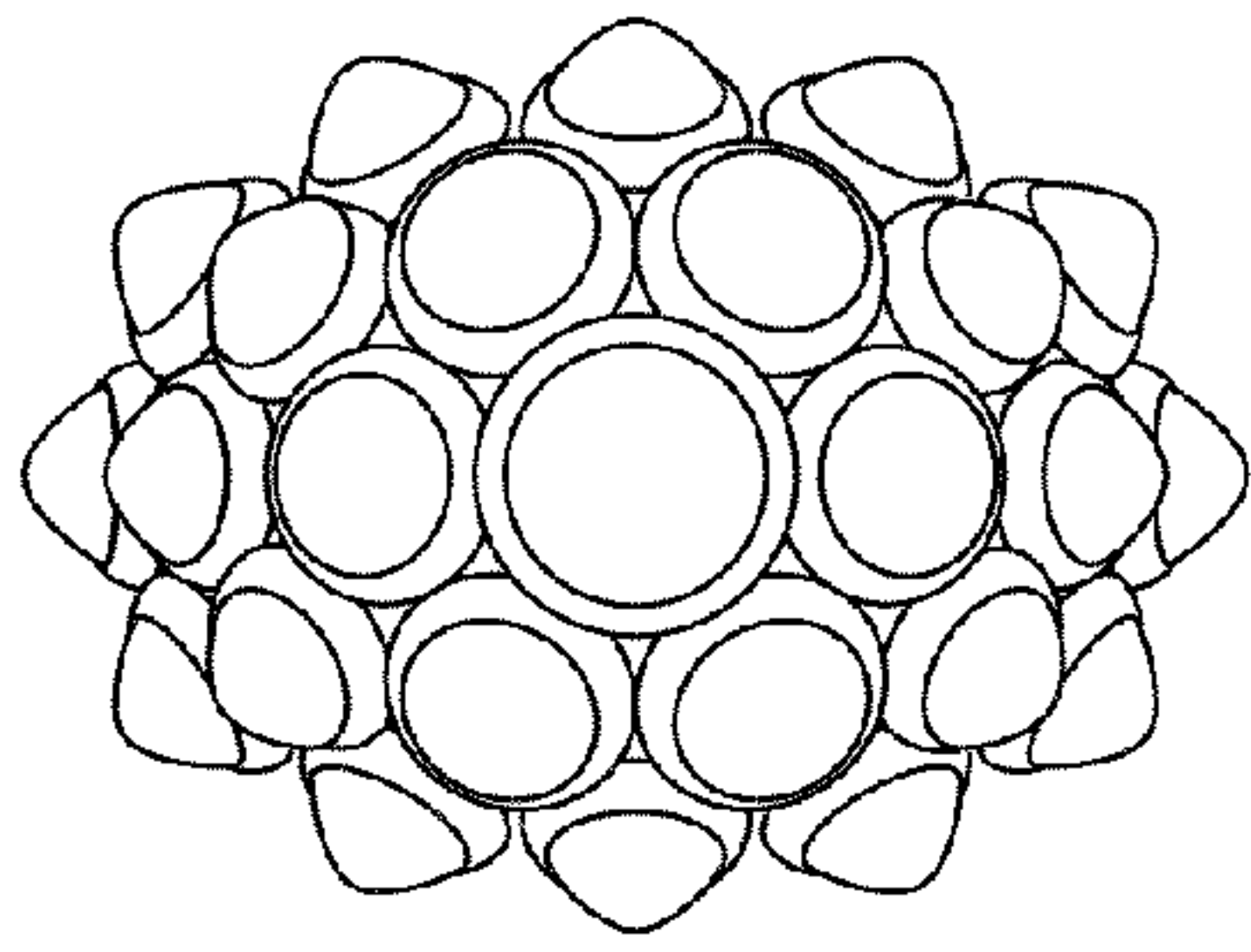

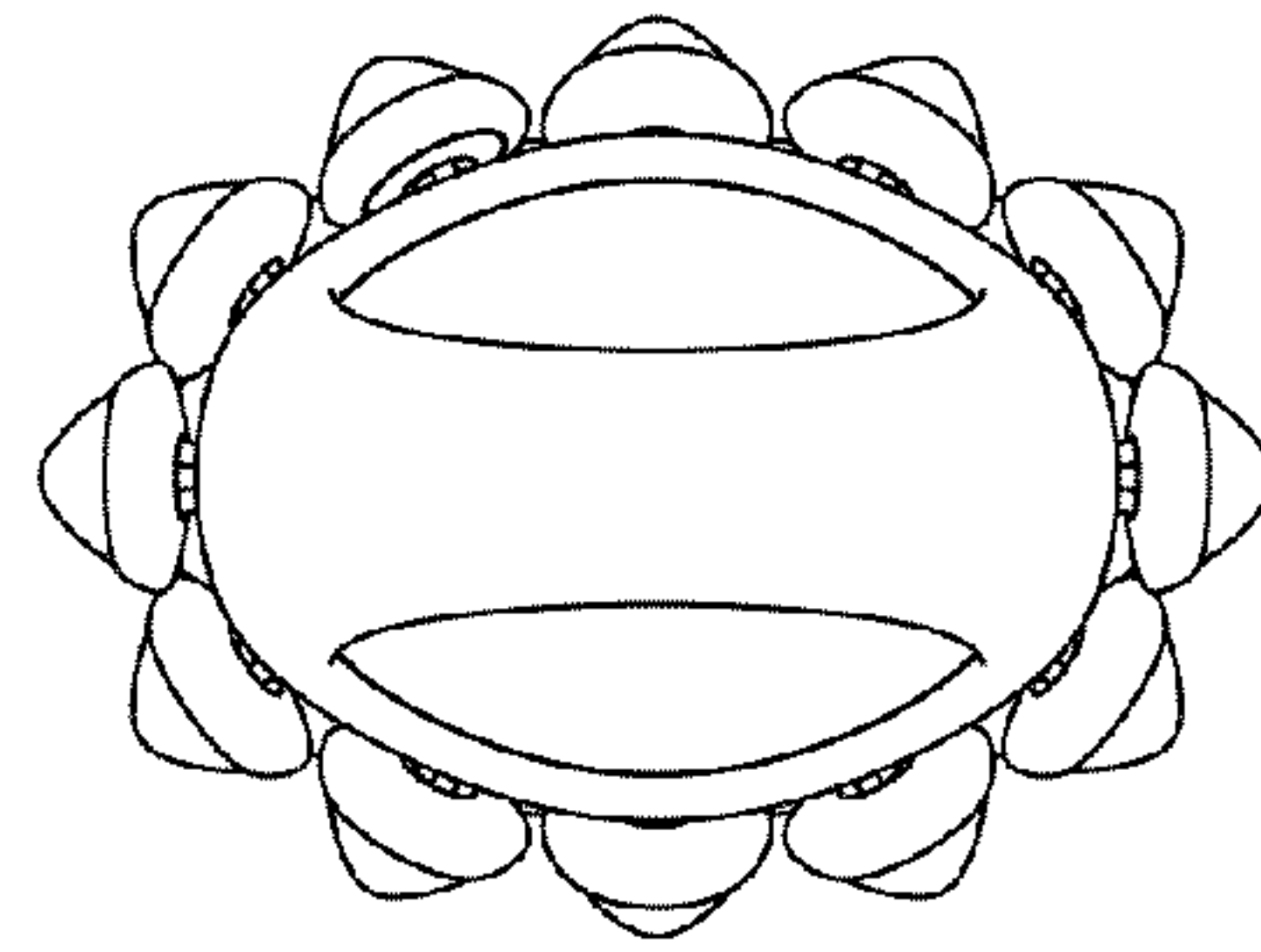

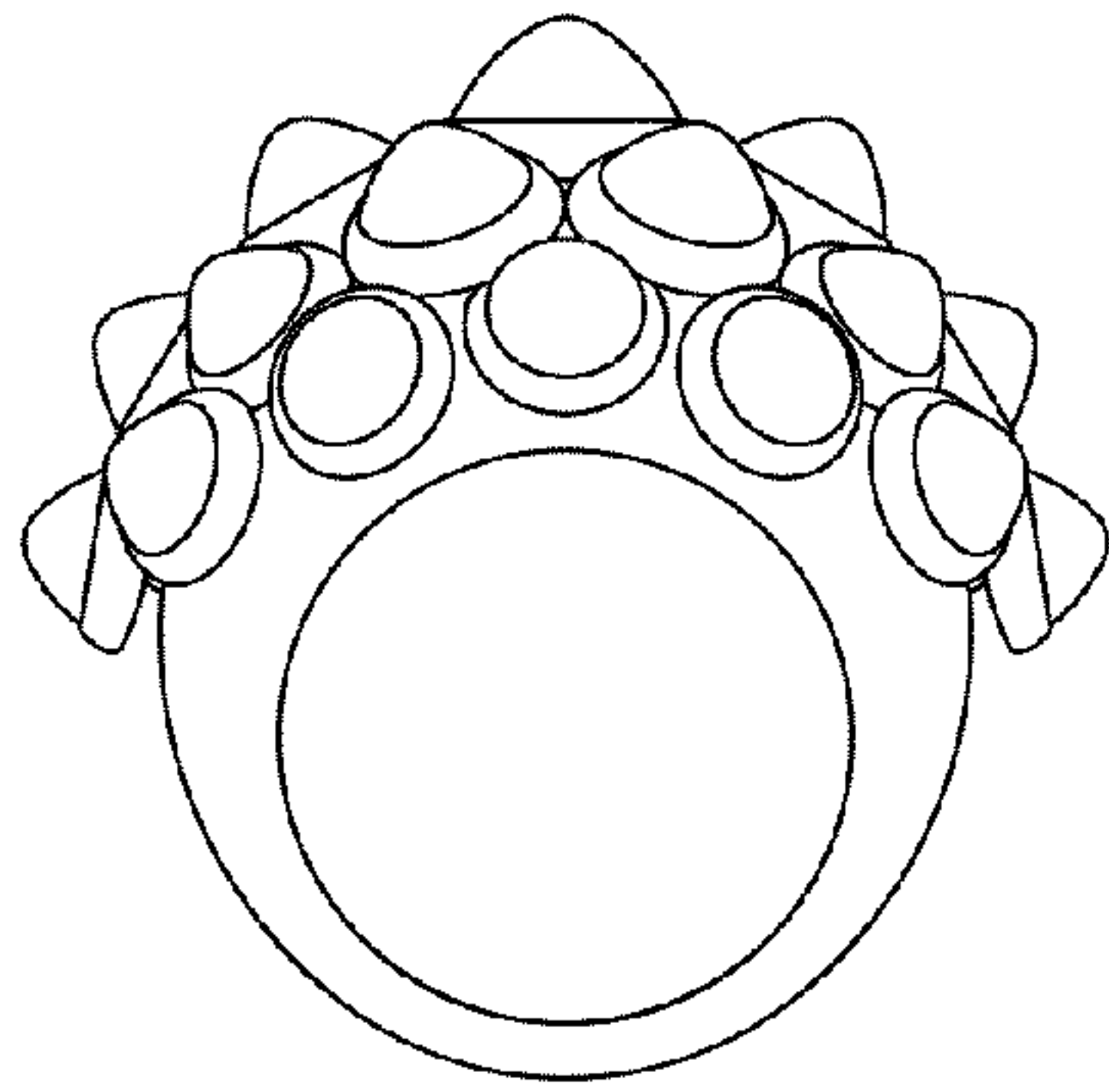

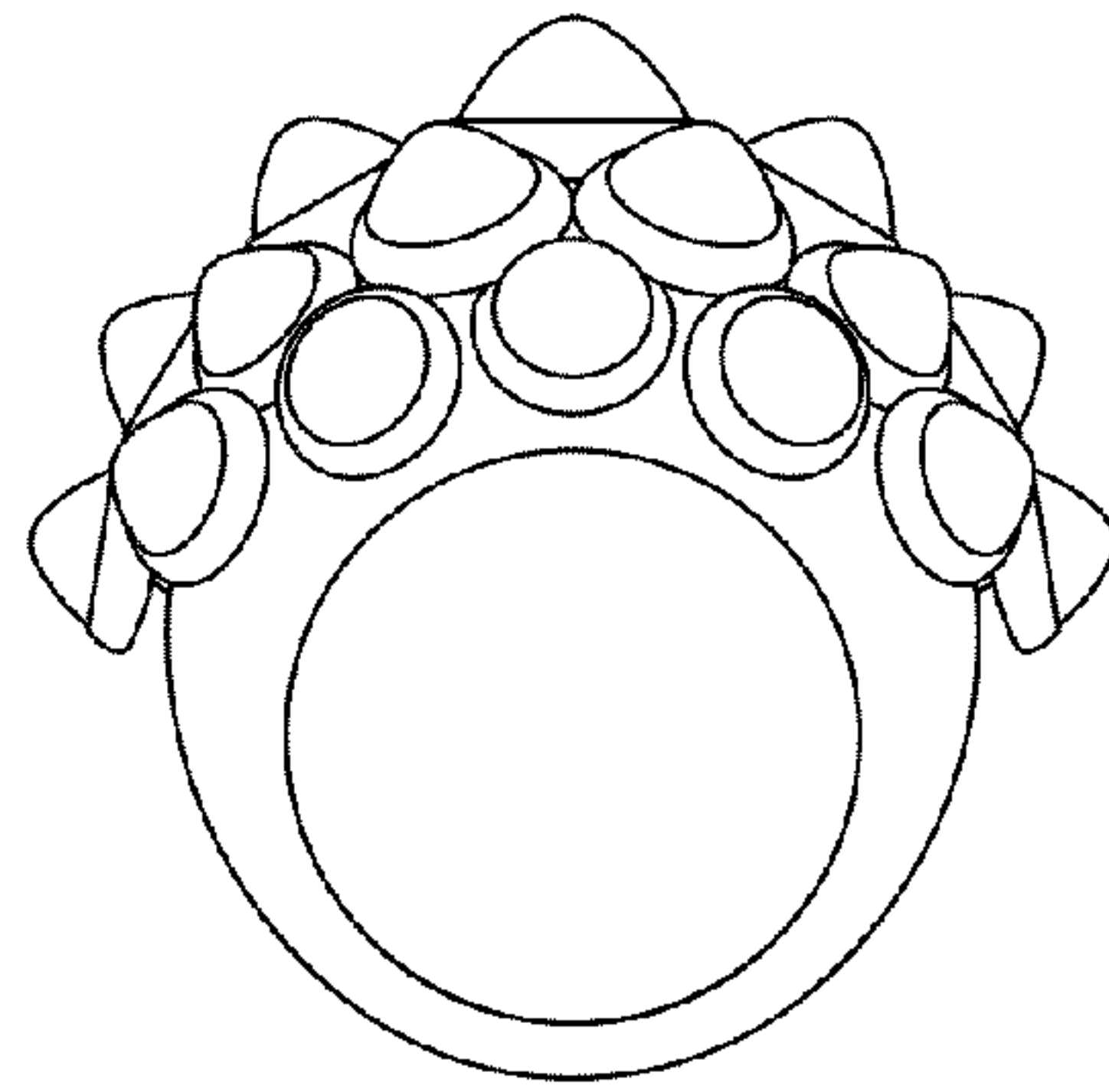

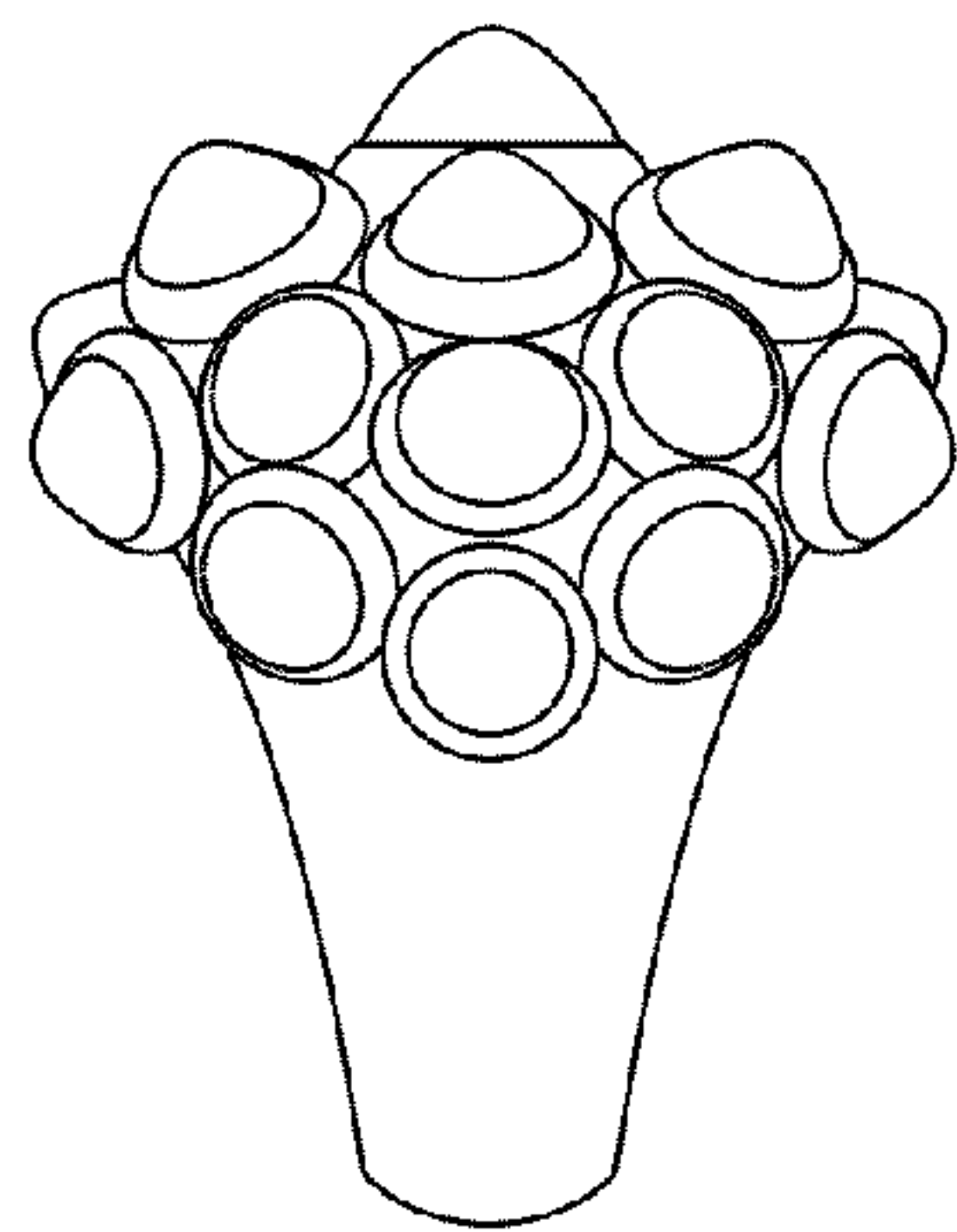

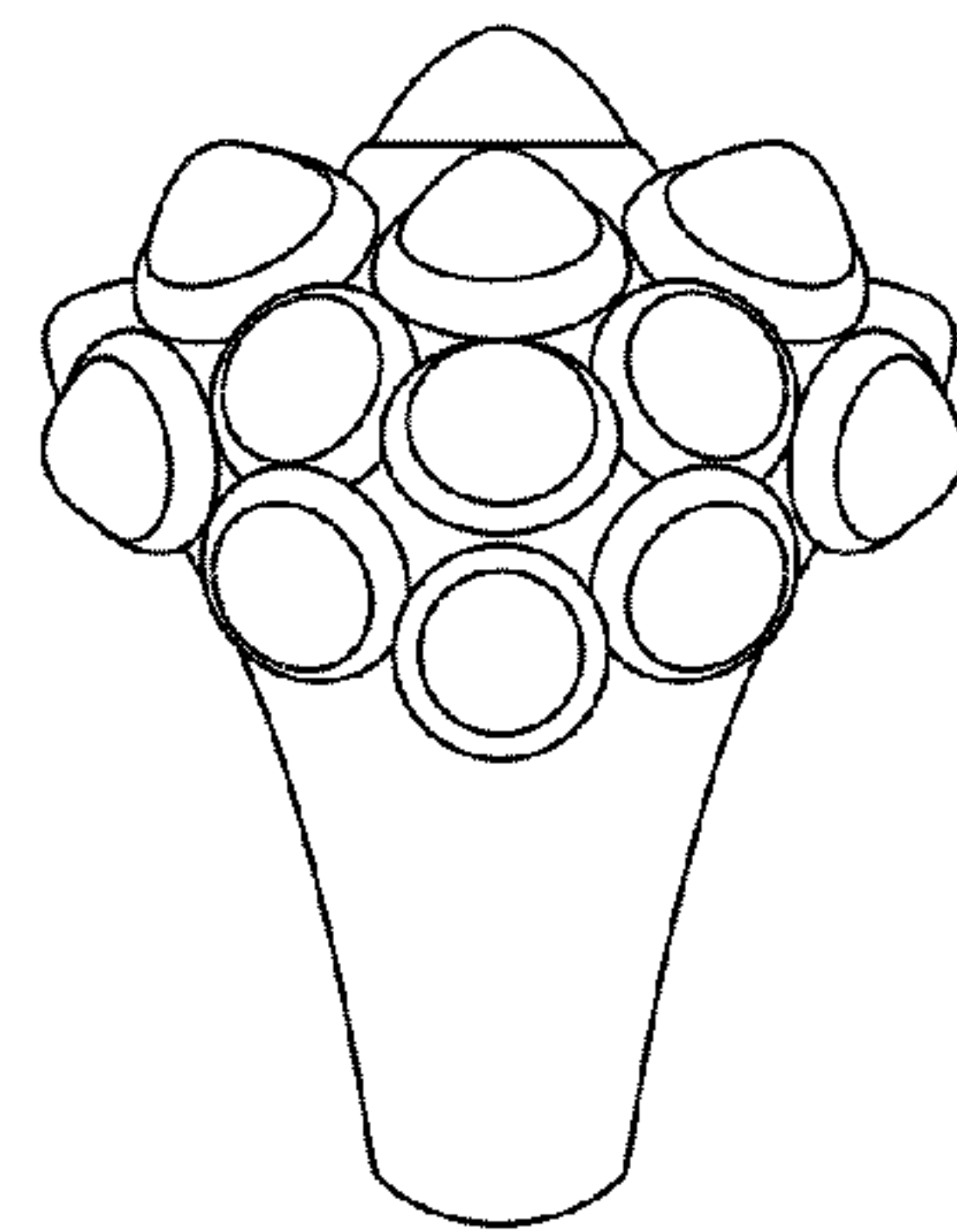

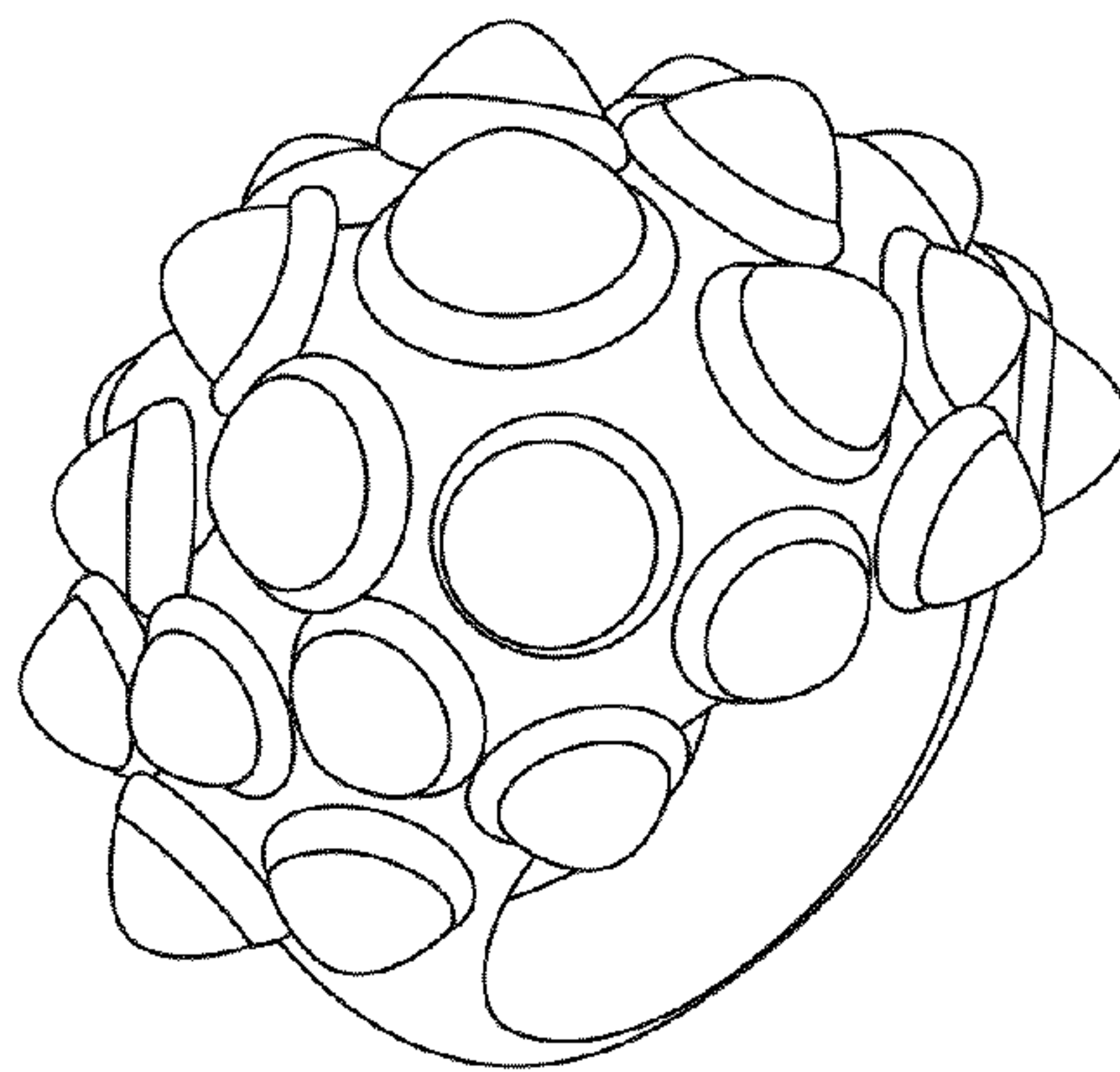
