The ornamental design for a motorcycle, as shown and described.

DESCRIPTION

FIG. 1 is a left frontal perspective view of a motorcycle showing my new design;

FIG. 7 is a front view thereof;

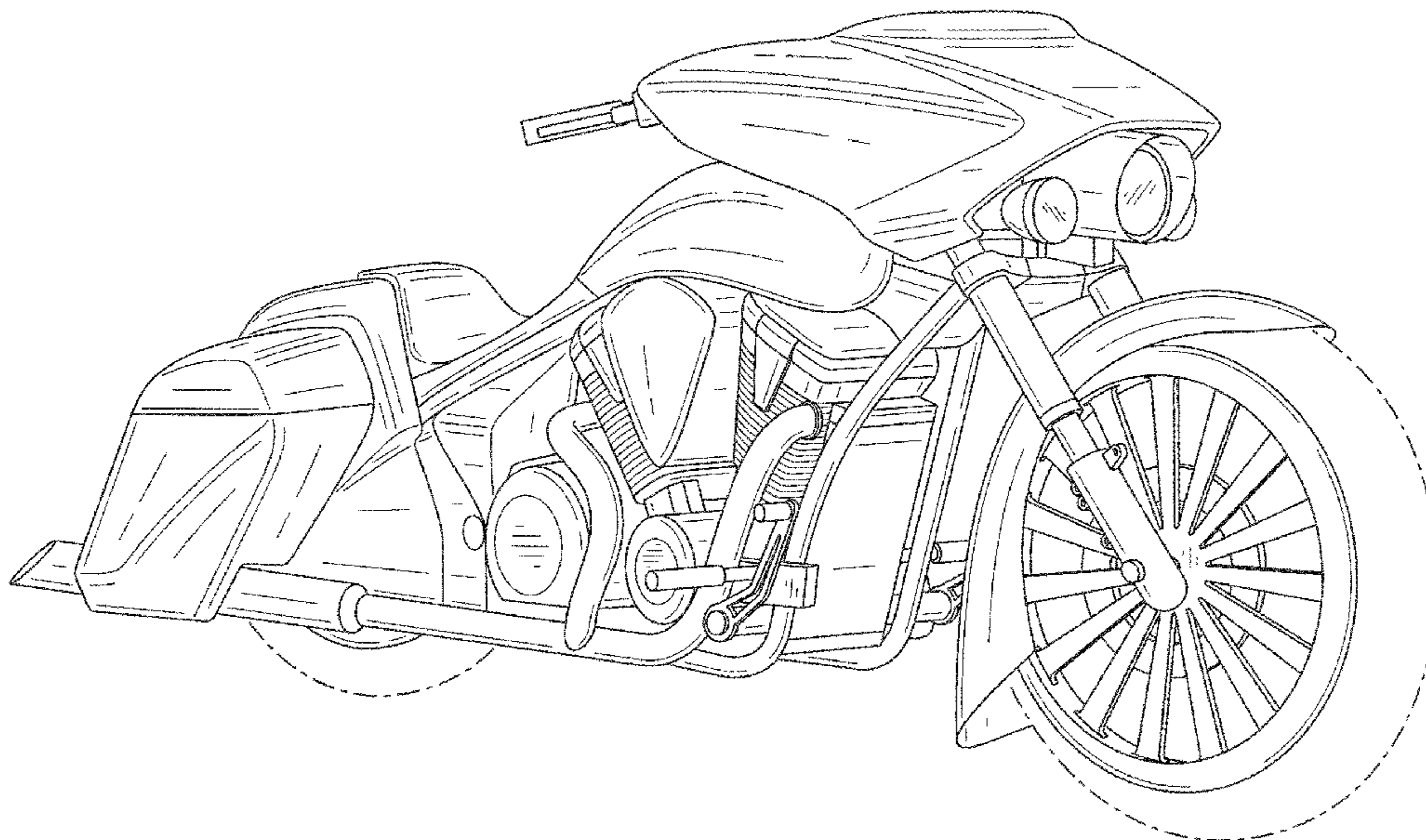
FIG. 8 is a rear view thereof;

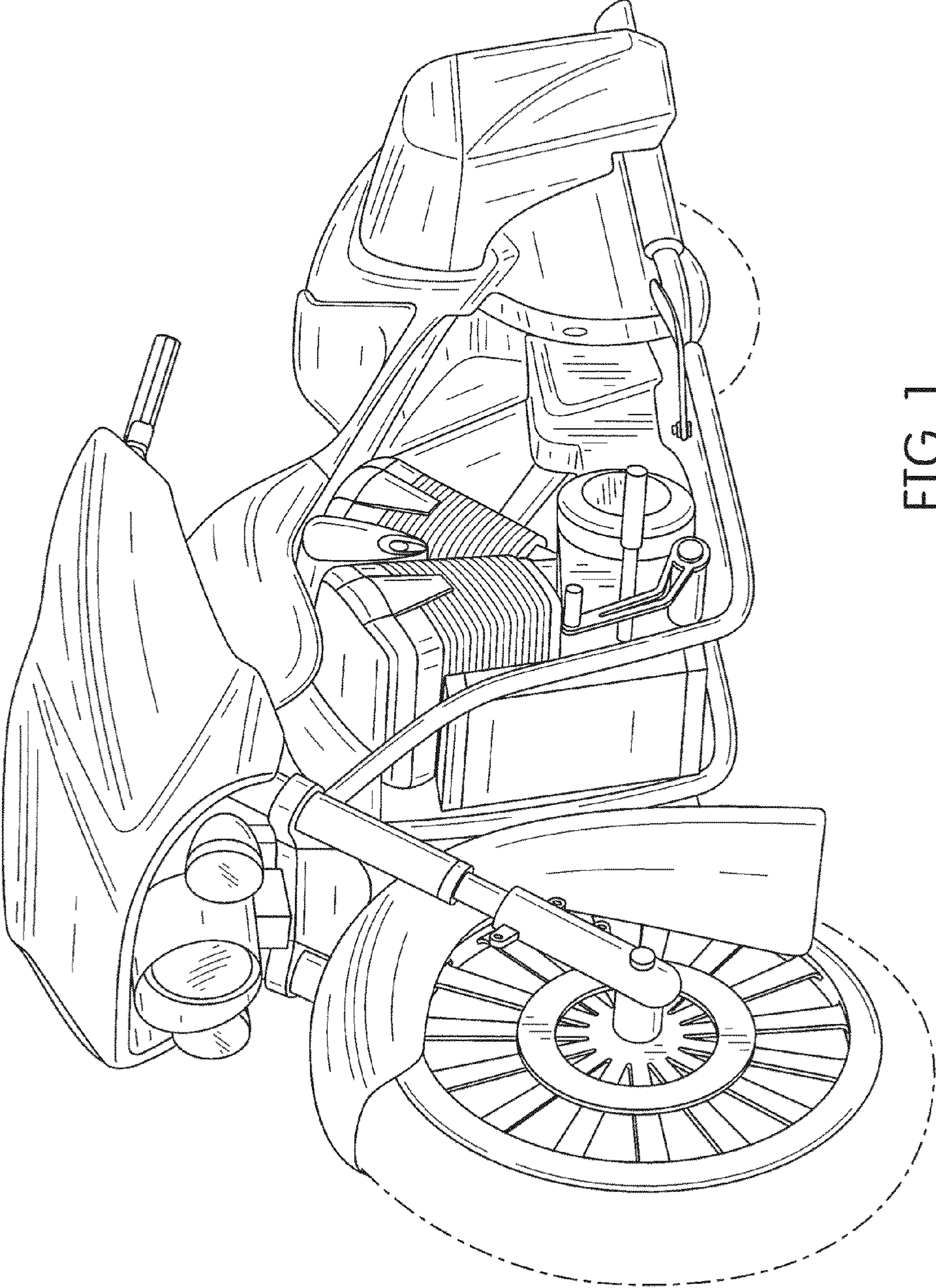

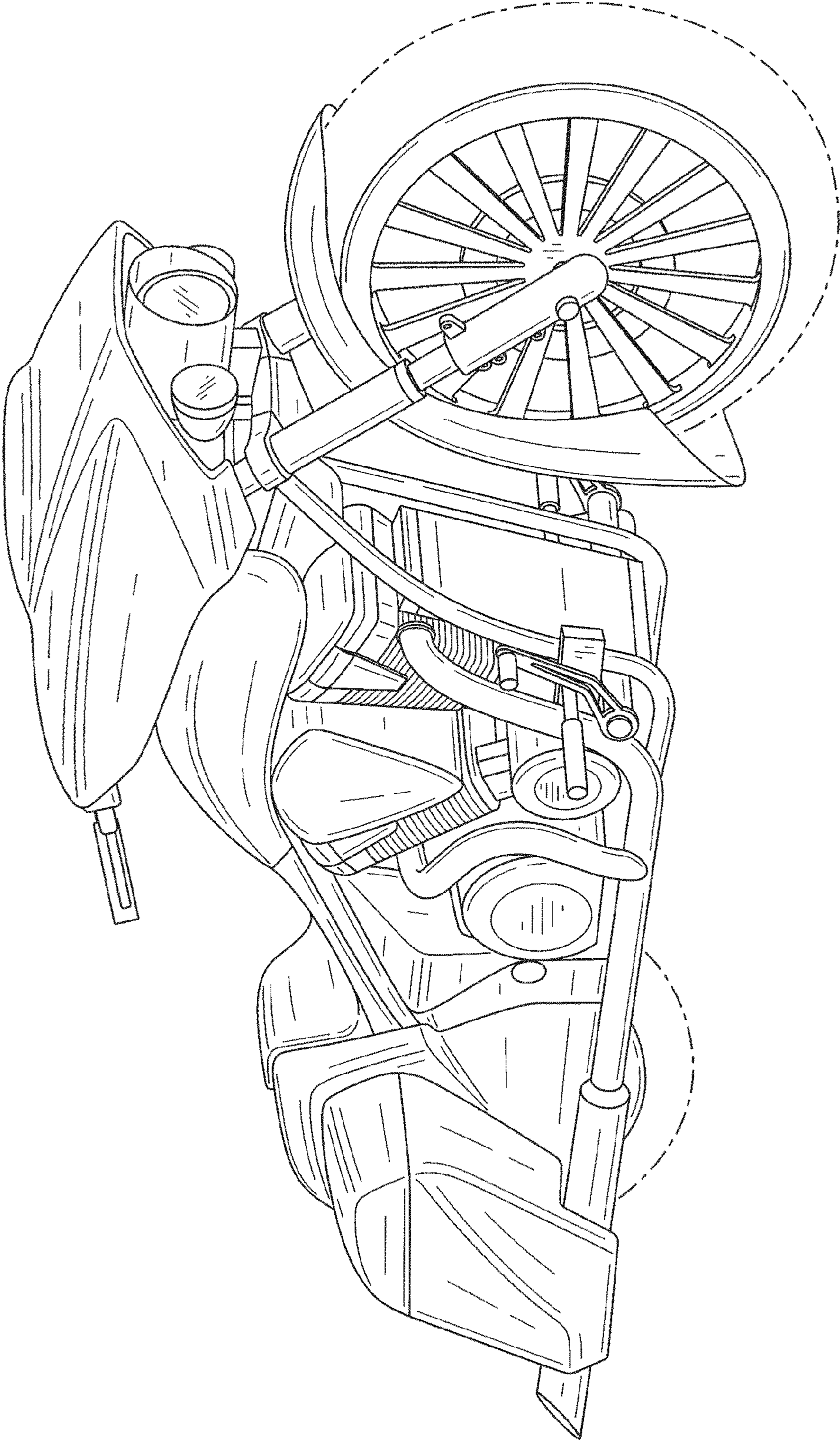

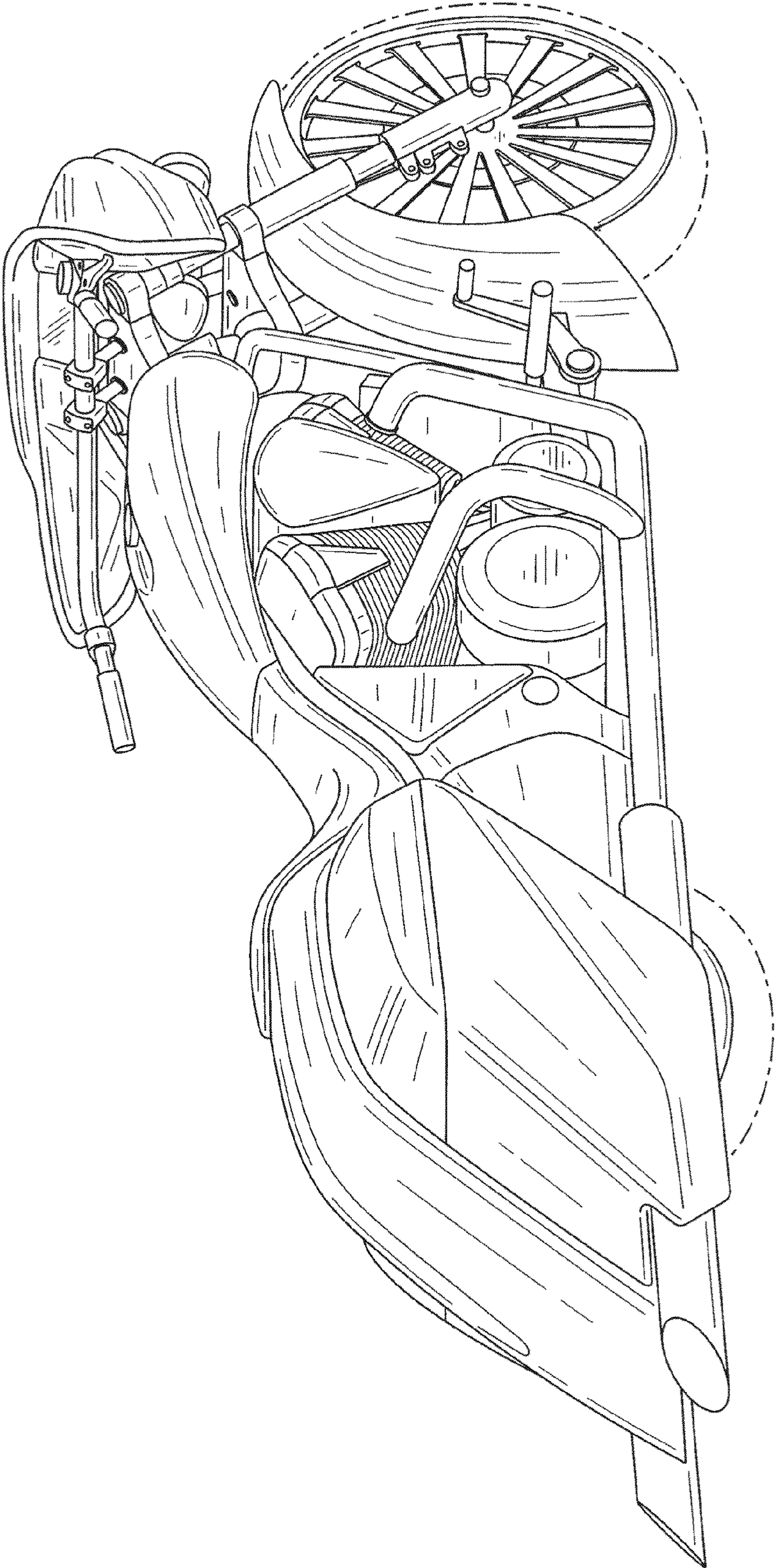

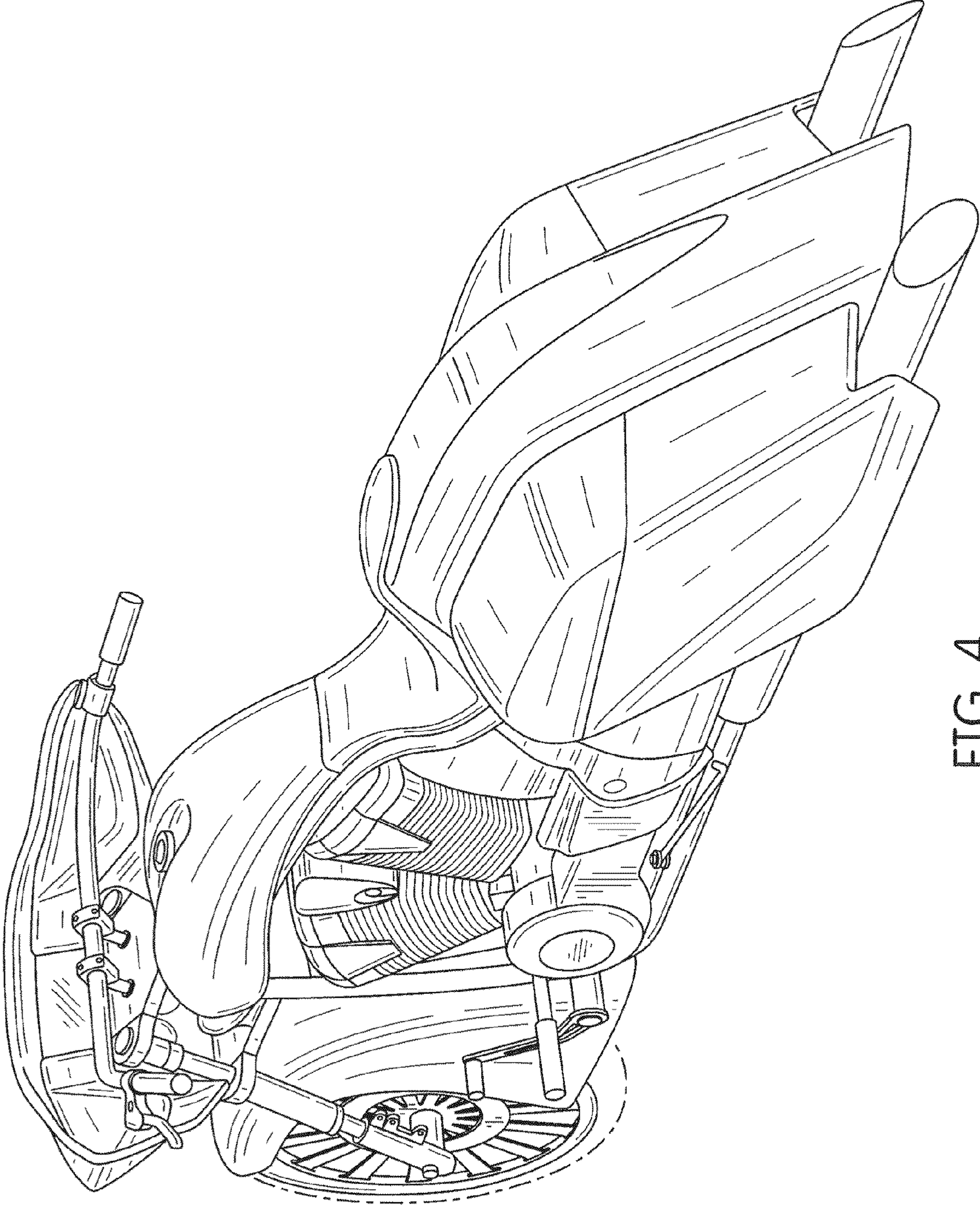

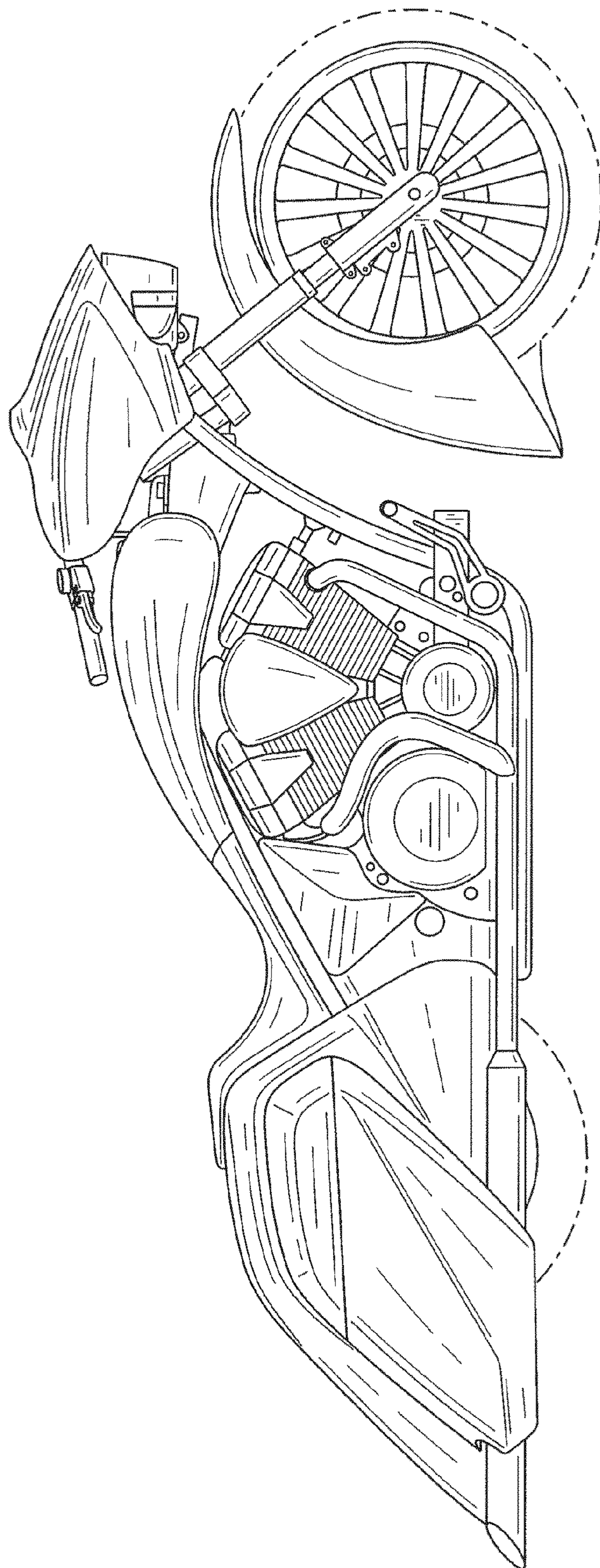

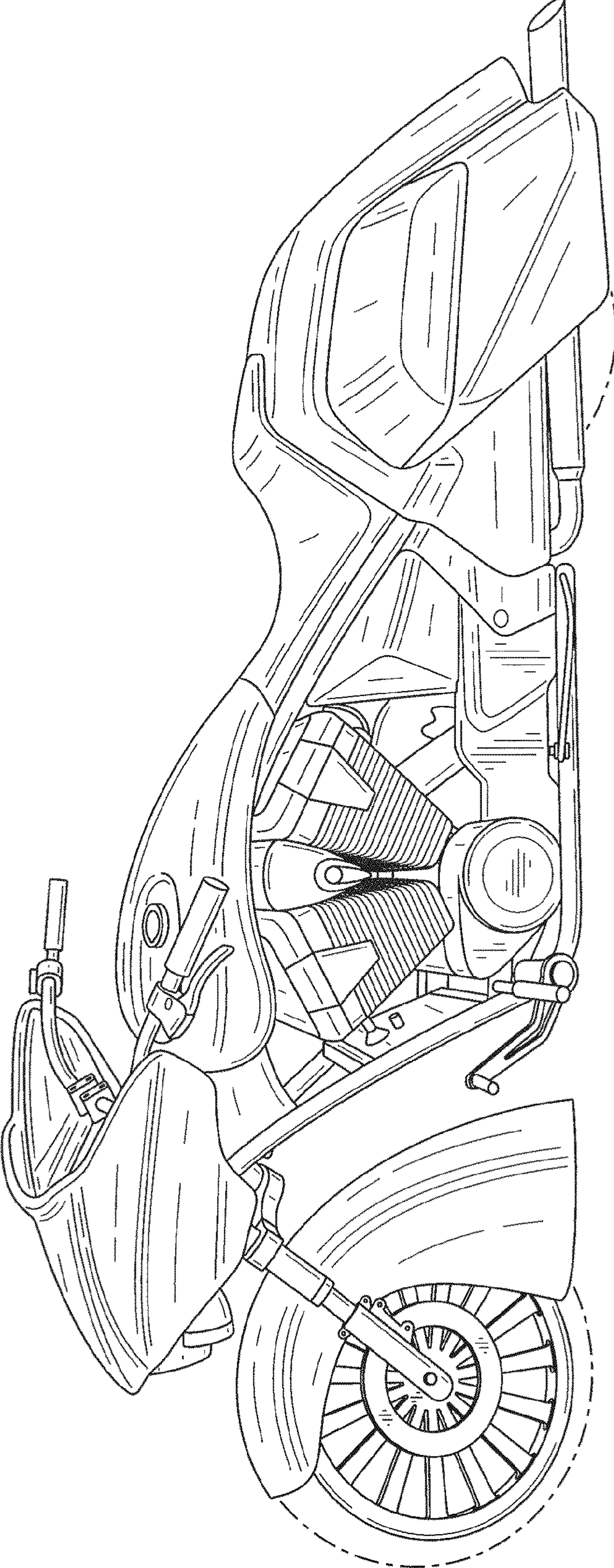

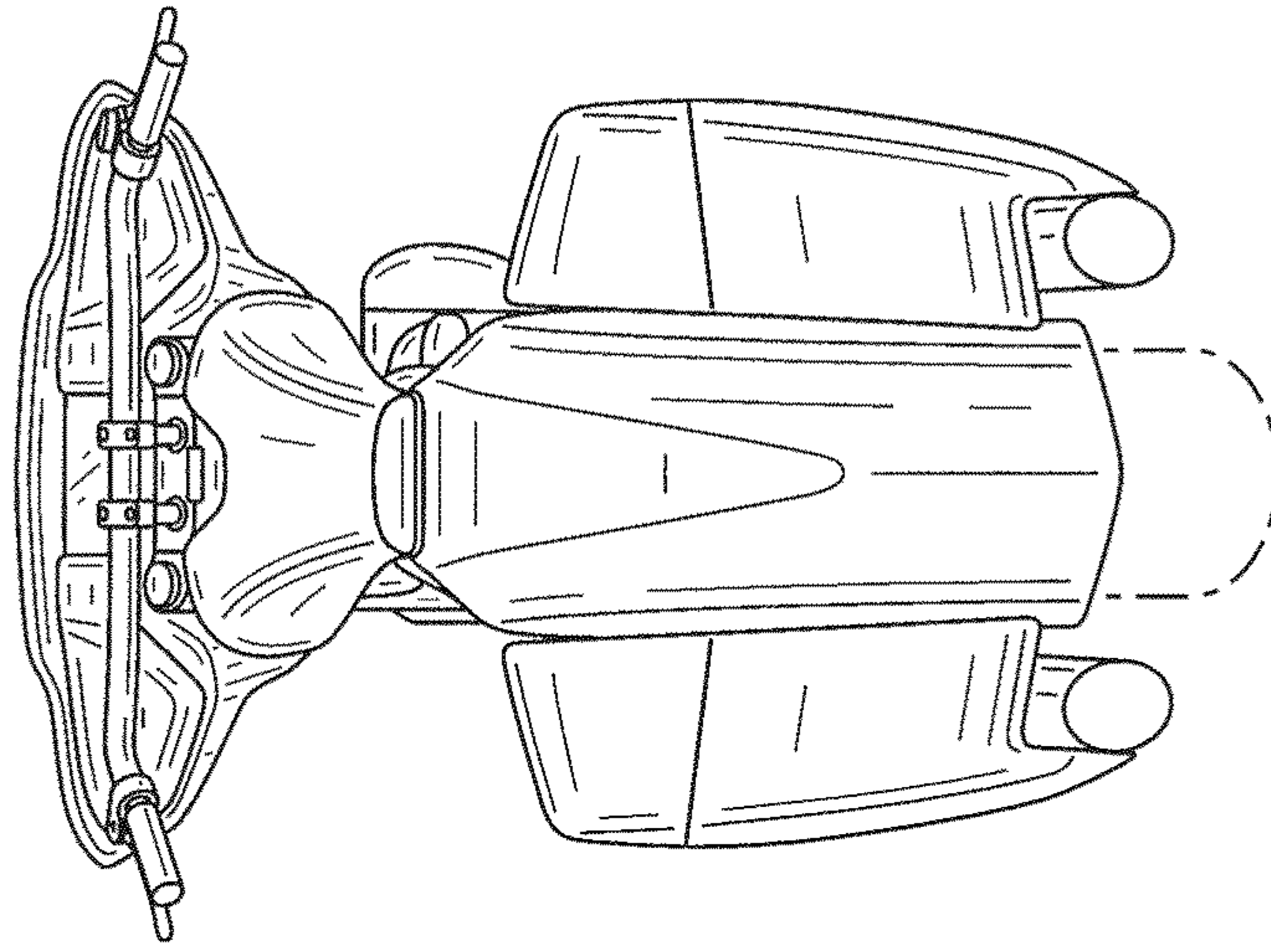

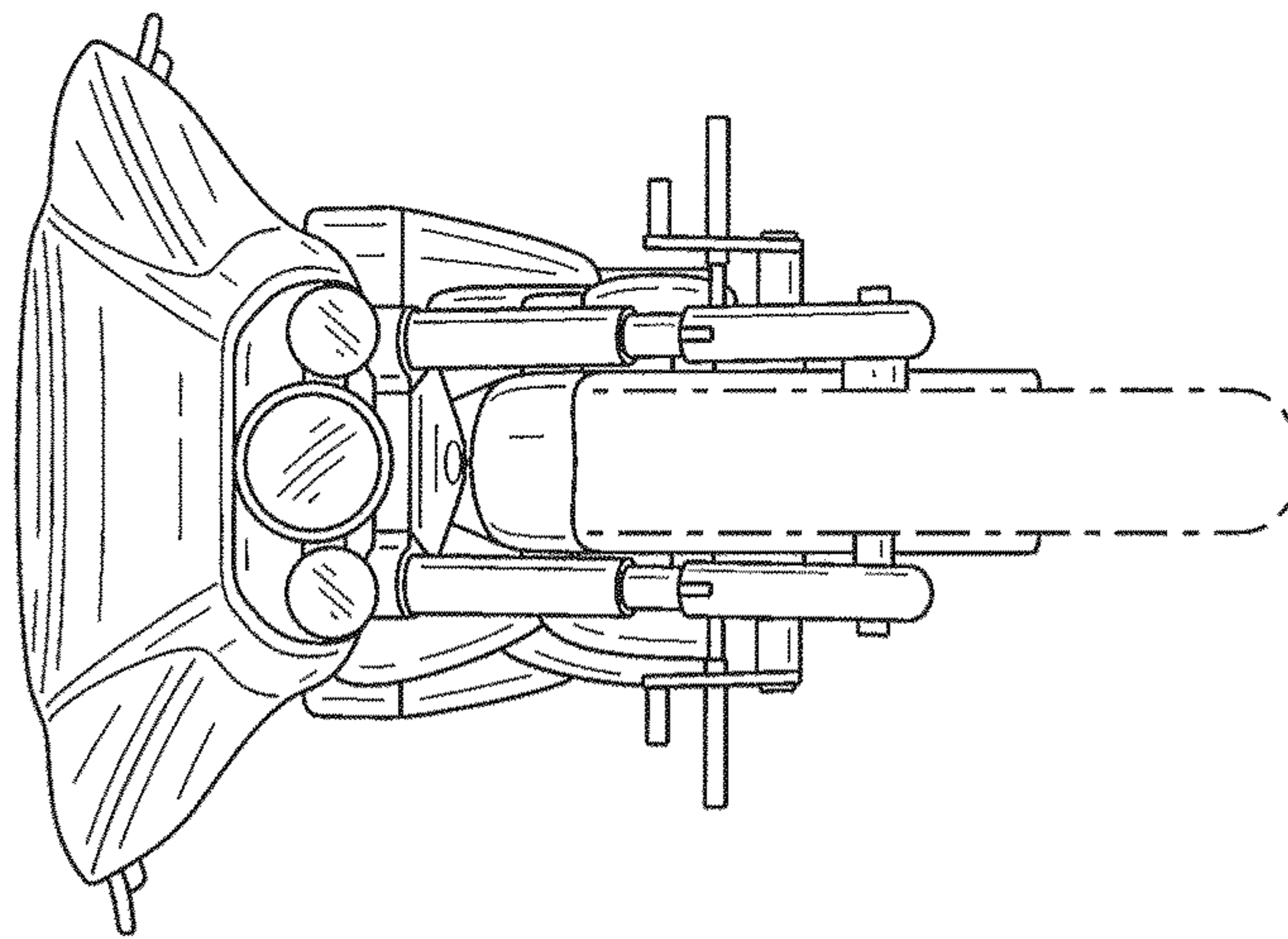

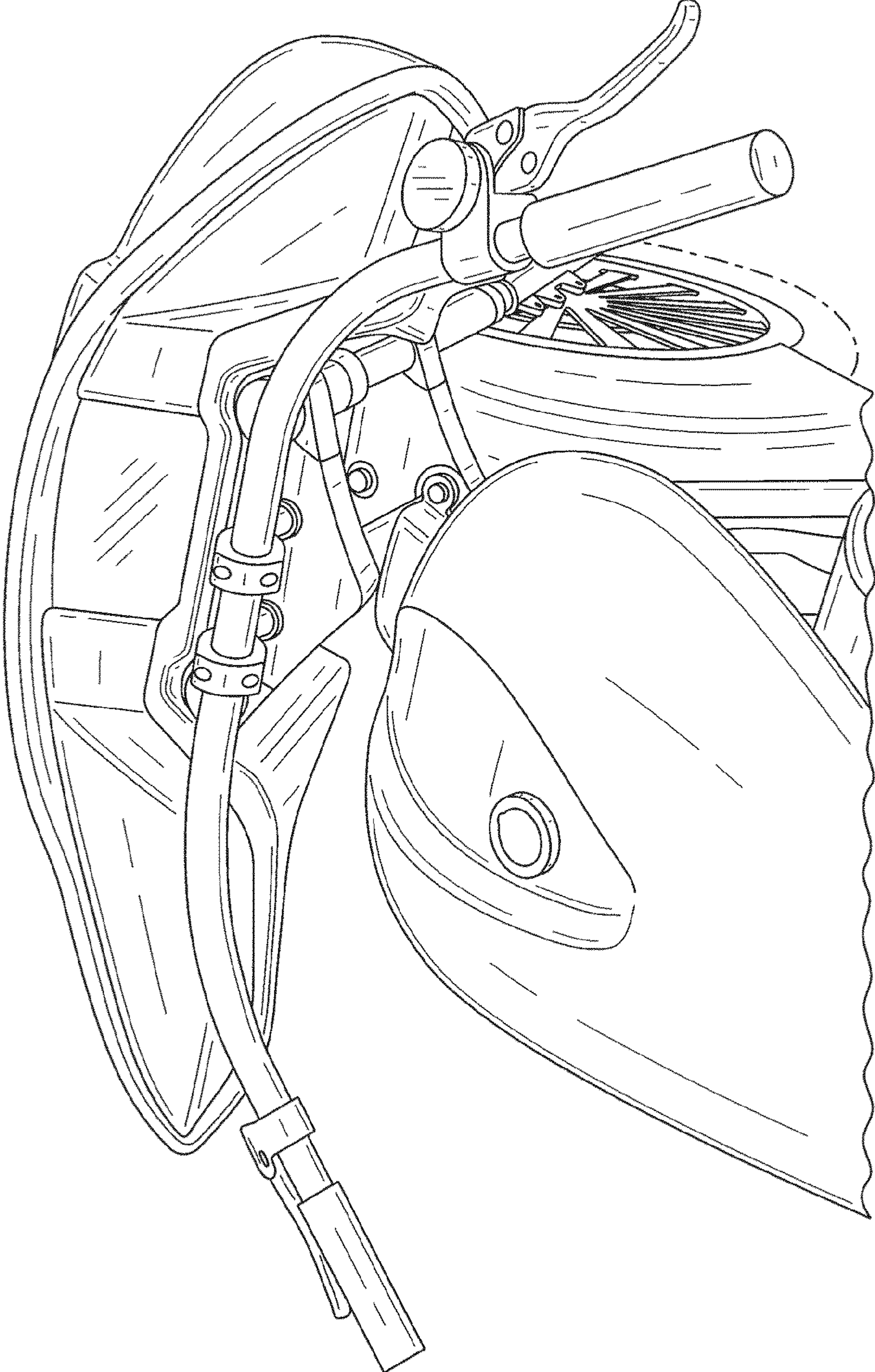

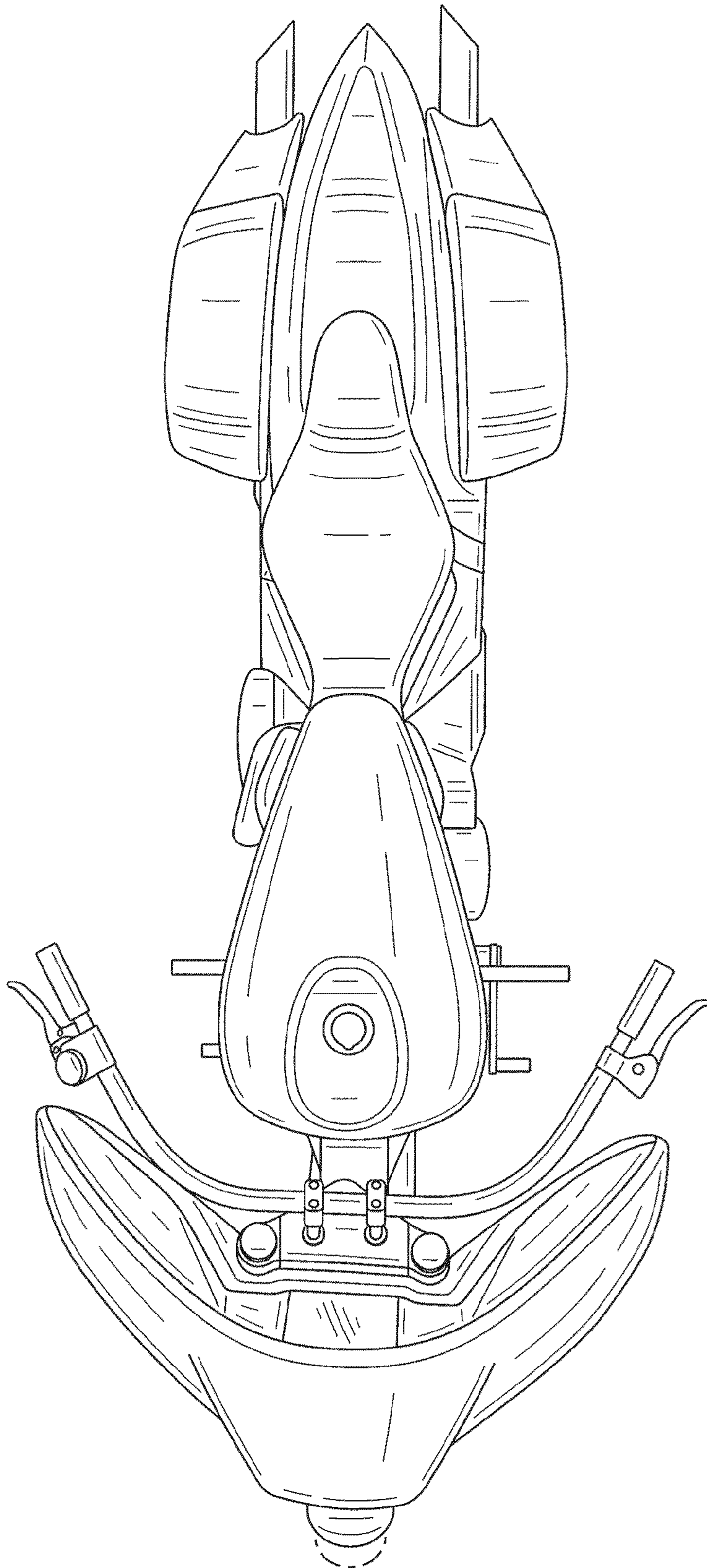
