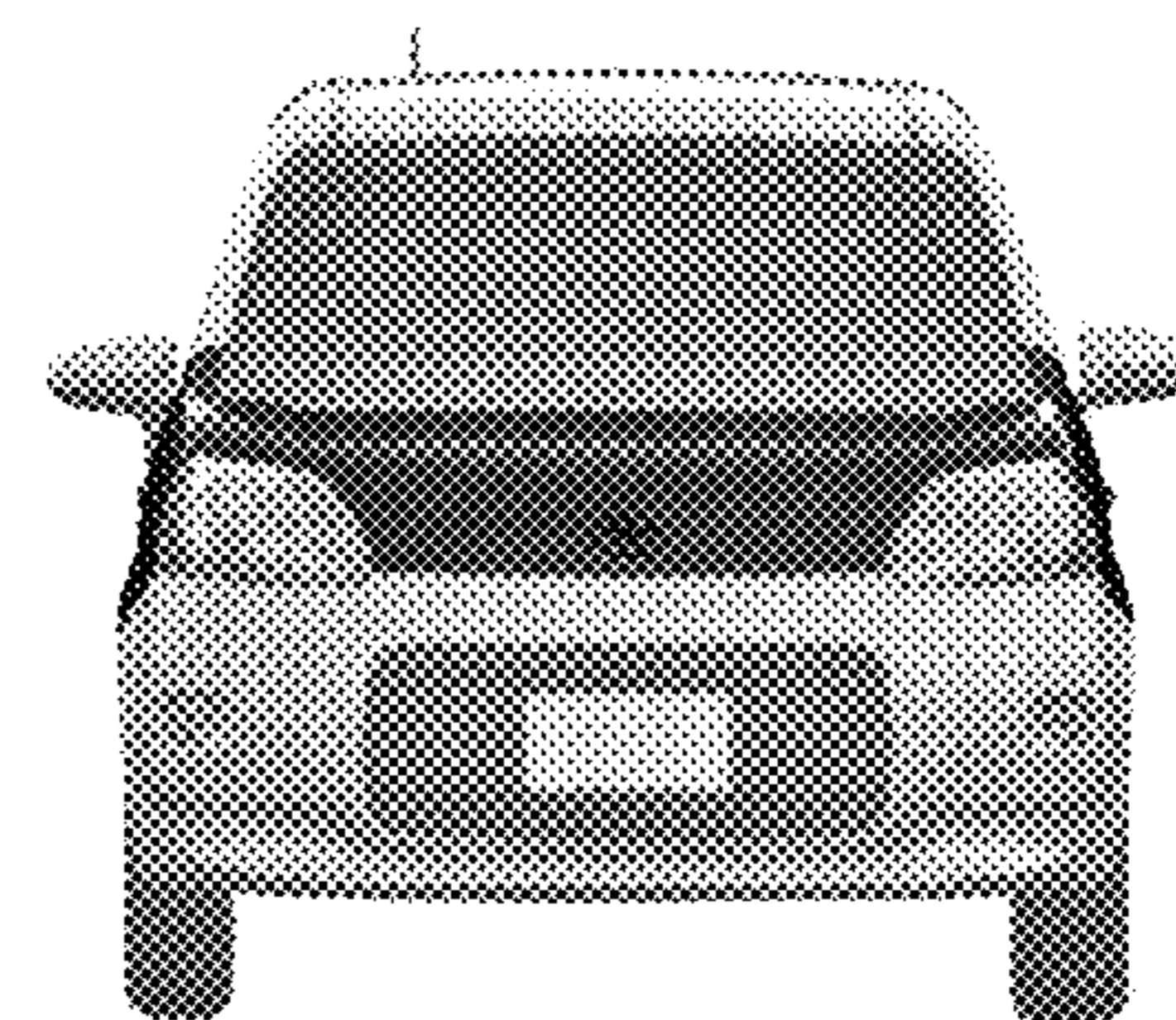
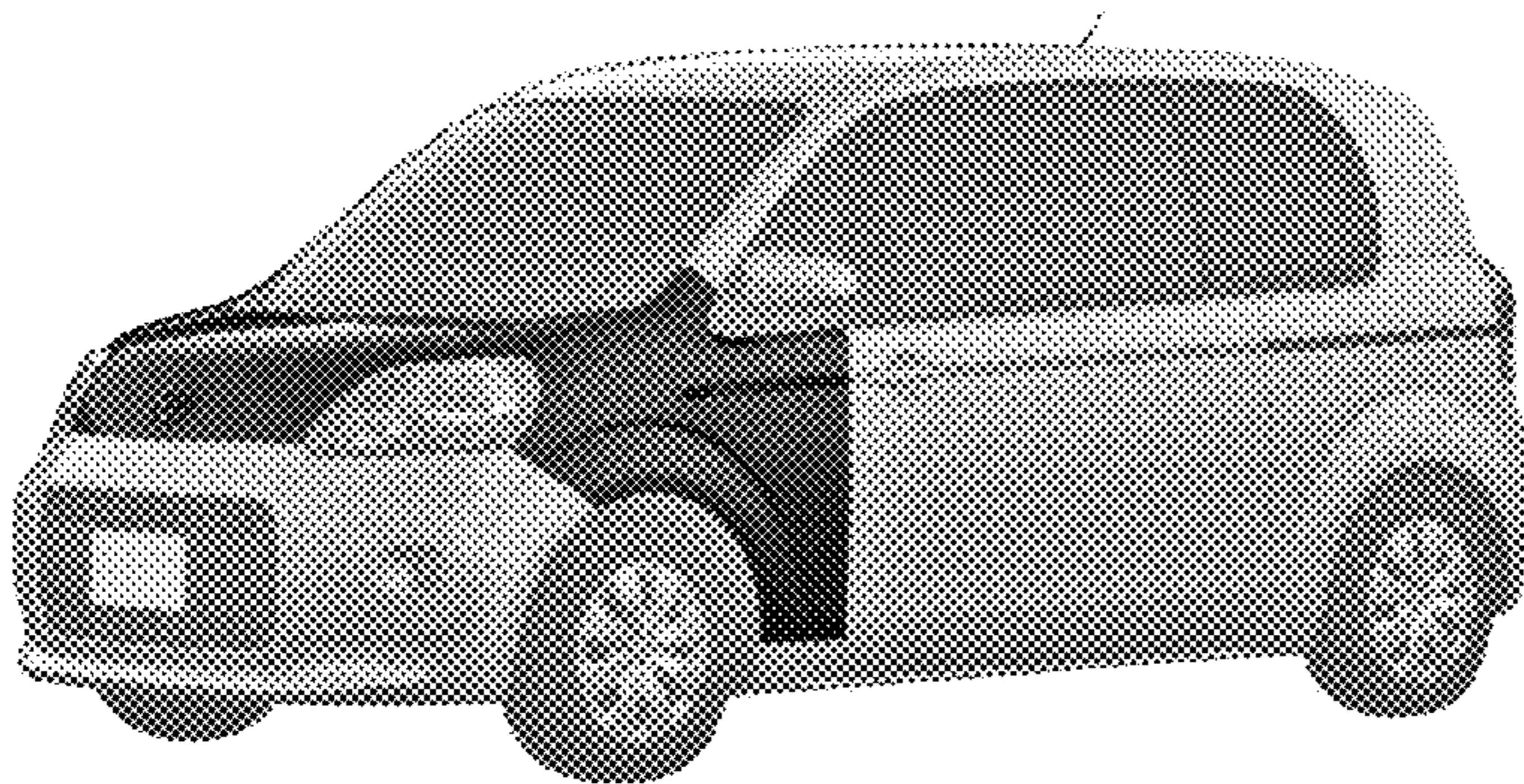
The ornamental design for the front panel for an automobile, as shown and described.

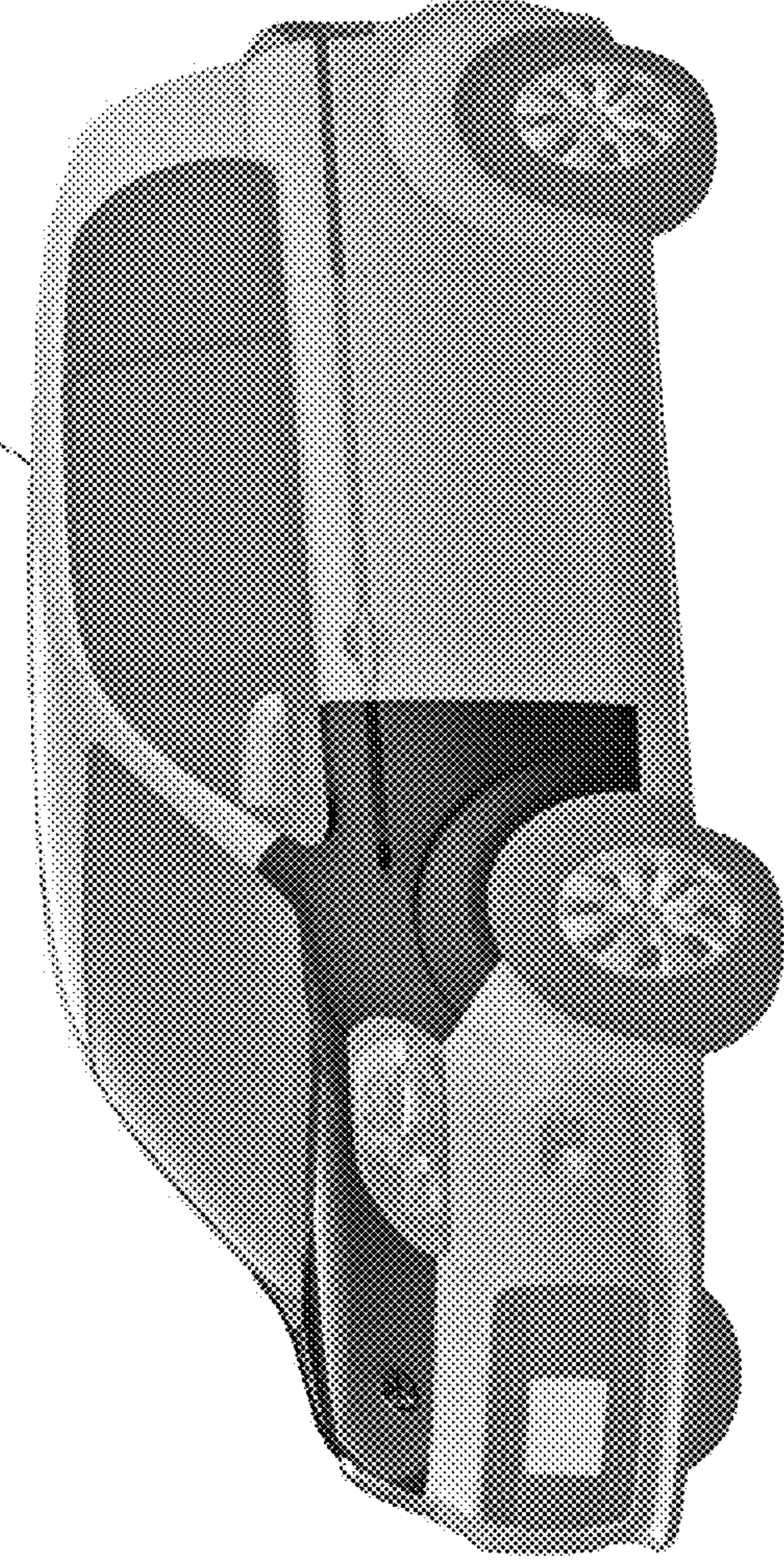

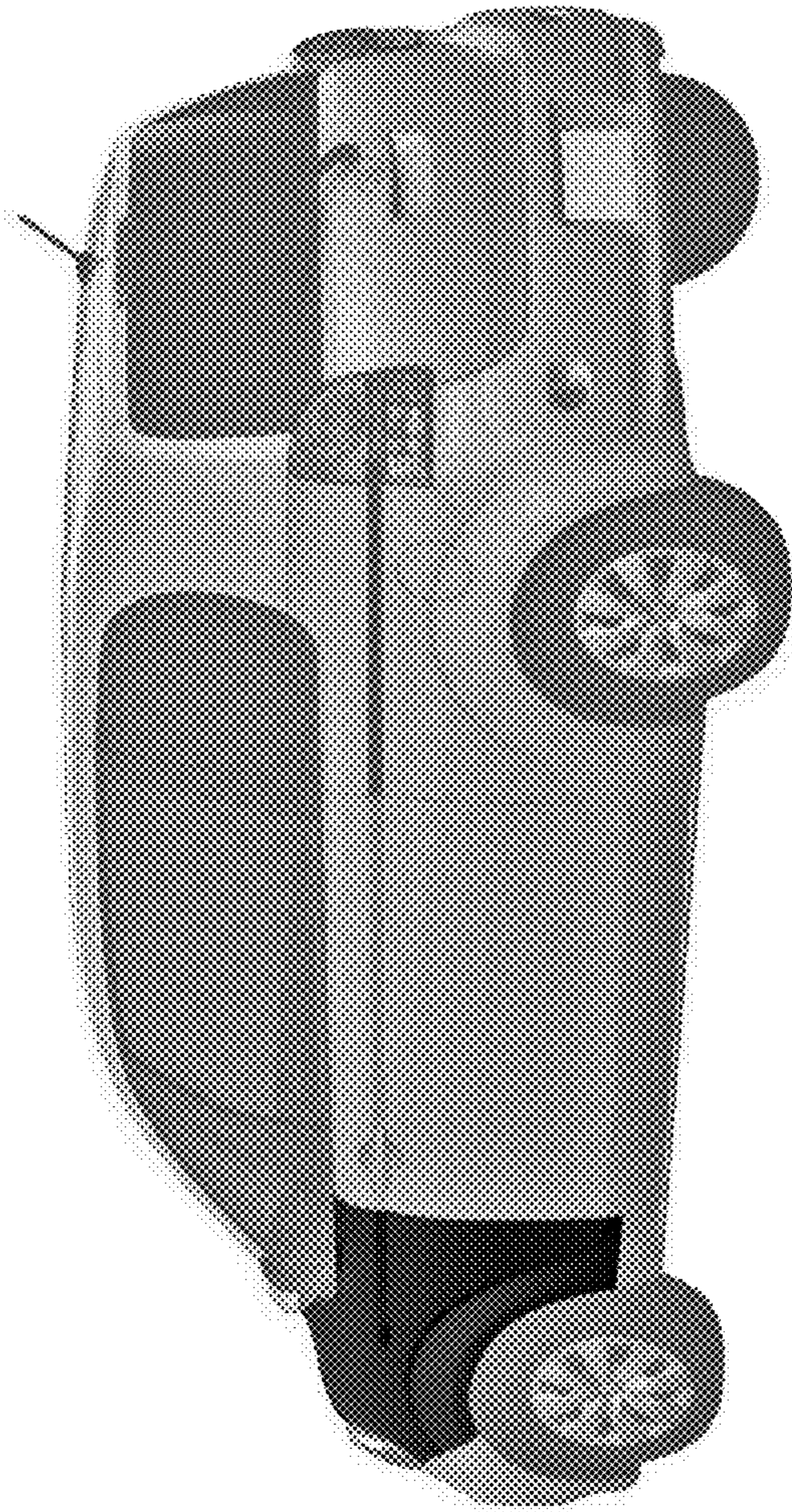

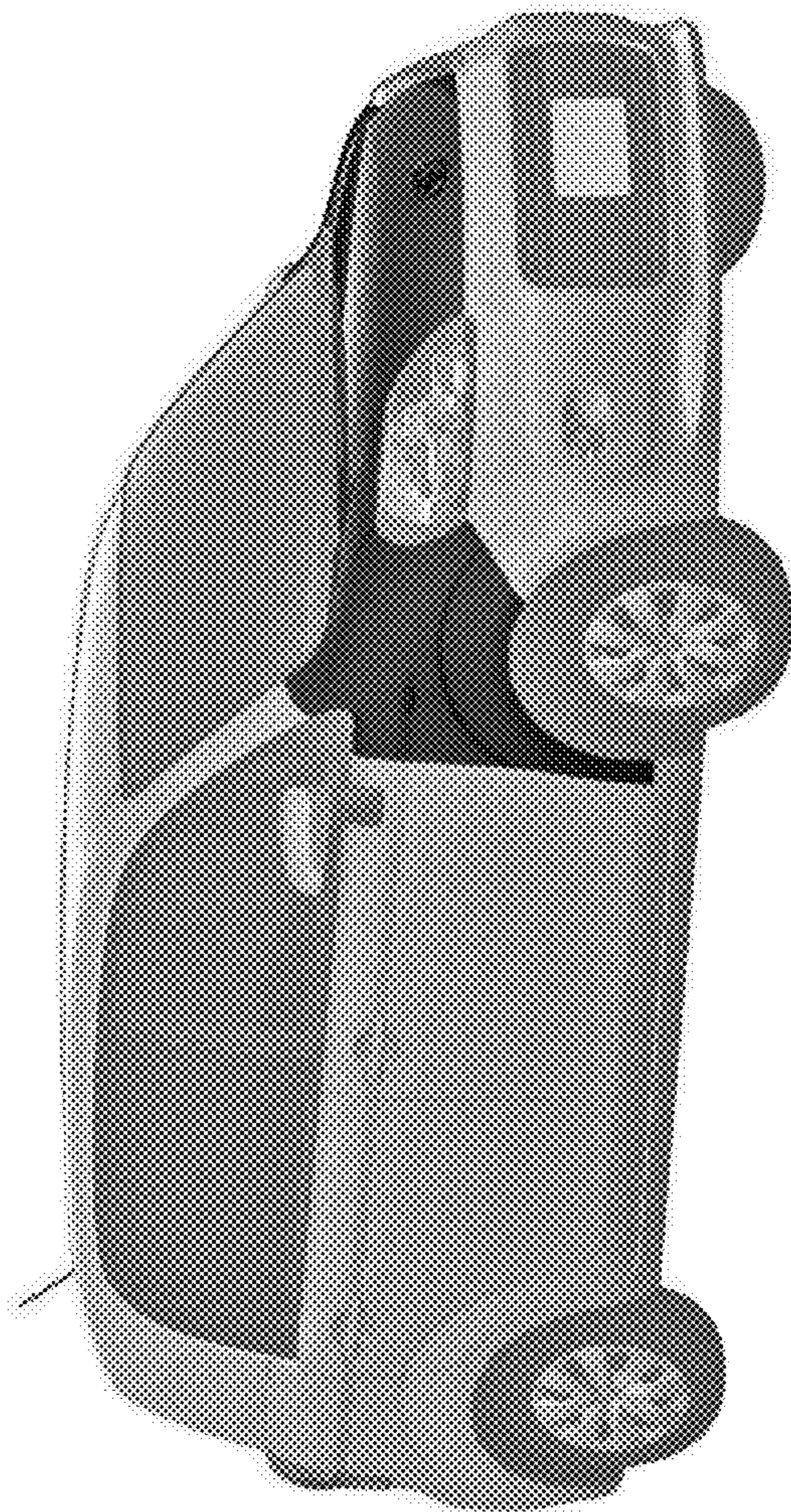

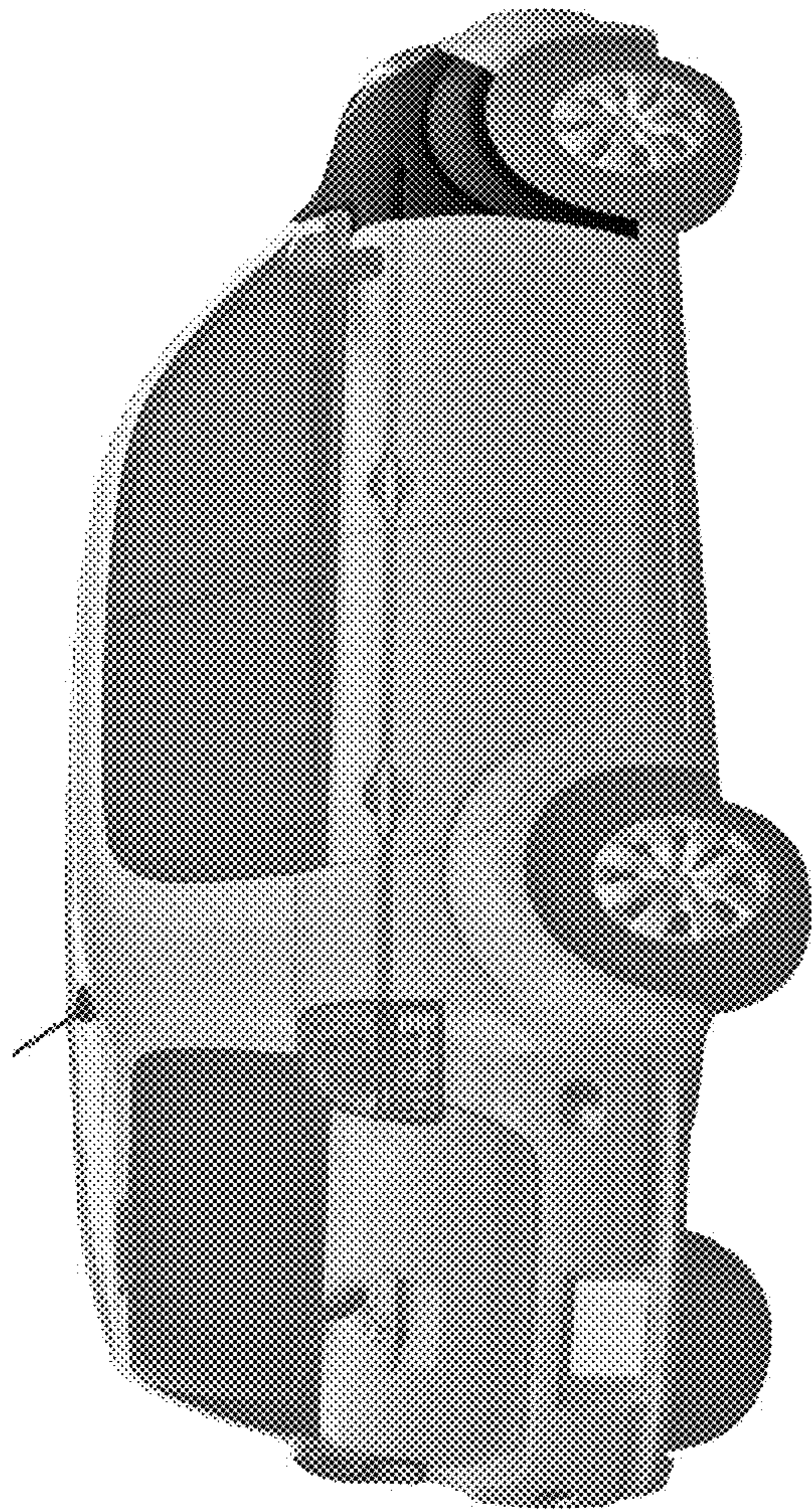

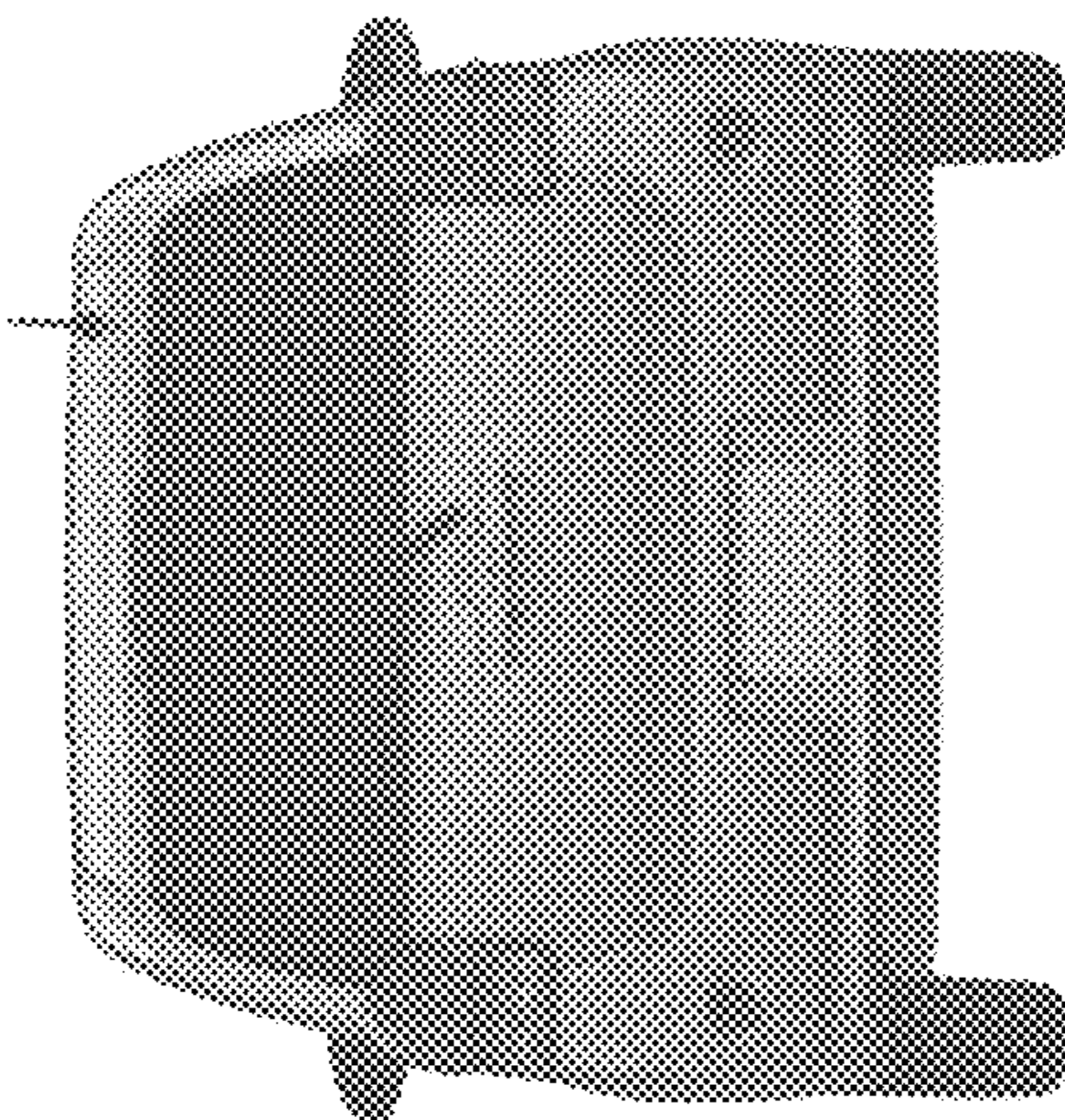

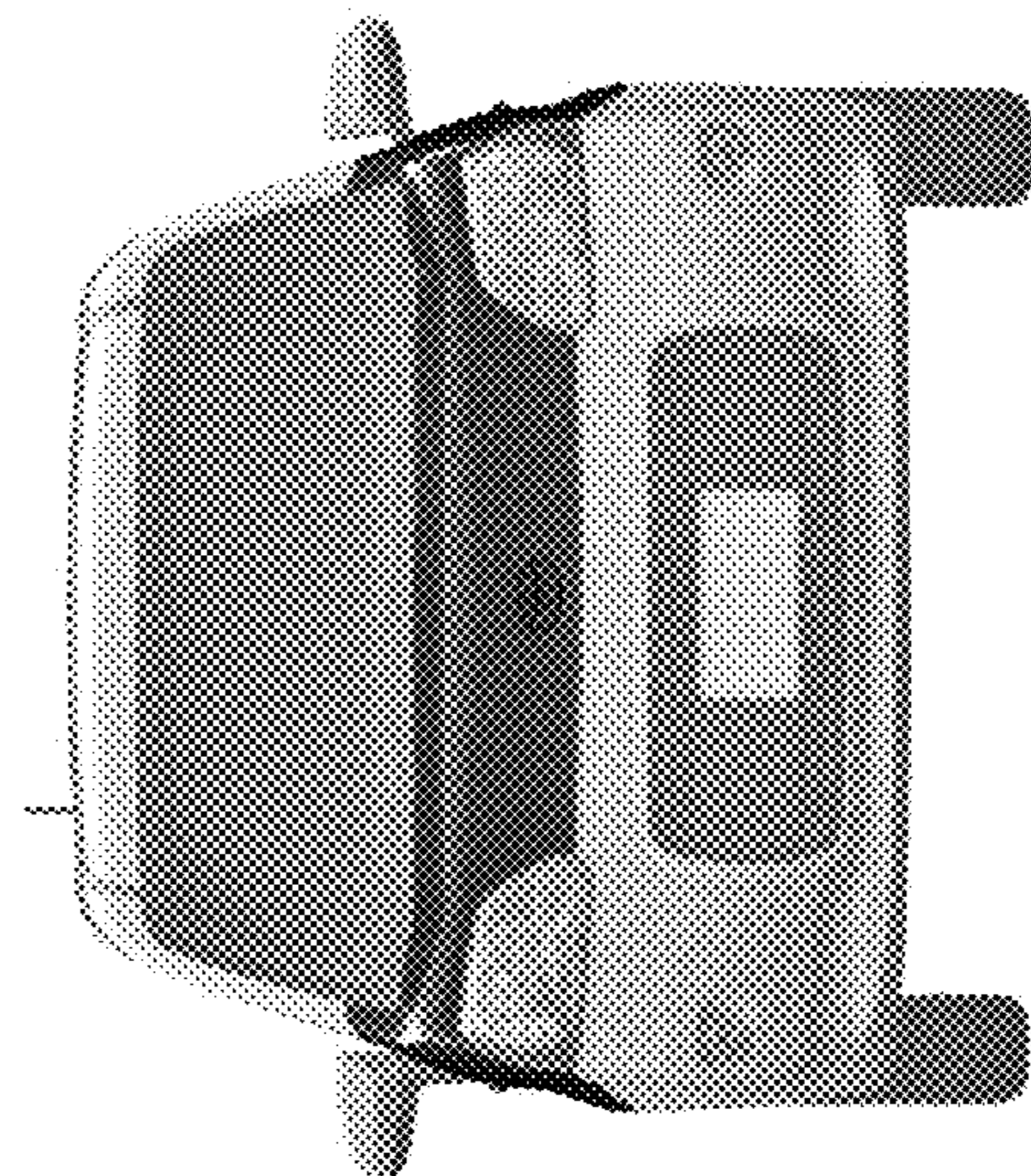

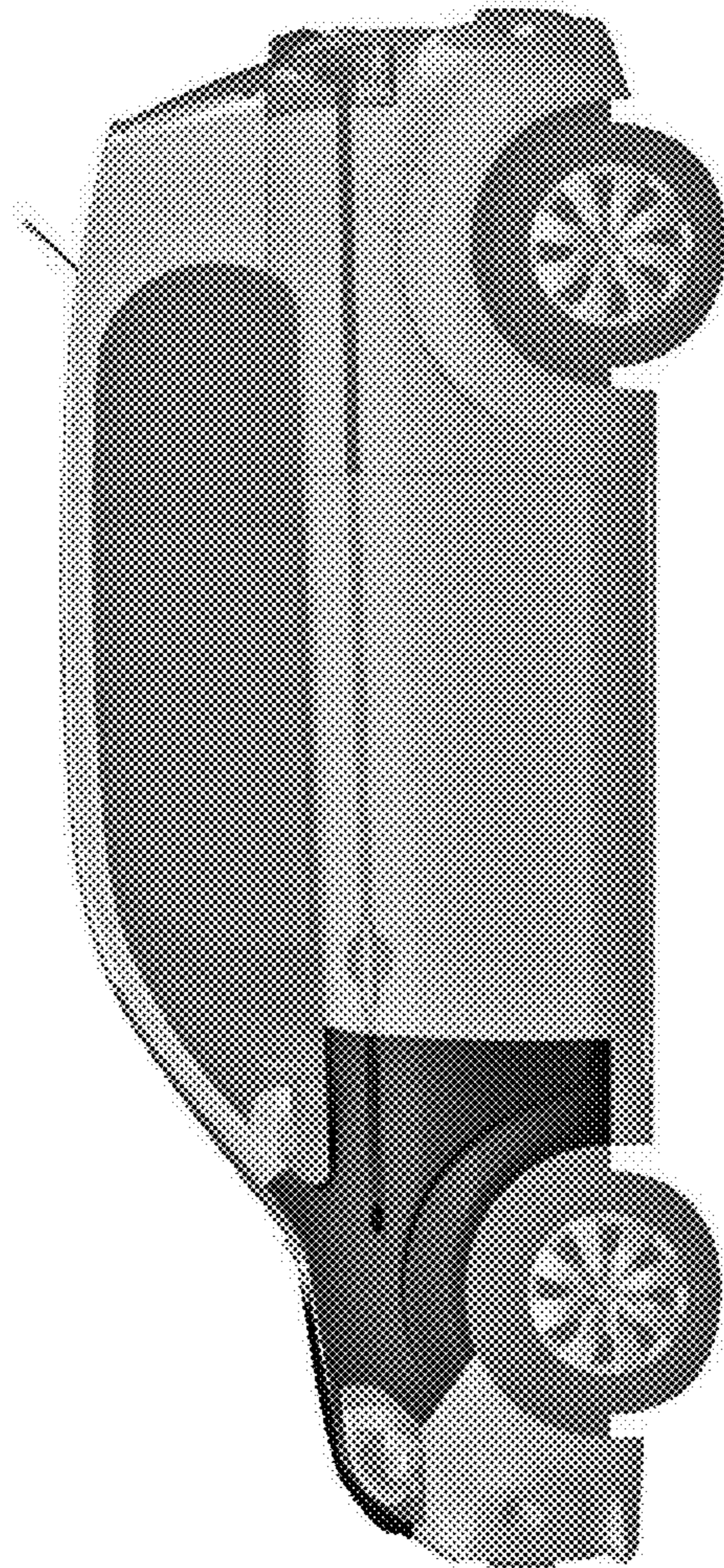

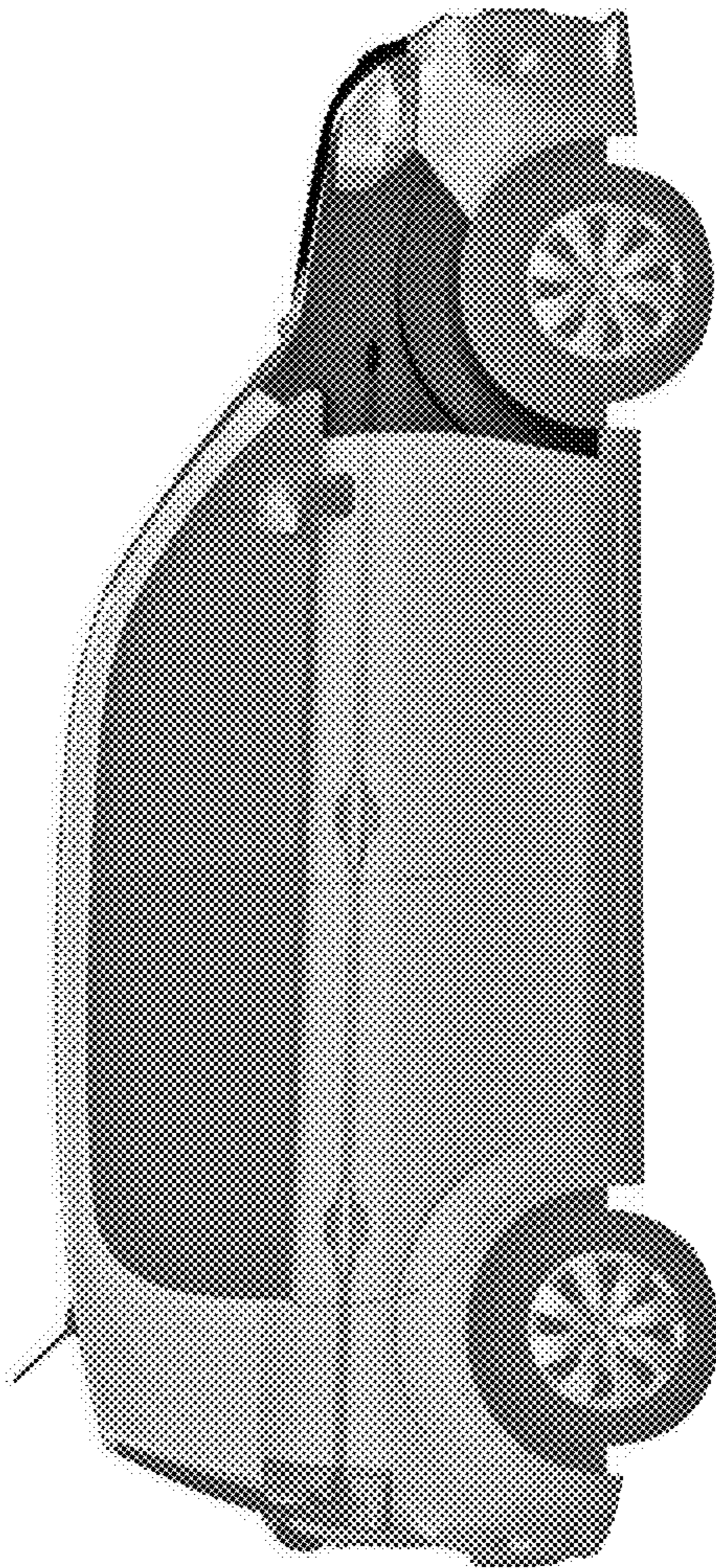

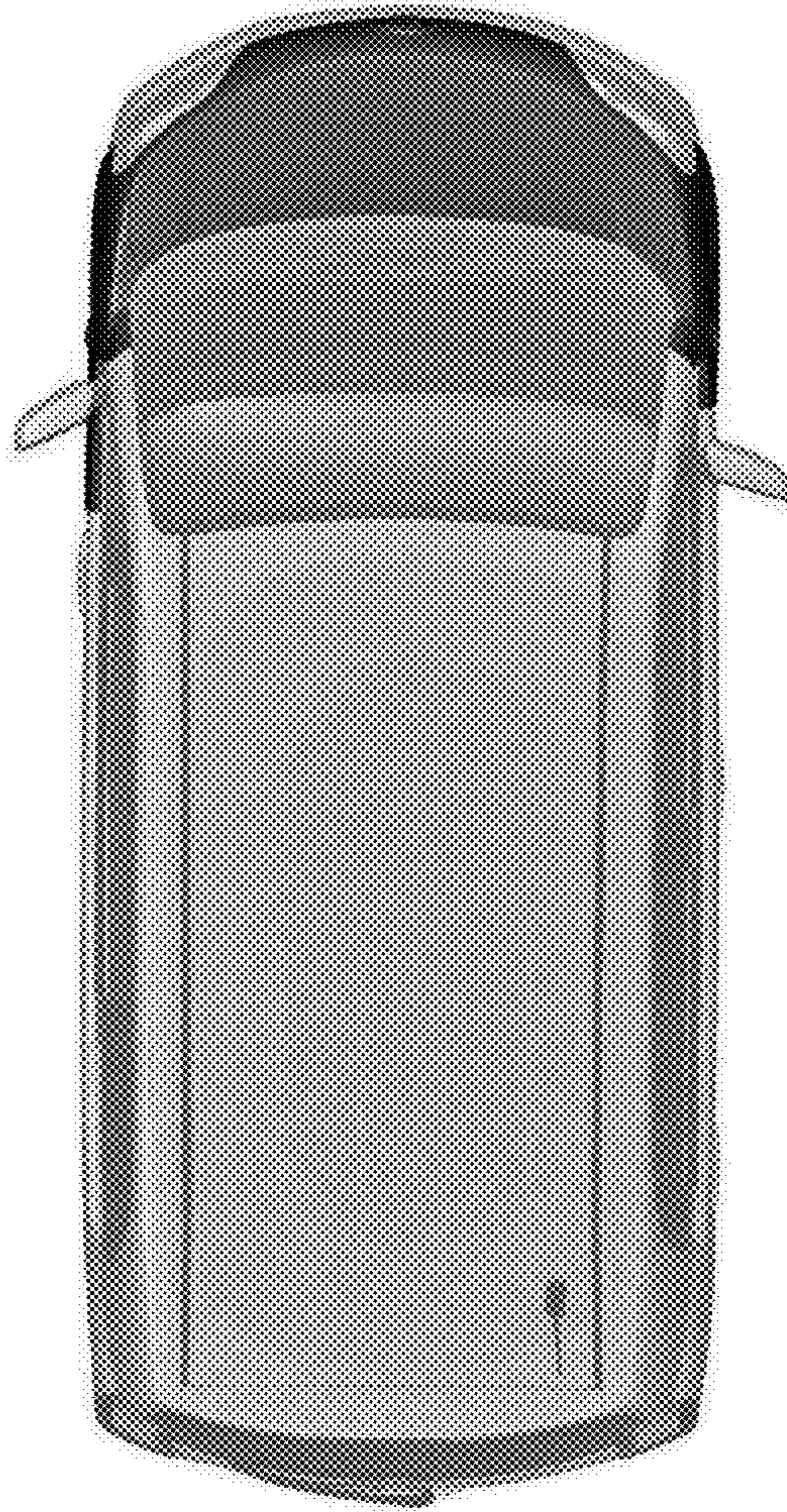
