FIG. 1 is a front view of a portion of a display with a graphical user interface showing a first embodiment of our new design; and,

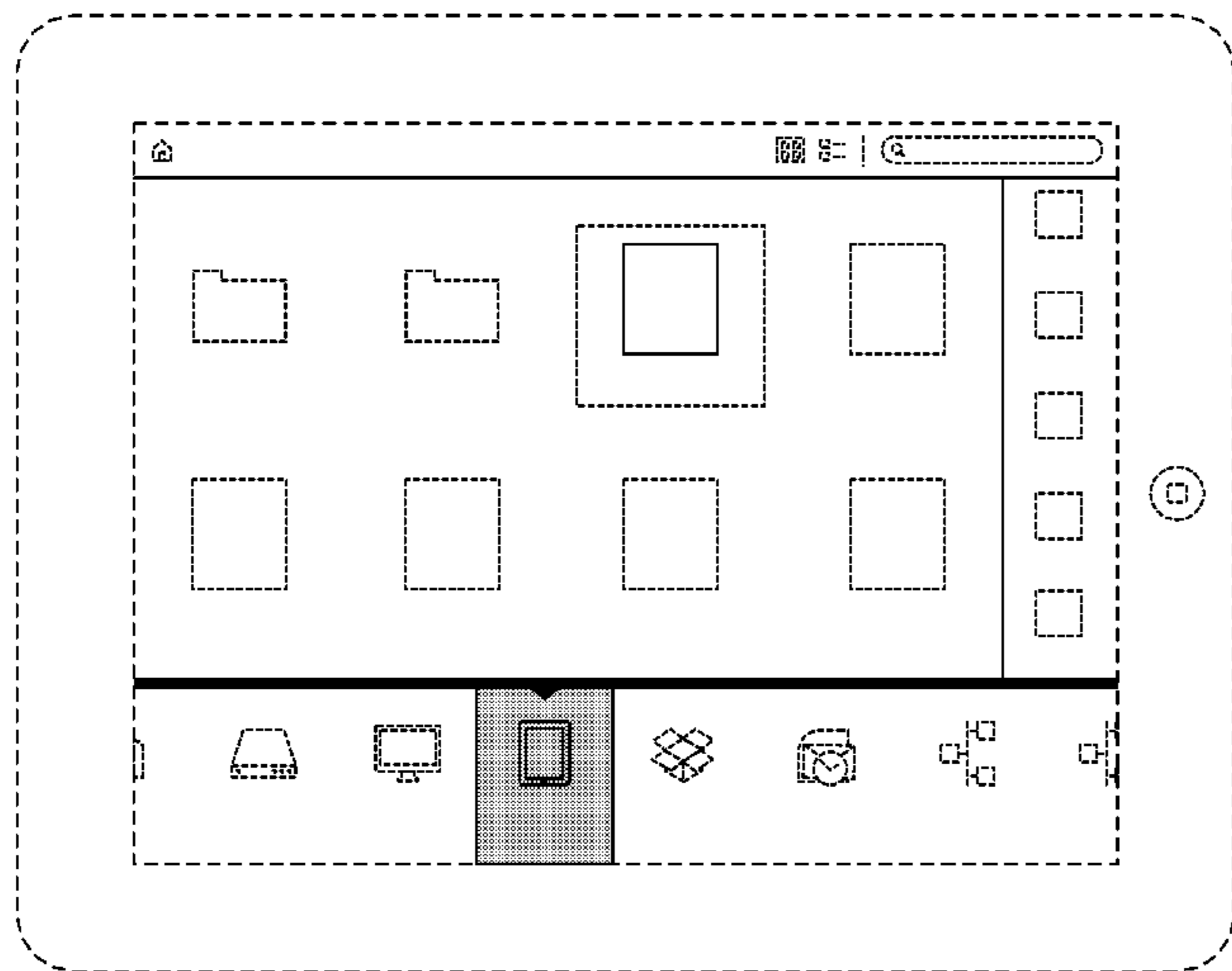
FIG. 2 is a front view of a second embodiment thereof.

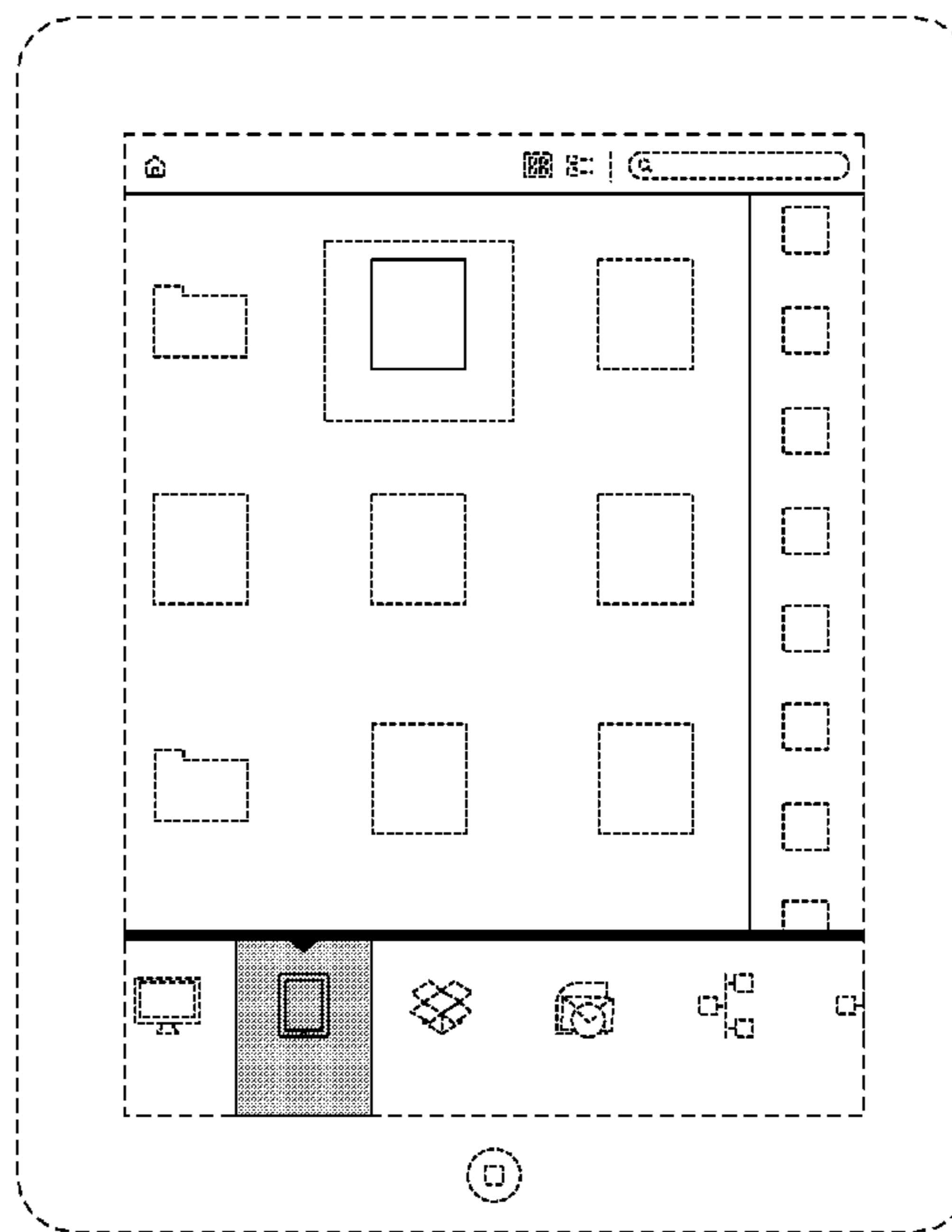

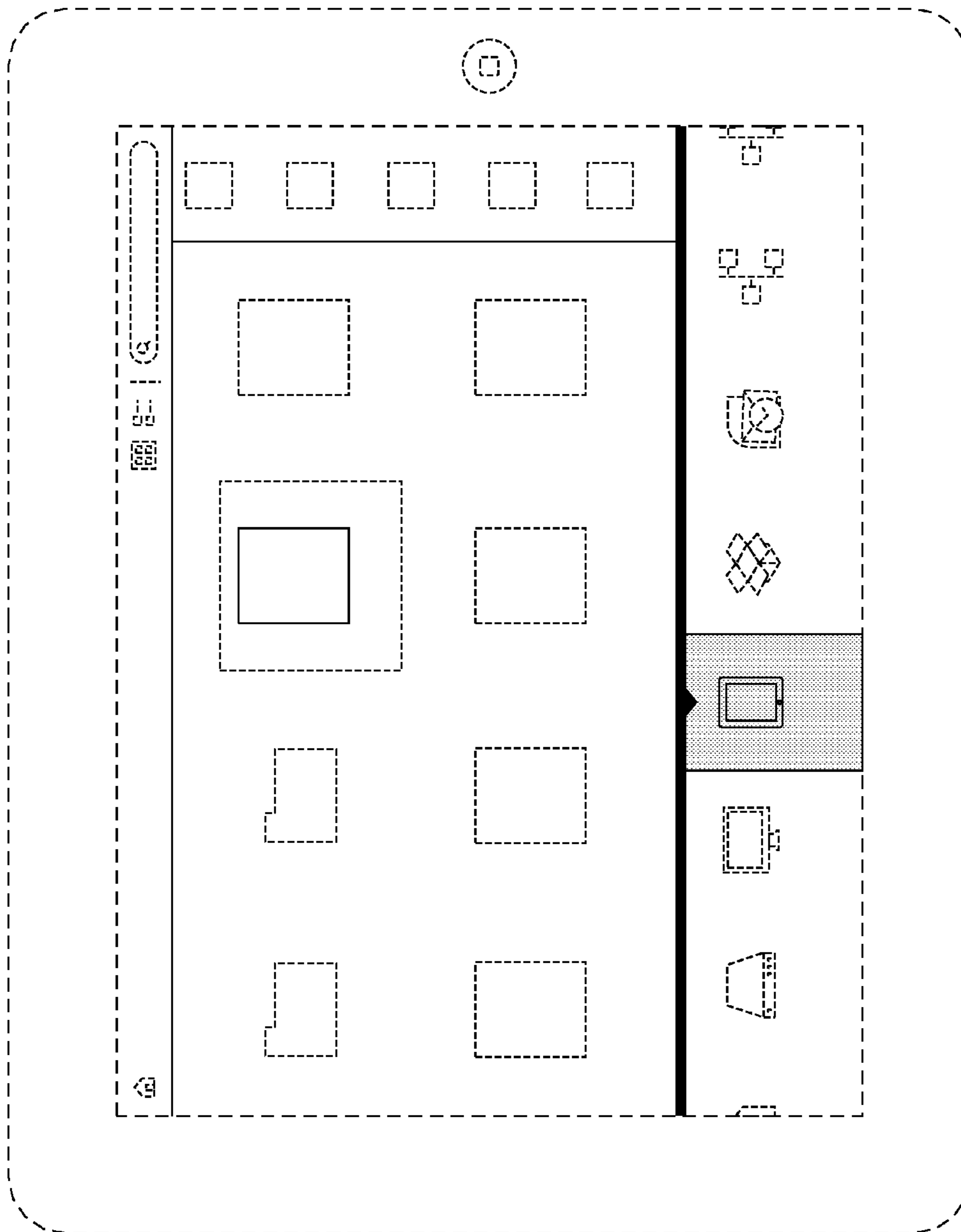

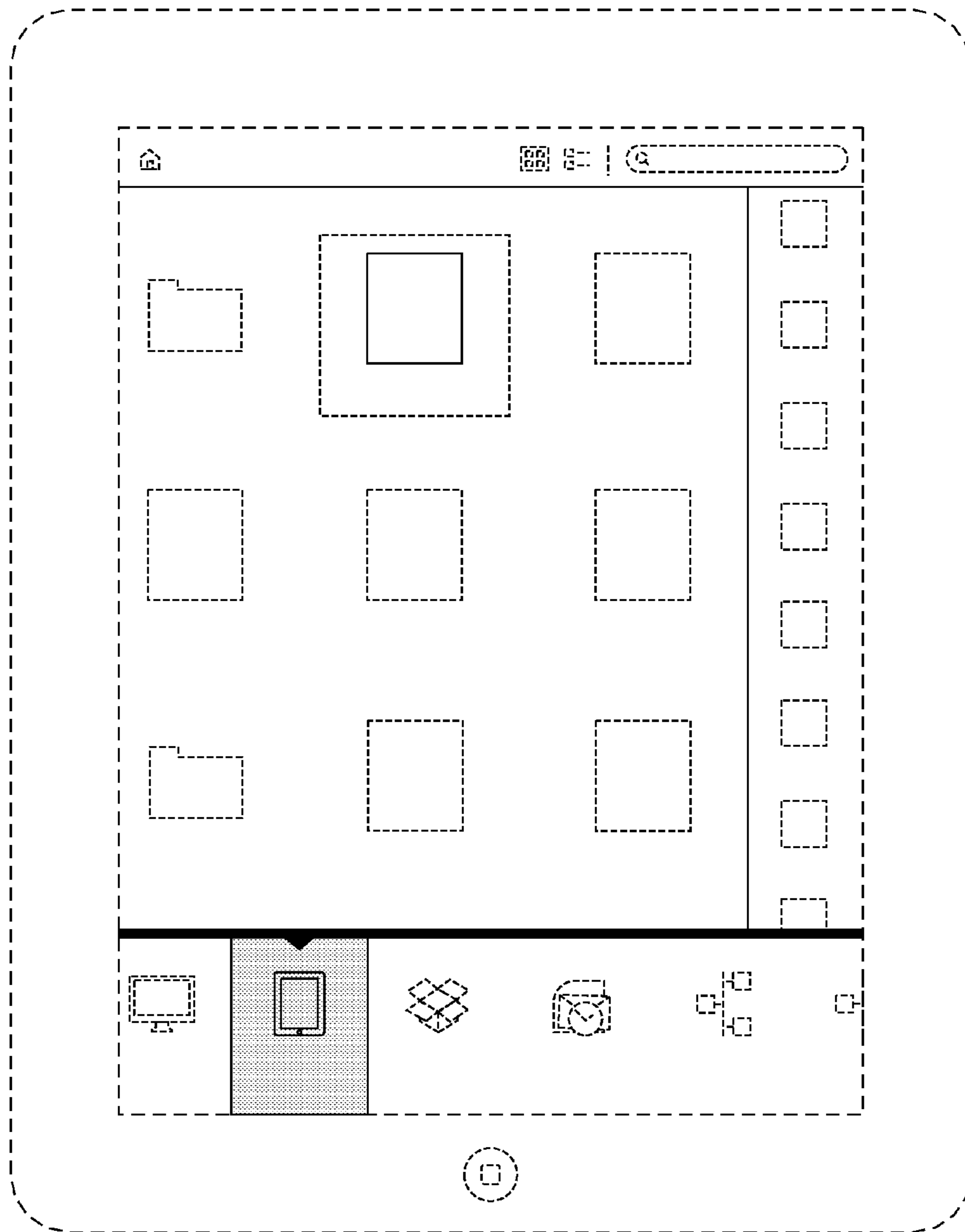
