(57) **CLAIM**

The ornamental design for a marker pen, as shown and described.

DESCRIPTION

FIG. 1 is a front side elevational view of a marker pen showing my new design.

FIG. 2 is a front elevational view thereof, the rear being a mirror image of the front view.

FIG. 3 is a left side elevational view of FIG. 1.

FIG. 4 is a right side elevational view of FIG. 1.

FIG. 5 is a top plan view of FIG. 1; and,

FIG. 6 is a bottom plan view of FIG. 1.

The broken lines showing the bottom in FIG. 6 are included for the purpose of including a portion that forms no part of the claimed design.

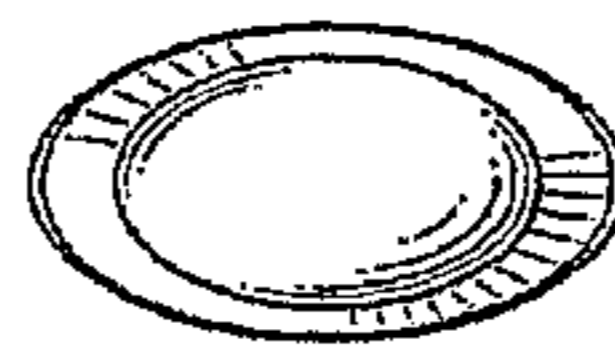
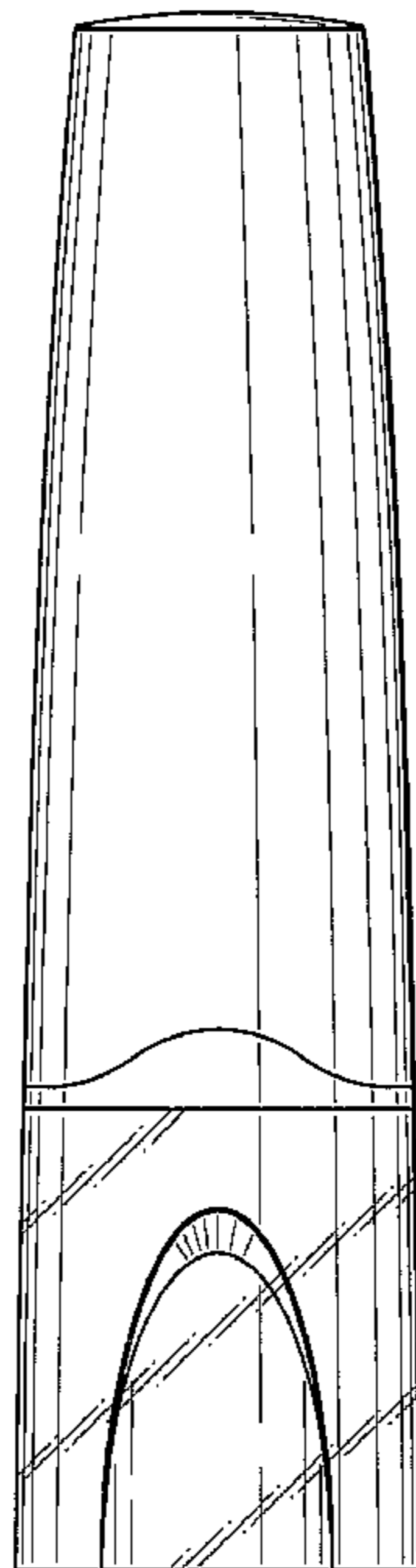

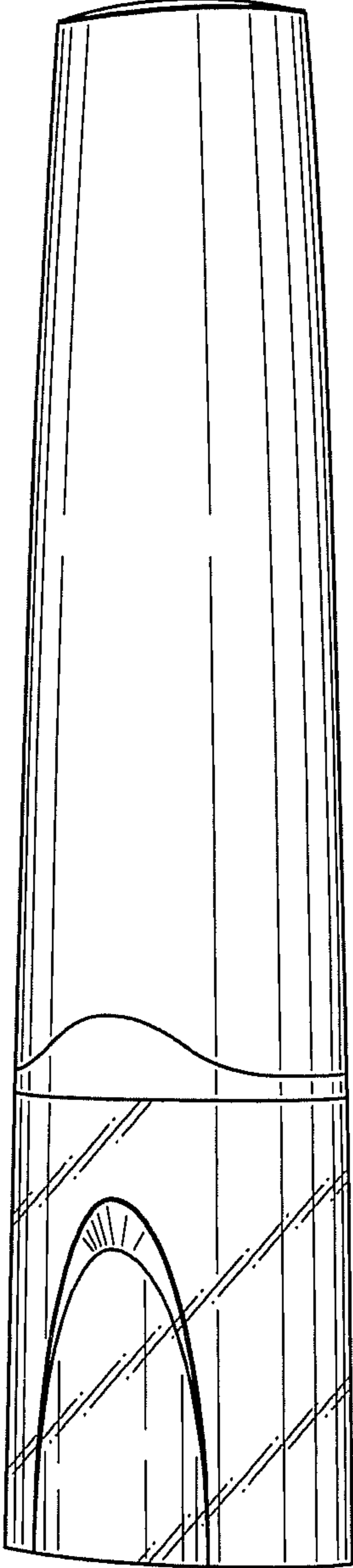

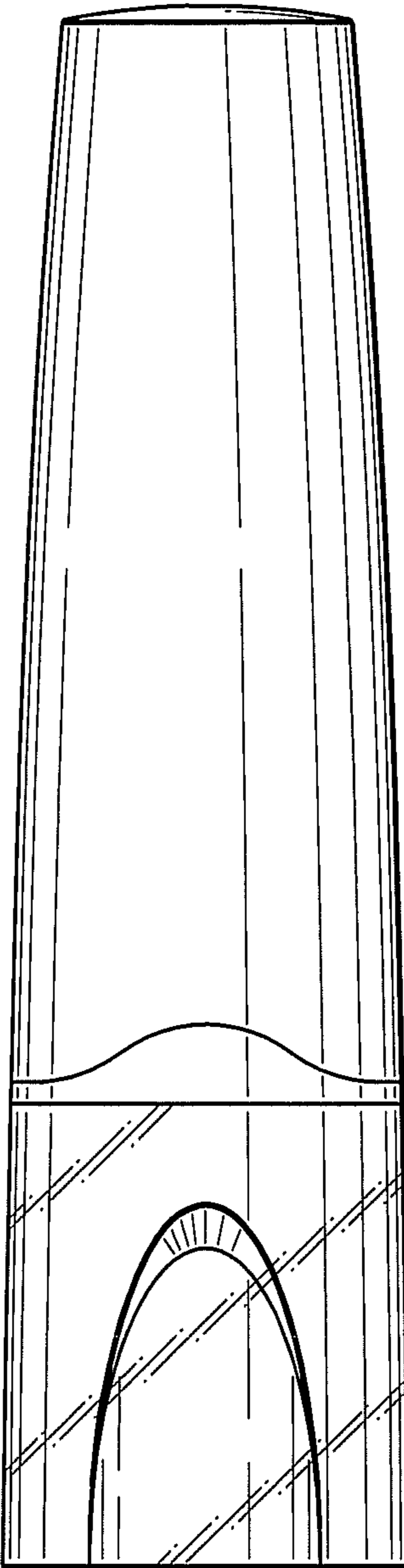

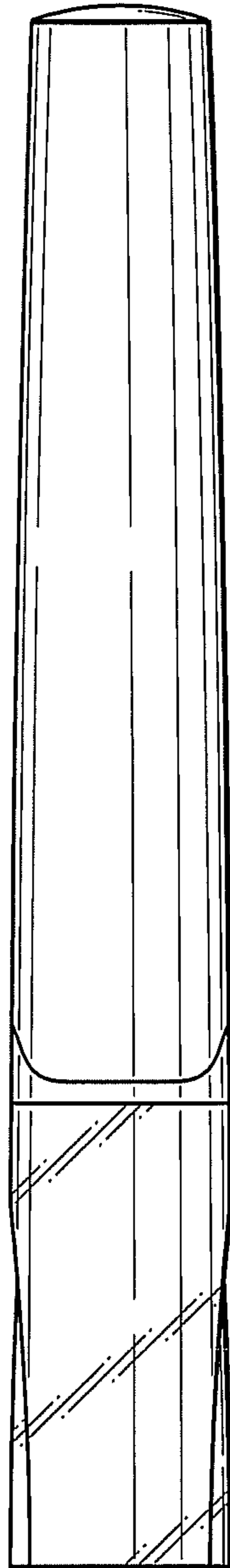

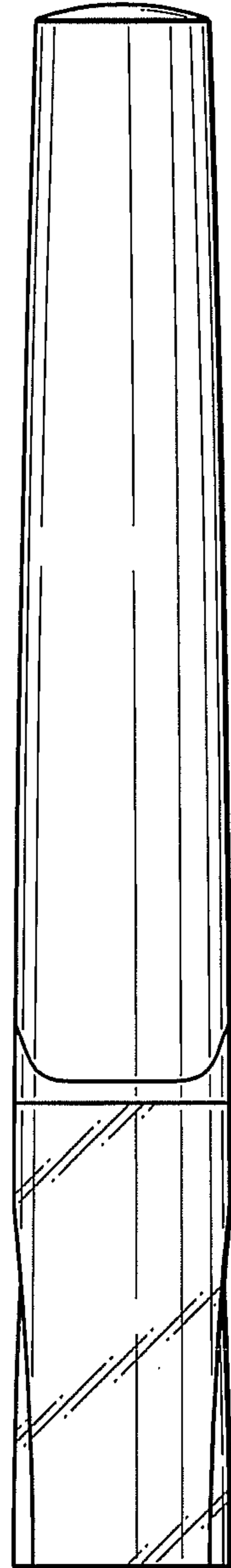

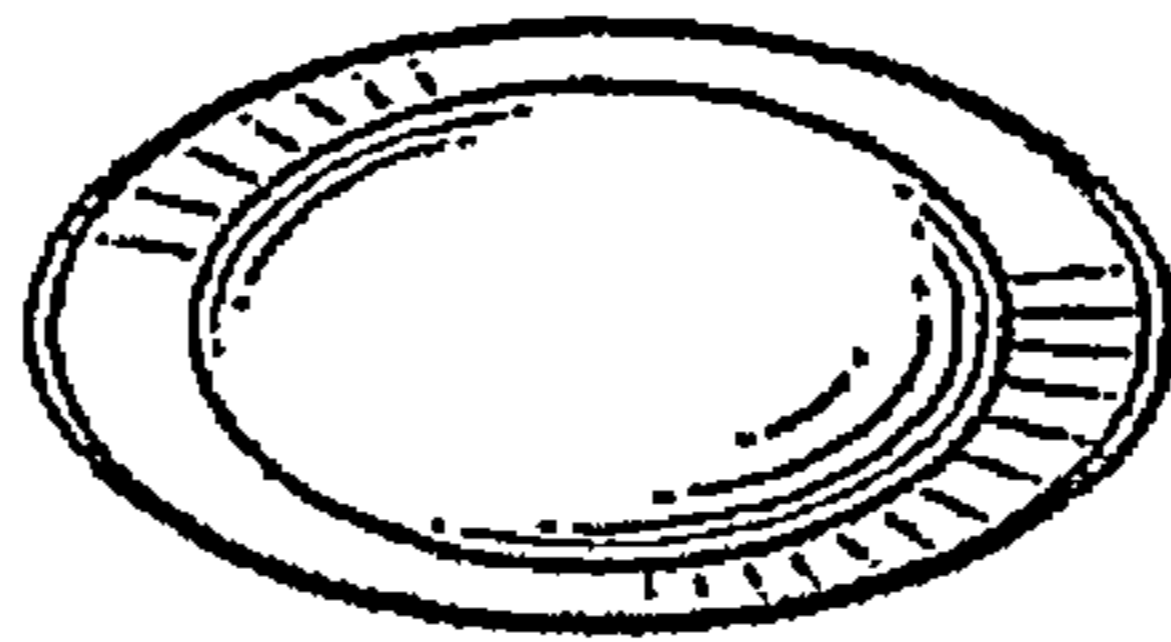
