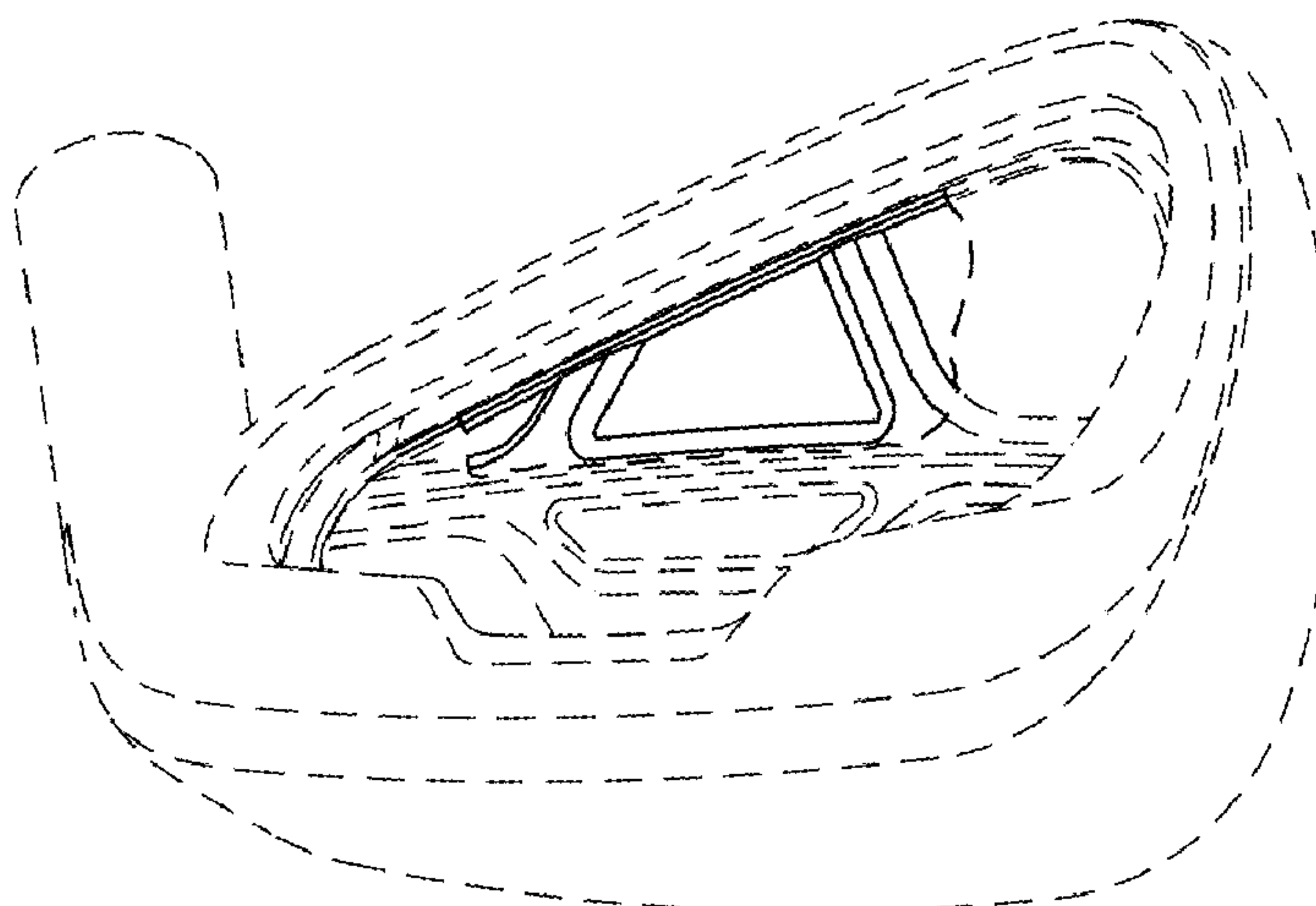
(57) **CLAIM**

The ornamental design for a golf club head, as shown and described.

DESCRIPTION

FIG. 1 is a front toe-side perspective view embodying the inventive design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a rear bottom perspective view thereof;
FIG. 4 is a rear toe-side perspective view thereof;
FIG. 5 is a rear heel-side perspective view thereof; and,
FIG. 6 is a rear toe-side perspective view thereof.
The broken lines immediately adjacent the shaded areas represent the bounds of the claimed design, while all other broken lines are directed to environment and are for illustrative purposes only; the broken lines form no part of the claimed design.

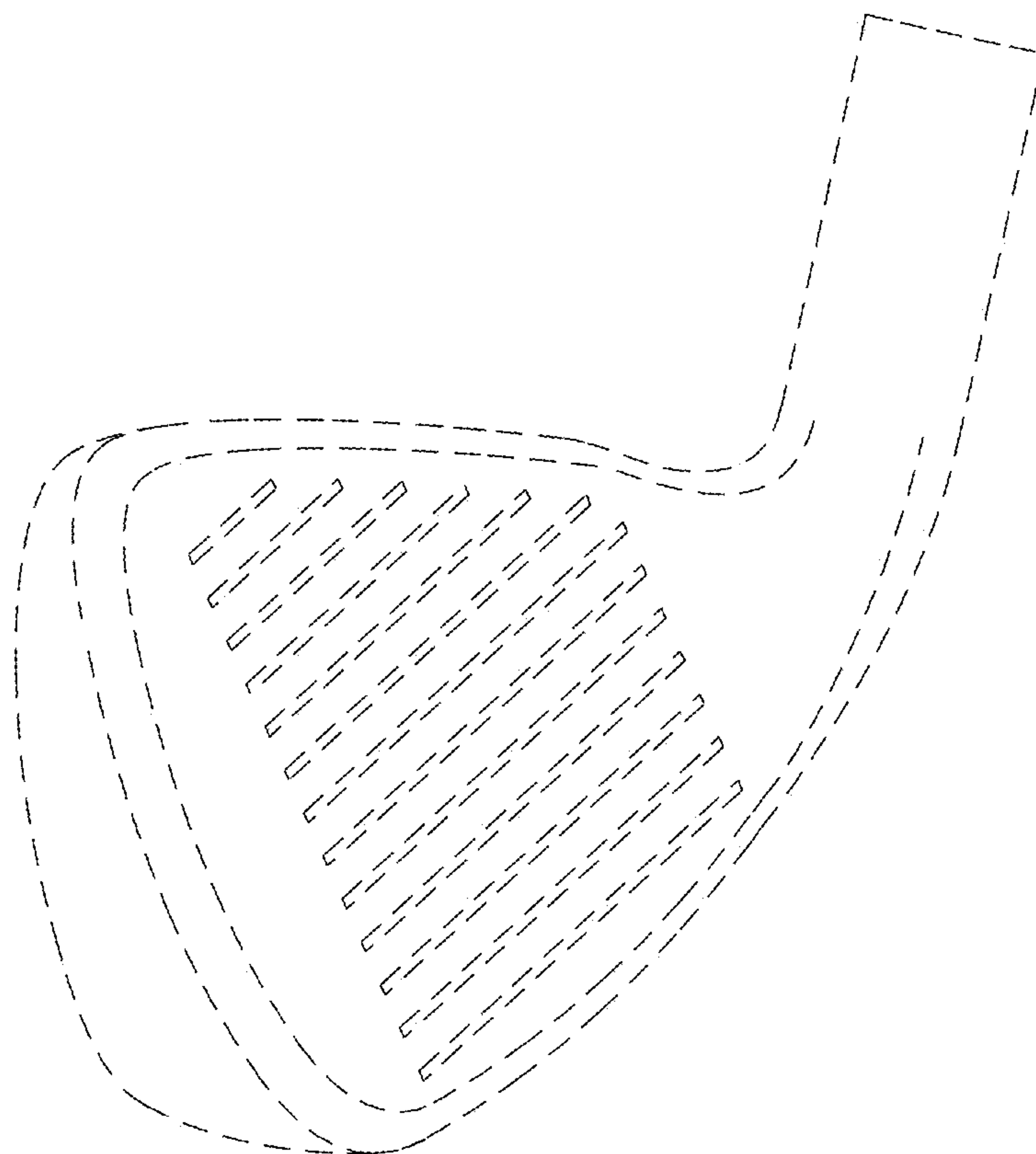

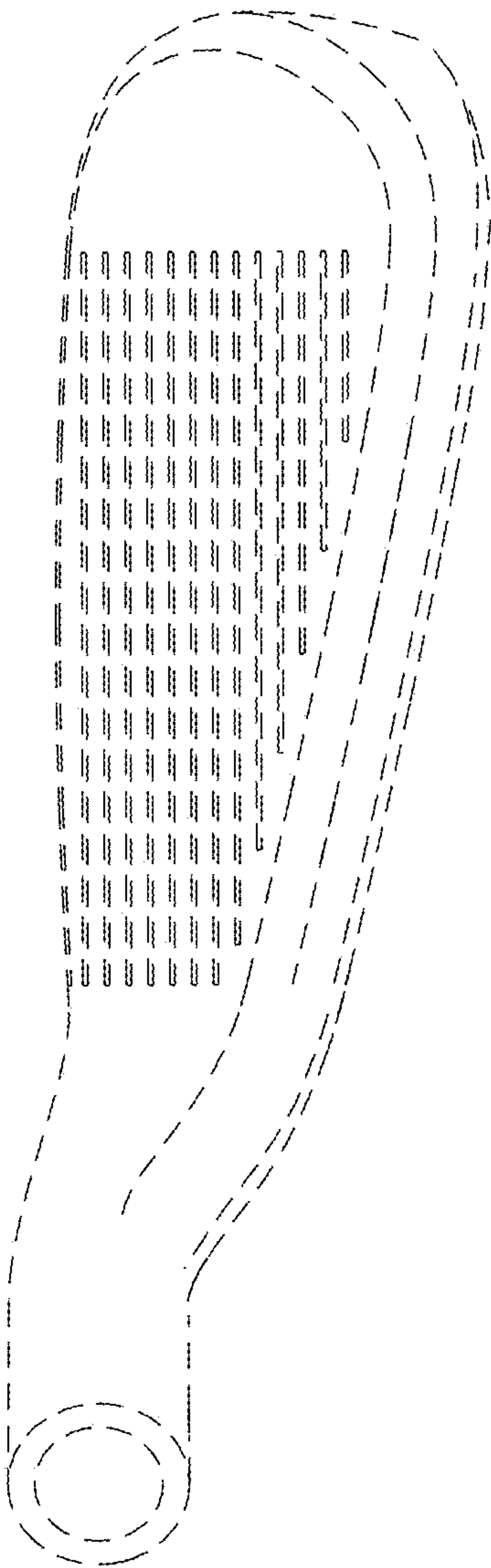

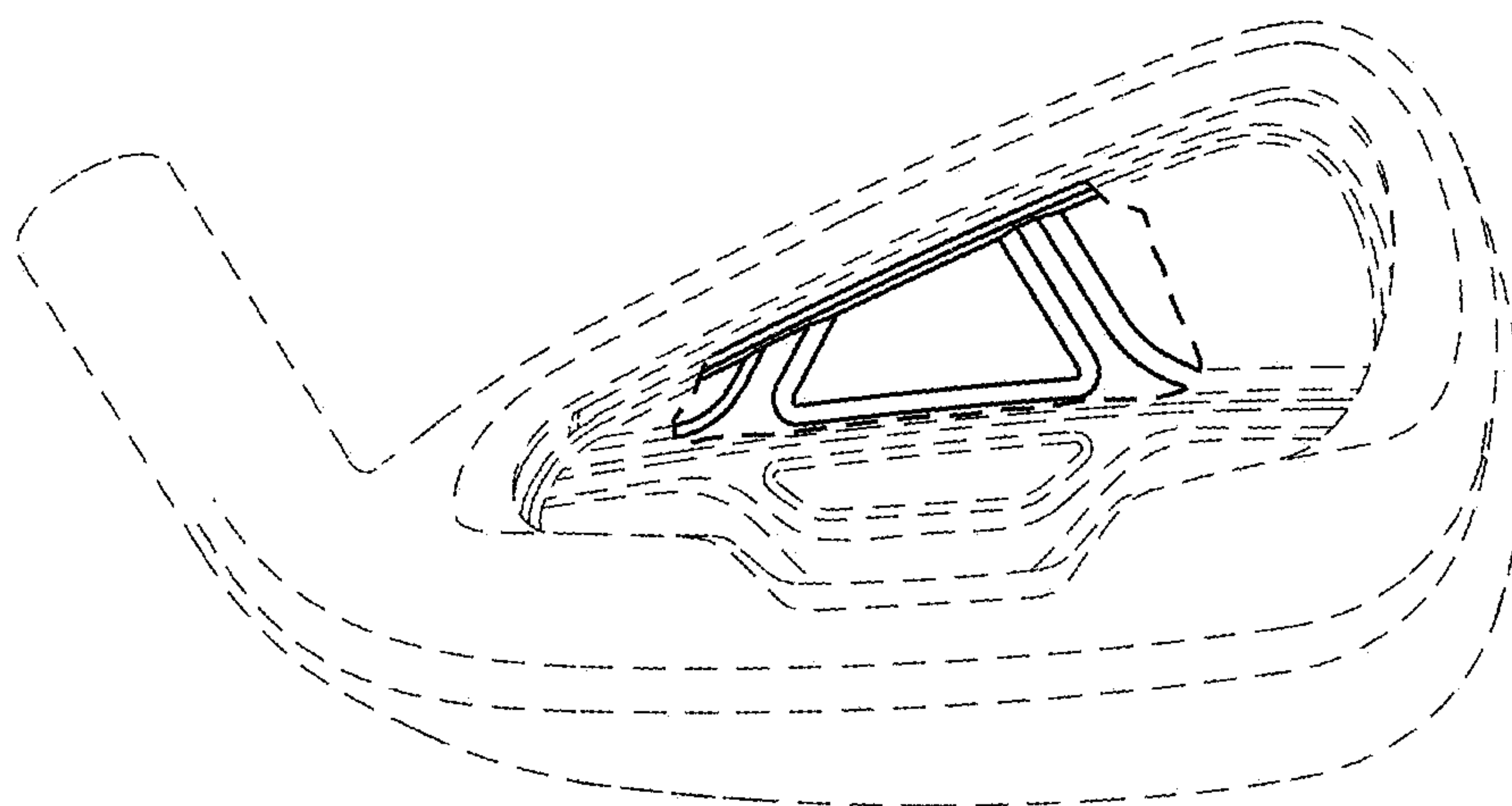

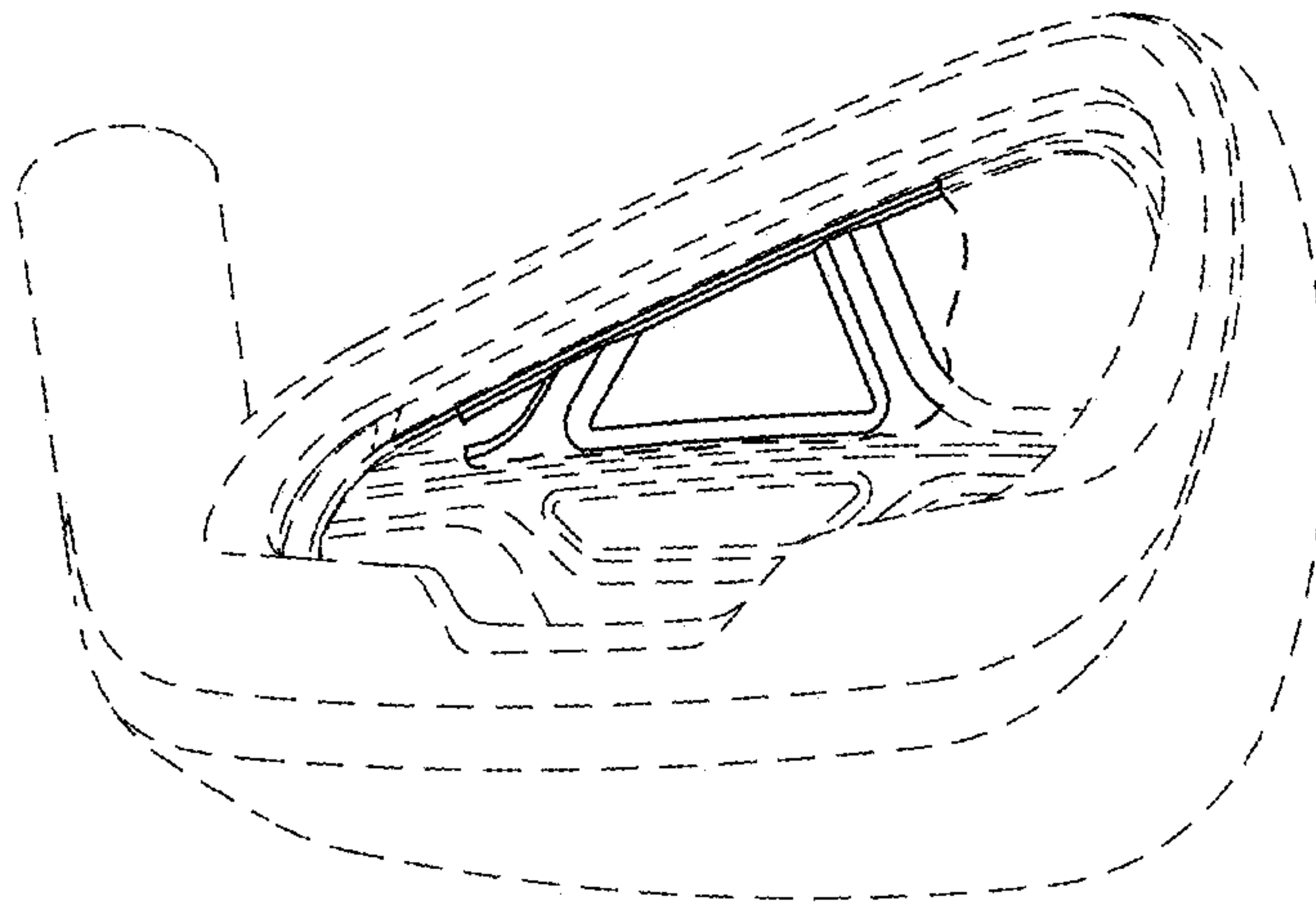

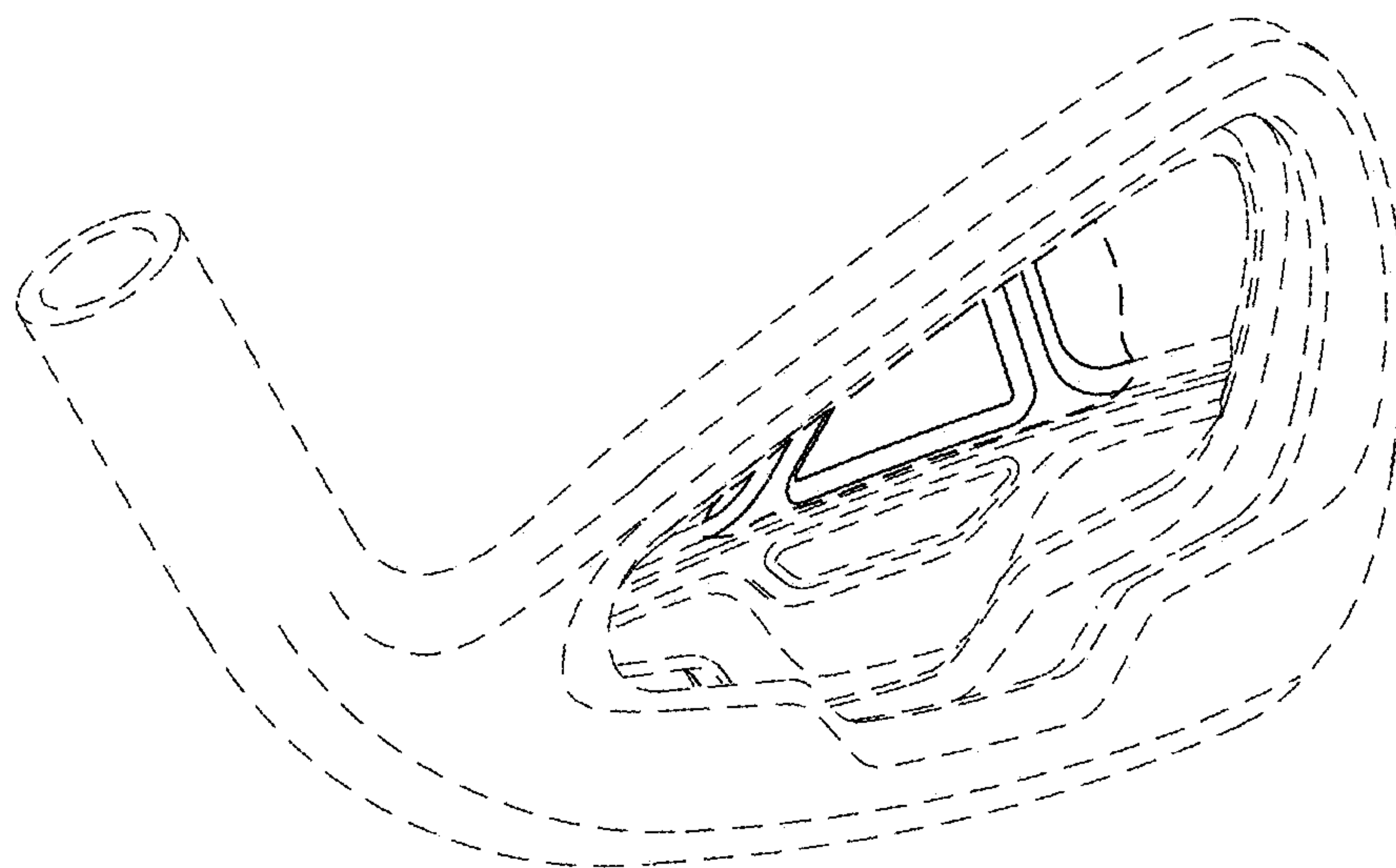

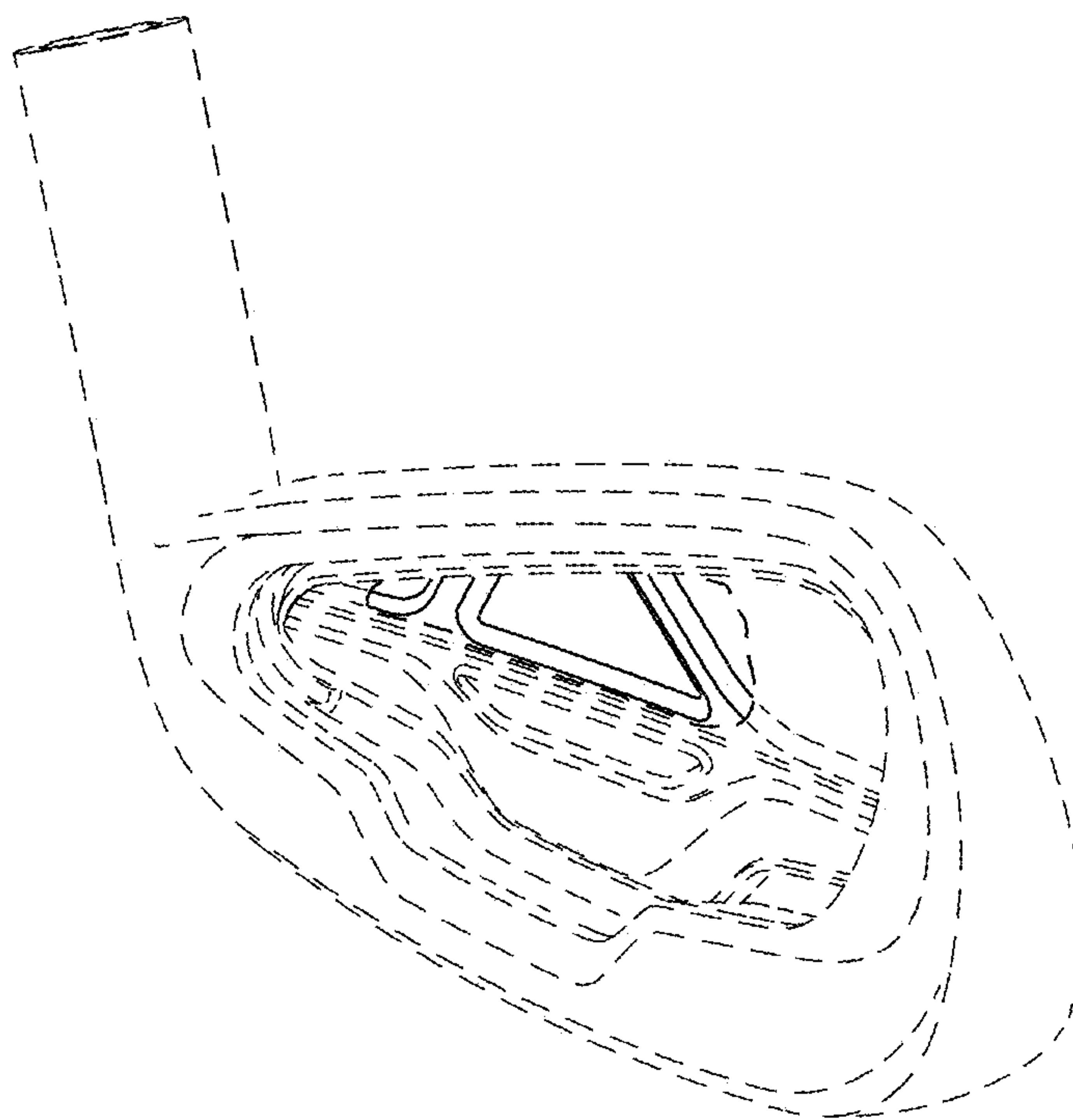
