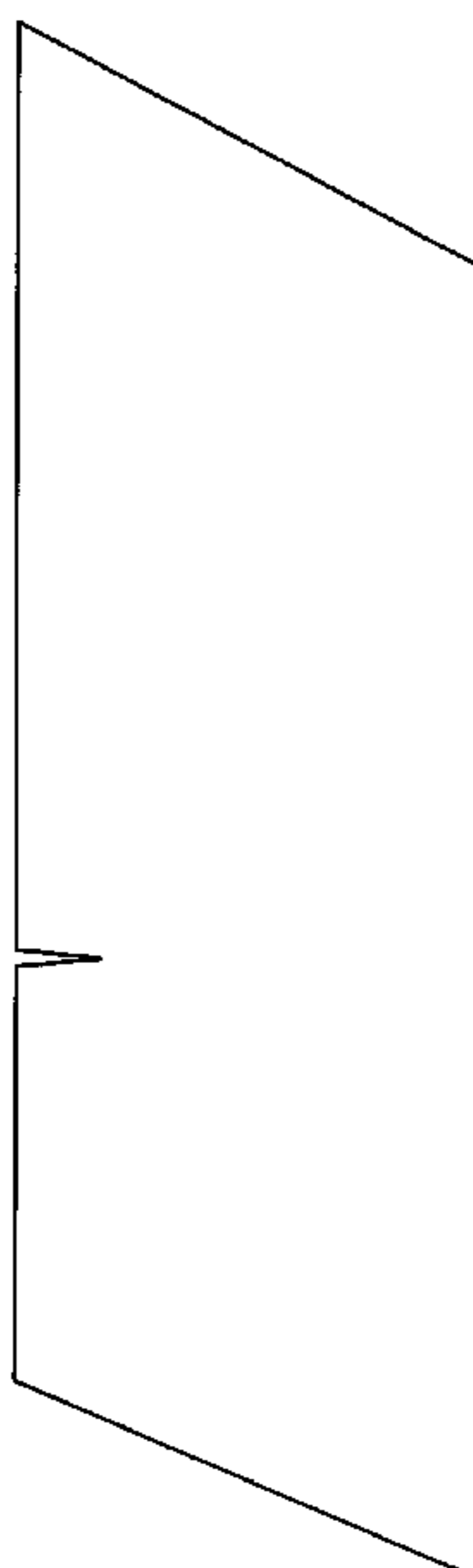
(57) **CLAIM**

The ornamental design for protective spat for cleated or spiked sports shoes, as shown and described.

DESCRIPTION

FIG. 1 is a side elevational view of a protective spat for cleated or spiked sports shoes showing our new design; FIG. 2 is a rear perspective view thereof, shown in a semi-open configuration prior to use; FIG. 3 is a bottom perspective view thereof shown in use; FIG. 4 is a top plan view thereof; FIG. 5 is a bottom perspective view of the design of FIG. 5 in use on an unclaimed shoe; FIG. 6 is a left side elevational view thereof; and, FIG. 7 is an opposite side elevational view thereof. The showing of a shoe inserted in the protective spat for cleated or spiked sports shoes in FIGS. 5-7 is for illustrative purposes only and forms no part of the claimed design.

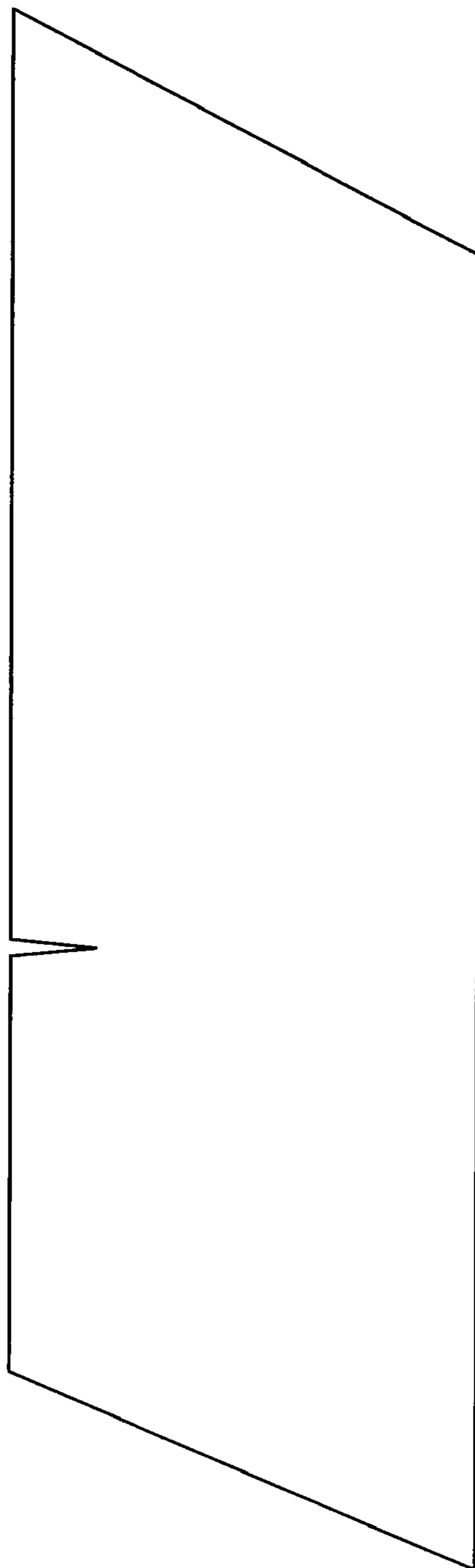

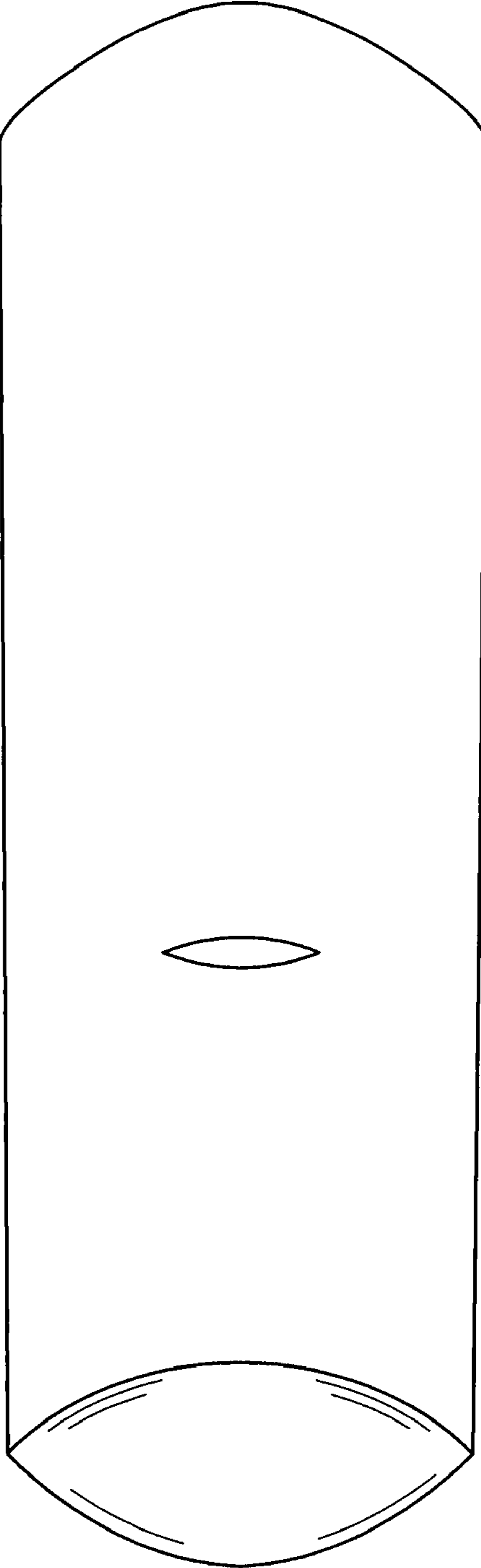

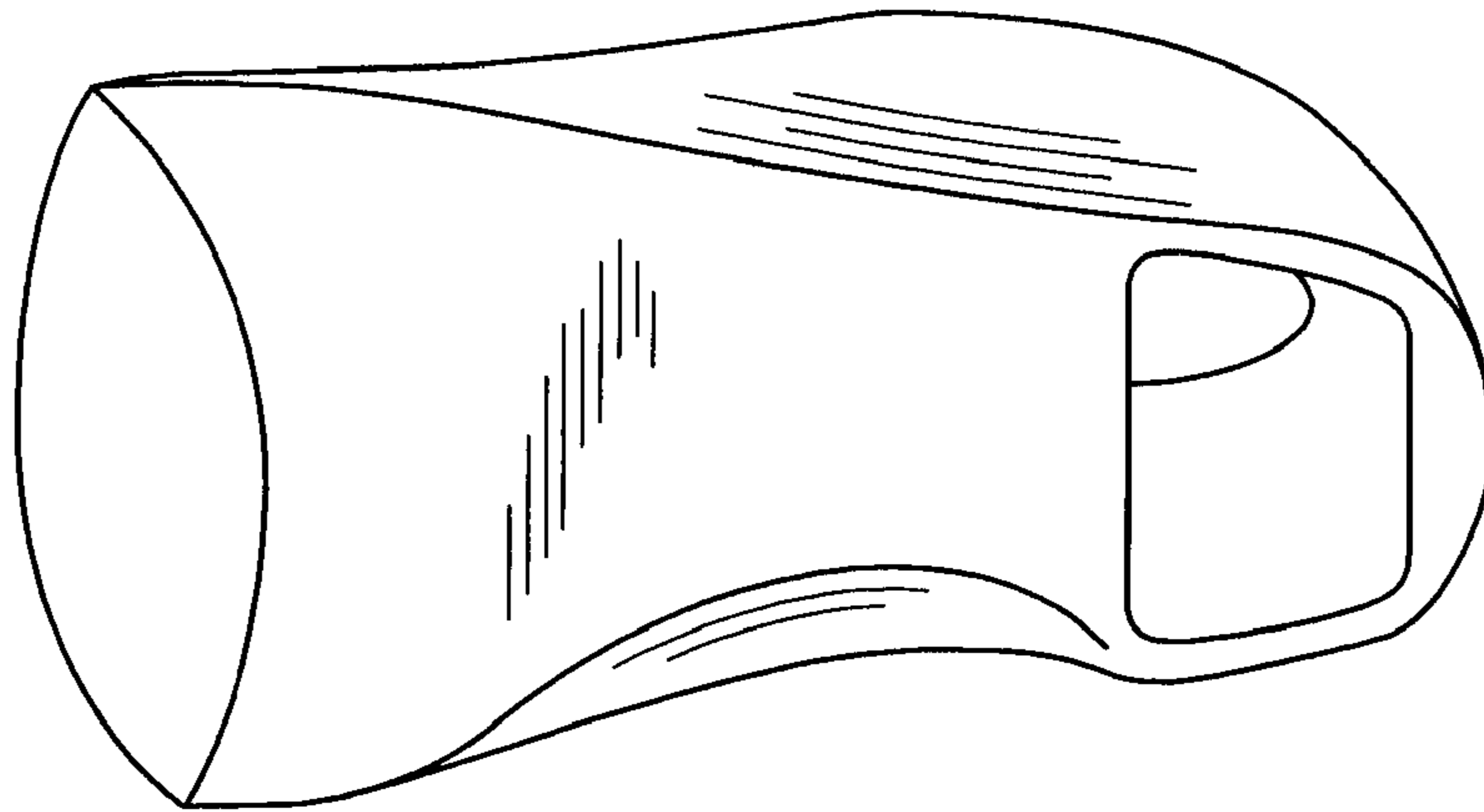

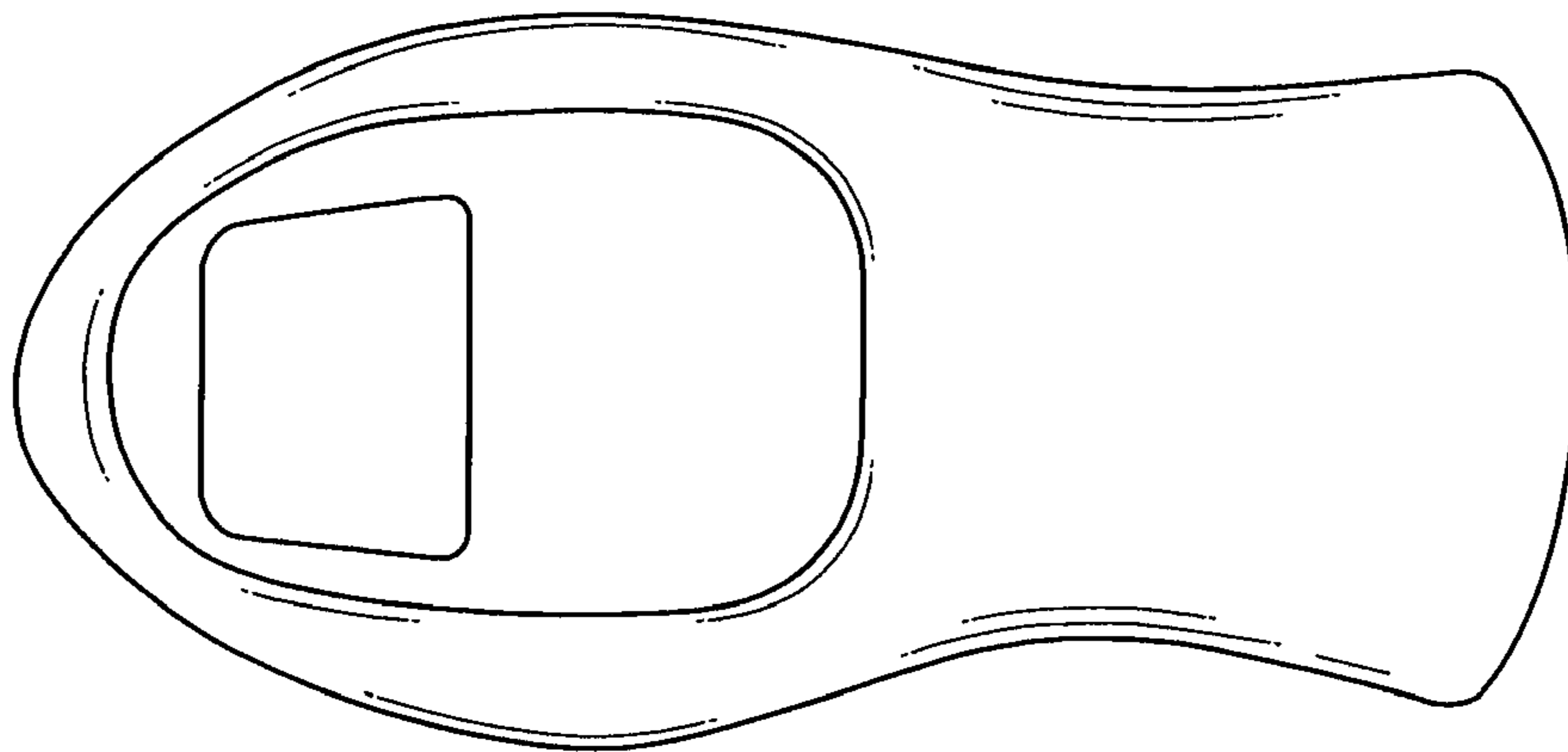

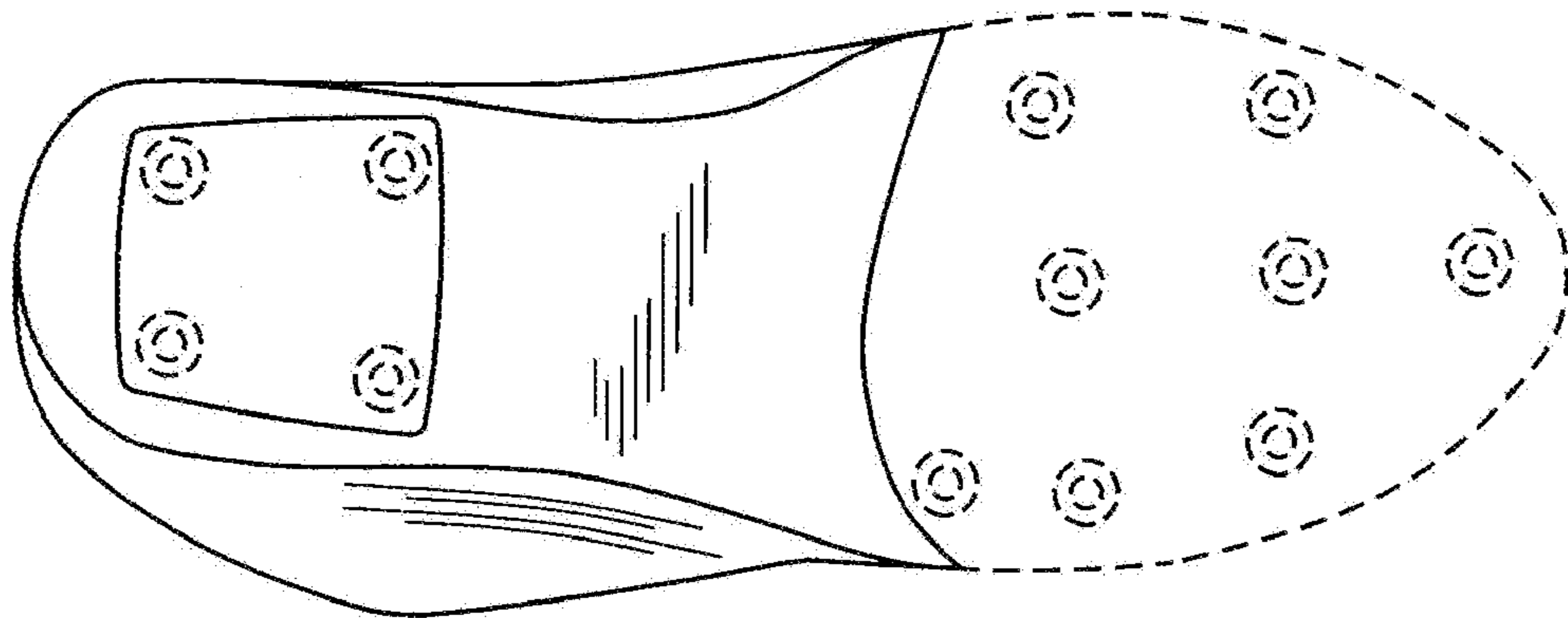

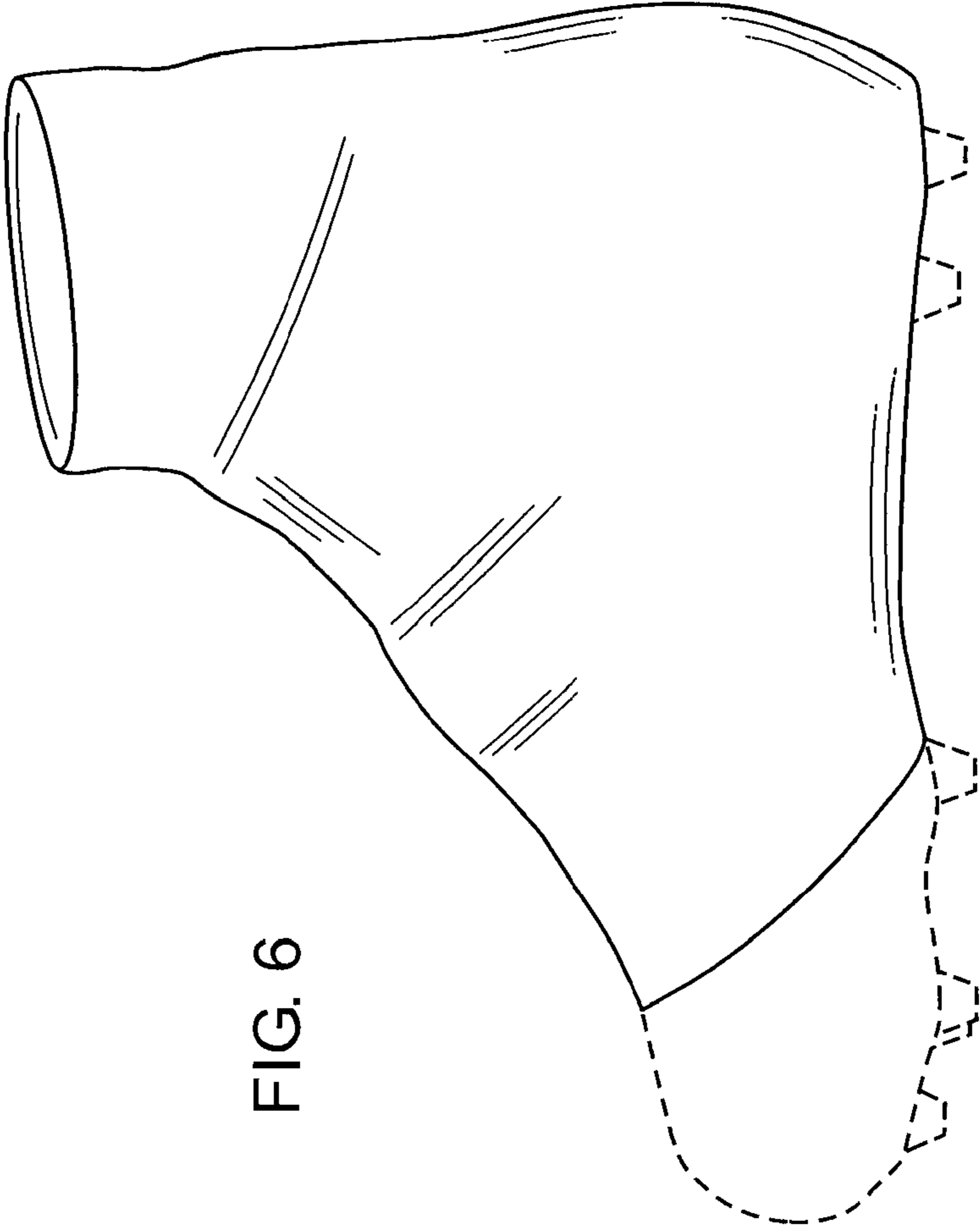
