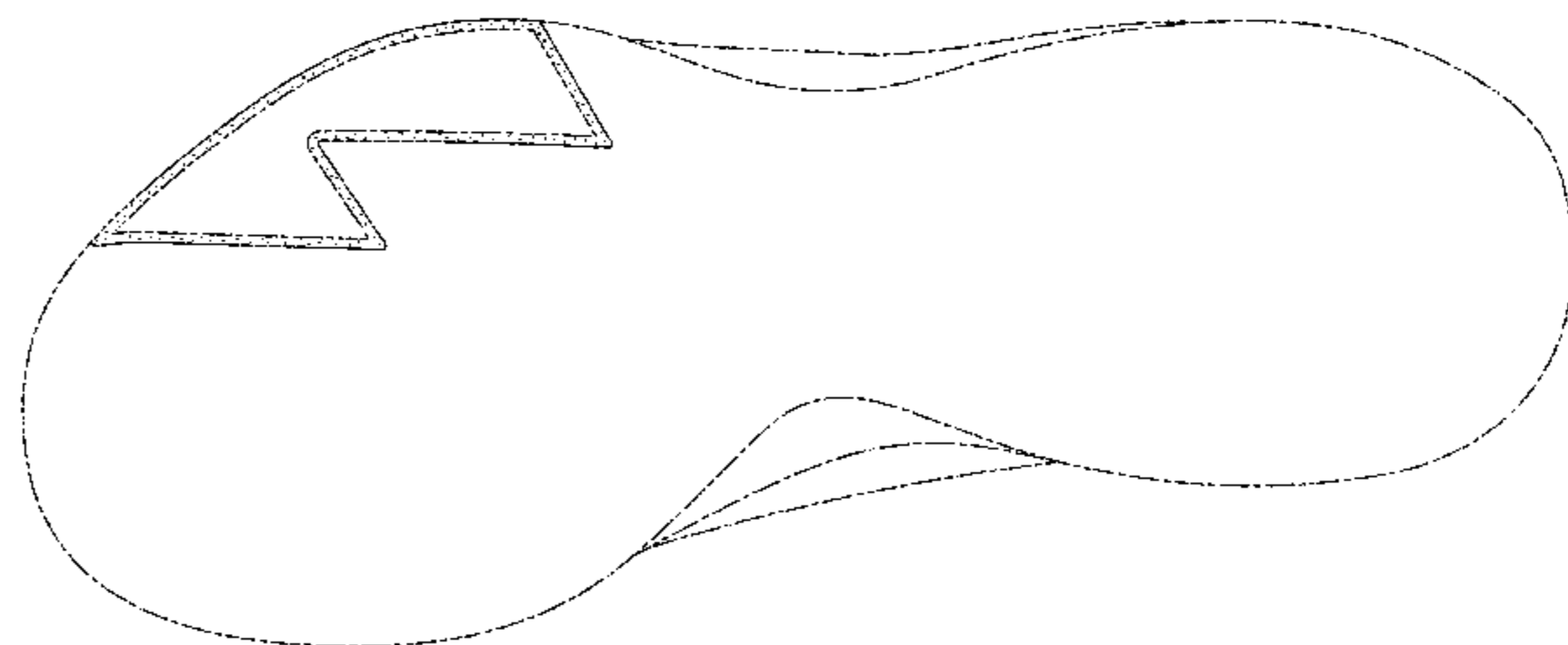
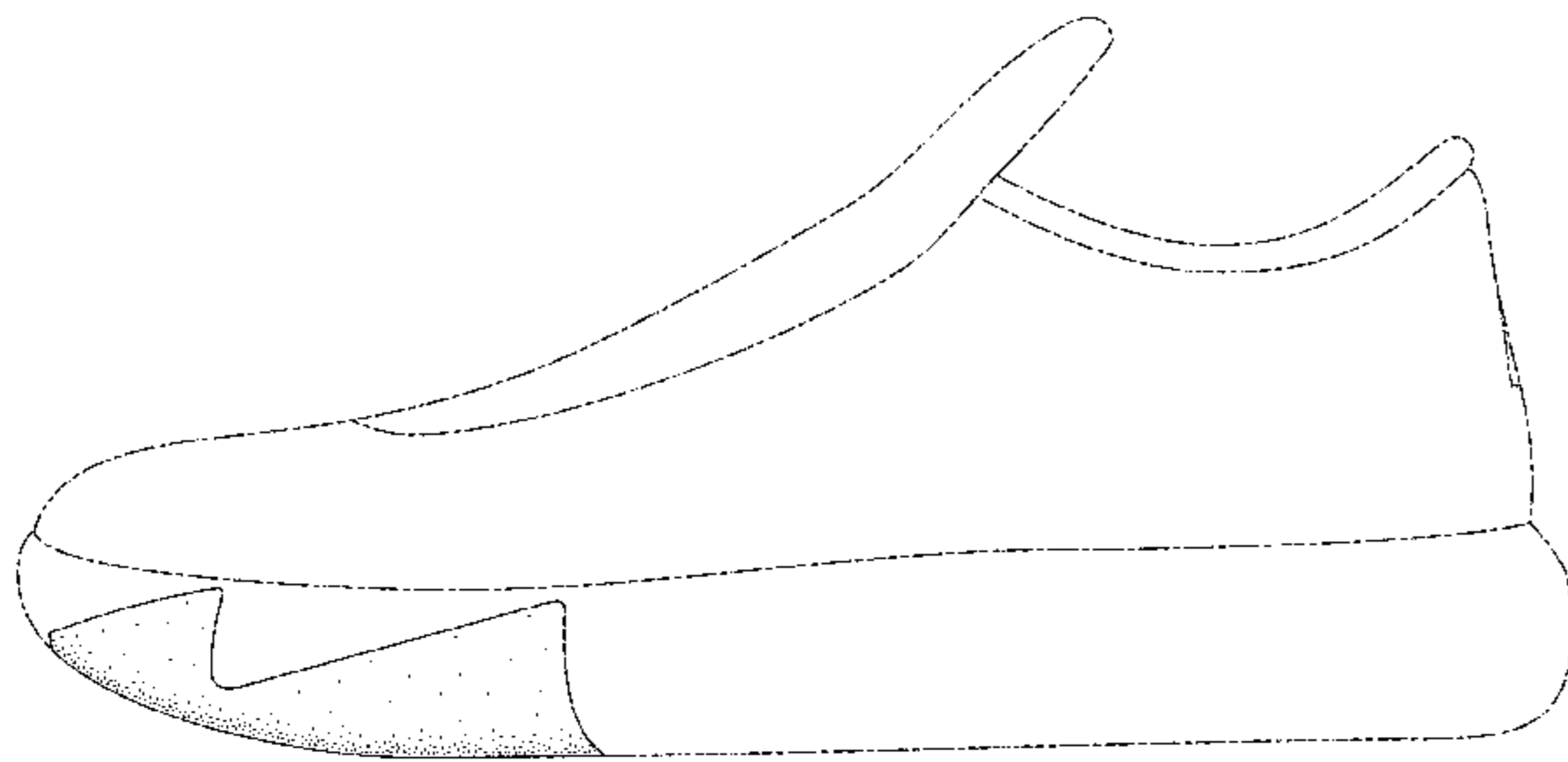
(57) **CLAIM**

The ornamental design for a shoe sole, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a shoe sole showing my new design;

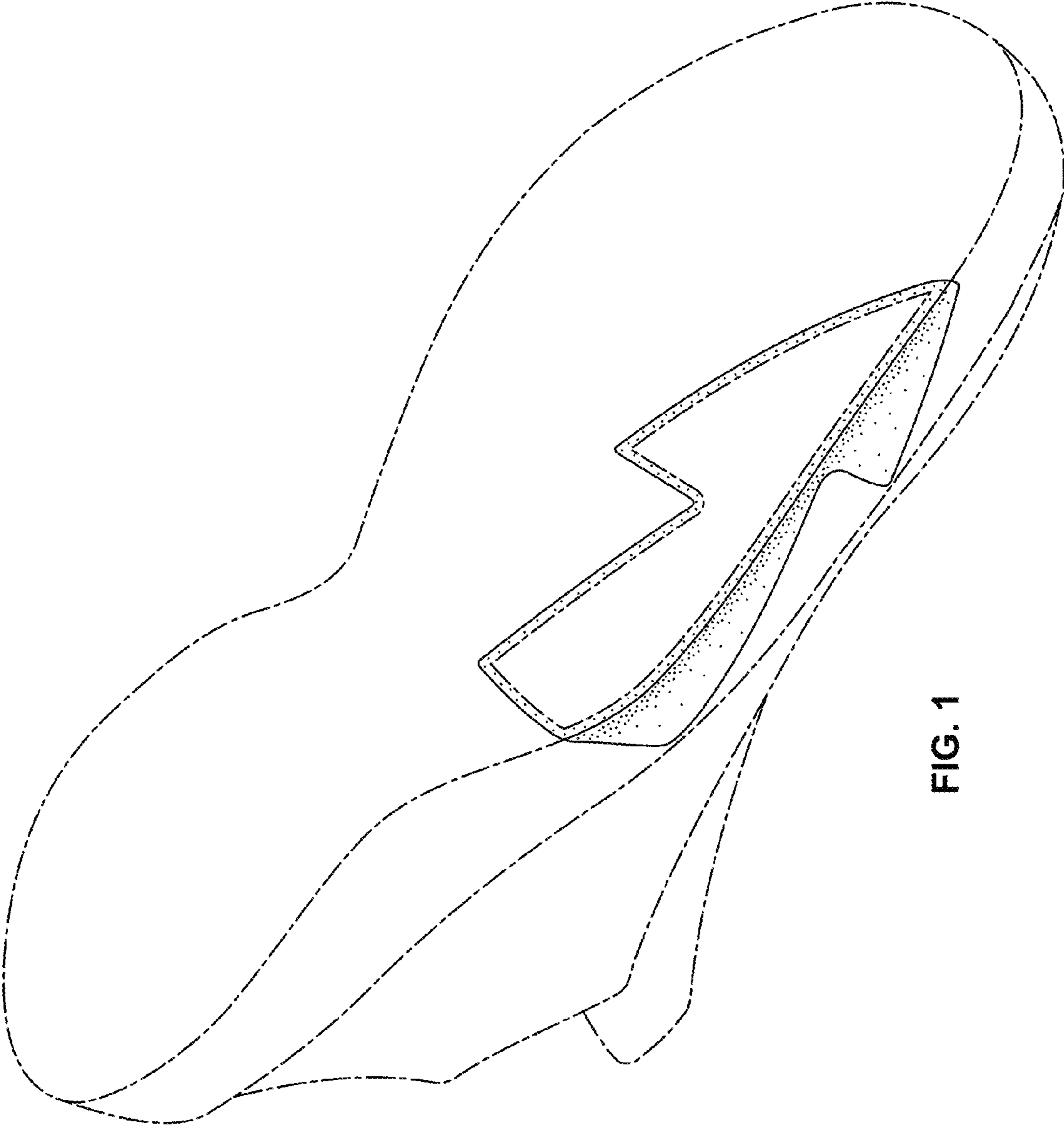

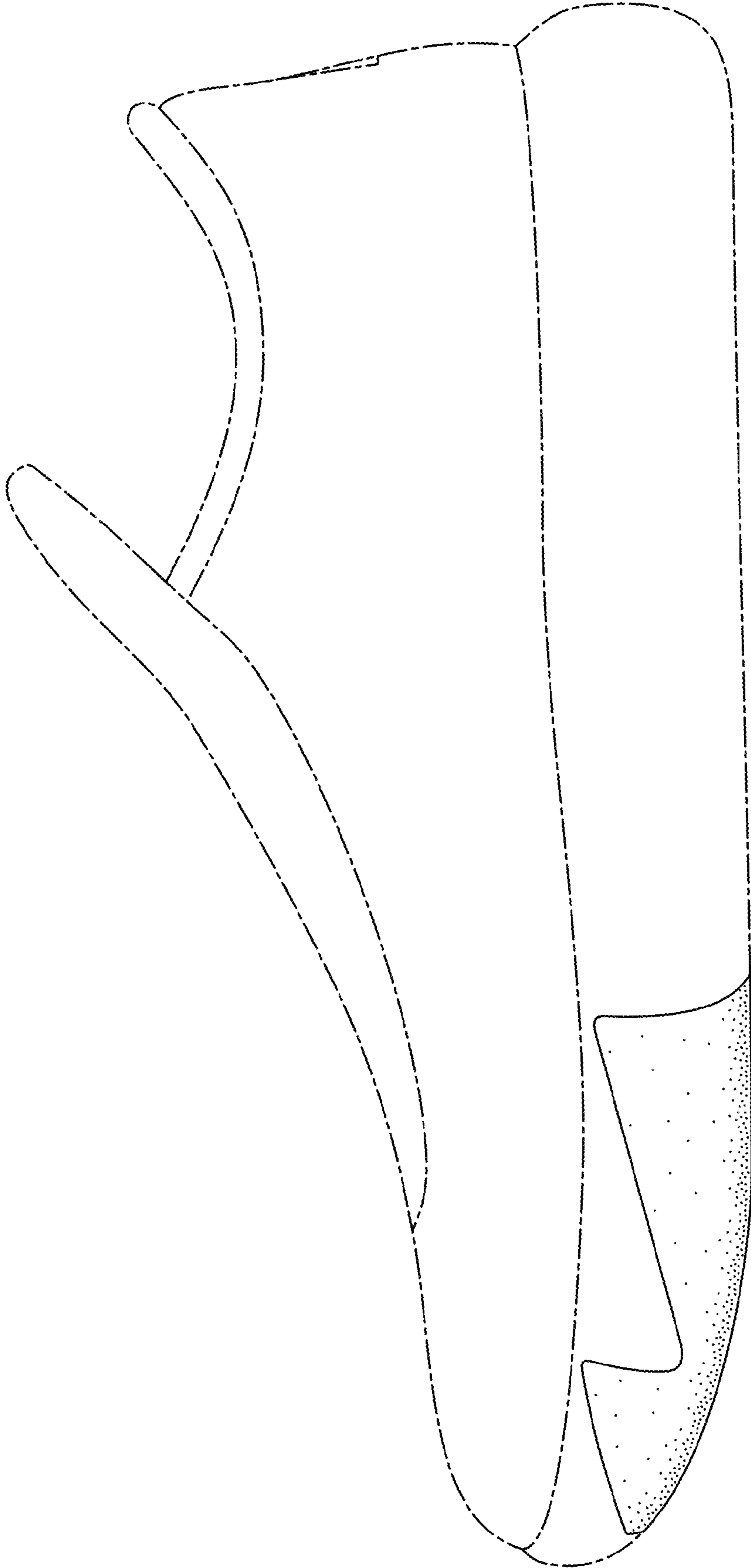

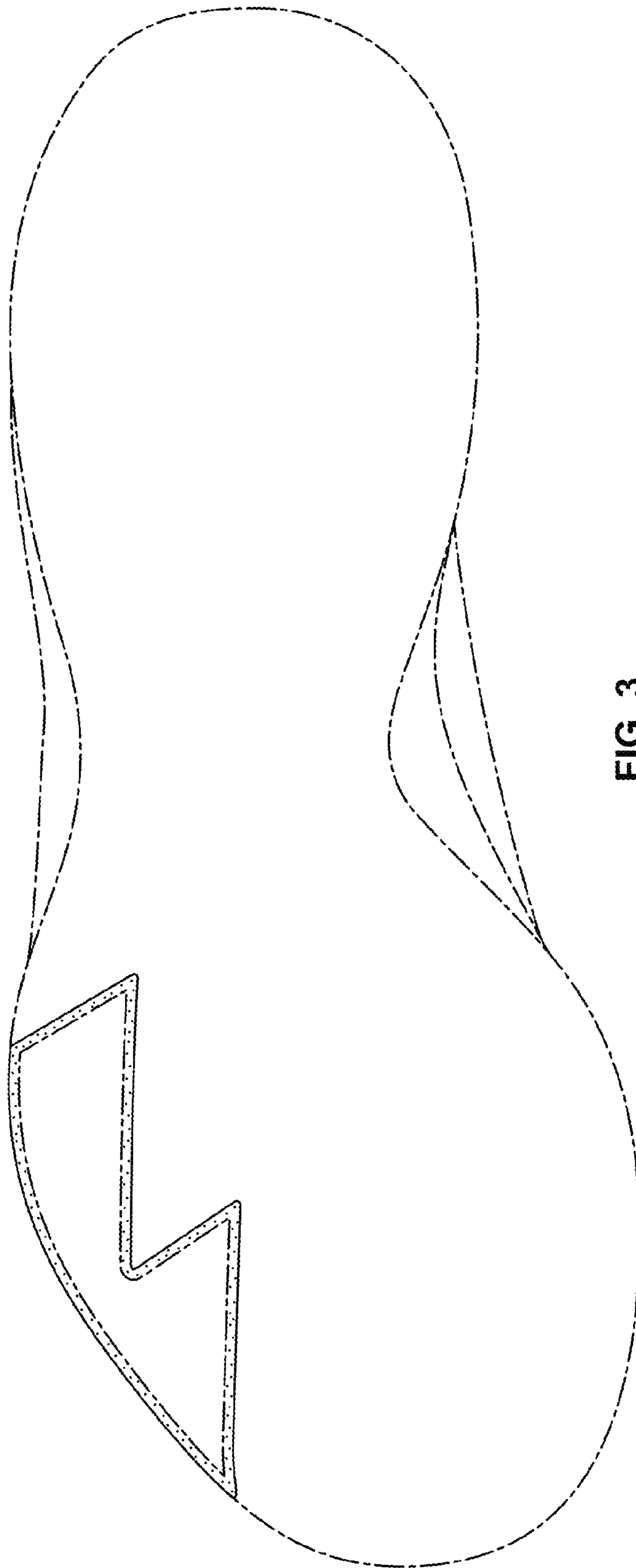
